AATF Reinstates Commitment To Improvement Of Farmers Livelihood

he African Agricultural Technology Foundation (AATF) has reiterated its commitment not to renege on its promise of transforming farmer's livelihood through innovative agricultural technologies that will improve incomes, food, and nutrition security in sub-Sharan Africa.

According to a statement s i g n e d b y t h e Communication Officer (West and Central Africa) AATF, Alex Abutu, made available yesterday,

Dr Emmanuel Okogbenin, A ATF Director, Programme Development and Commercialization restated the commitment during the training programme organized to equip seed companies with necessary skills to undertaking dry season cowpea production in Kaduna.

Dr Okogbenin said that AATF will continue to promote agricultural innovation through publicprivate partnerships and advised the seed companies to take advantage of dry season production to complement wet season production which will ensure adequate supply of PBR cowpea seed to farmers. He also noted that farmers have been educated on the benefits of the product and they are waiting anxiously for more certified PBR cowpea seed from seed

companies.
He expressed appreciation to Institute for Agricultural Research (IAR) for the collaboration which produced the PBR cowpea.

Also speaking, Prof. Ishiyaku Mohammed, Executive Director, IAR, Zaria commended the collaboration with AATF that led to the development and release of Nigeria's first genetically modified crop.

"Nigeria is now a reference point in areas of biotechnology products in Africa and we must continue to scale up production of this technology to make it available to farmers.

The Pod Borer Resistant Cowpea is a classic example of how technology can provide solutions to one of the major challenges confronting cowpea farming," he said.

Prof. Mohammed noted that for many years plant breeders tried without success to find solution to the ravaging attacks of M a r u c a b u t t h e "collaboration between AATF and IAR led to the development of this great technology."

He said, seed companies were pivotal to the commercialization of the PBR cowpea project and there is need for constant capacity building. "The PBR cowpea is a huge success in the biotechnology space in Nigeria and more seed companies are eager to take up the product. There are testimonies from farmers in terms of high yield, resistance to pod borer, improved income because of planting the PBR cowpea."

He enjoined the participants to fully take advantage of the training which will build their capacity in PBR seed production.

He also encouraged the participants to always contact AATF/IAR for f u r t h e r questions/clarifications.

All the nine seed companies licensed to market the PBR cowpea attended the training which saw presentation from Dr Seydou Traore, Regional Energy Advisor, United States African Development Foundation, amongst others.

AATF believes that the agricultural sector is a key foundational pillar as Africa consolidates its economic growth and carves out its new position as a major global economic powerhouse and the next growth market in the world.

It was formed in response to the need for an effective mechanism that would facilitate and support negotiation for technology access and delivery and formation of appropriate partnerships to manage the development of innovative technologies for use by smallholder farmers in

with questionable character.

"Voters are also always advised to shun those unhealthy schemes whereby a president or state governor handpicks a successor. Nothing promotes entrenched corruption, cronyism and poor leadership more that such schemes as such dubious arrangements.

"The nation will never be able of identify and select good leaders among its people so long as some dubious people are allowed to manipulate the selection of candidates and the ultimate election processes," ACF said.

The group said that in a few days, some 93 million Nigerians will go to the polls to elect a new President, 31 State Governors, 469 Members of the National Assembly, and 990 Members of the 36 State Houses of Assembly.

"There is no doubt that this is a gigantic and important exercise. Our hopes and prayers are that the elections will be held peacefully, and will produce outcomes that will help take the country closer to its main development goals of building a free, just, democratic, and egalitarian society.

"A great, united, and self-reliant nation, with a strong and dynamic economy. A land full of bright opportunities for all citizens.

Clearly, the necessary requirement for achieving success in the elections is the determination of Nigerians to ensure it actually succeeds.

"Towards that end, the federal government, in particular, must commit itself to delivering what should turn out to be a fair, transparent, credible and hitch-free elections the outcomes of which must be decided only by the votes cast," the statement said.

ACF explained that the President has at various times, and at different fora, promised to do that. "The nation looks forward to the fulfillment of that promise.

At times such as this when the nation in election mode, such as time like this, the ACF has always taken the liberty to draw the attention of voters to the right qualities they should look for when deciding whom to cast their votes for.

"At each occasion such as this the key selection criteria we recommend to voters to consider are very clear and objective party manifestos and the character and track records of the candidates," it added.

The group explained that cardinal and national goal of Nigeria includes the creation of a nation in which: "though tribe and tongue may differ, in brotherhood we stand".

"We, as a nation, believed so much in such slogan that at one time, it was a part of our national anthem!

"And in simple terms, it means that in our search for good leaders, we

must cast our nets far beyond our ethnic, religious or geographical interests.

"A leader does not have to come from our tribe, zone, region or religious persuasion. We should seek for leaders that best cater for our national interests, and who are elected within the tenets of democratic processes.

"The tenets that allow people to choose leaders who will best cater for interests of the generality of the people, not their individual personal or the interests of their ethnic or religious groups.

"When 17 State Governors from Southern part of Nigeria, and from different political parties met last year and demanded that a Southerner must be elected as the president of Nigeria, the heavens did not fall. It was accepted that as we are in a democracy, they were entitled to their views and opinions.

"Quite recently also, some 14 Northern Governors belonging to the ruling All progressives Congress Party, (APC), and came out with the announcement that they had committed themselves to ensuring that a candidate of their party from the Southern part of the country is elected president of the country.

"Their reason was that the emergence and subsequent election of a person from the southern part of the country will serve to entrench the principle of North/South power rotation in the politics Nigeria.

"Though the principle of power rotation is still largely and somewhat controversial, nonetheless, under our democratic dispensation we must reconcile ourselves to accepting that Nigeria is a country for all its citizens, and each citizen has right to choose whatever he or she believes to be in the best interests of themselves and their followers.

"At the same time, however, they also have to accept the principle of power rotation between North and South.


"Leaders in all climes must take all steps to ensure the safety of lives and property of all Citizens and foreigners in their domains," the group advised.

Financial Misappropriation: Katsina Govt Withdraws Case Against Shema

a t s i n a Government has withdrawn a Case of f i n a n c i a l misappropriation of eleven billion Naira instituted before State High Court of Justice against the former Governor of the State Ibrahim Shehu Shehu Shema.

The funds were said to h a v e b e e n misappropriated from the coffers of Association of Local Governments of Nigeria (ALGON) in the state while Shema was Governor.

The former governor was facing another Case of misappropriated fivepoint-seven billion Naira SURE-P Funds instituted

against him by the EFFC. Giving reason for the withdrawal of the case, the Director of Public Prosecution Katsina State Ministry of Justice, Abdurrahman Umar said the State Attorney-General a n d Commissioner for Justice exercised the powers vested on her by Section two of sub-section eleven of the 1999 Constitution as amended to discontinue the case.

In view of that the two defendants in the case, former Governor Ibrahim Shema as well as Lawal Dankaba were discharged from all charges against them

It would be recalled that the state government in 2016, filed the case against Shema and one other.

Cash Swap: Security Placed On Red Alert In Kaduna

o 11 o w i n g intelligence report gathered, security agencies have been placed on high alert and have been directed by the Kaduna State Government to decisively uphold law and order.

This was contained in a statement signed by the Commissioner, Ministry of Internal Security and Home Affairs, Kaduna State, Honourable Samuel Aruwan, made available yesterday.

"The Kaduna State Government has received credible intelligence reports of plans by various groups to deliberately disrupt public peace, by organizing street protests.

"The Kaduna State Government hereby reminds citizens that such protests remain strictly prohibited. Citizens are strongly advised to avoid all actions remotely capable of inciting a breakdown of law and order," it said.

"Any resort to unruly or violent conduct is illegal

and against the public interest which values law and order," it warned.

The government said that

it has continued, "to empathize with citizens who have been placed in untold distress as a result of the CBN cash swap policy. Residents must shun the baiting of mischievous groups hoping to ride on these hardships and incite violence.

"The Government of Kaduna State, and other concerned state governments, are

deploying the full instrumentality of the law to attain a proper resolution, and thus bring relief to citizens," it saud. It added that government is also studying options for addressing challenges being faced by citizens with regard to transport to

ODCF National President in a statement made available to journalists in Ibadan on Sunday, said the new Naira swap and cash withdrawal policy is already creating suffering for the masses in Nigeria. "We are calling on the

through the Central Bank of Nigeria (CBN) to expedite action on the c as h s w a p / c as h withdrawal limit policy and make the new Naira notes available for the people," he said.

Barrister Raji added, "it is very clear that the situation in the country, especially that of the cash swap and cash withdrawal limit policy has caused a lot of hardship for the people, this has shown in the emotional outburst that has led to violent riots across the country and loss of lives and properties".

He stressed that the people of Oke-Ogun should remain calm and avoid activities that might lead to violence and destruction of properties in the region, saying, "in Oke - Ogun, we should remember that the development process to get our region to an enviable level has started, the federal and State

government have started looking towards developing natural resources in our area while business owners are thronging towards the region to establish their businesses'.

On the need to eschew violence at this critical period so as not to destroy the little we have and chase away those coming to help build more', Barrister Raji tasked community leaders in Oke Ogun to be working towards attracting and building public infrastructures rather than destroying them through violent mob actions and protests.

"I urge our monarchs, community leaders, market leaders, youths leaders and others to please have periodic discussions with our youths so they will have sense of belonging in this process of safeguarding the little we have till we have more"

He however challenged youths in Oke-Ogun to also see the 2023 elections as important to change the fortune of Nigeria for the better, asking them to vote for their conscience and eschew violence, saying, youths should rather decide on good leadership come the 2023 elections rather than rioting.

3 Suspects In NDLEA Net Over UK, Saudi Arabia, New Zealand, Cyprus Bound 52.10Kg Illicit Narcotics

t least, three suspects have been arrested by operatives of the National Drug Law Enforcement Agency (NDLEA) over attempt to export 52.10 kilogrammes of ephedrine, a precursor chemical and active ingredient for the production of meth.

The consignment, said to be heading to the United Kingdom, Saudi Arabia, New Zealand and Cyprus, according to report, were intercepted at the Murtala Muhammed International Airport (MMIA), Lagos; N n a m d i A z i k i w e International Airport (NAIA), Abuja and some courier companies.

Our correspondent gathered that the suspects, identified as Nwudele Basil Christopher; Chiedu Ezenwani Francis and Donatus Nwojiji were nabbed at the Trade Fair Complex in Ojo area of Lagos.

The spokesperson of the anti-narcotic agency, Femi Babafemi in a statement yesterday, confirmed the report.

According to Babafemi, attempts to export 52.10 kilogrammes of ephedrine, a precursor chemical and active ingredient for the production of meth, concealed in bunches of fishing threads and packed among other items in jumbo sacks that were thwarted at the SAHCO

export shed of the Lagos airport on Sunday, January 31, and Monday, February 1, 2023.

He said that it took the painstaking efforts of NDLEA officers and deployment of sniffer dogs to be able to discover the complex mode of concealment of the illicit substance.

At least three traders at the Trade Fair Complex in Ojo area of Lagos: N w u dele Basil Christopher; Chiedu Ezenwani Francis and Donatus Nwojiji have been arrested in connection with the substances.

Also, at three different courier firms in Lagos, operatives intercepted two cocaine consignments weighing 400 grams each, going to United Kingdom and Saudi Arabia. They were hidden in walls of cartons used for packaging.

Two other consignments containing 500 grams and 100 grams of meth were also blocked from being shipped to New Zealand after they were discovered concealed in food items.

Similarly, at the Abuja Airport, vigilant operatives of the Agency on Monday, February 13, intercepted a 29-year-old Apeh Kelvin Ogbonna while attempting to board Turkish Airline flight TK0624 going through Istanbul to Cyprus, with 4.5 kilograms of meth concealed in false bottoms of his travelling bag.

The suspect claimed he was running a boutique business in Enugu before he decided to travel to Cyprus for a degree in Business Administration. No fewer than 2,684,900 pills of tramadol and other pharmaceutical opioids were seized by operatives during interdiction operations in some states

The statement further read: "In Adamawa, a total of 250,000 pills of tramadol and exol-5 as well as 1800ml of codeine neatly concealed in the reserve fuel tank of a trailer from Onitsha, Anambra state were seized at Mubi and a dealer, Hussaini Ibrahim (a.k.a Bafu) arrested.

in the past week.

"While a total of 279,000 pills of tramadol 200mg and 225mg were recovered from a suspect, Hammajan Suleman, along Okene-Abuja highway in Kogi, on Monday 13th February, 376 blocks of skunk weighing 229.36kgs and a Toyota Camry car used in conveying the consignment from Edo state enroute Kano by another suspect, Moses Alabi were handed over to NDLEA by a patrol team of the Nigerian Army, in Lokoja on Tuesday 14th February.

"In the same vein, two suspects: Christian Nnachor, 23 and Chinonso Obiora, 20, arrested with 1,843,900 tablets of Diazepam and 300,000 pills of Exol-5 by soldiers

along Abuja-Kaduna express road were transferred to the Kaduna State Command of NDLEA on Monday 13th February while Christopher Maduka, 43, was arrested with 10,000 ampoules of pentazocine injection by NDLEA operatives on Saturday 18th Feb. along Abuja-Kaduna highway.

"In Kano, Ahmed Suraj Rabiu was nabbed with 89 bottles of codeine syrup in Badawa area of the state, while Amadu Musa and three others were arrested in Kofar Mata with 53 blocks of cannabis weighing 41.9kgs. In Niger state, a trans-border trafficker, Abdullahi Isah was arrested along Jebba-Mokwa highway with 188 blocks of skunk that weighed 107 kilograms, which he was attempting to take to Niger republic.

"While 24kgs of Arizona variant of cannabis and 2,000 pills of opioids were recovered from Ibrahim Isiyaku along Nguru-Kano road in Yobe, no fewer than four suspects: Usman Abubakar, a Chadian; Muhammad Ali; Ibrahim Yahaya and Babagana Abdullahi were arrested in connection with the seizure of 61.45kgs of cannabis and 22.1kgs of exol-5 in Jigawa with follow up operations in Kano. The consignments were ordered by Usman with a view to taking them to Chad.



Governor Inuwa Inspects Ongoing Kumo General Hospital Project

*Expresses Satisfaction With Quality, Speed Of Works
*Says Project To Be Ready For Commissioning Before May 29 This Year

overnor Muhammadu Inuwa Yahaya says the General Hospital, Kumo under construction will be ready and handed over for public use before May 29, this year.

A statement signed by the Director-General (Press Affairs) Government House Gombe, Ismaila Uba Misilli, dated Saturday February 18, said

he made the pronouncement when he paid an unscheduled visit to the site where he inspected all the units under construction at the state- of -theart project.

Though unplanned, Governor Inuwa engaged the contractors handling the project on the level of work done so far and asked if there were any challenges.

As he was being taken round, he took his time to check the quality of materials and fittings used for the finishings, and expressed satisfaction that the contractors are working within agreed specifications.

"What I saw was absolutely good. It met my expectations and I challenge anybody to come and verify whether it has met international standards or not. I am convinced of the quality; I am convinced of the speed, especially; I am confident that before 29th of May this year, this hospital will be completed and handed over for use by the public", he said.

"Our intention is to make it work with Lincoln University which is supposed to partner with us, to operate the Science and Technology University; and they are going to have a medical faculty. Eventually this will turn to a Teaching Hospital by all standards because all the equipment needed are ready. We are just waiting for the contractors to put finishing touches. They are at the last stages of the project", he told newsmen.

The Governor urged the people to take ownership of projects sited in their areas, reiterating his belief that "people must be able to run projects by themselves and run it well. The project is for the people, I do not own the project. People must own it because government is an amalgamation of the people. Myself, themselves and leadership at all levels. When they manage it well, it will

outlast us by the grace of God".

the citizens of Gombe is the reason he is in government and that he is ready to do more even as he heads for elections in a few weeks time.

As his convoy was leaving the site, teeming youths of Kumo gathered around his vehicles cheering him and showering praises amidst shouts of Four plus Four, indicating their unflinching support for him to be returned for another four years in office.

Saleh asserted this in Kaduna during an investiture of the 16th Branch Chairman of the

Association of Medical Laboratory Scientists of Nigeria (AMLSN), where he also noted that international conspiracy is also a factor fueling the lingering insecurity in the country.

He however, said that the nation is blessed with abundant resources that if properly channeled, would solve the insecurity challenges confronting the nation within a period of a fortnight.

Saleh who is also a Forensic Scientist and Public Security Analyst, said, "With the amount of intelligence we have, and resources at our disposal; both in intelligence and the uniform security services, I can assure you that if there is a political will to solve the problem of insecurity bedeviling this country, two weeks is too much to end insecurity in the country.

"Sincerely, we have men and women from these security services that are patriotic and ready to lay down their lives in service of their father's land, just



to ensure that their follow citizens can sleep with their two eyes closed confidently and conveniently."

While speaking, he further explained that conspiracy of silence and political conspiracy are also key players in fueling the insecurity in the country, adding that these conspiracies are aimed at making the country ungovernable.

He therefore, urged the government to strengthen intelligence agencies in the country on their mandates of foreign and counter intelligence operations.

According to him, the intelligence agency is an equivalent of CIA in Nigeria, which he opined that the agency and other sister agencies should be properly utilised, especially in the area of intelligence gathering.

The Public Security Analyst also advised that the traditional rulers should be giving a constitutional role in the area of intelligence gathering.

Legal Practitioner Laments Sufferings Of Southern Kaduna People

Kaduna based legal practitioner, ▲Gloria Mabeiam Ballason, has observed that the years of suffering and persecution of Southern Kaduna people has been on for decades.

She explained that before the 1960s, mothers, sisters and forbears were carted away as slaves and forcefully married in Zazzau.

She also observed that the people's harvested agricultural products in farms and barns were forcefully seized and used as fodder to feed the animals of slave masters.

Speaking in a keynote address delivered at the public presentation and launch of: "Southern Kaduna: Yesterday, Today & Tomorrow" in Kafanchan, the legal practitioner noted that amidst these oppressions, Southern Kaduna people fought and refused to be a conquered territory.

She stated that for those who may just have joined the story in recent times, the overwhelming nature of the painful experiences the people now suffer, may seem isolating and frustrating enough because our forebears battled and worked so hard to get us to where we are today.

She enjoined the people to build a region where faith is anchored in character as opposed to empty religiosity, saying that in a world that is increasingly becoming sullen and despicable in vices, the people owe it as a duty to demonstrate faith through virtue and to be a people of substance who are known to be resolute in principles. The legal practitioner suggested that the people of the area must continue to invest in agriculture and education, lamenting that it is now difficult to get to the farms but the people must continue to device means to farm to feed and stay alive on safe lands while

combatting the terrorists. She added, "We must insist on our identity and culture. Cultural rights are human rights recognized in International Law and Covenants and the Nigerian Constitution. (See Article 27 of the Universal Declaration of Human Rights, Article 15 of the International Covenant on Economic, Social and Cultural Rights and Sections 21 and 39 of the 1999 Constitution of the Federal Republic of Nigeria (as amended). It is therefore criminal and a violation of rights for any government to change the names of chiefdoms or the identity of a people, desecrate their cultures or balkanize their identities.

She urged the people of Southern Kaduna to instill in their people pride in their identity and imprint in the children the assurance that they are enough and must refused to be named by what anyone thinks they are and lay hold of the original identities of their people and their lands, traditional titles at all levels should be in their dialects and not in another external tribe as it is how a people define who they are and stamp it on the



sands of time.

According to her, hate and violence must be banished, saying that the people cannot afford for today's victims to become tomorrow's combatants, as any region that has known perpetual violence has to consciously work to recalibrate against being defined by it.

She stated that, "the timelines show that from the 1980 Kasuwan Magani crisis through 1986 in Yarkasuwa, Lere District, 1987 in Kafanchan, 1992 in Zangon Kataf, 1999 in Southern Kaduna, 2000 which saw an unprecedented escalation in casualties, 2002 Miss World, 2011 in Anchuna, 2011 at Tabak, Kukum-Kagoro and then from 2012 till date, the cycle of violence meted on our communities in Southern Kaduna has continued".

She lamented that the lives and history of the people have been shaped by these unfortunate incidents, saying that they are not

slow-boiling conflicts as is often wrongly reported, but are systemic killings and mass atrocities crimes of genocidal proportions that demand international intervention and the political marginalization and the economic, educational and infrastructural deprivation, reveal a structural neglect.

As if that is not bad enough, she stated that under the Nasir el-Rufai government, the region has experienced unprecedented persecution, politically, the diversity of the state is not represented as thousands of civil servants and teachers have been thrown out of jobs, stressing that tertiary institutions in Southern Kaduna were exclusively shut down by the government as the identities of the people were changed by executive fiat and cultural heritage have been destroyed with paramount leaders and dissenting civic voices and journalists imprisoned, kidnapped or killed.

Currency Redesigning, Step To A Better Nigeria - Senator Akpan

Don't Hold Census During Ramadan, Council Of Ulamas Begs FG

*Demands sacking of bad eggs in security agencies *Says old, new Naira notes should be allowed to circulate

hile admitting that census is a very important activity in any country which provides governments with information and data necessary for development, the Council of Ulama of Nigeria has appealed to the Federal Government not to hold the scheduled 2023 exercise during the month of Ramadan

The council made the appeal in a communique issued after its Annual General Meeting (AGM, held at the National Headquarters of Jama'atu Nasril Islam (JNI) on February 16 and 17, 2023, signed by its National Secretary, Professor Muhammad S. Abubakar.

"The Council is fully in support of the exercise, but the timing is wrong as it will involve Ramadan period.

"The Council therefore, calls for little adjustment so that Muslims can fully participate without any hindrance," the group said.

The meeting was attended by Muslim Scholars, Imams, and Academician across the states of the federation and Abuja.

It explained that the participants had exhaustive deliberations on a number of issues at the end of which the following observations were made.

"The insecurity challenges pervading the country for over a decade now accounting for unquantifiable losses, human and material is a great concern to all Nigerians;

"The new policy of Naira redesignation is inherently not a bad idea. The Council however condemns the refusal of the CBN to release adequate quantity of the new notes, a phenomenon that has thrown most Nigerians into unmitigated hardship.

"Nigeria's'general elections are commencing from 25th February 2023 in sha Allah. Eighteen political parties have combed every nook and cranny of the country canvassing for votes:

"It is a matter for great concern that the prices of petroleum products especially the PMS and the diesel are becoming prohibitive. Nigerians are torn between subsidy removal, deregulation and refinery maintenance," the communique



said.

The Ulamas lamented that the perennial conflict between farmers and herders and by extensions the recent unprovoked attack on innocent herders which led to the death of about forty persons and undisclosed number of cows at Rukubi village in Doma Local Government Area of Nasarawa State is unacceptable;

"So far tens of thousands of human lives and animals worth Trillions of Naira have been lost in the ensuing conflict between herders and farmers;

"The unparallel courage and doggedness of His excellency

Babagana Umara Zulum of Borno State in tackling the Boko Haram insurgency and its consequences, particularly the rehabilitation of the IDPs and empowering themis

highly commendable," the communique said.

The Council therefore, called on the government to massively recruit security personnel, to embark on pre-emptive attacks within the bandits hide out, to adequately equip and train them, to improve on their welfare and intelligence gathering, and to rid the services of bad and rotten eggs among them;

They also called for the lifting of

all deadlines imposed on currency retrieval and that the old and new currencies should be allowed to run concurrently until the old currency is completely phased out;

"The Council calls on the CBN to make the new currencies available in large quantity throughout the country and without any restrictions.

"For instance, there is one senatorial zone with twelve local governments and only two have banks. In such cases no amount of Naira swap can solve their problems," they said.

On the general elections, the council equally called on INEC

to remain an impartial umpire for the exercise to be free, fair and credible.

"The security agents are also called upon to selflessly superintend the conduct of all the elections and to contain any miscreant or trouble shooter whose conduct is inimical to the successful elections;

"We call on the contestants to be good winners and good losers, those defeated should follow the appropriate legal channels to channel their grievances. While the winners should refrain from provocative and dishonorable behavior.

"Nigerians are also strongly urged to come out in their multitudes and exercise their franchise without succumbing to the highest bidder," the Ulamas said.

The Council called for the urgent redress of fuel scarcity and the escalation of its prices.

"As a matter of urgency, constructed private refineries should be allowed to commence operation to save our foreign reserves," they added.

The Council backed the idea of 'ranching' (Ruga) which they said is a global best practice.

"No matter what is spent along that line is not worth losing a single life," the communique pointed out.

They also called on the federal government to institute a high judicial panel of enquiry to dig out the perpetrators of Rukubi crime and get them punished accordingly.

The Council urged Muslims to pray for the defeat of Boko Haram insurgents and the success of Governor Zulum in tackling their menace and capacity to

settle all the IDPs.

The Council of Ulama commiserated with their brothers and sisters in Turkey and Syria over the devastating earthquake that shattered the two countries.

"The Council requests Muslims all over the world to extend the hand of brotherhood by conveying relief materials to the victims and praying for the departed souls," it concluded.

overnor David Jumahi of Ebonyi State has suspended the activities of the Ebubeagu security outfit due to a recent high court judgment and inaugurated two new vigilante outfits called Ebonyi State Neighbourhood Security Watch and Ebonyi State Vigilante Corps respectively.

Governor David Umahi disclosed this in a broadcast on Friday, stating that activities of the security outfit have been suspended and two new vigilante outfits have been formed to ensure security of lives and property across the state.

"The Ebubeagu security outfit will not function in the state until the stay of execution is granted and appeal entered.

"This is in obedience to the rule of law and whether it is good or bad for our people, it is the court's judgment"

Governor Umahi noted that the judgement from a court of equal jurisdiction had a month ago, restrained anyone from disbanding the outfit because of its contribution to the security of the state.

same subject as the second one shouldn't had been due to an earlier decision on it.

"When the stay of execution is granted, Ebubeagu will function again.

He appreciated the state House of Assembly for their commitment in passing into law, two sets of vigilante outfits which processes commenced since 2021 in Ebonyi state. Alhaji Garba Shehu disclosed that, "there is indeed a problem and nobody will pretend that it doesn't exist and it is precisely because the President is concerned with this problem that he opened several avenues for consultation with leaders and groups across the country, culminating in his broadcast to the nation on Thursday morning."

I Want To Champion Challenges Of My Constituents At National Discourse - APC Reps Candidate

Dr. Samuel Adesola Adedayo, a medical doctor, a former chairman of Apapa Iganmu Local Council Development Area and the All Progressive Congress (APC) House of Representatives candidate, Apapa Federal Constituency in the forthcoming 2023 general elections, in a no hold barred interview with RAYMOND TEDUNJAYE, said his mission is to bring the challenge of his constituents for national discourse. Excerpt:

aving served as a Council chairman, what informed your decision to vie for the House of Representatives position?

Well, for me, it's a call to service. I had been local government chairman for two terms, which is the limit and am not tired of serving my people. I have therefore put forward myself to defend their common interest at the Green Chamber and improve their livelihood.

What would be your priority if elected?

I will work with Representatives from other parts of the country to enact laws that will improve the welfare of the down trodden. Most areas in Apapa Federal Constituency are categorised as low income areas and many of the residents are peasants. In that constituency, we have 10 Wards and four of those Wards are in an elites environment, that's those in Apapa GRA and Apapa Tincan Wharf, but the large percentage of the people that live in Ijora Oloye, Apapa-Iganmu, that constitute six Wards are peasants.

The whole of Apapa Iganmu is actually a slum and one of the things we need to do is to reduce the gap between the rich and the poor if we don't want to run into crisis because the standard of living in that place is well below average. I believe if their Representative can bring there challenges to a national discuss, people will see the need to assist them.

As a former Council chairman in the Constituency, what would you consider as their major challenge?

Well, I will like to look at it from various segments of that society. I want to look at the large number of unemployed youth, they constitute a risk to the society. Not all of them are uneducated, many of them are educated but have no jobs. Secondly, there are some of them that have no skill, we should help them to develop a skill as a form of empowering them so that they can stand on their own and earn a decent living.

There are two major Ports at Apapa Federal Constituency, but right now, this Constituency is short-changed in terms of renumeration as regards what the Federal Government earns as revenue from them. We should look at the Ports along the Nigerian coast and earmark something like derivation for them. People living along those areas should have a form of relief because they generate alot of money for the Federal Government. Therefore, the Federal Government needs to pay special attention to them.

The other issue may be issue of accommodation, housing is a big problem for these people. If you see the way they're living, the government needs to do a lot to assist them, this can be done either through mortgage or owner occupier.

The environment is also not too conducive for living well, it's in jeopardy.because there is open drainages

with mosquitos and all those kind of a thing. Honestly, we need to do something drastically to improve the environment and this will in turn boost their living standard. And of course, we have a large number of children in the society and we need to take care of their education.

Again, even the sporting facilities in those areas, we need to improve on them. When I was the Council chairman, I facilitated the building of a mini Stadium for them, but nothing has been done there since I left office. We need to encourage them so that we can also pick those of them that are skillful for further development.

These are some of the things am thinking about and of course am going to liase with the stakeholders to know exactly what are their needs so that we can do the need assessment. Once we do the need assessment, I will work with other legislators and the executive of course to see how we can improve the standard of living of these people. Honestly, we have a large number of them that are earning below one dollar a day. So we must look at a way of reducing what they call the gene index.

What are your chances of winning the election?

Let's start by discussing the platform on which am contesting. The All Progressive Congress (APC) is a platform that is acceptable to the people in Lagos and this is due largely to what the government of the progressives has done since 1999 and they have been helpful to the people of the state. So, I can't see anybody living in Lagos that have not benefitted directly or indirectly from the progressive governance that we have since 1999 that was spare headed by Asiwaju Bola Ahmed Tinubu.

This is an advantage for me. The second one is that on a personal note, I have been Council chairman between 2008 and 2014 and I have been residing with them since 1988. I have been a community leader and a philanthropist in that area and am at home with every segment of the community. When you talk of the Yorubas, am at home with them, you talk of the Hausas, am at home with them, even the minorities like the Ilajes, Apois, the Nuipes and all of them. Again, because I have an hospital there that serves all these people and it's like a community hospital for that area. Am sure those competing with me will lose their deposit if they ever bet.

The fuel scarcity issue coupled with the crisis of cash crunch seem to have hit up the polity and there is anxiety that the Election may not hold, how do you react to this?

I am a firm believer in God and I believe it doesn't matter what people are doing to scuttle the election. The election will hold, we will have winners and a



democratic government in place, ready to take over power from the outgoing government.

I don't want our people to be discouraged. There is no doubt that there are some forces that are trying to scuttle the election and those forces shall be defeated

by the grace of God. I appeal to our people not to be discouraged because they will soon smile.

I believe if Asiwaju wins by the special grace of God, there will be remarkable changes based on what he had done when he was Governor of Lagos State.




But as if punching it in the bags

Recently, just after the APC presidential campaign in Kano, while his principal headed for Edo State for the next phase of campaigns, Kashim Shettima stayed put in Kano for three days reconciling all factions and ensuring that all stakeholders in this most crucial state are all on the same page ahead the polls. Needless to state that all issues in the state are today a thing of the past with Kano ready to vote enmasse for the APC. Alexander the Great's, "I am not afraid of an army of lions led by a sheep; I am afraid of an army of sheep led by a lion" statement might have been used over time in the depiction of strength in leadership and character, however, it will once more come into play on Saturday as days wind down to hours, minutes and eventually to seconds.

An established fact remains that Shettima's massive involvement and presence in the presidential elections has been a huge win for the presidential aspiration of Bola Tinubu. It can be said that in the choice of Kashim Shettima, the presidential candidate of the APC struck gold.

2023 Election: Are The Security Agencies Ready For The el-Rufa'is?

he death of a thousand good men is not as tragic as having an unfit man in a position of national leadership - Usman dan Fodio.

The above quote by Sheikh Usman Dan Fodio, a Fulani philosopher, Islamic religious teacher, revolutionary, and leader who founded the Sokoto Caliphate and ruled as its first Caliph, is quite true. This is so because an unfit leader can cause the death of millions and plunge a nation into chaos, anarchy and civil war.

We are just about five days away from a presidential election, an important one because it is to usher in a new president since the occupant is about to complete his tour of duty.

However, it is coming on the heels of a currency redesign and scarcity coupled with the unavailability of Premium Motor Spirit, causing long queues at fuel stations. Unfortunately, despite the issue of fuel scarcity being a perennial problem for us, one of the presidential candidates told the nation that it was aimed at himas well as the Naira redesign.

Sadly, some governors in his camp seem to have accepted his allegation hook, line and sinker, making them rush to the highest court in the land to seek a reversal of the currency policy. They did not stop at that; they are doing all they can to blackmail and arm-twist the president, who is in the same party as them and to whom most of them owe their electoral fortunes.

It may have been okay, perhaps, if it stopped at that. But no, it did not. They are openly calling for mutiny, instigating the public against the president, who is the symbol of our sovereignty.

The governor of Kaduna State, who could never have been a state governor in the first place if not for the bandwagon effect the popularity of President Muhammadu Buhari had on the elections of 2015, has called for outright disobedience of the president. And in doing so, he swore that if his presidential candidate won the election of 25 February, they would abrogate the redesign policy.

First, he started by saying "a cabal in the villa" was against

his candidate. He then said, "the North has no elders". He moved on to speak about the "dullness" of those around the president, that he has no confidence in the intelligence of those advising the president, a euphemism for saying the president is unintelligent!

In all this, he claims that he is a staunch believer in "the rule of law", and "respecter of the judiciary" and has an unmitigated love for the "masses". But is that true?

People who knew him well have told us otherwise. In his book, "My Watch" Vol 2; pages 110-112, Obasanjo summed Nasir el-Rufa'i as "a petite-sized man with an elephantine brain that has a penchant for lying, disloyalty."

Former Vice President Atiku Abubakar, who was instrumental in bringing the Kaduna State governor to the limelight, also accused him of dishonesty, disloyalty and biting the fingers that fed him. Senator Shehu Sani, in January 2019, then representing Kaduna Central in the Red Chamber, while on The Osasu Show with Osasu Igbinedion, predicted that Nasir el-Rufa'i will turn against President Muhammadu Buhari in the future. He described him as a "serial betrayer" who turns against any government when it is no longer in his favour.

Now, the "serial betrayer" is claiming to be fighting for the "poor" and is caressing "respect for the judiciary". But nobody takes el-Rufa'i with any seriousness when he speaks of love for the masses, the rule of law or obedience to court orders. He has, on countless occasions, refused to abide by court orders in his capacity as governor; a man whose successor as minister of the Federal Capital

Territory inherited over 3,000 court cases. We can still 'see' the picture of the late Justice Bashir Sambo sitting outside his house as it was being demolished on el-Rufai's instruction despite a restraining court order. That singular act, more than anything, hastened the northern elder to his grave.

The late Justice was an elder in the genuine sense of the word. He was a Grand Kadi, Sharia Court of Appeal, Kaduna, and later that of the Federal Capital Territory, Abuja. He also chaired the Code of Conduct Tribunal and was an acting national secretary-general of Jama'atu Nasril Islam (NJI) as well as the chairman of the Kaduna State Council of Jama'atu Nasril Islam. The late Justice was an executive member and treasurer of the Council of Ulama of Nigeria, an executive member of Jama'atu Nasril Islam and an executive member of the Nigerian Supreme Council for Islamic

Affairs (NSCIA). He also published volumes of Islamic Religious Studies Books. But then, el-Rufa'i, our enfant terrible, has concluded that the north has no elders but him because he is 63 years old!

As for the love of the masses, when some state governors, especially that of Yobe State, Honourable Mai Mala Buni, were providing succour for the people of their states, it is on record that el-Rufai turned Kaduna into a hell on earth to the

extent that all those passing through were subjected to the most inhuman and degrading treatment. Surely, if he was concerned about the economic well-being of the people, he would not have demolished many of the masses' means of livelihood.
