he Ooni of Ife and the Co - Chairman of the National Council of Traditional Rulers of Nigeria (NCTRN), Oba Adeyeye Enitan Ogunwusi on Thursday, cautioned politicians against violent conduct before, during and after the 2023 general elections.

Ooni Ogunwusi gave the caution during a 'State of the Nation' address at his Ile Oodua Palace, Ile-Ife as this year's general elections kick off tomorrow.

The Ooni emphasized that there is no need for the politicians in the country to be desperate in their quest for power especially in this general elections.

"No politician can force his or herself on Nigerians and this is why our politicians should avoid being desperate in their quest for power. If you don't win today, it may be

## UN Agencies Express Concern Over Soaring Maternal Deaths, Urge Countries To Reduce Trend

report, "Trends In Maternal Mortality," released by United Nations agencies has shown that a woman dies every two minutes due to pregnancy or childbirth.

The UN agencies, World Health Organization (WHO) and United Nations Children's Fund (UNICEF) and others said that the new data show major setbacks for maternal health in many parts of the world.

They pointed out that the new data has highlighted stark disparities in healthcare access.

"Every two minutes, a woman dies during pregnancy or childbirth, according to the latest estimates released in a report by United Nations agencies today.

"This report, Trends in maternal mortality, reveals alarming setbacks for women's health over recent years, as maternal deaths either increased or stagnated in nearly all regions of the world," the UN bodies pointed out in a news statement issued on 23rd February 2023.

"While pregnancy should be a time of immense hope and a positive experience for all women, it is tragically still a shockingly dangerous experience for millions around the world who lack access to high quality, respectful health care," Dr Tedros Adhanom Ghebreyesus, Director-General of the World Health Organization (WHO), said. "These new statistics reveal the urgent need to ensure every woman and girl has access to critical health services before. during and after childbirth, and that they can fully exercise their reproductive rights."

The report, which tracked maternal deaths nationally, regionally and globally from 2000 to 2020, shows there were an estimated 287 000 maternal deaths worldwide in 2020.

The above figure marked only a slight decrease from 309,000 in 2016 when the UN's Sustainable Development Goals (SDGs) came into effect, the report noted.

The UN organs said that while the report presents some significant progress in reducing maternal deaths between 2000 and 2015, gains largely stalled, or in some cases even reversed, after this point.

According to them, in two of the eight UN regions – Europe and Northern America, and Latin America and the Caribbean – the maternal mortality rate increased from 2016 to 2020, by 17 per cent and 15 per cent respectively.

They explained that elsewhere, the rate stagnated, stressing that the report noted, however, that progress is possible.

Citing example, WHO and UNICEF said that two regions – Australia and New Zealand, and Central and Southern Asia – experienced significant declines (by 35 per cent and 16% respectively) in their maternal mortality rates during the same period, as did 31 countries across the world.

"For millions of families, the miracle of childbirth is marred by the tragedy of maternal deaths," UNICEF Executive Director Catherine Russell, said. "No mother should have to fear for her life while bringing a baby into the world, especially when the knowledge and tools to treat common complications exist.

Equity in healthcare gives every mother, no matter who they are or where they are, a fair chance at a safe delivery and a healthy future with their family."

In total numbers, maternal deaths continue to be largely concentrated in the poorest parts of the world and in countries affected by conflict. In 2020, about 70% of all maternal deaths were in sub-Saharan Africa. In nine countries facing severe humanitarian crises, maternal mortality rates were more than double the world average (551 maternal deaths per 100 000 live births, compared to 223 globally).

"This report provides yet another stark reminder of the urgent need to double down on our commitment to women and adolescent health," said Juan Pablo Uribe, Global Director for Health, Nutrition and Population at the World Bank, and Director of the Global Financing Facility. "With immediate action, more investments in primary health care and stronger, more resilient health systems, we can save lives, improve health and wellbeing, and advance the rights of and opportunities for women and adolescents."

Severe bleeding, high blood pressure, pregnancy-related infections, complications from unsafe abortion, and underlying conditions that can be aggravated by pregnancy (such as HIV/AIDS and malaria) are the leading causes of maternal deaths. These are all largely preventable and treatable with access to high-quality and respectful healthcare, the report highlighted.

It stated that communitycentered primary healthcare can meet the needs of women, children and adolescents and enable equitable access to critical services such as assisted births and pre- and postnatal care, childhood vaccinations, nutrition and family planning. However, underfunding of primary health care systems, a lack of trained health care workers, and weak supply chains for medical products are threatening progress, the report

Roughly a third of women do not have even four of a recommended eight antenatal checks or receive essential postnatal care, while some 270 million women lack access to modern family planning methods. Exercising control over their reproductive health particularly decisions about if and when to have children - is critical to ensure that women can plan and space childbearing and protect their health. Inequities related to income, education, race or ethnicity further increase risks for marginalized pregnant women, who have the least access to essential maternity care but are most likely to experience underlying health problems in pregnancy, the UN agencies' report elaborated.

"It is unacceptable that so many women continue to die needlessly in pregnancy and childbirth. Over 280,000 fatalities in a single year is unconscionable," UNFPA Executive Director Dr. Natalia Kanem, said. "We can and must do better by urgently investing in family planning and filling the global shortage of 900,000 midwives so that every woman

can get the lifesaving care she needs. We have the tools, knowledge and resources to end preventable maternal deaths; what we need now is the political will."

They added that COVID-19 pandemic may have further held back progress on maternal health. Noting the current data series ends in 2020, more data will be needed to show the true impacts of the pandemic on maternal deaths. However, COVID-19 infections can increase risks during pregnancy, so countries should take action to ensure pregnant women and those planning pregnancies have access to COVID-19 vaccines and effective antenatal care.

"Reducing maternal mortality remains one of the most pressing global health challenges," said John Wilmoth, Director of the Population Division of the Department of Economic and Social Affairs. "Ending preventable maternal deaths and providing universal access to quality maternal health care require sustained national and international efforts and unwavering commitments, particularly for the most vulnerable populations. It is our collective responsibility to ensure that every mother, everywhere, survives childbirth, so that she and her children can thrive."

The report revealed that the world must significantly accelerate progress to meet global targets for reducing maternal deaths, or else risk the lives of over 1 million more women by 2030.

# Adultery: Court Sentences Zazzau Palace Guard, 3 Others To 12 Months

others to one-year
imprisonment each or

Delivering judgment yesterday, the Chief Magistrate, Abubakar Lamido said, the court was satisfied with the confessional statement made in the Police report which was admitted as exhibits.

He said the court has not found the defendants with any criminal case before any court of law, hence they are to serve 12 calendar months instead of 24 months in the correctional center or a fine of N50.000 each.

It would be recalled that the five men, including a dismissed palace guard, appeared before a Chief Magistrates' Court in Zaria, Kaduna State, over alleged adultery and criminal conspiracy on Jan. 11.

The offences contravene Sections 59 and 368 of the Kaduna State Law 2017 The convicts are Ismaila Abubakar (Dismissed Palace Guard), Hussaini Abubakar and Kabiru Shuaibu, Nafiu Kabiru, while Ibrahim Abdullahi was earlier freed when the Court discovered that he was innocent.

#### We Must Vote Out Old Politicians, Chikun/ **Kajuru ADC Reps Candidate Says**

"For a people-oriented organization such as the National Population Commission, constant and effective engagement with the media is a crucial first step. It must take in the attainment of its constitutional mandate of generating data for national planning."

According to Hon. Okereke, with the approval of Mr. President for the conduct of the next Population and Housing Census in April 2023, preparations are in top gear for the successful implementation of the census project across the country, adding that census is a national event and it is mandatory for every citizen to participate by presenting themselves to be counted.

He, therefore, called called for the support of all stakeholders to deliver to the country a credible and reliable data for sustainable development planning.

Earlier in her remarks, the state Director NPC Ebonyi State, Barr. Mrs. Julia Nneka Manyike noted that in a bid to achieve maximum success in the 2023 Population and Housing Census, it is imperative for the commission to re-strategize in order to properly educate and enlighten Nigerians on the need to support the successful conduct of the 2023 census.

She said that the commission has deemed it fit to collaborate with journalists for effective delivery of their mandate to ensure a successful 2023 Population and Housing Census.

She further explained, ``The aim of the one-day state level capacity building workshop is to improve the quantity and quality of media contents on the 2023 Population and Housing Census and the specific objectives which amongst other things, are to strengthen journalists understanding and application of basic concepts in census taking; to neutralize negative prejudices, misperception and misrepresentation on the census exercise among sections of the Nigerian media and to update journalists on the status of preparatory activities for the 2023 census.

President Buhari. They had wanted a Southern President. How would you reconcile that or do you share in their emotions?

When you say my people, I am sure you are talking about the South and political leaders or the leadership of the PDP from the South. The leadership of the PDP went into a negotiating room even before the primaries of the political parties. We don't know what they negotiated and what transpired at negotiation. If they were very clear as to what they negotiated or did not agree on, we will not be hearing and seeing some of the things we hear and see. If they were unanimous in disagreement with what they negotiated, I mean somebody like Governor Udom Emmanuel, we know him for his character, won't stand down and accept the chairmanship of of PDP presidential campaign council, the governor of Delta state will not accept the Vice Presidency of this country. You see, these are men of principle. You go into a negotiating room and the negotiation collapses, then you will need to let your followers understand what you negotiated and agreed on. But the issue that became a screamer is the resignation of the National Chairman. We don't mind Atiku Abubakar continuing as our presidential candidate; that is what we heard in the streets.

We are talking of the presidency of Nigeria.

I would have been satisfied if we were firm to say no to the participation of a Northern PDP Presidential Aspirant in the party primary. For me, I have assumed that the South-South political Leaders in the PDP opened the door to the Presidential Aspirants of the North. Thereafter, we found ourselves box and can't do otherwise.

We are loyal followers and we remain in the party to follow.

Do you think the activities of the Governor of Rivers State, Nyesom Wike could have negative effects on the presidential ambition of Atiku Abubakar and by extension PDP?

Well, I don't know what Governor Nyesom Wike is doing. I don't live in Rivers State. I am a member of the Peoples Democratic Party in Akwa Ibom State and not in Rivers. Whatever he is doing I concede to him that he is a leader and has the right to act as he deems fit. But I also like Nigerians to be conscious of the fact that the people of Rivers State have their understanding of what they want in Nigeria and the election of the 25th of February 2023. They are politically enlightened so they won't be led otherwise in the exercise of their franchise. We cannot for the time being say that it will be positive or negative but we are sure that our party will win even in Rivers State.

As an entrepreneur, you are in position to advise your friend whom you are so optimistic is the next president of Nigeria: what would be topmost on your priority list, considering the policies that will make Nigeria work again?

If I'm given an opportunity to talk with my Presidential candidate, I will say as a priority, let's confront insecurity head long. As a young man in this country, I used to drive alone at night from Calabar to Kaduna and from Calabar to Lagos without the fear of bandits, kidnappers, etc. But all that changed. I would advise him to confront insecurity head long. I do not know anybody that said "If I perish, I perish" and perished. Damn everybody and interests. He has to confront it in all the states. Let us have peace and security in this nation so that lives will return to normalcy. Again what I will say is that we must make deliberate policies that stimulate the micro and small scale enterprises. We must be deliberate in the programs that stimulate agricultural investment. We must not look at the mono economy again. Thankfully there is a diversification of our economy in recent times but we must give life to it. I believe

when we do these and secure safety to life and property, people are happy and they are moving freely for their businesses, we will begin to return to the days of Glory. But listen to this I will tell my president we must de-emphasize ethnicity, tribalism, nepotism and religious bigotry in our national lives. These have killed Nigeria. Everything we do today is seen in the prism of what village you come from, what ethnic group you come from, where and what you worship. We must insist on remaining a secular. It is our secularity that should be non-negotiable. Let's begin to look at competence. Those are the few things I would tell my president.

In Akwa Ibom State specifically, Atiku Abubakar is accused of masterminding the liquidation of the Aluminium Smelting Company, Ikot Abasi and NNMC, Oku Iboku. As a business man, what do you think is the implication of this?

The site of NNMC and ALSCON leave me bitter most of the time. Do not forget that NNMC is right in my backyard. Incidentally, the businesses of government are marked SECRET, and facts surrounding them are hearsays. I am unable to responsibly comment on the privatisation debate and I doubt very much that it will impact our electoral fortunes.

Chief Olusegun Obasanjo was the president when Atiku Abubakar was the Vice. Obasanjo has come out on several occasions to caution Nigerians against trusting his former Vice with the number one office in Nigeria, Do you want to fault the former president sir?

This same President Olusegun Obasanjo endorsed Waziri Atiku Abubakar in 2019, didn't he? He endorsed this government of APC that has failed us woefully. How does the same man deny a man he endorsed previously?

I would love all Nigerians to look up to God who knows it all. We are only men.

We know in parts. The approximately 200 million Nigerians are at liberty to think and make their choices in life. Each Nigerian has the free will to adopt his or her preferred candidate and vote as you please. But, to think we are in a Nigeria that is anymore going to be influenced by the choice of the political leaders is an error because these leaders failed us woefully in their endorsements previously. So, I don't need to worry my head over such cautions.

Sir, what do you have to tell Nigerians out there concerning Saturday, 25th February, 2023?

Well, I would say that up to this moment, I will commend the Independent National Electoral Commission. I will also say we have the Electoral Act 2022 that is helping in at least smoothening the rough edges of our political process. We are not there yet.

I was born in this country before it became an independent nation and I have not been able to find comfort anywhere else in this world except Nigeria. There is no country we have been given by God like Nigeria, Nigeria is ours. We all have equal rights to this country. Please love Nigeria, guard the affairs of Nigeria jealously. On the 25th of February, go out and vote for that candidate you know will take this nation out of the present darkness. And I have spoken about Waziri Atiku Abubakar as the only presidential candidate that resolve the current Nigeria crises. That is my conviction. That is what I have to say. Atiku fits it.

You have not spoken about Akwa Ibom State and the forthcoming elections. What are the chances of PDP in the face of litigations and the growing presence of the other political parties?

The position of Akwa Ibom State is very unique. God has favoured PDP in Akwa Ibom State and we are confident all the PDP candidates will be returned elected.

#### Court Dismisses APC's Suit Against LP Reps Candidate For Ogo Oluwa/Surulere Federal Constituency

Tith few hours to the February 25 polls, the Federal High Court sitting in Ibadan on Wednesday, dismissed a suit filed by the All Progressives Congress (APC) and three others to disqualify the Labour Party (LP) House of Representatives candidate for Ogo Oluwa/Surulere Federal Constituency, Mr Adesoji Adedeji, from contesting the Saturday's National Assembly election.

Justice Uche Nma Agomoh in his judgement, said there was no evidence before the court to support the case of the plaintiffs and consequently dismissed the case for being academic, stale and lacking in merit.

The judge awarded a total cost of N100, 000 against APC to be paid N50, 000 each to Adesoji's counsel, Sunday Aborisade and the lawyer for Labour Party, Kehinde Yekini and as well also cleared Adedeji Adesoji to contest in Saturday's election, having been validly nominated by the Labour Party.

Justice Agomoh on the issue of locus standi of the plaintiffs to file the suit raised by Aborisade, agreed with him that those who filed the suit have no business doing as they are

not members of the Labour Party, describing them as "meddlesome interlopers and busybodies" who engaged themselves in what does not concern them.

On the issue of the suit been filed out of time, the judge also agreed with Adedeji's lawyer that pre-election matters are sui generis and that the case should have been filed within 14 days of the occurrence of the action the plaintiffs complained of.

New Nigerian recalled that in the suit filed on September 30, 2022 APC alongside other plaintiffs, namely Ajani Josiah, Chief Adewale Sunday, Adesiyan Semiu, claimed that Adedeji was nominated by Labour Party and Peoples Redemption Party (PRP) in violation of Sections 30, 34 and 35 of the Electoral Act.

The plaintiffs asked the court for an order to compel the Independent National Electoral Commission (INEC) to bar Adesoji from participating in Saturday's election, having been purportedly nominated by two parties with the court earlier striking out an application for extension of time filed and moved by the counsel for the plaintiffs.

#### General Elections: Go Out, Vote For Candidates Of Your Choice - Olubadan \*Says all eyes on INEC

he Olubadan of Ibadanland, Oba Mahood Lekan Balogun on Thursday, asked Nigerians not to abandon the polls, but go out and vote for the candidates of their choice. #### NAPTIP Rescues 2,743 Traffick Victims

bout 2,743 trafficked victims Lhave been rescued by the National Agency for the Prohibition of Trafficking in Persons (NAPTIP), its Director-General, Fatima Waziri-Azi, has disclosed. Speaking at a press conference in Abuja on Tuesday, she explained that 1,440 reported cases of trafficking in persons were received by NAPTIP, saying that 412 external trafficking cases (28.6%) and 1,028 internal trafficking cases (71.4%).

She further explained that 2,743 victims were rescued in collaboration with other sister law enforcement agencies with male children, 233 (8.5%); female children, 688 (25.1%); male adults, 363 (13.2%); and female adults, 1,459 (53.2%).

According to her, "Victims of inward trafficking were 45, that is; victims trafficked into Nigeria; returned victims from abroad were 251; and intercepted victims were 1,484, that is; those who were on their way out of Nigeria."

The Director-General said that most of the victims were trafficked by road

through their borders all across the country.

She said that the agency also secured 80 convictions in 2022: 45 males and 35 females, stressing that the agency's counter-trafficking project, launched in collaboration with the Canadian Government, was to address human trafficking gradually.

Speaking further, the Resident Electoral Commissioner (REC) hinted that 2,305,903 Permanent Voter's Card, (PVC) have been collected meaning that 2,305,903 eligible voters are expected to vote in the 2023 general elections.

Dr Tella declared that of the 3,276,675 registered

voters in Oyo State, only 2,305,903 PVCs have been collected so far leaving a total of 760,766 PVCs uncollected.

The INEC then called on all eligible voters in and across the state to come out en mass and vote for candidates of their choice during the elections.

Dr Tella while tasking stakeholders in the 2023 general elections to cooperate with the commission to conduct free, fair and credible elections in the state gave the total number of polling units in the state as 6,390.

### Gov Makinde behind last minute cancellation of our mega rally -Oyo SDP


scheduled to hold today at Mapo Hall", he said.

would know that we have the power to resist the cancellation, especially as it was done in the last minute. It is extremely injurious to us as our people had left far places as early as 5.30am in chartered vehicle to travel to Ibadan."

SDP Senatorial candidate in Oyo North, Honourable Mulikat Adeola, while speaking, said it was unfortunate that the rally was put off in the last minute, adding that the party members should troop out to Mapo Hall on Wednesday for the rally.

## **2023 Polls: INEC Distributes Sensitive Materials To LG Offices In Kadunà**

n preparation for the upcoming general elections come February 25, 2023, the Independent National Electoral Commission (INEC) Kadunà office, has flagged-off the distribution of sensitive materials to the 23 local government offices in the state.

Speaking during the event at the Central Bank of Nigeria (CBN) Kaduna Branch premises, the Administrative Secretary, Malam Muhammad Auwal Mashi, said that the commission is moving ahead of its task to ensure a smooth running of the activities.

Auwal Mashi, further explained that, the sensitive materials consist of the ballot papers and form EC8 for the presidential election, Senatorial and House of Representatives that will be held on February 25, 2023 and all the 23 local government electoral officers have been called from the field.

He added that, unlike the previous election of 2019, where they had almost above 90 political parties, this time around, there are only 18 political parties, and it's only in the presidential election that they are having all the parties contesting, but for other elections, the state commission is not having the complete candidates.

He said, "if you look at the quantity of the materials we are going to distribute, it's not as huge as it was in 2019, and hopefully, it is not going to take long to distribute to the various local government electoral offices.

"We just had an inter-agent meeting with the Inter-agency Consultative Committee on Election Security, and we made it clear to them that, we are taking the materials to the local government areas and our plan is for the security agencies to provide us with the security for the men and the materials to be taken to the LG offices, including those areas

where we have security challenges.

"It is a well-known fact that, Kaduna State has 4.3 million registered voters, so we should expect to have a similar number of votes because we do not wish to disenfranchise anybody, everyone that has registered in Kaduna is going to cast his vote on the election day," he stated.

"Similarly, we are in receipt of some of the monies that will be required for the execution of the election, but not for all aspects of the elections. For instance, there are some of the corps members we need to engage, so we intend to give them cash for their allowances, but not all their allowances for logistics and other things.

"We have also discussed with the NURTW and NATO that we are going to give them some part of their money in cash, and they have agreed to it, because the money will be given in four tranches and we have received

the first and second tranches, but the other two are meant for the next set of elections.

According to the commission's Administrative Secretary, the people should expect a very good election, because they started making arrangements for the 2023 elections immediately after the 2019 general elections and in between then and now, a lot has happened.

"For instance, the electoral act has been amended, there has been about at least 83 or so amendments, which has given us the lead way to conduct elections in the best possible way. And again, we are going to use the BVAS voting system that cannot be manipulated and will be the same that is going to used to declare the elections," he noted.

Auwal Mashi, assured the general public that they are going to witness a very fair election and the likes of which have never been seen in the history of Nigeria.

## Protest Day 7: Over 120 Anti-corruption CSOs Give IGP 7-day Ultimatum To Arrest, Jail EFCC Boss

\*Call on Buhari to urgently sanitise Commission, preserve his integrity

ver 120 frontline Anticorruption Civil Society Organisations (CSOs), on Friday, held a massive town hall meeting, in Lagos, to round off their week-long protest against what they called "Politicisation of the Economic and Financial Crimes Commission (EFCC), Disobedience of Court Orders and Infringement on Human Rights of Nigerians" under the leadership of Abdulrasheed

Bawa.

The protesters, who began to have a large following on social and conventional media, since their first public protest last Friday, gave the Inspector-General of Police a seven-day ultimatum to effect the Court order that committed Bawa to prison for contempt, noting that the EFCC's alleged desperate recruitment of "counter-CSOs" would not help the Commission. According to them, though the first phase of the protest ended on Friday, the CSOs would jointly and individually petition relevant international agencies, demanding sanctions against Bawa until he becomes law abiding and serves his jail term.

Spokesperson for the Transparency and Accountability Group, Ayodeji Ologun, insisted that the EFCC boss could not appeal the contempt ruling without first obeying the order, saying the Nigerian authorities were dangerously toeing the path of anarchy with the incessant disobedience of court orders, especially by an agency set up to stamp out corruption.

He said the politicisation of the EFCC was evident in the slant of its operations, noting that while series of petitions were piled up unattended at the EFCC offices



on monumental corruption a cross Nigeria, the Commission's boss had allegedly demonstrated that his task was mainly political vendetta.

The activists kicked strongly against the EFCC's statement that they were hired CSOs, saying those on the struggle had been at the forefront of the fight against corruption for years and were well known for their doggedness and patriotism.

"When Bawa was still learning to wear his pants, or hiding in his parents' home, many of us here were already at the barricades fighting for democracy and the office he is enjoying today. Back then, nobody paid us to fight for justice. Whoever is saying we were paid to do this must be thoroughly examined. We are strictly activists, not political

jobbers," Director, Activists for Good Governance, Declan Ihehaire, said.

"We are saying President Buhari should sack Bawa and if he doesn't sack him, we are sure that whoever is coming on board, come May 29, 2023, will listen to us and have Bawa sacked," he added.

The CSOs accused the EFCC of greater corruption and called on President Muhammadu Buhari to immediately put machineries in motion to sanitise the Commission so that the war against criminals and corrupt elements in Nigeria would make a meaning.

"Go to EFCC office today, there won't be parking space. Most of them, who are police officers, drive different types of exotic cars that their colleagues who don't work with EFCC cannot afford," Spokesperson for the Coalition of Anti-corruption Organisations, Olufemi Lawson, said.

Reviewing the protests so far, he stated, "For one week, we have, as a coalition, embarked on a sustained agitation for the removal of Mr Abdulrasheed Bawa as the Chairman of the Economic and Financial Crimes Commission. The Coalition, comprising of over 120 active organisations, has been able to sustain this, despite sponsored blackmail, intimidation and campaign of calumny by agents of the embattled EFCC Chairman, Mr Bawa.

"Today, we have invited selected leaders of our various organizations, to further press home our demand, under an atmosphere of engagement with some more stakeholders, whom we have also invited to be part of us today.

"As frontline Anti-corruption activists, we wish to restate our uncompromising demand, for President Muhammadu Buhari to immediately releive Mr Bawa of the position of the Chairman of the EFCC. Mr Bawa has lost the moral capacity to continually preside over such an important law enforcement agency, having become a signpost for disobedience to the rule of law, particularly express orders of our courts."

Lawson, who is also the Executive Director, Centre for Public Accountability, added, "This is just the first phase. We will be submitting petitions to

relevant international agencies and embassies demanding sanctions against Bawa until he becomes law-abiding. We can't allow our Judiciary be rubbished by anyone.

"We are by this medium, giving a seven-day ultimatum to President Muhammadu Buhari, in line with the mood of the nation currently, to direct the Inspector General of Police to effect the arrest order on Bawa and commit him to prison, as ordered by the court, after which our nationwide protests would resume."

He saluted the courage of various leaders and groups who had been part of the sustained agitation for Bawa to be sacked on account of disobedience of court orders, and had refused to be intimidated even in the face of obvious threats.

The 'Bawa Must Go' protests, which started a week ago, were led by CACOL Chairman, Debo Adeniran; Executive Director, Zero Graft Centre, Kolawole Sanchez-Jude; Chairman, Coalition Against Corruption and Bad Governance, Tovin Raheem; Executive Director, Centre for Public Accountability, Olufemi Lawson; Spokesperson for the Transparency and Accountability Group, Ayodeji Ologun; Director, Activists for Good Governance, Declan Ihehaire; and Ahmed Balogun of Media Rights Concern, among over 100 notable leaders of Anticorruption CSOs.



## **Atiku: Northerners Are Not Stupid!**

tiku Abubakar, Waziri Adamawa, the 77-year old presidential candidate of the People's Democratic Party, (PDP), in the 25th February, 2023, elections maybe an household name in the North, but he cannot lay claim to the 14 million followers of President Muhammadu Buhari of the All Progressives Congress (APC), in the region.

If anything, he symbolizes the sort of savagely self-serving professional politicians that Northerners and indeed all Nigerians have since started to shun. After a comfortable career in the 'plum' Nigeria Customs Service and more than three decades in politics, Atiku's only legacies are lucrative private enterprises such as the American University of Nigeria Yola, Intels Logistics and Adama Beverages Limited, makers of Faro drinks.

To start with, the North-East geopolitical zone of the country would not vote for Atiku Abubakar because the former vice-president neglected the region when he was in office between 1999 and 2007.


He could not record eight projects in his home zone in those eight years to the extent that even the road to his village, Ganye in Jada Local Government Area of Adamawa State, was recently constructed by the APC government of President Buhari. Between 2009 and 2019 when Boko Haram terrorists held sway especially in Borno, Yobe and Adamawa states, Atiku lived more abroad than at home and could not orchestrate any coordinated assistance using his celebrated clout at the national and international arenas.

Atiku Abubakar's sixth and hopefully last shot at Nigeria's presidency does not also enjoy the sympathy of the other geopolitical zones in the region. Perennial political peregrination has never been a respected practice in Northern politics. In 1993, he contested the Social Democratic Party presidential primaries losing to M.K.O. Abiola and Babagana Kingibe.

He was a presidential candidate of the Action Congress in the 2007 presidential election coming in third to Umaru Yar'Adua of the PDP and Muhammadu Buhari of the ANPP. He contested the presidential primaries of the PDP during the 2011 presidential election losing out to President Goodluck Jonathan. In 2014, he joined APC ahead of the 2015 presidential election and contested the presidential primaries losing to Buhari. In 2017, he returned to the PDP and was the party's presidential candidate during the 2019 presidential election, again losing to incumbent President Buhari.

To win this time, the former vice-president has tried to define himself as the northern candidate in the coming presidential elections. At the start of the campaigns in October 2022, he told the Arewa Town-hall Policy Dialogue in Kaduna that Northerners do not need an Igbo or Yoruba as president but "someone from the North."

According to him, "I think what the average northerner needs is somebody who is from the north and who also understands the other parts of Nigeria and who has been able to build bridges across the rest of the country. This is what the northerner needs. He doesn't need a





Yoruba candidate or an Igbo candidate." The era of divide-and-rule politics is over. How can someone campaigning as a unifier utter such anti-North and anti-unity claims?

Thus, while the Waziri Adamawa believes his path to power lies in the north, winning majority of the votes in the region would not be possible for the PDP candidate. He would have to contend not only against his two main opponents, Bola Ahmed Tinubu of the APC and Peter Obi of the Labour Party, he would also have to tame the rising profile of Rabiu Musa Kwankwaso-led New Nigeria People's Party (NNPP). His worst weakness, however, is the terrible trackrecord in delivering the dividends of democracy to the people.

Voters in the northwest region are still groaning and mourning over the multiple tragedies including the debilitating economic situation and devastating security condition traced back to the PDP's 16 locust years in power. Their embittered disposition is unlikely to translate into votes for the former vice-president. In particular, the populous states of Kano, Kaduna, Sokoto, Kebbi, Zamfara, Niger and Jigawa are all APC afficionados.

Any candidate who sees nothing wrong with the awful and pathetic state of affairs in the north is not worth voting for. The underdevelopment in the north was foisted by such northern leaders. In other words, the north undeveloped the north. Over the decades, the north has been held down by leaders of northern extraction who presided over Nigeria and saw nothing wrong with endemic poverty and misery culture. The coming polls promise to put paid to that.

Atiku's condemnation of the APC's Muslim-Muslim ticket is clearly a case of sour grapes because it makes Tinubu a strong candidate in the Muslim north. In contrast, the PDP's religiously diverse ticket hasn't earned him the same robust political mileage in Christian-dominated parts of the north. Rather, the Labour Party's Peter Obi is more favourably looked upon among some northern Christians.

The North is the most backward in

Nigeria judging from any developmental index. Based on the three Human Development Indexes, (HDI), namely life expectancy, education and per capita income, it is obvious that virtually all the states in the North fall below the HDI of 0.539 as of 2019. How would the region develop with a mass of illiterate citizenry? How do we turn this ugly scenario around other than by electing dedicated, progressive, visionary and committed leaders at both the federal and state levels?

The North is re-thinking and seeking a way out of the underdevelopment quagmire. It is no longer clinging onto the old attitudes that have failed the people. The 2023 general elections provide a historic opportunity for it to seek to change the unenviable narrative. The North is ready for a political paradigm shift. It intends to inject a new life into the leadership of the region and nation.

Like the leopard and its stubborn spots, Atiku cannot change his character of callous disregard for ordinary citizens. Only recently, he called on the Federal Government to not extend the deadline for the transition to the newly designed currency notes despite the outcry especially among the unbanked rural dwellers that constitute the bulk of the population of the North.

This call is reminiscent of his appeal for the repeal of Sharia law introduced after public demand by some Northern states with overwhelming Muslim majorities. It is also a flagrant violation of the religious and cultural rights of citizens as contained in the 1999 Constitution of the Federal Republic of Nigeria and extant universal conventions.

However, Atiku's most pathetic political promise is the release of Nnamdi Kanu, founder of the IPOB and a worse perpetrator of atrocities against Northerners than even Chukwuemeka Ojukwu during his 30-months civil war. What manner of justice rewards aggressors and fails to even acknowledge the deaths and destruction meted on the victims? Would he offer the same treatment to Boko Haram's Abubakar Shekau and similar terrorists or is this just a depraved pitch by a desperate do-or-die

politician?

As if these travesties are not evil enough, the PDP contender also promised to do a single term in the presidency and handover to an Igbo candidate in 2027. This is the most undemocratic declaration ever made by a contestant in any democracy. How can a single candidate speak for the whole North and declare where his own successor would emerge even before his own election?

In the final days to voting, Atiku plans to unleash all manners of religious and tribal sentiments to sway voters in the North. Unfortunately for him, the North has since written him off as an untrustworthy and dishonest person not worthy of their bulk support. As an observer put it "Atiku thinks Buhari just woke up to get 14 million votes in the kitty from a section of the country because of ethnicity? No. Buhari built a legacy of honesty and forthrightness over the years while Atiku's legacies are direct opposites of these."

In 1999 at the launching of a book on Sa'adu Zungur written by Prof. M.A. Yakubu, the current Chairman of INEC at Arewa House in Kaduna, Atiku as the Vice President of Nigeria and the most senior political office holder from the North in the Federal Government at that time publicly pilloried all Northern leaders. He told his bewildered audience that the Northern leaders and elders were the people who failed the North and the nation. He said they were the ones who had caused the problems.

The Northern Elders Forum (NEF) in its recent statement declared that Atiku has no credentials to be a sole Northern presidential candidate. Their reason is that he has not been seen as somebody who is close to the North because he has not been fair to us. He is somebody having his base outside the North. According to Alhaji Seidu Baba, a founding member of the NEF, Northerners commonly view Atiku as an untrustworthy and dishonest person who does not deserve their massive votes during the 2023 poll.

# Social Media and the 2023 Election Campaigns

HE Centre for Democracy and Development has just published a major study on social media and the 2023 election campaigns which I summarise here. Currently, the number of active social media users in Nigeria has risen from 27 million, in 2019, to 36 million ahead of the 2023 elections. Given the challenge of prevailing misinformation and disinformation on social media platforms, and the way such disinformation can permeate into the media more generally, greater access to online information does not necessarily create more informed citizens. In fact, in Nigeria, it has confused the citizenry while entrenching preexisting divides based on ethnicity and religion especially as malinformation, a deliberate sharing of genuine information with an intent to cause harm, thrives in this election season.

As the elections approach, we are witnessing renewed sophistication and organisation in the push for disinformation. Key players are focused on glorifying or delegitimising political candidates and undermining the credibility of the Independent National Electoral Commission (INEC). At the same time online organisation remains largely informal, in part by design, with political parties driving disinformation behind the scenes through unofficial party accounts or hired influencers. In addition to the use of platforms such as Facebook, Twitter, Instagram and WhatsApp, TikTok, with its predominantly video content that can bridge educational divides, is playing an increasingly important role. So too are Twitter Spaces, which are recorded and then shared, as a podcast, across social media platforms in ways that increases listenership.

"The disinformation ecosystem has created lucrative opportunities, particularly for youth. Some of the most prominent political influencers on social media, who are hired by political parties or individual candidates, earn up to N500,000 (US\$1200) a month, whilst those with smaller followings are likely to receive nearer N50,000 (US\$110)."

Cross-platform posting remains critical to understanding Nigeria's digital ecosystem as screen grabs or content from one platform can be shared across all others, broadening the reach beyond the number of direct users. Content also moves from online forums into offline spaces with soldiers of mouth spreading online content through streets talks, in motor parks and at newspaper stands.

This makes curbing disinformation very challenging in Nigeria. But at the same time these networks for the flow of information can also promote democracy. Civic awareness of the continuous voter's registration process and the importance of participating has largely been driven by a sustained online campaign in the run-up to 2023, while the platforms can be used to fact check and hold elected and aspiring officials to account. Finding a balance that accentuates these positives and diminishes the negative aspects must be a priority as the elections approach.

In the 2019 elections, the Atikulated Youth Force, the social media team of the People's Democratic Party (PDP)'s presidential candidate, and the Buhari Media Centre (BMC), with links to the All Progressives Congress (APC), dominated the online discourse. Such groups are still present in 2023, although part of the BMC has now evolved to centre around APC presidential candidate, Bola Ahmed Tinubu, with his supporters identifying as being 'BATified'. However, they have been supplanted in 2023 by Obidients – the label used by the supporters of the Labour Party (LP) presidential candidate, Peter Obi. They are the most active online actors in this election.

In addition to promoting his candidacy, many have been accused of spreading disinformation. In fact, the candidate himself was compelled to call them to order in September 2022, after his presidential campaign was accused of using overzealous social media supporters to skew the narrative in his favour. Obi also distanced himself from any engagement of his supporters in any malicious campaigns against his opponents in a series of tweets. But such malevolent online campaigns engineered by all leading parties continue to be a prevailing feature of Nigeria's information ecosystem. The disinformation ecosystem has created lucrative opportunities, particularly for youth. Some of the most prominent political influencers on social media, who are hired by political parties or individual candidates earn up to N500,000 (US\$1200) a month, whilst those with smaller followings are likely to receive nearer N50,000 (US\$110).

In previous elections text and


pictures were dominant but, in 2023, the emphasis is more on real time livestreaming of audio and video content on social media platforms. One of the innovations this year is the organisation of political song challenges as the one coordinated by Dauda Rara, a prominent northern political musician, and is called 'Jagaban Shine Gaba'. The challenge encouraged citizens to mime a song with creative videos and upload it to TikTok.

Rara and his team of judges reviewed the entries and awarded 12 cars, 30 iPhones and selected a further 50 individuals to receive N100,000 (\$220) each. Other political actors have also been promoting challenges that favour their candidates by offering gifts or rewards for those that generate the most viral content. Coupled with the TikTok's fairly lax community guidelines and limited enforcement, these challenges can be used to push disinformation "without those responsible being penalised" in the view of one user.

TikTok content also reaches individuals without an account through cross-posting, meaning that it can reach Nigerians with limited literacy when it comes to written text. It is much cheaper to send out jingles on TikTok, which previously had to be placed on radio and TV channels, and with phone sharing and cross-platform posting, the audience reached can still be significant.

WhatsApp remains utilised to coordinate election organisations, circulate audio and visuals, and has the largest reach in terms of direct numbers of users. Voicenotes remains critical, especially in local languages, with content regularly played and replayed to an audience that has no direct online access. Other closed network platforms like Telegram are also increasingly influential. These closed spaces are also used to help organise campaign rallies and other large gatherings both online and offline. The latter is a concern given that senaratist groups, such as the Indigenous People of Biafra (IPOB), have Telegram channels where they talk directly to supporters, spread disinformation, recruit adherents and plan offline activities.

For all social media platforms, the line between the online and offline remains blurred. For example, during this election campaign cycle, a letter on with the official INEC letterhead, and purportedly signed by the INEC spokesperson, was released claiming to commence the investigation of the APC presidential candidate on drug related charges. However, this letter was a forgery and it originated on WhatsApp, moved quickly across social media, and was read out on national broadcast platforms such as Arise TV. There was never any investigation, nor was the statement issued by INEC, but in a rush to break the news, and possibly influenced by media partisanship, it became a mainstream story.

A factcheck eventually revealed that while Shettima was indeed sitting and having a meal with people, they were not Boko Haram members but nomadic Fulani parents whose children he had enrolled in secular schools in

# It's Easy Defending Criminality When You're Not the Victim

EXPECTED a backlash when on February 3, 2023, I \_published a piece: "Recreating the Holocaust in their own image." It came as expected. The various reactions reinforce my position that our world can be a far better place if only otherwise decent humans would not rationalise evil. But it is quite easy to rationalise criminality, if you are not the victim. To such decent people, I usually say, please put yourself in the position of the victim and see whether you will still hold the same position. But such a plea is usually a tall order as many seem set in their ways, are socially or religiously indoctrinated. It can be explosive, potentially dangerous or almost impossible to ask somebody who holds religious beliefs on a matter, to rethink his position.

Sure, there were many who supported my simple act of drawing attention to the issues in the Palestine, especially the ongoing genocide and calling for a resolution in favour of a two-state solution in which Israel and the Palestine will live in secured borders, in peace and raise their families as good neighbours. The famous African novelist, Chinua Achebe, wrote: "Let the kite perch and let the eagle perch too – If one says no to the other, let his wing break."

The French slaughter of about two million Algerians in order to stop that country's independence and assimilate it, is no less a genocide than the Nazis massacre of six million Jews or the Belgian slaughter of 15 million Congolese. But it was a genocide because the Germans exterminated over 60,000 of the total 80,000 Herero people; that was eliminating 80 per cent of the people. It also killed over 10,000 of the Nama people. That figure may seem 'small' but it was 50 per cent of the Nama

people."

There are people I will not waste my time explaining matters to for they are far gone in their ways or are direct beneficiaries of evil. For instance, why would I waste precious time and space trying to persuade Israeli Prime Minister Benjamin Netanyahu to stop his philistine or Nazist approach of genocide to the Palestinian issue when that is his political oxygen? Why would Netanyahu allow peace when violence, which he calls 'security', is the bait he uses to fish in Israeli political waters? Today, it is these criminal tactics that may save him and his wife, Sara, from going to jail having been indicted over three years ago, on charges of bribery, fraud and breach of trust.

However, there are decent people I feel obliged to take up issues with since there is a chance they can rethink their ways and work for a better humanity. I will restrict myself to reactions on an international platform I belong to but will not mention names because I have not sought their permission to do

One measured response was: "Using terms like genocide and extermination is so far from the truth that it amounts to slander." This line of thinking continued: "What's going on between Israel and the Palestinians isn't genocide. It's more complicated than that. Yes, you're right about Israeli displacement going on there. But it's nothing on a massive scale like what happened in other places in the region... that caused more casualties and destruction..."


A grave mistake in this type of analysis is that it assumes that genocide is based on the number of casualties, not the act itself. The Oxford Dictionary defines genocide as "the deliberate killing of a large number of people from a particular nation or ethnic group with the aim of destroying that nation or group." It does not make sense to wait until a people are wiped out before we agree there is genocide. The French slaughter of about two million Algerians in

order to stop that country's independence and assimilate it, is no less a genocide than the Nazis massacre of six million Jews or the Belgian slaughter of 15 million Congolese. In contrasting the Turkish genocide against the Armenians, he sought to rationalise it thus: "The difference with Israel is that it is also about its security. It's a small country that also feels threatened. Much of what they have been doing in the last 75 years of their existence is out of security." Incredible! So, Israel wants security, but denies security for its Palestinian neighbours? The truth is that both peoples need security and one cannot be secured by denying the other security.

On the continued theft of Palestinian lands, including East Jerusalem, which has seen Israeli illegal settlements increase from 115, 700 in the 1993 Peace Accords to over 350,000 within 20 years, a rationalisation is provided: "They want to split the Palestinian lands in the West Bank with Israeli settlements in between because it also prevents any future Palestinian state from consolidating and be possibly a threat." So, the plan is to deny the Palestinians a country in their indigenous homestead.

### Egypt 2023: Nigeria back on track For World Cup Ticket

even-time champions Nigeria steered their campaign back on the rails after defender Solomon Agbalaka's 71st minute header collected all three points from host nation Egypt at the Cairo International Stadium on Wednesday night.

The defender met Muhammad Aminu's corner kick with a bullet header that Egypt's goalkeeper Mostafa Amin could do nothing about, and it is the host nation that now faces the stark possibility of elimination from the 23rd Africa U20 Cup of Nations.

After Nigeria lost her opening game by a lone goal to Senegal and the host nation could only putter to a scoreless draw against Mozambique, it was a given that both teams would tear at each other from the beginning. The hosts mounted the highest pressure in the first quarter-hour but shot wide when presented with the opportunity to nick it.

Amin saved twice from Ibrahim Muhammad in the 28th minute but at the other end, eight minutes later, Abdelrahman El Sayed again blasted wide in front of Chijioke Aniagboso.

Aniagboso did a tidy job throughout,

including saving point-blank shots on two occasions in a ferocious second half.

Eight minutes after the restart, Ahmed Belasi could have put the North Africans ahead, but his header went wide with the goal begging. Ten minutes later, Aniagboso kept his calm to deny Rafaat Bayoumi, and two minutes later, Ibrahim Muhammad could have shot Nigeria ahead with a flash shot from the edge of the box that went narrowly wide.

Aniagboso again came up big for Nigeria in the 66th minute, with substitute Omar El Saei confident he was on to a great thing.

Five minutes later, Agbalaka's bullet header put Nigeria in front, and despite opportunities for both teams afterwards, the scoreline remained unchanged.

Senegal, who hammered Mozambique 3-0 in the earlier match, lead Group A with six points and have virtually sealed a quarter-final place. Three-pointer Nigeria stay in second place, and will be expected to overwhelm one-pointer Mozambique when both teams clash at the same venue on Saturday.

Egypt have the daunting prospect of battling Senegal, with defeat sure to mean early elimination for the host nation.
