# **Increasing Banditry:** Zamfara Govt Orders Citizens To Purchase Guns, Announces Other Measures • Forms special committee to receive intelligence • Establishes additional paramilitary unit

## Shuts down all petrol stations in affected areas

ollowing the increase in the activities of bandits in various parts of the state and the government's commitment to ensuring adequate security and protection of lives and property of the citizenry in the state, particularly during this rainy season, the Zamfara State Government has

resolved to take further measures to deal with the recent escalating attacks, kidnapping and the criminal levies being enforced on its innocent communities.

A statement signed by the Ibrahim Hon Commissioner for Information Zamfara State, Magaji Dosara, sighted by our correspondent on Sunday morning, said the measures include directing individuals to purchase guns for self-defense.

"This act of terrorism has been a source of worry and concern to the people and government of the state. Therefore, in order to deal decisively with the situation in our respective communities, government has no option than to take the following measures:

A. Government has henceforth, directed individuals to prepare and obtain guns to defend themselves against the bandits, as government has directed the state commissioner of police to issue license to all those who qualify and are wishing to obtain such guns to defend themselves. Government is ready to facilitate people, especially our farmers to secure basic weapons for defending themselves. Government has already

concluded arrangement to distribute 500 forms to each of the 19 Emirates in the state for those willing to obtain guns to defend themselves.

B. People must apply from the Commissioner of Police, license to own guns and such other basic weapons to be used in defending themselves.

# **60th Birthday: Continue To serve** Nigeria, Buhari Tells Gbajabiamila

President Muhammadu Buhari has urged the Speaker of the House of Representatives, Rep. Femi Gbajabiamila to remain patriotic to Nigeria like he has always been.

While urging him to continue to serve the country in every way possible, President Buharinoted that Gbajabiamila as Speaker of the House, has positively changed the public perception of the relationship between the legislature and the executive.

Buhari spoke at a special prayer session organized in honour of the Speaker to mark his 60th birthday at the Ansar-Ud-Deen central Mosque, Wuse 2, Abuja on Saturday.

Represented by his Chief of Staff, Prof Ibrahim Gambari, who said the president had directed him to wish the Speaker a happy 60th birthday, he also noted that President Buhari has always stood for free and fair process, which was why he was happy when Tinubu emerged as the presidential flag-bearer of APC in such a process.

"The message from Mr. President is to congratulate you on your 60th birthday. He also wants to urge you to continue to serve the country well."

He said the House of Representatives under Gbajabiamila has ensured a good working relationship with the Executive arm against the notion in some quarters that the National Assembly should "be antagonistic to the Executive

He also said President Buhari wanted to assure Nigerians that he did not have any intention to subvert the constitution to extend his tenure in office.

President Buhari also wanted to reiterate his belief in the aspiration for a peaceful and a united Nigeria, Prof Gambari said.

On his part, the presidential candidate of the All Progressives Congress (APC) Asiwaju Bola Ahmed Tinubu also described the Speaker of the House of Representatives Rep. Femi Gbajabiamila as a patriotic Nigerian, who uses his position to enhance good governance.

Tinubu, who is also the National Leader of APC, said God has made it possible for Gbajabiamila to impact positively on the lives of Nigerians through the Legislature.

The APC presidential candidate prayed for God to continue to bless and grant the Speaker long life and wisdom to serve Nigeria

"May God continue to give you good health. May He also answer your prayers. Only God will put us on the right path and continue to guide us through life to overcome the problem of leadership.

"May God give you good health to work for Nigeria. It is a complex country that you have to navigate through. May Allah in His infinite mercy give us the stability, the peace to govern; the love that we share for one another, the patriotism that will make us proud of our country," he said.

The Chief Imam of the Ansar-Ud-Deen Mosque, Dr. Musa Olaofe, who led the



prayers for Gbajabiamila, prayed Allah to protect and guide the Speaker.

In a short lecture on leadership, good governance and tolerance, Dr. Olaofe said Nigeria is difficult to govern due to its nature.

However, he said, with good leadership, there will be good governance, urging Nigerians to be tolerant with one another for meaningful progress.

He noted that Gbajabiamila is a unifier as he brought people from different parts of the country together to work with him.

Imam Olaofe stressed that the Qur'an admonishes Muslims to be good and lenient to all human beings, saying the Speaker represents both.

In his votes of thanks, Gbajabiamila expressed gratitude to the president for his kind words and for delegating his Chief of Staff to attend the prayer session.

The Speaker also said that he owed his political journey to God through Tinubu, whom he said the Almighty Allah used to uplift him and many others politically and otherwise.

Gbajabiamila equally

thanked his mother, Hajiya Lateefat Olufunke Gbajabiamila, who raised him in a good manner as well as his wife, Salamatu, who organized the prayer session. "Let me first of all start by appreciating the president though the COS. Let me also appreciate my benefactor. Many believe that wherever you find yourself, all power belongs to Allah.

### Tinubu, Obi, Others Can't Substitute Running Mates Under New Electoral Act - Advocacy group

head of the 2023 general elections, the Center for Reforms and Public Advocacy (CRPA) has said that under the new Electoral Act 2022, running mates nominated by Presidential, Governorship candidates of various political parties are not Subject to withdrawal, substitution.

Both presidential candidate of the ruling All Progressives Congress (APC) Bola Ahmed Tinubu and Labour Party (LP) Peter Obi, submitted placeholder with the hope to substitute their running mate late.

But in a statement released Saturday in Abuja by the Executive Director of the centre, Ifeanyi Okechukwu, said the Constitution and the Electoral Act 2022 make clear provisions on the yardstick for withdrawal and substitution of candidates, adding that provision, as contained Sections 28 and 84 of the amended Electoral Act 2022, relate to only the candidate – presidential and gubernatorial – and not their running mates.

According to the statement, substitution of candidates by political parties becomes possible in cases of withdrawal or death of candidates and these are president, gubernatorial, Senate, House of Representatives and State Assemblies who were nominated by political parties through valid primaries in accordance with Section 29 and 84.

"Section 33 of the Electoral Act says "A political party shall not be allowed to change or substitute its candidate whose name has been submitted under section 29 of this Act, except in the case of death or withdrawal by the candidate: 'Provided that in the case of such withdrawal or death of a candidate, the political party affected shall, within 14 days of the occurrence of the event, hold a fresh primary election to produce and submit a fresh candidate to the Commission for the election concerned'; and to conform with section 33, section 29 must be adhered to, to ascertain categories of candidates captured.

"Section 29 in subsection (1) says 'every political party shall, not later than 180 days before the date appointed for a general election under this Act, submit to the Commission, in the prescribed Forms, the list of the candidates the party proposes to sponsor at the elections, who must have emerged from valid primaries conducted by the political party.'

"So, it is no more business as usual, the current electoral law is very stringent in many areas especially methods of political parties' primaries, who are delegates, how withdrawal is done, how substitution is done and transmission of results, among others.

"The current and subsisting electoral law does not capture a scenario that makes possible a substitution of associate candidates or running mates either by account of voluntary withdrawal or death. Subsequently, any substitution of running mates nominated by presidential and gubernatorial candidates comes flat in the face of the law.

"While this might not have been a deliberate oversight, it must be accepted that the law is sacrosanct and nothing can be added or removed from it unless through amendment of sections 31 and 33 to make provision for that in the future.

"Until then, in accordance with section 31 which says "A candidate may withdraw his or her candidature by notice in writing signed by him and delivered personally by the candidate to the political party that nominated him for the election and the political party shall convey such withdrawal to the Commission not later than 90 days to the election" and section 33, only candidates who were nominated through valid primaries by political parties and whose names were submitted in accordance with section 29 can withdraw and be substituted under the law, not running mates that were not nominated through any primaries but by presidential and gubernatorial candidates."

While commending the electoral umpire for the latest of the activity by the commission in ensuring that the 2023 elections meet with the requirements of the law as established by the Constitution of the Federal Republic of Nigeria and the Electoral Act 2022, as amended, the group, however expressed "concern about the likelihood of infractions that are already being cooked by some political parties as it relates to the issue of replacement of their associate candidates or running mates in the presidential election.

"Many lawyers, legislative experts and even INEC have made it clear that what we are having are presidential running mates, which the Constitution and Electoral Act refer to as "associate candidate" and "running mate" and not placeholders."

The statement urged cautioned the INEC on "the catch-word of placeholders as being bandied by some political parties is not known to the law and that the law does not give a room for a substitution of running mates in the 2023 election guidelines. "We also wish to impress upon political parties that they must familiarize themselves with the relevant aspects of the new electoral law and avoid actions that are capable of causing infractions."

## Oyo Govt To Recruit Additional 500 Amotekun Corps

yo State Governor, Engineer Seyi Makinde has disclosed that the insecurity situation in Nigeria deserves that all hands must be on deck to curtail it

Speaking at the weekend during a monthly security meeting with local government Chairmen, Vice Chairmen, heads of security agencies, traditional rulers and stakeholders held at House of Chiefs, Secretariat, in Ibadan, the governor said government cannot handle the insecurity alone.

Governor Makinde pointed out that already in Oyo State, he has approved the recruitment of additional 500 men for the Oyo State's Western Nigeria Security Network (WNSN),

codenamed Amotekun to enhance security of lives and properties in the State

"Security is everyone's business and if we all play our parts well, we will have a safer and more secured environment, although security of lives and properties is paramount responsibility of government, but government cannot do it alone except with cooperation of the entire citizenry and as we can see from the report gotten all over the country," he said.

Governor Makinde added, "

achieved by the effort of
government alone but with
the efforts of the all
stakeholders, most
especially the security
commanders."

"This meeting is aimed at getting the situation report

from various quarters on security as well as to dialogue on what to do as stakeholders and fine tune necessary steps, this will help government to put necessary machinery in place for people in the state to sleep with their two eyes closed and as the operation of the Amotekun corps is concerned, we have perfected the process of employing 500 more hands to enhance their performance and further deepen the security architecture of our State."

Commenting on whether to incorporate local vigilante members into the existing security team for the enhancement of security in the state, Governor Makinde charged that the time has come for all stakeholders and the general public to join

hands with his administration in the effort in ensuring peaceful environment.

Appreciating security agencies in the state for their unrelenting support towards making peaceful coexistence among the people of the State possible, the governor charged the people of Oyo state to keep the pace up in order to allow for more influx of investments and commercial growth.

The Otun Olubadan and former Governor of Oyo State, High Chief Rashidi Ladoja while speaking during the meeting lauded Gov Makinde for being proactive in the area of security which has greatly helped the State, when compared to neighboring States, especially in the media reports of cases of insurgency.

## Kidnapped Ekiti Retiree Set Free

he kidnapped retired Chief Pharmacist with the Ekiti State Ministry of Health, Chief Israel Bamisaye who was reportedly kidnapped by suspected abductors on Thursday has regained freedom

A family source in Orin-Ekiti, Ido/Osi Local Government Area of Ekiti State, where Bamisaye was abducted, confirmed to journalists on Saturday, that the victim paid a sum of N4.5 million ransom to regain freedom.

Bamisaye was said to have been

kidnapped by seven gun wielding men along his farm located between Ero Dam and the Ekiti State farm settlement located at Orin- Ekiti, Ido/Osi Local Government Area of Ekiti State

The retiree was said to have been kidnapped around 4 pm while working on his farm.

The source said: "The Pharmacist paid N4.5m ransom. The initial amount was a sum N10m, but it was negotiated to that level".

Meanwhile, the Police Public Relations Officer, Ekiti Command, DSP Sunday Abutu,who confirmed his release,said the man was let off the hook around 10pm Friday's evening.

Abutu said the abductee was released at Obbo Ayegunle, a border town in Kwara State.

"He was freed at Obbo Ayegunle in Kwara State. Our men and the local hunters as well as Amotekun operatives were inside the bush searching for him for over 27 hours before he was located.

"Our people would have to be security conscious. That is the first thing to do to get rid of criminals.

"They should also give the police and other security agencies good information that we can work with, we can't do it alone", Abutu stated.

### Families Of Deceased NSCDC Personnel Receive Over N200M Backlog Of Insurance Benefit

t least, a total sum of over N200m was at the weekend, paid to families of the Nigerian Security and Civil Defence Corps (NSCDC) personnel who died in the course of active service to the nation.

The payment, according to a release by the Director Public Relations Department of the Agency, DCC Olusola Odumosu is in fulfillment of the Commandant General's promise to prioritize the welfare of the personnel.

It quoted the Commandant General Dr. Ahmed Abubakar Audi saying that the recognized operatives were just a few amongst the backlogs recorded by the Corps.

"In fulfilment of the Commandant General's promise to prioritize the welfare of the personnel of the Nigeria Security and Civil Defence Corps (NSCDC), over N200m was paid to families of personnel who died in the course of active service to

the nation.

"The NSCDC Boss, in a brief ceremony at the Corps National headquarters, Abuja, said research has shown that in order to achieve results on set goals, the workforce must be cared for adequately. This is to enable them to put in their best", it reads in part.

According to the CG, the operatives recognized were just a few amongst the backlogs recorded by the Corps.

"Chief among the priorities of my administration is to improve welfare of personnel and one of such efforts is geared towards remembering our colleagues who served meritoriously and paid the supreme sacrifice in the process, leaving their families behind"

"We will continue to make serious efforts to encourage staff to put in their best while still in active service, we will work alongside the Head of Civil Service of the Federation to ensure the payment of others on the waiting list".

"If you didn't hear the

names of your persons, don't feel left out because we have a huge backlog and we are trying to see how it could be sorted out in due time," Dr Audi said. He thanked President Muhammadu Buhari and the Head of Service for attending to the needs of the Corps by ensuring that the pain and suffering of dependants left behind by deceased personnel are alleviated.

The representative of the Head of Service, Abubakar Mai jam'ah assured the Corps of their continuous support and partnership, stating that all outstanding allowances would be paid as soon as funds are made available by the Ministry of Finance.

On the remaining backlog, he charged the Head of Insurance Unit of the Corps to rise to the challenge of pushing for insurance of dead officers as at when due, to avoid delay.

The CG congratulated the beneficiaries and charged them as next of kin to make judicious use of the money received to better the lives of the deceased the death of their loved ones would not be in vain. He explained that those who have not been able to get theirs now should be patient, adding that he inherited a backlog of arrears of death benefits when appointed as the CG

C. A secretariat or centre will be established for the collection of intelligence on the activities of informants.

D. people are strictly warned and advised to make sure that any information or intelligence about an informant must be true and nothing but the truth, as all information on such informants must carry correct data on the suspects, including their pictures, correct names, address, occupation and witness to testify the genuity of the information given, as government is taking punitive measures against any one found as informant. Any person who give wrong information against anybody, will be served the same punishment with an informant and will be treated as such.

E. Government has requested the state House of Assembly to pass, as matter of urgency, the informants bill before it, to enable government take the drastic measures on informants as contained in the bill.

F. Government has ordered for the recruitment of 200 additional Community Protection Guards in each of the 19 emirates of the state, making it 500 per emirate, to increase their manpower and strengthen its force and capacity to deal with the bandits," it said.

Government would not condone any act where innocent people are being killed.

In the same vein, those who refused to honour and respect the peace dialogue are hereby warned to allow peace within our respective communities. Government is hereby directing the military, police, civil defence and other security agencies to mobilise their operatives and take fight to the enclaves of the criminals with immediate effect.

Nigerian first-class graduate of Economics, Mr. Gabriel Adudu has raised an alarm over what he said is currently going on in the Federal Inland Revenue Services (FIRS) under the leadership of Muhammad Mamman Nami as the Executive Chairman.

Adudu said the place has become only for the bourgeois and the high-class citizens for their children and wards to work there not for the overall interest of the Nigerian masses.

He expressed worries on how his certificate in economics is becoming a waste after many attempts to secure a job with the FIRS.

According to him, he attended many interviews with the financial agency but his understanding of what is going on in the organization is whose son or daughter are the applicants.

"I understand that if you are not a son or a daughter of a governor, minister, Senator, SGF, or even a highranking member of the National Assembly, that place is not meant for you.

" If you're not coming from the office of Mr. President or vice president, then be ready to pay close to ten million for you to secure a job there as a graduate.

"I'm so sorry for what has become of the nation that we the younger generation are not proud of," Adudu said.

Mr. Gabriel also alleged that the Executive Chairman has in recent times, under his watch, employed hundreds of people who are most from Niger State.

He observed that the employment principles of federal character were not duly followed, which has undermined the unity and cohesion of Nigeria the country's leadership is fighting tooth and nail to protect.

"Today we have found ourselves in a country where there are only two citizens, the rich and the poor, the bourgeois and the masses, first-class citizens and second class, the high class, and the low class, the powerful and the powerless.

"Few others are above the law, while the rest are victims of the manipulative justice, the commoners are the so-called Nigerians while the elites and their families are the real Nigerians who ought to work in places like FIRS, CBN, NNPC, NIDC,

"I reliably gathered that recently, 500 people were employed secretly through an interview conducted in South West Nigeria, where only candidates from 'who is who' in the country were appointed to work with the FIRS, same place they will tell you there is no vacant post. I'm tired of what is happening in my country," he cried out.

Adudu urged the government of President Muhammadu Buhari to stop the employment and expose those racketeering employment in the country, especially in those agencies considered juicy places.

He said investigating what is happening with FIRS through the Directorate of Employment will give President Buhari a good perspective of what is happening in the country.

"I'm sure President Buhari is not aware of all these abnormalities going on in many sectors of our country. If he knows, he will not allow this.

"Let the FIRS Chairman and the Federal Character Commission be sanctioned over commercializing employment at the expense of unemployed Nigerians who are from less privileged backgrounds.

'Mr. President Sir, Nigerians believed you when you said you are for all, and you are for nobody. Why taking the exercise to Lagos and the world is accusing Chief Bola Ahmed Tinubu, the APC Presidential flag bearer as the one adding salt to the nation's injury of unemployment?

"We are anxiously waiting for the President's intervention to stop and cancel the employment that only favored some specific class of individuals. Our parents are also taxpayers and as such, we are bonafide Nigerians that deserve to work anywhere without knowing anybody." Adudu stated.

# Again, Police Kills Bandit In Kaduna, Recovers Arm, Ammunition

he ongoing offensive against criminal elements by Police operatives under the untiring Commissioner of Police Kaduna Command CPY.A Ayoku psc(+), mni has once again yielded positive result with one bandit neutralised, an AK49 assault rifle, locally fabricated long range revolver with its twelve (12) polymer cased cartridges and one operational motorcycle, recovered.

The tactical operation came via a distress call received in the early hours of 23rd June, 2022 at about 0730hrs that some armed bandits were sighted along Galadimawa Kidandan road in Giwa LGA of Kadura Stata

Kaduna State.
Their movement was strongly suspected to be for their usual heinous mission. In a bid to truncate such a mission, the CP immediately ordered for deployment of

strong nearby force to the location for a possible engagement and restoration of safety.

The Operatives engaged the hoodlums with clinical precision and succeeded in countering the bandits' mission as they were compelled to retreat into the forest with some sustaining bullet injuries while one other was gunned down, his AK49 as a ult rifle and operational motorcycle recovered.

Equally, a locally fabricated long range revolver with its 12 polymer cased cartridges was recovered when search of the area was conducted.

Meanwhile efforts are geared towards restoring public confidence with rigorous patrol and surveillance of the area in order to prevent any further attack on communities or commuters.

The Commissioner of police Kaduna Command applauded the character and commitment of the Officers aimed at the safety and security of the State. He further tasked them to sustain the recent gains since victory is near where criminality will be a thing of the past.

# Robbery Suspect Killed As Police Apprehends 2 Others, Recovers Firearm, 104 Live Ammunition In Delta

n armed robbery suspect has met his waterloo in a gun duel with police operatives, with two others arrested.

The breakthrough occurred during two different operations, in which one locally made gun, 104 live cartridges and four expended cartridges were recovered.

One of the robbery attack was said to have happened along Jesus Avenue in in Umusadege quarters in Kwale, Ndokwa West LGA, where a team of from Kwale Division led by the DPO CSP Godwin Igochie engaged some armed robbers in a shoot out.

According to report, one of the hoodlums sustained fatal gun shot injury during the melee, while others escaped. He was said to have died later in the hospital while receiving treatment, It was gathered that one locally made gun, four live cartridges, and four expended cartridges were recovered from them.

The second incident was said to have involved

the Anti Crime Patrol team attached to 'C' Division Asaba while on stop and search duty at the head-bridge Asaba and four suspected robbers on a motorbike.

Our correspondent gathered that two out of the suspects were arrested with a black polythene bag in which 100 rounds of 7.62MM AK 47 live ammunition were hidden.

The duo of Michael Reuben, 29yrs and Odemba Onochie, 30yrs, both of Okoanala Oko in Oshimili South LGA of Delta State were arrested in connection to the incident.

The police public relations officer DSP Edafe Bright who confirmed both incidents in a release, said the

command has launched manhunt for the other fleeing s u s p e e c t s, while Investigation is ongoing.

It reads, "On 21/6/2022, the DPO Kwale Division received a distress call that an armed robbery operation was taking place along Jesus Avenue in Umusadege quarters in Kwale, Ndokwa West LGA, the DPO Kwale Division CSP Godwin Igoche Mobilized and led the Divisional Anti-Crime Patrol team to the scene, the suspects on sighting the police, engaged them in a gun duel, during which, one of the hoodlums sustained bullet injuries while others escaped.

Upon sighting the Police,

they abandoned the bike and took to their heels, the Officers gave them a hot chase culminating in the arrest of two of the four suspects namely; Michael Reuben 'm' 29yrs and Odemba Onochie 'm' 30yrs, both of Okoanala Oko in Oshimili South LGA of Delta State. In the black polythene bag in possession of one of the suspects, Michael Reuben, one hundred (100) rounds of 7.62MM AK 47 live ammunition were recovered hidden inside the bag. Manhunt for the other fleeing suspects is ongoing".

### Attack On Journalists In Lagos, Ekiti: IPC Demands Strong Action

he International Press Centre (IPC) has stated that it is extremely concerned about the attack on journalists in the convoy of Governor Babajide Sanwo-Olu on Sunday June 19, 2022 in Lagos.

According to widely publicised reports, the ugly and bloody incident occurred in the aftermath of a visit to the Palace of Oba Rilwan Akiolu by the A P C Presidential candidate, Asiwaju Bola Ahmed Tinubu who was accompanied by the Lagos State Governor.

The affected journalists, Adeola Ogunrinde and Omatseye Atsenuwa of Smooth 98'1fm, were severely injured, while Adedoja Salam of TVC was left in a state of shock. Executive Director of IPC, Mr. Lanre Arogundade, said in a statement, that the worst could have happened to the journalists and therefore, charged both the Police and the Lagos State Government to bring the perpetrators to justice to serve as deterrent to those who may be planning similar attacks on journalists in the count down to the 2023 elections.

On Jeremiah Omoniyi,

IPC also decried the arrest and detention of the campus journalist who was deployed by the Centre for Journalism I n n o v a t i o n a n d Development (CJID) to c o v e r t h e E k i t i governorship poll.

"Omoniyi was arrested and taken away by the DSS during the polls on Saturday June 18, 2022 for allegedly recording a video of a brawl involving party agents at a polling unit in Irepodun/Ifelodun Local Government area in the state," the statement said.

Mr. Arogundade said the conduct of the DSS operatives amounted to undue harassment and obstruction of a professional journalist on legitimate election duty.

According to him, the leadership of the DSS and other security agencies should sensitize their officers on election duty that there is no law preventing journalists from covering, recording and reporting incidents on Election Day.

"It is also worth reminding all security agencies that the role of the media during electoral processes and electrions is recognised by the constitution and the Electoral Act and any assault on any journalist or other media professional on electoral duty therefore means that the laws of the country are being undermined,

"The fact that the weekend attacks bring to more than 40 the number of dangerous and life threatening incidents involving journalists and other media professionals as documented by IPC's Safety Alert Desk in the year 2022 alone underscores the need for such protection for journalists in Nigeria", Mr. Arogundade said.

IPC said further that the Lagos and Ekiti incidents have again made it imperative for media owners, the political parties and the government to put in place mechanisms for the protection of journalists during campaigns and elections.

"For instance in a place with security challenges, we can find a way to get around it, our nets will get there," he assured.

He further assured that said some challenges identified in course of carrying out campaigns are being worked around.

Momodu. explained said

that it is expected that one net covers two persons.

"We have estimated the number of nets needed based on the census figures.

"If during micro planning we have gaps, it may affect ration of number of people in a house hold, with number of nets they will give. We can hardly go beyond four nets to each household. It is not equal that every household however, will get four

nets," he explained.
According to him, the ITNs should serve for three to four years.

"It can kill the mosquito if it perches on it and other mosquitoes in the area where the net is located," he said.

The one-day media parley was organised by the Federal Ministry of Health in collaboration with the Society for Family Health.

### **Incessant Pirates Attack Unsettles** Akwa Ibom Fishermen

ishermen in Akwa Ibom State have **L** expressed worries over what they described as incessant attacks by pirates operating within the riverine areas, saying, it has become a hindrance to sustainable income generation and poverty alleviation activities.

They said they have lost their fishing boats, outboard engines and nets worth millions of Naira, a development they said has affected the income of multipurpose cooperative society members in the area.

Bassey Etim, President of Nation Feeders Multipurpose Cooperative Society in Uruan Local Government Area, a coastline community with people engaged in fishing stated this during a one-day national agri-preneur training scheme organised by the Small and Medium Enterprises Development Agency of Nigeria (SMEDAN) held in Uyo.

Etim said the attacks apart from adversely affecting the income of their members, has led to loss of some lives while fishing.

According to him, the absence of modern drying machines is also hampering the growth of the cooperative society in the fight against poverty and wealth creation, saying that their income is also affected by the activities of large scale fishing businessmen whom he claimed, are stifling small scale fishing entrepreneurs.

"That is why we formed the cooperative to enable us embark on large scale fishing activities of the large scale fishermen who buy off all fish products before we hit the sea, is frustrating and hindering a thriving cooperative movement in the area," he explained.

Etim, who was giving an account of how the grants by SMEDAN have been utilised in creating wealth and promoting small business, said they have been limited to subsistence fishing contrary to expectations as they have been unable to go to the high sea as a result of their inability to

compete with the large scale fishermen and businessmen.

Also speaking, the President of Ukeme Otobong Multipurpose Cooperative Society in Esit Urua, Eket Local Government Area, Mfonobong Abasiekong said the grants given to cooperatives have helped them to grow their businesses but appealed for assistance to enable them acquire either tricycles or a mini trucks for the evacuation of oil palm fruits after they have been harvested.

She also solicited for assistance in acquiring amodern oil palm processing facility to help them generate more income for members.

In her remarks, Lucy Ekpeyong, Coordinator of SMEDAN in Akwa Ibom State described cooperative societies as the powerhouse of the rural economy, saying that they should acquire skills in business development of a common product or service, saying it would ensure sustainable poverty alleviation programme.

She stressed the importance of record keeping, being transparent in financial transactions and urged people to raise funds for their projects through shares allotment and investment savings as well as thrift services.

Presenting Wale Fasanya's address, the Director-General of the agency, reiterated its continued support to agri-preneurs through various schemes such as one local government one product, women self-employment, national business skills development initiative among others and restated the commitment of President Muhammadu Buhari to tackling unemployment through the development of agriculture and its value chain.

She lauded the Akwa Ibom State Government for "unflinching support towards the growth of Micro, Small and Medium Enterprises (MSMEs) in the state."

" Often their rights are trampled upon or denied, leading to in many cases avoidable violence in the Nigerian society.

" Thus, the necessity to establish nongovernmental and apolitical organization dedicated to peace and harmonious coexistence between various groups and ethnicities, especially amongst headers and farmers," he

He stressed the need for interface between herders and host communities for lasting peace, saying bullet approach alone cannot end violence and banditry in Nigeria.

hile lamentations ring loudly on the academic decay and debilitating state of Nigeria's education sector, one man is holding tenaciously the light of hope with his educational policies and projects. The administration also ensures constant payment of External Examination fees such as WAEC, NABTEB, NBAIS and Basic Education Certificate Examination (BECE) in addition to MOCK examination conducted every year.

Governor Yahaya's administration is currently constructing 5 Mega Senior Secondary Schools as well as improving the standard of other Junior Model Schools in the State.

A comparative analysis of WASSCE results from 2015 to 2021 indicates tremendous improvement in performance of candidates. The percentage rises from 12.7% in 2015 to 79.5% in 2021.

### **Conflict, Drought, Threatens Lives Of 20 Million**

unger is tightening its Lgrip on more than 20 million Ethiopians who are facing conflict in the north, drought in the south and dwindling food and nutrition support beginning next month, the UN food relief agency warned on Thursday.

"The combination of conflict and drought have caused inflation to soar," the World Food Programme (WFP) added, noting that as of April, the Food Price Index in Ethiopia was up by 43 per cent compared to the same month last year.

Meanwhile, the prices for vegetable oil and cereals are up by over 89 per cent and 37 per cent year-onyear.

War and hunger

According to WFP, 19 months of war have left more than 13 million people in the north requiring humanitarian food assistance, mainly in conflict-affected zones in Afar, Amhara and Tigray regions.

Over the past two months, since the Government announced a humanitarian truce, food and humanitarian supplies have been flowing into the Tigray region.

And while WFP has delivered over 100,000 tonnes of food since 1 April - enough to feed 5.9 million people for a month – fuel deliveries have not kept pace.

Less than half of the two million litres of fuel needed has entered the region in recent weeks.

WFP has finally been able to meet the food needs of over 800,000 people in Tigray and has just completed its most recent deliveries of emergency food rations to 1.3 million people in Afar and Amhara.

In Tigray, over 20 per cent of under-age-five children, and half of pregnant and breastfeeding women, are malnourished, according to WFP.

Meanwhile, 32 per cent of parents in Afar zone 4 one of five administrative zones in the region – and 16 per cent in Amhara reported

that over the previous three months, malnutrition drove their children under five to health centre.

A recent WFP assessment of conflict-affected zones in both regions cited this as well.

And in southern and south-eastern Ethiopia, an estimated 7.4 million people wake up hungry every day as the country grapples with the fourth failed consecutive rainy season.

Ukraine aggravates food crisis

At the same time, the ripple effect of the war in Ukraine is set to exacerbate Ethiopia's food security crisis.

With over three-quarters of WFP and government wheat – a country staple – coming from Ukraine or Russia, the precarious situation there is threatening to push its cost, as well as that of fertilizer, beyond the means of millions of Ethiopian farmers.

Humanitarian operations risk shutdown

Moreover, a severe WFP funding shortage has prompted the UN food relief agency to caution against of a looming malnutrition crisis.

Its financing to treat more than 1.4 million acutely malnourished women and children in Northern Ethiopia is fast running out.

So far, the severe lack of funding has enabled WFP operations to provide nutrition treatments to only 40 per cent of the mothers and children affected in northern Ethiopia between January and April. That means just 560,000 out of the targeted 1.4 million.

And the gap has forced ration cuts for more than 700,000 refugees there, who now receive a mere 50 per cent of their minimum nutritional requirements.

WFP is aiming to reach more than 11 million of the most vulnerable over the next six months but is grappling with a staggering \$470 million funding gap.

# Who Wins Osun Governorship Election?

n 2018, I wrote a piece on the then governorship candidates of the leading political parties in Osun State. In the article, entitled 'Osun: Picturing into the future' (ref: The Nation, September 18, 2018), I tried to showcase each candidate's quality as well as what his candidature meant for the peace and progress of the 'State of the Virtuous.' The election took place on September 22, 2018.

Evidently, a lot has happened within the last four years: one of the candidates eventually became the state governor and he is almost completing his first term in office while another has gone to 'acquire' a university degree somewhere. Some have gone a-shopping for greener pastures elsewhere while others have simply returned to the mundane routine things of life – politics of the belly! In all, while some hold the notion that politics globally is a by-product of permanent interests, not permanent friends, to others, vying for governorship office in this part of the world is akin to a ceremonial ritual. Whichever option, life continues!.

As another round of governorship election draws nearer, a section of Nigerians is already of the view that, since Governor Gboyega Oyetola has been at the helm of affairs in the state, his governance profile makes him a sellable candidate; that, mutatis mutandis, the All Progressives Congress (APC) candidate has the experience of four years as the state governor; plus eight years as Chief of Staff under the immediate past government.

To them, if anything, the next four years could only offer him an opportunity to improve on the extant enviable delivery records of the goods of democracy, because it won't be his lot to start learning the ropes again.

Frankly, it is easier for somebody to propose that he'll pay salary arrears, if elected as governor. It is however a different ballgame when he is confronted with, say, the state's monthly Internally Generated Revenue (IGR), placed, sideby-side, the overheads of one or two ministries.

These are some of the things to be considered by the electorate before they mortgage their votes, because it will take another four harrowing years before it can be changed.

Also on the ballot is Ademola Adeleke of the Peoples Democratic Party (PDP). Words on the street refer to him as a compulsive giver. But, to the larger majority, the administration of a state is beyond being a nice man. Having won his party's renomination, the 'Dancing Senator' was recently quoted as boasting that he would be going into the election to spend 'not only Naira, but dollars, pounds and euro"; and that, "this time around", it would be "fire-for-fire."

Well, while the unwritten implications of Adeleke's outburst are frighteningly nauseating, what remains unclear is what he is hoping to reap when he gives those hard currencies. More than that, Nigerians are interested in knowing what the candidate is investing in, sources of the funds and the rate of returns.

They are also wondering who subsequently owns the state treasury; and



with what will the state be run? In a word, Adeleke's statement suggests that politics and elections in Osun State are run by money; that victories in elections are secured with big bucks; and that the prize goes to the highest bidder.

Next is Akin Ogunbiyi of the Accord Party (AP). A businessman and an Insurance magnate, the 59-year-old Agricultural Economist-turned-politician is the Group Chairman of Mutual Benefits Assurance Plc., which commenced operation in 1995. Among other things, Ogunbiyi has promised to "ensure full industrialization" of the State, if elected as governor.

Again, it is not in doubt that the AP candidate will be going into the contest with a rich experience. He also has the international clout, which is an added advantage to governance matters any day. Neverthelesss, the touching truth is that governance goes beyond fantasizing. For example, to industrialize a state like Osun, the people must buy into the vision, which feelers from the State reveal he hasn't done much about. Will it not be suicidal if, at the expiration of, say, 3 months in office, there are no tangible things to show to the electorate as the industrialization of the State?

On good authority, the Labour Party (LP) candidate, Yusuf Lasun is an acknowledged mobilizer who understands the essentials of street Without being a prisoner to sentiments, politics. Jokes apart, the Ilobu, Osun Omigbodun is well-known in Osogbo, the State-born politician and the immediate state capital. But then, that there is not

past Deputy Speaker of the House of Representatives is one of Nigeria's nouveaux riches with the resources to actualize the dream of a governorship status. Even so, the stain on his ambition is a function of the solidness of his influence. Needless therefore to repeat that Lasun is living in old glory! He is banking on his past popularity profile. Yes, he was asked to negotiate his way out in the 2018 Osun APC governorship primary election; but the former Federal lawmaker insisted on going for the exercise. At the end of the day, it only revealed his popularity a dismal fourth or so on the ballot tray. Now that he is contesting again, he will need to work hard to swing any surprise.

Goke Omigbodun of the Social Democratic Party (SDP) is an architect and a priest of the Anglican hue which, as God would have it, is also my denomination. In fairness to posterity, the former chairman of the Osun State Property Development Corporation has a nice pedigree and appears a gentleman. He is brilliant and a church person. But, much as these qualities may help tame some of the known excesses of the average politician, managing a state as complex as Osun is not something that can be achieved from a wishful thinking. It goes beyond merely enriching one's personal career profile.

much about his legacy in the public domain is a statement of fact. Whether he will also perform in office or not is presently unknowable, empirically.

In the merits of the above, one can only wish the gladiators in the forthcoming election, slated for July 16, 2022, the best of luck. It is hoped that they would shy away from acts that are inimical to the creeds of democracy and good governance

On the whole, the central rule of democracy is the voter turnout, neither the wads of cash nor wattages of lies with which covetous politicians are always tempted. Besides, leadership structure in civilized democracies is pre-planned: you cannot just go and pick an imbecile from the street and ask him to lead a country or state. Yes, such a 'candidate' may be popular and ... have deep pockets. He may well extemporaneously speak and arouse the mass of the people easily. "People are hesitant to taking their children to

school because our education system is in a state of coma," he said.

The Emir contended that, "over 95 per cent of teachers are not qualified to teach, our learning environment is in shambles, and majority of our schools lack teaching aids."

He urged government, stakeholders and donors to intensify efforts in addressing the problems. Earlier the Chairman of Jigawa Education Partners, Malam Tasi'u Abubakar said despite the billions of Naira budgeted for education and the free Girl-ChildEducation Policy in Jigawa State, there are certain sociocultural barrier's hindering girls enrollment in Jigawa State.

In a related development, a Kazaure based cleric, Ustaz Shehu Kazaure has identified poverty and illiteracy among rural parents as contributing factors retarding the development of education especially that of the girl-child.

After about 30 minutes break, the protesting

Alhaji Alaran added, "people have talked so much about the fact that these herders have invited their people from foreign countries and their number is today very alarming that they outnumber our people in many communities in Oke-Ogun".

"These people are still in critical conditions, we are not happy about this and we will not fold our hands while our people are daily killed and maimed by these bandits."

Alhaji Alaran maintained that the time has come for the government at the federal and State levels to take the security of lives and properties of Oke-Ogun very important.

"There have been calls by concerned individuals like traditional rulers and the Chairman, Western Nigerian Security Network (WNSN), code named Amotekun in Oyo State, General Kunle Togun, that the forests in the Oke-Ogun region have been surrounded by foreign Fulani bandits and there have been several successful efforts to dislodge the bandits in the last two years".

# Group Rejects August End Voters Registration Deadline

he leadership of unified Nigerian Youth forum (UNYF), has rejected the extension of the Continuous Voters Registration and validation for additional 60 days.

Expectedly, the UNYF opined that the Continuous Voters Registration and validation should go the way of international standards and best practices by stopping the registration a week or few days to general elections.

Abdulsalam Moh'd Kazeem, President, Unified Nigerian Youth Forum, in a statement said, "As one of the developing Nations, expectedly we should go the way of international standards and best practices, there's nothing wrong for the registration to stop a week or few days to general elections, but we are aware that we are not ready for such due to some certain factors associated with electoral

processes in our nation, the budgetary allocation of INEC is enough reasons for all stakeholders to demand for the best in the above regards."

The statement explained that if the registration should stop on August 29 as proposed by the Independent National Electoral Commission, over 7.7 millions of their members who would attain the age of 18 by September 3rd and September 25th 2022 will be automatically disenfranchised due to INEC proposed new deadline.

The youths noted that going by the independent National electoral commission (INEC) proposal, the registration would stop by August ending, saying that to them, it shows that many eligible Nigerians will be delebrately disenfranchised and their members inclusive.

It observed that it is unconstitutional, shameful, unacceptable, inlegal and outdated for INEC to proposed closing her portal five (5) months to the general elections in this 21st century, where technology is the new order of the day.

It stated that the Independent National electoral commission attempt closing the Continuous Voters Registration and Validation excercise by August ending calls for serious concern, stressing that the amount allotted for elections periodically and the support they enjoyed has further expose the commission lack of determination to give our nation the best, for instance, over 150 billions is budgeted for 2023 general elections.

## Medical Outreach: Lagos Govt Launches Floating Clinic Boat

Lagos State Government has launched a 'Floating Clinic Boat,

iber Glass, Mono Hull Boat 200HP x 2 capacity, for inland waterways medical emergency and riverine communities medical outreach services.

The initiative is part of efforts to increase access to prompt, qualitative and efficient healthcare services on the waterways and riverine communities across Lagos.

Director of Public Affairs in the state's Ministry of Health, Tunbosun Ogunbanwo, said this on Wednesday.

"The Floating Clinic Boat; a brain child of the Lagos State Ministry of Health and the Lagos State Waterways Authority (LASWA) is equipped with four medical observation beds, medium sterilization unit, o2 bottle, gauge, infusion stand, foldable stretcher and fully kitted first aid box, Ogunbanwo said.

According to him, the clinic boat is compartmentalized into four sections including the Wheel house (for captain and crew), observation room (for patients),

Doctor's office and Nurses station and reception.

The floating boat clinic, he pointed out, has marine safety equipment including life jackets, fire bucket, life buoy, life rat fire extinguisher and navigational lights, as well as navigational equipment like garmin ecomap, compass, VHF radio accessories and siren.

Speaking at the unveiling and inspection of the boat clinic, the Permanent Secretary, Lagos State Ministry of Health, Dr. Olusegun Ogboye explained that the idea behind the Floating Clinic was to help provide first aid, medical emergency care and basic healthcare services at accident scenes on the inland waterways and riverine communities in Lagos State.

He said: "The Floating Clinic is mainly to deal with emergencies on the waterways and provide outreach services to riverine communities. This is part of the initiative by the Ministry of Health to ensure that we extend our medical and ambulance service to the waterways, remote riverine communities and areas that can only be accessed by water. This is also an example of partnership

between different agencies of government; the boat actually belongs to LASWA but will be operated by the Ministry of Health"

Ogboye disclosed that the Floating Clinic will be deployed for the ongoing integrated measles and COVID vaccination campaign in riverine communities and water ways across Lagos State adding that it is part of a plan initiated by the present administration of Governor Babajide Sanwo-Olu to ensure that emergency services in Lagos are ramped up to the point where response time are reduced.

In his words: "This is a strong partnership between LASWA and the Ministry of Health. LASWA has provided the boat, the crew and gas to run the boat, and the Ministry of Health will provide the human resources and medical consumables for health care provision. It is part of a plan that has is initiated by Mr. Governor to ensure that emergency services in Lagos are ramped up and we can respond very quickly to emergencies.

"This is the beginning of the initiative. There is definitely an intention to expand, scale up and integrate our ambulance services; our ambulance boats, mobile intensive care units and transport ambulances. It is something that

we have planned that is certainly why we are starting with one boat and we are going to expand. It is a sustainable idea, we already run ambulance services, we are only expanding to include the waterways and we have the human resources to run it".

The Permanent Secretary noted that there will be a minimum of two medical personnel on board the Floating Clinic at any one time who will run shifts adding that citizens in riverine communities can have access to the Floating clinic by dialing the Lagos State Emergency numbers.

"Once you contact the emergency numbers the clinic will be deployed. LASWA can also deploy the clinic during emergency response on the water ways. If there is a call about an emergency on the waterways, remote and riverine areas, the emergency process will be activated", he said.

Speaking in the same vein, the General Manager, LASWA, Mr. Damilola Emmanuel noted that the initiative will further add to the integrated emergency and rescue system being put in place by LASWA to ensure safety of commuters and wellbeing of citizens of riverine communities.

Mr. Elkana, said the purpose of the meeting is to communicate E4A's new investment approach, strategies, and anticipated outcomes to KADMAM and to also understand where KADMAM is in terms of its operations and sustainability of its interventions.

# How Enugu Gas Fire Went Off Miraculously - Caritas Varsity

#### By; VICTOR DAZANG, Kaduna uthorities of Caritas University in Amorji-Nike, Enugu State on Thursday, expressed delight over

what is now referred to as a miraculous outage of the gas fire incidence that occurred within its premises between May 22 and June 14 this year.

The management of the university specifically expressed appreciation to God for his divine intervention in seeing off the rampaging fire

that ranged for 21 days.

The fire incident defied all conventional and technical measures by government and non-state fire services for the period but went off on its own on the 14th of this month. The efforts were fully funded by the university.

The incident was caused by the activities of some contractors who were drilling a water borehole on the university premises. Surprisingly, there was no single fatality

throughout the period the fire raged. About 24 companies and government

agencies got involved in the curtailing of technically," Prof Orji stated. the fire. They could not stop the fire.

Addressing a news conference, the university management led by its Pro-Chancellor, Dr Martin Anagbaoso, and the Deputy Vice Chancellor, Prof Michael Uchenna Orji said they were filled with joy that the fire eventually went off on its own.

"The light went off itself miraculously. On our own we know it's Jesus that did the miracle and and made it possible for the light to go off," Orji said yesterday while conducting journalists round the site of the fire incidence.

The deputy vice chancellor appreciated the federal and state governments and other stakeholders for their prompt response to curtailing the fire.

He told reporters that the university will go on with the drilling of the water borehole in the school, but would employ more technical measures in doing so. "We still have the intention of going on with water exploration. In terms of getting water, we will go on but we will be guided

He said the school incurred loses, including spending much money trying to curtail the fire. Asked how much was spent as part of efforts to get solution to the situation, Orji simply said "it's huge amount of money," saying that it cannot be immediately quantified.

Meanwhile, Oweri zonal coordinator of the Nigerian Upstream Petroleum Regulatory Commission (NUPRC), Engr Enorense Amadasu has disclose that his commission is currently investigating the actual and remote cause of the gas fire and emission incident.

Engr Amadasu said the NURPC has deployed a manager to be in charge of the area with a mandate to ensure the well is properly secured. "We recognised that we needed to quickly put off the fire because of the challenges inherent in the incidence." Amdasu said while providing incite into the commission's effort to put out the fire.

Government had said it would carry out

specific detailed study on the environment.

Engr Amadasu said NURPC will do various investigative studies in the area. He failed to say when the report of the proposed study would be completed. The zonal coordinator also ruled out the possibility of the suspected gas substance coming out from existential pipeline in the area. He said government would do general survey on gas deposit in the region.

Dr Anagboso who was there when the fire and gas emissions went off said there was no issue of death in the incident as was reported by some an online newspaper. He said the university quickly created an over zone round the fire point to ensure that the fire didn't extend to other facilities of the

# In Defence of Democracy

N 2018, President Muhammadu Buhari, courageously redressed the historic injustice of the criminal annulment of June 12, 1993. The president again put it better (and I agree with him!) in the 2022 Democracy Day address he delivered penultimate Sunday that: "On June 12th 1993, Nigerians saw the best in our citizens as we all went out to vote peacefully. By June 24th 1993, we also saw the worst of our leadership as the elections were annulled".

According to him; "We must never forget the sacrifices of the heroes of Nigeria's democracy during 1993. Their patriotism and peaceful struggle should guide our actions especially when it comes to electing our leaders and holding them accountable, now and in future". He also rightly conferred posthumous honours on Chief MKO Abiola and others.

Next year marks the 23rd anniversary of uninterrupted democratic process defined here as a system of regular free and fair elections at federal, state and local government levels. That was after 30 years of brutal military dictatorships that included 3 years of civil war of mass deaths.

Nigerians in the last two decades have made the point that votes and votes-count are the desirable ways for ensuring good governance. Next year, Nigeria is set for the seventh presidential election cycle. There have been scores of states elections and bye-elections.

Of course there are hundreds of federal and state legislative elections and thousands of local government elections since 1999. I commend INEC which despite the imperfect political environment is improving on the electoral process to make elections increasingly credible. Nigeria as democracy

destination

On Sunday, INEC's website polled 84,004,084 registered voters. That comes to 176,846 polling units! Eighteen registered political parties. In quantitative terms, Nigeria is the largest democracy destination in Africa! That 84 million registered voters, equals the population of Turkey. The point cannot be overstated: Nigeria has rich democratic heritage beyond the last two decades. Communal accountability openness and representation were the hallmarks of precolonial Nigeria. Democratic political parties and civilian leaders fought for Nigeria's independence. It was a federal



parliament that passed the first motion in 1962 that created the first state, Mid-West state (present Edo). Today is a continuation of the same democratic legacy.

In 2015 a sitting President Goodluck Jonathan lost the election. He commendably and graciously accepted the result thus facilitating historic smooth transition of power. He did not lead an insurrection against National Assembly as President Donald Trump attempted after losing election to the Democratic Party in 2020. Jonathan was a product of a doctrine of necessity and consensus-building following the death of the late President Musa Yar'Adua in 2009. Certainly, Nigeria has come of age in democratic renewal. It is self-evident therefore that constitutionalism and democracy had guaranteed political stability and predictability in governance than military rule which once led to avoidable civil war and underdevelopment of Nigeria. Democracy; forward ever

Nigeria and indeed Africa should never return to the dark days of military dictatorship with all its gross violations of workers', trade unions' and human rights. We are in interesting times of democracy renaissance in Africa. Ghana has commendably democratic elections in 1992 after long years of military dictatorship with good turnout of voters. Opposition party, NDC, won

2008 election just as APC won in Nigeria to defeat PDP in 2015. President John Atta Mills unfortunately died on July 24, 2012 just as we lost a sitting president, Umaru Yar'Adua. All these point to consolidation of democracy in Africa. Same with South Africa where, since liberation of Nelson Mandela from 27 years' imprisonment, six democratic free and fair elections had held.

No lessons from Mali

However, there are disturbing developments in West Africa. Mali in particular has become a new word for whimsical additive senseless coups. Today all civil societies, political parties in Africa must join ECOWAS to condemn the unhelpful military coups in Mali, Guinea and Burkina Faso. Military class in West Africa should follow the examples of Senegal, Nigeria, Ghana and South Africa and subordinate themselves to elected civil authorities.

The military should NOT opportunistically "weaponise" the shortcomings of democracy to usurp power which belongs to the people in the first instance. ECOWAS should toughen the sanctions against military juntas and make sure they return to democracy to deepen democracy not military intervention.

MINILS and democracy Why is the Michael Imoudu National Institute for Labour

Studies (MINILS) concerned

about democracy and democratic process? The point cannot be overstated: MINILS is an institutional democracy dividend. The late President Shehu Shagari who was democratically elected formally commissioned the foundation of MINILS on May 4, 1983. MINILS was conceived in the third National Development Plan (1975-1980). Next year, the institute is set for its 40th anniversary.

The mandate of MINILS is in itself democratic: to build the capacity of workers, employers and government officials in labour and industrial relations through participatory training, research, education and interinstitutional linkages. The goal is to promote labour management relations best practices and industrial harmony for sustainable democratic development.

Democracy implies dialogue and tri-partism is a prerequisite for dialogue in industrial relations. When the ILO was first set up in 1919, its founders decided that it should be tripartite because they were convinced that social justice in the field of labour could only be achieved with the involvement of the social partners at all stages. The ILO advocates dialogue and negotiation at all levels, and it therefore seeks to develop the capacities of representative organisations and protect such basic human rights as freedom of association, equality of opportunity and

treatment and freedom from forced or compulsory labour. This tripartite approach is also evident in the process of consultation between the representatives of governments, employers and workers leading to the adoption of international labour standards, which are central to the ILO's efforts to protect workers and combat poverty".

One modest achievement in the last one year is formulation of first strategic four-year plan founded on the democratic values of openness, transparency, inclusivity, women and gender/ youth involvement. The institute is set to deepen the academic curriculum of our implant, regular programs to include social dialogue, social justice as well as civic education to ensure workplace democracy. So for MINILS, democracy is a total, NOT partial, commitment. The four National Minimum Wage Acts from 1981 to 2018 had taken place under democratic dispensations. Indeed, the military violently curtailed freedom of association, dissolved NECs of NLC in 1986/87 and 1994. Today, unions and civil societies operate unfettered under the rule of law.

# Heroes of a Blighted Nation

EMI Soyinka, Professor of Medicine may not be known much outside the medical field or outside the university system where he taught for thirty years. Certainly, he was known in the world of HIV/AIDS where he worked tirelessly to bring succour to the victims. He is of course far less known than his famous elder brother and Nobel Laureate, Professor Wole Soyinka. But like his brother, he was a humanist and advocate of social justice.

Many of us who were in the University of Ife, UNIFE, now Obafemi Awolowo University in the 1980s knew Femi Soyinka quite well because he was a dependable ally of students and workers on campus who stood by the truth.

I recall an incident. On May 31, 1981, a 23-year old Part II History student, Bukola Arogundade, of Room 200, Awolowo Hall was abducted in Ile-Ife town and his head severed.

On June 7, 1981, the students populace decided to organise a procession to participate in his funeral. But the police led by Chief Superintendent of Police, Francis Osenweneiwe Ogbechie, who had ruled the procession illegal, laid ambush for the students at the intersection of the town and Ondo Road, near the Mayfair Hotel. They attacked the peaceful procession and in the process, four students, Miss Wemimo Akinbolu, Part III, Arts, Miss Fatimo Adebimpe, Part II, Education, Miss Dorcas Olubukola Ojewole, Part I, Arts, and Mr. Paul Adetunji Alonge, Associate Student, Education, were killed.

Government immediately announced that they did not die from the police attack, but through electrocution. It produced a Police Constable No 63591, Peter Ighotegha Ofrukama, who claimed that when his team got to the dead students, he touched the head of Miss Ojewole and received an "electric shock."

The student populace and the university community would not buy this, arguing that if the four students were electrocuted when they touched each other, why was Ofrukama who pursued the students and claimed to have also received the electric shock alive and well?

They felt the government would seek to work to the given answer; that the students were electrocuted.

The Police turned to Dr. William Olufemi Odesanmi, a pathologist in the university who also worked for the police, to perform post mortem on the four students. His verdict was electrocution. Professor Femi Soyinka, who was the University's Medical Director and Dean of the Faculty of Health Sciences decided

to bring all possible evidence to light. This was in accordance with the Vice Chancellor's appeal that the Government Tribunal of Inquiry into the deaths, should be assisted in all ways.

One of the steps he took was to get the Senior Mortuary Attendant, Mr. Lamidi Adediwura available to give evidence. But Dr. Odesanmi became panicky. He petitioned the Vice Chancellor alleging that Soyinka was trying to get the tribunal to obtain: "medical evidence from an illiterate attendant."

He claimed that Soyinka's action in sending the Mortuary Attendant to the Tribunal amounted to: "depriving a citizen of his right to liberty and right to earn a living." He said the action also amounted to a threat on his life adding that: "Prof Femi Soyinka, my Dean, will have a case to answer should anything happen to me."

But Soyinka was not deterred and insisted that all witnesses must be brought to the tribunal even if their evidence contradicted claims by other witnesses. Later, there were questions on the forensic report, but the clearly partisan Tribunal Chairman, Justice Salihu Moddibo Alfa Belgore rejected the appeal to recall Dr Odesanmi.

With the advent of HIV/AIDS, Soyinka turned to fighting the pandemic, mitigating its impact in the country, vigorously researching into it, fighting stigmatisation, participating in prevention of mother-to-child transmission and encouraging Voluntary Counselling and Testing, VCT. On Tuesday, June 14, 2022 at his residence in Kukumada Village, Ibadan, Prof Femi Soyinka left.

That same day he departed, a conscientious journalist, social mobiliser, gender activist and Head of Human Security and Civil Society at the Economic Community of West African States, ECOWAS, Raheemat Momodu, attended a meeting. We had worked as journalists and championed a brand of journalism under a radical group, the New Trend Movement. She went on to become the Chairperson of the National Association of Women Journalists, NAWOJ in Lagos State.

Then I moved to the Nigeria Labour Congress, NLC to become a full time



trade unionist and she moved to the Friedrich Ebert Stiftung, FES, as it Gender Equity Programme Officer.

Both organisations moved to Abuja, but FES, a socially conscious German organisation did not then have an office in the city. So it was accommodated in the Labour House headquarters of the NLC. So we ended up working in the same premises and became closer.

She had a colleague, Juliana Anosike with whom she struck a close relationship, and I teased them as 'Siamese Twins.'

Then I moved on to become the Secretary General of African Workers which made me the workers' representative in the African Union, AU. In 2013, I was surprised to find Raheemat at the AU African Heads of State Summit in Addis Ababa. It was a happy reunion. She was at the AU as the ECOWAS Liaison Officer. Then I returned to Nigeria and she was also moved back to the ECOWAS Secretariat in Abuja.

I sent her messages promising to visit. Then this Tuesday, June 14, 2022 there were messages that she might have passed on. I called her 'twin' Ms Anosike who said they spoke the previous day but had slumped while attending a meeting and was brought

in to the hospital dead.

So, a country in dire need of heroes, lost two in one day. But Nigeria is blessed because we throw up heroes, sometimes from unexpected sources. That was the case of Ejiro Otarigho a fuel tanker driver. He was driving his fuel-laden tanker in a crowded part of the East-West Road, Agbarho, Ughelli, Delta State when his assistant alerted him the truck was on fire.

He glanced back and saw "a scary ball of fire." The instinct of most would be to jump off a burning fuel tanker. But he was in a crowded area with residential houses and knew the flame would engulf the area burning people and property. He did the unthinkable. He asked his assistant to jump down while he drove the burning tanker for four kilometres out of the town towards the river.

He could not make it to the river, but when he got to an open space, he dived out before the entire vehicle became a huge fireball. Fortunately, he was unhurt. His selfless example, taught Nigerians that although our leaders cannot secure lives and property and many would try rationalise criminality in ethno-religious garbs, we will never lack heroes.

The Bulls had also prevailed 63-57 against the Sai Masu Gida, when both sides met earlier, in the final 8; and their

undoing was over relying on veteran captain, Abubakar Usman, whose 14 points and 2 assists, fell short of unsettling the Bulls from Gombe, who triumphed despite not having their Head Coach, on the bench.

The Winners, Nigeria Customs got a N2 million cheque, as Prize Money, while the losing finalist, Mo Heat took home N1.5 million.

Meanwhile, Senator Dino Melaye donated N300,000 for the winners and N200,000 for the beaten finalists of Mark DB all, rated the championships as "top notch", and the best basketball competition, in Sub Sahara Africa.

The other four teams that contested for honours in the final-8 are HotCoal Ballers of Abuja, FCT HardRockers, Kwara Falcons of Ilorin and Delta Force of Asaba.

he Commissioner of Sports Development Kaduna State, has handed down a June 30 Deadline for the submission of forms for participation from the 23 local government areas in the state, ahead of its 2022 Kada Sports Festival.

This is aimed at making the state prepare adequately ahead of the 2022 National Sports Festival (NSF), billed for Asaba, Delta State later in the year.

Sports Writers in Kaduna gathered this from a circular issued on Monday June 20, which reminded the LGAs.

The circular which emanated from the office of the Director of Sports (DoS), said the instruction was from the commissioner.

"I write to inform all LGCs that the Hon. Commissioner, Ministry of Sports Development has approved 30th June, 2022 to be the final day for the submission of all Registration forms for the forthcoming Kaduna State Sports Festival 2022," it said.

It warned that the Ministry will consider any LGC that did not submit it's entries on or before this date as not participating.

It further informed that the preliminaries for the sports festival will start early in July.

"The preliminaries will start on the 4th July, 2022 at all centres in all the team sports. Pls treat with despatch. Director of Sports D e v e l o p m e n t , f o r Commissioner," the circular

# International Friendly: Super Falcons To Face Japan's Senior Women Team In Kobe

ine-time African champions and FIFA World Cup ever-present Nigeria will take on the Senior Women National Team of Japan in a prestige international friendly match at the Noevir Stadium, Kobe on Thursday, 6th October this year. The date falls within

one of the FIFA Women International Windows for this year.

Nadeshiko Japan, which is the alias of the Women National Team of Japan, are rated 13th in the world, while the Super Falcons are 39th.

Both teams have clashed only once at competitive level – at the 2004 Olympic Women's Football Tournament. Nadeshiko pipped the Falcons 1-0 at the Karaiskakis Stadium in Piraeus on 14th August 2004.

Two back-to-back friendlies in 2013 were won 2-0 each by Nadeshiko.

Japan's entertaining girls won the FIFA World Cup in Germany in 2011, beating Team USA in a pulsating penalty shootout after regulation time ended 2-2. Nadeshiko thus became the first team from Asia to win a senior FIFA World Cup trophy.

The Super Falcons are perennial champions of the African continent and have participated at every FIFA Women's World Cup since the competition began in 1991, reaching the quarter finals in 1999.

# WAFU B U17: Eaglets go for broke against Junior Elephants in semi final clash

ead Coach Nduka Ugbade has assured that Nigeria's Golden Eaglets will go all out against their Ivorian counterparts in Tuesday's first semi final match of the ongoing WAFUB U17 Championship in Cape Coast, Ghana. "Whatever we have done here (beating Ghana and Togo) will not mean much if we don't go all out and grab our ticket to the AFCON and to the Final. We will throw everything into the fray."

The Eaglets, five-time world champions, decimated Ghana's Black Starlets 4-2 in the tournament opener and then eased past Togo's Young Sparrowhawks 3-1 to finish as Group A winners. The Ivorians finished as runners-up of Group B, dominated by Burkina Faso's Young Etalons.

Victory in Tuesday's encounter will send the Eaglets into the Final and with an opportunity to reclaim the WAFU B U17 title they won in Niamey, Niger Republic four years ago. It also provides the Nigerian youngsters a revenge platform against the Ivorians, who defeated them in the Final of the same competition in Lome early last year. Both Nigeria and Cote d'Ivoire qualified for the Africa U17 Cup of Nations from that tournament but the event was cancelled as hosts Morocco developed cold feet with the covid-19 pandemic still biting in some countries.

Meanwhile, President of the Ghana Football Association, Simeon Kurt-Okraku on Sunday visited the camp of the Golden Eaglets in his capacity as President of WAFU B region. He reminded the lads that Nigeria belongs to the top echelon of football –playing nations on the African continent, and has produced so many world –class players. He charged the boys to always adhere to the instructions of their coaches in order to grow, advance and excel in the beautiful game.
