Sources said the killing of the three young men is presently creating fears in the area which was rocked by chains of ritual killings few years ago.

Contacted Oyo State Police Command Public Relations Officer, SP Adewale Osifeso said, "investigation is ongoing, Updates would be provided accordingly."

AA Chairman Urges Nigerians To Show Love, Embrace Forgiveness

he National chairman of the Action Alliance (AA), Dr. Adekunle Rufai Omo-Aje has urged Christians across the nation to show love and embrace forgiveness and reconciliation during the Yuletide season, in line with the spirit of Christmas.

He expressed this in his massage to Christians on the celebration the birth of Jesus Christ.

Omo-Aje also enjoined Nigerians to seek divine guidance in choosing the right leaders for the country during the coming polls in 2023.

According to him, as the country moves into the election year 2023, there is one thing that all Christians and indeed all people of good will, must do and that is to pray for guidance in choosing the right leaders to lead them at different levels.

He stressed that the situation in the country is such that without the help of God, the people certainly are incapable of doing it by themselves.

The AA National Chairman assured Nigerians that if his party is voted into office in 2023, attention would be given to revamping the economy, addressing poverty and curbing insecurity, among other things.

He maintained that his party was ready to dismantle every platform of bad leadership and install good leadership.

2023: Archbishop Ndagoso Tasks INEC On Free, Fair Elections, Says It's Sinful To Sell Or Buy votes

head of the 2023 general elections, Catholic Archbishop of Kaduna Archdiocese, Most Reverend Matthew Man-Oso Ndagoso has charged the Independent National Electoral Commission (INEC) to do all within its powers to ensure that the forthcoming general elections are conducted in a free and fair atmosphere that enables all eligible citizens to exercise their franchise.

"In other words, no eligible voter should be disenfranchised for lack of a c c e s s to his/her permanent voter's card (PVC) and polling stations. Votes selling or buying is not only illegal a c c o r d i n g to the Constitution, but a sin before God,"he said.

Delivering his Christmas message on Saturday in Kaduna, Archbishop Ndagoso lamented that, "we celebrate Christmas in our country amidst fears, trepidation and anxiety caused mainly by continued acts of banditry that takes the lives of many of our compatriots on a daily basis, kidnappings for ransom, armed robbery, un-abating

farmers/herders conflicts, insurgency ritual killings.

"As if these were not enough, we are now faced with a very high cost of living affecting all aspects of life with more and more people in the land joining the ranks of those already living below the poverty line, in abject poverty."

"We all know the culprits:

bad leadership that encourages mediocrity, nepotism and ineptitude which in turn breeds corruption and bad governance that have earned our country the unenviable position of the world capital of the poor." Ndagoso appealed to all the faithful of the Archdiocese and indeed all people of goodwill to ensure that no matter how much sacrifice it requires, they should ensure that they have their PVCs collected.

"The distribution of the PVCs which is already in progress in INEC offices in LGAs since December 12, will last until December 22, 2022 and continue at the ward level from January 6 to 15, 2023 and revert to the LGA level from January 16 to 22, 2023, the distribution will continue in LGA offices," He added.

He however, challengef

Christians to trust in God and not to live in perpetual fear, even when they do not understand fully what the future portends for them, especially as they continue to struggle with insecurity, biting poverty, incessant kidnapping for ransom, killings and anxiety over the 2023 general elections.

"Like the shepherds we must have the faith and trust to face our future with confidence and determination, knowing that our God is with us all times, no matter how difficulty and challenging our situation maybe," Ndagoso stressed.

On same faith tickets in 2023 general elections, he maintained that, "since ours is a multi-cultural and multi religious society anyone who aspires to lead this kind of society must be one with the capacity to manage these diversities.

"It goes without saying that no sensitive Nigerian politician would ever contemplate running a same-tribe-ticket at certain levels of our national life because of its implications for our national cohesion.

"In the same vein, one would have thought that given where we are with the fragile nature of national cohesion, no considerate and sensitive politician would think of running a same-faith-ticket especially at the national level because of the threat it poses to our delicate national cohesion.

"One would have thought that prospective national public office holders at this point of our national existence, would be people sensitive enough to this delicate national issue and have the foresight and ability that will enable them to harness and properly direct the various gifts, talents, energies and resources of the different regions of the country for the common good of the nation.

"But as the Catholic Bishops Conference of Nigeria (CBCN) pointedly said in its communique at the end of its 2022 Second Plenary in Orlu: "While it is not our responsibility as religious leaders to dictate to political parties the choices of their presidential, vice presidential and other candidates, we have the duty to advise the citizenry to bear in mind the implications of these choices while electing the next set of leaders."

company's Head of Corporate Communication, Abdulazeez Abdullahi in Kaduna on Tuesday, said in the cause of its investigations, the company's officials visited Gwargwaje community and met with families of the affected persons on three occasions since the incident to mourn with them and gather relevant information on the

According to the statement, from the direct interaction with victims and community leaders, the fatalities recorded involved only six persons. It said five of the deceased persons lived on Kagoro Close, Gwargwaje except one person who resided in the Police Barracks. It said it had not received any information of more fatalities since its last visit to the community on Saturday.

The statement said it has

also gathered detailed information on all those who sustained injuries or lost properties. It added that it has been liaising with relevant security authorities and the traditional institution in Zaria to discuss next steps. Kaduna Electric said releasing the fatality figure has become necessary in view of the need to correct the erroneous information being peddled by a section of the media.

Allow Oppositions Political Spaces To Freely Operate, Gov Bala Tells Council Chiefs

Tith the countdown to the 2023 general elections gathering momentum, Governor Bala Mohammed of Bauchi State, has urged local government administrations across the state to allow political spaces for the opposition to operate in a freely atmosphere devoid of hindrance or rancour.

He told the council chiefs, "Local Government administrations are hereby urge and directed to make sure they allow the political spaces for the oppositions to operate freely without any hindrance. This is the mark of democracy".

Speaking Saturday while swearing-in newly chairmen of Local Government Caretaker Committees, the governor said that the rule of the game must be adhered to, and anyone found wanting in this regard would incur the full wrath of the law.

Senator Bala Mohammed therefore directed security agencies in the state to be watchful and apprehend any person or group of persons found to be engaged in unwholesome activity.

"As you know the 2023 general elections are fast approaching and electioneering campaigns are in full gear. I therefore, appeal to all political parties and their supporters to conduct themselves in an orderly manner, and eschew thuggery and other forms of malpractices".

He explained that the assignments given to the caretaker chairmen is a trust, as they have a duty to Allah (SWT) and obligation to their fellow beings, saying "One day you must give account of your stewardship. You should not therefore have tempted to abuse the trust bestowed on you. You should remember that you are to serve the people and

not to become their bosses. He warned them not to be tempted to betray the confidence reposed in them while in their various duty posts to serve their people, stressing that his administration attaches great importance to probity, accountability and strict adherence to due process in governance as indicated by their actions since their coming on board as a government.

The governor also warned the new appointees that the present administration in the state has no place for corrupt, disloyal, indolent and incompetent officials, as they should also be absolutely loyal to the state and be totally committed to its objectives.

Mohammed similarly admonished the local government chairmen to be judicious in handling finances of their respective local governments, and be fair in their dealings with all

categories of people, shun bootlickers and rumormongers, and pay special attention to their internally generated revenues to complement what is being given them by the state government and from the federation account.

"Following the expiration of the tenure of elected local government councils in the state about two months ago, the need arose to fill the vacuum created in the leadership of the Local Governments. Due to the impending general elections, which would be conducted about two months from now. there is no time to conduct Local Government election" To this end, the governor said, the Bauchi state government has left with no option other than to appoint caretaker committees to run the affairs of the local governments pending the conduct of Local Government election.

They were said to have crossed the red line while relaxing at the each identified as Baracuda, located around Abraham Adesanya axis of Ajah, Eti-Osa Local Government, Lagos State.

It was learnt that officials of the Lagos State **Emergency Management** Agency (LASEMA). commenced search and rescue operations to safe their lives, an exercise which end in futility.

Our correspondent that the tragedy occurred on Monday when the fun seekers visited the beach as part of the activities to celebrate the yuletide season in the state.

Eyewitnesses at the beach narrated that two of the drowned persons were trying to rescue the third person when they also went missing in the water. The Permanent Secretary, LASEMA, Dr. Femi Oke-Osanyintolu, confirmed the tragedy through a statement made available to newsmen on efforts made by the agency to rescue the victims.

According to the statement, on arrival at the scene of the incident, it was observed that two persons at the beach drowned inside the ocean at the aforementioned

"Further investigation gathered revealed that two adult males were trying to rescue an adult male from drowning before the high tide of the ocean drowned the two adult males.

"In addition, the lifeguard at the beach reported that the victims swam beyond the red line which wasn't safe for them to engage in the rescue.

However, the agency's LRT and Paramedics are on ground. And search and rescue operation is still ongoing".

Nigerians Must Unite To Defeat Insecurity, Economic Crisis - US Based Cleric

*Says electorate should dig deep before voting leaders in 2023

he General Overseer of Kings Worship Chapel and Centre International, Sabo Kaduna, Rev Albert Samson who is based in the United States of America, has said that for Nigeria to break free of the twin evil of insecurity and economic hardship bedeviling the nation, citizens must come together irrespective of their tribal or religious affiliations.

The cleric expressed this while speaking to journalists in his church office shortly after giving his Christmas sermon to mark the birth of Jesus Christ on December 25.

He decried the incessant cases of killings in all parts of the country especially the North. Rev Samson recalled that the North used to be haven of peace, unity and love.

"The North that I used to know is the one which if your money falls on the ground without you knowing, the Hausa man would call you back, and hand over your money.

The North that I know, is the one which you can travel in the night but today, the situation in the North is dire, today there are killings in Zamfara, Katsina, Benue and Kaduna," he lamented.

Rev Samson condemned the killing of thirty persons in Southern Kaduna, a trend which he said, portends danger for the unity of the country.

He said, "It is almost a week that over 30 indigenes of Kajuru were killed, we have not seen or heard the Kaduna State Government say anything about the killings. I expect the governor of the state to swing into action, makeling sure that the perpetrators are arrested.

"The government needs to show that he is running an inclusive government."

On the issue of 2023 general elections, the US based cleric said that Nigerians should query the credentials of candidates who want to be governor or president, before they are voted into power.

"If anyone wants to contest for the post of the president or governor, we must look at his past, we must ask what he or she has done and we must make sure that such persons do not have records of failure," he advised.

In a statement made available to journalists in Lagos, Bello-Koko stated that he does not have the opportunity to seek redress in court on the grounds of their rehashed and rehearsed lies, because they are

According to him, it is unfortunate that some online news media have lent their platforms to "these desperadoes" to ply their odious trade, noting that all the supposed assertions and innuendos in the report are nothing but spurious and malicious concoctions intended to cause a predetermined damage.

The NPA boss however, warned that henceforth, he will institute legal action against any medium used to publish unsubstantiated reports about him.

He said: "Having failed in their desperation to dent or hurt my integrity, they have resorted to a very cruel campaign of calumny against my person and my family.

"I need to reiterate that for all of my years as a banker and a public officer up till today, I have never been indicted or convicted by any court. And this fact is in the public domain. I'm also certain that my integrity as well as dedication and fidelity to the rules of public administration must have influenced the decision by the Federal Government of Nigeria to promote me from the rank of Executive Director (Finance and Administration) to Chief Executive Officer of the Nigeria Ports Authority

"Resorting to writing to the UK Government, seeking visa cancellation and forfeiture of assets belonging to my wife and I, is not only malicious but also cruel and wicked. I have yet to understand why these evil machinations would be orchestrated against me. Is the offence that I committed my acceptance and readiness to serve my country to the best of my ability? This latest attack, in the series of sponsored blackmails targeted at me, which began in 2021 immediately after I was elevated from the position of Executive Director of Finance and Administration to the position of Managing Director of the NPA is intended to damage my reputation. "Is there no limit to what vested

interests can do in their desperate pursuit of power and influence? In deceit, they have disingenuously claimed in the sponsored report that UK/Ireland Investigators were the ones that had written to the UK government after they had purportedly unearthed alleged criminal acts against me, bordering on money laundering activities, fraud, forgery, and tax evasion, which are all baseless figments of their malicious intent.

"Whereas, particulars cited in the report were the regurgitated allegations that they had sponsored and which had been doing the rounds in the media from the outset, this latest attempt is as spurious as their first attempt ever. Their claim that UK/Ireland Investigators, and not Metropolitan Police or Scotland Yard, are investigating me falls flat on its face and gives out the sponsors of the report- which is a piece of cheap blackmail-as desperate hustlers who are not civil and neither working in the interest of the society".

According to him, if the Economic and Financial Crimes Commission (EFCC) had been on the matter as indicated in the report, it is then unfair to suggest or claim that some questionable UK/Ireland investigators are now pushing for an exclusion order to ban him from ever entering the United Kingdom. While pointing out that there should be inter-agency collaboration in line with some bilateral or mutual agreements, he challenged the conduit pipes of the malice to go ahead and mention the names and true identities of the CSOs and the investigators.

He explained further: "I had, on several occasions, stated that the NPA under my leadership is not aware of any secret foreign accounts and I could not have been a beneficiary of something that I am not aware of and, which I would like to emphasize is non - existent to the best of my knowledge.

"The UK property they mischievously mentioned was declared with the Code of Conduct Bureau (CCB) and purchased before I was appointed into public office. It is also important to note that the property was purchased on a 15-year mortgage payment plan.

"As NPA MD, I run an open administration that gives premium to due process in the execution of the agency's core mandates. Our performances have been recently validated by the Bureau of Public Service Reforms (BPSR), which adjudged the NPA on my watch as a Platinum Level Organization, consequent upon the deployment of its Self-Assessment Tool (SAT) in the NPA for the independent assessment, validated assessment and in-depth analysis of processes and practices of the agency. Flowing from the assessment, the BPSR had returned a verdict of "exceptional performance by the NPA with a performance level of 91.25 per cent".

Bello-Koko said that according to

the Director General of BPSR, D.I. Arabi, the NPA's performance far exceeded expectations due to exceptionally high quality of work in all essential areas of responsibility, resulting in an overall quality of work that is superior, exceptional or unique.

He highlighted that under his watch, the NPA has specifically, in terms of tangible achievements that the various publics can relate with, recorded some modest achievements and has generated the sum of N286 billion and remitted over N100 billion to the Consolidated Revenue Fund (CRF) account of the federation as of November 2022.

Bello-Koko, while reeling out other achievements of the Authority, said that it's committed efforts at advancing trade facilitation recently won it the award of "Best Maritime Agency of the Year 2022" by Daily Telegraph Newspaper.

"In the light of the above, I cannot afford to be distracted by the deliberate shenanigans of blackmailers and vested interests who are desperate to upset the applecart of my sharply-focused leadership that is committed to emplacing and bequeathing to the nation a transparent and accountable management of the NPA now and in the years ahead.

"In rounding off, I will, henceforth, institute legal action against any media house that publishes unsubstantiated and damaging reports about my person", he added.

he Governor of Nasarawa State, Engineer Abdullahi A. Sule, has clocked sixty-three (63) years of existence on earth. Born on December 26, 1959, in Gudi Station, Akwanga-West Development Area of Nasarawa State, Abdullahi Sule's selflessness in serving humanity, devotion to duty and sense of humour, made him beloved to his family, friends and all people, thereby making him attractive like a magnet.

His father, Alhaji Sule, is the current traditional ruler, Sarkin Gudi, while his grandfather, Abdullahi Angulu, was the first traditional ruler of Gudi station. Abdullahi Sule began his education at the Roman Catholic Mission (RCM) Primary School, Gudi Station, in 1968, upon completion, he proceeded to the Zang Secondary Commercial School, Bukuru, in 1974.

In 1977, he passed his SSCE in Bukuru, before proceeding to Plateau State Polytechnic, Barkin Ladi and later Indiana State University, Terre Haute, Indiana, USA towards the end of 1980.

Through determination and hard work, he utilized a four-year scholarship to obtain both a BSc (1983) and an MSc (1984) degrees in Mechanical Technology respectively from the same Indiana State University, USA.

His work experience began in 1980 when he was offered employment by the Plateau Electricity Corporation, Jos, even before graduation in May 1980.

Upon graduation from government Technical College, Bukuru, he worked for about three months with the corporation before proceeding to Plateau State Polytechnic, in September 1980.


Engineer Sule, d i d h i s c o m p u l s o r y national service, NYSC, with the Plateau Utilities Board, Jos and later joined the Jos Steel Rolling Company Ltd in 1985 as a p r o d u c t i o n engineer.

In 1987, he received accelerated promotion from GL9 to GL 12 in recognition of his performance and hard work. He later left Jos Steel R o 1 1 i n g Company as a principal production engineer in 1989 and returned to the United States. On returning to the US, Abdullahi Sule went to Texas (San Antonio and later Houston) where

he worked for the following companies: Lancer Corporation, S a n A n t o n i o; O E M Components, Houston; Houston Engineering, Houston; Morgan Performance, Houston; Dril-Quip Incorporated, Houston and Osyka Corporation, Houston.

He worked in various capacities from workshop engineer to computer numerical control (CNC) programmer, NCN operator, facility engineer, project/production engineer and finally the director of business development for Africa and the Middle East for Osyka Corporation.

He returned to Nigeria in the year 2000 and along with some friends, started a company called Sadiq Petroleum Nigeria



Limited in Lagos and was made the pioneer Managing Director/CEO.

Later that year, Sadiq Petroleum Company participated in the privatization of African Petroleum Plc and won the bid. Upon acquisition of the 30% ownership of AP in November 2000, Engr Sule, was appointed APMD/CEO on April 2, 2001.

He resigned in July 2006 to take up another job with an American Multi-national oil service company called Tetra international in July 2006 as a Director of Business Development/ country Manager.

While in AP as the MD/CEO, he also served as a Director in IMB International Bank

Plc, Ulti-Care Pharmaceutical

and Chrismatel Holdings. He was also the chairman of AP Oilfield Service Ltd and Partner in star-AP Oilfield Services.

Sule was a director at the Dangote Group between 2010 and 2011. He was also the group managing director of Dangote Sugar Refinery Plc between 2011 and 2018 when he stepped down to contest the Nasarawa governorship election on the platform of the All Progressives Congress (APC).

In that March 9, 2019 election, Abdullahi Sule scored 327,229 votes to defeat his opponent of the Peoples Democratic Party (PDP) who scored 184,281 votes, while the All Progressives Grand Alliance (APGA) candidate got 132,784 votes. He was sworn-in as Nasarawa Governor on the 29th of May, 2019.

Nkwagu said, "Last year, 2021, the number was about 1,200 widows.

"You saw this time that the number increased.

"Everywhere, because of violence, killings, communal crises, a lot of children are left orphans and women widowed.

In a homily, Nkwagu admonished the widows and orphans to place their faith ultimately in God, pledging that the Church would continue to make them prominent beneficiaries of its welfare schemes.

In an interview, Rev Chukwuebuka Umeokafor, the Project Manager of the Anglican Diocese of Abakaliki Health and Community Development Initiative, explained that the NGO in collaboration with the Diocese officially instituted the welfare scheme since 2012.

He stated that there were over 2,000 widows as well as orphans profiled in its database, and commended the Bishop for his passion, which he noted, has continued to inspire the organization from inception.

"We are motivated by the



passion and vision of the Bishop, Rt Rev'd Monday Nkwagu.

"He had served in remote areas as a priest and understands fully what the widows and orphans are going through.

"So, when he was elected the Bishop, he took the commitment to ensure that we institute a programme towards the end of the year, through which the widows and other vulnerable group could be taken care of, so they don't feel inferior when others are celebrating Christmas.

"We have been doing this since 2012, and we have over 2,000 widows in our database.

"Currently, we have up to 30 of these children in various higher institutions across the country" Umeokafor explained.

NANS made the call during a courtesy visit to the research institute on Thursday, adding that, democracy advocacy group under the umbrella of Partnership for Legislative Agenda, (PLAN) also made similar call in Abuja last week, citing opportunities available in the chemical industry as what is missing in moving Nigeria forward for it to self reliant.

Comrade Usman Baba Kankia, National Secretary of NANS assured that the bill would enhance productivity and give Nigeria an edge to compete with other advanced countries, saying that the country has what it takes to be a pace setter in the production of chemicals and petrochemical products as initiated by the House of Representatives Member, Jos East/South constituency, Musa Dacchung Bagos.

NANS then called on the office of the head of service to grant approval to the Institute to recruit more specialised staffs in readiness for the task ahead of making the country depends in all that is produced within.

According to Oyo APC, the ruling PDP in the state and Gov Makinde are already putting in place what it described as clandestine plots to compromise the desired standard of free, fair and credible election expected from the Independent National Electoral Commission (INEC) in the conduct of 2023 general election.

It pointed out that the fresh alarm came " on the heels of allegations of vote-buying plot, sponsorship of violence to prevent opposition parties from carrying out their electioneering campaigns and planned compromise of some INEC officials all in the bid to forcefully secure an 'unmerited' second term for Gov. Makinde". The party in the statement frowned at " Gov. Makinde's scripted gesture of benevolence as being displayed in recent times to include Greek gifts to political leaders, religious bodies and others who he had abandoned to their fate since assumption of office in 2019".

"It is highly imperative for us to alert the public, INEC and the security agencies about certain steps being taken by the governor and some of his agents to perpetrate vote-buying and other sharp practices in their bid to compromise the forthcoming general election in the state in favor of the candidates of the PDP." it said.

APC added, "The truth of the matter is that Gov Makinde has got enough money from the treasury of the state to prosecute his mission to influence voters and other critical stakeholders before, during and after the gubernatorial election in particular. The sloppy manner in which Oyo PDP under Gov. Makinde carries out its



campaign activities has suggested to the discerning minds that the governor and his people do not place their hope of second term in office on decent electioneering and credible electoral process."

"Up till now, the ruling Oyo PDP

has not held a single political rally in any part of the state after more than 90 days when INEC had lifted ban on open campaigns in the build up to the 2023 general election.

Rather than engage the electorate and give an account of stewardship in the last 42 months with a view to retaining the confidence of the people",

APC stressed further, "Gov Makinde has commissioned a good number of foot soldiers to negotiate for votes with dole out of crumbs and financial inducement. A good reference is the hijack of federal government's social scheme whereby citizens are being paid varying sums of money to cushion the effects of economic meltdown".

"We have it on good authority that Oyo state government has taken possession of the cash distribution as they compel beneficiary to produce their individual permanent voter card which they collect and scan before releasing the cash incentives.

"Another set of foot soldiers now move round some parts of the state capital and other major cities in the state to obtain phone contact and bank account details of prospective voters who have PVC and willing to cast their votes in the forthcoming general election. Early this week, the governor sent a proxy (who is also a PDP candidate for the House of Representatives poll) to deliver some items packaged as Christmas/New Year gifts to some officials of INEC in a clear case of inducement ahead of the conduct of the 2023 poll.

According to APC, "all these are in addition to baits of contract bazaar, illegal allocation of government land, SUV gift among other things being packaged to woo some identified political gladiators, traditional rulers, religious leaders, civic society organizations, trade unionists, student bodies and influential personalities who have been established to be against Gov. Makinde's reelection bid on account of his poor first term performance.

It is on this note that we urge INEC, EFCC, ICPC, Code of Conduct Bureau and other relevant agencies of government to beam their searchlight on Oyo State and ensure that unscrupulous elements who are bent on disrupting the 2023 poll do not have their way".

Lagos Govt Disburses N750m Equity Funds As Free Insurance Coverage For Vulnerable Residents

o fewer than 230,000 indigent and vulnerable residents of Lagos State are currently benefitting from free health insurance coverage from state government.

Beneficiaries include members of elderly and orphanage homes, vulnerable persons living with HIV/AIDS, tuberculosis, sickle cell anaemia, and victims of domestic and sexual violence, spread across the 57 local government and local council development areas of the state.

The free health insurance coverage is sponsored by the State Government through the Eko Social Health Alliance (EkoSHA).

Speaking on Wednesday at the media launch of the Eko Social Health Alliance (EkoSHA) held at the Providence Hotel, GRA, Ikeja, the Commissioner for Health, Prof. Akin Abayomi explained that EkoSHA, an initiative of the Lagos State Stat Government coordinated through the Lagos State Health Management Agency (LASHMA), is an alliance of private institutions, public institutions, development and multilateral partners and individuals seeking the good of all residents of Lagos.

He said: "The initiative is designed to mobilize adequate funds to help the identified vulnerable residents of Lagos state access the health insurance through the Ilera Eko Social Health Plan under the Lagos State Health Scheme (LSHS). EkoSHA will also provide access to social welfare empowerment programs so that beneficiaries do not only have health insurance but are provided opportunity and support that will gradually lift them out of poverty".

Abayomi who was represented by the Director, Medical Administration, Training and Programs in the State Ministry of Health, Dr. Funmilayo Shokunbi further explained that the alliance, in addition to mobilizing more funds to help the identified vulnerable Lagos state residents access health insurance, will also collaborate with different departments and agencies engaged in social welfare empowerment and poverty alleviation programs so that beneficiaries do not only have health insurance but are provided opportunity to enhance their ability to attain sustainable livelihood.

"EKOSHA will collaborate with Social Welfare and Empowerment MDAs/ Organisations to provide a means of livelihood for these beneficiaries such that they do not remain dependent and can eventually afford to pay health in surance premiums for themselves", he said.

Abayomi noted that the Governor of Lagos State, Mr. Babajide Sanwo-Olu graciously approved 1% of the State's Consolidated Revenue Fund (CRF) as equity fund to pay for residents who cannot afford to pay health insurance for themselves in order to ensure that Lagos State residents, including its vulnerable population, have access to the state health scheme.

He said: "The Lagos State Government continues in giant strides towards the Sustainable Development Goals and especially the Universal Health Coverage (UHC) journey of the State. This is evident in the various empowerment schemes especially through the agricultural sector, the housing schemes, the health sector improvement, transportation and other infrastructural development under the leadership of Governor Babajide Sanwo-Olu".

The Commissioner disclosed that since the commencement of access to care for the vulnerable residents on the ILERA EKO Social Health Plan in 2020, a total of N750 million has been disbursed as equity fund in addition to the Basic Healthcare Provision Fund (BHCPF), and sponsorships from a few individuals and organizations; to

provide health insurance for the vulnerable residents of the State.

While noting that the media launch programme is intended to raise the level of public awareness for EkoSHA initiative to stir up a positive reaction in the minds and hearts of well-meaning Lagosians and Nigerians to raise funds to pay for the health insurance coverage of millions of v u l n e r a b l e residents of the State, Abayomi

called on philanthropists, well-meaning people and organisations to key into the alliance and contribute their quota in their various capacity.

"This is a laudable one and we must not relent till the goals and objectives of EKOSHA are met. It is also our aspiration that these efforts will improve the health indices of Lagos State. As an administration, we will be unrelenting in pushing the frontiers of innovative financing for healthcare in Lagos State till we build a healthcare system that works for all", the said.

Speaking in the same vein, the Permanent Secretary, Lagos State Ministry of Health, Dr Olusegun Ogboye who was represented by the Director, Diseases Control, Dr. Rotimi Agbolagorite noted that the objective of the EkoSHA initiative is anchored on mobilizing additional funds through a strategic alliance with suitable financial institutions leveraging on a crowdfunding financing model to provide more funding options for the health care of the vulnerable residents of Lagos.



According to him, other objective of the initiative include, urging funding partners and facilitators like banks, local and international donor agencies, corporate bodies, religious organizations, NGOs and high net worth individuals register for the adoption of vulnerable residents by paying premiums for their healthcare coverage and providing social safety net for beneficiaries through access to the state's numerous empowerment programs.

Ogboye explained further that the initiative targets the vulnerable and indigent persons as defined by in the LSHS Law which include members of the Lagos State Social Register (LSSR), vulnerable persons living with special conditions such as Tuberculosis, HIV/Aids, Sickle Cell Anemia and Lupus, victims of sexual and domestic violence, teen moms, members of Destitute, Orphanage and Elderly Homes as well as other vulnerable groups as determined by LASHMA.

While commending the the Governor of Lagos and the First Lady of Lagos State, Dr. Ibijoke Sanwo Olu for their passion and commitments in ensuring that indigents, domestic and sexual abuse vulnerable live a good and healthy life, the Permanent Secretary stated that the State government is always open to collaborations from everyone who has the interest of the vulnerable and indigent people at heart and can partner with the government to sponsor beneficiaries in any of the three EKOSHA ACE Model of adoption, crowd funding and events model designed to raise additional funds for the healthcare of the vulnerable and indigents in the State.

Engr. Mohammed further charged them to be attentive, dedicated and committed to the training programme by embracing the training as a great opportunity to learn much about security, insecurity, challenges, implications, contemporary issues on terrorism and insurgency, crime and homicide, among others, as well as the guiding rules and regulations of their respective informal security operations.

He also charged them to comply with the principles and techniques of private security agents and personnel volunteer groups in the North East Zone, while stressing that the theme of the training workshop is apt and in line with the prevailing security challenges in the North East.

The coordinator pointed out to stakeholders that it is important they know their role in the society as informal security operatives in combating insecurity in the North East of Nigeria can never be over emphasized.

Few participants that spoke to our correspondent in Maiduguri, said the training is an eye opener and they have the high expectations that they would be exposed and it will create a kind of knowledge and awareness on security issues and operations, which will go a long way in assisting and guiding their operations.















Wase Group Slams Prophet El-Buba Over Comments

group called Wase Patriots in Plateau State, has debunked what they described "as the traded mischief of Isa El-Buba" against their traditional ruler, HRH the Emir of Wase, Alhaji Sambo Haruna, President Jama'atu Nasril Islam, Plateau State Chapter.

There are things I won't say here where the meetings took place, himself and one of the Emirs in this state, Wase"

According to them, "From the quoted statement of El-Buba, Plateau State and indeed the respected religion of Christianity, is no doubt, heading steadily to another quagmire of extricating themselves from the maniac stranglehold of some demented self-appointed preachers and their sundry co-travelers, determined to turn the state into another mine field in which blood must flow to water their insatiable quest to position themselves for undue recognition and for pecuniary gain, albeit irresponsibly."

According to the group, "we watched from a dignified distance the dangerous antics of some mischievous selfappointed preachers in both



One of the leaders of CJTF in Bama also said that the ISWAP members and Boko Haram insurgents planned to resume attacks during the Christmas and forthcoming general elections, but added that, they are ready to counter them whenever they launch any attack.

"The intelligence we received on their plans, especially their attempt to attack soft targets in Bama LGA energized us to be on alert, coupled with the successful airstrike which has reduced their number despite their regrouping and attacks," the source added.

Lawyer Murder: Sanwo-Olu, IGP Usman, CP Alabi Condemn Act, Assure Speedy Trail, Justice

agos State Governor, Babajide Sanwo-Olu, the Inspector General of Police, Usman Baba Alkali and the Lagos State Commissioner of Police, Abiodun Alabi have condemned the gruesome murder of a lawyer by a police personnel in Lagos.

The deceased, a female lawyer identified as Mrs. Bolanle Raheem was allegedly shot dead by an errant police officer on Christmas day in Ajah area of the state.

According to report, the cop, an Assistant Superintendent of Police attached to Ajiwe police station shot the victim, while with her family were on their way out for Christmas Day celebration.

Sanwo-Olu in a statement by his Chief Press Secretary, Gboyega Akosile, condemned in strongest terms, the alleged shooting and death of the lawyer.

The governor expressed shock and sadness over the mindless shooting of, "an armless citizen" by a police officer whose primary function is to protect the same citizen.

Sanwo-Olu sympathized with the family, friends and associates of the late Bolanle Raheem, pledging the state government's full support and cooperation with the police authorities in their investigation to unravel the remote and immediate cause of the shooting, that led to the untimely death of the innocent citizen, with a view to ensuring that justice is served.

He said, "I have studied preliminary reports on the matter and have instructed the appropriate government officers to immediately get on it. We must ensure a speedy justice for the late Bolanle. Our government cannot sit back and watch our citizens killed by the same law enforcers that should ordinarily protect them.

"I'm aware that the Lagos State Police Command have arrested, disarmed and detained the police officers involved in the shooting incident. I can assure you that the accused persons will have their day in court and nothing will be spared under the Laws of Lagos State, until justice is served adequately. We will ensure that it is done speedily because justice delayed is justice denied."

Governor Sanwo-Olu however, appealed to residents to remain calm and not take the law into their hands on the matter, assuring Lagosians that the government will live up to its responsibilities and get justice for the late

The governor prayed for the repose of the late Bolanle Raheem's soul, asking God to grant her immediate family and friends the fortitude to bear the irreparable loss.

Similarly, the Inspector-General of Police, IGP Usman Alkali Baba, condemned the shooting and killing of Mrs Omobolanle Raheem, describing the incident as unfortunate and sad.

He has ordered speedy investigation and prosecution of the officers responsible for the ugly and unprofessional act, which doesn't portray the Nigeria Police Standard Operating Procedure and core values.

In a statement by the Force Public Relations Officer Olumuyiwa Adejobi, the IGP commiserated with the family, friends, and colleagues of the deceased as he prays for the repose of her soul.

He further assured the general public of justice in the case while he warns officers and men of the Force to be professional and people-oriented in the discharge of their duties and operate within the ambit of the law, as the Force's leadership will not condone any inappropriate or unprofessional acts.

In the same vein, the Commissioner of Police, Lagos State Command, CP Abiodun Alabi, has expressed heartfelt condolences to the family, friends and colleagues late lawyer.

In a statement by the Police Public Relations Officer (PPRO), of the command, SP Benjamin Hundeyin, the Commissioner of Police has ordered that the errant officer be taken into custody alongside his team members.

"The CP has equally directed that the case be transferred to the State Criminal Investigation Department, Yaba for in-depth investigation.

"This has become one too many, especially bearing in mind that a similar incident occurred at the same location less than three weeks ago. The condemnable incident is against the standard operating procedures (SOP) and rules of engagement of the Force, and to say the least is embarrassing.

Death Sentence On Abduljabbar UnIslamic, Would Be Appealed - Bauchi Clerics

igh level Clerics in Bauchi State under the under the under the auspices of an Islamic organization 'As'habul Kahfi Warraqeen' have condemned in totality and rejected what it called un-Islamic, wrong and so-called death sentence recently delivered by Judge Ibrahim Sarki Yola on Sheikh Abduljabbar Nasiru Kabara for alleged blasphemy.

"The purported un-Islamic, so-called judgment by Ibrahim Sarki Yola is totally wrong and un-Islamic, we therefore reject it because the judgment was negatively manipulated from the beginning to the end, said the organization public relations officer, Abdullahi Musa.

The 'As'habul Kahfi Warraqeen' Public Relations Officer said in a statement in Bauchi Monday that the judgment was politically processed by Governor Abdullahi Umar Ganduje because Sheikh Abduljabbar was a critic to Governor Ganduje's corrupt tendencies which he vehemently kicks against. "We notice that some of the sects who now ganged up to eliminate Abduljabbar were the ones who committed series of blasphemies in their preaching, but nothing was done to them, as they continue to practice their religion without hindrance".

Musa allegedly



enumerated these blasphemers to include Qaribu Kabara, Abdulrazak Yahya Haifan, Abbas Jega, Jalo Jalingo, Ahmad Gumi, Abdulwahab Abdullah and Sani Rijiyar Lemo, saying "But because they are close to people in power, they went scot free while our spiritual leader who is innocent is now facing persecution".

They therefore ganged up against him and labeled false allegations of blasphemy against him in order to smear him and

eliminate him through the court", PRO said.

According to him, the allegation of blasphemy a g a i n s t S h e i k h Abduljabbar is nothing but campaign of calumny a n d c h a r a c t e r assassination by his detractors including Governor Ganduje and some clerics who feel t h r e a t e n e d b y Abduljabbari's increasing popularity.

Malam Abdullahi Musa explained that the detractors purported an allegation of blasphemy to give Abduljabbar a bad name, and have justification for their evil plan to exterminate his life, hence the Bauchi clerics resolve to appeal against the judgment in a higher Court of law to quash this unsatisfactory judgment and impose his

Political Tussle: 3 Confirmed Dead, APC Chairman's House **Burnt in Ebonyi**

*Umahi orders arrest of culprits

bonyi State Police Command has **d**confirmed the killing of three persons in Ekoli-Edda over a political tussle between the State All Progressives Congress (APC) chairman, Chief Stanley Okoroemegha and the former LGA chairman of the council, who is the House of Representatives candidate of APC, Barrister Eni Uduma Chima.

As a result of this, Governor David Umahi has ordered for the arrest of both of them, pending investigation into the matter.

According to the press release issued by the State Police Public Relations Officer (PPRO), SP Chris Anyanwu, the incident occurred on Monday at about 16:30hrs, when a distress call was received that sporadic shootings and killings were going on at Ekoli-Edda between Ebubeagu operatives who accompanied their boss, Chief Stanley Okoro Emegha, the State's Chief Security Consultant, and another group of men purported to be loyalists to the immediate past Council Chairman, Hon Chima Eni, who is also the APC flag-bearer for National House of Representatives in the area.

He further stated that, `Ebonyi State Police Command is presently investigating a case of murder, arson and malicious damages to government property and individuals' resulting from apparent struggle for supremacy and who controls the area politically among two notable political stalwarts in Ekoli-Edda, Afikpo South LGA of the state.

"It was gathered that the open shoot-out was not far-fetched from previous grudges existing among the two factions. In the

process, a youth leader identified as Eseni Kalu Egwu was fatally wounded, later rushed to a neighboring hospital at Ohafia, Abia State, where he was confirmed dead.

``Angered by his death, the youth of the area mobilized and went on rampage, killing Eme Orji, a younger brother of Chief Stanley Okoro Emegha and an Inspector of Police attached to the Special Protection Unit (SPU). The irate youth equally set ablaze the village house of the Security Consultant, his Toyota Hilux van and a Toyota SIENNA space bus belonging to the Police Command's Tactical Teams.

'When the Tactical Teams were despatched to Ekoli-Edda to take control of the situation, they were ambushed by the youth of the area at the village entrance. However, the operatives were unhurt.

"The bodies of the three deceased persons have been evacuated and deposited at different morgues. A total of eight suspects were arrested among the irate youth while others are still at large.

'Also, the two political gladiators at the middle of the whole imbroglio, who happen to hail from the same community, have been placed on protective custody to douse the tension in the area, while a scrupulous investigation has been activated by the Deputy Commissioner of Police in-charge of SCIID here in Ebonyi State.

Also, Governor David Nweze Umahi has directed the immediate arrest and prosecution of the State APC Chairman, Chief Stanley Emegha and Candidate for Afikpo North/Afikpo South Federal Constituency, Chief Eni Uduma Chima for their roles in the murder of three persons in Ekoli Edda.

Agbakoba Moves To Challenge Powers Of EFCC In Court

Senior Advocate of Nigeria (SAN), Dr. Olisa Agbakoba, has announced his intention to go to court to pray for a declaration on the exact scope of the powers of Economic and Financial Crimes Commission (EFCC).

Agbakoba's decision is as a result of his concern that the EFCC often exceeds its powers in the investigation and prosecution of alleged offenders of Nigeria's criminal laws.

He said that he had held a media conference to express his concerns, which he does occasionally on several national issues.

He said that he felt that the EFCC exceeded its powers in what it considers to be its public duty in the war against corruption in Nigeria.

"The EFCC issued a response stating that I was wrong to take the view that it sometimes acts outside the scope of its powers vested by the EFCC Act.

"The EFCC referred to some cases, but I would say that in a very recent decision, Dr. Joseph Nwobike SAN vs The Federal Republic of Nigeria FRN SC/CR/161/2020, the

Supreme Court drastically limited the scope of powers of the EFCC, as it recognized that the EFCC being very powerful could not be allowed to run amok.

"I am not a court. Neither is the EFCC. I will proceed to the court for a declaration on the exact scope of powers of the EFCC, especially in relation to states of the Federation. A declaration by a Judicial authority is the most valid process to authenticate if am right or wrong with respect to my position that the EFCC often acts contrary to the law.

"I am not in any way

against the EFCC on the fight against corruption. As admitted by the EFCC, I have always supported the fight against corruption.

"My concern is that the EFCC, in its undoubted statutory powers to stamp out corruption in Nigeria must strictly conform to the prescriptions of the law.

"EFCC must not in the fight against corruption, undermine the rule of law. So to the courts, I go," Agbakoba narrated, stressing that the scope of the powers of EFCC will be tested by the courts.
