

2nd Term: Remove Your Name From Rebuilt Adogba Central **Mosque Or Lose Our Votes, MURIC Warns Gov Makinde**

he Muslim Rights Concern (MURIC) on Saturday, asked Governor Seyi Makinde to immediately remove his name from the rebuilt Adogba Central Mosque, which his administration demolished in 2020, or

corporate dignity of the Muslim community of Oyo State in particular, and the entire Muslim Ummah in Nigeria", he said.

MURIC Executive Director, Prof. Ishaq Akintola in a statement, said the governor was wrong to have renamed the Adogba Central Mosque, Iwo Road, Ibadan, after himself and that the mosque's original name must be maintained.

According to MURIC, Gov Makinde has no moral right to name the mosque after himself, because it was a replacement of the original mosque which was demolished by his administration.

"Our attention has been drawn to the name of Governor Seyi Makinde of Oyo State which has been conspicuously printed on the newly rebuilt Adogba Central Mosque, Iwo Road, Ibadan. It had better not be. It is an insult on the "We demand that Makinde remove his name from that mosque. It does not belong to him. It is an attempt to rewrite history. Adogba Central Mosque was built for the Organisation of Tadomunul Muslimeen by the Saudi-based Haramain Islamic Organisation,".

The MURIC Executive Director stressed that the mosque was demolished by the Gov Makinde administration despite protests by the Muslim community, alleging that the demolition was one of Makindes's anti-Muslim actions.

"He (Makinde) threatened to pull down

he went ahead with the demolition and promised to rebuild it.

He stressed further, " the governor has rebuilt the mosque in another location but he renamed it after himself. We are shocked to our marrows. What audacity! It is desecration of our place of worship. "We cannot worship Makinde. We will worship Allah alone. It would have been right if he had not destroyed our mosque ab initio. But now we can still ask him 'Where is our mosque?' It is highly immoral. His action also lacks tact.

"Makinde can only be justified to name the mosque after himself if the money spent on its construction belonged to him personally. He needs to prove that to us but he has not. He used our common patrimony. That money belongs to the tax

"We say capital 'NO' to 'Makinde Central Mosque'. It is a rogue nomenclature. Our mosque is 'Adogba Central Mosque.' Engr Seyi Makinde has no mosque. "Apart from the immoral angle, the governor has exhibited ulterior motive. Even the timing of the completion of the mosque was calculated to coincide with the 2023 electioneering period. Seyi Makinde has played on the intelligence of the Oyo State Muslim community.

"Unfortunately the governor does not know that the Muslims are not pleased with his action. The best advice we can give him at this point is to remove his name from the mosque and replace it with the original name of the mosque which he destroyed, viz, Adogba Central Mosque," Akintola said.

Kaduna PDP Requests Release Of Arrested Members

h e Peoples' Democratic Party (PDP) in Kaduna State, has strongly condemned and rejected what it termed the blatant abuse of power used by the state All Progressives Congress (APC)-led government, saying the harassment is because the APC-led government in the state is staring defeat in the coming elections.

While addressing newsmen during a press conference on Thursday at the Kaduna PDP secretariat, the state Chairman, Hon. Hassan Hyet said that as a matter of urgency in view of the act of deliberate harassment and intimidation that PDP members are experiencing in the state, they find it necessary to hold a press conference.

He added that, it is compulsory for them to draw the attention of Nigerians and the international community to the undemocratic acts of harassment against PDP members in state, as the APC-led government would be held responsible if anything happens to their members currently in detention.

According to the state Chairman, the Assistant Campaign Director in charge of their broadcast department, Hon Saidu Adamu, has only been released on bail after being arrested by the DSS since March 7, 2023, while two other members, Talib Mohammed Lawal and El-Abbas Mohammed have been arrested and currently in detention. He said, "we have it on good authority that directives have been given by the state Governor, Malam Nasir el-Rufa'i to security agencies in the state to arrest members of the PDP campaign management team. Already trumped up cases have been prepared for each of the members.

"We recall that on 30/01/2023, we had cause to write a petition to the Commissioner of Police when 14 of our members were randomly arrested in Kudan Local Government Area. We wrote another petition on 01/03/2023 asking the Police to be mindful of plans by the APC to incite the public through the use of some Islamic clerics.

"We ask for either the immediate release of those arrested, or charged to a competent court so that the needed legal process can start. Doing otherwise would amount to an infringement of their fundamental human rights and a clear misuse of state power," Hyat said.

Meanwhile, the Kaduna State Chairman requested the security agencies in the state to stay neutral in all the electoral processes, as that would help the state to stay peaceful before and after the March 18 Gubernatorial and state Assembly Elections.

"Information reaching us is that the APC Government in Kaduna



State has drawn up lists of people to be picked in various local government areas in order to cripple the PDP. This is very unbecoming of an elected governor who is on oath to be fair to all.

"The desperation of the serving APC governor and its gubernatorial candidate is such that they are moving from one local government to another, threatening the remaining traditional/ward heads and civil servant with dismissal should they fail to deliver their polling units to APC," he alleged.n Meanwhile, Hon. Hyat called on EFCC and other anti-corruption agencies, security agencies alike to take the necessary action by arresting trailer loads of rice, noodles, spices, etc being sent to various local government areas in the state to influence the poor voters.

"This is pure vote buying which is against the law. APC government in Kaduna State has never donated items either during Sallah, Ramadan fasting, Christmas or Easter to the masses of Kaduna State, why now?

"We call on the good people of Kaduna State to remain resolute and focused. Do not sell your future and the future of our children and the unborn for a morsel that will not last more than a day. The time to chase out this satanic regime is now. PDP is the solution," he said.

Hon. Hassan Hyat urged the state party members, well-wishers and the public to remain calm and law abiding, hence, these are several acts of calculated harassment that the APC government has initiated against their members.

Be Non-Partisan To Ensure Credible March 18 Polls In Akwa Ibom, Rights Group Urges INEC

By; PATRICK TITUS, Uyo he Independent National Electoral Commission (INEC) in Akwa Ibom State has come under scrutiny of alleged complicity in electoral fraud, with rights g r o u p u r g i n g t h e Commission to be neutral and non-partisan in the Governorship and State House of Assembly polls billed for March 18, 2023. Speaking to journalists in

Uyo on Sunday, the Akwa Ibom State Director of Center For Human Rights & Accountability Network (CHRAN), Otuekong Franklyn Isong said that, to sustain the existing peace enjoyed in the state, INEC must ensure neutrality, and guarantee free, fair and credible March 18 polls.

He said that the call become necessary going by what the group witnessed in the state d u r i n g the Feb 25 Presidential and National Assembly elections.

CHRAN State Director, who, in collaboration with other Civil Society Groups, Professional Bodies and Trade Unions in Akwa Ibom, also hinted of a plots by some politicians in the state to i m p or t th u g s fro m neighbouring states to mar the March 18 elections to favour a particular political party and its candidates.

To avert violence before and during the March 18 election in the state, the Rights Group called on security agencies in the state to be on alert especially around the riverine areas and border communities in the state.

"Going by our observations in the Presidential and National Assembly Elections, the INEC was culpable and complicit in the electoral fraud and malpractices witnessed in the elections. INEC was a contestant instead of being a non-partisan electoral umpire. INEC provided the platform for the politicians who carried out rigging in large scale and electoral fraud in the polls. "We wish to call on the INEC in Akwa Ibom State to be neutral and non-partisan in the Governorship and State House of Assembly polls billed for 28th March, 2023. "Worrisome to us, is the fact that our intelligence network, however, reveals that some politicians in Akwa Ibom State are perfecting plots to import

political thugs, as well as real and/or fake security personnel from neighboring states, particularly, Rivers, Abia and Bayelsa into Akwa Ibom State with the intention to subvert the votes and wishes of Akwa Ibom people during the Governorship and State House of Assembly Elections billed for Saturday, 18th March, 2023.

"We hereby call on the Nigeria Police and other law enforcement agencies to be on alert, and rise to the occasion of ensuring that the State remains peaceful while Akwa Ibom people go out en masse to elect the Governor and State House of Assembly Members of their choice come Saturday, 18th March, 2023.

"We urge the security agencies in the State to pay serious attention to our riverine and bordering communities before, during and after the elections.

Urging the politicians on the state not to see election as a do-or-die battle, Isong said, "We appeal to the political class, particularly, the governorship candidates and their supporters not to approach the forthcoming elections with the "do-ordie" spirit, but with the spirit of sportsmanship.

"No political office is worth the blood of any Akwa Ibomites. At the end of the elections, only one person will occupy the Office of the Governor of Akwa Ibom State and Akwa Ibom people will be the winners." Isong added.

Recall during the Feb 25 Presidential and National Assembly elections, CHRAN whose civic responsibility is to deepen democracy in Nigeria nay Akwa Ibom State, had mobilized its members across the State as observers Some members of CHRAN joined sister and partnering civil society groups to monitor the election around the entire 31 local government areas of Akwa Ibom State. The CHRAN also set up a Situation Room at its office in Uyo, where reports were received through a toll-free line and its social media platforms. In most cases, observer reports were accompanied with photographs and video clips. The State Director, Otuekong Isong told journalists.

Four Injured As Suspected Thugs Attack LP Campaign Convoy In Southern Kaduna

he Labour Party governorship campaign convoy of Hon Jonathan Asake in Kaduna State was attacked by thugs on Friday in Gidan Waya, Jema'a Local Government Area of Kaduna State.

A statement issued by James Swam, Media Aide to Jonathan Asake said, "Four youth were injured in the process, including two boys and two girls while no vehicle was damaged." The incident happened



when the campaign convoy was passing through Gidan Waya during Friday prayers on its way to Godogodo and other towns as the campaign team toured the local government. After the first three vehicles in the convoy made their way through the old tyres used to demarcate the road, thugs started throwing stones, big sticks and other harmful objects at the long convoy. It took the timely intervention

Group Appeals To TinubuTo Consider Loyalty, **Competence In Forming Cabinet**

The Tinubu Presidential Campaign Shettima Diaspora Network (TSDN), an All Progressives Congress (APC) support group has appealed to Sen. Bola Tinubu, the President-elect to consider loyalty, commitment and competence in selecting those that will form his cabinet.

Dr Uche Paul Ogbonnaya, the group's Director-General made the appeal in an interview with newsmen in Abuja yesterday.

He noted that there were great Nigerian brains in the Diaspora within the APC, willing to come back to the country to contribute to its development if given the opportunity.

He, therefore, advised that loyalty and dedicated party members within and outside the country should be considered in every political appointment because they had worked for the party and the country generally.

"Professionally, Omole is a United Kingdom Defence Ministry NSVcertified Senior Consultant with over 30 years of experience in the International Project Management Industry. "Having Omole as the country's next Foreign Affairs Minister will be having a round peg in a round hole.

"Recognised as one of Nigeria's Diaspora Icons by the Nigerians in Diaspora Commission (NiDCOM) in 2022, Omole is grounded in crisis management and in delivering value-based programmes.

"He is professionally and educationally qualified with a distinction Masters' Degree in Law specialising in conflict resolution and a Masters' degree in IT to serve as Foreign Affairs Minister," Ogbonnaya said.

He added that with a chain of other degrees and certifications, Omole had been involved in leading

assignments, international transition projects and public sector-focused projects.

Ogbonnaya noted that ahead of the Feb. 25, presidential election, Omole travelled the world to campaign for Sen. Bola Tinubu, the presidentelect, because of his excellent relationship with the international community.

He added that being a worthy ambassador for Nigeria over the years in the Diaspora, Omole liaised with Members of Parliament and congresspersons across the board and had a good rapport with Nigerians abroad.

Tragedy: Youth Protest As Councilor Is Burnt To Death In His Car In Ebonyi

By; MKPUMA **ENYINNA**, Abakaliki here is political tension in Okposi Achara Community as gunmen shot a ward councilor and set him ablaze with his car around 11:00pm on Saturday.

The youth in the area went on rampage to protest the killing yesterday.

A close source in the area, explained that the councilor whose name was given as Ugwu Ogbonnaya (AKA SPACO) was murdered at Okposi Court area and was set ablaze in his car by unidentified gunmen on Saturday night, while returning from his shop, a drinking joint in Okposi. Reacting to the incident, the Chairman of Ohaozara Local Government Area, Hon.Chinonso Ajah, condemned the gruesome murder of the ward councilor, saying that he will deploy every legitimate means to unravel those behind the killing and ensure they are brought to book.

He described the late councilor as a peaceful and easy going person who does not associate with any form of violence, stating that no political ambition worth the blood of an innocent citizen.

``I condemn in its entirety the Murder of my dependable Councilor and will deploy every legitimate means to unravel the hands behind this mayhem in my local government and ensure they are brought to book.

"No form of contest of any sort or nature is worth the blood of Innocent citizens of our land. Our land forbids it and that has been the protective sage for our people right from the ancient times.

``We know Hon Ogbonnaya Ugwu (SPACO) to be easy going, soft spoken and accommodating as he barely would be associated with any form of violence. These traits of his makes it more painful to know he was gruesomely murdered by unknown faces.`

Also, when contacted for her reaction, the Police Public Relations Officer (PPRO) in Ebonyi State, M r s O n o m e Onovewakpoyeya who confirmed the incident, said that it happened around 11:00pm on Saturday night, adding that investigation is ongoing to unravel those behind the crime.

``For now we can't say who is responsible, but we got news of the death and investigation is ongoing. It happened yesterday at after 11pm, but was reported this morning," she said.

Ungwan Wakili that led to the Fulani man being shot alongside one police officer. According to him, "The situation later escalated in the evening, when a group of youth went for fishing and were attacked as one person was butchered to death by suspected terrorists."

According to him, the situation has been brought under control with the presence of security personnel in the area. Meanwhile, a 24-hour curfew has been imposed on four communities by the Zangon Kataf Local Government Council chairman, Francis Sani, with the sole aim of preventing further breakdown of law and order in the area.

A statement by Special Assistant (Media) to the Executive Chairman, Yabo Chris Ephraim on Saturday's night said, "A 24hour curfew has been imposed on Ungwan Juju, Mabuhu, Ungwan Wakili and Zangon Urban with immediate effect. This is to allow men of the Nigerian Army to restore peace on that axis.

Confirming the incident on phone to our correspondent, Police Public Relations Officer (PPRO), DSP Muhammed Jalige said that security forces are on top of the situation.

He explained that from the briefing he received from the Area Commander, trouble started a couple of days ago, when a boy rearing cattle was murdered.

"We have been trying to manage the situation while investigating the sad occurrence before trouble broke out," he said.

On the number of casualties recorded, DSP Jalige said that a joint security team will be combing the bushes in the area Sunday afternoon to search for bodies, if any, as well as apprehend the suspects that were responsible for the killings. "We are on top of the situation and all the hoodlums responsible would be rounded up," he assured. According to him, but for the timely intervention of joint security personnel coordinated by the Area Commander, the terrorists would have had a field day. "Repelling the hoodlums was a tedious task for our security agencies, but they were successful as the terrorists

scampered away from the scene," he said.

NSCDC Apprehends 9 Suspected Fake Currency Syndicates, Recovers Large Sum Of Dollars, Naira Notes

t least, nine s u s p e c t e d notorious fake currency syndicates have b e e n arrested by operatives of the Nigeria Security and Civil Defence Corps (NSCDC) over alleged possession of fake dollars and naira notes.

The suspects were said to have been arrested during two separate operations in Nasarawa and Plateau states, following credible intelligence by operatives a t t a c h e d t o t h e Commandant General's Special Intelligence Squad.

A large sum of both fake dollars and naira notes were said to have been recovered from the suspects.

The Director of Public Relations if the Corps Olusola Odumosu in a statement said all the suspects are assisting the agency to further its investigation.

While giving a breakdown of the arrest, he said, ' Acting on credible Intelligence, the Commandant General of the Nigeria Security and Civil Defence Corps' Special Intelligence Squad (CG's SIS) in a clandestine operations, arrested two syndicates alleged to be involved in offences ranging from criminal conspiracy, cheating, obtaining by trick (OBT) and production/distribution of counterfeited US Dollars (USD) and new Naira notes into the society.

" One of the groups arrested which consisted of four male adults were caught in possession of fake sixty-four thousand, eight hundred US dollars (\$64,800) and four hundred and seventy-five thousand naira (N475,000) notes, while fake notes of N1.5m was also seized from the second group consisting of five male adults. " The names of members of the syndicate arrested with the sum of N1.5m are ; Dantala Omale, 'M', 30yrs, Plateau State, Musa Abdullahi, 'M' 24yrs, Plateau state, Audu Abdulazeez, 'M', 56yrs, Gombe State, Umar Hassan 'M', 46yrs, plateau state and Mahammadu



Badaru Yakubu 'M' 30yrs, Nasarawa State.

" The arrest was effected when one Dantala Omale was lured to Nasarawa from Plateau state and picked up by the squad on the 22nd of February, 2023, with fake new naira notes of N412,000.

" The arrested suspect confessed getting the fake notes from Musa Abdullahi, AKA Baballe which led to the arrest of Abdullahi on 22nd of February, 2023 at Namu area of Quanpan LGA in Plateau state in possession of N49,650 old naira notes.

' After a thorough interrogation, Abdullahi confessed that he usually gets his supply of fake currencies from one Audu Abdulazeez, AKA Dan-Gombe, who the squad arrested on the 3rd of March 2023, at Plateau Express service motor park in Jos, Plateau State, at about 11:20 a.m with N350,000 fake newly redesigned Naira notes. " The effort of the squad to arrest all members of the syndicate paid off when Abdulazeez confessed to giving one Umar Hassan the fake notes. When Hassan was apprehended, he was in possession of N20,500 and he also confessed to his involvement in the crime and that he regularly transact with one Mohammadu Badaru Yakubu, who was also arrested close to the old CBN office in lafia town, at about 3:10 p.m on

March 5, 2023 with fake N2000 of the new Naira notes.

" Further investigation however, revealed that the group operated within and a r o u n d Plateau, Nasarawa, Bauchi & Gombe states.

" Members of the second syndicate arrested with the exhibits of \$64,800 and N475,000 are; Jonathan Dakogol, Abbas Ibrahim, Isa Ukashatu and Aminu Isa.

" Isa Ukashatu and Jonathan Dakogol were arrested with fake \$64,800 and N475,000 at Akurba of Lafia LGA, in Nasarawa State after being lured to deliver the money to a client.

" Upon arrest, Dakogol volunteered and led the CG'S SIS operatives to Kurgwi area in Quaan'Pan LGA, Plateau State, where one Aminu Isa who was alleged to be a herbalist was also arrested.

OFR, commended the CG's SIS for a job well done and described the criminal gangs as economic saboteurs destroying the country through the perpetration of financial crimes and defrauding of innocent citizens.

"He stated that their arrest is a good omen for the country because it helped to stop the distribution and influx of fake currencies into society which could have caused great

setbacks to the economy. " He charged the squad leader, DCC Appollos Dandaura, and his team to intensify efforts for more arrests by launching their dragnet further into every nook and cranny of the country in order to fish out other dangerous criminal elements and syndicates perpetrating heinous financial crimes at the detriment of the nation.

" He warned all criminal syndicates to desist from this venture and get other legitimate means of survival or face the wrath of the law because NSCDC and other security agencies will fish them out no matter their hiding places. "The arrested suspects are still assisting the Corps with useful information for further investigation and would be handed over to the appropriate authority for prosecution after the preliminary investigation is concluded. Meanwhile, a manhunt has been launched for other fleeing members of the syndicates".

Two PDP Chieftains Bag 3 Years Jail Over N142m Election Bribe Scam

Two Chieftains of the opposition Peoples Democratic Party (PDP), in Bauchi State.have been sentenced to three years imprisonment for offences that bordered on conspiracy and money laundering to the tune of N142, 460,000.00 (one hundred and forty two million, four hundred and sixty thousand naira).

The duo, named Saleh Hussaini Gamawa and Aminu Umar Gadiya were convicted by a Federal High Court presided over by Justice Hassan Dikko, on March 2, while ruling on the two count charge brought against the defendants by the Economic and Financial Crimes Commission (EFCC).

The Head, Media & Publicity of the Commission Wilson Uwujaren made the disclosure in a statement made available to journalists on Saturday.

According to Uwujaren, " The defendants were first arraigned on June 4, 2018 and re-arraigned on October 16, 2018 on a two count charge for allegedly receiving over N142million to influence the outcome of the 2015 presidential elections in Bauchi State.

"Count one of the charge reads, "That you, Saleh Hussaini Gamawa and Aminu Umar Gadiya, all members of the Finance and Funds Disbursement Committee of the Peoples' Democratic Party (PDP) 2015 General Elections, and in such capacities sometimes in March, 2015 in Bauchi State within the jurisdiction of this Honorable Court did agree amongst yourselves to commit an offence, to wit; Conspiracy to accept cash payment exceeding the threshold provided by law, thereby committed an offence contrary to Section 18(a)

and punishable under Section 16(2) (b) of the Money Laundering (Prohibition) Act, 2012(as amended) now No.1, 2012".

"Count two reads, "That you, Sale Hussaini Gamawa and Aminu Umar Gadiya, all members of the of the Finance and Funds Disbursement Committee of the peoples 'Democratic Party (PDP) 2015 General Elections, and in such capacities sometimes in March, 2015 in Bauchi State within the jurisdiction of this Honourabe Court did accept cash payment of N142,460,000.00 (One Hundred and Forty Two Million, Four Hundred and Sixty Thousand Naira) from the Directorate of Finance, Bauchi State PDP Campaign Organization exceeding the required threshold of cash payment, thereby committed an offence contrary to Section 1, 16(1)(d) and punishable under Section 16(2)(b) of the Money Laundering (Prohibition)Act, 2011 (as amended) now No.1, 2012"

"The defendants had pleaded not guilty to the charges, setting the stage for the case to proceed to full trial. In the course of trial, the prosecution presented one witness and tendered documents marked as Exhibits A1, A2 and A3. Both defendants testified in their respective defence.

"At the close of evidence, the final written addresses were filed, exchanged and adopted on January 17, 2023, with the prosecution asking the court to convict the defendants as charged. The defence, on the other hand, submitted that the evidence presented against the defendant by the prosecution was not credible and urged the court to discharge and acquit the defendants. Justice Dikko then reserved judgment for March 2, 2023.

that lasted more than three hours,

Justice Dikko reviewed the facts of the case and the submissions of counsel and arrived at the conclusion that the prosecution proved the cases against the defendants beyond reasonable doubt on count one and convicted them as charged. He however discharged and acquitted the 2nd defendant on count two".

According to justice Dikko, "the fact that the defendants in this instant case endorsed exhibit A1, A2 and A3 to receive cash to the tune of N142,460,,000.00, well in excess of the legal threshold designated by law, there can be no other conclusion but that the defendants conspired to so commit the offence and I am satisfied beyond reasonable doubt. It is rather astonishing that in the defence of the count, the defendants completely disregarded the damaging evidence of exhibits A1 A2 and A3 kying right before

A1,A2,and A3, lying right before the Court. I therefore find the 1st and 2nd defendants guilty of conspiracy as charged in court one and are accordingly convicted".

On Count two, he said, "I have relied almost entirely on Exhibits A1, A2 and A3, and a close scrutiny of the Exhibits demonstrates that the 1st defendant, Saleh Hussaini G a m a w a received N105, 840,000.00 in Exhibit A1, N27, 650,000.00 in Exhibit A2 and N8, 970,000.00 in Exhibit A3, summing up to N142,460,000.00, all in the presence of, or witnessed by the 2nd defendant Aminu Umar Gadiya.

The content of these documents leaves no one in doubt as to who received the money, that is Saleh Hussaini Gamawa (1st defendant) who is a natural person from the Bauchi State PDP Campaign Organization (Director of Finance) which is not a designated financial

institution, and for the purpose of payment to participants during the National and Presidential Elections. "The offence under Section 1 of the Money Laundering (Prohibition) Act, 2012 is one of strict liability. The fact of the payment or receipt of cash in excess of the threshold alone is sufficient to ground a conviction as can be noticed in the exhibits before this court and again, I am satisfied beyond reasonable doubt. Consequently, I find the 1srt defendant guilty of the count and is accordingly convicted. The 2nd defendant is hereby discharged and acquitted on this count"".

In his allocutus, the 1st defendant urged the court to be lenient and temper justice with mercy.

"I have a large family which includes the family of my elder brother who turned blind and cannot fend for his family; they look up to me for sustenance, since the beginning of this case neither the political party nor the Government came to my rescue, thus I urge the court to forgive me", he stated. The 2nd defendant also pleaded for leniency, arguing that he is a retiree and had not benefited from the money.

Before sentencing the defendants, Justice Dikko acknowledged their pleas for leniency but insisted that they must be punished to serve as deterrent to others.

"I consider your pleas that you have family who will suffer in your absence thus I will be lenient, however your offences must be punished appropriately to deter others in the society from perpetrating same."

He consequently sentenced the 1st and 2nd defendants to 2years imprisonment at the Bauchi Correction Service or a fine of N3,000,000.00 each in lieu of imprisonment on count one; while the 1st defendant bagged a further 2years imprisonment or a fine of N3,000,000.00 in lieu of imprisonment on count two.

Oyo Guber Polls: Gang Up Mounts Against Gov Makinde, PDP

ith less than a week to the March 18 governorship polls, there are strong indications of possible coalition of political parties against the incumbent governor, Engineer Seyi Makinde's reelection bid in Oyo State.

New Nigerian investigations revealed that as at present, top politicians in the state with some political parties are now busy fine tunning a repeat of the 2019 coalition of parties which produced Governor Sevi Makinde in the last election. In one of the recent moves, a former governor of the state and the Osi Olubadan of Ibadaland, Senator Rashidi Ladoja while addressing Oyo State PDP chieftains including a former deputy governor in the state, Alhaji Azeem Gbolarumi in his Ondo Street, Bodija residence hinted of the fresh coalition against the ruling administration in the state. The former governor said that as at present, the Social Democratic Party. Labour Party are into the coalition while other political parties in the state have signified their intentions to join in the coalition.

PDP National Assembly candidates in the February 25th elections to the alleged posture of Gov Makinde towards the election stressed that in the next few days to the governorship election, the coalition will be firmly on ground.

High Chief Ladoja at the forum cited the example of Governor Ademola Adeleke of

addressing members the party said there is the need for coalition of political parties to correct the wrongs in the state and that in line with this, SDP has agreed to a coalition with the APC and its candidate in Oyo state.

"We believe that to right these wrongs, there is need for us to form a virile coalition with a party that can dislodge this administration that has shown itself to be lacking in development. That is why, after many meetings with major stakeholders even outside of our party, we arrived at Sen. Teslim Folarin of the All Progressives Congress, APC", he said. former Minister The emphasized that despite the differences that may exist between individual PDP members, the overall survival of the PDP and electoral victory of its candidates in the March 18 election should be paramount for now.

He maintained that all PDP leaders in Oyo State should ensure that they deliver their respective mapped out by various wards and Local government areas to the PDP, saying, his relationship with the PDP, "is like that of a nursing mother to her child and that it would be wrong for him to work against a party he helped to nurture to maturity in Oyo state". Elder Oyelese said, "as a true party man and one of the founding fathers of PDP in Oyo State, it is not in his character to pull down a house he has helped in building," and that he fully understands the implications of such an action of working against ones political party.

Supreme Court Affirms Lawal As Zamfara PDP Governorship Candidate

he Supreme Court has affirmed Dauda Lawal as the authentic governorship candidate of the Peoples Democratic Party (PDP) in Zamfara State.

Lawal's affirmation is coming over a week to the March 18 governorship election scheduled by the Independent National Electoral Commission (INEC) in the state.

In a unanimous judgment, the five-man panel of Justices dismissed an appeal brought against the

nomination by another Lawal had in the primary governorship aspirant, Dr Ibrahim Gusau.

In the lead judgment delivered by Justice Adamu Jauro, the Supreme Court upheld submissions of the Counsel to Lawal, Damian Dodo, that his client was legally and lawfully nominated in line with the provisions of the law.

Justice Jauro upheld the judgment of the Court of Appeal Sokoto, which had on January 6, this year, endorsed the second primary election that produced the candidate.

election polled 442 votes to emerge victorious over Dr Ibrahim Gusau and Other aspirants.

Justice Jauro held that a Federal High Court in Gusau which nullified the primary elections twice had no jurisdiction at the time it adjudicated upon the suit instituted by Dr Gusau.

The Court of Appeal Sokoto Division had in June 6 upheld the primary election which produced Dr. Dauda Lawal, as the candidate of the Peoples Democratic Party (PDP) for the March 11, 2023, governorship election in Zamfara State.

The first PDP governorship primary election held on May 25, 2022, was challenged at a Federal High Court in Gusau and was nullified.

The High Court in its judgment ordered for fresh primary election which was conducted on September 23, 2022, but was also quashed by the same court for irregularities.

Not satisfied with the High Court decision, Dr. Dauda Lawal Dare, Adamu Maina-Waziri, the Chairman Primary

in the state that their candidates were endorsed by some clerics. According to him, "I think you are aware of a letter by the Kaduna State's Christian Association of Nigeria's chairman, which endorsed the PDP governorship candidate. 

Drama As ADP Suspends Kaduna Guber Candidate, Sani Sha'aban Indefinitely

The leadership of Action Democratic Party (ADP), Kaduna State chapter has s u s p e n d e d i t s gubernatorial candidate, Alhaji Sani Sha'aban over an alleged antiparty activity.

Acting Chairman, Kaduna ADP, Alhaji Umar Isah who made this known during a press conference held in Kaduna on Friday, said the party lost confidence in him, since the day he chose to campaign against its presidential candidate.

Umar said, "It may, however, interest you to note that since the emergence of Hon. Sani Mahmud Sha'aban, the party assumed it has found a worthy candidate to fly its flag, the gubernatorial candidate constituted a campaign team and we assumed that it was the beginning of seriousness to contest for the gubernatorial seat in Kaduna.

"Since, this earlier development as stated above, Hon. Sani Sha'aban has not been forthcoming with his dealings with the party and members of his campaign team. He has not kept to agreed arrangements that were put in place to galvanize the campaign activities in the state for the ADP and the gubernatorial candidate.

"His disregard for the party and the campaign team he constituted, has created division in the party, forcing prominent members and elders to either abandon the ADP or adopt nonchalant attitude, which is causing the party dearly of its support gained within the short while. It is unfortunate that few months to the general elections, the party has remained virtually invisible at a time of heightened campaign and mobilization of voters. "This most unfortunate situation is caused by the disinterested and nonchalant attitude of Sani Shaaban, who has

shown utter disregard to the party's Leaders and due process. T h e invitation a n d subsequent disinvitatio n from the **BBC** Hausa debate was an eye opener and raised alarm for the party, which led to the party further investigatin g

f urther investigatin g and checking with INEC on the status of uploading Hon. Sani Shaaban's name

on their portal. "Efforts to follow up and

ensure that his name is uploaded on the INEC portal did not yield positive results, we have not been able to ascertain the status of his candidature.

"The candidate alone, knows why he keeps saying he is running for the gubernatorial seat, knowing fully well that his name is not on the portal and keeps organizing little campaign gathering, but all is a hoax, the party and campaign team has been following him, but to the party's dismay he has continued to undermine the party and his campaign team.

"We therefore, found ourselves in very difficult situation, such that up to now, we have been unable to commence serious campaigns due to lack of seriousness, preparedness and commitment on his part. "INEC handed the agent tags for both presidential and gubernatorial elections to me as the state chairman, of which I released the tags for Zone 1 to Hon. Sani Shaaban to distribute and cater for the agents but to my dismay after the elections, the agents held on to the tags, saying they have not been paid by the gubernatorial



candidate, fortunately I still have in my possession the Zone 2 and 3 tags, which he keeps insisting I hand over to him, but with the way he handled the agents and the tags for Zone 1, I did not release the tags to him for which he has orchestrated this turn of events.

"To my surprise, I was told sometime yesterday from unconfirmed reports that I have been suspended, as at the time of this press release, I have not been served any letter by the National Party, but a copy has been given to the gubernatorial candidate which he and his people have been circulating on the social media. I know the national chairman to be an experienced party man, a man of due process who stood for the just concluded Presidential elections 2023. "There is a due process for suspension or removal of a state chairman according to the party's constitution and it must be a decision of the National Working Committee subject to ratification by the National Executive Committee. It is doubtful if this due process was followed. Gentlemen of the press above are some of the happenings with others which for want of time cannot be exhausted in one press conference,

which has led to the decision by some of the exco here to clarify what is in the media space.

"I therefore, wish to inform members of the party, the public, all our supporters and associates that the Party hereby suspends Hon. Sani Shaaban from the party indefinitely and he should forthwith desist from parading himself as the gubernatorial candidate of the ADP. Thank you all and may Allah bless us all," he said.

The chairman clarified that Sha'aban was made to be the replacement of former party candidate, Yusuf Jibrin and his running mate, John Solomon, but all efforts to upload his name on INEC portal proved abortive, adding that they are going to be on the ballot, come March 18, 2023 with the original candidates on the portal. It would be recalled that Sha'aban, a gubernatorial aspirant of the ruling All Progressives Congress (APC) and son-in-law to president Muhammadu Buhari, resigned his APC membership in Nov. 28, 2022 after the Federal high court sitting in Kaduna, said it lacked jurisdiction to entertain his case filed against the gubernatorial candidate of

APC, Senator Uba Sani.

How CG Isah Idris Jere Helped In Conduct **Of Free, Fair, Violence Free Election**

In recent times, the Nigerian Immigration Service under the current Comptroller General, Isah Idris Jere, has taken a turn for the better.

The paramilitary organization has become more efficient, dedicated, and professional in its approach to national issues, especially in the run-up to the 2023 general election in the country.

One particular aspect in which in which Nigeria Immigration Service (NIS) excelled was in curbing the menace that foreigners would have poised to the country during and after election.

Before the coming of the new Comptroller General, Isah Idris Jere, Nigeria was known for numerous cases of foreigners participating in the electoral processes and also involvement in post election violence. These were the cases in the 2011 and 2015 Presidential polls.

However, on assumption of office, the Immigration boss gave directives that each state commands must ensure that all illegal aliens should be fished out while those that posed security threats to the nation's democratic processes be given particular emphasis.

The Comptroller General did not give directives alone, but committed resources, his integrity and personal efforts and it paid off.

Similarly, in order to reduce the incessant cases of foreigners interfering in Nigeria's election, the NIS arrested 516 non-Nigerians in Zaria LGA of Kaduna State in the month of February.

Francisca Dakat, explained that out of the 303 apprehended, 285 were adults and 18 were minors.

According to her, the mop-up exercise was in line with the service directives that non-Nigerians should not partake in the forthcoming general elections.

Government Area of Ogun State, South West Nigeria. The NIS on Saturday paraded the immigrants at its office in Abeokuta, the state capital.

Speaking at the event, the state controller of immigration, Jibrin Yakubu, said the immigrants have no valid travel documents or means of

down acceptable ECOWAS protocol and United Nation rules of engagement and respect to Human rights.

He said the operation however led to the proper documentations of illegal migrants and migrants in the state with 89 expired travelled documents renewed by the arrested illegal migrants," the other illegal immigrants have been guaranteed by their home countries of quick documentations. And the data base of the NIS is more robust from the operation." Result of the directives and action from CG Isa Idris Jere has led to the noticeable absence of cases of foreigners in Nigeria's polling booths in the March 25 Presidential and Parliamentary poll. Secondly, there haven't been any case of foreigners caught in the act of violence during the polls as well.

Shortly before the election, in order to prevent aliens from interfering in the country's electoral process, the Nigeria Immigration Service under Jere seized 6,216 permanent voter and national identity cards from migrants in 21 border states nationwide.

Sources said that 2,393 voter cards and 3,823 National Identity cards were seized from persons believed to be in unlawful possession of the documents.

The states where the items were seized include Adamawa, Akwa Ibom, Bauchi, Edo, Liman Kila, Kaduna NIS comptroller, said the illegal immigrants were from Niger Republic, Togo, Senegal, Cameroon, and Chad.

Days later, the Command struck again with the massive arrest of about one thousand illegal migrants in the same state.

Previously, a sting operation netted over 303 illegal migrants in Uyo and Akwa Ibom.

The Comptroller of Immigration Service, Akwa Ibom State Command, Mrs.

Dakat stressed that before the

exercise, the command had carried out a sensitization workshop for all non-Nigerians resident in the state.

She commended the Comptroller General of NIS, the State Government, and other security agencies for their support to ensure the success of the mop-up exercise.

Not done with the general cleanup of illegal aliens in the Northwest and South South of the country, the Service (NIS) also arrested and paraded 32 Chadians and one Togolese in their hideouts in Odeda Local

livelihood.

The controller, who described the immigrants as a security threat to the country, said they were arrested when officers stormed two of their hideouts in the local government area of the state.

In Bayelsa, CG Isah Idris Jere sanctioned Operation Saukan Shahu or the Eagle Has Landed which led to the arrest of 44 Nigeriens, 35 togolese, 20 Beninese and 6 Ghanaians. Sunday James, the state NIS Comptroller, while addressing newsmen in his office in Yenagoa, declared that the operations followed the laid

Nigeria: Divided In Flesh, United In Spirit

his was first published on 20/08/2018, but it is still relevant, more so now that the presidential election held on 25/02/2023 has exposed our weaknesses.

Outsiders, especially foreigners and Nigerians in Diaspora, may think that the bubble could burst any time soon and Nigeria could go to war with itself. They may well be forgiven for thinking so, especially if social media is their only means of gauging what obtains in Nigeria.

In the Nigerian social media space, battles are fought 24/7. Politically, those who stand with President Muhammadu Buhari are at daggers drawn with those who think the apostle of "change" should be changed. Those who want Buhari to give way are also rooting for their various heroes. Muslims and Christians do not see eyeball to eyeball while at the same time contending with intrareligious quarrels.

In that 'war front', the three major ethnic groups are battling one another and the minor tribes are fighting everyone. The citizenry sees the security agents as enemies; the security agents view everyone with suspicion. Even traders see their customers as awuf seekers; conversely, the customer sees the trader as a fleece.

Politicians see the electorate as one who seeks to take advantage of his sheepish following, but the ordinary man looks at the politician as one who has monopolised his rights. Even the husband views his wife as one who noses into his affairs and the wife always suspects the husband of hiding things from her.

The employee is full of envy for his oga who "eats" from his sweat, even if it is the oga who sweated to buy the Keke NAPEP; the oga suspects his employee is keeping what should have come to him to buy the new cloth he saw on his back.

This mutual suspicion ranges from the harmless and hilarious to the most dangerous in which insults and curses are hurled back and forth and even the gods are invited to release their wrath to deal with "enemies". Religious and tribal stereotyping to the outright request for Armageddon to fall on Nigeria is what one normally encounters on social media. There is a total lack of respect and decorum. But do all these reflect what we, Nigerians, truly are, think or wish for one another? No, not all. We are among the most desirous of peace and development among the nations of the world. Most Nigerians are miffed that we are where we are despite the abundance of human and natural resources the God of creation has blessed

us with.

Nigerians know that many countries of the world have taken, borrowed our resources or copied our templates and are now miles ahead of us. Many of our sons and daughters have gone to foreign lands and excelled. For instance, the designer of many models of Ford vehicles we cruise in is a Nigerian. The developer of GSM's 3G and 4G is a Nigerian. Nigerians have discovered or improved on theorems and theories in foreign lands. Nigerians have broken records in foreign schools and have achieved great breakthroughs in medicine, engineering, architecture, etc.

Nigerians are proud of these beacons of light and hope, not minding their tribes or religions, but they at the same time cry, "Why can't we do it here?"

While giving vent to their frustrations over Nigeria's seeming lack of direction, those with little control over their emotions can invariably descend to gutter language. For others, it is due to low intelligence. Such persons are not able to think up ideas that would bring solutions. For them, it has to be rofo rofo at the expense of truth. However, by and large, Nigerians love one another and rejoice with one another in happiness and sympathise with one another in sadness. I was impressed by the volume of sincere, heart-touching condolences that poured my way on social media when I lost my wife in March this year. This means that while issues of national pride, such as sports and academic achievements, unite us as one, politics, religion and ethnicity are what push us to reach for each other's jugular.

The challenge before us as a nation, especially our leaders who use them to promote their interests, is to divorce them from our governments.

Elections with Guns to the Head: Reversing Judiciary-Induced Democratic Regression

Y big story this week is that the Independent National Electoral Commission (INEC) has reversed itself, saying that there is no winner in the February 25 National Assembly elections in Doguwa and Tudun Wada federal constituency of Kano State. It would be recalled that INEC had earlier announced Hon. Alhassan Doguwa, incumbent Member representing the federal constituency and Majority Leader of the House of Representatives, who contested on the All Progressives Congress (APC) platform, as winner of the election. After reviewing the facts of the matter, INEC on Tuesday, removed Doguwa's name from the list of Reps-elect, attributing the development to irregularities in the electoral exercise. The commission had said he was declared winner of the election by the Returning Officer under duress.

This followed the arrest of Doguwa in connection with the violence which broke out in the federal constituency during the collation of the election results, leading to the death of two persons when a secretariat of the New Nigeria Peoples Party (NNPP) was set ablaze allegedly on the order of the embattled lawmaker. The police arraigned the ranking lawmaker at a Magistrate's Court in Kano, which remanded him in prison.

Nigerians were shocked when Doguwa was granted a N500 million bail and released from detention in time to apparently repeat such acts in the elections that were scheduled to hold tomorrow but subsequently rescheduled for next Saturday. How could someone charged for murder in an election be released just days later and in time to repeat such action for another election. When the story of Nigeria's democracy is told, the judiciary would occupy one of the most despicable roles. Professor Ibrahim Adamu Yakasai, the Returning Officer for the election, in a letter to INEC written on 27th February 2023 had explained clearly that the results he declared in favour of Ado Doguwa were false, read under duress and fear for his life.

He had the courage to admit this and correct the error leading to the decision of INEC to cancel the said results and announce new elections would be organised for the constituency. My fear is that Doguwa would go to court and a judge would declare that the law does not say results announced under duress are invalid. We have seen that before. This time, I hope Nigerians would not accept such an outcome should it occur.

"In most of such cases of signing results under duress, the judiciary has chosen to play dumb by ruling that the law says the results read by the returning officers stand and have thereby sided with forces that were raping basic democratic precepts. There is however a strong sentiment in Nigeria today that there must be accountability and sanctions for people who violate the principles of free and fair elections and seek to hide under legal technicalities."

Let us recall. To convince the presidential election petition tribunal sitting in Abuja to nullify the April 16 general election that brought President Goodluck Jonathan into power, the Congress for Progressive Change (CPC) presented evidence that its supervisory agent in Cross River State, Mr Bassey Okon, was compelled to sign a distorted final result of the presidential poll in the state at gunpoint (Vanguard, 15 September 2011) and it was dismissed. Another example was that of Professor Ibeabuchi who before reeling out figures at the district collation centre in the Independent National Electoral Commission (INEC) Office in Orlu, Mr Ibeabuchi, a professor, said he was being held "under duress" to announce the results: "My name is Ibeabuchi Izuchukwu Innocent, a professor at the Federal University of Technology Owerri (FUTO), the returning officer for Imo West (Orlu) senatorial zone... My area commander; my P.Os; the party agents here present; members of the press; ladies and gentlemen. I have been held hostage here for days so I'm trying to ease off and take my life home back to my children and for the sake of that I am calling

these results u n d e r d u r e s s . " (P r e m i u m Times, 25 F e b r u a r y 2019) the r e t u r n i n g officer said. There was

also the case o f t h e returning officer of Orumba North LGA, Dr. Michael Otu, who stunned stakeholders a t the Anambra State governorship election collation centre on Sunday when he denounced the result he signed. He accused the electoral

officer that was supposed to work with him of collaborating with some people to scuttle the election results in the area. He stated this while delivering his report to the State Returning Officer, Prof. Florence Obi, at the ongoing election result collation. He said there was no election in the entire local government area. He said a crisis fomented by policemen led to his signing the result under duress: "I signed a report I didn't believe in. I signed it under duress. I was teargased... I could not even go out to ease myself. They were monitoring me up and down. At a point, I saw that my life was in danger, so, I have to sign the results they prepared (PM News, 7th November 2021). Such stories have tended to create the basis to completely delegitimise Nigerian elections because they are so scandalous and anti-democratic that they become what Nigerians remember about the elections. When one looks at the 25th February elections in Kano for example, the trending story is about Ado Doguwa, the murders and declaration of results under duress. The reality of the Kano elections was that it went very well in over 90% of the polling units, there was neither violence nor fraud. Normal elections are not a great story so all that recedes to the back of people's memories and they remember the violence. At the national level, what we remember is that failure in posting presidential elections on the IReV portal. The fact that BVAS machines were successfully used to accredit voters in most polling units has disappeared as the story of the elections in spite of its importance in providing legitimacy to the process.

YIAGA Africa, which did a parallel vote tabulation count, said in its report that the figures for Imo and Rivers States appeared questionable and did not tally with their estimates and projections. This means the numbers for the 34 other states and FCT were in their findings fairly accurate.

Nonetheless, for many people, the whole election was a sham and should be cancelled. My concern is that when we carry out fairly good elections, we do not see our success as a few trees block our sight of the forest. If the judiciary does its work well and we begin to see accountability for actors who brazenly violate electoral rules and procedures, it would reassure Nigerians and place them on the path of beginning to see relative success when it happens. My mother Was a Woman

AM blessed because I am blessed by women. This Wednesday, March 8, I received messages from some women wishing me a happy International Women's Day. They know I am not part of their gender. But they are aware that I support, speak and fight for gender equity, equal rights and justice for all irrespective of class, race and gender. One of the earliest such messages I received came from the Cuban Ambassador Clara Pullido.

She dotes on some of us like a mother hen protecting her beloved ones.

She sees herself as a daughter of Africa. Her Master's Degree was in Ghana where she studied Nigeria's political history and she has been Cuban Ambassador to the African Union, Ethiopia, Algeria and now, Nigeria. She advocates on women and their role in emancipating humanity. It is through her I met the female ambassadors and diplomats from Asia, Europe, Caribbean and Latin America that I have come to know.



This 2023 Women's Day, to me, was a particularly sad one as I watched with sorrow many petty traders in the streets, almost all of who are women, turned destitute because the Buhari administration's currency policy has made cash so scarce that they barely have customers. Things are so bad that even to buy a small packet of biscuits, some pepper or an orange on the streets would require cash transfer which in many cases, gets stuck. So, their perishable goods have perished; some rotting in the farms. So many have become impoverished, and needless to state, the vast majority of these victims of the inept and thoughtless implementation of a new currency change, are women. However, these adversities and a climate of impunity and violence has not stopped women from being courageous and standing their ground. When during the Presidential and National Assembly Elections of February 25, political thugs invaded a polling station in Surulere. Lagos and stabbed Mrs. Bina Jennifer Efidi, they must have assumed they had discouraged her and other voters from casting their ballot. They were mistaken; they had taken on a woman who they assumed is fickle. But after her wounds were treated, even with blood trickling down her face and in her blood-soaked T-shirt, she returned to the polling station, daring the thugs, and casting her vote. Mrs. Efidi has become the symbol of resistance against street thugs and political violence in Nigeria.

Efidi reminds me of the resistance of Rosa Parks, the African-American lady who on December 1, 1955 in racist Montgomery, Alabama, refused to give up her seat for a Whiteman. Her resistance violated the segregations laws then in place. She was arrested for civil disobedience, detained and fined. But she refused to bow. Her resistance inspired the Blacks' one year boycott of the city's bus service, and the November, 1956 ruling that under the Equal Protection Clause of the 14th A m e n d m e nt of the American Constitution, bus segregation is unconstitutional.

The ongoing mass protests in Iran was triggered by the killing of Jina 'Mahsa' Amini, a lady arrested on September 13, 2022 for allegedly not properly wearing her hijab. She was allegedly beaten and died three days later while still in police custody. Women spearheaded and sustained the protests. The religious police took on the wrong gender and got dissolved.

There are lots of conflicts in the world and women, who tend to take care of the family, including their husbands and children, suffer a lot. But where the men are intimidated by forces of oppression and repression, women in many cases, step forward. For instance, in the ongoing Israeli genocide against the Palestinian people, many women have become involved, including engaging in physical combats with Israeli soldiers who come to effect the demolition of Palestinian homes to give way for illegal settlements. One of the most famous is Khalida Jarrar, a 60-year-old Palestinian lawmaker whose last stint in Israeli prison was two years ago. She had been jailed at least four

Even the United States (US), which traditionally covers Israeli atrocities, admitted the Israelis killed her. Its report "concluded that gunfire from IDF (Israeli Defence Force) positions was likely responsible for the death of Shireen Abu Akleh". Cornered, Israel admitted that she was "accidentally hit by IDF gunfire" but would neither allow its troops nor the marksman interviewed or brought to justice for murdering the 52year-old journalist. The struggle against Apartheid in South Africa was long and bloody because the regime was supported by powerful countries like the US and United Kingdom. As the repression grew and men were targeted, women stepped forward with the famous Women's March of 1956. In that march, the women adopted a South African proverb: "Wathinta Abafazi Wathinta Imbokodo", which meant: "You strike a woman; you strike a rock."

The leaders of that march on the Union included Helen Joseph who gave up all her privileges of being a White woman to fight for social justice; Lilian Ngoyi, the first woman member of the African National Congress National Executive Council; and Albertina Sisulu who later led the largest coalition that saw the back of Apartheid. They were followed into battle by formidable women, the most famous being Winnie Mandela. The Apartheid regime found too late that when "You strike a woman; you strike a rock". Katsina Govt Approves N2.6bn **Contract For Road Dualization** Of Kofar Soro-Kofar Guga By; SULAIMANAHMED MISAU, Katsina

atsina State Executive Council has approved contract of dualization of the road from Kofar Soro to Kofar Guga round about in the metropolis at the cost of over two point zero-six billion Naira.

The Permanent Secretary Ministry of Works, Housing and Transport, Engineer Abdu Usman confirmed this while briefing newsman on the outcome of the meeting presided by Governor Aminu Bello Masari.

Engineer Abdu Usman remarked that the project with the completion period of eight months was intended to reduce traffic congestion along the road.

The Permanent Secretary also said the executive council had approved the award of a three kilometer Jibiyar-Maje-Tashar-Aibo to Niger Republic boarder road already started under the NEWMAP programme.

According to him, the project initially awarded at the cost of over nine hundred and sixty one point four million naira had already had fifty percent of it covered by the NEWMAP, adding that State Government would complete the remaining fifty percent of the road project.

He said savings made from the fifteen kilometers covered had been proposed to be used on the execution of additional road projects in Katsina metropolis.

They include Mangal Juma'at Mosque T-junction to Abattoir quarters and Obasanjo drive road both to be constructed at the cost of over three hundred and eighty nine million naira.

The council meeting he said had also approved the ratification leading to the upward of two ongoing projects to include GRA Fly-over Bridge and Kafur-Gurai road.

In the meantime Katsina State executive council has approved three hundred and sixty seven million naira for the rehabilitation and upgrade of Musawa Dam.

Commissioner for Water Resources Alhaji Musa Adamu Funtua revealed this while briefing newsmen after the council meeting presided by Governor Aminu Bello Masari.

The Commissioner remarked that, the project would cover raising the broken embankment, Dam reservoir and over head tank among others.

He said the council had also approved the award of contract for the upgrade of quality control laboratory and Administrative block at the Ajiwa water works.

The Commissioner said the project would cost the State Government over seven hundred million naira.

Other projects approved by the executive council include replacement of rusted and broken pipelines among others.

Similarly, the executive council has granted approval for the tertiary institutions owned by the State Government to use their internally generated revenue in providing exit package for the retiring principal officers.

They include Vice Chancellor, Deputy Vice Chancellor, Bursar and Chief Librarian in case of University and Provost, Rector, Bursar and Chief Librarian for the Hassan Usman Katsina Polytechnic, Isa Kaita College of Education and Yusuf Bala Usman College of Legal Daura.

Special Adviser to the State Governor on Higher Education Dr. Bashir Usman Ruwan Godiya made this known at a news briefing after the council meeting.

He said all the affected officers would also go with their official vehicles on auction. The briefing was coordinated by the State Commissioner of information Abdulkarim Yahaya Sirika.
