The Independent National Electoral Commission (INEC), has declared Senator Uba Sani of the ruling All Progressives Congress (APC), as the winner of the Saturday governorship election in Kaduna State.

Declaring the result, the State Collation Officer for Gubernatorial Election (SCOGE), Prof. Lawal Suleiman Bilbis said, the number of registered voters in the state are 4,335,208, accredited voters are 1,581,662, valid votes cast are 1,546,747 invalid votes cast are 19.114 and total votes cast are 1,565,861.

Professor Bilbis said, Senator Uba Sani of the APC polled 730,002 votes. He said, Hon. Mohammed PDP: 15,108

The People's Democratic Party (PDP) Candidate, Hon. Mohammed Isa Ashiru Kudan won in 13 local government areas of Kaura, Sanga, Kajuru, Makarfi, Jaba, Jema'a, Zangon Kataf, Soba, Chikun, Kagarko, Lere, Kachia and Kudan. The APC gubernatorial candidate, Sen. Uba Sani won in 10 local government areas of Giwa, Ikara, Kauru, Sabon Gari, Kubau, Zaria, Kaduna North, Kaduna South, Igabi and Birnin-Gwari. Six Bag 156yrs **Jail Term Over Drug Trafficking** In Ogun, Lagos

have been Sentenced to 156 years imprisonment by Federal High Courts in Ogun and Lagos states for offences bordering on drug dealing, conspiracy and transportation of illicit substances.

The convicts were said to have been arrested during a separate operations by operatives of the National Drug Law and Endorsement Agency (NDLEA) and arraigned before the courts.

Worse hit is a 27-year-old drug dealer, Ahmed Abdulsabur who was arrested in 2022 by NDLEA operatives and prosecuted in charge n u m b e r FHC/AB/20C/2022 at the Federal High Court, Abeokuta, presided over by Hon. Justice Joyce Obehi Abdulmalik. Delivering her judgment

on the six counts charge brought against Ahmed, Justice Abdulmalik convicted and sentenced him to 10 years imprisonment on each count, bringing the total number of his in jail term to 60.

arraigned on three counts in charge number FHC/L/87c/2023, the trial judge, Justice Akintayo Aluko on Thursday 16th March convicted and sentenced each of them to five years on count one; seven years each on counts two and three.

This brings the total number of years for each of them to 19 years jail term and the four of them to 76 years imprisonment. While the judge ruled that the sentences should run concurrently, he also gave the four convicts the option of paying N20 million in lieu of the jail terms.

This is in addition to granting the application by the NDLEA for the final forfeiture of a white colour Ford bus with registration number: PHC 315 ZT, used in conveying 532. 8 kilograms of Loud variant of cannabis on the day of their arrest, Sunday 22nd January 2023 along Lagos/ Ibadan expressway.

The court also granted the final forfeiture of N3 million offered as bribe by the convicts to NDLEA officers.

The drugs concealed with 'take away' food packs in 19 big cartons were seized in the white Ford bus heading to Port Harcourt, Rivers state along Lagos-Ibadan expressway at 2:35am on Sunday 22nd Jan.


He appreciated people of the state for giving them the mandate to lead, himself and Dr. Hadiza Sabuwa Balarabe.

For Quenching Gamboru Market Fire, Zulum **Rewards 149 firemen with N14.9m**

*Orders recruitment of 38 volunteer-firemen

overnor Babagana Umara Zulum on Sunday, paid a 'thank you' visit to headquarters of the Borno State Fire Service in Maiduguri.

The visit was in recognition of swift response by firemen who quenched a major fire outbreak at Gamboru Market in Maiduguri, preventing destruction from escalating to

the magnitude witnessed two weeks ago at the Maiduguri Monday market.

Zulum told the firemen he was impressed with their gallantry and for that, he approved the release of N14.9 million as grants to about 149 firemen operating under both the federal and state fire services.

"I am here purposely to convey my deep appreciation to all of you for the great work you have been doing. Yesterday

(Saturday) we had another fire disaster at Gamboru market and I was informed of your efforts towards quenching the fire. This goes to show how committed you are and we want to once again extend our appreciation to you", Zulum said.

The beneficiaries comprised of 60 firemen working with Borno State Government, 49 working with the Federal Fire Service, as well as 38 volunteer-fire fighters.

Zulum directed that each of the 149 fire men be given N100,000 and a bag of rice, as part of appreciation from Borno State Government.

Meanwhile, Governor Zulum during his visit, directed the employment of 38 volunteerfiremen into the Borno State Fire Service as permanent staff.

The volunteers, 20 of them with the Maiduguri International Hotel and 18 with Borno State Fire Service were offering supportive services without receiving salaries which permanent staff are entitled to. The governor also directed the management of Borno State Fire Service to immediately send to

his office all of their requirements that will ensure the optimal performance of firemen in prevention and responses to fire incidents.

Zulum extended similar gesture to the Federal Fire Service, asking them to submit requirements in order to get some intervention from the state government.

YPP Rejects Akwa Ibom Election Results, Alleges Intimidation

he Young Progressives Party (YPP) in Akwa Ibom State has rejected the results of last Saturday's governorship/state assembly elections in the state, alleging massive rigging, and described it as a ruse on the intelligent of the electorate.

YPP also alleged that the conduct of the polls was bloodletting exercise executed by agents of Governor Udom Emmanuel–led administration and officials of the Independent National Electoral Commission (INEC) in favour of the Peoples Democratic Party (PDP).

Addressing a press conference in Uyo on Monday, State Secretary of YPP, Ambassador Kelvin Umoh explained that his Party refused to sign the results sheet of the governorship election where Pastor Umo Eno was declared winner by INEC because it did reflect the collective will of the electorate in the State.

Umo, whose text of the Press Conference was tagged: "Not The Will Of The Electorate In Akwa Ibom State" stated that reports from YPP agents, voters and independent observers as collaborated by credible intelligence have pointed to evidence that the elections were rigged against the will of electorate who had desired the opportunity to elect and usher in the right leadership in next dispensation.

YPP State Secretary also alleged that faked security personnel who dressed in police, military and para-military uniforms were used against YPP agents and supporters in polling units and registration area centres across the state.

His text read in parts, "On Saturday, March 18, 2023, the electorate in Akwa Ibom State witnessed a spectacle of wellorchestrated rigging scheme and bloodletting brazenly executed during the Gubernatorial/State House of Assembly polls by agents of Governor Udom Emmanuel-led administration and officials of the Independent National Electoral Commission (INEC) in favour of the Peoples Democratic Party (PDP). "At the collation and announcement of the Gubernatorial election result on Sunday, March 19, 2023 by INEC, we, as a Party, did not append our signature on the result sheet because it doesn't reflect the will of the electorate in Akwa Ibom State.



"Reports from party agents, voters and independent observers as collaborated by credible intelligence, were categorical that the conduct of the Gubernatorial/State House of Assembly elections was a mere ruse on the intelligence of the electorate who had earnestly desired to use the opportunity to usher in the right leadership in the next dispensation for the State.

"To pull the wool over the eves of poll observers and members of the public, the rigging syndicate of the state administration and INEC officials selected a few locations to allow the conduct to run a bit fairly – mainly in most parts of Ikot Ekpene Senatorial District and Uyo Senatorial District while Eket Senatorial District was shambolic, as most of the polling units' results were prewritten. "Worse still, the PDP state administration also deployed hired thugs who were dressed in Police, military and Paramilitary uniforms to kill, molest, maim and chase away YPP's Party Agents and supporters in the Polling units and Registration Area Centres (RACs) across the State. "Instances abound like the case in Ibiono Ibom where PDP armed militia killed some of our supporters including Mr

Abraham Bassey Ekpenyong at the INEC office. This dastardly act was carried out by a team of police men from Government House, Uyo led by Danjuma Saleh who moved in a convoy of six white hilux pickup trucks.

"In Atan Offot, Uyo, a YPP Local Government Agent was beaten mercilessly by thugs, about 15 in number, led by Mr Ime Uwah, SSA to Governor U d o m E m m a n u e 1 w h o personally had a gun with him.

"Mr Ime Uwah's gang also went around polling units in Atan Offot to chase away YPP Agents and key supporters while carting away electoral materials and

results from these units – inflated them and announced in favour of the PDP. This carting away was done even in the presence of foreign observers.

"Furthermore, three of our supporters were killed at Etim Ekpo and several others in other LGAs across the state. Even at Onna LGA, where Governor Udom Emmanuel hails from, thugs in police and military uniforms led by his Chief protocol officer, Mr Edmond Ufang, intimidated and maimed our supporters freely. In fact, any person identified as a supporter of YPP was decreed as a persona non grata, deserving elimination" YPP State Secretary stated.

Revealing further, he said, "Aside these ugly scenes, the fact is that fake result sheets as against the originals pre-signed by the REC were used in collating results in most units across the state. We have official reports that the same dastardly acts played out in other areas of the State including but not limited to all LGAs in Eket senatorial district, and some local government areas in the state like Ini, Ukanafun, Oruk Anam, Etim Ekpo, Ika, Abak, Essien Udim, Ikot Ekpene, Itu, Etinan, and Uruan. "Also worth mentioning is the massive hijacking of electoral materials in these LGAs by the

PDP agents in collusion with INEC staff and security personnel in these areas. For instance, materials in Ini LGA were hijacked to Dr Glory Edet's house; that of Ika to Barr Utibe Nwoko's house; that of Ikot Abasi to Engr. Uwem Okoko's house; Eket to Hon Francis Archibong's house; Oron to Senator Akon Eyakenyi's house, etc.

"On another plank, the state government and the PDP agents were seen brazenly and openly paying people N10,000 to buy their votes. Credible intelligence suggest that the state government and the PDP agents paid about N1.3 Million per unit across the 4,353 units in the state, \$5,000 to each ward across the 329 wards in the state as part of their voters buying strategy". Umoh positioned that the YPP gubernatorial candidate on the state, Senator Bassey Albert Akpan, the preferred choice of the people is never in doubt and will be legally pursued to secure justice. He also called on the Department of State Services (DSS), National Intelligence Agency (NIA), Foreign Missions, International Observers and relevant bodies to stand up against the malfeasance by INEC and the PDP in the last Gubernatorial/State House of Assembly elections in the state.

Sheikh Niasse fondly called Sheikh al-Islam is a man of many firsts, including being the first West African, black man to lead prayers in the revered Al-Azhar Mosque in Egypt as well as serving as the first Vice President of the Muslim World League, an international Islamic NGO based and founded in Makkah, Saudi Arabia in 1962 by King Faisal Abdulaziz ibn Al Saud.

I was visiting Dakar for the first time to experience and report the third edition of the Sahara Conference of the Basketball Africa League (BAL). The BAL in its third year is an initiative of the National Basketball Association (NBA) Africa to promote basketball talent across the continent. Kwara Falcons, champions of the premier basketball league in Nigeria is one of the six teams battling in Dakar to clinch four slots for the BAL playoff finals scheduled for Kigali, Rwanda between 21 and 27 May, later this year.

It is Friday and I craved to say my Jumuat prayers at the Sheikh Niasse mosque in Kaolack.

Earlier on Thursday, I did book transportation online Senegal Dem Dikk, public transportation from Dakar to all other major regions of the country. 7am on Friday, seated in an airconditioned coach, we set out for Kaolack driving through other major cities including, Fatick and Gandiaye. Less than 30 minutes to arriving Kaolack, I was struggling with the language barrier while asking fellow passengers where would be my best stop in order to easily access the Sheikh Niasse mosque popularly called the Medina Baye Niasse. An elderly man in his mid-sixties spoke to me in English relieving my anxiety. Abdoulaye Mohamed who apparently has visited many parts of Nigeria asked me, "where are you from my friend? When I replied Nigeria, he simply mentioned he has visited many Nigerian states including Lagos, Abuja, Sokoto, Kano and Kaduna for religious

activities. "Are you going to Baye Niasse?" he asked. I told him, I am visiting for the first time to experience Kaolack, Pa Abdoulaye offered to be my host for the entirety of my stay in Kaolack.

We arrived Kaolack, hot and sandy city at about 10:30am

after over three hours smooth drive from Dakar and headed straight to the family home of Sheikh Mahmun Niasse, one of the children of Sheikh Ibrahim Niasse, where I was given free, decent accommodation and food. Sheikh Tijjani Niasse, paternal grandson of Sheikh

Ibrahim Niasse became my guide showing me around the Baye Niasse mosque and Kaolack city which bares striking resemblance to northern Nigeria in terms of building and street structures. After the Jumuat prayers, we were guests of Sheikh Mouhamadou Mahy Cisse at his residence. Sheikh Mahy, maternal grandson of Sheikh Ibrahim Niasse is a globally revered scholar currently serving as the official spokesperson of Tijaniyyah and the Director of Studies at the African American Islamic Institute.

"The world needs peace and love which is the legacy of Prophet Muhammad (peace be upon him) whom Allah has sent to all mankind to take people from darkness to light. The more we spread peace and love, the more we uphold the legacy of the Prophet (peace be upon him)," Sheikh Mahy admonished.

After Sheikh Mahy's admonition, it was time for lunch. Sheikh Mahy led more than forty persons gathered in his modestly furnished living room in eating from same bowls with bare hands showing love in practicality, irrespective of cadre and nationality. I wondered about this profound hospitality accorded me and the simplicity of the Niasse family. A Nigerian student, Misbahudeen who has been living in the city for the past five years and speaks Wollof, the local Senegalese language fluently, confirmed that overwhelming hospitality towards strangers is not just associated with the Niasse family, but rather a prominent culture of Kaolack, expressed by both rich and the poor.

Memo To The Newly **Elected Governors**

ongratulations to all the brand new elected and re-elected Governors. Is not easy! The time to hit the ground running is NOW!

However, you need to know that, the work of a Governor begins with a transition period and if the primary responsibility of the Governor is to govern, that begs the question, HOW?

One thing you need to know is that campaigns are over, now it's time to think and answers some of these questions - such as.

1. How can I approach the job as a newly elected Governor?

2. How can I convert my campaign promises into Agenda & Results?

3. What is expected of me as a newly elected Governor as per things to do before the inauguration?

4. Want immediate decisions must be made?

5. What are the key things I need to do as per – policy development, governance, and communication tools?

In responding to some of these questions here are 7 Low Hanging fruits for a quick win... 1. Constitute a transition team with robust TOR, remember you only have two months to inauguration. As Governor-elect you will soon have full power and responsibility of the executive branch of the state.

Constitutionally and practically - the statutory power of the Governor is often perceived by new Governors as more limited than they imagine.. The Notes developed by the transition committee will give you an insight into what is expected of you. 2. Constitute a technical team to handle the transition, you need a combination of technocrats and politicians. The ability of the Governor-elect to navigate the difficulties of governing will largely depend on the quality of work done by the transition team. 3. Begin to build and nurture relationships with other arms of government, to effectively



navigate the turbulent waters of governance, you need to have a strong working relationship with civil servants, legislatures, the press, and the public... Begin to do that today, through breakfast meetings and dinner.

4. On making appointments, the most important decisions a governor-elect will make during the transition will be selecting Governor's office, central

executive council. Apart from individuals you also need a 'team' that will drive and coordinate the day-to-day individuals to staff the running of the state. Competence, character, and management agencies, and commitment should be

paramount in engaging people to work with.

5. Follow the rules of the game, and look at the processes of your administration as important tools to accomplish your key objectives. Communicate your goals to the team members, your target, milestones, and results should be very clear to all. As a newly elected Governor, make sure you keep your priorities firmly focused.

6. Implementation of the 4 Years Strategic Plan – if you have one, good! If don't have to develop one within 6 months of your administration. Immediately upon taking office, the Governor-elect is expected to be a master of the intricacies of the state government. Plans and programmes are the lifeblood of the state government, including emergency response plans and tracking of people's complaints, and delivery of results.

7. Media Team and Press Relations, we are in the era of people surviving through 'cooking and sharing fake news', therefore as a Governor-elect, you need a robust media team. Engaging the electorates through social media and offline. Mistakes at the beginning of your tenure can lead to serious challenges. Using the full power of press relations is not all about daily updates on social media, but it is about the overall narrative of the governor's tenure.....

In conclusion, you need to know that, the transition period of a new Governor has often been described as the most intense period after the campaign. Also, you need to know that...successful Governors are principles leaders who remain in touch with their constituents. Remember to shape your administration with leadership, management, results tracking, and communication tools. Restructuring: Buhari Writes His Name In Gold

n life, it is not the much said that matters but the much done of the much said. That's what President Muhammadu Buhari just demonstrated by signing some devolution of powers into law.

Restoration of federalism to Nigeria as agreed between the nation's founding fathers (Zik, Awo, Ahmadu Bello, et al) and colonial Britain is what the deafening clamor for restructuring is all about. The 1999 Constitution could be the worst in the nation's annals for imposing a unitary system in a federal environment, with 68 key items on the Federal List compared to a little over 30 flimsy and sundry items contained in the Concurrent List.

When the powers that confer socioeconomic autonomy to a federating unit as obtained in a true federation are considered, one would see that virtually all of them are concentrated and consolidated on the Exclusive List – Power/Electricity, State police, Ports, Railway, Solid minerals, Local government, State Assembly, Judiciary autonomy, and many more.

Under Dr. Goodluck Jonathan as President, most of these issues were addressed and passed in the last amendment, which he was to sign into law just before handing over, as is the case with Buhari at the moment. Jonathan refused to sign the amendments even though NASS had passed them and the concurrence affirmation by 24 State Houses of Assembly had also been passed. These were necessary devolution items needed in the constitutional alterations, which must be moved from the Exclusive List to the Concurrent List if Nigeria will be a federation indeed again. A reliable source said that Jonathan signed but used Tippex correction fluid to erase his signature for reasons best known to him. During the Obasanjo years, no constitutional alteration bill succeeded. The one that would have seen the light of day, some lawmakers smuggled the 3rd term clause into it for the benefit

of the same Obasanjo. That single clandestine move killed the move to alter the 1999 Constitution to devolve powers to make the States truly federating units.

One had expected that the nation could have attained 100% restoration to true federalism between Obasanjo and Jonathan since the current constitutional arrangement disfavoured the south more. But the two Presidents from southern Nigeria divide frittered away their combined 14 years in power and couldn't even move a single devolution item from the Exclusive List to the Concurrent List. And it took a Buhari, who the odds never favoured to sign the first significant devolution of powers into law thus succeeding where others before him woefully failed and thus wrote his name in gold.

What just happened reminds one of a certain parable in the Bible. The two sons (Matt. 21:28-32) is about two brothers whose father tells them to go work in his vineyard. One tells his father that he will but doesn't do it. The other tells his father that he won't go but ends up working all day among the vines. Jesus then asks the question, "Which of the two did the will of his father?" The answer is clear: the one who worked, though initially refusing to do so.

This reminds us also that actions speak louder than words. Many Nigerian leaders make statements declaring they would restructure but never did when given the opportunity. Though it is still a far cry as certain powers such as Fiscal federalism, State Police, Ports, Solid minerals, and some others are not part of what Buhari signed into law, the four items that passed are quite a milestone and will start the process for regional integration and creation of true economic hobs for regional and national development. There can't be a greater parting gift for a president whose administration brought so much hardship, escalated insecurity, and imposed debilitating poverty and most recently, a most controversial presidential

election denounced by both Nigerians and the international community. This decision to devolve key powers to states is therefore redemptive to the President and suffering credibility.

Let us take a look at the alterations that have given the states some key powers as federating units. Buhari has signed 16 Constitution Amendment Bills; States can now generate, distribute electricity, and own railways and State assemblies/Ju diciary now have financial autonomy; presidents and governors must appoint ministers and commissioner s within 60

days among others. With the Fifth Alteration Bill No. 33, Devolution of Powers (National Grid System), Nigeria's 36 states are allowed to generate, transmit, and distribute electricity in areas covered by the national grid. This is perhaps the most important. Another granted right to the state governments is the power to establish their railway service – Fifth Alteration Bill No. 32, the Devolution of Powers, Railways. With this, the railway moves from the Exclusive Legislative List to the concurrent list. With this law, a zone like South-east can put in place railway network that will ring up the 5 South-east states. Finally, changing prisons to



correctional service and redesignate correctional service in the Concurrent list is the fourth right signed away from the Assemblies can now stand up to Exclusive List by the President. States can now set up their Prisons to keep offenders generated by them. This will lead to a drastic decongestion of federal prisons. Summarily, these amendments are key devolutions and represent a major shift in the nation's federal structure. Since the two twin problems of Nigeria are leadership and structure, any fundamental alteration of the nation's structure is a solution to the nation's problems. What is more, there is no separation of powers in the states for the reason that there is no autonomy of States' Houses

of Assembly and State Judiciary. This is now resolved with these signed Bills and State the State governors who have been enjoying absolute powers and corrupted by it since 1999. Thank you, Mr. President, for the courage and the precedence. Kenya and the Majengo Syndrome

JUST returned from a trip to Kenya and it is a fascinating country where people are passionate about politics but frustrated at the narrow field of key players. The same elite have been circulating for decades and making permutations about whose turn it is to rule while the people are distressed about the limited choice and offer on the table. The next general election is scheduled for 9th August, in a few days' time, and campaign is heating up.

Kenya is very similar to Nigeria in the sense that the political class has used power to become extremely wealthy, made politics an expensive game to block new entrants and fight each other during each election to determine the new boss of the political and national elite. As for the masses, who cares?

What struck me most about the country was my trip to a slum in the centre of Nairobi called Majengo. I was given an excellent social history and current dynamics tour of the slum by two great guides, Iddi and Rashid, a great admirer of Nigeria's legendary football star, Rashid Yekini. The squalor of the slum is striking with terrible drainage, lack of sanitation, drug and alcohol abuse with so many young people spending their lives drinking "illicit liquor" – it is shameful that the term is still in use in Kenya. Beside the community is the biggest secondhand clothing market and hub for East Africa. The real story is that as with all slums around the world located in city centres, the gentrification moguls are after the high value land and are literally getting the masses burnt out, kicked out or bought out by the propertied classes. The stories are depressing, those who refuse to sell out suffer "mysterious" arson on the property which then has to be demolished for public health purposes and there goes the land on which high rise

developments are built. There is no major metropolitan city slum in the world without similar stories.

Majengo was established between 1900-1920 by settlers, mainly Muslim Bajuni from the coast between Mombasa and Lamu, brought in by the colonial administration to service the new capital city my guides told me. Since then, it has been stories of circles of displacements of the poorer previous inhabitants. The next group was returnees from the First World War campaign who settled there and made the area more cosmopolitan starting the process of the displacement of the earlier mainly Muslim inhabitants. Then there was the entry of the Somali when they started making money from various streams of revenue including piracy and commerce. Currently, the Chinese are coming into the country, linking up with the national bourgeoisie and developing high rise property that is changing the skyline.

The sad story, according to Iddi and Rashid who have spent the last fifty years in the area, every national government has promised a massive programme of urban regeneration for the area to get their votes, after the elections, a few estate blocks are built and the place is forgotten until the next one. The other side of the story of course is that there is a history of the availability of strong arms for hire in Majengo for election violence and as the next elections arrive in a few days, it might be harvest time for some people. Kenya is a real tourist-oriented country. The National Museum requires at least four hours to go through the various exhibitions and collections. Both the National Archives and the Nairobi Gallery also have great exhibitions and artefacts on display. It was at the National Archives that I saw on display the stamp issued by the Nigerian

I did see a lion hunting down a gazelle for breakfast and the Nigerian in me wondered fleetingly why the bush meat is reserved solely for carnivorous animals

minus humans. Of course, that is silly thinking even if in Nigeria humans have hunted down and eaten most of the antelopes as bushmeat. My prayer however is that we should learn from the Kenyans, never eat bushmeat, in any case they are spreading dangerous diseases, reserve them as entertainment for the eyes of tourists and national visitors.

Challenges of a New African Ocean and Continent

S we sleep, nature is ever awake, working. Even if we snore, it cannot be as loud as the rumbling Mount Nyiragongo volcano in the Democratic Republic of Congo which this week, is threatening to blow out as it did on May 22, 2011. The tragic flood Freddy which is ripping through Malawi, Mozambique and Madagascar claiming some 300 lives, is like a drop in the ocean compared to the new ocean nature is burrowing through the continent.

"The challenges of having a new ocean in Africa which would slice through the continent creating two distinct continents are quite enormous. It starts with the question; do we need a new ocean? If no, can we still prevent it? If yes, how do we prepare for it including the huge lands that will be yielded to it, the people that would be displaced, countries recreated, merged or new ones that would be born?" The East African Rift System (EARS) elongating from the Afar area of northern Ethiopia, splitting up countries like Kenya and Tanzania from parts of Africa has been found to be separating at seven millimetres per year.

The most obvious indication of the shifting tectonic plates, created a 35-mile-long rift in the Ethiopian desert in 2005. This was a most revolutionary and extra ordinary occurrence as the tectonic shift that normally took several hundred years, occurred in just a few days.

What if the African Continent broke apart?


Geologists point at tell tales of rapid shifts in the bowels of the continent such as the Victoria micro plate, the biggest of its kind on earth; tucked between each side of the rift, it has for two years now, been rotating anti-clock wise. There are also, several active volcanoes in the East African region which are contributing to the breakup of the continent. These include the Ol Doinyo Lengai 'Mountain of God' in Tanzania which rises to an Christopher Moore of the University of Leeds in the United Kingdom, in employing satellite radar to monitor the volcanic activity, said: "This is the only place on Earth where you can study how continental rift becomes an oceanic rift." On Africa, he adds: "We can see that oceanic crust is starting to form, because it's distinctly different from continental crust in its composition and density."

Cynthia Ebinger, a geophysicist at Tulane University in New Orleans, who is studying the phenomenon, revealed: "The hottest inhabited town on the Earth's surface is in the Afar. Daytime temperatures often go to 130 degrees Fahrenheit and they cool off to a balmy 95 degrees at night."

"The earth, about 240 million years ago, was a single supercontinent known as Pangaea before slowly splitting into seven continents. Now with Mother Africa which gave birth to the six other continents, pregnant again, an eighth continent will be born. The Arabian plate in the last thirty million years has been moving apart from Mother Africa leading to the creation of the Red Sea and the Gulf of Aden."

Ken Macdonald, a marine geophysicist and professor emeritus at the University of California, Santa Barbara, explains how the new ocean will get its waters: "The Gulf of Aden and the Red Sea will flood in over the Afar region and into the East African Rift Valley and become a new ocean, and that part of East Africa will become its own separate small continent."

The challenges of having a new ocean in Africa which would slice through the continent creating two distinct continents are quite enormous. It starts with the question; do we need a new ocean? If no, can we still prevent it? If yes, how do we prepare for it including the huge lands that will be yielded to it, the people that would be displaced, countries recreated, merged or new ones that would be born? Preparations for this future can start with tackling something as mundane as a name for the new ocean. Africa is bounded in the north by the Mediterranean Sea, the west by the Atlantic Ocean, the east by the Red Sea and the Indian Ocean and in the south by the Atlantic and Indian Oceans. But none of these bear its name. Indian Ocean was named after India while the Atlantic Ocean, which until the 19th century, was called the Ethiopian Ocean, was finally called Atlantikôi pelágei or the "Sea of Atlas" named after the Greek god, Atlas. So, since the African Union, AU has not succeeded through diplomatic negotiations or the United Nations to properly rename either the Atlantic Ocean or Indian Ocean after Africa, maybe the new ocean that may arise in another five or ten million years

will be named the African Ocean. But should we wait for so long?

In the case of a child, we tend to fix a special day for the naming ceremony during which we roll out the drums and celebrate. Can we do less if unto us a new continent is born? Should we be excited that our continent may become two? Obviously, there are advantages such as landlocked Zambia, Uganda, Rwanda, Burundi, the Democratic Republic of Congo and Malawi having their own coastlines. But the geologists say the smaller of the emergent continents comprising Somalia, Eritrea, Djibouti, the eastern parts of Ethiopia, Kenya, Tanzania, and Mozambique where the valley ends, may drift away from the rest of the continent.

Doubtlessly, with a new ocean, there will be far more maritime activities including shipping and fishing and a possible shorter route to other parts of the world. But is this an advantage Africa can take or we would sit back and allow foreigners take advantage and control the new routes and maritime business? In casting a glance into that far future, there are issues like: would the twin continents remain as one or develop apart like North and South America? What would be the security implications and would trade tie them together as a common entity even if they have become like separated Siamese twins? There are many advantages and challenges of Africa splitting into two separate continents with a new ocean between them. But do I have the right to peer into a future millions of years away? I think we really need to discuss that future as it may come earlier than humans think. For now, let us see how far we have gone with the AU Vision 2063.

Social Change Does Not Descend From Heaven



OCIAL change does not descend from Heaven. That was the basic message at an international conference on the "Challenge of Building an Alternative Political and Socio-Economic System". Cuban Ambassador to Nigeria, Her Excellency Clara Margarita Pulido Escandell, gave the opening address at the July 16, 2022 virtual conference to mark the 17th Anniversary of the Nigeria-based Amilcar Cabral Ideological School-Movement (ACIS-M.)

Leading speakers from eight Latin American, North American and African countries, she submitted that the solution to biting world crises is the solidarity of the human race. Cuba at the height of the COVID-19 pandemic in 2020 when other countries shut their borders, had sent out over 3,000 doctors, nurses and other health personnel to 28 countries to combat the pandemic. She said human beings need solidarity even if it comes at a high cost, adding that solidarity is what Cubans have: "In our gene, our blood and our hearts."

Speaking of the pandemic for which the small island had produced five vaccine candidates with at least two in use, she said Cuba had vaccinated over 90 per cent of its entire population, including children. She described the current situation in Cuba as good because of the strive to improve life, including proposed new laws to expand family rights, and bad due to the effects of COVID-19 and a six-decade United States (US) blockade of the island country, a situation made worse by the piling of 240 extra sanctions on the country. In summarising her presentation, Ambassador Pulido said US propaganda trying to portray Cuba as a failed state is false, adding: "In Cuba, we have peace and the government is led by the population. Yes, it is the people leading the government." His Excellency David Vasquez Caraballo, the Ambassador of the Bolivarian Republic of Venezuela, submitted that there is the need to build a new international system in which countries would have the right to independence and sovereignty. He said there is a rearrangement of such political relations in Latin America which has swept through countries like Venezuela, Nicaragua and Bolivia. On the realities in Venezuela, he said part of its problems was the Executive Order signed by then American President Barack Obama which designated Venezuela as in one part can spread to another. He said there are troops from the Economic Community of West African States (ECOWAS) in Guinea-Bissau but that they are primarily there to impose an undemocratic President on the country. He said coups have been used against the PAIGC which was the ruling party in the country and that just on May 16, 2022, President Umaro Embalo, now the Chairman of ECOWAS, sacked the National Assembly to keep the PAIGC which controls world we knew yesterday is not the world we know today and certainly would not be the world we will know tomorrow. He regretted that Ghana has become an American military satellite.

Ambassador Brahim Buseif of the Saharawi Arab Democratic Republic (SADR), also known as Western Sahara, in his solidarity message, thanked ACIS-M for being one of the founders and pillars of the Nigeria Movement for the Liberation of Western Sahara.
