NGO Demands Improved Budgetary Allocation For Girls with Special Needs

Non-Governmental Organisation (NGO), Centre for Girls' Education (CGE), has Lappealed to the Kaduna State Governor, Malam Nasir el-Rufai, to accent the improved 2023 budgetary allocation for Science, Technology, Engineering and Mathematics (STEM), for girls with special needs by 0.46% of the current allocation.

Kaduna State Team Lead of CGE, Aisha Bello Aminu, made the appeal at the weekend during an inception meeting of "Advocacy for Improved Budgetary Allocation for STEM Education for Girls with Special Needs in Kaduna" project with different stakeholders, to formally introduce the project to enable mutual understanding of project goal and deliverables.

CNS Gambo To Deliver Lead Paper For International Symposium In South Africa

n an effort to boost Blue Economy and Security in Africa, the Nigeria's Chief of Naval Staff (CNS), Vice Admiral Awwal Zubairu Gambo, has been selected as the Lead Speaker for an international symposium coming up in South Africa in May.

The two-day symposium is organized by the Security Watch Africa Initiatives (SWAI) and the Centre for Military Studies (CEMIS) from Stellenbosch University, South Africa.

The theme of the symposium fixed for 4th and 5th of May, 2023, is 'BLUE OCEAN ECONOMY AND **SECURITY IN AFRICA:** CHALLENGES AND PROSPECTS FOR AGENDA 2063'

The Symposium, holding at the STIAS Conference Centre, Stellenbosch, South Africa, seeks to explore various aspects of the Blue Ocean Economy and the potential roles that the Navies of various countries can play, in conjunction with public and private sector entities, in ensuring security on the continent's ocean waters.

It is aimed at articulating practical mechanism in actualizing the Blue Ocean Economy for the African continent using the Nigeria's Chief of

President / Chief Executive Security Watch Africa, Mr. Patrick Agbambu in a release in Lagos said the discussions are also aimed at exploring how African Navies have experienced the unlocking of the Blue Economies in Africa.

It will further assist to foster inter-naval cooperations and relationships between ECOWAS and Southern Africa Development Community (SADC)

providing an important opportunity for the Chiefs of Navies to frame the agenda for Naval participation in their respective Blue water economies.

It will allow each Navy to provide a keynote address regarding their experiences in defending the blue water economy.

There will also be

syndicate discussions, and a feedback session to allow each syndicate to report their findings. The conference will close with a consolidated report of these findings.

Among those expected to attend the symposium Ministry/secretary of Defence personnel, Practitioners in the maritime space, Academics, Defence Industry representatives.

Also expected at the symposium are Students of the Military Academy while a limited number of seats will be opened for the public to apply to attend.

The call for delegates will close on 20 April 2023 for foreign delegates and 28 April 2023 for African delegates.

Man In Police Net For Allegedly Stripping Girl Naked For Turning Down Marriage Proposal

he Kogi State Police Command has arrested one Arome Danjuma as prime suspect for allegedly ambushing and stripping a girl naked in a viral video. Danjuma, alongside his friend, said to be currently at large, is reported to have carried out the dastardly act in Achigili Village around Abocho under Dekina Local Government Area of the

The Police Public Relations Officer (PPRO), SP Williams Aya, while briefing journalists at the command's headquarters in Lokoja on Saturday, said investigations were still ongoing to apprehend the other suspect who was on the run.

The incident was widely condemned by the general public and according to the state PPRO, the culprits would be made to face the full wrath of the

The police spokesperson added that the suspect would soon be charged to court.

The victim, who identified herself as Alami, said one of the suspects approached her for marriage which she refused.

Narrating the incident, she said, "One of the guys approached me for marriage which I refused. When I closed from work on my way going home at about 8pm last week Sunday 19th, he attacked me and forced me to his house and started beating

"Another person was waiting in his house carrying knife and axe threatening to kill me if I don't pull off my clothes. I had no option but to obey

them if not they would have killed me in the room. When I pulled off my clothes, they started filming my nakedness and later posted it on the internet. They just want to destroy my life".

Speaking during an interview, the suspect, Danjuma, confessed to have committed the crime, stressing that, he conspired with his friend to commit the atrocity.

Reacting to the incident, the Commissioner of Women Affairs who was represented by the Director, Research Planning and Statistics, Ministry of Women Affairs, who is also the Secretary of the Kogi State GBV Technical Workgroup, Mr. Oseni Isaac, described the incident as one of the most barbaric in recent time.

He described the act as animalistic which he said would not be acceptable in the state.

Isaac noted that the ministry is out to fight any act of gender-based violence in the state, warning that it would no longer be business as usual for anyone who intends to perpetuate gender-based violence in Kogi State.


Also reacting, the Executive Director, Challenged Parenthood Initiative, Eunice Agbogun, described the incident as barbaric.

"This is the height of gender-based violence. This is a serious crime against humanity. We feel that this case must go through the entire process and justice must prevail. Am glad that the police have prevailed.

Crisis: Oyo SDP Suspends Guber Candidate, State Secretary

he crisis rocking the Social L Democratic Party (SDP) in Oyo State at the weekend, assumed fresh dimension as the party announced the suspension of its governorship candidate in the March 18 polls, Barrister Michael Lana.

Oyo SDP in a letter to the party's National Secretariat signed by its State Chairman, Hon state secretary Michael Okunlade, also suspended its State Secretary, Mr Idowu Awokoya.

In a swift reaction, Barrister Lana dismissed the purported suspension, saying, "Don't mind them. They are jokers and lovers who are trying to redeem themselves from their inglorious alliance with the APC.

The party in the letter, asked its National Secretariat to ratify the suspension of Barrister Lana and Mr. Awokoya, the state secretary.

In the letter addressed to

the SDP National Chairman dated March 31, the Oyo State SDP accused Barrister Lana of alleged, "Anti party activities and no s u b s t a n t i a l contribution to the party".

Oyo SDP in the letter titled, "Suspension of Mr Folorunsho Lana and Idowu Awokova as a member of SDP in Oyo State and as a respectively accused the state Secretary of alleged, " indiscipline, insubordination and dropping the name of the national secretary to

The party maintained in the letter that it " also resolved that Ajibola Adeniyi of Lagelu local government under the Ovo central secretarial district to replace Idowu Owokoya in acting capacity"

No Constitutional Provision for Interim Govt in Nigeria - Agbakoba

Senior Advocate of Nigeria (SAN), Dr. Olisa Agbakoba, has expressed shock on disclosure made by the Department of State Security (DSS) that secret plans are underway to put an interim government in place in Nigeria.

He argued that such arrangement will undermine the country's democratic process and transition.

He described the idea as a major setback, and advised that it must be

Agbakoba said this in a statement issued on March 30, 2023.

He said, "It is shocking to learn from the Department of State Security that secret plans are underway to undermine Nigeria's democratic process and transition, by arrangements of what is described as an interim government. This will be a major set-back and we must all resist."

The senior advocate suggested that the gravest possible consequences must be applied to all who are associated with the idea, and said that it

"The general elections have held, albeit under the most challenging circumstance. But a president-elect has emerged and we must respect and accept this as fact. At least for now. All leading Presidential candidates have approached the courts with grounds of complaint concerning what they consider as electoral irregularities. If the presidential candidates have accepted the democratic process by lodging petitions before the courts, then it is very difficult to understand upon what beging anyone considers that an interior understand upon what basis anyone considers that an interim government is a viable and legal alternative. We must all reject this nonsense and respect our Constitution, which has no provision for interim arrangements," Agbakoba said.

He pointed out that as the President-elect is sworn into office on May 29, the Judicial process will ultimately render a decision.

"As Nigerians, we must turn to the Courts to render a decision on the petitions before them. The Judicial process will certainly carry a huge responsibility in the process of democratic consolidation," he clarified, adding: "The notion of the contraption referred to as interim government, has no place in our lives and our constitution. We must

The country would witness remarkable difference from what we are witnessing presently".

82,000 Women Die From Pregnancy, Childbirth Related Complications In Nigeria Annually - UNICEF

he United Nations Children's Fund (UNICEF), has explained that a new global maternal mortality report indicated that in Nigeria, 82,000 women die from pregnancy and childbirth-related complications every year. Eduardo Celades, the UNICEF Nigeria Chief of Health, during a media dialogue on COVID-19 and routine immunisation organised by UNICEF Nigeria Office on Friday, in collaboration with the Child Rights Information Bureau (CRIB) of the Federal Ministry of Information and Culture.

According to the report, titled: 'Trends in maternal mortality 2000 to 2020' was done by the United Nations Maternal **Mortality Estimation Inter** Agency Group (MMEIG) - comprising WHO, the United Nations Children's Fund (UNICEF), the United Nations Population Fund (UNFPA), the World Bank Group and the United Nations Department of Economic and Social Affairs, Population D i v i s i o n (UNDESA/Population Division), and covers the period 2000-2020.

Celades explained that it translated to 225 deaths from maternal mortality every day, saying that it showed that the number of women dying from pregnancy-related causes was very high in the country.

The way out, he said, "involved a three-prong approach, which involves increasing effective investments in primary health care at the state level, as well as the Basic Health Care Provision Fund (BHCPF)."

The UNICEF Nigeria Chief of Health further explained that the second one was to expand the National Health Insurance Scheme, stressing that it is a powerful tool to achieve Universal Health Coverage (UHC) and reduce maternal mortality. He added that the third one was to target the most vulnerable, including women who don't have access in hard-to-reach areas to be able to curb the menace.

Celades lamented that Nigeria had the second highest number of zerodose children in the world, while calling for the prioritisation of routine immunisation in order to protect Nigerian children from vaccine-preventable diseases.

countries. On this, we seek your support to continue to empower journalists in Nigeria as we look forward to having the second edition of the JIFORM intercontinental migration summit hosted in Germany later this year" he said.

Responding, Gerald said his office would welcome a proposal to actualise a workshop for journalists and take steps to ensure its success when approved.

He added that the German government has a series of opportunities for skilled and qualified migrants from Nigeria especially in education and those who are qualified as teachers.

The Deputy Consul while wishing the JIFORM well on its desire to stage a migration summit in Germany said his office was looking forward to also liaising with other German organizations in Nigeria to be part of interaction with the media during the proposed training programme.

The JIFORM founded in 2019 in Lagos comprises over 300 journalists covering migration across

These included the initiation of the annual global migration conference with the 3rd edition held in Toronto, Canada in 2022. The JIFORM in partnership with Nekotech Centre of Excellence pioneered the African Migration summit in Ghana in 2021 and organised the West African Media Migration Summit in Togo in the same year.

Apart from these, the JIFORM in collaboration with the City University, New York City in Brooklyn between November 2-4, 2022 held the inaugural intercontinental migration summit and has equally put in place an annual national migration summit which berth in Lagos on February 9 to serve as a retreat for journalists and stakeholder on migration matters in Nigeria.

The politician also explained that already the South West has a President, while North East has Vice President and so North West that


produced the highest votes to the president, deserves the Senate President position too to strike a balance.

"After the battle, the troops exploited the location and recovered two AK-47 rifles, two AK-47 magazines and 57 rounds of ammunition. Six motorcycles belonging to the bandits were destroyed during the encounter," it said.

sage presented a prince with a set of three small dolls. The prince was not amused.

"Am I a girl that you give me dolls?" he

"This is a gift for a future king," said the man. "If you look carefully, you'll see a hole in the ear of each doll." "Ok?"

The sage handed him a piece of string. "Pass it through each doll," he said. Intrigued, the prince picked up the first doll; put the string into the ear. It came out from the other ear.

"This is one type of person," said the man. "Whatever you tell him, comes out from the other ear. He doesn't retain anything." The prince put the string into the 2nd doll. It came out from the mouth.

"This is the 2nd type of person," said the man. "Whatever you tell him, he tells everybody else.

The prince picked up the 3rd doll and repeated the process. The string did not reappear from anywhere else.

"This is the 3rd type of person," said the man. "Whatever you tell him is locked up within him. It never comes out."

"What is the best type of person?" asked the prince.

The man handed him a 4th doll, in answer. When the prince put the string into the doll, it came out from the other ear.

"Do it again," said the sage. The prince repeated the process. This time the string came out from the mouth. When he put the string in a 3rd time, it did not come out

The term "no man's land" typically refers to a disputed territory that lies between two opposing forces, often in the context of war or conflict. It is a contested area where neither side has complete control or authority. Nigeria is a no man's land, everything is in contention and in contestation, at one point or the other!

The debate surrounding Nigeria as a no man's land has been ongoing for many years, with different viewpoints and opinions being put forward. Some argue that it is an essential part of the politician's strategy at dividing the populace, providing a buffer zone between opposing forces that allows for tactical movement and protection whether by faith, language or any other foolish nepotic reasoning, after all we have very few shared values.

Others argue that no man's land is a symbol of the futility and tragedy of war, we are a perfect example. In this view, the existence of no man's land reflects the failure of diplomacy and the inability of opposing sides to find peaceful solutions to their differences. Our recent elections again have exposed us badly, from Muslim—Muslim ticket conversations, to the Lagos Yoruba/Ibo warfare and wordfare!

Overall, the debate surrounding no man's

land reflects the complexity and nuance of the i s s u e s surrounding us as a people. While there are differing viewpoints and opinions, it is clear that the human cost of natives, nonnatives, indigenes and non-indigenes, south and north and that efforts towards peaceful resolution are essential to reducing this c o s ti s imperative.

While Nigeria has experienced conflicts and disputes over land ownership, the term "no man's land" is not commonly





Yobe, The State Of Party Chairmen

his is not what I had intended to discuss this week, but circumstances have given it priority. Yobe is a state that is blessed. Here, I am not talking about how blessed it is with peaceful and peaceloving people. No. Nor am I talking about the natural resources the Maker buried there. No, not at all. I am not even going to talk about the abundance of human resources in Yobe State.

As far back as the 4th century, Aristotle surmised that man is either a political animal (in its natural state) or an outcast like a "bird which flies alone."

The dominant ideology of man as a political animal stems from his ability to reason and communicate with others; therefore, he has the potential to change his living conditions for the better because he can recognise the difference between right and wrong.

And so it is that man naturally plays politics wherever he is, from the moment he opens his eyes in this world to when he closes them for good. He does so wherever he goes and in whatever he does. The infant knows how to get attention with its tantrums.

We all play politics within peer groups, in schools and workplaces. You have to be good at it to have control over your family or else they bounce you about like froth floating on a fast river.

No aspect of humanity is devoid of politics. One may think religion should be an exception, but look at how the religious world is divided among the children of Abraham. And for mainly political reasons - as politics confers power, influence and wealth - the two sides are yet to come together and follow just one path.

Since man is an inborn politician and survives only in a society, it goes without saying that there must be an organised setting with a division of labour. Some people naturally gravitate towards a natural calling while others are forced into it by circumstances.


And so we leave the larger politics of running the society to others born into it, who want to, or who we request to because of certain qualities we see in them. And it is through such that

governments are formed.

In the early part of human history, when societies were being formed, the strongest ran the affairs of man. But societies glued together, for selfpreservation, to form nations and, with time, the bravest took over because the bravest can overcome the strongest with guile; call it native intelligence. We saw this in the case of David and Goliath or the folklore of Achilles or in the legend of the 300 Spartans. Throughout history then, intelligence and bravery have always defeated brute force.

When the intelligent and brave organised the strong and not-sostrong into armies, military power ruled, but democracy has now permeated the world and soldiers have given way to

civilians to govern nations.

In a democracy, eligible members of a society or nation have the inalienable right to install a government through elected representatives. While there are various forms of democracy, here we practise the multi-party presidential system akin to that practised in the United States of America. The strength, reach and ultimate success of a political party may, inadvertently, rest heavily on the shoulders of its national chairman.

Nigeria has had many parties since the First Republic but I am particular about four national parties out of many because they concern this write-up – they are the Great Nigeria Peoples Party (GNPP), the Peoples Redemption Party (PRP), the All Progressives Congress (APC) and the Peoples Democratic Party (PDP).

All of them, at one point or the other, had a man from Yobe State as national chairman. Alhaji Waziri Ibrahim, the apostle of politics without bitterness, who many think was from Borno State, is actually from Yobe and he chaired the GNPP. Khalifa Hassan Yusuf, also from Yobe, took over the chairmanship of the PRP when its founder, the late Aminu Kano, died on April 17, 1983.

In the current dispensation, Yobe State Governor Mai Mala Buni took over the chairmanship of

the APC at its darkest hour, when little remained for it to tip over into the abyss. He was able to stabilise and strengthen it by courting at least three opposition governors, members of the National Assembly from the opposition, and other influential stakeholders. The credit for APC's victory in the just concluded elections should be attributed to him because he laid the foundation for it. Without his intervention, perhaps there wouldn't have been an APC as it now is - strong and allconquering.

And now the PDP has also found it fitting to give another son of Yobe State, Ambassador Umar Iliya Damagum, the mantle of its chairmanship. He, too, is coming when the party is in its lowest spirits and threatened by extinction. He will face a lot of challenges from larger-than-life political figures and egotistical men who are stupendously rich.

Though Damagum is said to have a mind of his own, is fearless, not easily intimidated and so cannot be cowed, the question on the lips of observers is, will he be able to chair the PDP to success like the talented sons of Yobe before him, or will their shoes be too big for him?

Only time will tell is an overused cliché. But he has begun on a sound footing by reversing the suspensions of some of the party's prominent members.

Kaduna PDP Vows To **Reclaim Mandate**

eople's Democratic Party (PDP) has vowed to use legal means to reclaim mandate as the All Progressives Congress (APC's) Senator Uba Sani received certificate of return as governor-elect of Kaduna State.

"There were massive jubilations all over the state in anticipation of announcing our candidate as winner but happiness of kaduna people was truncated by declaring Uba Sani as the winner.

"This will not stand because Uba Sani did not win the election from all available facts and figures in our custody which shall be made available to the public in due time, "he assured.

Speaking on conduct of some returning officers whom he accused of acts unbecoming of academia, Mr. Hyat lampooned returning officer for Lere Local Government Area Professor Ladi Adamu of Ahmadu Bello University (ABU) whom he accused of allowing herself as a willing tool by politicians to rig and manipulate results of the governorship and state assembly exercise.

He said Prof. Ladi would be called to testify at election tribunal to state how she was used to announce a false result.

He urged the professor of Mass Communication to borrow a leaf from her counterpart in Abia State who resisted to dance to the tune of the power that be to misappropriate mandate of the people.

Apropos of the so-called Interim National Government

hat I find confusing is the re-fashioning of fears about the abortion of elections for an interim government in a totally different context.

Any attempt to truncate our democracy is a threat to the existence of the state itself and must be resisted by all democrats. When, therefore, an important institution such as the DSS comes out to make public comments on such a matter, it is important that the content of the messaging is indeed about preserving our democracy and not playing to the gallery of some spokespersons to an elected official.

Over the past couple of weeks, there have been statements and a petition by spokespersons to President-elect Bola Tinubu -Femi Fani-Kayode, Festus Keyamo and Bayo Onanuga claiming that there is a subversive plot to deny their principal access to the presidential seat he won. I never really understood the argument, as I had not seen any action different from what has happened after previous presidential elections. The fact that some of them are questioning Tinubu's success at the tribunal is certainly not something new in our politics.

On Wednesday, Nigeria's secret police, the Department of State Services (DSS), joined the fray and announced that some key players are indeed plotting to impose an unconstitutional interim government on Nigeria. The service confirmed the speculations and calls by some for a truncation of Nigeria's democratic system. It said that the plot was an "aberration and a mischievous" way of setting aside the constitution, undermining civil rule, as well as plunging the country into an avoidable crisis. The DSS spokesperson, Peter Afunanya, said the planners, in their many meetings, had weighed various options, which include sponsoring endless violent mass protests in major cities to warrant a declaration of State of Emergency.

What then is the plot? I am not

sure I understand it. Nigeria is a country where public demonstrations are very common and legal, and they do not result in the declaration of states of emergency. The state of emergency is declared by the president and the legislature. President Buhari has affirmed consistently and repeatedly that he is eager to hand over power to the declared winner of the 25th February election, Bola Ahmed Tinubu, so I do not see the logic of his declaring a state of emergency to stop the handover of power. Senate President Ahmed Lawan and Speaker Gbajabiamila are also definitely not in the political mould of anticonstitutionalists, so I am at a loss on where the fear of the declaration of a state of emergency is coming from.

What I do not understand, therefore, is the path that would lead to the unconstitutional imposition of an interim government. Which branch of government is engaged in nefarious meetings to put a stop to our democracy? Is it the executive, legislature or judiciary? What we know for sure is that Nigerians are committed to the sustenance of democracy and would fight to preserve it.

The other possibility coming from the DSS statement pertains to frivolous cases currently in the judiciary. Nigeria has the highest level of election-related petitions in the courts in the contemporary world. The fact of the matter, however, is that our Constitution allows for this and they are a legal and legitimate route to resolving contestations on electoral matters. Indeed, the counsel given to people who have been declared losers in an election is to go to court, rather than contest the loss on the streets.

statement is to get democracy defenders to stand by and get ready to defend democracy against antidemocratic elements, then the message needed to have been clearer. If, yet, the message is that there are fifth columnists within government branches planning evil against our democracy, then what is required is not a press release and tweets from the DSS; the suspects should be arrested and charged for their treasonable plot. The statement is coming barely a month after the 25 February presidential

election that produced Bola Tinubu as Nigeria's next leader. Mr Tinubu was the candidate of the ruling All Progressives Congress (APC) and if some elements within the same government are plotting regicide, then immediate action against them must be taken. We cannot accept an end to the handover of power on 29 May, which has now become a constitutionally-entrenched habit we are all proud of.

My recollection is that the idea of an interim government was popularised by Afe Babalola, the renowned philanthropist, legal icon and founder of Afe Babalola University in April last year. He proposed that the 2023 general elections be suspended in favour of a six-month interim government to be drawn from various strands of the Nigerian social, economic and political life. Virtually all Nigerians condemned his proposal, which was expressly meant to truncate Nigerian democracy. Mr Babalola was looking for an unconstitutional shortcut to address his concerns over restructuring. That issue is no longer relevant because the elections held and the outcomes have been decided and what has not been addressed would be in the tribunals.



Th next iteration of the interim government was in rumours that emerged alleging that some people close to President Buhari were hatching a conspiracy to impose an interim government and have the then coming elections postponed. As soon as those rumours surfaced, President Buhari once again spoke and assured Nigerians that the elections would hold and power would be handed over to the winner of the presidential race. What I find confusing is the re-fashioning of fears about the abortion of elections for an interim government in a totally different context, in which the elections have already taken place and a winner has emerged, even if the election results are in court, which in the Nigerian context is normal.

Emotions over the elections remain high and hurtful actions and words have been expressed over the period. Nonetheless, it is important to state that Nigerian elections have been improving steadily since 2011 and while significant problems remain, the only meaningful approach is to continue the advocacy for the continued improvement of the quality and integrity of our elections. The Voices of Man and God May Differ

HE Imo State gubernatorial election in March, 2019 was a crowded field of seventy. A former Deputy Speaker of the House of Representatives and candidate of the Peoples Democratic Party (PDP), Emeka Ihedioha came first with 273,404 votes. Coming a distant second was Uche Nwosu of the Action Alliance who polled 190,364 votes. Third was Ifeanyi Ararume of the All Progressives Grand Alliance with 114, 676 while Hope Uzodinma of the All Progressives Congress (APC) – the ruling party in the country – with 96,458 votes, came fourth. Former Governor Ikedi Ohakim of the Accord Party with 6,846 votes came fifth. Ihedioha was accordingly sworn into office as the elected Governor.

However, Hope Uzodinma, the man who came a distant fourth in the elections, approached the Supreme Court making what appeared to be a laughable and hopeless case that in his pouch, he had votes from 388 polling units which a policeman who is not a member of the electoral commission, had collated for him. In still unclear circumstances, the Supreme Court admitted these unverified votes and awarded all to Uzodinma without indicating the votes scored by the 69 other contestants. Also, without evidence of Uzodinma meeting other constitutional provisions, the apex court declared him the State Governor!

A shocked Governor Ihedioha raced back to the Supreme Court urging it to review its decision in the interest of justice and democracy, but the gods of the court in a false sense of infallibility declared that whatever they decide is eternal: "it shall remain forever."

So, is the 'victory' of Uzodinma magic or miracle? If the argument is that it is only God that puts people in power, was he also the one that put Adolf Hitler in power who gassed six million Jews and ignited the Second World War that led to 75 million deaths? Was he the one that put King Leopold II of Belgium in power resulting in the massacre of 16 million Congolese just to satisfy his colonial greed?

One of the seven Lords who sat in judgement, Justice Centus Nweze, was a voice crying in the wilderness of justice. He pointed out, amongst other things, that Uzodinma had at the Election Tribunal admitted that he hijacked the result sheets from the electoral officials and completed the result sheets by himself.

He warned his fellow Lords that "the decision of the Supreme Court in the instant matter will continue to haunt our electoral jurisprudence for a long time to come." But his colleagues would not listen. So it came to pass that they imposed Uzodinma on the people of Imo State, hence the popular appellation of the

latter as a 'Supreme Court Governor' This is what Fela would have called 'Government magic'

But no matter the illusion, the Supreme Court Justices are mere mortals imbued with human frailties. However, matters took a spiritual turn when on July 2, 2021, the President of the Christian Association of Nigeria (CAN), His Eminence, Samson Ayokunle, travelled from his Oyo Town homestead and crossed the River Niger to go sanctify and beatify the controversial election results.



In the 2019 elections, his supporters sang approvingly in the streets that anybody who opposed him would be shot. Indeed, people were killed before, during and after the elections. Thugs celebrating his victory burnt alive Mrs Acheju Abuh, the PDP Women Leader right inside her

ver 30 junior athletes would be called to camp from the AFN All Comers, U-18 and U-20 Trials that ended at the Ahmadu Bello Stadium, Kaduna, the Athletics Federation of Nigeria (AFN) Technical Director, Samuel Onikeku has said.

Onikeku, an officer and Sports Secretary of Nigerian Customs Service, told sports writers in Kaduna that the performances recorded are laudable, "we are happy as a federation for bringing the All Comers, U-18 and U-20 Trials competitions to Kaduna to represent the Northwest. It's what the AFN president and board promised to do. We are happy that a national record is set. We have an U18 girl setting a national record and we are happy that 11 personal best times were set which is good for Nigeria.

"We are going to pick over 30 athletes from this competition for camping for the African U-18 and U-20 championships in Lusaka, Zambia. The AFN technical committee will meet to pick the team for the continental championship and present to the AFN board for approval and they would be called to camp in Abuja. From the camp, the team would depart for Lusaka, Zambia. We are happy to have good performances in Kaduna, the Ahmadu Bello Stadium track is one of the fastest tracks in the country and the whether is always competition friendly. So, another junior competition will be coming to Kaduna very soon."

Speaking in the same vein, Secretary General, Athletics Federation of Nigeria (AFN), Mrs. Rita Mosindi commended the

performances of the junior athletes, noting that Nigerian 100m hurdles world record holder, Tobi Amusan started same way when she attended the 2011 World Youth Championship in Athletics in Lille, France. She however called for sponsors to support AFN programmes, while urging athletics coaches and states associations to comb the grassroots for young talents.

"Some states are not here for the All Comers, U18 and U20 selection trials for the African U18 and U20 Championship in Lusaka, Zambia because they don't have grassroots programme. We registered over 700 athletes which is good for us. You cannot do without the grassroots because that is where we get young talents to replace the ageing stars.

"We are calling on sponsors to come in and help sponsor our programmes. We thank Premium Trust Bank for their support but we want more sponsors because we have lots of competitions for the year. We want to combine education and sports by engaging our youth from young age. We are looking at U13, U20, we are getting support from World Athletics to carry out grassroots programmes.

"I took Tobi Amusan to the 2011 World Youth Championship in Athletics in Lille, France, 11 years later she broke the world record. We have so many talents but we don't know how to harness them. The timings from our athletes here are very good. This is beginning of the season, the first event of the year and this is World Athletics Championship year, hopefully we would get more good performances as the season progresses," she added.
