

This followed a prolonged battle of superiority between the G-5 and the national chairman of the party, following the outcome of the party's presidential primary, which saw former Vice President, Atiku Abubakar emerge as its presidential candidate ahead of the 2023 general elections,

Kidnappers Demand N50m Ransom, Family Of Abducted INEC Ad-hoc Staff In Kogi Says

he kidnappers who abducted six adhoc Independent National Electoral Commission (INEC) officials in Kogi State have demanded N50 million for the release of their kidnapped victims. The victims were said to be returning from Kupa North and South under Lokoja Local Government Area in Kogi State before they were attacked by armed hoodlums. However, the Police

Public Relations Officer, (PPRO) in Kogi State, SP William Ovye Aya in a statement issued to journalists concerning the incident, said 96 persons were rescued by the Police, three were injured and two victims were yet to be accounted for. However, addressing a press conference on Monday on behalf of the families of the kidnapped victims in Lokoja, an Assistant Presiding Officer II, (APO II) in the March 18th Kogi House of Assembly election identified as Babalola Oluwatobi Peter said his sister was part of those who are still held in

captivity.

Peter, who is a brother to one of the victims therefore faulted the claim from the Nigeria Police Force that all the kidnapped victims have been rescued.

According to him Muhammed Maimunat and Abdulrahman Raji, who are two serving Corps members are still being held captive.

INEC Ad-Hoc staff who are still in captivity according to Peter are Oyaniran Atinuke Ruth, Florence Shayo Ajayi, Opara Tina and Blessing. Narrating the ugly incident, Peter said "We were coming from Kupa North and South for the Kogi State House of Assembly election. I worked in the North, so we left the North some minutes past six and we got to the South at 8:03 PM when we were asked to move to Lokoja by our SPOs.

He said that he resisted the temptation of going to Lokoja that night just like Corps members who supported his position but the SPO south said he wanted to move.

"When we got to Obajana, the armed robbers attacked us. We had six

vehicles and our car happened to be the second one" he said.

While the second vehicle mistakenly rammed into a culvert and could not move, the third vehicle hit us from the back he said.

According to him, of the three police officers, only one was armed When the armed robbers attacked us, the armed Police officer was the one who instructed us to pull off our white and run for our dear life.

"The incident happened between 1 am-2 am. Those people that were kidnapped were directly from our bus. We told the security agency including INEC that we are still looking for six people including my sister. They said we should not worry that we would find them", he said.

Much to his chagrin, he expressed his shocked when he read in some dailies that the kidnapped victims have been rescued.

"Nothing of such. They contacted us recently, demanding N50 Million" Peter claimed.

"The kidnappers keep calling us with different numbers. You cannot call them, but they can only

call you. They even told us to send them a recharge card which we did just because we don't want them to hurt my sister and every other victim in their custody.

He, however, called on the Government and security agencies to work towards the release of the abducted victims.

The husband of one of the victims, Olawafemi Olakanmi said he last spoke to his wife (Florence Shayo Ajayi) around midnight before the incident occurred. "I have not slept since my wife was kidnapped on 19th March 2023. I only call on God to set my wife free" he stated.

All efforts to speak with the Police Public Relations Officer, (PPRO) in Kogi State SP William Ovye Aya proved abortive as at the time of filing this report on Monday.

He failed to pick up calls or respond to text messages sent to his phone lines.

It would be recalled that some ad-hoc INEC staff were abducted in Obajana early on Sunday, 19th March 2023 during the Kogi State House of Assembly election.

Fire Guts Popular Balogun Market Again

n less than two months, another section of the popular Balogun market in Lagos has been gutted by fire. It affected the topmost floor of a five storey building where ladies shoes are warehoused. Property estimated to the tune of millions of Naira were said to have been destroyed by the inferno. The fire reportedly broke out at No 32 Balogun Plaza, a section renowned for the storage of ladies shoes at about 8.00am. However, no casualty was recorded during the fire incident due to the early arrival of emergency responders. As the inferno lasted, there were fears of further escalation as balls of fire billowed, thick smoke

took over sky, causing panic I'm the area.

As at press time, the cause of the incident could not be ascertained. But some witness attributed it to spark of electric power surge.

Operatives of the Lagos State Fire and Rescue Service, the Police, Lagos State Emergency Management Agency (LASEMA) and a couple of other agencies were on ground to cordoned off the area for rescue operation. The Director Lagos State Fire and Rescue Service, Margaret Adeseye confirmed the incident when contacted. She said the fire outbreak affected only the topmost floor of the five storey building, adding that it was brought under control as at 10.30am.

Following a distress call, the police operatives were said to have engaged a group of suspected terrorists, who were shooting sporadically along Yantumka road in Danmusa Council area of the state on Tuesday, 27th March, 2023 at 2.30pm.

The Command Police Spokesperson SP Gambo Isah in a statement made available to journalists said the Divisional Police Officer Danmusa Division, led a team of Policemen to the area, engaged the hoodlums in a gun duel and successfully repelled them.

It reads, "On 27/03/2023 at about 1430hrs, a distress call was received that terrorists in their numbers, shooting sporadically with AK 47 rifles, blocked Danmusa – Yantumaki Road, Danmusa LGA of Katsina state. Consequently, DPO Danmusa Division, led a team of Policemen to the

area, engaged the hoodlums in a gun duel and successfully repelled them.

"In the course of scanning the scene, one of the terrorists-bandits was neutralized and his dead body recovered. Additionally, one AK 47 rifle with twenty-two (22) rounds of 7.62mm live ammunition of AK 47 rifle was also recovered at the scene.

" Many of the terrorists were reasonably believed to have been neutralized and/or escaped the scene with gunshot wounds.

" Search parties are combing the nearest bushes with a view of arresting them and/or recovering their dead bodies.

" The Command is appealing to members of the communities around the area to report to the nearest police station any person found or seen with a suspected injury.

" The Command appreciates the efforts of the Police for the display of uncommon courage, gallantry and professionalism in dealing with the hoodlums, please".

reclaiming the presidency, lost in 2015 to the All Progressives Congress (APC). This is even as many were

of the opinion that the APC in its eight-year rule, performed abysmally, with the economy suffering down turn, alongside pockets of insecurity prevalent in several parts of the country.

The G-5 were aggrieved that Alhaji Atiku Abubakar emerged PDP

presidential candidate, arguing that power ought to have returned to the South, after President Muhammadu Buhari's eight years in office.

Kaduna Moves To Ensure 100% Immunisation Of Pregnant Women, Nursing Mothers

The Deputy Governor of Kaduna State, Dr Hadiza Sabuwa Balarabe has stressed the need for pregnant women and nursing mothers to ensure their children are fully immunised from polio and other preventable child killer diseases. Dr Hadiza Sabuwa Balarabe stated this at the Annual Ramadan Tafsir organised by the Federation of Muslim Women Associations in Nigeria (FOMWAN) held at Sultan Bello Mosque.

Dr Balarabe explained that children not fully immunised from polio pose great danger to other children in the community stating that "if one child contact the polio virus about 20 children are susceptible to contract the disease from him/her in the community". The Deputy Governor described as false the claim that polio vaccine prevents pregnancy saying since 1989 when the vaccine came and has been in use, there is no evidence showing that it causes infertility".

She also emphasised the need for hygiene and regular cleaning of the environment as key in preventing the spread of diseases. Dr. Hadiza Balarabe urged them to inculcate the habit of visiting hospitals for routine checkups during and after pregnancy.

"In Kaduna State, out of 100 children only 62% are fully immunised and we need between 85-90% immunization cover for the children population to protect all children from polio virus", she said.

She added that, "we still experience outbreak of measles in some communities. This is due to low immunization coverage because children that have not taken the vaccines put other children in danger"

The Deputy Governor expressed worries over the low skill birth attendance by women in the state, saying out of every 100 women who attended antenatal only 10 % give birth in health facilities, a situation she said is responsible for the high rate of infant mortality in Kaduna State.

Ramadan: Zenith Pathfinders Organizes Free Medical Screening For Muslim Community In Ogun

s part of the moves to ensure that Muslims are medically fit to observe Ramadan fasting, the Zenith Pathfinders on Sunday, organised a free medical screening, consultations and counselling for over 200 Muslim men, women and children in Adiyan Muslim Community, Agbodo Oja in Ogun state.

It was learnt that the free medical screening which was held at 296, Orodu Road at Ilese Bus Stop, Adivan in Agbado Oja was aimed at making the Muslims in the community to be medical fit for Ramadan fasting.

It was further learnt that the healthcare package that were given to the Adiyan Muslim Community included, free check of blood pressure, sugar test, as well as specialist consultation giving required prescriptions and drugs to people.

In a bid to also alleviate the

suffering of the less privileged, the Zenith Pathfinders also donated household item, shoes and cloths among other items to the Muslims.

Hajiah Aminah Yahya, who is the founder of the Zenith Pathfinders in an interview with Journalists, expressed joy seeing the smiles on the faces of people who benefited from the medical outreach and household items.

Hajiah Yahya said the purpose of the medical screening is to encourage the Muslims to know their medical status before fasting so that can be able to have a hitch-free Ramadan.

She said, "We are at the Adiyan Muslim community where we are holding our second edition of Pre-Ramadan Medical Screening. We started last year with over 300 participants but for this year we have over 200 participants. The essence of having this program before Ramadan is to encourage our people to know their medical status before Ramadan comes in. They have to know their health status so that they can take care of themselves before Ramadan so that they can have a hitch-free Ramadan. We also gave free household items like cloth materials, fans, freezer and others to over 150 Muslims." Speaking, Dr. Alabi Olarenwaju Usman from Nigeria Navy Reference Hospital, Ojo Lagos, who is the special consultant that attended to the Muslims at the medical outreach said that majority of the Muslims that participated in the medical services are medical fit to fast in the month of Ramadan.

52 Die Of Cerebrospinal Meningitis In 21 States NCDC

he Nigeria Centre for Disease Control (NCDC), has said that 52 persons were killed by Cerebrospinal Meningitis (CSM) in 21 states in the country between 2022 and March 5, 2023.

A situation report released on Monday, explained that as at March 5, a total of 628 suspected cases including 52 deaths (CFR 8.3%) were reported from 21 states in 2022/2023 CSM seasons.

According to the report, Abia, Bauchi, Bayelsa, Benue, Borno, Ebonyi, Gombe, Imo, Jigawa, Kano, Katsina, Kebbi, Kogi, Nasarawa, Niger, Oyo, Plateau, Sokoto, Taraba, Yobe and Zamfara were some of the states that reported the suspected CSM cases in 2022/2023. The report explained that

91% of all cumulative cases were from four (4) states of Jigawa (509 cases), Bauchi (23 cases), Zamfara (22 cases) and Oyo (14 cases).

The report gave 62% for males of the cases while 38% were females.

The report explained, "Ten LGAs across five states, Jigawa (7), Bauchi (1), Oyo (1), Plateau (1) and Zamfara (1), reported more than 5 cases each this CSM seasons 2022/2023." According to NCDC, the number of new suspected cases in epidemiological week nine decreased by 84% compared with epidemiological week nine.

Continued monitor of Cerebrospinal Meningitis response across states would be done by the national multi-sectoral Cerebrospinal Meningitis Technical Working Group (TWG).



Nigeria College Of Taxation, Fiscal Studies Bill Passes Second Reading

bill for an Act to establish the Nigeria College of Taxation and Fiscal Studies passed its Second Reading last week at the Senate.

The presentation of the Bill was made by Senator Abdullahi Aliyu Sabi CON on the floor of the Senate Tuesday last week, where he noted that the institution, if established would provide professional and academic training as well as certification for tax administrators, tax practitioners and tax professionals across the country.

In his presentation, Senator Sabi, who represents Niger North Senatorial District of Niger State stated that the College had become necessary given the important role that taxation is playing in the nation's economy, and that this institution would help formulate and draft tax policy for the country while addressing human capital gaps in the country's tax industry.

"It is becoming increasingly clear that diversifying the sources of government revenue to focus on sustainable sources is inevitable. This diversification puts taxation at the centre of the revenue mobilization discussion; the attainment of this laudable objective would require tax experts who have been properly and adequately schooled to formulate tax policy, draft and interpret tax legislation, carry on private tax practice, and administer taxation in the



competence, and adaptable personnel to man the tax system. There must be a conscious development of the field of taxation and fiscal policies in Nigeria to awake the society on the importance of taxation as a sine qua non to our development.

"Nigeria must go beyond the mere inclusion of taxation in the curriculum of educational institutions; instead the country must establish a modern system that facilitates the study of taxation via a well laid out academic curriculum, guided and focused by practical realities of Nigerian taxation and the revenue ecosystem," he noted.

Senator Sabi further

third parties, creating complications, multiplicity and uncertainty in the tax system," and that it would correct "aggressive and orthodox methods for tax collection" while also carrying out a "regular review of obsolete tax laws that do not reflect modern realities."

He noted that all these would help the country address its fiscal and revenue challenges and achieve the objectives of the National Tax Policy.

In his presentation, the distinguished Senator representing Niger North also cited that countries such as Kenya, Japan, India, Australia, Austria, Singapore, and Malaysia have established similar institutions for developing capacity in taxation, excise duty and customs and fiscal matters, and that this has impacted positively on their economy through significantly high tax-to-GDP ratios.

Kogi Vs EFCC: Court Adjourns Ruling On Asset Forfeiture To April 20

By; ADO ADEBOYE, Akure Federal High Court sitting in Lagos yesterday, fixed April 20, 2023, to rule on a Kogi State application seeking to vacate an interim order of court freezing 14 properties linked to Kogi State governor.

Justice Nicholas Oweibo fixed the date after taking submissions from the Governor's counsel, Mr Abdulwahab Mohammed SAN and the Economic and Financial Crimes Commission Counsel, Mr Rotimi Oyedopo SAN.

The court had on February 22, made an interim forfeiture order following an exparte motion to confiscate 14 properties and firms in Lagos, Abuja, and the United Arab Emirates as well as N400m, recovered from one Aminu Falala.

When the matter came up on Tuesday, the Kogi state counsel told the court that he had an application dated March 9, 2023 seeking to vacate the order of the court made on February 22.

Mohammed, while moving the application stated that about the third quarter of 2021, EFCC approached the court to freeze Kogi State's N20bn salary bail out loan that was allegedly hidden in Sterling bank.

He said that when the Kogi State government called Sterling Bank, the bank denied that such account existed, and that they challenged the freezing order made by Justice Tijjani Ringim that the order was obtained illegally.

Mohammed further stated that EFCC instead of apologizing, sent a press release that the money had been returned to the Central Bank of Nigeria.

According to him, the Kogi S t a t e Government approached the state High court, presided over by the present Chief judge justice Majebi who granted an o r d e r restraining the EFCC from having anything to do with Kogi State until the substantive matter was determined. He argued that the order of the

taking any step against Kogi State Government was still subsisting.

"The EFCC in flagrant disregard of the said Order of the Kogi State High Court and her pending appeal at the Court of Appeal Abuja Judicial Division, arrested one Ali Bello Nephew of the Applicant herein, who is an associate of the Kogi State Government on the 29th of November, 2022.

"That the EFCC in flagrant disobedience of the subsisting Order of the High Court of Kogi State, interrogated the said Alli Bello and coerced him to oblige them information pertaining to most of the properties listed in the Order of this Honourable Court made on the 22nd of February, 2023.

16 Bags Of Items Belonging To Victims Of Kaduna-Abuja Train Attack Remain Unclaimed - Kaduna Govt

xactly one year ago, on the 28th of March 2022, a horrendous attack was launched by terrorists on the Kaduna-bound train from Abuja.

The terrorists derailed the train at around 7pm by setting off an Improvised Explosive Device (IED) to blow up a section of the track.

They then opened fire on the coaches, and kidnapped scores of passengers from the train. In the heat of the confusion, a terrified passenger finally alerted the Ministry of Internal Security and Home Affairs on the exact location of the train, which was traced to Kasarami-Audujongom general area of Chikun LGA.

According to a statement signed by the Commissioner, Ministry of Internal Security and Home Affairs, Kaduna State, Samuel yesterday March 28, 2023, immediately, Major General K. Mukhtar, the then GOC 1 Division and Brigadier General UT Upuene, then Garrison Commander, moved with their brave troops to secure the train and rescue the remaining passengers. Subsequent developments confirmed that nine passengers were killed in the attack, with over 60 kidnapped and more than 20 injured.

Passengers injured were successfully evacuated by the troops, staff of Kaduna State Emergency Management Agency and other humanitarian volunteers, along with the remains of the slain passengers. After the search and rescue, troops carefully secured passengers' luggage and thereafter, handed them over to the Kaduna State Government on March 31, 2022.

Also supplied, was a detailed inventory of over 100 items of luggage and several loose belongings carefully labelled. Records confirmed that nine victims had already collected their belongings directly from the 1 Division Headquarters.

Consequently, the Kaduna State Government can now report that between 3rd April and 17th November 2022, 62 persons (victims of the attack or their relatives) came forward to claim 94 items of luggage containing a range of personal items.

Other loose belongings identified and retrieved from the Kaduna State Government by their owners include certificates, documents, passports, car and house keys, cash, ATM cards, mobile phones, tablets, laptops and their accessories, books, perfumes, as well as clothing and jewellery items.

As of the time of this update, 16 bags remain unclaimed, along with an assortment of loose belongings including prayer mats, books and clothing items.

"The Kaduna State Government will continue to maintain detailed records of all items collected, including the contact details of victims or their representatives.

"One year on, the Kaduna State Government again offers its heartfelt commiserations to all victims of the tragedy, and their families. The efforts of all security agencies in responding to the attack to secure the lives of many passengers are recognized and deeply appreciated.

"The window is still open for the collection of the remaining items at the Ministry.

"The Government appreciates the 1 Division, Nigerian Army for the brave efforts of its officers and men, and diligent collaboration with the Kaduna State Government following the attack. The Government similarly appreciates the 453 Base Services Group (Nigerian Air Force), the Department of State Services, the Kaduna State Police Command, the Nigeria Security and Civil Defence Corps, and the Kaduna State Vigilance Service. Gratitude also goes to the Borno State Government for valuable collaboration towards solutions to common problems.

"The Government pays special recognition to Major-General TA Lagbaja, the GOC 1 Division, Nigerian Army, who also doubles as the Force Commander, Operation Whirl Punch, as well as the officers and men of both land and air components; the Commander, 453 Base Services Group, Air Commodore AA Adedoyin; the Commandant, Nigerian Navy School of Armament Technology Kachia, Commodore ME Ejumabone; the Director of the Department of State Services, Abdul Enenche; the Commander, 402 Special Forces Brigade, Brigadier General EU Effiong and his Commanding Officers; the Commander Sector 7 Operation Safe Haven, Brigadier General TM Opurum; the Commissioner of Police,

Yekini Ayoku, the State Commandant, NSCDC, CC Idris Adah, and all other heads of security agencies engaged in the battle against terrorism. Stopping the elites from replacing Nigeria

By Owei Lakemfa. Owei Lakemfa published this piece exactly two years today.

leapt for joy last week. News about Nigeria is usually depressing. But this one was elating. I had in my column titled: 'A country led by the blind and deaf ' highlighted the case of 14-year-old Habiba Gwaram, a student of Government Girls Secondary School, Jangebe, Zamfara State. On February 26, 2021 she had been kidnapped by bandits along with 316 schoolmates. But when the captives got to the kidnappers den, Habiba met her father, Mallam Iliya Gwaram who, along with her sister, had been kidnapped three months earlier.

The father had the presence of mind to quickly tell his daughter not to identify either him or her sister as they may be killed. The child did as told, but had to endure seeing him tortured. Four days later, she was freed with her mates. But she did not forget her father. When the freed girls met the state Governor, Bello Matawalle, she told him about her father and the fact that he and other victims were being held in the same place she and her colleagues were held. Her initiative paid off as the governor took steps to resume dialogue with the bandits leading to the release last Monday night of Gwaram and nine others.

The newly released were made up of three men, four women and of my life like l cried the day the girls were taken back because 1 felt it was the last time I would see my daughter."

I had wondered how the 14year- old Habiba was processing the whole nightmare of having her family kidnapped, she suffering the same fate three months later, enduring the movement through forests and darkness to the kidnappers den, finding her father and sister at the den, being unable to do anything, and leaving them there in the hands of conscienceless killers. The nightmare will not go away quickly, but had she lost her father and sister to the kidnappers, I am not sure she would never have recovered from the trauma.

Tragically for Nigerians, despite vows by President Mohammadu Buhari and his security chiefs that the abduction of school children will end, the trauma continues. Just last Thursday March 11, 2021, another batch of female students were abducted, this time from the Federal College of Forestry and Agriculture Mechanization, Mando, Kaduna. While the recent mass abduction of school children had been mainly in rural or semi urban areas, this one is right in a busy city which was the capital of Northern Nigeria. The school is close to the Nigeria Defence Academy and is in the same area we have the Kaduna International

Airport and the Air Force Base. The media reported the bandits shooting for hours and rounding up the students without any arm of the security services responding. Yet, we have all sorts of security agencies and chiefs marching around with stars and peeps peeping from their uniforms. I have thought a number of times that if we have a serious government, it should send home a service chief or head of security agency each time school children are abducted en-mass. But this is wishful thinking as even those chiefs who had extended their stay in the military and overstayed their welcome, were eventually sent forth with

1 postings as i f t h e Nigerian foreign relations terrain is a place to reinforce failure. As for the Police Force, expecting it to meet the expectations of the citizenry is like Waiting for Godot; even the Inspector General of Police, Mohammed Abubakar Adamu, going by the provisions of the 2020 Nigeria Police Act, is n o t а policeman.

The bandits seem to perceive that there is a lack of will to

protect school children. That must be the reason why between December 11, 2020 and March 11, 2021; a three-month period, about 800 school children have been kidnapped in Katsina, Kankara, Kagara, Jengebe and Kaduna. These victims are part of the children in school; there are some 13 million out of school children who are simply abandoned to their fate. A few months ago, as I drove towards the Veritas University, Bwari-Abuja, I noticed a crowd at the Bwari-Veritas junction. I slowed down trying to make out what was amis. I noticed no sign of commotion as motorists on both sides drove freely. I slowed down at the intersection only to discover that these were street children newly off-loaded on Abuja. Some were already 'empowered' with begging bowls, many were yet to be so



enriched. I slowed down and began to count. When I got to 36 which is three dozens, I stopped. These children are all over Abuja; obviously far from home, out of parental care, unlettered, unskilled but determined to survive. They are now so many and competition amongst them so strong that some have invented new means of begging an increasingly impoverished populace. Somebody told me of an experience in Kubwa, one of the largest satellite towns in Abuja. There was a knock on an office door which was in a gated premises. The manager and some of his clients involuntarily stood up as some homeless children walked in with their begging bowls. They calmed down when they realised it was not an invasion; just hungry children leaving the streets to press for alms. I have no doubt

that in the next few years, such visits by the street children would not just be to beg, but to demand with threats.

Tragically, our political elites who as coup plotters, beneficiaries of military regimes and conscienceless administrations, led the country to its present quagmire, do not seem to have woken up to reality. They are still having a ball and 'privatising' the country's resources. I had analysed this parasitic class long ago and thought the best thing is to replace them, but today, I find myself and many patriots struggling to ensure that these political elites do not replace the country. Left to them, rather than fix Nigeria, they will prefer to sell it to the highest bidder, preferably in foreign currency as they have so bastardised the Naira that they no longer find it useful.

three children. This was the reason I leapt for joy. Hopefully, Gwaram's nightmare would have come to an end with his rescue, but the experience will always replay in his mind. He gave a first-hand account of the abducted girls: "I have been in captivity with these other people for more than three months when on that Friday morning, 1 saw the school girls being brought into where we were camped by our abductors. At first, 1 didn't know who they were or where they were coming from, until I saw the face of my scared daughter looking at me...I never cried in the whole

he gubernatorial candidate of the New Nigeria People's Party (NNPP) in Ogun State, Ambassador Olufemi Ajadi Oguntoyinbo yesterday, hailed the state election petition tribunal for granting the party's request to inspect all Bi-modal Voter Accreditation System (BVAS) machines and other sensitive materials used for the March 18 2023 polls.

Ambassador Oguntoyinbo in a statement personally signed by him, praised the tribunal for granting the party's prayers over omission of the party's name on the ballot during the gubernatorial and House of Assembly elections in Ogun State.

According to him, NNPP complained that INEC did not print the name of the party on the governorship ballot papers, as prescribed by the Electoral Act.

Ambassador Oguntoyinbo stressed that omitting the name of the party on the ballot paper was a ploy to rob him and the party the victory in the just conducted gubernatorial and state Assembly elections.

The NNPP governorship candidate then called for the rerun of the election in

Ogun state so that the party's name will be properly inscribe on the ballot paper.

New Nigerian recalls that the Ogun state election petition tribunal granted all the prayers of the NNPP in the motion exparte filed on Friday to challenge the omission of its name on the ballot paper in the state.

The party headed for the tribunal on the ground that this act has disenfranchised its members, loyalists, supporters and the masses from voting for the party during the guber and state Assembly elections.

NNPP in the motion ex-parte supported it with an eight-paragraph affidavit deposed by the State Chairman of the party, Olaposi Oginni asked the tribunal to allow it make photocopies, scan and record all sensitive materials used by INEC in the March 18 governorship election, ahead of its petition and that it would seek the nullification of the governorship election in Ogun due to the omission of its name on the ballot papers. Granting the party's prayers, the Chairman of the tribunal, justice Argum Ashom agreed with the NNPP on the prayers, "in that effect the reliefs are granted as prayed."
