He lamented that the lingering insecurity had brought all development initiatives to a standstill, saying that as it, people hardly go to farm or go for business activities for fear of the unknown, stressing that these are things they are trying to make people understand in order to live a harmonious life.

He further lamented, "The situation has drastically affected agricultural production; people no longer go to the farm for fear of being killed. Just two weeks ago, some people were killed in their farmlands. Not in their houses. In their farmlands with hoes in their hands." According to him, houses

are being destroyed, food reserves burnt, agricultural activities brought to abrupt halt. Intergroup relations tainted with suspicion, adding that it is not good looking at how many grow up where people of different ethnic groups live together without any problem in the past.

The council chairman lamented that resources that would have been used

to bring about development in the local government were being channeled into addressing the fallouts of the crises.

He added that presently, more than 20 survivors of the attacks receiving treatment at Sir Patrick I brahim Yakowa Memorial Hospital, Kafanchan and Bingham University Teaching Hospital, Jos, saying that the victims are in dire need of help in order to come back to life.

He stressed that those whose houses and food items were destroyed by the attackers also need immediate help to rebuild their lives, appealing to the federal and Kaduna governments to come to their aid to cushion the effect of their present predicaments.


"We feel very much fulfilled about that airport, and people have not stopped talking about it.

he Action Alliance (AA) has said that it withdrew the petition challenging Tinubu's victory at the Presidential Election Petition Tribunal in Abuja, because of unity of the nation, saying the party would not want to be the reason Nigeria will be thrown into another horrific experience similar to June 12, 1993 Presidential elections believed to have been won by late Chief MKO Abiola of the Southwest extraction.

The chairman of the party Honourable Adekunle Rufai Omo-Aje, disclosed this in a statement made available to the media in Kaduna on Monday May 8, 2023.

The party added that as active democrats in the democratic experiment, they shall not be used by proponents of the interim government to achieve their concocted agenda of taking over the government through the back door.

"These two men among others, had their parties winning positions in the elections, yet they never approached this Presidential Elections Tribunal, in spite of their party loses.

"For this also, we considered many other reasons as canvassed by some of our leaders, we see no sense in furthering on with this protest petition.

"One of the reasons advanced by some of our leaders as well, is the believe in the ability of Asiwaju Bola Ahmed Tinubu, being a proponent of restructuring, which has been one major reason why we have the barrage of agitations in our land today, to evolve a kind of policy that could engender resurgence of trust in our togetherness as a national entity.

Navy Hunts Illegal Security Maritime Outfits, Warns Against Enlistment

Authority of the Nigerian Navy have warned unsuspecting members of the public to shun the purchase of forms of fake security outfits and impostors currently ongoing.

he authorities asked that anyone with useful information about the impostors and illegal maritime outfits should be forwarded to the Nigerian Navy so as to facilitate the arrest of the miscreants".

The Navy listed some of the proscribed maritime outfits operating illegally in the nation as "Nigerian Merchant Navy, Nigerian Merchant Navy Coastal Defence Force, Nigerian Coast Guard, Merchant Navy Maritime Academy, Nigerian Merchant Navy Coast Guard Security and Safety Corps, Maritime Security Agency and Nigerian Maritime Law Enforcement Agency amongst

others".

Director of Naval Information, Commodore A.O. Ayo-Vaughan made the disclosure in a statement titled, 'Worrisome Activities of Impostors and Fake Maritime Security Outfits'.

It reads, "The Nigerian Navy (NN) has noted with dismay the unscrupulous activities of some impostors and self-acclaimed maritime security outfits who make use of naval uniforms and accourrements including uniforms that resemble naval uniforms to deceive, harass, intimidate, and defraud unsuspecting members of the public.

"Some of these outfits go as far as selling recruitment forms to the public and even conduct secret recruitment exercises and training.

"The activities of these impostors and miscreants are observed to be on the rise notwithstanding the proscription order of the Federal Government of Nigeria official Gazette No. 58 Vol 100 titled "the Dissolution and Proscription of Certain Associations Order, 2013" banning all such firms/outfits.

"The Order in Paragraph 2 states that "As from the commencement of this Order, the dissolved and proscribed associations shall not be formed into any new associations by whatever name or title, within the meaning of this Order".

"Suffice to state that the NN in the past had arrested and handed over for prosecution, members of some of these outlawed organizations.

"Nevertheless, their illegal activities have continued unabated in some parts of the country, particularly the South-South geopolitical zone.

"Pertinently, the proliferation of illegal maritime security outfits is worrisome and may worsen the scourge of insecurity in the country with likely grave impact on national security.

"It has therefore become necessary to notify the public and appeal for caution.

"Relatedly, information about these impostors and illegal maritime outfits should be forwarded to the NN so as to facilitate the arrest of these miscreants.

"Essentially, operatives of the NN in conjunction with other Maritime Law Enforcement Agencies will continue to maintain vigilance in order to locate, promptly apprehend and prosecute these miscreants in accordance with the laws of the land.

"The public are thus enjoined to report any suspected impostor or fake maritime security personnel to the nearest police station and/or naval base.

"In addition, the public are advised not to patronise or purchase entry/recruitment forms from these proscribed outfits. "Report suspicious behaviour of any group of persons or organizations who claim to be personnel of the NN or who are found dressed in or in possession of naval uniforms and accoutrements or similar uniforms and accoutrements including those conducting fake recruitment and naval training.

"The Nigerian Navy does not sell entry/recruitment forms to the public as is the practice of some of these fraudsters.

"Hence, anyone selling recruitment forms is not naval personnel but an impostor.

personnel but an impostor.

"The perpetrators of these illegalities are warned that the Nigerian Navy as statutorily empowered, will leave no stone unturned in her bid to secure the maritime environment for enhanced security of lives and properties and for the conduct of legitimate maritime commerce and related economic activities.

NUT Commends Kaduna Govt Over Sacked Teachers Recall

aduna State Chapter of Nigeria Union of Teachers (NUT) has commended the state government for reinstating 1,288 public school teachers that were earlier sacked after the competency test.

In a letter dated April 5, 2023, which had reference number NUT/GO/G7/Vol 4/732 and signed by state secretary, Adamu Ayuba Kaltungo, the union appreciated the "kind gesture extended to our esteemed members who were affected by this government policy."

According to NUT, the reinstatement will "go a long way in bridging the gap of the teacher-pupil ratio being experienced in the public primary school sector."

It would be recalled that Kaduna State Universal Basic Education Board(KADSUBEB) had sacked 2,357 primary school teachers over the competency test in June 2022, explaining that 2,192 teachers were dismissed for their failure to sit for the test, while 165 teachers were sacked for poor performance.

F U N M I After written complaints, the board reviewed some cases, where some affected workers claimed that they were kidnapped at the time of the test, while some claimed that they were central administration staff and as such, were exempted from the exercise.

In April, KADSUBEB reinstated 1,288 sacked teachers, arguing that "having examined and verified their complaints, the state government approved the reinstatement of 392 teachers, who wrote and passed the test, and 515 central administration staff that were officially exempted from the test.

"Others are: 298 teachers, who were verified to be sick at the time of the test, as well as 61 teachers that were kidnapped or involved in accidents verified by their respective Education Secretaries.

"Also, 22 teachers, who were permanently removed from the payroll for unsubstantiated claims were equally reinstated, amounting to a total of 1,288 reinstated workers," KADSUBEB had explained.

"The North would be demanding for leadership of the National Assembly, including the President of the Senate and the Speaker of the House of Representatives.

"The North has 68 per cent stake in Nigeria and would not be begging for appointment of positions like Secretary to the Government of the Federation (SGF), which can be fired at any time by the president

"The case of Babachir Lawal readily comes to mind. We will make our demands being the ones who produced the highest votes that produced the president," the source said. The insider who is one of the conveners of the meeting, pointed out that in 2011, the North voted Goodluck Jonathan and decided to vote him out and vote Muhammadu Buhari in 2015.

"In 2023, in the spirit of equity, we looked the other way against our kinsmen and gave Bola Ahmed



Tinubu the highest number of votes.

" We expect to demand positions in his government. Some of our demands would be that of Central Bank of Nigeria (CBN) Governor, Minister of Finance and other positions taken at our meeting tomorrow," the source hinted.

He further explained that they want someone who understands the region and feels their pains to be the CBN Governor so that

some of the problems they are facing can be adequately addressed.

" Look at Yobe State for example, only two banks are operating there, one is the micro finance floated by the state government. Fifty million Northerners don't have bank accounts. How then would they transact business, but through cash. We want someone who understands that," he said.

He said that the CBN under Sanusi Lamido understood that and issued licences to bureau de change operators and there was multiplying effect in the economy then.

He disclosed that a communique which will be well publicised would be issued at the end of the meeting, clearly spelling out the demands of the North which are expected to be met by the incoming administration.

"If they are not met, the North will decide to take its 68 per cent and invest elsewhere in 2027," he revealed.

Plateau Civil Servants Embark On Indefinite Strike Over Unpaid Wages, Other Demands

ivil servants under Public Service Negotiation Council Plateau State Chapter, has announced the commencement of an indefinite strike action over unpaid wages and other demands.

According to the workers, effective midnight of Wednesday 10th May 2023, they are downing tools in order to press their demands presented to the Plateau State Government which according to them, are yet to be addressed.

This position was contained in a letter

addressed to the Head of Civil Service dated 10th May 2023 and made

The letter which is titled, "NOTICE OF INDEFINITE STRIKE ACTION", signed by Titus I. Malau and Timothy Gopep, Chairman and Secretary of the Workers Union respectively reads that "At the expiration of our four (4) days extension to the earlier seven (7) days ultimatum given to government to address the demands of workers in our letters dated 19th April 2023, 3rd May 2023.

"Also, following the

meeting of 10th May 2023 with the Head of Civil Service and the Secretary the umbrella of the available to journalists in to the Government of the Joint National Jos the Plateau State State in attendance, it is evidently clear that Government has not shown enough commitment to address the issues as presented in our charter of demands before its tenure expires as earlier presented," the union said.

The union disclosed that following a joint meeting between the Joint Council $a\ n\ d\quad N\ L\ C\ /\ T\ U\ C$ Leadership, it was resolved that an INDEFINITE STRIKE ACTION be declared from midnight of 10th May, 2023.

The union however, assured government that they are readily available for discussion even as the strike continues.

The workers are alleging that the Simon Lalong-led administration among other things, is owing months of unpaid wages, even though some claimed that they have been paid up to February 2023 salaries.

The state government is yet to work out who respond to this development as at time of filing this report.

Efforts to speak to the commissioner or information on this matter was not successful as he could not pick the repeated calls.

Bandits Kill Woman, Burn Houses In Zango Kataf

Uyo oncerned by the need to check HIV 'AIDS prevalence in Akwa Ibom State and to ensure free and supportive environment for all, Governor Udom Emmanuel has been called upon to sign the HIV Anti-Stigma a n d Discrimination Bill into law.

Number two (2), People will be free to come out of their closet to disclose their status and live comfortable, because without disclosure and we are talking about epidemic control, it will not be, it can't come to board and I am really pleading with my governor.

Bauchi Governor Flags Off 2023 Farming With 2bn For Purchase Of Raw-materials

*Announces sale of bag of 50Kg NPK Fertilizer at N15,000:00 as against N17,800:00 *Prays for a bumper harvest this year

overnor Bala Abdulkadir Mohammed of Bauchi State on Tuesday, launched the sales of fertilizer for the 2023/2024 farming season with two billion Naira committed for the purchase of raw-materials to produce fertilizer for the farming season. This was disclosed in a statement

This was disclosed in a statement signed by the Special Adviser on Media and Publicity to Bauchi Governor, Muktar Gidado, made available on Wednesday May 10, 2023.

It explained that at the launching of the sales of fertilizer for the farming season held at BSADP office in Azare, headquarters of Katagum local government area of the state, the governor said, already his administration has settled all the outstanding debt to the Nigerian Sovereign Investment Authority.

Governor Bala Mohammed said the state government has also committed some funds to the maintenance of the Bauchi Fertilizer Blending Company to ensure seamless production of the commodity.

According to him, the consistency in conducting annual sales of fertilizer and farming season is a clear manifestation of the desire of his government to invigorate the agricultural sector for the social and economic development of the state.

He said in an efforts to diversify the economy of the state and ensure food security, agricultural sector would continue to be given the priority it deserves as agriculture is the main source of livelihood of the majority of the people of the state, especially those in the rural areas.

"It is to the glory of Allah (SWT) that we are gathered here today to launch the rainy season farming and flag-off the sales of fertilizer for the 2023/2024 farming season. The fact that we have never missed the launching of the farming season and annual livestock vaccination for a single year since we came on board as a government four years ago, is a testimony of our commitment to massive crop and animal production.

"It is however a matter of concern that the majority of our farmers have not embraced modern agricultural practices. There is therefore the need to deploy agricultural extension workers to required knowledge and skills to Indeed, the role of extension workers in any agricultural activity cannot be over emphasized.

"At this juncture, I want to draw the attention of our farmers to this year's Seasonal Rainfall Prediction (SRP) by the Nigerian Meteorological Agency which indicates that in most parts of the State, planting season is going to start towards the end of this month (May), and there may be flooding in some parts. I therefore want to urge farmers to make good use of this information to avoid planting in an area that is highly susceptible to flooding.

"It would also be recalled that at the beginning of last year's

planting season, we experienced outbreak of Army-worms in some parts of the State. Although concerted efforts were made to control the worms, little success was recorded due to the rapid spread of the menace. This resulted in the destruction of crops on many farms. In order to avoid a recurrence of the incident this year, the Ministry of Agriculture has been directed to immediately submit their requirements for the control of the Army-worm menace for approval."

The governor also said in an effort to address the inadequacy of extension workers in the state, the Ministry of Agriculture has been directed to forward proposal for employment of extension workers and other agric-related personnel to the office of the Head of Civil Service for onward submission to the Civil Service Commission.

He noted that, in the continued effort to provide farm inputs to teeming farmers this year, the State Government has through the Bauchi Fertilizer Company (BAFCO) blended 200 trucks of NPK 20:10:10 fertilizer and production of the commodity and directed the Ministry of Agriculture to ensure that the fertilizer is taken to each District and Ward in the state.

Governor Bala Mohammed who announced the sale of a bag of 50 Kg NPK 20:10:10 (Dan Bauchi) Fertilizer at N15,000:00 as against the cost of production of N17,800:00, said government will provide fertilizer on loan to









interested civil servants in the tate to be paid on instalments through deduction from source.

"As a government, we are worried about the low level of farm mechanization in the State. Consequently, we have arranged for the supply of 70 units of tractors and implements. The decision to prioritize farm mechanization in the State is aimed at minimizing human labour in crop production. We will henceforth be committing more resources for the development of this sector.

"It may please you to know that I have given an anticipatory approval for the allocation of at least 10% of the total budgetary

allocation of the State for the development of agriculture. The Honourable Commissioner of Agriculture is therefore directed to forward the approval Assembly for ratification.

"We are very much aware that our price for a bag of fertilizer is below the price tag by most of our neighbouring States. There is therefore every tendency that middlemen would take advantage of the subsidy to sell the commodity at higher cost. Ministry of Agriculture is therefore directed to collaborate with law enforcement agencies to apprehend and deal with such middlemen according to the

Why Yari Is Unstoppable As Senate President - Dambatta

Nasir Dambatta is the President of the North West Progressives Forum. In this interview with newsmen, he explained why former Zamfara State Governor, Abdulaziz Yari should be the Senate President of the 10th National Assembly. Excerpt:

hy are you rooting for Senator Abdul'Aziz Yari when the APC has reportedly already decided on Godswill Akpabio?

First, Yari is a candidate from the North West, with vast executive cum-legislative experience. Secondly, the North-West is on record to have provided the highest percentage of votes of over 30%, over and above every other geopolitical zone in the country.

Let us not forget that the president-elect scored a total of 8.79 million. That was how the North West emerged tops with 30.0% votes cast in the entire presidential elections. Even T i n u b u ' s i m m e d i a t e Constituency of South West came second with 25.9%.

The North Central came third, with 20.0%, while the North East came fourth with 13.5%. The South South came fifth with 9.10%, while the South East came a distant sixth with a mere 1.45%.

On the scale of electoral fortunes in that election, Yari's Northwest beats all. That is why our North West Progressives Forum cautioned president-elect not to support the underperformed geopolitical zone in the presidential elections.

We still think Yari is the best among all the people in the race. Our position is not with prejudice to the stand of the All Progressives Congress (APC) because the ruling party is also entitled to their opinion in a democracy, though massive protests against APC's choice of Senate Presidency and Speakership are still raging in the media. I saw South West governors from Tinubu's immediate Constituency, rejecting the APC stand. I saw Coalition of Northern Groups(CNG) warning against what they see as direct imposition on the National Assembly.

The story is no less different at the House of Reps too, as some n e w s p a p e r s alleged underground moves to deal blows on current leadership under Rt Hon Gbajabiamila. It is now very difficult to conclude that the APC's final decision is popular enough.

On what premise do you think Yari is a comparatively better choice for the Senate President slot than say Akpabio or Orji Uzor-Kalu?

It is on record that Yari has been in the APC for many years, and his membership predates the merger that led to the formation of the APC itself. Let us not forget that Yari was a powerful force since the era of ANPP.

He was once a party secretary that handled many internal crises in Zamfara State when democratic space was seriously overheated.

He neutralized opposition and brought the party back to its feet. He calmed frayed nerves and made the party even stronger than it was before the internal wrangling. Please check your records and tell me when Senator Akpabio joined the APC; exactly how long? When did Senator Orji Uzor-Kalu join the APC? You see, in politics, you cannot overlook how much input a loyal party member has made into the success of the party. I dare say that Yari has spent hundreds of millions to support party activities and remains a oneman squad against hunger and poverty in Zamfara State, even after his exit as governor of the

He was very generous to the poor people of his immediate constituency, and that is why he won the Senatorial election fair and square. I doubt if there is a strong basis of comparison between Yari and the duo of Akpabio and Uzor-Kalu.



What facts do you have at hand to justify Yari's suitability when he is just a first-time senator?

The issue of first-time Senator being a back- bencher has since been demystified by some senators in the outgoing Senate. Look at how a so-called first timer, Senator from Kaduna Central, moved several motions and initiated over 30 bills in less than two years. Look at how his bill on repeal of old banking laws became the first bill ever, to be signed into law by President Buhari

There are many first time Senators who made giant strides in their legislative activism. Most importantly, Senator Tambuwal from Sokoto, for instance, is first-time Senator today, but he was once a Speaker in the House of Representatives. Again, our most-favored contestant ---Abdul'Aziz Yari was a Honorable member of the House of Representatives and he is therefore, not new to legislative business. That's why our group remains unperturbed by the infantile argument of first-timer and old-timer Senators.

Don't you think having Yari as Senate President would amount to another same-faith executive and legislative arms combination?

Well, as a group, we are looking at what the constitution says as opposed to sentimental arguments of faith-based affinities. No where in the entire Nigerian Constitution has religious affinity been mentioned as a point of consideration for any elective office. No political or even appointive office in Nigeria has anything to do with which religion you profess. What is abundantly clear in the Constitution is what geopolitical zone you belong to. There is no mention of Muslim or Christian affinities as a basis for the electoral contest.

How do you think a Yari-led Senate would be different from what we have been seeing since 1999?

Our group forsees a dogged fighter for democratic and social justice. We forsee a more harmonious legislative and executive relationship with Yari as Senate President because he served both ways and acquired the requisite experience. In terms of screening of competent nominees of the incoming president, we forsee the Senate adept at the grilling of nominees and end of the era of bow-and-go screening of presidential nominees (laughter).

WPFD: Freedom Of Expression Must Be Regulated - Oyo Correspondents' Chairman

*Says regulation will prevent provocation, disruption of peaceful co- existence

he Chairman of Correspondents' Chapel of Nigeria Union of Journalists (NUJ) in Oyo State, Comrade Adebayo Raji has advocated regulation on freedom of expression particularly on social media.

Comrade Raji who made the call on Wednesday while delivering a paper at the 2023 World Press Freedom Day organised by the National Association of Seadogs (Pyrates Confraternity) Webinar, said this is necessary to avoid unnecessary provocation, disruption of peaceful coexistence.

Speaking on the topic, "Press Freedom and Nation Building: Prospects and Challenges", the Correspondents' Chapel Chairman said press freedom, which can also be referred to as freedom of expression is a right that can't be restrained or repealed by human laws, but must be put into check to avoid abuse being experienced on social media.

Emphasizing that freedom of expression is guaranteed by Section 39 of the 1999 Constitution of the Federal Republic of Nigeria (as amended), Comrade Raji cautioned the citizens to know that there is no absolute freedom of expression anywhere in the world, particularly, in Nigeria.

"The press freedom, which we can also be referred to as freedom of expression is a right that can't be restrained or repealed by human laws, sometimes it is called natural rights, but it must be regulated to avoid unnecessary provocation, disruption of peaceful coexistence and other forms of disunity", he said.

Comrade Raji added, "It is the right to express views publicly through various means of mass communications. It can be through public protest and demonstrations, or through published articles, books or leaflets; television or radio broadcasting; works of



art; the internet and social media.

"The law also provides and protects the freedom to receive information from other people by being part of an audience or reading a magazine or newspaper, listening to the radio, watching television, reading information on social media and so on. But the way some people are operating social media in form of propaganda, misinformation and disinformation is alarming and needs to be put to check by regulation"

Comrade Raji stressed, "The Freedom of Expression is guaranteed by Section 39 of the 1999 Constitution of the Federal Republic of Nigeria (As Amended).

Section 39 (1) of the 1999 Constitution, Federal Republic of Nigeria provides inter alia that "every person shall be entitled to freedom of expression, including freedom to hold opinions and to receive and impart information without interference'.

He urged media practitioners to get in touch as a kind of reaction from the person or people or organisations involved in the information they want to disseminate to get more facts or the other side of the story.

"We should also note that there is no absolute freedom of expression anywhere in the world, particularly, our dear country, Nigeria. This will lead us to Section 37 of the 1999 Constitution, which provides that: The privacy of citizens, their homes, correspondence, telephone conversations and telegraphic communications is hereby guaranteed and protected."

"At this point, what can we do not to fall victim against Section 37 of same Constitution. We need to verify and double check that the information we want to disseminate to the public is fact. We should get in touch as a kind of reaction from the person or people or organisations in volved in the information we want to disseminate to get more facts or the other side of the story".

Capon, Jolly Rogers Deck, National Association of Seadogs, Olufemi Adesope in his welcome address, said the webinar was organized as part of citizens' summit objectives and that the event was organised in order to interface with the public.

"To interface with the public and advance our core agenda on humanitarianism and public advocacy for citizens rights and improved welfare condition – targeted towards a just society built on strong institutions, peace and responsible governance," he said.

Gov Makinde's Reforms Of Oyo State Chiefs Law, Long Overdue - Group

*Says Ibadan Mogajis, Baales, traders, others happy

he Convener of Oyo Renaissance Forum, a Socio-cultural group, Chief Adeola Areago on Monday, declared that the planned move by Governor Seyi Makinde to reform the Oyo State Chiefs Law is long overdue.

Chief Areago in a statement, said the news of the planned review of the Chiefs Law of Oyo State is already being a p p l a u d e d b y a l l stakeholders, including Mogajis in Ibadan, Baales, traders and others.

According to him, Ibadan Mogajis, Baales, market men and women, Chiefs and others are happy with the Governor, Engr Seyi Makinde over planned move to reform the Oyo State Chiefs Law, saying they believed that once the bill becomes law, it would allow for the wearing of beaded crowns by Senior chiefs in the State especially Olubadan In-Council and some notable Baales of ancient towns and villages.

"As a potential beneficiary including other Mogajis, Senior Chiefs and Olubadan-in-Council members, everybody is happy with the Governor. The planned review of the law to allow for the wearing of beaded crowns by a number of qualified chiefs shows the Governor of the State as a responsible and responsive leader committed to ensuring a better Oyo State and Ibadan in particular", he said.

Chief Areago added, "Many of our senior citizens; the elites whose legendary Baales in ancient communities deserve beaded crowns to become more respected in the comity of other monarchs across the State, are also happy with His Excellency"

"The State lawmakers should also be commended for its move to fast track the passage of this bill. Their names would be etched out in history alongside His Excellency for making the long-awaited dream a reality.' The United Kingdom based historian and scholar tasked Gov Makinde to show more commitment to the executive bill on the matter currently before the State House of Assembly and ensure timely passage of same in order to make the long-awaited reform of the State Chiefs Law a reality.

' I have seen various statements supporting the proposed amendment of Chiefs law by the Governor. This is highly commendable. The governor should go ahead with his

action for now. He should ignore critics. It is normal. Once it becomes law. Law is Supreme. And everybody would just have to re-adjust to the new reality in Ibadan and Oyo State in general.

'It is therefore, a thing of joy that the new law would give the Governor the power to be the prescribing authority on all chieftaincy matters.

Not only that," another source who is in the known of Obaship issues, explained, "this bill, if passed into law, empowers the Governor as the sole appointing authority for Obas and Chiefs without any recourse to the Council of Obas — thereby removing all checks and balances.

It would be recalled that the state's Attorney-General and Commissioner for Justice, Prof Oyelowo Oyewo disclosed that many of the requests to the state governor by traditional leaders known as Baales to wear beaded crowns at different domains across the state have remained pending for so long because of the inability of the council of Chiefs to meet.

He noted that the absence of the state Council of Chiefs which ought to interface with the governor before granting approvals for such requests have not also been able to sit for necessary deliberation over a long period of time.

The Attorney General added that these factors necessitated the proposal by the state executive council headed by governor Makinde to amend section 28 of Oyo state Chiefs Law in order to further improve the process and that the proposed amendment, when fully effective, will empower the state Governor as the sole authority without consultations with the Chiefs to grant approvals for wearing of beaded crowns.

Oyo state Commissioner for Local Government and Chieftaincy Matters, Barrister Olasunkanmi Olaleye, while shedding more light on the proposed amendment bill said, "the state executive council deliberated on section 28 sub section 1 of the Chiefs Laws of Oyo state.

"The law as it is today is that the Governor can only approve application for beaded crown after consultations with Oyo state Council of Obas and Chiefs but we all know that Council has not met for a very long time now and we have a lot of applications for approval of beaded crowns. So, that section 28 of the law has now been amended to give the governor sole authority to approve application for beaded crown in Oyo state without consultations."

Customs FOU Zone B Makes 188 Seizures Worth Over N600m

he Nigeria Customs Service Federal Operations Unit (FOU) Zone 'B' has made a total of 188 seizures worth over six hundred and twenty-eight million Naira. This was disclosed by the Comptroller FOU Zone B, Musa Ibrahim Jalo at a press briefing held at the zone's headquarters in Kaduna yesterday, where he said the feat was recorded between March and April, 2023. He said the success was recorded, following the marching order handed over to their operatives under his command.

" It is my pleasure to welcome you all to this media briefing, meant to furnish you with information on the antismuggling activities of the Federal Operations Unit Zone 'B' of the Nigerian Customs Service between March and April 2023.

"Gentlemen of the press, you may recall that during the

handing and taking over of the mantle of leadership of the Unit on 27 January 2023; I tasked the operatives of the Unit to work hard to suppress smuggling activities in the Zone which led to series successes.

"During the period under review, our operatives made a total of One Hundred and Eighty Eight (188) seizures of Seventeen (17) different prohibited items with a total Duty Paid Value (DPV) of Six Hundred and Twenty-Eight Million, Two Hundred and Eighty-Six Thousand, Six Hundred and Sixty Naira and Sixty-Two Kobo (N628, 286, 660.62K) only at different locations in the Zone.

"Notably among the seizures are as follows:

"On 6th April 2023, the Operatives of the Unit while on credible intelligence intercepted One (1) Used Mitsubishi Canter with Registration Number AKR 10 XG conveying Sacks of Cannabis Sativa otherwise known as Marijuana concealed with Bags of Cassava flakes

(Garri) and Sawdust along Bungudu-Tsafe Road in Zamfara State.

"After physical examination, the vehicle was found to contain 46 sacks of Marijuana, with a street value of Two Million, Sixty Nine Thousand, One Hundred and Forty-Four Naira and Forty Kobo (N2, 069,144.40K)," he said

According to him, "similarly, on 23rd March 2023; our operatives arrested a suspicious white illegal narcotic substance together with Two (2) male suspects and One (1) locally made pistol in the course of our anti-smuggling operations at Maigatari axis of Jigawa State. The suspected illegal substance together with the male suspects was brought to the Office for further action.

"The Officials of the National Drug Law Enforcement Agency (NDLEA) Kaduna State Command were invited to carry out a test on the suspected illegal substance to determine its true nature. The test further proved

the illegal substance to be OPIUM Substance with a total weight of Four Hundred and Forty-Two grams (422g).

"The street value of the OPIUM substance is Thirty-One Million, Eighteen Thousand, Five Hundred and Sixty-Eight Naira and Ninety Eight Kobo (N31, 018,568.98K) only.

"The 422 grams of Opium Substance together with the suspects and 1 locally made pistol were handed over to the NDLEA Kaduna State Command on 30th March 2023 for further investigation," he explained.

Comptroller Jalo said that in a related development, on 25th April 2023 at about 1130hrs, their operatives while on stop and search operations, also arrested One (1) Used Volkswagen Golf driven by a Nigerien citizen along Jibia-Katsina Road.

"During the operation, the patrol officers observed and identified a sack in the vehicle that was later opened, and assorted

Military camouflaged shirts, trousers, and T-shirts were found.

"After further examination and interrogation, the driver was identified to be a Nigerien Citizen and the suspected uniforms were to be delivered to an unknown person in Katsina.

"The Uniforms were counted to be Twenty-Two (22) pairs of Foreign Tactical Military Camouflage Shirts and Trousers and another Twenty-Five (25) pieces of Military Camouflage T-Shirts," he said.

He noted that the seized items (Foreign Tactical Camouflage Clothing) together with the suspect have been handed over to the Directorate of Security Services (DSS) in adherence with the collaborations between the two agencies for further investigation and possible prosecution.

He pointed out that their eagledeyed officers likewise impounded 140 Jerry cans (25 litres each) of Automotive Gas Oil (Diesel) with DPV of Two

Million, Seven Hundred and Forty-Six Thousand, Six Hundred and Thirty-Nine Naira (N2, 746,639.00).

"Similarly, the Unit Intercepted 1, 147 Jerrycans of Premium Motor Spirit (25 litres each) worth Two Million One Hundred and Sixty-Seven Thousand Six Hundred and Fifty-Seven Naira Ninety-Five Naira, (N2, 167,657.95).

"In line with the extant laws and guidelines as directed by the Customs Headquarters, the PMS and the Diesel that were seized have also been auctioned and the proceeds remitted to the coffers of the Federal Government," he explained.

Giving a breakdown, he said that other items seized during the period under review include:

"Thirty-Seven (37) Units of Used Vehicles, Five (5) Units of Vehicles (Means of Conveyance)

*"2,109 bags of Foreign Parboiled rice (50kg each) and 69 bags of Foreign Parboiled Rice (25 KG each)

"8 Jerrycans of Foreign Refined Vegetable Oil (25 Litres each) "1,241 cartons of Foreign Spaghetti and Macaroni."

According to him, other items are 39 bales of foreign secondhand clothing, 30 sacks of foreign second hand shoes, 14 cartons of foreign fruit juice, 21

cartons of foreign pomade, 80 pieces of foreign car batteries and one carton of foreign milk.

"In line with the cordial relationship between the Nigeria Customs Service and the National Drugs Law Enforcement Agency (NDLEA), the 46 sacks of Marijuana together with means of conveyance would be handed over to the Commandant NDLEA Kaduna State Command for further action.

"I am happy to inform you that our renewed effort has been recognised by the Comptroller General of Customs, Colonel Hameed Ibrahim Ali (Rtd) CFR and his management team by giving the Unit a Letter of Commendation to the Unit. This would go a long way in boosting the morale of the Officers and Men of the Unit.

"At this juncture, I wish to reiterate my commitment of enforcing the Federal Government Fiscal policies in accordance with Standard Operating Procedure (SOP) as our operatives are battle-ready to carry out our mandate effectively.

"I am also using this opportunity to solicit with host communities around the border areas to continue to provide us with useful information that will assist our operatives to impound prohibited goods in the interest of the nation.

"Finally, let me use this opportunity, to first, commend, the Comptroller General of Customs, Colonel Hameed Ibrahim Ali (Rtd) CFR and his management team, for their logistics support to the Unit, our sister agencies, namely the Police, DSS, Military, NDLEA, Standards Organisations of Nigeria (SON) among others, for their collaborations, as well as the media, for its support and being objective in disseminating our efforts in the fight against smuggling," he said.

he aphorism that there is no hiding place for the golden fish was practically manifested last week when the Executive Chairman of Federal Inland Revenue Service (FIRS), Muhammad Mamman Nami deservedly bagged double awards from reputable organisations. The nation's number one tax collector at separate events was named winner of the Institute of Chartered Accountants of Nigeria (ICAN) Merit Award and the winner of the BusinessDay Excellence in Public Service Award.

Obaro Ikime: The Intellectual as Hostage

ENERAL Ibrahim Badamosi Babangida, the Dean of Coups in Nigeria, finally staged a coup for himself on August 27, 1985. The veteran coup plotter could sniff coups years away. On December 17, 1985, he rounded up over 100 military officers for allegedly conceptualising a coup. Some, including his childhood friend, Major General Mamman Vatsa, were sentenced to death.

When it was announced that the ruling military junta was to meet in the evening of March 5,1986 over the death sentences, Nigeria's famous literary triumvirate: Wole Soyinka, John Pepper Clark and Chinua Achebe, rushed to meet Babangida in the morning. The dictator vowed to them: "I wish to give you my word of honour – I shall go into the crucial meeting determined to do everything in my power to save them. I assure you, I shall not be party to their execution. That I can promise you."

"The case proffered against Ikime was that he provided the intellectual basis for the Orkar coup, including campaigning for a religious upheaval and ethnic division which saw Orkar purporting to excise part of the country. In 1990, Ikime who was the chairman of a committee on the Chapel of Resurrection, had read a communiqué to the church in which he warned those talking about dipping the Quran into the ocean in Lagos, advised against religious war and entreated the church to pray against it. The prosecution brought some members of the church, including an organist, to testify; but once they came faceto-face with Ikime, they buckled, and the case collapsed."

But as soon as the trio left, the meeting was convened so that by the time Soyinka got to his Abeokuta home, Vatsa and the other military officers had been executed. So, when on Sunday, April 22, 1990 an actual coup attempt, called the 'Orkar Coup' was carried out, Babangida and his gang went into frenzy. Hundreds of military officers were arrested with an unknown number murdered before they could get to trial. The junta also used the opportunity to shut-

down some newspapers and detain 19 senior journalists, accusing them of participating in the coup.

It then turned on lecturers whom Babangida for years had accused of "teaching what they are not paid to teach". The Gestapo on May 2, 1990 descended on the Obafemi Awolowo University. But the philosopher, Dr Dipo Fashina, escaped the dragnet. Then they abducted Professors Toye Olorode and Idowu Awopetu. As the convoy sped off, the alert students of the campus gave chase, caught one of the abductors, a secret service officer, whom the students detained for 12 days despite threats by the regime to invade the campus.

The Gestapo also went to Ibadan where they abducted famous historian, Professor Obaro Ikime, of the University of Ibadan. While the OAU lecturers were unapologetic radicals, Ikime, who was also a well-known sports administrator and Anglican priest, had no such inclinations. So, his abduction came as a surprise.

In Lagos, Olorode was detained at the Security Service detention centre on Awolowo Road; Awopetu at the centre on Kingsway Road; and surprisingly, Ikime was taken to the notorious Inter Centre, built into the Ikoyi Cemetery where the most 'dangerous' elements and many of the alleged coup plotters were kept. In the 95 days he spent in detention, he was allowed to wear just a pair of clothes.

The three professors were reunited at the Military Tribunal chaired by Brigadier Rufus Modupe Kupolati where they were charged as conspirators in the Orkar Coup. Olorode and Awopetu were jointly charged. The 'evidence' against them were that a conference against the World Bank was planned for the day of the coup attempt and that the duo belonged to a radical organisation called the Ife Collective which had produced a publication on 'Alternative to SAP' (Structural Adjustment Programme). Both defenders said they were opposed to coups and did not believe in replacing one set of coup plotters with another. Rather, they wanted the military's exit from politics and the enthronement of 'Peoples'



Power'.

The case proffered against Ikime was that he provided the intellectual basis for the Orkar coup, including campaigning for a religious upheaval and ethnic division which saw Orkar purporting to excise part of the country. In 1990, Ikime who was the chairman of a committee on the Chapel of Resurrection, had read a communiqué to the church in which he warned those talking about dipping the Quran into the ocean in Lagos, advised against religious war and entreated the church to pray against it. The prosecution brought some members of the church, including an organist, to testify; but once they came faceto-face with Ikime, they buckled, and the case collapsed. In order to avoid this type of collapse, the prosecution in the case of inciting ethnic hatred and conflict, decided to use Ikime's published works against him. It produced his Keynote Address delivered at the National Seminar on the National Question held in Abuja on August 4, 1986. In the paper titled: "Towards Understanding the National Question", Ikime had submitted that Hausa, Yoruba, Ijaw and other such nationalities did not exist before the 17th century, so they were recent creations. Secondly, that unlike Islam and Christianity, traditional religion often serve as integrative forces and were accommodative.

"Ikime's solution was that in a federation, there must be equal ownership and greater equity for all. In the argument before the

While Ikime seemed to have fallen for this ploy, Olorode and Awopetu refused and Justice Moni Fafiade ordered them recalled." Thirdly, that while Islam

brought Islamic culture and made no separation between the state and region, Christianity brought Western European culture and education and secularism. So, while the Jihad created a religious and political entity in the Sokoto Caliphate resulting in a greater Northern togetherness, there was no such cohesion in the South.

Fourthly, that the colonialists in 1939 deliberately broke the South into two regions but left the North intact, thereby not just creating Igbo, Yoruba and Hausa-Fulani majorities, but also giving the impression that the North was larger than the South and awarded it double the seats than the South. He argued that if it were based on population - there was no national census until the controversial 1952/53 – the East and the West would not have been awarded equal number of seats. This colonial legacy, he said, led to politics being

conceptualised as largely a trade-off among the three, while the other nationalities were "treated as mere pawns".

Fifth, that contrary to Bala Usman's claims that the lines between the Hausa and Fulani had become blurred, the Hausa elites are conscious that following the Jihad, they lost the top political positions to the Fulani.

Sixth, that in appointments, lower qualifications were required from candidates from the North rather than promote greater equity.

Ikime's solution was that in a federation, there must be equal ownership and greater equity for all. In the argument before the tribunal, the intellectual took the prosecutors to the cleaners. On August 1, 1990, Ikime was released but compulsorily retired on October 15, 1990. Professors Olorode and Awopetu were similarly treated. Their retirement was illegal and they challenged it in court. any farmers in Nigeria have over Lthe years been at the mercy of the voracious Red-billed Quelea birds, grasshoppers, and the various types of worms which decimates crop fields speedily year in and year out. Quelea bird is a small sparrow-like bird but very destructive. A single bird can eat 10 grams of grains in a few hours. While worms are small creepy pests whose larvae feed on all types of green leaves and grasses and destroy crops within minutes. Usually, at the early stages of cereal crops such as maize, rice, cowpea, beans, peanuts, millets, sorghum, and all grasses, these creeping worms appear on farmlands. especially at the early onset of the rains and destroy the plants.

Quelea birds surface mostly during the pre-harvest seasons. These birds, in great numbers, flock on croplands to devour the maturing crops within days.

Plants pests that put farmers' crop fields and vegetation at great risk include the notoriously ravenous armyworms, the gregaria, the cutworms, locusts, and the Quelea birds, etc which are deleterious pests capable of devouring entire crop fields within weeks.

These pests as perennial invaders which attack farmlands ferociously, are known to be causing great losses to many farmers annually and they impoverished many farmers in Nigeria.

Such plants pests have remained grave threats and nightmares to farmers, crop fields, and the government's trajectory and policy on a griculture and food production.

Church Building Demolition In KASU, Court Fixes Date For Ruling

Chief Magistrate

Court, Kaduna has fixed May 31, 2023 to rule on whether or not it has the jurisdiction to entertain the case of alleged demolition of church building at Kaduna State University (KASU). The case was instituted by Rev. John Joseph Hayab and Dr E. D. Monday against Mr Ismail Umaru Dikko and Mr Yusuf

The matter came up yesterday for hearing for the complainants to present their case before the Court but an objection was raised to say that the defendants are public officers.

Counsel to the complainants, Barrister Gloria Mabeiam Ballason stated that the defendants were suit in their personal capacities and not as public officers.

After listening to the arguments of both parties, the Chief Magistrate, Stephen Hassan, fixed 31st May to rule on whether or not the court has the jurisdiction in the matter.

The complainants had

approached the court that on the 6th June, 2022, at about 1:45pm, in the premises of the Kaduna State University main campus, Tafawa Balewa Way, Kaduna, a heavily armed security agents and operatives of a bulldozer, the defendants, without authorization and approval, demolished and defiled the only Churchin-building structure in the University premises and thereby committed the offence of failing a place of worship, contrary to section 179 of the Panel Code Laws of Kaduna state, 2017 and punishable under the same section.

According to complaints counsel, "That the officers of the complainants had mobilized for construction which was ongoing, but to their amazement, the 1st and 2nd defendants interfered with the progress by bringing in a bulldozer and armed security operatives to demolish the ongoing structure, intimidate, harass, assault and terrify the complainants and labourers and workers working on the building site and further destroyed evidence of their illegal actions."
