

World Day 2023: 40% Adult Africans Hypertensive, Only A Quarter Taking Medicines - WHO

THO Regional Director for Africa, Dr Matshidiso Moeti has said that in the African region, close to 40% of adults aged 30-79 years are hypertensive and only a quarter of these are taking medicines.

He added that Optimal Blood Control is only Pressure attained in 11 per cent of patients on medication.

A statement signed and issued by Igwebuike Kingsley, WHO Communications, Borno State and made available to newsmen on Wednesday, said, "Hypertension is an important risk factor for cardiovascular diseases (CVDs) mostly heart attack, stroke, and heart failure which account for a significant burden of premature mortality from non-communicable diseases (NCDs).

"Hypertension is easy to diagnose and there are safe and cost-effective treatment including pharmacologic and behavior change interventions. WHO has prioritized decentralized management and care for NCDs including management of hypertension, using the WHO Package of Essential Noncommunicable disease interventions for primary healthcare.

"In addition, the WHO has published a guidance on the technical specification for automated blood pressure monitoring devices to ensure improved access to accurate, affordable blood pressure devices which is often a significant barrier to proper medical care in low-resource settings.


"We need to regularly check our blood pressure and incase it is raised, adhere to medications as prescribed by the health provider," Moeti said.

The statement said this year, the theme is, "Measure Your Blood Pressure Accurately, Control It, Live Longer" while every year, the global community commemorates the World Hypertension Day on the 17th of May, aimed at drawing attention to combatting the low level of awareness of hypertension as well as the limited availability of calibrated devices for accurate blood pressure measurement.

He identified the condition dubbed as the 'silent killer' and often times people with hypertension will not have any specific signs or symptoms directly attributed to the condition. While symptoms are usually foreboding of damage on specific organs in the body including the heart, brain, eyes and kidneys, resulting from poor control.

"We can fight hypertension and the responsibility starts with us as individuals and as communities taking control of our health and well-being.

"We need to adopt healthy lifestyles such as reducing salt intake, increasing portions of fruits and vegetables consumption, increasing physical activity, and avoiding tobacco and excessive alcohol



consumption," Moeti added.

He further explained that effective prevention and control of hypertension requires a multisectoral approach, hence this approach should involve collaboration between the health sector and other sectors, such as education, finance, and agriculture, to address the social determinants of hypertension.

The Regional Director added that governments in Africa can lead the way by implementing their commitments through policies and programmes that address the root causes of hypertension, promote healthy environments, and improve access to healthcare services.

According to him, this will

require a significant investment in healthcare infrastructure, training of healthcare workers, and increasing access to affordable medications.

Moeti noted that early detection through routine screening at all health service delivery levels is important and calibrated and validated blood pressure measuring devices should be available in all health facilities.

"In addition, quality assured medicines should be available for management of hypertension, particularly at the primary level, as well as a robust mechanism to collect data to monitor outcomes from treatment and care.

"In conclusion, addressing

hypertension in Africa requires a multi-faceted approach that involves individuals, communities, and governments working together. For example, interventions such as promoting healthy diets and increasing physical activity can be implemented in schools.

"We must work together to join the global effort to address hypertension and its related health consequences. For those living with hypertension, regularly measure your blood pressure accurately, control it, and live longer.

"By taking action today, we can prevent and control hypertension and improve the health and well-being of millions of people in Africa,' Moeti said.

Brain Drain: Comptroller James Advocates Capacity Dev, Technology Transfer For Qualified Nigerians

Hajj Airlift: CSO Urges Improved Security Across Airports, Hajj Camps

he Independent Hajj Reporters (IHR), a Civil Society Organisation (CSO), has called for more security measures to be in place at airports and Hajj camps during this year's exercise.

The IHR is a media related CSO that monitors and reports Hajj and Umrah activities within and outside Nigeria.

Its National Coordinator, Ibrahim Muhammed, yesterday, said in a statement that this would dissuade the perpetration of criminal activities in places where intending pilgrims would transit from.

He called on agencies responsible for security across all departure centres to be up and doing to ensure the safe airlift of the pilgrims.

The National Hajj Commission of Nigeria (NAHCON) has fixed May 25 for the inaugural transportation of Nigerian intending pilgrims to Saudi

Arabia

"Nigerians may recall that pilgrims from Niger State had to be ferried to Abuja because of security challenges in Minna and inadequate security around Minna Airport.

"Also, Kaduna bound aircraft had to be diverted to Kano due to security concerns while a convoy of vehicles conveying intending pilgrims in Sokoto State was attacked by suspected bandits leading to the death of a security agent," he said.

Muhammed also said preparations for this year's airlift is already being challenged by the Sudanese conflict and urged authorities to ensure that adequate security personnel are deployed to all departure centres.

He advised all State Muslim Pilgrims Welfare Boards and Agencies to borrow a cue from NAHCON by coming up with a standing committee on security with a mandate to ensure full protection of all intending pilgrims and facilities being used for transit.

"Various security outfits exist across all the states and local government areas and it is our belief that it will not take too much to select capable hands to work 24/7 until all pilgrims are airlifted.

"The same scenario should be replicated during return journeys. No resources or efforts put to ensure adequate security is too much," he concluded.

Why I Didn't Celebrate My Victory -- Sen Uba Sani

aduna State Governorelect, Senator Uba Sani has clarified that he has been concentrating on his duties as a lawmaker at the National Assembly, after receiving his Certificate of Return, from where has continued to attract developmental projects to the state.

Senator Uba Sani who made this known in an interview with some Kaduna-based broadcast-journalists, conducted in Hausa and aired last Thursday, dispelled rumours that he has left Kadunasince his election.

" I have been performing my legislative duties as a Senator since after the election. I'm still a Senator of the Federal Republic of Nigeria who is representing Kaduna Central Senatorial District at the Upper Legislative Chamber. Immediately I received my Certificate of Return, I returned to Abuja to continue from where I stopped," he added.

Senator Uba Sani disclosed that the N3 billion Central Bank of Nigeria (CBN) intervention for the construction of Faculty of Engineering at the permanent site of Kaduna State University (KASU) has been increased to N5 billion.

According to him, it is not in his character to embark on merry-making to celebrate his victory, as the opposition would have wanted, because that is not the right thing to do.

The Governor-elect pointed out that prayers were offered by both Islamic clerics and Christian clergy, to seek God's guidance in the discharge of the burden that has been placed on him as the number one citizen of Kaduna State.

"The opposition said that I didn't mark my victory with all kinds of celebrations. They don't know the personality called Uba Sani. It's not in my character to embark on such celebrations.

" During Ramadan Fasting, Imams congregated, read the Glorious Qur'an and thanked Allah for the victory. They also prayed that, just as He granted me victory, the Almighty should also assist me in governing Kaduna State in a just and equitable manner.

"Three days afterwards, a group of pastors also came and prayed for me and our dear state. We didn't embark on partying. This was how I celebrated my victory. My religion tells me that Allah bestows success on whosoever He wants, not because I am better than everyone," he added.

He also dispelled the accusation that he has been dodging to be served court documents regarding the ongoing petition that was filed by the People's Democratic Party (PDP), challenging his victory.

According to him, the law stipulates that court documents can be served by substituted service, in the event that the respondent is not

available, adding that personal

service is not compulsory.

The governor-elect also promised to carry all segments

property by Kaduna Geographic Information Service (KADGIS) on Thursday May 18, 2023.

One of the affected property slated for demolition is Cane Properties located at Plot 11 Murtala Square.

Director of Cane property Alhaji Ibrahim Makarfi when contacted confirmed the

development, adding that the company had already contracted its lawyers.

Sources in KADGIS confided in our correspondent that the demolition notice was in line with statutory regulations in the Land Use Act which empowered state governments the rights to approve and revoke landed properties within their

jurisdiction for exigency and developmental reasons.

New Nigerian Newspapers could not however verify the reason for revoking Makarfi's property, a former Governor of the state and national leader of People's Democratic Party (PDP).

Bayelsa: Timi Frank Files Criminal Complaints Against Sylva

*Urges court to direct police to investigate ex-minister's conflicting certificates

complaint case against the
immediate past Minister
of State for Petroleum
Resources, Timipre Sylva
at a Chief Magistrate
CourtAbuja.

In the suit filed by his Counsel, Edward Omaga Esq. of Graylaw Practice LP chambers, Frank urged the Chief Magistrate of the Federal Capital Territory (FCT) to cause a direct criminal compliant to be issued against Sylva over alleged inconsistencies in his name and doubts over participation in the National Youth Service Corps (NYSC) scheme.

Frank, who is the United Liberation Movement for West Papua (ULMWP), Ambassador to East Africa and Middle East, averred that based on documents before him, the actual identity of the former minister seems to be in doubt.

The suit reads in part: "Over the years, the complainant (Frank) has also shown his resolve in fighting and exposing corruption in public places and holding public officers accountable to their oath of office.

"The defendant (Sylva) on his part once served as the Executive Governor of B a y e 1 s a s t a t e between2008 till 2012 and recently resigned his position as Minister of State for Petroleum Resources sometime around 30th March 2023.

"Facts and documents a vailable to the complainant reveal that the actual identity of the aforesaid defendant is in serious doubt.

"Recently, the complainant while undertaking a private investigation visited the United States District Court, Eastern District of Pennsylvania where Chief Timipre Sylva instituted a libel case against one Jackson Ude.

"In the course of hearing, Chief Timipre Sylva signed a verification of interrogatories answers dated April 1, 2022 and attached various documents in proof of his identity.

"The said a cade mic documents include a First School Leaving Certificate with No. 092915 dated 1st July, 1976 issued to Anagha Timipere who finished from

A j e r o m i Central School, Araromi-Apapa, Lagos State.

"Also, the defendant claims to hold a West African Examination Council (WAEC) General Certificate of Education with certificate No. PO851528 and Candidate No. 21735215 dated December 1981 issued to Marlin Anagha Timipre...

"The complainant equally discovered that the erstwhile Minister of State for Petroleum Resources parades a Bachelor of Arts Degree in English with Second Class (Upper Division) from University of Port Harcourt dated 19th August, 1986 issued to Anagha Timipre Marlin. "The defendant equally holds a Doctorate in International Relations (Honoris Causa) from UBIS University in Geneva, Switzerland, dated 22nd September, 2011 and issued to Chief Timipre Sylva.

"The certificates mentioned above have visible anomalies and do not depict the true identity of Chief Timipre Sylva. It is confusing as to who Chief Timipre Sylva is.

"There is no evidence anywhere showing that Chief Timipre Sylva ever changed his name from Anagha Timipre Marlin to Timipre Sylva in 1986 after he purportedly



graduated from University of Port Harcourt.

"Investigation by the complainant further reveals that there is also no record that the defendant has National Youth Service Corps (NYSC) Discharge or Exemption Certificate, as the case may be, either in the name of Anagha Timipre Marlin or Timipre Sylva.

"Records abound in public domain that Chief Timipre Sylva intentionally presented the a for ementioned inconsistent, conflicting or forged academic documents before the Bayelsa State Gubernatorial Screening Committee in 2007 as well as the Nigerian Senate and House of Representatives in 2019 under oath for purposes of screening into the positions of Governor of Bayelsa State and Minister of State for Petroleum Resources.

"In a bid to escape the long arms of the law, Chief Timipre Sylva concocted a Deed Poll and Federal Republic of Nigeria Official Gazette dated 11th and 12th May, 2022 to cover up his alleged offences.

"In the documents...Sylva attempted, albeit belatedly to make the general public believe that the manifestly conflicting names: Anagha Timipere, Marlin

Anagha Timipre, Anagha Timipre Marlin and Chief Timipre Sylva appearing on the academic certificates he has been parading for decades all belongs to him.

"The complainant believes that the said Deed Poll and Official Gazette are nothing but mere pieces of paper...procured by Sylva to mislead people and wriggle himself out of being investigated, prosecuted and jailed for the alleged offence.

"The Complainant is worried like every other reasonable Nigerian as to why the defendant waited till May 2022 before procuring the Deed Poll and Official Gazette...

"That the complainant is crying for justice in this matter and only an intervention by the Court can answer the cry.

"That it will be in the best interest of Justice to bring the defendant to answer to the complaint.

"Based on the foregoing, the complainant humbly prays the Honourable Court to direct the Nigeria Police Force to carry out investigation of the alleged offences concerning the defendant. "Whereof the action of the defendant constitutes the offence of forgery contrary to Section 366 of the Penal Code."

Obaseki Hails Judiciary For Peace, Stability In Edo

*Urges more action to strengthen independence, welfare

he Edo State Governor, Mr. Godwin Obaseki, has hailed the judiciary for their contributions to the peace and stability being witnessed in the State, calling for increased action to strengthen the judiciary and make it more independent.

Obaseki spoke when he received the leadership of the Edo State Judiciary, led by the Chief Judge, Hon. Justice Joe Acha, at the Government House, Benin City. The Chief Justice was on a customary farewell visit due to retirement.

Reiterating the need for sustained reforms for a more sustainable justice system, the governor said, "The structure and demographics of the judiciary is something we need to think about for sustainability. I'm glad that the amendment extending the retirement age is being considered. We need to

take a long-term view of the judiciary and see how people appointed will be able to sustain the law for a longer period."

He continued: "When I assumed office, I made it very clear that for us, the judiciary is the bastion on which our democracy rests and that without law and order, we cannot have a vibrant democracy. I'm glad that we have all witnessed what has happened in Edo in the last six and a half years.

If we did not take steps in the very early stage of our administration to enforce law and order in this state, I'm not sure we would have had the level of socioeconomic development we have today. That we do is as a result of the support we received from the judiciary. So, whatever that we have achieved as the executive arm of government is largely due to the working relationship we had with the judiciary."

Obaseki added, "It is very clear, therefore, that we must take concrete measures to strengthen our judiciary and make it more independent. I'm glad that with Justice Acha, we have been able to begin to create a roadmap for the judiciary - a roadmap that should focus on the welfare, training, and improving the work condition of the judges and other tiers of the judiciary in Edo State just as we've done for the executive. We need to develop a work plan that insists that the ordinary Edo citizen has unfettered access to justice and strengthens those courts that provide that access, particularly the lower courts."

According to him, "We must ensure that we improve the conditions of the judiciary to the best in terms of benefits, housing, office and post-retirement conditions and I'm glad that Justice Acha has started that process which I hope your

successor will ensure that we finalize and institutionalize."

The governor further noted, "I am glad on how you have adopted technology and the other investments that we have agreed to make in the judiciary. I'm hopeful that the infrastructural refurbishment which you have started, making sure that our judges in the outstations live and work contentedly and also ensuring that we provide adequate security for them, we will improve on and sustain the growth recorded.

"I appreciate our retiring Chief Judge who has worked very hard and his colleagues in the judiciary, and the cooperation we have received from you for the last two years. Be rest assured that you started a process and you must benefit from them. I know there are NJC guidelines that can inform us of the parting packages which we will

commence implementing with you."

Earlier, Justice Acha expressed appreciation to the governor for his support to the judiciary, noting, "As is customary, I have led the leadership of the judiciary to pay you a farewell visit. The Constitution of the Federal Republic of Nigeria, Section 291 subsection 1, provides that a High Court Judge must retire upon attaining the age of 65 years. Come the 19th of May, I will be 65 years old."

He added, "I could not have wished for a better governor. Your passion to turn Edo State into an Eldorado is legendary. I immediately discovered that we share the same passion for the overall development of Edo State. You not only intervened in some of our critical infrastructural and personnel needs, the welfare of judges and staff of the judiciary has been greatly enhanced and we have made tremendous progress."

"WHO has been working closely with Borno state Ministry of Health and State Primary Health Care Development Agency to build the capacity of key state and LGA officials on Epidemic Preparedness and Response".

"WHO and partners have also been providing relevant tools and materials for the frontline teams to work and remain active in all parts of the state regardless of the situation in the area or time of the year", he said.

He further explained, the RRT training is part of the efforts to ensure that new team members are adequately equipped to respond swiftly and effectively to alerts or disease threats in communities and health centers. He urged the State and LGA PHC Directors and key health officials attending the training to ensure they conduct stepdown training to other team members and frontline staff who were not able to attend this training.

You're Outdated! PEPC Slams Tinubu's Lawyer, Olanipekun

*Atiku's lawyer gets thunderous applause

he Presidential Election Petition Court (PEPC) yesterday in Abuja, told Chief Wole Olanipekun SAN, lead counsel to Bola Ahmed Tinubu that he was citing old laws against the request by the Presidential candidate of the Peoples Democratic Party (PDP), Alhaji Abubakar Atiku for live coverage of proceedings of the court.

Chairman of the court, Justice Haruna Simon Tsammani drew the attention of Olanipekun to a portion of the Code of Conduct for Judicial Officers being wrongfully cited to justify Tinubu's opposition to live coverage of proceedings in Atiku's petition.

At yesterday's proceedings, Tinubu, APC and INEC had separately kicked against the request by Atiku for live coverage of proceedings of the Court to engender public trust and confidence in the court.

Atiku through his lead counsel, Chief Chris Uche SAN had cited the monumental importance of the petition nationally and internationally to back up his demand for live telecast of the proceedings.

But in his bid to justify his vehement opposition, Olanipekun had cited paragraph 4.6 of the Code of Conduct for Judicial Officers which he claimed prohibited Judicial Officers from broadcasting, televising proceedings during court session

He cited the disputed law following the submissions by Chief Chris Uche SAN, that there was no law or statute barring live telecast of court proceedings.

As Olanipekun was about to read the portion of the law, Justice Tsammani cut in and told the legal luminary that he was citing a wrong law.

Justice Tsammani told Olanipekun SAN that the portion he was citing to justify his arguments against live coverage had been amended and the portion being cited had been deleted completely.

The Chairman of the Court maintained that the portion being claimed by Chief Olanipekun SAN was no longer in the new Code of Conduct for Judicial Officers and as such, not applicable.

While making a case for live broadcast of Atiku's petition, Uche SAN had drawn the attention of the Court to Justice Oputa Panel of

Inquiry that was telecast live and hailed all round in the country.

The Senior lawyer said that non of the respondents would be prejudiced if the petition is broadcast live.

Specifically, he said that there was no single law or statute against live broadcast of court proceedings adding that the fact that it has never been done before should not be misconstrued to mean that it cannot be done this time.

The submissions of Uche SAN had drawn thunderous applause from the crowd who for some minutes clapped before the court announced that clapping was not allowed in Courts.

Atiku had approached the Court hearing his case against the outcome of the February 25 presidential polls, for an order allowing live broadcast of the day to day proceedings regarding his petition because of its monumental importance.

Atiku and the PDP in the application specifically prayed the tribunal for "An order Directing the Court's Registry and the parties on modalities for admission of Media Practitioners and their Equipment into the courtroom."

The application filed on their behalf by their team of lawyers led by Chief Chris Uche, SAN, is predicated amongst other grounds that: The matter before the Honourable Court is a dispute over the outcome of the Presidential Election held on 25th February 2023, a matter of national concern and public interest, involving citizens and voters in the 36 States of the Federation and the Federal Capital Territory, Abuja, who voted and participated in the said election; and the International Community as regards the workings of Nigeria's Electoral Process". They contended that being a unique electoral dispute with a peculiar constitutional dimension, it is a matter of public interest whereof millions of Nigerian citizens and voters are stakeholders with a constitutional right to receive.

The Independent National Electoral Commission, INEC, President-elect, Bola Ahmed Tinubu and the All Progressives Congress APC in response kicked against the request of the former Vice President for live telecast of his petition challenging the declaration of Tinubu as winner of the 2023 presidential election.



A'Ibom Judges, EFCC Trade Blames Over Slow Prosecution Of Criminal Matters

t a meeting of the National Judicial Council (NJC) Corruption and Financial Crime Cases Trial Monitoring Committee (NJC COTRIMCO) and designated judges, the prosecuting officers of EFCC and ICPC, judges in Akwa Ibom State and officials of Economic and Financial Crimes Commission (EFCC), traded blames on why prosecution of criminal matters in court are delayed.

During the meeting in Uyo yesterday, the Akwa Ibom State Chief Judge, Justice Ekaette Obot pointed frequent transfers of prosecuting officers as reason to the delay in the prosecution of most of the criminal matters in the state.

Obot said relevant security agencies in the country should regulate properly the transfer of the Prosecuting Officers of Financial and Other Related Crimes Agencies to avoid delay of criminal matters in Court.

"if the relevant authorities could regulate the transfers of these Prosecuting Officers such that when one is posted to Akwa Ibom, Abuja, Abia or any other state, he stays there for at least five or six years before being transferred, it will go a long way to hasten the process.

"Officers should stay long enough in a station to conclude matters they are prosecuting," Obot said.

Justice Gabriel Etteh in his comments during the interactive session said that most of the prosecuting officers are often transfered in the middle of prosecuting matters.

Etteh added that by the time a replacement will be sent, a considerable time has been lost and the replacement in most cases would be nonchalant over the matter.

"My Lord, apart from the arbitrary transfer of the prosecutors, which is a big issue, some of these officers are not hardworking, I must say.

"Imagine an officer

"Imagine an officer coming to a court just to ask for adjournment with flimsy excuses. This lack of enthusiasm from the prosecuting officers is frustrating prosecution of criminal matters," Etteh said

In his contribution, Justice Bassey Nkanang, said the attitude of prosecutors of financial crime agencies most times make judges to be at cross road.

Nkanang stated that in most cases the prosecutors failed to show up for their cases, even after being served and the defense counsels would mount pressure on the Judge to terminate the case because of lack of seriousness on the part of the prosecutor. He said striking out cases

He said striking out cases that touch on financial crimes would send a wrong signal, but when a matter is delayed in court, there is a tendency that it would be struck out.

In defence, the Chief Prosecutor of the Economic and Financial Crimes Commission (EFCC), Mr Takon Ndifon had accused the state government of stifling the agency of discharging its duties in the state.

He noted that the Akwa Ibom Government had secured Court injunction barring the agency from investigating any of the high ranking official suspected to be involved in financial crime

"The State is against the

EFCC and ICPC. The State Government has gotten Court injunction barring us from investigating their high ranking officials.

"They are even the ones frustrating these matters from going to Court, it's not as if the monies when recovered would go into our pockets but to the State coffers, which would be used for development.

"If we are given free hands and allowed to investigate high profile cases in Akwa Ibom that require investigation, we can sanitise the system, but how can we do that when there is an injunction? Though we have appealed that order. It's still pending," Ndifon said.

The Chairman of NJC COTRIMCO, Justice Abimbola Ladipo, said he had heard the prayers of each group and would channel them to the Council to take actions.

Ladipo, however, called on the state Chief Judge to always have meetings with the judges and the prosecuting officers to know their problems and if there was need, she should make a report

Seme Customs Impounds Unregistered Pharmaceutical Products Worth Over N27m, Petroleum Product

peratives of the S e m e A r e a Command of the Nigeria Customs Service (NCS) have impounded cartons of unregistered pharmaceutical products worth N27,861,538, New Nigerian Newspapers has learnt.

According to reports, the consignment were intercepted by the operatives while conducting stop and search along Abidjan-Lagos Corridor.

The products were concealed inside a truck with registration number GL 6663 GH belonging to a major Nigerian conglomerate on May 9, 2023 at about 08:30pm by officers of the command.

The Customs Area Controller (CAC), Comptroller Dera Nnadi, mni, told journalists that the seizure contravened Customs' ban on importation of pharmaceutical products through the land border without approval.

Nnadi disclosed that the products also does not have National Agency for Food and Drug Administration and Control (NAFDAC) registration numbers, while five out of the seven seized products have expired.

He explained further: "The truck was taken to the station at Seme for proper examination and upon the conduct of the examination, the following unregistered pharmaceutical products were discovered:

"MORPHINE SULFATE 100ml x 1076 bottles; AMODIAQUINE SUSPENSION 60ml x 94 bottles; VERMOX 500mg x 2970 packages x 1 sachet x 1 tablet; MEPACRINE TABLETS 100mg x 390 packets x 1000 tablets; CLOFENAC SR 100mg x 298 packets x 10 sachets x 10 tablets; LOSARTAIL POTASSIUM 50mg x 1485 packages x 2 sachets x 28 tablets and VIREST 400 ACICLOVIR tablets. B.P 400mg x 499 packages x 5 sachets x 5 tablets.
"The Command and

indeed every Nigerian is worried about this particular seizure considering the dangerous use of morphine which is a derivate of opium. This drug can be deployed to illicituse to aid criminals. Command also seized 1,200 Jerry cans of Premium Motor Spirit (PMS) equivalent to 36,000 litres with a Duty Paid Value (DPV) of N11,271,690.93.

Nnadi upon resumption as CAC in January had pledged to adopt new strategies that could boost trade while enforcing the nation's anti-smuggling laws along the corridor, in line with the ECOWAS protocols on free movement of goods and persons.

According to him, officers and men of the Command have since keyed into reform policies which has translated into remarkable achievements recorded.

He reiterated the Command's commitment to fight smuggling under any guise, stating that those trying its resolve will continue to meet their waterloo as it remains resolute at ensuring adequate surveillance of the borders.

Also, the Command handed over seven large sacks containing 553 parcels of cannabis sativa intercepted in a Ford Bus and two suspects arrested in connection with the seizure of April 21, 2023, to the National Drug Law Enforcement Agency (NDLEA).

Two other suspects had earlier been handed over to sister security agency for necessary action.

The NDLEA Commandant, Seme Badagry Command, Abubakar Wada, while receiving the seizures, commended Customs for the achievement.

He expressed satisfaction with the synergy between the two agencies, stating that their working relationship will continue to get better in order to achieve more results.

NBS And The Scorecard Of An Eclipsing Administration

ith a few days to the May 29 inauguration of the new administration in the country, it is glaringly evident that President Muhammadu Buhari led Federal Government of Nigeria has successfully completed its constitutional two terms of eight years.

Though there exists no codified, metered or iron cast way of assessing the administration's performance, it is, however, assumed that an administration that spanned eight years must have milestone(s) of achievement to point at. Indeed, while there are flicker and recognizable flashes of achievements in some sectors of the nation, interim particulars in my view, suggest that infrastructural provision is the administration's greatest accomplishment.


The crucial point, then, is how do one define what constitutes infrastructural success and how was it achieved? What are/were the opportunity cost of the purported success?

In February 2021, President Buhari reportedly established the Infrastructure Corporation of Nigeria (InfraCorp), with initial seed Capital of N1 trillion, provided by the Central Bank of Nigeria (CBN), the Nigerian Sovereign Investment Authority (NSIA) and the Africa Finance Corporation (AFC). InfraCorp was also expected to mobilize up to an additional 14 trillion Naira of debt capital.

Through InfraCorp, Buhari catalyzed and accelerated investment into Nigeria's infrastructure sector via originating, structuring, executing and managing end-to-end bankable projects in the country,

Today, the administration has to its credit; 56km Lagos-Ibadan Standard Gauge Rail completed and commissioned, within a Nigerian-record-time of four years (2017 to 2021). 186km Abuja-Kaduna Standard Gauge Rail Line completed and commissioned in 2016, 327km Itakpe-Warri Standard Gauge Rail completed and commissioned in 2020, 33 years after construction began. Also, the administration going by media reports invested over a billion dollars in three flagship projects: Lagos-Ibadan Expressway (for completion in May 2023), Second Niger Bridge (for completion in May 2023), Abuja-Kaduna-Zaria-Kano Expressway (two of three sections for completion in May 2023) among others.

Even when this piece holds the opinion that the administration demonstrated understanding of the pivotal role infrastructural provision plays in providing the society with the services that underpin the ability of people to be economically productive, it will on the other hand objectively qualify the aforementioned achievements as sparse and insufficient, particularly when juxtaposed with a catalogue of adequately



unattended sectors (education, security, Power, Niger Delta region Labour and Employment etc).

In fact, each time I reflect on President Buhari's 8years administration, the fears expressed by a friend in 2015 about the present administration comes flooding.

Adding context to the discourse, my friend amidst euphoria triggered by the declaration of the 2015 presidential election result, cautioned me with these few words; "men will change their ruler expecting to fare better; this expectation induces them to take up arm against him, but they only deceive themselves, and they learn from experience that they have made matters worse'.

Still, in that milieu, I had reminded him that the result ushered in a season of integrity in the country, he again replied thus; no single attribute could be identified as a 'virtue'. Remember! He added, 'Politics has its own rules'.

Eight years after that conversation, I cannot categorically say that my friend was right or wrong in his prediction. But the present instinct in the country explains two things; first, apart from the fact that the shout of integrity which hitherto rend the nation's political space has like light faded, jeer has since overtaken the cheers of political performance while fears have displaced reason -resulting in an entirely separate set of consequences – irrational hatred and division.

The reason for this spiraling feeling is

understandable!

Take as an illustration, in 2020 alone, there were outright abridgment of the masses' welfare by the Federal Government via increase of Value Added Tax (VAT) from 5 to 7.5 per cent, reintroduction of Stamp Duty Charge, reintroduction of Stamp Duty on house rents and C of O transactions, electricity and petrol price hikes crisis among others. These were inextricably linked both in their causes and solutions.

Each of these challenges has its roots in the administration's payment of little attention or lip service to expert warnings about the poor state of the economy, and further fed by Federal Government's persistent formulation of policies with no clear definition of problem, the goals to be achieved, or the means chosen to address the problems and to achieve the goals; adoption of coquettish tactics that make the masses fall in love with excitement while they (leaders) remain inwardly detached; keeping them in control.

There are very recent examples.

According to a recent report by the National Bureau of Statistics (NBS), it stated that in April 2023, the headline inflation rate rose to 22.22% relative to March 2023 headline inflation rate which was 22.04%. Looking at the movement, the April 2023 inflation rate showed an increase of 0.18% points when compared to March 2023 headline inflation rate. Similarly, on a year-on-year basis, the

headline inflation rate was 5.40% points higher compared to the rate recorded in April 2022, which was 16.82%. This shows that the headline inflation rate on a year-on-year basis increased in April 2023 when compared to the same month in the preceding year (i.e., April 2022).

Likewise, the report added that on a month-on-month basis, the All-Items Index in April 2023 was 1.91%, which was 0.05% points higher than the rate recorded in March 2023 (1.86%). This means that in April 2023, on average, the general price level was 0.05% higher relative to March 2023. The percentage change in the average CPI for the twelve months ending April 2023 over the average of the CPI for the previous twelve months was 20.82%, showing a 4.37% increase compared to the 16.45% recorded in April 2022.

While the above qualifies as an occurrence that its pain is deepened by the fact that it was avoidable, it is important to further underline that if there is a particular area where the present administration cannot boast of clean hands, it is in the incessant debt accumulation(foreign and domestic).

It is a common knowledge that in January 2023, Patience Oniha, Director general, Debt Management Office (DMO), while fielding questions from journalists at the public presentation and breakdown of the highlights of the 2023 appropriation act in Abuja, noted that the incoming Federal Government would inherit about N77 trillion as debt by the time President Muhammadu Buhari's tenure ends in May.

Aside from signaling an indication that Nigerians should expect tough time ahead or better still, may not anticipate a superlative performance from the incoming administrations as they will from inception be over burdened by debt, what is, however, 'newsy' is that each time the present Federal government went for these loans, Nigerians were usually told that the loan seeks to stimulate the national economy, making it more competitive by focusing on infrastructural development, delivery of inclusive growth and prioritizing the welfare of Nigerians to safeguard lives and property; equipping farmers with high tools, technology and techniques; empowering and enabling mines to operate in a safe and secured environment and training of our youths through revival of our vocational institutions to ensure they are competitive enough to seize the opportunities that will arise for this economic revival."

Again, it is evident from the above that the nation did not arrive at its present state of indebtedness by accident but through a well programmed plan of actions and inactions that engineered national poverty and bred indebtedness. The state of affairs dates back to so many years in the life of the present Federal Government.



Even the legislators diverting the country's attention on such a matter know they are joking. Otherwise, they would not be littering our cities with their billboards and posters soliciting to be elected into the leadership of the National Assembly when they know the general populace, being neither Distinguished Senators nor Honourable Members, are not eligible to vote in the hallowed chambers.

I have not read about these legislators or their horde of supporters making a case for pro-people programmes the next Assembly should pursue; how to check the financial recklessness of previous assemblies, or the content of the character of those aspiring to lead the Assembly. It is all about zoning, sharing offices, and by extension, cornering the resources of the country.

Some even warn that the scenario of the 8th Assembly when Senator Bukola Saraki broke ranks and got himself elected against the position of the party, should not be repeated. I ask: why not? Was the rebel Saraki leadership not far better than the out-going rubber stamp Assembly leadership?

The idea that only National Assembly members should determine who the Senate President or House Speaker should be is as ridiculous as saying politics should be left to politicians alone. Even when the Constitution empowers the President to pick ministers, he cannot be allowed to do so without pressures and



interference from various groups, parties, communities and interests, including the National Assembly. Indeed, it will be ridiculous to expect one man alone to pick a minimum of one minister from each of the 36 states without outside interference. Even if we all close our eyes and play deaf to the process of NASS members electing officers, that would not mean the Assembly will be independent; a parliamentary leadership that wants to sell out will do so irrespective of whether its ascension was backed or rejected by 'outsiders'. In any case, the idea of whether the NASS is independent or not would not be determined by its antagonism to the Executive. The fact is that the way the NASS runs is

The fact is that the way the NASS runs is so compromised that it cannot be independent of the Executive. First, it pays its members all sorts of allowances and emoluments, outside what is officially approved. And that is to the extent that the net payment to a member of the House of Representatives comes to some N10 million (\$21,621) monthly and that of the Senator, N14 million (\$32,272) monthly.

Secondly, the Assembly pads the National Budget so heavily that President Muhammadu Buhari in his 2022 Budget claimed that the NASS inserted 6,576 new projects in the budget, including over 1,500 into the budget of the Federal Ministry of Agriculture alone. These insertions are done without regard to needs, feasibility studies, conceptualisation, design, costing or availability of funds. This, as we are

aware, is an annual ritual in the NASS.

Thirdly, the parliamentarians hijack executive responsibilities by awarding themselves 'constituency projects' which they cost, award, implement, supervise and approve by themselves.

Perhaps a more fundamental issue is the electoral process that produced many of the NASS members which we all know cannot stand the most basic of scrutiny. Some were not even candidates produced through normal party primaries; and for many, their elections were characterised by financial inducement, blatant votebuying, intimidation and violence. In summary, the process which produced some NASS members was criminal.

For many legislators, investing huge sums in getting elected into parliament is a worthy investment because the returns are very high; perhaps the highest and safest investment in the country.

So, what we truly need in Nigeria is not the so-called independence of the legislator from the Executive, but his independence from an un-parliamentary culture. A critical step is to make it so unattractive that only those interested in serving the people will seek election into parliament. I am never tired of making a contrast between the Nigerian Senator who for the work of making laws collects an obscene net of \$32,272 monthly or \$387,264 annually, and his Cuban counterpart who receives not a single cent for doing the same work. While the Nigerian Senator claims to be doing legislative work full-time and lays claims to other monies, including for vehicles,

the Cuban Senator has a full-time work and being a legislator is part-time. So, in Cuba, after a normal day's work, while his fellow workers are going home to their families or for relaxation, the Senator is heading to the National Assembly for the voluntary part-time work of making laws. Therefore, where in Nigeria a Senator may be willing to buy votes, employ thugs and violence in order to get elected or reelected, the Cuban Senator does not buy votes, and may not even be too keen to get elected. Yet, the quality of law making in Cuba, is not inferior to that in Nigeria. If anything, going by the pro-people laws in Cuba, the Cuban National Assembly is far superior to that of Nigeria.

This is not about a socialist or non-socialist system, it is about basic human decency. For instance, Mahmud Ahmadinejad, the two-term President of Iran who left office in August 2013, did not retire into stupendous wealth like former Nigerian Presidents. He merely returned to his work as a lecturer in the Civil Engineering Faculty of the Iran University of Science and Technology.

When he returned to his teaching job after a ten-year absence, he told his colleagues and students: "I am very happy to be back, as if I am home."

Again, unlike former Nigerian Presidents and state governors who have convoys of expensive cars, including bullet proof ones, Ahmadinejad has been seen going to work in crowded buses. He has no fear of being mobbed because he was and remains part of the Iranian people.

NBS And The Scorecard Of An Eclipsing Administration

As noted in my recent and similar intervention, the nation was warned with mountains of evidence that this was coming, it was also pointed out that under the present condition of indebtedness, it may be thought audacious to talk of creating a better society while the country battles with the problems of battered economy arising from indebtedness, yet, our leaders who are never ready to serve or save the citizens ignored the warnings describing it as a prank. Now we have learnt a very "useful" lesson that we can no longer ignore.

In 2019, the rising debt profile of the country dominated discussion when the Senate opened debate on the general principles of the 2019 Appropriation Bill. Most of the contributors to the referenced debate asked the executive to exercise some level of caution on its borrowing plan in order not to return the country to a heavily indebted nation it exited in 2005 through Paris Club debt relief.

Senate Leader, Senator Ahmed Lawan, (as he then was) kicked off the debate when he read "A Bill for an Act to authorize the issue from the Consolidated Revenue Fund of the Federation the total sum of N8,826,636,578,915 only, of which N492,360,342,965 only, is for Statutory Transfers, N2,264,014,113,092 only, is for Debt Service, N4,038,557,664,767 only, is for Recurrent (Non Debt) Expenditure while the sum of N2,031,754,458,902 only is for contribution to the Development Fund for capital Expenditure for the year ending on 31st day of December, 2019."

While noting that the budget deficit will be funded through borrowing, Lawan among other things stated; "about 89% of the deficit (N1.65 trillion) will be financed through new borrowings while about N210 billion is expected from the proceeds of privatization of some public enterprises. Debt Service/Revenue Ratio which was high as 69% in 2017 has led to concerns being raised about the sustainability of the nation's Debt.

Reacting to Lawan's words, many Nigerians raised the alarm on the country's rising debt profile. They noted that though the budget estimates should be given expeditious consideration and passage in view of the time already lost, the borrowing plan contained in the Bill should be properly scrutinized. They insisted that scrutinizing the borrowing plan became necessary to prevent the country from exceeding its borrowing limit when juxtaposed with the ratio of Gross Domestic Product (GDP).

Even some Senators in their submissions frowned at the nation's increased borrowing proposals on our yearly budget which they described as becoming unbearable. "Yes, money must be sought for by any government to fund infrastructure but it must not be solely anchored on borrowing which in the long run, will take the country back to a problem it had earlier solved. "Besides,

there are other creative ways of funding such highly needed infrastructure."

Others at that time were particularly not happy that the debt profile of the country would soon rise to \$60 billion from less than the \$20 billion it was before the present government came to power in 2015. While they noted that the components of the \$60 billion debt profile include \$23 billion external debt and \$20 billion local debts, these concerned Nigerians observed with dissatisfaction that another \$12 billion was already being processed for presentation to the National Assembly to finance Port Harcourt to Maiduguri rail lines.

Still on the 2019 budget borrowing proposal, it noted that "Nigeria is gradually turning to a chartered borrowing nation under this government all in the name of funding infrastructure. "This must be stopped because the future of the country and in particular, lives of generations yet unborn are being put in danger." Even with the high level of indebtedness of the country, "the government in power is planning to further devalue the Naira to about N500 to one US dollar." They concluded.

Similarly in February 2022, Economic experts going by media reports urged the Federal Government to seek a debt moratorium and reduce the cost of governance to reduce funds expended on debt servicing, as it stands as the best available option.

This, according to them, will enable the government to suspend payment for now and re-strategize — particularly, the government cannot continue to service its rising debt profile at the expense of meeting the competing needs of the people, a similar expert warning was recently handed by Economic analysts that the Federal Government's soaring borrowings could eventually suffocate the country if not mitigated.

Indeed, from the above torrents of explanation/concern expressed by these experts, this piece clearly agrees that 'Nigeria's debt stock has finally become an issue that calls for more drastic approach to support the fiscal and monetary authorities to tow the nation's economy out of the doldrums.

Qualifying the above sad account as a bad commentary is the awareness that despite these prophecy of foreknowledge which deals with what is certain to come, and prophesy of denunciation, which on its part, tells what is to come if the present situation is not changed; both acting as information and warning respectively, the President Muhammadu Buhari led Federal Government has become even more entrenched in borrowing, ignoring these warning signals.

In 2020, one of the reputable national newspapers in Nigeria in its editorial comment among other observations noted that Nigeria would be facing another round of fiscal headwinds this year with the mix of \$83 billion debt; rising

recurrent expenditure; increased cost of debt servicing; sustained fall in revenue; and about \$22 billion debt plan waiting for legislative approval. It may be worse if the anticipated shocks from the global economy, like Brexit, the United States-China trade war and interest rate policy of the Federal Reserve Bank go awry. The nation's debt stock, currently at \$83billion, comes with huge debt service provision in excess of N2.1 trillion in 2019, but set to rise in 2020. This challenge stems from the country's revenue crisis, which has remained unabating in the last five years, while the borrowings have persisted, an indication that the economy has been primed for recurring tough outcomes, the report concluded.

The situation says something else.

Another news report within the same time frame indicated that the federal government made a total of N3.25tn in 2020, and out of which it spent a total of N2.34tn on debt servicing within the year. This means, the report underlined, that 72 per cent of the government's revenue was spent on debt servicing. It also puts the government's debt servicing to revenue ratio at 72 per cent.

It was in the news that PricewaterhouseCoopers, a multinational professional services network of firms, operating as partnerships under the PwC brand, in a report entitled; 'Nigeria Economic Alert: Assessing the 2021 FGN Budget.', warned that the increasing cost of servicing debt will continue to weigh on the federal government's revenue profile. It said, "Actual debt servicing cost in 2020 stood at N3.27tn and represented about 10 per cent over the budgeted amount of N2.95tn. This puts the debt-torevenue ratio at approximately 83 per cent, nearly double the 46 per cent that was budgeted. This implies that about N83 out of every N100 the federal government earned was used to settle interest payments for outstanding domestic and foreign debts within the reference period. In 2021, the FG plans to spend N3.32tn to service its outstanding debt. This is slightly higher than the N2.95tn budgeted in 2020."

Today, such fears raised cannot be described as unfounded just as this author doesn't need to be an economist to know that as a nation, we have become a high risk borrower.

Looking at the above facts, this piece holds the opinion that the present debt profile presently crushing the country may not have occurred by accident.

And, even as the nation goes on borrowing spree and speeds on 'borrowing lane', and at a time the World Bank indicates that "almost half of the poor people in Sub-Saharan Africa live in just five countries: and they are in this order, namely; Nigeria, the Democratic Republic of Congo, Tanzania, Ethiopia and Madagascar, the situation becomes more painful when one remembers that no

one, not even the Federal Government can truly explain the objective of these loans and whether they were utilized in the masses best interest.

It would have been understandable if these loans were taken to build standard rail system in the country that will assist the poor village farmers in Benue/Kano and other remote villages situated in the landlocked parts of the country, move their produce to the food disadvantaged cities in the south in ways that will help the poor farmers earn more money, contribute to lower food prices in Lagos and other cities through the impact on the operation of the market, increase the welfare of household both in Kano, Benue, Lagos and others while improving food security in the country, reduce stress/pressure daily mounted on Nigerian roads by articulated/haulage of vehicles and drastically reduce road accidents on our major highways.

Again, it would have been pardonable if the loan were deployed to revitalizing the nation's electricity sector, to re-introduce a sustainable power roadmap that will erase epileptic power challenge in the country and in its place restore the health and vitality of the nation's socioeconomic life while improving small and medium scale business in the country.

What about the nation's refineries?

The present administration as part of its campaign promise in 2015, agreed to ensure a better deal for Nigerians. Specifically, it promised to take measures that will strengthen corporate governance in the Nigerian National Petroleum Corporation, NNPC, as well as in the oil and gas sector as a whole. This is because of the belief that weak structures made it possible for the endemic corruption in the management of both the downstream and upstream sectors of the oil and gas industry. But eight years after such demand was made and Jonathan gone, the three government-owned refineries in the country have not been able to function at full capacity as promised by the present administration.

Today, if there is anything that Nigerians wish that the FG should accomplish quickly, it is getting the refineries to function optimally as well as make the NNPC more accountable to the people. What happened under president Jonathan has become a child's play when compared with the present happenings in Nigeria's oil/gas and electricity sectors.

What the above tells us as a country is that more work needs to be done and more reforms to be made. It also reminds us that as a nation, we are poor not because of our geographical location or due to absence of mineral/natural resources but because our leaders fail to take decisions that engineer prosperity.
