Petroleum Dealers In Court Over Allegations of Payee In Ebonyi

By; MKPUMA ENYINNA, Abakaliki The Petroleum Dealers Association of Nigeria, Ebonyi State chapter, yesterday, shutdown businesses as a result of the ongoing court case to resolve the issue of `Payee' between the petroleum dealers and Ebonyi state Board of Internal Revenue.

Addressing newsmen after the court sitting in Abakaliki, the Chairman of the Petroleum Dealers Association of Nigeria, Ebonyi State branch, Hon. Njaka Silas alleged that the Board of Internal Revenue in Ebonyi State took about 18 companies to court over payee issues, insisting that monthly emolument of their staff must be compiled and forwarded to the board, but the petroleum dealers association insisted that it is abnormal to do so since their company's staff are unstable, irregular and not permanent because they can easily abandon the job and move elsewhere anytime they want. Hon. Silas further explained that the issue of 'Payee' is not obtainable in other sister states in South East like Enugu, Imo, Anambra and Abia, questioning why their state should be different from others.

some of our members to court on the issue of 'Payee' ie we did not do filling for some years, now.

"As we have case in court, our offices can't be open; we do close our offices as we go. And as we are going back, our offices will be open again.

We don't have any personal issue with government, except that Ebonyi state Board of Internal Revenue took about 18 companies to court over allegations of 'Payee', that they did not file payee for previous years.

"What they meant by filling payee is that the names of our workers should be submitted since we pay our workers monthly, at the end of the year, we compile monthly emolument and forward to them, but the new law says, if somebody doesn't earn up to thirty thousand, a certain number of staff, should not do it which is not applicable to us. ``We have made inquiries from Anambra, Enugu, Abia, Imo and the are not doing it.So many other states in the country are not doing it, why is our own seeming to be different.

bout 40 people were on Sunday abducted by gunmen during a Church, Madala along Buruku Baringi road, Kaduna in Chikun local government area of Kaduna state.

Confirming to New Nigerian about the incident, the chairman, Christian Association of Nigeria (CAN), Kaduna State Chapter, Rev. John Joseph Hayab said, "The worshippers were in the Sunday service in the church when around 9:30am, they heard gun shots very close to the church. The gunmen attacked the church and went away with 40 worshippers."

He added, "Along the way, somehow 15 of the kidnapped persons returned, remaining the rest 25 who are presently in captivity without any word from their abductors."

According to him, efforts are being made to get in contact with the abductors concerning the remaining people and prayed that the abductors would be merciful to release the remaining 25 back to their families.

When contacted, the state Police spokesman, DSP Mohammed Jalige, promised to contact the DPO of the affected area for prompt action.

Airlines' Maintenance Capacity Low In Nigeria - Ogun NNPP Guber Candidate *Demands govt's seriousness in aviation sector

The Ogun State gubernatorial candidate of the New Nigeria People's Party (NNPP) in the last general elections, Ambassador Olufemi Ajadi on Monday, tasked the Nigeria Civil Aviation Authority (NCAA) to take urgent steps on aircrafts operating at Nigeria's airports.

Ambassador Ajadi in a statement, said this is necessary in view of the various challenges encountered by passengers during flights as a result of poor maintenance capacity of aircrafts operating at Nigerian airports.

According to him, the situation is a primitive system that needs urgent attention from various relevant government authorities, saying the Nigeria Civil Aviation Authority (NCAA) and other relevant government agencies should be up and doing in the area of policy formation, implementation and execution, such as mandating airlines operation with standard and better aircrafts. Ambassador Ajadi also called for stringent sanctions against any airline that fails to airlift passengers on scheduled time, as well as other violation of local content policy of the country, where some airlines are still selling tickets in dollars instead of Nigerian currency, Naira. Recalling that his recent experience in boarding an aircraft within the country was not palatable and nothing to write about, Ambassador Ajadi pointed out that most of the airlines are operating with old and obsolete aeroplanes that are unfit

He stressed that the airline industry, especially those running local businesses, should be monitored and sanctioned if

necessary by the relevant federal government agencies like NCAA, adding that nonchalant attitude of government towards some areas of human endeavours and economic growth and development are major factors responsible for negligence of most of the airline companies. " If government wakes up to its responsibility in sanctioning most of these erring airline operators, they will think twice and wake up to their responsibility. But our government does not take us serious, I have called their attention twice to our plight in the aviation sector but nothing good comes from their part, this is the third time I am

Kidnapped Victim Killed, Others Rescue By Police In Abuja

gun duel between operatives of the Federal Capital Territory (FCT) Police Command and some kidnappers claimed the life of a kidnapped victim identified as Tama Jonathan.

SP Josephine Adeh, the FCT Police Public Relations Officer, in a statement on Sunday, explained that the operation led to the rescue of at least 58 abductees.

Udulu Forest in the Gegu Local Government Area of Kogi State, bordering Sardauna Forest in Nasarawa State hosted the kidnapped victims, according to the statement and other identified kidnappers' dens in communities bordering the FCT.

Adeh explained that the bandits and kidnappers, while sighting the security team coordinated by the police, immediately opened fire leading to a gun battle, but were overpowered and escaped with bullet injuries, leaving behind their victims. She explained that one Tama Jonathan, a kidnapped victim sustained injury during the rescue operation and died on the spot, saying that his remains have subsequently beßen released to his family for burial.

The other 58 rescued victims, according to the statement are being treated at the hospital and would be reunited with their families.

The statement said, "Rescue is part of efforts by the command's leadership, in a sustained joint operation with other security agencies, vigilantes, and hunters from the various local communities, to combat violent crimes in the FCT, rescue victims, and bring perpetrators to book."

Haruna Garba, the Commissioner of Police, FCT Command, vowed that efforts are on to prevent any further threats to the safety and security of residents, adding that the command would not relent in ensuring the rescue of any resident held hostage by criminals and would also bring the perpetrators to book.

Akwa Ibom HIV Anti-Stigma Bill: More Calls On Gov Emmanuel To Append Signature

oncerned by the need to check HIV AIDS prevalence in Akwa Ibom State and to ensure free and supportive environment for all, Governor Udom Emmanuel has been called upon to sign the HIV Anti-Stigma and Discrimination Bill into law.

This is in spite of the advocacy mounted by various concerned groups in the state, including the Association of People living with HIV/AIDS.

Speaking to our correspondent in Uyo, on Monday, the Coordinator Association of Positive Youths Nigeria, Akwa Ibom State chapter, Mr. Churchill Kingsley said assenting the bill into law will be a foundation for the state to leverage on

"If the bill is signed into law by the governor, we will benefit, we will enjoy the reduction on prevalence that is number one (1). Number two (2), People will be free to come out of their closet to disclose their status and live comfortable, because without disclosure and we are talking about epidemic control, it will not be, it can't come to board and I am really pleading with my governor.

Police Confirms Killing Of 4 In Akwa Ibom Cult War

Uyo igeria Police Command in Akwa Ibom State has said that four persons were killed during a cult clash at Nwaniba axis of Uyo metropolis yesterday. New Nigerian in Uyo learnt that the clash which started little on Sunday evening between the Red Heart and Lions Confraternity went wild yesterday evening, causing motorists and other passerbys around the two hot zones to scraper for safety.

The command Public Relations Officer, (PPRO) SP Odiko Macdon in a statement made available to journalists in Uyo, stated that the Commissioner of Police, CP Olateyo Durosinmi

Olatoye Durosinmi is miffed at the disruption of Public Order and Safety by two rival cult groups at Anua Offot and Use Offot, both at Nwaniba in Uyo Local Government Area, leading to the loss of four lives.

Parents, Guardians Raise Alarm Over Rising Cost Of Education

E ducation is a vital legacy that every parent longs to leave behind for children or wards, but in achieving success, there are basic items students need and one of such is essential writing materials.

Training of children in this era has a lot of tasks ahead, as parents struggle to ensure their wards have every necessary material to be used as part of their learning aids in class. Primary and secondary schools in Nigeria have resumed for a new session, parents and guardians have raised alarm over increasing prices of textbooks, stationery and school items.

Speaking with some parents, in an exclusive interview, they lamented that sending their wards to school has added to the economic burdens currently being felt in the country.

But in achieving success, there are basic items students need and one of such, is essential writing materials. According to Mrs Amaka Godwin, at the school her children attend, "school fees have increased, prices for text books that we buy for 1,000 have increased to 1,500 and 2,000, school bags and writing materials have jumped up, not excluding

prices of socks of N50 to N70, which is now N200 and above, not excluding prices of cardigans and other school related materials.

On the part of school fees increase, another parent said her ward brought a note from the school to notify them of school fees increments, "also the school has decided that students should buy their books from wherever they wish, since prices from publishers have jumped up," she lamented.

She said the decision was taken as some parents thought the school was the one adding extra money to the price of books and this will amount to lots of financial expenses.

Meanwhile, on school fees, some of the schools are under going decision to increase their fees, while some are contemplating, due to the recent surge in prices of books and other school materials needed for students, which have added to the burden on parents.

Confirming the development from bookshop owners and stationery dealers in the market, Mr Eze Nwanko lamented the cost price of essential writing materials, while also revealing that publishers are also lamenting that cost of producing the books is now expensive.

He said, "it is not our fault. It is what we buy that we sell and we cannot sell at a loss".

Consequently, parents and students who cannot afford the new textbooks opt for old ones that are similar and are quite affordable.

According to him, to run an effective workshop this period in the country and around the world, is a challenge as the cost of materials used in manufacturing the items have increased, leading to the increment in the cost of their purchase, affecting supplies.

"The West African Examination Council (WAEC), students and pupils in exit class, next week will begin their final year exams," Mr Eze further said, hinting that essential writing materials increase as students resume for writing WAEC, is not an easy task as it is characterized with one striving for success and sales is still at a slow level.

Mr Eze also said, the books publishers used to bring them for between N350 to N500 are now demanding N1,500 to N2,000.

Going on a survey at Sheikh Mohammed Gumi Central Market in Kaduna, revealed that 40 and 60 leaves notebooks have increased from N800 and N1,200 to N1,500 and N2,400 respectively.

Also, a piece of pen, pencil, sharpener and ruler now cost N50 and N30 respectively. Two years back, a pen cost just N20, while a pencil was sold between N5 or N10.

However, the prices of school bags have also jumped. The least price in the market was between N3,500 to N4,000, depending on the quality for either fairly used popularly known as Okrika, or inferior quality bags.

He explained that, "within the past few months, we were not finding survival to be an easy one, but now it is a different thing entirely".


Also, original leather sandals for students cost between N3,500 and N5,000, while rubber sandals for pupils in primary school cost between N1,700 to N2,500.

Cost of textbooks, New General Mathematics is N2,500 and Intensive English costs N3,500 without workbook.

An average story book for primary school students, which used to be sold between N300 and N500, now costs between N1,000 and N1,200. Speaking to a parent, Hajiya Aisha Umar, she lamented that she has spent every penny on her to buy few things for her children.

She said, items are just too expensive. They keep adding money to them every year. Imagine a biro costs N50. Something we used to buy for between N10 to N20 few years ago.

On visiting a seller of exercise books, Malam Aminu Dauda, he said, "the patronage of exercise books in Nigeria is spiking up now



that schools have resumed, since parents procure them for their kids to take to school.

"This is because almost everyone who knows how to write uses an exercise book. However, it is a business, the essentiality of exercise books to students cannot be overemphasized, this is because it forms the basis through which whatever is learnt in school can be remembered.

"When students get back home, they pull out their notebooks and begin to go through them, be it in preparation for a school test or exams, hence the notebooks store the information which the student needs to go through at least one more time to recall what was done in class.

"It does not in any way mean that a seller has to wait for school to resume, even during holidays, parents buy exercise books for their children for home lessons, exercise books are not used by students alone.

"Secretaries in corporations and organizations use exercise books to take minutes during meetings, traders use exercise books to write their inventory as well as documents, their debtors and creditors," he explained.

With Tinubu, Nigeria's Journey To True Development **Begins, Says Rep Adefisoye**

Hon. Tajudeen Adefisoye, popularly known as Small Alhaji is the outgoing member representing Idanre/Ifedore federal constituency of Ondo State in the Nigerian House of Representatives. He opens up for the very first time on his shocking loss in the February 2023 National Assembly election. He also speaks on his expectations of Bola Tinubu's government after his inauguration and on other national issues.

Did you see it coming that you would lose your bid to become a ranking member of the House of Representatives?

I didn't see it coming. In fact, I never thought that I could lose the election. The result came as a surprise to so many people. I truly rated myself before the election based on my legislative performance, high level of dedication to my constituency and unprecedented projects that I brought to my constituency. Going by the judgment of people in my constituency, I am obviously the best MHR in the legislative history of the constituency.

I won my primary election based on this record of performance and I was willing to work with everybody during the main election. Although I knew I would have a big problem the day I decamped to the APC because majority of the youths in my constituency were not so happy with the decision. They had preferred that we remain in the SDP that brought us to office. Nevertheless, I made frantic efforts to explain what necessitated the decision to them but I could perceive that this decision still did not go down well with a majority of my youthful followers. We had a rally two days before the election and with that crowd alone, I honestly felt that I was good to go.

Surprisingly, everything changed on election day when you could even see our party agents working against me. Most of the APC party agents worked for the PDP on the election day. Painful enough, the security agents too were all out against us. Sincerely, I still couldn't fathom what really transpired on the eve of the election that I could only term with on the day of the election.

Painfully too, APC leaders in Idanre Local Government just decided not to work for me. They shockingly sold me out after I had handed over my entire election structure to them. They simply told all my groups to collapse under the party and stay loyal to the party. All my groups did as instructed by the APC leaders in Idanre, but we all realised too late that the leaders had already compromised heavily by selling out to the PDP.

I know that the majority of the people weren't happy after I decamped from SDP to APC. This was after APC members had earlier attacked members of the SDP during the Local Government election. I guess that this was also one of the reasons for the loss in Idanre.

I won the other local government massively and I must give kudos to the leaders of Ifedore Local Government. Although a few of them engaged in antiparty too a large majority supported me.

What are your expectations of the incoming government of Asiwaju Bola Tinubu?

You know I seriously campaigned both online and offline for Asiwaju because I so much believe in him. If you go and check my campaign videos, pictures and even my social media pages; you will see that I so much believed in Jagaban. I said it then that Asiwaju is coming to give us the much-needed and obviously developmental template that will serve as a good guide to successive governments. As a matter of fact, this is where the Nigerian journey to true and lasting development will begin.

We are very much in need of political and developmental direction in Nigeria and this is what Asiwaju has come to offer. We really don't have a clear-cut direction since the return of democracy in 1999. Past presidents were more particular about the title of the president rather than giving deserved attention to the real issue of long-lasting development.

I am totally convinced that Asiwaju means business. He is certain to make things right and we will see a lot of developmental changes under him and I am glad Nigerians will want him to continue automatically after his first four years. You can go and check Twitter and see how I was so much abused on account of pitching my tent with Asiwaju. I am the most abused lawmaker on social media because of my support for Asiwaju Bola Tinubu. I was even blackmailed at a point that I said anyone that refused to vote for Asiwaju must be a bastard.

The President-elect is already giving lots of responsibilities to the youth and that is a good one. He has promised to start the student loan which is also a good one. I am very confident that Asiwaju will appoint a lot of youths into major positions by the time his government starts.

He needs to listen more to the people from the grassroots to get first-hand information and not filtered ones if he wants to readily gain the support of the youths. I am of the opinion that Asiwaju needs to work with result-driven youths that also share his vision on good governance, innovative leadership and how best to empower the Nigerian youths. I am very sure that this will definitely take a whole lot of burden off him. Who would you have supported to become the next speaker of the 10th National Assembly if you had been reelected? I am a party man and will continue to remain a completely loyal party person. I am not unmindful of the fact that the interest of a party always supersedes that of the members. On the basis of this, I would have gone in the direction of the APC party. This means that anybody that is endorsed by the APC national leadership would have automatically been my own candidate too. Are you done with partisan politics and what's your next political plan if your answer is on the contrary?

Done with politics?

This question is funny I must confess. I am just 38 years old and I have a lot of legacy projects within and outside of my constituency. I have leveraged on the vehicle of politics to touch and transform lives. I couldn't have done all these on a wider scale without the vehicle of politics. I am still very much in politics and I know that better and bigger responsibilities are awaiting me and I hope to continue contributing to the development of my state and Nigeria as a whole. I will still be 38 at the completion of my tenure as a member Federal House of Representatives. At this age, I still have the energy and zeal needed for optimal delivery of responsibilities. I have obviously performed very wonderfully as a federal lawmaker and it was this same outstanding performance that got me the award of African Lawmaker of the Year in 2020. This temporary setback happened because people of the grassroots were only angry that I left them for a bigger party. We will address them when it is time and I know they will soon be happy that I joined the APC by the time they begin to see the developmental agenda of Asiwaju for Nigeria. I can confidently tell you that I am still a big factor in the politics of my constituency and Ondo State at large. I am obviously good to go. I have the experience and the intelligence to serve anywhere. We have in the last four years brought a lot of positive changes to.

On the operation of these cameras, Mr. Oreagba assured that Lastma Officers have been duly trained on the usage and so they are capable of handling these gadgets adding that the camera would have significant effect on defiant behaviour on the road.

Delta Police Decimates Suspected Robbers, **Kills One Apprehends 5 Others**

he ranks of armed robbers in Delta State have continued to suffer defeat in the hands of Police operatives as one feared dead and five others arrested in a gun duel.

Three firearms, which include two locally made single barrel, one locally made cut-to-size double barrel guns, six live cartridges, nine expended cartridges were and a car marked PYN 595 PW. suspected to have been stolen were recovered from them.

The deceased suspected kidnapper and three others, according to report, had engaged the detectives in a shoot out while escaping into a bush after a robbery operation.

Our correspondent learnt that he sustained a fatal gun injury and died while receiving treatment.

The four man gang was alleged to have been terrorising and robbing innocemt citizens were said to have snatched a Lexus car along Warri-Sapele road on 4th

May, 2023 at about 1.00pm. It was gathered that they were engaged in the gum battle by a crack team of detectives from "B" Division Warri, led by the DPO SP Bolarinwa Alabi. The Delta State Police Command Spokesperson DSP Bright Edafe who confirmed the incident in a release gave details of how the five suspects were apprehended.

It reads," On 3/5/2023, the Deputy Commissioner of police operations DCP Johnson Adenola, had a brainstorming meeting with key officers in the Command where strategies were mapped out to nip the activities of kidnappers in the bud.

"Tactical commanders were directed to proceed to Ughelli and Warri alongside their men to reinforce the divisions.



WPFD: 66 Nigerian Journalists, 3 Media Houses Attacked In 2022 - IPC

he International Press Centre (IPC) on Friday, alerted that no fewer than 66 Nigerian journalists suffered various forms of attack in 2022.

IPC Programme Officer, Mrs Melody Akinjiyan who made this known while presenting report of attack on journalists in 2022 at the World Press Freedom Day (WPFD) Media Roundtable in Ibadan, said three media houses were also affected by the attack.

Speaking at the WPFD Media Roundtable and Stakeholders' Forum on Journalists' Safety and Protecting Freedom of Expression in the age of Misinformation and Disinformation organised by IPC in partnership with the Nigeria Union of Journalists (NUJ), Oyo State Council, sponsored by Open Society Foundation, she said the 66 reported attacks was a worrisome rise as compared to the over 40 cases recorded in 2021. According to the IPC Programme Officer, the attacks are 24 physical a s s a u l t , s e v e n abductions, one gun attack, two threats to life, two threats to disclose source /intimidation, one invasion, one media shutdown and one robbery.

Mrs Akinjiyan listed others as one denial of access to information, two harassment, 21 unlawful arrest and detention, one hacking of account and two threats to sanction/payment of fine.

"Of the 66 journalists, 56 are male and 10 female. Among them are 13 print journalists, 26 broadcast, 24 online media practitioners and three others", she said.

Mrs Akinjiyan added, "26 of the journalists are from the South-West, 16 from North-Central, 10 from South-South, six from North-East, four from North-West and 10 from South-East.

"The states where the incident happened are Zamfara, Jigawa, Kaduna, Kwara, Gombe, Taraba, Adamawa, Bauchi, Lagos, Ondo, Osun, Ogun, Oyo, Enugu, Bayelsa, Delta, Edo, Cross River and FCTAbuja," she said. Speaking further, the IPC Programme Officer stressed that the various attacks as reported were allegedly carried out by security agencies, political thugs, armed robbers and militant groups like the Islamic State's of West Africa Province (ISWAP).

While tasking journalists to demonstrate greater sense of solidarity in dealing with attacks on media and abuses on rights of colleagues in the profession, Mrs Akinjiyan pointed out that the figure compiled were the only reported of the several unreported cases, urging journalists in the country to share information on attacks with IPC.

The IPC Director, Mr Lanre Arogundade while launching IPC's Centre for Safety and Protection of Journalists (I-CSPJ), disclosed that its goal is to contribute to the future of rights by advocating and promoting the safety of journalists.

Mr Arogundade maintained that the establishment of the centre is also to create awareness on the imperative of protecting journalists especially as they serve as frontline workers during crisis or emergency situations.

"The overarching framework for the establishment of I-CSPJ is the strategic objective of expanding the frontiers of press freedom in Nigeria and Africa, which journalists' safety is an integral part. The goal of I-CSPJ therefore is to contribute to that future of rights by advocating and promoting the safety of journalists", he said.

Mr Arogundade added, "And creating awareness on the imperative of protecting journalists especially as they serve as frontline workers during crisis or emergency situations".

Engineer Sule gave the approval shortly after being presented with the report of the committee s a d d l e d with the r e s p o n s i b i l i t y o f conducting the selection of the new Aren Eggon, at the Government House, on Friday.

The governor emphasized that, the selection of the new Aren Eggon was carried out in line with the strict policy of transparency under his administration.

He disclosed that, out of the 22 kingmakers allowed by law to select the new Aren Eggon, only three qualified to undertake the selection namely the village heads of Wakama, Wulgo and Aribadu.

In line with my strict policy of transparency, I refused to meet any of them and I have instructed all those seeking for this office, about 11 of them, to go and campaign among the three selectors.

"For the first time, they came in here (Government House) today after the election and I used the opportunity to confirm from them whether that is exactly the person they selected. In front of other traditional rulers, they confirmed that that is their selection. "I asked them if they did that as a result of any kind of influence and they said no. Based on that, I agreed to go ahead and implement the report," he stated. Thereafter, Engineer Sule presented the selection of Justice Ahmad Ubangari (rtd) before traditional council of chiefs led by the Emir of Lafia, HRH Justice Sidi Bage Muhammad (rtd) for ratification. " In line with my commitment to be fair, and to approve whatever has been submitted to me, I

submit it to you our royal fathers for your comments before I endorse it finally.

"With this, we have finally approved the selection as was done by the three kingmakers and I want, on behalf of the government, wish the new Aren Eggon a wonderful and successful reign. I pray that he will receive the support of our chairman of traditional council and support of all the other members of the council so he will succeed in his new position," Engineer Sule stated.

Earlier, presenting the report of the selection committee with Mohammed Sani Bala, Permanent Secretary, Ministry of Education and Mohammed Sagir A. "The presiding officer futher confirmed that the exercise was conducted peacefully and Justice Ahmad Ubangari rtd scored 2 votes against one vote scored by Dr. James Angbazo during the ballot. " I therefore wish to submit that the new government should as a matter of priority revisit the issue of compensation, payable to the families of our compatriots who have paid the supreme price in the line of duty and others harassed or assaulted by agents of the state".

Speaking further, the Oyo state NUJ Chairman stressed, " as journalists, we must at all times uphold the integrity and sanctity of our profession by ensuring that ethics of our profession become our guiding philosophy in our daily lives".

"To this end, I want to urge the President-Elect Asiwaju

industry, especially journalists by instituting a judicial panel of enquiry in facilitating justice for our Comrades attacked; maimed or killed in the line of duty".

AFRIMA Demands Justice For Slain AKA, Urges Governments In Africa To Protect Music Stars

By; JACOB ONJEWU AKA to serve as a deterrent to criminally-minded individuals

The International Committee of the All Africa Music Awards (AFRIMA), has implored governments of African countries to arrest the growing cases of violent deaths against music stars on the continent, just as it urged the South African authorities to expedite the process of prosecution of the killers of rapper Kiernan Forbes popularly known as AKA.

AFRIMA recalls that the 35year-old AKA was killed in a cold-blooded shooting on February 10, 2023, at a nightclub in Durban, South Africa and the awards body is demanding that everyone linked to his gruesome murder be expeditiously brought to justice.

President and Executive Producer, AFRIMA, Mike Dada, in a statement, said governments of African nations must make deliberate efforts to prevent violent attacks against music talents, averring that the disturbing trend could potentially erode the gains recorded in the creative industry over the years if not checked.

Dada said the murder of AKA is a wake-up call to governments across the continent to scale up their security architecture to encourage the protection of talented individuals. He suggested that efforts should be sustained to checkmate the proliferation of small arms especially.

AFRIMA said the senseless killing of AKA utterly hurts African creative space, insisting that South African authorities must arrest and prosecute everyone involved in the dastardly act.

"We strongly demand from the government of South Africa to arrest and prosecute all the persons involved in the killing of AKA to serve as a deterrent to criminally-minded individuals who cut short the lives of talents at their prime. The crime deterrent is for criminals to know that there is a big chance for them to be arrested, prosecuted and convicted; we strongly call for justice to be sufficiently served in this case.

"However, this is also a call to the governments of various countries across the continent of Africa to react to this gruesome killing by addressing the challenge of the proliferation of small arms. The trend of arms proliferation in Africa has had an impact on the continent's internal security, which has led to violence and the deaths and injury of thousands of innocent citizens including our music stars and we encourage steps that will lead to the protection of the lives of our talented stars.

"Our ideals include using the platform of AFRIMA to promote the strength of Africa and tell a positive story of the continent and we believe we can tackle p o v e r t y, i n e q u a l i t y, unemployment, climate change and other challenges bedeviling our dear continent through music but the lives of creative talents should be protected to fully realise these lofty dreams," he said.

Similarly, speaking on AKA's killing, AFRIMA's Country Director, South Africa, Lekunutu Seboko, said the government of the country must back up its promises and assurances with concrete action by solving the murder case in good time. He believes bringing the perpetrators of the heinous crime to book will deepen the trust and belief in a better future for not only the music stars in the country but all South Africans, where they can feel safe and secure in their homes and communities.

"AKA's sudden death is a deeply

disturbing tragedy and development in South African music: the ghastly manner of his death has h a d international reverberations and our government must endeavour to bring his assailants to book to prove to the world that we indeed operate a system that uplifts justice and sanity. "Undoubtedly, the African music landscape is diminished by his untimely death; but it is now the responsibility of South African authorities to ensure that justice prevails. We understand that some arrests have been made, but the process of bringing everyone connected

to his death to book must be swift because justice delayed is justice denied," he said.

AFRIMA also reacted to the sudden death of another South African rapper Costa Titch who died in March while performing on stage.

Dada said the invaluable contributions of Costa Stitch, whose real name was Constantinos Tsobanoglou, and AKA to Africa's creative and music ecosystem would be sorely missed.

He added that African music was yet to come to terms with the sudden demise of the two great artists, describing them as true musical giants whose incredible songs and voices touched countless lives.

He added that AKA set the bar high for South African hip-hop just as Costa Titch took it up a notch and the two superstars



collectively and collaboratively projected African music and culture on the world stage with many songs they did together.

He added that the two music icons were prominent figures in the AFRIMA community, recalling that AKA was a winner while Costa Titch won multiple nominations.

Dada said: "The deaths of AKA and Costa Titch will continue to cause significant reverberations across the African music fraternity because their contributions to the art were simply magical. Their music, messages, and successes gave hope to young Africans mired in poverty, violence, and uncertainty. Their works did not only elevate the hip-hop genre to the mainstream of South African music but impacted the global music audience in a manner that deepened the acceptance of African music and culture on a large scale.

"Their losses are personal to us in AFRIMA because they have been part of our journey. We recall that AKA won the Best African Collaboration award in the 2015 edition of AFRIMA for his effort on 'All Eyes on Me' which features Burna Boy, Da LES and others, while Costa Titch got a historic six nominations in the recently held 2022 edition. The greatness of their crafts is still being acknowledged even in their graves.

"We are still sombre and sad about their sudden departures. They inspired the whole of our continent; full of faith, courage, and strength, they have left a huge void in the music industry and their invaluable contributions to the African music ecosystem would be missed forever."

Over N22bn Owed By Electricity Customers In Kogi – AEDC

buja Electricity Distribution Company (AEDC), Kogi Regional office has claimed that over N22 billion worth of consumed energy is being owed by electricity consumers in the state.

The Regional Manager, AEDC, Mr. Danladi Baba disclosed this in an interview with journalists on Saturday in Lokoja.

According to him, the customers as a whole, are owing AEDC over N22 billion worth of debt, and every month they add value to their debt.

He said the state government alone is owing N483 million as of April 2023, while other debts are from private individuals, companies and other customers.

"For the past four months in Kogi, we import energy of nothing less than N1 billion but we hardly get N500 million in average every month.

"We encourage our customers to pay their electricity supply debt to avoid the AEDC from being disconnected from the National Grid," Baba said.

The regional manager stressed that regular payment of electricity bills and

outstanding debt would lead to improved electricity supply for customers to enjoy. He explained that some Electricity Distribution Companies (DisCos), who could not fulfil the obligation of the market, were recently disconnected by the Transmission Company of Nigeria (TCN) from the National Grid.

This he said, is because of their inability to pay for what they imported as energy. "The obligation of the market is that you must meet up with the payment for the energy that you are taking.

"Thank God the AEDC is not part of those Discos that were disconnected and that is why we are appealing to our customers to pay up their accumulated bills.

"If care is not taken, the disconnection by TCN from the grid can affect AEDC also," Baba said.

He, however, noted that the drop in the electricity supply in March and April was due to the shortfall in the allocation given to them by TCN from the National Grid.

"We can only dispense to our customers what is being allocated to us. We hope for improvement in the allocation very soon. "The highest we have gotten in a month is N543 million and sometimes it drops below N500 million", he said.

Lesson From Sudan's War

PEOPLE heaved a sigh of relief by the arrival of the first batch of Nigerians, mostly students caught in the war in Sudan brought back to the country on Wednesday. They landed at the Nnamdi Azikiwe International Airport, Abuja in the night. They were three hundred and seventy-six and evacuated from Egypt by Air Peace and Nigeria Air Force (NAF).

Foreign countries have scrambled to evacuate their citizens and buses were hired by the Nigerian government to take the students from Khartoum, Sudan, to Aswan, Egypt, before they would be brought back home.

"Sudan, already a poor country, now, it is being made worse by the war causing displacement, destruction and poverty. Though the leaders of the warring factions are not fazed, they don't care. However, the massive evacuation of foreigners should worry them as they bring money to the economy of the country."

Egypt had also caused a problem by refusing the evacuated Nigerians entry at the border asking for normal visa procedure in this abnormal time. Eventually, after many days, things were sorted out.

Some of the evacuees have told snippets of the ordeal they went through for many days. They suffered thirst and hunger and fear of the unknown. But at last they are home and we hope the rest would be brought back safely as well.

The war broke out in Sudan between government soldiers and the Rapid Support Forces (RSF), a paramilitary force, which includes militias controlled by the vice president, on April 15.

Since Omar Hassan al-Bashir was deposed in a coup in 2019, having ruled since 1989, Sudan has not been stable as the civilians that took part in the 'revolution' of removing him have been holding protests for return to civilian rule. The army, from all indications, is not in a hurry to relinquish power. General Abdel Fattah al-Burhan is head of the armed forces and therefore the country's president, while General Hamdan Dagolo, better known as Hemeti, is his deputy and the leader of the RSF. In any case, a war is a terrible thing and may Nigeria not witness it again, that is after the Civil War of 1967-1970. Those that think if Nigeria goes to war they would be insulated and suddenly have their 'own' country to run should take a lesson from Sudan. This is an internal war not an aggression from a foreign country. Someone who had witnessed the Nigerian civil war once told me that if a war breaks out, you would find yourself in another town while the members of your family would also find themselves in different other places and some may never meet again.

With over five hundred people dead and thousands injured, there are destructions; hospitals have run out of supplies. Even the Sudanese themselves have fled to neighbouring countries of Chad and South Sudan.

Sudan, already a poor country, now, it is being made worse by the war causing displacement, destruction and poverty. Though the leaders of the warring factions are not fazed, they don't care. However, the massive evacuation of foreigners should worry them as they bring money to the economy of the country.

"But no matter what, the African Union should try its best to bring an end to the war in Sudan. It should be up and doing. We should wake up and not wait for others to come and help us. Africa has a lot of problems; we don't need a war."

The cry for revolution as the only way for eradicating 'corrupt' leaders and bringing in 'pure' leaders that would usher in good governance devoid of corruption is a farce. It is romanticism, because as soon as the revolutionists are installed and tasted power, they would sing a different tune and may become more corrupt than the previous leaders they accused of corruption.

When the war is over, who will rebuild Sudan? Unlike Ukraine that is attacked by Russia and supported by the United State of America in its individual capacity and the North Atlantic Treaty Organisation (NATO), also led by the US as well because it is more like a proxy war between Russia and the West, as such, it would be rebuilt by them; Sudan may probably remain in a perpetual state of getting food and medicine aids, and so on, for decades after the war without recovery.

Health Insurance: Commissioner Seeks Partners Support For Informal Sector Enrollment

By; ALEX UANGBAOJE, Kaduna aduna State Commissioner for Health, Dr. Amina Muhammed Baloni, on Thursday, tasked Civil Society Organizations, donor agencies and other relevant stakeholders to help drive sensitization for the informal sector enrollment into the state's

Health Insurance Scheme. Dr. Amina, noted that the informal sector which accounts for about 99.9% of the state's population, is not on Health Insurance Scheme, a situation she said, is not helping the sector.

She made the appeal during the dissemination of Basic Health Care Provision Fund (BHCPF) spot check finding for quarter four of 2022, by Kaduna State Maternal Accountability Mechanism (KADMAM) with support from Legislative Initiative for Sustainable Development (LISDEL) and Evidence for Action (E4A MamaYe). According to her, the health sector performance for last quarter of 2022, as presented by the mechanism, was an evidence of the State government's commitment to the health care of her citizens.

"The score card is showing the efforts that the Kaduna State ministry of health and it's other agencies has done in improving the health sector of Kaduna State, though we are not quite there yet. "We accept that we have some areas we have to improve, this is what I want to leave for the next administration to build on. They will build on what has already been achieved to correct some of the lapses and improve on what has been done. "I think the team health should be recognized for what has been done, I thank the Governor

especially for his commitment to health. "The challenges we have

with financing is not a lack of commitment by the government, it is generally the economic recession, recall that in years past where there's no recession these funds were released very frequently giving the resources we have for everything." The Commissioner explained. She advised the incoming government to prioritize health because according to her, "this is the basis for which production of the citizens will continue." She charged all agencies under the ministry to be responsible for the feedback for the referrals system of the BHCPF to improve service delivery,

proper reporting system Dr. Baloni, urged the mechanism and other partners to stick to the ministry's BHCPF checklist to avoid duplication of standard, commending them for their support, adding that if all what the ministry budgeted for health were to be released, the state would have seen wonders in health care service delivery.

The BHCPF performance score card, presented by KADMAM's Evidence Sub-committee Chair, Abdulrahaman Mikail, showed that the state government did well in the last quarter of 2022, in terms of governance, coverage and service delivery, except for three aspects of service where the performance was scored 0%. The survey which was a pilot for BHCPF performance in the state was conducted conducted in the four metropolitan Local Government Areas of Chikun, Igabi, Kaduna North and Kaduna.

for BHCPF throughout 2022, and did not also release the one per cent equity funds for same period. The survey equally showed that only 34 per cent children under 1 year a g e a c c e s s e d immunization during the period.

Earlier in her welcome address, representative of KADMAM, Co-chair, Mrs. Dorcas Adeyemi, thanked the commissioner for always giving the mechanism the requisite support to carry out their responsibilities.

She said their intention is to support government to succeed in delivering quality, affordable and accessible healthcare services to the citizens.

Mrs. Adeyemi therefore, called on the ministry to act on the recommendations made by "ensuring adequate supply of vaccines and consumables to designated facilities in the state. We request Kaduna State Government to release the one per cent consolidated revenue monthly as approved in 2023 budget.

"We are requesting state government to timely release and cashback the 25% state counterpart funding for BHCPF implementation. The state MOH should provide adequate feedback mechanism between primary and secondary health facilities to enhance referral for BHCPF enrollees." On their part, representatives of E4A MamaYe and LISDEL, Elkana Aliyu and Adedamilola Ademuyiwa, commended the state government for always opening their doors to partners to contribute their support to government efforts. They promised to continue to support government within their resources to ensure an improved healthcare delivery system.

Crises In Sudan: The Hajj Airlifts Dilemma, The 3 'Hard' Choices

The scheduled signing of 2023 Hajj airlift a g r e e m e n t s b y NAHCON and the Hajj carriers could not be completed due to the ongoing crisis in Sudan.

The five selected Nigerian airlines namely, Max Air, Air Peace, Azman Air, Aero Contractors, Arik Air and Value Jet promised to further make consultation before they will append their signatures to the airlift contractual agreement.

President Muhammadu Buhari had approved Saudi-based Flynas and other Nigerian airlines including Max Air, Air Peace, Azman Air, Aero Contractors, Arik Air and Value Jet to fly Nigerian pilgrims.

While the first five were selected to fly pilgrims from the 36 states and FCT, Arik and Value Jet were selected to offer chatter services to pilgrims travelling under private tour operators.

When NAHCON invited the airlines for a signing agreement on Thursday at the Hajj House in Abuja, only the Saudi-based Flynas signed the agreement while the representatives of other Nigerian airlines declined. Flyna's position is based on the Bilateral Air Service Agreement Nigeria signed with Saudi Arabia on the Hajj airlift quota. In the agreement, NAHCON allocated 28,515 pilgrims to Flynas, 16,326 to Max and Air Peace was to transport 11,348 pilgrims.

NAHCON Commissioner of Operations, Magaji Hardawa explained that the conflict in Sudan has put the airlines in a difficult position. He explained that all the airlines will now require longer flight paths to get to Saudi Arabia.

A layman will argue that the airliners have agreed to transport Nigerian pilgrims to Saudi Arabia and that it is none of NAHCON or pilgrims' business how and which route they fly through to reach Saudi Arabia, but the professionals understand that in the aviation industry, not all 2 plus 2 is 4.

First, the entire 2023 hajj airlift plans were structured based on the traditional mode of transporting Nigerian pilgrims via Sudan Airspace to Saudi Arabia. The prices of flight tickets were negotiated and agreed upon based on the flight time of flying via Sudan airspace which is approximately 4:30 minutes flight time. With the closure of the Sudan Air space, the Nigerian Hajj carriers will require additional 2 hours or more flight time to airlift pilgrims through alternative airspace. That is the odd development in the matter. However, it is extremely disturbing that both NAHCON and the Nigerian-approved

airliners had to wait until the day of signing the airlift agreement before they troubleshoot the negative impact the closure of Sudan Airspace will have on airlifts of pilgrims - particularly, the airliners who are professionals in the aviation industry – or do they think that NAHCON will reflect the difference in the flights time and the financial implications in the agreement after 2023 Hajj fare has been announced and pilgrims have paid?

There seems to be a communication gap which is not desirable at this critical moment especially with less than 16 days to the commencement of Airlift because Hajj air carriers were officially selected on the 7th of April and On April 16, Sudan's CAA notified the world that all air navigation services have been suspended in Sudan's airspace, including above FL245 in adjacent South Sudan, due to 'security reason. There is 17 days gap in which the airliners could have drawn the attention of NAHCON to the likely effects this will have on their operations and table what they envisaged Most importantly, the 2023 hajj fare was tailored to reflect the

number of hours pilgrims from each state will spend before arriving in Saudi Arabia.

For example, Maiduguri to Jeddah is about 1609 nautical miles (2,979 kilometres) with 4 hours flight time, that is why Pilgrims from Maiduguri – Yola axis are to pay N2,979, 000:00 million as 2023 hajj fare. Pilgrims from Northwest zones like Kano, Kaduna, and Katsina are to pay N2,919,000:00 Jeddah to Kano is 1850 nautical miles (3426 Kilometers) with 4:30 minutes flight time. However, Lagos to Jeddah is about 2269 nautical miles (4199 kilometres) plan considering the timeline.

This is the dilemma caused by the crises in Sudan as earlier raised by Independent Hajj Now that Flynas Reporters. has signed the airlift agreement, Nigerian-approved airliners may have no option but to accept and signed because the 28, 515 pilgrims that will be airlifted by Flynas cannot be billed by NAHCON and if that is the case. NAHCON cannot as well readjust hajj fare of the remaining pilgrims for the local airliners - unless the Federal Government wades to shoulder the differences as the situation may activate Yes, and I repeat, NAHCON and the airlines are faced with two immediate hard choices: To review the 2023 hajj fare to reflect the current challenges (a no- go-area option), for the airlines to accept the unforeseen challenges and take it as part of a business tough call, for the Federal Government to wade in and bridge the gap of contention. May Almighty Allah wades into the crises in Sudan and makes this year's hajj a success Amen. Mohammed is the National Coordinator, Independent Hajj Reporters-Nigeria.

civil society organization that monitors and reports Hajj had earlier this week via press statement stated that the crises in Sudan may reconfigure the current arrangement put in place by the National Hajj Commission of Nigeria to airlift Nigerian pilgrims to Saudi Arabia and called on the federal government to quickly review and finds an alternative plan to serve as a backup. Here we are. The suspension of signing of the hajj airlifts agreement by the Nigerian approved Airlines for further consultations should not come as a surprise to those who truly understand the algorithms

with 5 hours and 26 minutes of flight time.

To reflect the flight time, the pilgrims from Lagos are to pay N2,999, 000:00 million as the 2023 Hajj fare. With the crises in Sudan, the airlines will have to take another route that will completely distort the arithmetic of 2023 hajj fare computations, especially on-air tickets.

To me, the likely solution could have been for NAHCON to readjust prices of air tickets as embedded in hajj fare to reflect the flight time for each zone if the Sudan airspace remained closed – a difficult task that disorganized the entire 2023 hajj

My Democracy is Not Your Democracy

TE were gathered. Some intellectuals, social activists, journalists, serving and retired diplomats. The primary issue was democracy. Is it universal and is there just a single, or multiple roads, to democracy? Is the British democracy which calls itself the Mother of Parliaments, superior to the American version; is the latter better than the Australian or the Chinese; is Russian Democracy superior to the Ukrainian? It was Thursday, April 27, 2023 and the venue was the Cuban Embassy on Diplomatic Drive, Abuja.

The out-going Cuban Ambassador, Clarita Pulido Escandel, was presenting the report of the April 19, general elections in her country and explaining Cuban democracy within the context of democracy in the modern world.

A product of the consummate Cuban diplomatic tradition which puts people at the centre, Pulido reminded us that Africa had seven days earlier, lost one of its famous liberation fighters and internationalists, Chris 'Che' Matlhako of South Africa's African National Congress (ANC) and five days later, the United States had on April 25. lost one of its most famous singers and a giant of the Civil Rights Movement, Harry Belafonte. She asked us to honour the duo, not with a minute silence as is traditional, but with music that represents their vocal nature in the cause of liberation humanity. She then played the famous song 'Malaika' (My Angel) a duet by Belafonte and Miriam Makeba, also known as Mama Africa. We rocked to the Swahili hit song which was composed in 1945 by Tanzanian musician, Adam Salim. Makeba had been forced into exile and made stateless by the Apartheid regime. She had stayed in the US and during her first visit to Africa in 1962 had learnt the song in Kenya, sang it at a concert in 1969 and made a duet with Belafonte who had become her mentor. They were two of the sweetest voices on both continents.

The Cuban elections into the National Assembly of Peoples' Power had seen the election of 472 Members of Parliament by 68.56 per cent of voters. Miguel Díaz Canel Bermúdez was reelected as President, Salvador Valdés Mesa as Vice President, Esteban Lazo, as Speaker. Leaders were also elected for the Council of State. The Prime Minister was also ratified and the Council of Ministers appointed. She explained that the system of elections in Cuba is that the populace vote directly for parliament which then votes in the executive leadership. So, democracy in Cuba is a combination of direct and indirect elections.

What is most interesting for me is that unlike Nigeria where the Senator is cumulatively paid some N14 million monthly and the Honourable Member of the House of Representatives is paid cumulatively, some N10 million monthly, their counterparts in Cuba are not paid a dime; neither salaries nor allowances. The Cuban parliamentarian does his normal job after which he attends parliament to make laws. There are those who claim Cuba is not a democracy. This is debateable. I see democracy as a system of government by popular representation based on the vote of the electorate in which the will of the people prevails. A famous definition which is more a description is by a former American President, Abraham Lincoln, who said: "Democracy is the government of the people, by the people for the people." A Nigerian politician during the General Strike and mass street protests in January 2023, paraphrased Lincoln when he said in Nigeria 'Democracy is the government of the greedy, by the greedy for the greedy.'



America thinks itself perhaps the greatest democracy in the world. However, American democracy did not include the Black people until 1964 when the Civil Rights Movement and international campaigns made it too embarrassing.

Although it is assumed that America is a democracy, not a few are uncomfortable with its kind of democracy in which majority vote is not what counts, some electoral college. In its 2016 elections, Hilary Clinton, with 65,845,063 votes or 48.2 per-cent of the total vote, lost to Donald Trump with62,980,160 votes or 46.1 per-cent of the votes.

In the follow-up elections, the sitting American President Trump tried to use arms to get himself re-elected. Until today, Trump has not been brought to book, and may well contest the its leader as Prime Minister. Even if the overwhelming majority of the populace do not want the British Prime Minister, but he can win his single constituency seat and please his fellow parliamentarians, he can stay in power indefinitely. There are no term limits in British democracy; Prime Minister Robert Walpole spent about 21 years in office and William Pit, about 19 years. The shortestlived is Liz Truss who spent 49 days having been appointed on September 6, 2022 and throwing in the towel on October 25, 2022."

Democracy in Britain can even be more ridiculous than the convoluted American one. It runs a 'Constitutional monarchy'. The government is called 'His Majesty's Government'. There, you have a mixture of monarchism and parliamentarianism. When Prime Minister Cameroun lost direction and his Brexit compass malfunctioned, he became a liability and had to go. His replacement, Boris Johnson was known to be an unreliable politician who had been sacked as a journalist for manufacturing an interview that never took place. By the time his lies including trying to deny attending a social party when the country was supposed to be on Covid-19 shutdown, caught up with him, Britons were fed up with him and he resigned. The best option would have been for the people to decide through

free elections who should govern them, but their system of democracy does not allow them such freedom until the five-year general election circle is completed or cut short by the governing party. Until then, they must be governed by whoever the parliamentary caucus of the Conservative Party throws up.

The UK brand of democracy is the West Minister in which the party or a coalition with the highest number of seats appoints its leader as Prime Minister. Even if the overwhelming majority of the populace do not want the British Prime Minister, but he can win his single constituency seat and please his fellow parliamentarians, he can stay in power indefinitely. There are no term limits in British democracy; Prime Minister Robert Walpole spent about 21 years in office and William Pit, about 19 years. The shortestlived is Liz Truss who spent 49 days having been appointed on September 6, 2022 and throwing in the towel on October 25, 2022. A major drawback of British democracy is that the Prime Minster needs only to be a parliamentarian voted for by only one of its 650 constituencies. So, he does not need to be known or voted for by the rest of the country. A major issue about democracy is that the world tends to look only at its form and not its content. Democracy should be a system that delivers on the basic needs of the people and not rhetoric and propaganda.
