

el-Rufai Sacks 2 Traditional Rulers, 3 Village Heads

overnor Nasir el-R u f a i h a s approved the deposition of the traditional rulers of Piriga and Arak Chiefdoms, His Highness, Jonathan Paragua Zamuna and His Highness, General Aliyu Iliyah Yammah, respectively.

A statement signed by the Commissioner of Local Government, Hajiya Umma K Ahmad, stated that the two traditional rulers cease to hold their respective offices from Monday, 22nd May 2023.

The statement said that the depositions follow recommendations from the Ministry of Local Government in line with the provisions of Section 11 of the Traditional Institutions Law No. 21 of 2021.


According to the commissioner, "the District Head of Garun Kurama, Mr. Babangida

Sule, will oversee the affairs of Piriga Chiefdom, pending the appointment of a new chief, while the Council Secretary has been directed to initiate the process for the appointment of a new chief.

"Mr. Gomna Ahmadu, the Council Secretary of Arak Chiefdom, will oversee the affairs of the chiefdom and also initiate the process for the appointment of a new chief."

According to the statement, ''the government found unacceptable the response of HH General Iliyah Yammah to the query regarding his appointment of four district heads, contrary to the one approved for his chiefdom, and his non-residence within Arak chiefdom."

"The deposition of HH Jonathan Zamuna follows the recent communal clashes between the Gure



and Kitimi communities of Piriga chiefdom in Lere LGA, and his non-residence within the chiefdom," the statement added.

The statement also announced the immediate disengagement of the village heads of Aban, Abujan Mada and Anjil in Arak Chiefdom.

President Buhari Commissions Kajola Wagon Assembly Plant

President Muhammadu Buhari on Monday, commissioned Kajola Wagon Assembly Plant in Ogun State.

he wagon assembly plant, which has been completed, has a locomotive and rolling deport.

It has the capacity to produce 500 wagons per year of open wagons, container flat wagons and box

"Out of 368 various types of wagons needed and awarded to Messrs CCECC (China Civil Engineering Construction Corporation), about 220 wagons of the existing rolling stock procurement contract are to be produced at the Kajola plant pending when the plant would be transformed to full wagon manufacturing plant," Buhari explained.

He said the establishment of the Kajola Assembly Plant was a Corporate Social Responsibility by Messrs CCECC Nigeria Limited in the Lagos-Ibadan Railway Modernization Project - being a section of the Lagos-Kano Railway Modernization Project.

The President pointed out that with his approval, the Ministry of

Transportation signed an Agreement in March, 2018 with Messrs. CCECC as Direct Foreign Investment (DFI) by the company in compliance with the Presidential Order No. 5 to promote companies' involvement in infrastructure development and transfer of technology to Nigeria.

"Expectedly, the Federal Government is to facilitate the establishment of the plant by providing enabling environment and necessary support in terms of Tax Waivers, Utilities (Power and Water Supply), Access Road and Rail Sidings etc. This responsibility was carried out meticulously by the Nigerian Government," the President stated.

The ground breaking ceremony of the Wagon Assembly Plant was performed by the Vice President, Professor Yemi Osinbajo GCON, on November 8, 2019 as part of the effort of the Federal Government in the promotion and development of local capacity in Assembling and Manufacturing of Rolling Stock, as well as a means to generate employment and boost economic opportunities for the citizenry.

Buhari highlighted other advantages of setting up the plant, stressing that it is the potential to be provided by the on-going rail projects in the country and Sub-African Region which will generate significant demand for Nigeria's Rolling Stock. "Havingg said that, I am glad to announce to you that we are here to commission the completed Kajola Assembly Plant here in Ogun State and to further inform you that the first set of Wagons assembled here in Nigeria is being rolled out for further deployment for freight services.

"With the milestone achieved, we are seriously working to open the first University of Transportation in Daura, Katsina State. The intension of this University is to ensure adequate turn out of graduates, technicians, artisans, researchers on different areas of transportation especially railway transportation to guarantee the sustainability of the massive infrastructural provision of this administration on rail transportation.

"We therefore, expect that very soon graduands of the University of Transportation Daura and returnees from various Universities in China that were awarded scholarships by Messrs. CCECC will occupy their pride of place in the Kajola Assembly Plant," the President elaborated.

Nigerian Police, South Australian Authorities Apprehend Serial Fraudster In Abuja, Recover 60,000 AUD

peratives of the Nigeria Police Force - National Cybercrime Center (NPF-NCCC) have successfully apprehended one Ogenevowero Emefeke, a 37-year-old resident of Guida Area of the Federal Capital Territory (FCT) for pulling-off an elaborate fraudulent scheme on an Australian National and recovered the sum of sixty thousand Australian Dollars (60.000.00 AUD) from the suspect.

This is coming on the heels of actionable intelligence made available by the South Australian Police Department (SAPOL).

The suspect, in a written statement during Police interview, freely admitted to having committed the fraud and several others dating back to 2021.

This was contained in a release by the Force Public Relations Officer CSP Olumuyiwa Adejobi made available to journalists on Monday.

According to the statement, ":In unmasking his modus operandi, investigation reveals that the suspect and his cohorts usually adopt pseudo identities of renown International celebrities, carefully select their victims through different social media platforms, lure them into an attack popularly known as "Romance Scam", and after gaining their trust,

subsequently play on their emotion to swindle them of their resources. Investigation further revealed that the victims are usually vulnerable men and women in desperate search for emotional comfort and fame.

"The Inspector-General of Police, IGP Usman Alkali Baba CFR, while applauding the new wave of anti-cybercrime achievements recorded by NPF-NCCC under the constructive leadership of the Director National Cybercrime Center, DCP Ifeanyi Henry Uche, via collaborations with international anticybercrime agencies, charged the Center to sustain the drive.

" In the same vein, the IGP urges members of the Public to exercise restraint in engaging in Businesses and Relationships with individuals whose real identities have not been physically verified. While the processes to repatriate the recovered fund to the victim through the Australian Consulate is being perfected, the suspect will be charged to court upon the conclusion of investigations.

Buhari Unveils Dangote Refinery, Expresses Confidence In Accelerated Economic Growth

he much publicised Dangote Petroleum Refinery in Lagos has been commissioned by President Muhammadu Buhari, just as he expressed confidence in the ability of his successor to sustain the framework of public private partnership policies to accelerate the pace of our economic growth and development.

Speaking at the occasion attended by Heads of State from Ghana, Togo, Niger, Senegal and a representative of the President of Chad, the President described the feat as a significant milestone for Nigeria's economy and a game changer for the downstream petroleum products market in the entire African region.

"This mega industry we are commissioning today is a clear example of what can be achieved when entrepreneurs are encouraged and supported and when an enabling environment is created for investments and for businesses to thrive.

"I am confident that my successor, His Excellency Asiwaju Bola Ahmed Tinubu, will sustain the improvement in our economic and business environment and strengthen the framework of our public private partnership policies to accelerate the pace of our economic growth and development.

"I am happy to leave our economy in very competent hands," he said.

The President who commended Alhaji Aliko Dangote's leadership in executing the 650,000 barrels per day refinery urged other entrepreneurs to emulate his example in driving economic growth and realizing Nigeria's economic potential.

He stressed the need for African countries to come together, integrate their economies, eliminate trade barriers, and rally their populations to achieve Agenda 2063 for the continent's prosperity.

"I urge and encourage our other great entrepreneurs to emulate this iconic Nigerian industrialist and join the Government in accelerating our growth in order to realize our country's globally recognized economic potential.

"When I travel around Africa and

meet and engage my brother Heads of State (and I am delighted some of their Excellences are here) I often sense a quiet expectation that our country is blessed with resources and human capacity to lead Africa's rise to economic prosperity and the attainment of Agenda 2063 - 'The Africa we all want.'

"But to achieve the goals of Agenda 2063, Africa must come together - we must integrate our economies, eliminate barriers to trade and energize our youthful population to scale up our productive capacity.

"We must create necessary conditions for our private sector to grow and partner with the public sector to accelerate economic growth across the continent.

"We must not allow outside powers to use some of our leaders to destabilize our economic and political trajectory," he said.

President Buhari acknowledged the visionary investments made by the Dangote Group, under the leadership of Dangote, in transforming Nigeria's economy through its involvement in critical industries such as cement and fertilizer.

He noted that investment in these sectors have played a crucial role in shifting Nigeria from heavy import dependence to becoming a net exporter.

President Buhari acknowledged that Nigeria's economy has faced significant challenges over the years, including deficits in economic infrastructure, insurgency, and external crises such as the Global Financial Crisis, oil price collapses, the COVID-19 pandemic, and the Russia-Ukraine war.

"The consequence of these challenges constitute a severe strain on our economy, limiting Government's ability to provide basic infrastructure without resorting to huge borrowings.

sector and a strong commitment to public private partnership, our economy would continue to remain severely challenged and our economic growth impeded.

"Government therefore, will and should continue to provide an enabling environment and encourage innovative public private partnerships in all sectors of our economy," he said.

The President emphasized the administration's commitment to this approach, citing Executive Order 007 of 2019 which f a c i l i t a t e d t h e rehabilitation/construction of many roads by private sector investors using a Tax-credit scheme.

"It is my hope that the succeeding Administration will continue to apply such innovative schemes in partnership with the private sector to accelerate the provision of critical infrastructure in particular roads, power and gas pipelines," he said.

Alhaji Aliko Dangote emphasised the refinery's role in fulfilling the group's corporate vision of promoting self-sufficiency and global competitiveness.

"We have built a Refinery with a capacity to process 650,000 barrels per day (plus 900,000 tonnes of polypropylene) in a single train which is the largest in the world. We have selected the best plants and equipment and the latest technologies from across the world. "Our products slate is designed to meet the highest quality standards and high-value products including Premium Motor Spirit (PMS), Automotive Gas Oil (Diesel), Aviation Turbine Kerosine (ATK); all of Euro V Standards that will enable us not only meet our Country's demand but also to become a key player in the African and global market.

"Our coastal location and offshore loading and offloading (SPM) facilities with a capacity to receive all our crude oil supplies and evacuate up to 75% of our liquid products give us direct access to the rest of Africa and the global market for exports. In addition, 80 percent of our production can be discharged through trucks nationwide."

He disclosed that the huge investment of over \$18.5billion in this industry was prompted by the company's desire to support and contribute its quota to the Federal Government's sustained effort to transform the economy and reposition Nigeria as the leading nation in Africa, and a respected member among emerging economies in the world.

"Once our plant is fully on stream, we expect that at least 40% of the capacity will be available for export and this will result in significant Foreign Exchange inflows into the country.

"Overall, we are committed to operating our Plant in line with international best practice requirements, recognizing the importance of protecting the environment, and putting in place stringent environmental, health and safety policies to ensure that the refinery operates in a safe and sustainable manner," he assured.

CSO Urges Governors-elect To Avoid Political Changes That May Disrupt 2023 Hajj

group, the Independent Hajj Reporters has urged governorselect to sustain the ongoing Hajj operation in their various states by avoiding unnecessary political changes that may disrupt the successful completion of the 2023 exercise.

The airlift of Nigerian pilgrims will begin on Thursday May 25, about four days to the inauguration of the new president and state governors across the country.

IHR, a not-for-profit civil society organization that monitors and reports Hajj activities in Nigeria and Saudi Arabia, disclosed this in a statement signed by its national Coordinator, Ibrahim Muhammed made available to our correspondent yesterday.

The statement said, "While we congratulate and welcome the newly elected governors, we strongly appeal to them not to alter the ongoing operational structures in their various states to avoid disrupting the ongoing 2023 operational blueprints that may eventually create confusion during the airlifts of our dear pilgrims.

"It is noteworthy that arrangements for all Hajj services have been completed while NAHCON, states Muslim Pilgrims Welfare Boards, Hajj air carriers and other service providers have mapped out strategies on how the exercise will be executed."

The CSO observed that there is currently serious apprehension within Nigeria Hajj industry that some of the incoming governors may replace some of the critical pilgrim boards

the airlift of pilgrims, thereby disrupting the operational ecosystem. Independent Hajj Reporters, therefore, urged the incoming governors to be sensitive to the plight of the pilgrims who have paid their savings to perform the Hajj ritual, "whenever they decide to effect some changes in the administrative algorithms of the pilgrims' boards.

"Our concern is the pilgrim's welfare. We appeal to the new governors to be circumspect in taking any decision so as not to jeopardise the smooth hajj operations."

"The closest Hajj officials that can be reached by pilgrims are the state pilgrims boards officials - who registered the pilgrims, c o n d u c t e d enlightenment, facilitated the issuance of their visa, distributed bags and uniforms to them.

"These operational activities gave the local pilgrims officers direct contact with the pilgrims and at most times, they knew the pilgrims by name. The consequence of distorting the state pilgrims' board's administrative structure is that the Executive Secretaries to be appointed will immediately come with their own teams to replace the local pilgrim's assistants who had earlier created an interactive bond with the pilgrims.

The CSO said the appeal is expedient because of the peculiar nature of the 2023 airlift occasioned by Sudan's civil war.

"At this time, any politically motivated decision must be wellthought out not to disrupt the smooth hajj operation," the statement said.

EFCC: Supreme Court Cautions FG Against Harassment Of Kogi Officials

he Supreme Court has cautioned Nigeria's anti-graft agencies against harassing officials and associates of the Kogi State Government pending the determination of a suit instituted by the Attorney General of Kogi State against the Attorney General of the Federation challenging the constitutionality of Acts establishing some anti-graft agencies, including the Proceed of Crime Protection and Prevention Act 2022, and their applicability to the state.

The Acts mentioned in the Originating Summons include those establishing the Economic and Financial Crimes Commission (EFCC), Independent Corrupt Practices and Other Related Offences Commission (ICPC) and the Nigerian Financial Intelligence Unit

When the matter came up before the full panel of the Supreme Court yesterday, May 23, 2023, Counsel to the Attorney

General of Kogi State, Abdulwahab Muhammed, SAN, drew the attention of the Court to the continued harassment and even arraignment of associates of Kogi State Government in various Courts despite the pendency of the Suit that was filed in February, 2023. Chief A.A. Adeniyi, SAN, also represented the plaintiff (Kogi State AG).

However, Counsel to the Attorney-General of the Federation, T.A. Ghazali, SAN, who was in Court, strangely claimed not to have been served the Originating Process.

The full panel of the Court, led by Hon. Justice Amina Augie, in reaction to the concerns raised by Counsel to the plaintiff (Kogi AG), was unequivocal in making it clear to all parties that once a dispute had been submitted to the Court, and in this case, the apex Court of the land, all persons and authorities in Nigeria are expected to stay further action and await the outcome of the suit. The court therefore, advised parties to stay further action on the subject of

litigation pending the outcome of the suit and adjourned the hearing of the substantive originating Summons to October 10, 2023.

The Attorney General Of Kogi State had, in February, 2023, in Suit No. SC/178/ 2023, approached the Supreme Court vide an originating Summons to invoke the original jurisdiction of the Supreme Court to determine the Constitutionality of the EFCC Act, the ICPC Act, the NFIU Act, the Proceed of Crime (Prevention and Management Act) 2022.

He contended that, going by the pronouncement of the Supreme Court of Nigeria in the case of Joseph Nwobike V.FRN to the effect that the United Nation Convention Against Corruption is the precursor to the EFCC, NFIU, ICPC and Proceed of Crime (Prevention and Protection) Act, and that these laws, having not been enacted in consonance with Section 12 of the 1999 Constitution (as amended), are unconstitutional and have no applicability whatsoever to Kogi State under whatever guise.



I Have No RegretsLeaving PDP For APCSenator Balogun

*Says Makinde begged him with second term ticket, he rejected

he Senator representing Oyo South Senatorial District, Senator Kola Balogun has hinted that he has no regrets leaving the Peoples Democratic Party (PDP) for the All Progressives Congress (APC) despite not securing second term ticket to the National Assembly.

Senator Balogun who dropped this hint on Saturday while featuring on Fresh FM 105.9FM live interview programme "South West Political Circuit" also said Gov Seyi Makinde begged him to come back to the PDP and picked the party's Senatorial ticket after he left the party but that he rejected the offer

The APC Senator stressed that the governor offered him the ticket before the primary which produced Mogaji Joseph Tegbe as the PDP candidate for the election in Oyo South Senatorial District.

"What may not be known to most people, the general public, is that at a point after I left the party and there was this controversy on whether what he did was right or wrong, he actually sent for me to come back and take the ticket. That was before the primary that produced Joseph Tegbe (the PDP candidate for the Oyo South Senatorial District in the 2023 elections), "he said

Senator Balogun added, "Gov

Makinde actually sent someone to my wife- a lady-to please tell me to come back and take the ticket. I was in Abuja. My wife called me and said the governor said I should come and take the ticket. But I said I don't want the ticket anymore. I said 'no, he can keep his ticket. I am gone, goodbye'. So, that was

what happened at that time"
"My life is not only about being a Senator. I have been something before I became a senator. By God's grace, I will continue to be something after being a senator. I said what, that (going back for the ticket) means is that I will be subjected to public ridicule within a space of one month to be jumping from PDP to APC and back to PDP, all in the name of a senatorial ticket."

He maintained that he had no regret leaving the PDP for the APC despite the fact that he failed to secured the ticket of his new party to seek a return to the National Assembly.

"I have no regrets leaving

PDP. I will not do anything different, leaving for APC. What you may not know is that, that was the most unexpected thing to happen, not just by me but by a lot of PDP members, leaders and followers.

Speaking further, Senator Balogun stressed, "this was because the governor (Seyi Makinde) and I were really close. He was always telling whoever that cares to know that there was no vacancy in Oyo South Senatorial District", saying, "but you know, politics is a long concentric circles of intrigues. 24 hours is a long time in politics. You think the deal is done, is sealed, but you wake up the next day, something else is happening. So, things happened that changed the colour of that arrangement,"

Senator Balogun stressed that a lot of PDP senators were upset with Governor Makinde about the decision to withdraw his second term ticket, saying, "Senator Gabriel Suswam told me he saw him somewhere and asked why he should do that. "This is because when

"This is because when (Prince Uche) Secondus was the PDP National chairman, the National Assembly PDP Caucus and the National Working Committee, the state governors and senators are not usually friends. There is always this unhealthy rivalry between governors and Senators. But mine was different.

"Each time my colleagues were talking at such caucus meetings about their terrible experience with their governors, I was the only one that was saying my governor and I were close and we were truly close.

There was a day we, Senate Committee on the Army, came on an oversight to Oyo State, led by Senator Ali Ndume. We didn't tell the governor that we were coming. Ndume said, 'we are going to a PDP state, I don't know if the governor will receive us'. I said, 'why not?' Senator Balogun added, " I called the governor, he picked it and he said, 'please come' and he received us. They were surprised. Our Hospital Demolished With Patients Dragged Out, Shiites Cry Out

embers of the I s l a m i c Movement in Nigeria, have condemned the early Sunday morning demolishing of eight property linked to their members within Kaduna metropolis, with one of the affected buildings, a hospital, which had patients on admission.

Briefing the press yesterday in Kaduna, the Islamic group called on well meaning Nigerians to prevail on Kaduna State Governor, Malam Nasir el-Rufai to abandon the planned demolition of 40 other houses linked to their members.

Reading the text of the briefing on behalf of the group, Mal. Aliyu Umar said that, "We cannot fold our hands, we must talk. We are bonafide citizens of Nigeria. el-Rufai is not a bonafide citizens than me. He is bastardizing everybody," he said.

According to him, leaked memo written and signed by the Director General, KASUPDA (Kaduna State Urban Planning and Development Authority), Ismāil Umaru PS/OFF/7A/Z1/338 (Pg 71), dated 20th April 2023, addressed to the PPS (Principal Private Secretary of the Governor), through the Commissioner, Ministry of Housing and Urban Development Kaduna State, on the above subject matter is relevant

"It is noticed from the memo, 48 structures belonging to the Islamic movement is earmarked for demolition across the state; 1,860 security personnel will be involved and N20,253,500 will be the cost of the demolition exercise.

"The sinister motive is to particularly clamp down on the Islamic movement once again. To cover up the deception for the exercise, 7 other locations were earmarked, but

"None of those locations

will cost up t o N2,500,000 and NONE will require above 180 security personnel to execute! The total cost approved for the exercise

N29,523,50 0 and the total security personnel required is N2,510," he said.

H e explained that from the memo, the acronym'IMN' is

alien to the Islamic Movement under the leadership of Allamah, Sheikh Ibraheem Zakzaky (H) and members of the movement have their various hard earned properties/structures as citizens of the Federal Republic of Nigeria.

"We wrote a rejoinder / release on Thursday 18th May, 2023 requesting the Kaduna State

Al-Kauthar Clinic, Fudiyya Danmadami, Fudiyya Rimi, Fudiyya Tudun wada and the personal house of a brother Alh. Musa Birnin Yero were all destroyed!! No Notice was served on any of our properties!!!"

He said that it is "therefore, disheartening to observe that the main

purpose of this demolition exercise it to again subjugate and oppress members of the Islamic Movement in Nigeria. We view this as an act of provocation and suppression that tantamount to the infringement of our fundamental

human rights as citizens and indigenes of Kaduna State.

"Furthermore, we would like to seize this opportunity to call on the Government to release the International passport of our leader, Sayyid, Sheikh Ibraheem Zakzaky (H) and that of his wife, Malama Zeenatudeen Ibrahim, without further delay to enable them seek medical treatment abroad. We also demand for the release of hundreds of our members that are in

detention centres across the country," he said.

Speaking outside the text of the briefing, he alleged that immediately they finished demolishing the hospital, they went to their school, descended and demolished everything.

"From there, they went to another school in Tidunwada, a storey building, which they went and brought down

"They went to Kawo a brother's house, who has

the picture of Sheikh Zakzaky pasted there, that was his offence, his house was brought down," he explained.

Speaking further, he alleged that their leader, Sheikh Ibrahim Zakzaky has been detained 11 times, taken to court nine times, since 1979 till date.

"He always wins. He has never been convicted, always defeating the government.

"This time he was discharged, all the 500 members accused were discharged," he pointed out.

He said that they are not violent, and they will continue to follow the path of peace by seeking justice at the courts.

"Why must he take that position as if he is above the law.

"We are calling on people of conscience to prevail on them to stop.

"They said 48 structures would be demolished, already eight are down, they should stop to prevent bloodshed.

"Now we are much more confident, we believe that this campaign will be successful and that this campaign will take us to the ultimate objective which is to increase the reserves of our country and also create opportunities around us. We believe that the time for oil and gas to vanish is still far away.

"We believe that oil and gas will continue to be principal in determination of the prosperity of our country of course more especially, providing energy security for our country. And this can't happen unless we have access to the resources and we are able to convert them into value and of course a new approach to doing this that is practical which is what we are doing in the Kolmani area."

According to the Nigeria National Petroleum Company Limited (NNPCL), the Wells have total depth of 14,000 feet, while the NNPC Enserv also said geologists have seen many potential reservoirs and

the company is set to prove that the hydrocarbon there could be oil, gas or both as Nigerian National Petroleum Company Limited (NNPC) has resumed oil exploration in the Lake Chad Basin in Borno state before the corporation stopped the process.

The Executive Director, Frontier Exploration Services at NNPC, Mukhtar Zanna, said NNPC using ACME Rig 5 will be drilling 14,000 feet into the Wadi-B well to get oil and associated gas.

"We are optimistic because we have read the data, also we have new technology. Following the demographic data, we added new emerging technology and deployed, including assessment detection, magnetic technique." while the EDzf, Exploration Services at NNPC, Aminu Maitama, was hopeful of an oil find, saying. "So, we believe in this location, we are going to report oil and gas in commercial quantities." Zanna said.

According to officials of the NNPC Energy Service Ltd (ENSERV), the project is being done under NNPC Frontier Exploration Service for the Nigerian Upstream Petroleum Regulatory Commission, NUPRC, nothing that, , exploration had earlier commenced in 1976 and continued until 1996 with the processing of 33,000km of 2D Seismic data which identified three prospective sub-basins (Gubio, Maiduguri & Baga/Lake Area).

Between 2008 and 2018, N N P C processed 1,962.20km2 of 3D Seismic data; in 2014, it suspended the Seismic Acquisition Operations due to insurgency. NNPC in July 2017 also announced the halt of the exploration activities after some workers recorded insurgency attacks.

The fresh drilling is part of the scramble for oil and gas deposits in Nigeria's frontier basins.





WRAPA Task Stakeholders On Implementation, Akwa Ibom Digitizes Passage Of VAPP Law, GEO Bill In Kaduna

He noted that the meeting was an avenue to re-access the level of commitment by the various stakeholders; what they have done and sill doing and what structures are being put in place to sustain the campaign.



Unveiling the digitized system in Uyo yesterday, the state governor, Mr Udom Emmanuel said the digitalisation which consists of the Human Resource Management and Asset Records of the state public service will make the management of over 29,000 workers easy with just a click of button on the computer.

Emmanuel added that the desire to digitize the civil service is in compliance with the dictates of the 21st century, adding that it would revolutionalise the operations of the civil service and end the duplication of personnel records

"When I came into office, I had the challenges of workers, pensioners coming to do verification. I said not in the 21st century can we be going through all these? Seamlessly, there can be a process that from the day you are applying into the civil service, you can just run through until the day you leave this earth, and that is what we just launched today. "I challenged my people that I would not leave office with what I inherited. The day I leave office, I must hand over to my successor, a full digitized civil service, at

major challenge. "So with what you are seeing here today, if we are advertising for a vacancy, say in the civil service, once you click and apply, the system would automatically assign you a number, and that number would be like your social security number. In other developed nations; that is the number you would use

least starting from the human

resource manager which is a

until you are out. "With that number, you apply, and they would invite you for interview, through that number you would be employed, you would retain that number. That number would be your file number, that number would be the number that will follow through your promotions, different grades, different salary steps until you get to where you retire.

"Once you retire, automatically that number would be assigned to your pension account. So you don't need to go back into series of verification exercises again. So seamlessly, that would be well monitored," he stated.

Speaking on how the digitized operations work, the Head of Civil Service, Elder Effiong Essien said Governor Emmanuel mandated the task of digitizing the civil service in 2021.

Essien stated that though it

was a tedious task, it was achieved, adding that the human resources management system of the operation is a solution to the management of the human resources from entry into the service to retirement. He explained that the

operations consists of self service, human resource data management, performance management and recruitment, noting that it is operational in all Ministries, Departments and Agencies (MDAs) and all employees of government can login with their particulars.

"I feel excited and fulfilled that the Human Resource Management System (HRMS), and the Asset Management System (ARS) which you envisioned and directed for implementation in 2021 is a reality today.

"The configuration of the system and the digitisation of the Human Resource Management and Asset Records of the state government has been completed and the solutions are live.

"It may be of interest to know that having to dig up files and other personnel records that have been dormant in the deep for years, dust, sort, invert, record, index, verify, scan each page; label, merge and upload the data into the system for nearly 29,000 workers were quite time consuming. We thank God that the effort has yielded the expected result.

"In addition to digitization of the records, hands-on training for state executive members, permanent secretary, directors, registrars and 243 trainers, that is train the trainees from all the MDAs have also been achieved.

"Today, the systems are ready for inauguration and officially go live. The human resources management system is a one stop solution for the management of the human resources from entry into the service to retirement. "It comprises four main application modules namely: self service, human resource data management, performance management and recruitment. The solution is deployed in all the MDAs and is open to all the employees of government to login with their particulars.

political activist and former Deputy National Publicity Secretary of the All Progressives Congress (APC), Comrade Timi Frank, has appealed to President Muhammadu Buhari to sack the Board and current management of the Niger Delta Development Commission (NDDC) due to various accusations and counter accusations of corruption within the commission.

Frank said these counter allegations and infighting between the Management team and the Chairman of the Board of NDDC has once again opened up the ugly chapter of the past, where the infighting ends up derailing the overall performances of the commission thereby, short-changing the people of the Niger Delta, yet enriching some with personal gains.

In a statement released to newsmen Monday in Abuja, the Bayelsa born political activist also called on the anticorruption agencies to quickly intervene and launch probe into some of the revelations of corruption allegations made by the Board against the Commission's Managing Director.

According to Frank, the inability to properly defend the 2021, 2022 & 2023 budget in unison at the Senate is a clear testament to the fact that the board lacks the basic prerequisites to oversee the affairs of the NDDC.

He said the people of Nigeria Delta had hoped that the new board would grow to become the hope and fresh air to the region, "but alas we're confronted with the same dilemma of corruption allegations and counter accusations by those responsible in managing the resources of the people.

"It is clear from the foregoing that the inability to work in unison for the overall good of the people will render the activities of the Commission in



jeopardy."

The statement added that the people of the Niger Delta are tired of being the scape goats whenever these infighting arises because of greed and selfishness.

"Following recent revelations of corruption in the NDDC and counter accusations of mismanagement between the recently inaugurated board and management of the commission at the Senate, it will be safe to conclude that the primary objective of piloting the affairs of the commission has suffered yet another setback in the twilight of this new management board.

"Furthermore, the fact that this expose, is coming at a time when all hands are supposed to be on deck in midwifing the rebirth of a new NDDC is very worrisome and embarrassing.

"Instead of harmonizing the blueprint for building a sustainable commission saddled with the responsibility of delivering first class interventions to the people of the Niger Delta, the NDDC is rather confronted yet again with

weighty allegations of corruption by members of its own board whose tenure only began less than 5 months ago.

"The startling revelations by the Chairwoman and counter accusations by the Managing Director and his team has once again left a sour taste in the minds of all genuine stakeholders in the Niger Delta project.

"Most shocking is the allegation of inflating the MD's imprest and the operation of several accounts as confirmed by the Executive Director Finance & Admin rather than maintaining a single account as stipulated by the Federal Government under the Treasury Single Account (TSA).

"Going by these embarrassing scenarios of distrust and the inability to properly harmonize working relationships between the board and its members, it will be safe to recommend a total dissolution of the board to give way for a more proactive and people's oriented board to midwife the NDDC into a world class intervention agency. "It is noteworthy that even

after a forensic audit was

carried out by the FG, paving the way for the smooth operations of the Incoming board, we're still confronted with the same quagmire bedeviling the commission."

Frank, who is the United Liberation Movement for West Papua (ULMWP), Ambassador to East Africa and Middle East, called on the National Assembly, EFCC and other anticorruption agencies to thoroughly investigate the accusations.

"I'm therefore calling on the National Assembly and the EFCC to urgently investigate these accusations of corruption in the NDDC by the board and come up with its findings for a proper recommendation to the Federal Government.

"We have had enough of these embarrassing situations in the NDDC and the Niger Delta at large and every stakeholder has a responsibility in speaking out at this time whilst ensuring that the proper image of the Commission is maintained in delivering the dividends of the region to the people."

Yaduma as Director General / Chief Executive Officer of Forestry Research Institute of Nigeria (FRIN).

"We invited you to this press conference today to share with you, our colleagues in FRIN and Colleges and thus the whole world, the good news that a breath of fresh air is blowing across the Forestry Research Institute of Nigeria, FRIN.

Rebuilding Our University System

ast Friday, I gave the Convocation Lecture at Modibbo Adama University in Yola. The theme was the Nigerian University System and the Public Good: Pathway to Recovery. I addressed the problem of declining finances of the university system, which makes it difficult for the universities to recruit and above all to retain quality staff, engage in research and provide a conducive atmosphere for learning and research. I also addressed the more complex story about the corruption of Nigerian society in general but particularly insidious in the university, which created a mentality of looting and wanton exploitation in whatever situation people find themselves.

"The university cannot serve the public good if it is perpetually on strike. The addiction of ASUU to the strike option as the only way to promote its interests has to stop. ASUU strikes have become part of Nigeria's national strife and trauma. Enormous working days are lost regularly due to strikes. Over the past twenty years, public universities have been closed for five years due to strikes. As Emmanuel Emmanuel, the best all—round student said in his valedictory speech, in his "final year", there were 18 months of strikes — do the maths."

University students' enrolment has had an immense increase since its inception. It started from barely 100 in 1948 to 3,681 in 1962 to 7,697 in 1965-66; to about 17,750 in 1972-73, to about 250,000 in 1994. Over the past two decades, there has been an incredible growth of student numbers. Currently, there are 1,855,261 undergraduate students in Nigerian universities out of which only 102,500 are in private universities.

Meanwhile, the university landscape has been transformed significantly with the dramatic growth of private universities where lecturers are not allowed to join the union.

Nigeria's national educational policy is based on the premise that the greatest investment that a nation can make for the quick development of its economic, political, social and human resources is education. It is considered to be the greatest force that can be used to bring about change. It is in this context that the Nigerian Constitution defines education as a public good that the State has an obligation to provide to citizens in an equitable manner as enunciated in Article 18 of the Constitution.

The problem with the constitutional policy is that successive governments since the Ibrahim Babangida regime have simply refused to place it on the policy agenda. They neither believe in it nor are they ready to implement it. There has been no national conversation on sustaining or reformulating the policy and the occasion of the in-coming government is an opportunity to place it on the public agenda.

The Academic Staff Union of Universities (ASUU) has however been very committed to it and has worked very hard for over four decades to sustain it. The public good was defined essentially as - FREE AND HIGH-QUALITY EDUCATION PAID FOR BY THE STATE. The arrival of radical unionism in the university system meant their engagement was no longer focused on catering for the advancement of the staff welfare of academics but also to have a greater voice in the operations of the Nigerian university system and the affairs of the nation at large. ASUU radicalism has however left the society behind on the theme of education as a public good.

"The strikes have seriously affected university calendars' over the decades and generations of students have lost one to two years of their lives waiting for their lecturers to return. The strikes have shortened teaching weeks and the capacity of lecturers to cover the course outline thereby contributing to the decline in the quality of graduates. Precisely because of this impact, wider sections of the elite have taken their children out of public universities to private universities where ASUU is not allowed to operate so there are no strikes, and lecturers teach and cover the course outline."

The university cannot serve the public good if it is perpetually on strike. The addiction of ASUU to the strike option as the only way to promote its interests has to stop. ASUU strikes have become part of Nigeria's national strife and trauma. Enormous working days are lost regularly due to strikes. Over the past twenty years, public universities have been closed for five years due to strikes. As Emmanuel Emmanuel, the best all-round student said in his valedictory speech, in his "final year", there were 18 months of strikes – do the maths. These long strikes have been sustained for a very long time because ASUU has the power and capacity to organise them without consequence to its material interests as eventually they do not work for the said periods and they get paid for the period which most academics use to work in private universities. The capacity to carry out long strikes, keep students at home for three to six or eight months at a time and get them to put pressure on parents and the government of the day to sign a deal is an apparent sign of strength.

Successive presidents have all been forced to sign deals, but signing is the simple issue, implementation has always been the bane of policies in Nigeria. It could be argued that in reality, ASUU is weak because it's too focused on grandiose victory called an AGREEMENT that often yields little in real results. This state of affairs might be changing. After an eightmonth strike from February to October 2022, the Government refused to pay lecturers the backlog of salaries for the period they were on strike. This might signal a change in the balance of forces. If government maintains its refusal to pay, ASUU will understand that long strikes are not always the best forms of industrial action.

"The Nigerian Government has not reflected on its philosophy of education for 50 years. Since ASUU started negotiating with the federal government in 1982, the union has always had a position paper but government has never had a position. It simply ducks blows from ASUU and threatens or cajoles them to reduce their demands. Government does not even brief its own negotiating team on the principles upon which it should negotiate with ASUU because it does not have any. A good example was the last three government teams – Wale Babalakin, Munzali Jibril and Nimi Briggs - all had their recommendations rejected by the government that appointed them. ASUU puffs and rants about disrespect of government to negotiated deals it signs but the Nigerian Government was never an interlocutor because it never had a position to negotiate from, so all its moves are tactical rather than strategic.'

The strikes have seriously affected university calendars' over the decades and generations of students have lost one to two years of their lives waiting for their lecturers to return. The strikes have shortened teaching weeks and the capacity of lecturers to cover the course outline thereby contributing to the decline in the quality of graduates. Precisely because of this impact, wider sections of the elite have taken their children out of public universities to private universities where ASUU is not allowed to operate so there are no strikes, and lecturers teach and cover the course outline.

As more elite take their children out of the public system, the unintended consequence is that increasingly, governments have less commitment to rebuilding the universities



because their children are not there, they are in private universities within or outside the country. The fact of the matter is that family budgets have transformed drastically over the past three decades with considerable percentages of the family budget devoted to expensive private education for children from the nursery to the tertiary levels. In other words, public education has been abandoned to the children of the poorest in society.

"A responsible government would have placed the current reality on the table for a national debate. They have not done this. The central task today is to get the government to engage the subject of education as a public good in today's context. My key recommendation is that the in-coming government should immediately produce a Green Paper on Education as a Public Good which would then be presented to a National Conference on Education as a Public Good."

The context today is that the rentier State has collapsed and massive corruption and oil theft have wiped out petroleum revenues. Over the past decade, public expenditure has been

based on massive borrowing and the country is now in a debt trap. The State is no longer capable of funding quality education for all. Nigerians know it and they decide for the education of their children. ASUU is stuck in the context of the political economy of the 1970s and 1980s.

A responsible government would have placed the current reality on the table for a national debate. They have not done this. The central task today is to get the government to engage the subject of education as a public good in today's context. My key recommendation is that the in-coming government should immediately produce a Green Paper on Education as a Public Good which would then be presented to a National Conference on Education as a Public Good. Key issues would include the following:

Making our educational system fit for purpose;

Developing a national strategy to Bring Back Our Students from foreign universities;

Enhancing equality and access to education; Funding of education, including payment of tuition fees and scholarships;

Ending the regime of permanent strikes in our universities;

Addressing corruption in the education system;

system; Ending Sexual Harassment in tertiary

institutions Raising academic standards

We should all lobby the incoming administration to immediately review the constitutional, legal and policy framework for higher education or simply the education system. The conference itself should be proceeded with stakeholder meetings where issues are discussed.


The award-winning poet and accomplished playwright with many books to his credit disclosed this to New Nigerian on phone, that the president-elect is an astute politician that has left
