# Sign Police Pension Board Bill Into Law, Retirees Beg Tinubu

Retirees under the Contributory Pension Scheme (CPS) have called on President Bola Tinubu to assent the bill for the establishment of the Nigeria Police Pension Board as a matter of priority.

When signed, it would liberate those under the National Pension Commission (PENCOM)managed scheme from servitude.

The body made the passionate plea in a statement signed by its national coordinator, SP Christopher Effiong (Rtd), made available to newsmen in Calabar.

It would be recalled that the 9th Senate had recently passed the bill for the Establishment of a Police Pension Board, a development that has left the National Pension Commission (PENCOM) defeated in its battle for the Nigerian Police Force to continue under the Contributory Pension Scheme (CPS).

Describing the bill as a milestone achievement, the national coordinator, who was represented by the Vice Chairman, Cross River State Chapter, SP Iwara Ibiang (Rtd), also urged President Tinubu, the national assembly and members of the public to ignore the press propaganda sponsored by the PENCOM's Director-General, Aisha Dahir-Umar and her agents who are bent on continuing police enslavement, cautioning "mischief makers and all those who have stood as clogs on the



# 103 Feared Dead From Tragic Boat Mishap In Kwara

boat conveying no fewer than one hundred persons including a father and his four children has capsized with no fewer than 103 feared dead at Egbu village in the Patigi Local Government Area of Kwara State.

It was gathered that about fifty bodies have been so far recovered from the incident as at time of filing this report while the incident had reportedly turned the entire local government area of the state into mourning.

The Etsu Patigi, Alhaji Ibrahim Umar Bologi the second who spoke to confirmed that the boat w a s r e p o r t e d l y overpowered by river waves, leading to the boat capsizing and leaving many people dead, while others sustained varying degrees of injury. Alhaji Umar disclosed that

about three victims were returning from a marriage ceremony before the sad incident occurred around 3am yesterday morning.

The Etsu Patigi disclosed that efforts are on to recover other victims of the boat mishap which he said comprised of four communities.

Alhaji Umar said the state governor AbdulRahman AbdulRazaq had directed him to engage his subjects to avert future occurrence. The Etsu Patigi urged boat operators to avoid overloading and called on governments to assist in providing life jackets to support boat operations in the axis of the state.

The spokesman of Kwara State Police Command, Okasanmi Ajayi, who confirmed the incident yesterday.



# **Cross River Gov Begs World Bank To Intervene In State's Environmental Issues**

ross River State Governor, Sen. Bassey Otu, has called for the intervention of the World Bank to address environmental issues in the state.

He made the call on when he undertook an on-thespot inspection of some erosion sites in the state erosion sites in the state capital such as in L e m n a / F e d e r a l Agriculture and a failed drainage along Yellow Duke Road.

"We cannot allow something like this in the middle of the town. Looking at this it must have taken a lot of lives, and property. The World Bank has intervention programs which I intend to follow up with, and this has informed my being here.

"We will take a look at the drawings, see what the existing plans are and work quickly to safeguard those who live around this area," the governor said. Giving assurance to the residents of the areas visited, he said, "We are here to work for them. Though resources are limited, we are going to work in the short and medium term to assure them that something is being done as against the long term."

# Anthrax: FG Warns Nigerians Against Eating Pomo, Bush Meat

The Federal Government has alerted Nigerians on health hazards associated with consuming animal skin popularly known as pomo in the country's parlance and bush meat following outbreak of Anthrax in neighboring nations.

Permanent Secretary Ministry of Agriculture and Rural Development, Dr. Ernest Umakhihe described the disease in a statement as bacterial, adding that it has already wrecked havock in West Africa subregion by taking lives and landing many others in hospitals. The disease according to the statement, "affects both animals and man, that is a zoonotic disease. Anthrax spores are naturally found in the soil and commonly affect domestic and wild animals.

"People can get infected with Anthrax spores if they come in contact with infected animals or contaminated animal products, " Dr. Umakhihe explained.

He however, added that the pandemic could not be said to be contagious in the sense that it cannot be contacted by coming to close contact with an infected person.

"Signs of Anthrax are Flulike symptoms such as Cough, Fever, Muscle A ches and if not diagnosed and treated early, lead to Pneumonia, Severe Lung problems, difficulty in Breathing, Shock and Death.

"Being a Bacterial Disease, it responds to Treatment with Antibiotics and Supportive Therapy.

"It is primarily a disease of animals but because of man's closeness to animals, non vaccinated animals with Anthrax can easily be Transmitted to man through the inhalation of Anthrax spores or consumption of contaminated/infected animal products, such as hides and skin, meat or milk.

"Annual vaccinations with Anthrax spore vaccines are available at National Veterinary Research Institute Vom, Plateau State and is the cheapest and easiest means of prevention and control of the disease in animals.

"However, Infected animals cannot be vaccinated but animals at risk can be vaccinated. So in this present case, there is the need to intensify animal vaccinations along Border States of Sokoto, Kebbi, Niger, Kwara, Oyo, Ogun and Lagos states because of their proximity to Burkina Faso, Togo and Ghana. Other states of Nigeria are equally advised to join in the exercise," he pointed out.

"Infected dead animals should be buried deep into the soil along with equipment used in the burial after applying chemicals that will kill the Anthrax Spores.

# Gov Uba Sani **Debt: Kaduna Female Contractor Appeals To Governor Uba Sani**

n indigenous company, Messers Bolanle Ogundele Ventures Kaduna, has appealed to Governor of Kaduna State, Senator Uba Sani to come to her aid and intervene in a debit case between her company and a state government contractor.

The Chief Executive of the company, Mrs Bolanle Ogundele who made the appeal during a press conference on Sunday in Kaduna, alleged that a Kaduna State major contractor, Messers Ronchess Global Resources Limited has refused to pay her company the sum of over 14 million Naira owed her company for the supply of materials since June 2022, despite repeated demands. According to her, her company, Bolanle I Ogundele Ventures supplied to Messers Ronchess Global Resources Limited, through a purchasing order, materials worth over 14 million Naira to the company since last year and the money has not been paid. "The materials which included sharp sand, hard core granites and stone base were supplied to the company and confirmed by the company," she said. While speaking, she explained further that the alleged refusal of Messers Ronchess Global Resources Limited to settle the debit has exposed her to ridicule from those her company collected the materials on credit to carry out the supply, due to her failure to pay the money for the aforementioned materials.

" I am one of the suppliers in the ongoing project titled: Kaduna State Road Agency (KADRA) Urban Renewal Road Project. " I did the supplies for Zaria, Danbushia and Sultan Road projects respectively," Mrs. Ogundele explained.

She said although, she instituted a civil case before a court to retrieve the money, but up till the time of the press conference, nothing came out of it, alleging that, 'It is because I am a woman, or an attempt to frustrate my efforts," the female contractor lamented.

Mrs. Ogundele also said that Ronchess Global Resources Limited paid her company some amount of money in April last year and up till now, nothing has been paid again.

"Last payment date was April 15, 2022, with some amount left unpaid of an invoice dated 23 March, 2022, and we commenced new supply between 22 April, 2022 and 25 May, 2022, and up till date no payment was made," she further said. Addressing newsmen yesterday, the Chairman of JTF Sabon Gyero Community, Uwaisu Yunusa confirmed that the Vigilantes under Kaduna State Vigilante Service (KADVIS) shot twelve persons, while some angry youth were trying to stop KASUPDA from carrying out some demolition at the community.

He said already, he reported the incident to the police DPO in charge of Millennium City and Environs and the victims were taken to Gabasawa Clinic Unguwar Rimi for medical attention.

Uwaisu Yunusa popularly

known as Sarkin Samari, lamented that the community of Sabon Gyero used to have a cordial relationship with KASUPDA and other agencies and he doesn't know why KADVIS would aim at innocent persons, including girls and boys under the age of twelve to sixteen with live bullets.

The victims are, Hasat Magaji, Rukayya Lawal, Hamza Bashir, Aminu Salisu, Rukayya Falallu and Sani Nura.



# FG Should Empower NIS To Produce Nigerian Passports -Comptroller James

h e F e d e r a l Government has been implored to grant the Nigeria Immigration Service (NIS) the right to produce the Nigeria International Passport, commonly referred to as the E-passport.

The Comptroller, Rivers State Command of the Nigeria Immigration Service (NIS) Sunday James, made the call in a write up titled, "Domestication of Production of Nigeria International Passport Pros and Coin".

He was of the opinion that Nigeria Immigration Service should be empowered to produce a product it sells to the public.

While siting the Defence Industry Corporation of Nigeria (DICON) where the military hardwares are produced by the DICON under the Defence ministry, he said that the passport booklet itself should be produced directly by NIS with the support of experts pending when the officers will be trained on the operations of the machines for full scale production.

He emphasised that the Nigeria Immigration Service established by the Act has a role to play in the specifics on the passport to be produced, the quality, texture and the regulation of its usage and issuance.

It reads, " The Federal Government of Nigeria should give Nigeria Immigration Service the Agency statutorily mandated by the Immigration Act 2015 the right of first consideration since the Service Issues and Administer the Processing, Procurement and Production of the Nigeria International Passport otherwise known as the E-passport.

"The Immigration Act 2015 Part II, Section 9 subsection (1)-(5), which deals with the power to Issue, procedure for Issuance and Administration of the Passport and the process vested on the Agency by the Law establishing the agency and the power vested on the Minister of Interior with respect to passport withdrawal, Comptroller James stressed.

While explaining what the Nigeria passport is and its importance, he said, "What is a Passport: A general definition states that it is an official document issued by a government, certifying the holders identity and citizenship, and entitling them to travel under its protection to and from foreign countries.

" Another definition is that a passport is an official travel document issued by a government that contains a person's identity. A person with a passport can travel to and from foreign countries more easily and access consular assistance.

" A Passport certifies the personal identity and nationality of its holder –Wikipedia. A Nigerian International Passport is your ticket to International travel. The passport allows or guarantees access to consular Services and assistance while abroad.

"The types of passport issued by Nigerian government are ordinary or standard Nigerian passport, Diplomatic, Official, Seaman and ECOWAS Travel Certificates are all forms of passports used to travel either International or Regional as the case may be.

" Nigerian passport on record provides Visa-free access to 46 destinations outside Nigeria, Nigerians also requires Visa to enter 183 destinations in the world. The Nigerian passport is ranked 94th place on the Guide passport index.

" The Nigeria passport ranking relative to other global passports is calculated by adding the number of countries that allow Nigeria Passport holders to enter without a Visa (i.e Visa-free countries) and those that allow Nigeria passport holders to enter by obtaining a Visa on arrival (i.e VisaonArrival Countries) or an Electronic Travel Authorization (ETA)". James disclosed that " There are currently a total of 26 Nigeria passport Visa free, 19 Nigeria Visa-on -Arrival countries, 1 ETA destinations. Altogether, Nigeria passport holders can enter a total of 46 destinations either without a Visa, through a Visa-on-Arrival, or Via on ETA. As a result the Nigeria passport ranks 94th in the world.

# Zulum Flags Off 2023 Cropping Season Sales, Distribution Of 442 Tractors, 100 Trucks Of Fertilizers

**G** overnor Babagana Umara Zulum of Borno State has flagged off 2023 Cropping Season Sales and Distribution of 442 Tractors, 312 ploughing and harrowing implements and 100 trucks of MPK Fertilizers yesterday at Borno Digital Farm Center, Muna along Mafa ÷Dikwa Road Maiduguri.

He directed five tractors to be distributed to each of the 27 LGAs of the state and one tractor to also be distributed to each of the 312 wards of the state totalling 442 tractors which will be sold to farmers through agricultural cooperative society at the discount rate of 50% on owner occupier basis out of the 1,000 tractors purchased by his predecessor, Senator Kashim Shettima, but could not be put to use due to insecurity in the state. He also directed that an

Agricultural Sales and Distribution.Committee should be constituted at each LGA with the Permanent Secretary of State Ministry of Agriculture and Natural Resources, Permanent Secretary of Borno State Agricultural Programme Development Agency, LGC ruling party SPC Chairmen, LGC Transition.Committee Chairmen and Borno State House of Assembly LGC State Constituency members, LGCs Heads of Agriculture among others as members of the committee in each LGC.

He lamented how tractors purchased and distributed to farmers were diverted and sold at the detriment of the rural farmers by unknown middlemen, politicians and government officials, while warning that anybody found wanting in selling or diverting of the tractors or fertilizers will be dealt with accordingly without fear or favour.

Zulum further assured that his government is ready to serve all and sundry, irrespective of status in the society, but urged the citizens of the state to be patient with the government as it cannot serve all at the same time, but nobody or part of the state will be left untouched or unreached with basic infrastructure.

He also pledged to acquire more farming implements, fertilizers, seeds and seedlings for farmers for sales and distribution across the state to boost agricultural production.

Earlier in his welcome address, the Permanent Secretary, State Ministry of Agriculture and Natural Resources, Bulama Gana commended the governor for prioritizing the agricultural sector of the state by providing farmers in both the urban and rural areas across the state with farming implements, fertilizers, seeds and seedlings at subsidized rates.

He also highlighted on the achievements of the ministry under the administration of Governor Zulum and ongoing agricultural projects and programmes across the state towards enhancing food production and sufficiency.

# X-Raying The New Electricity Act 2023

There exists some points that highlight as impressive the recent reported signing by President Bola Tinubu at the State House Abuja, of the Electricity and Power Sector Reform Act. 2005, which was passed in July 2022 seeking to repeal, and thus becoming the Electricity Act.

Aside consolidating all legislation dealing with the electricity supply industry to provide an omnibus and ideal institutional framework to guide the postprivatization phase of the Nigerian Electricity Supply industry and encourage private sector investments in the sector, the latest legislation is aimed at creating a comprehensive legal and institutional framework to guide the Nigerian Electricity Supply Industry (NESI).

Expectedly, multiple reactions have trailed this relatively recent development and this should not have come as a surprise. Some have "genuinely interesting" things to say, others do not. To the rest, their most significant concern was the process and experience emanating from past failures.

Pro-new Electricity Act commentators, for instance, believe that considering the strategic role that electricity plays in the socioeconomic development of any nation, there exist strategic reasons as to why the Federal Government must solve the current energy crisis in the country. To them, it is a right step taken in the right direction and it is a hopeful sign of good initiatives to come under President Tinubu led administration.

Despite the validity of the above " interesting comments', there are equally glaring signs that a 'chunk' of Nigerians were not moved by the advent of NewElectrical Act 2023. Aside from the fact that what they anticipate from the present government is no longer a new electricity Act but action, progress and result, their fears were further fed by the argument that there may be structural similarities between precious experiences and current proposition by the Federal Government.

Even when this piece believes that the new Act signed by Mr Tinubu promises to consolidate all legislations dealing with the electricity supply industry to provide an omnibus and ideal institutional framework to guide the post-privatization phase of the Nigerian Electricity Supply Industry and encourage private sector investments in the industry, it is on the other hands believed that Nigerians should not be blamed for the current state of despondency that pervades the new Electricity Act 2023. For a better understanding of where the piece is headed, the challenge of epileptic power supply in Nigeria can easily be likened to the proverbial cat with nine lives that have survived different administrations. Nigerians on their part are particularly not happy that instead of generating megawatts of electricity, successive administrations have become reputed for generating megawatts of assurances devoid of process and outcome fairness. Electricity generation and improvement-related promises by

successive administrations in the country has become a familiar music hall act.

Undoubtedly, Nigerians in my views are aware that the Power Sector remains very critical to meeting the industrial development aspirations but present unbelief is flourishing because Nigerians have suffered protracted unkempt process and disappointment in the hands of successive administrations and such failures affected the survival of humanity and our nation to the extent that many artisans have been thrown out of work while major manufacturing and textile companies closed shop due to epileptic power supply.

Let's cast a glance at some of these past failed promises.

In January 2022, the Minister of Power, Mr Mua'azu Sambo,(as he then was) assured Nigerians that the federal government was ready to generate 25,000 megawatts of electricity in the country. The Minister of Power, Mr Mua'azu Sambo, disclosed this in Katsina State recently during his inspection of several power transmission substation projects, including the ongoing windmill project located at Lambar Rimi in Charanchi Local Government Area of the state as part of efforts to enhance power-related businesses and other economic activities in the country.

In 2005, the government of former President Olusegun Obasanjo, going by media reports attempted to solve the power problem with the Power Reform Act which provided for the privatization of the power sector. As part of that reform, the then National Electric Power Authority, which was renamed Power holding Company of Nigeria, PHCN, was to be unbundled for privatization. But the reform did not go far before Obasanjo left office in 2007. But before then, a report observed that he had sunk \$16 billion into the NIPP without anything to show for it.

Before the dust raised by such colossal waste and phantom promise could settle, President Goodluck Ebele Jonathan (GEJ), in 2010 came up with a similar roadmap for electricity reform in the country.

During the launch of the programme, President Goodluck Ebele Jonathan (as he then was), even boasted saying; As President and Commander-in-Chief of the Armed Forces, I and my Vice President, Arc. Namadi Sambo, GCON, is conscious that what we do with the Nigerian electricity supply industry will go a long way in determining whether Nigeria remains in darkness or joins the rest of the world in the race for development. Our commitment is to bring an end to our nation's stunted growth and usher in the fresh air of prosperity by pursuing a new era of sector-wide reform which is driven by improved service delivery to every class of customers in the Nigerian electricity sector. Promising that with diligent implementation and meticulous application of what this Roadmap provides, we will see an end to the chronic electrical power supply shortages. In a similar style, Professor Chinedu Nebo, the then Minister of Power, in 2013 told Nigerians and of course the entire world that President Jonathan's power

sector privatization process is on already. Successful bidders, he added, have paid 25 percent of the bid offer. They are expected to pay the remaining 75 percent in less than 90 days after which they would take possession of the distribution companies. Also, Nebo going by reports had said that the handing over of the national integrated power projects, NIPP, would make power supply more stable

soon. Regrettably, as at the time of his departure from office in May 2015, there were neither traces of appreciable increase in power generation or the promised fresh air of prosperity. In 2015, the All

Progressives Congress led the Federal Government

emerged.

The party had in the previous year, as part of its draft manifesto, promised to revitalize the nation's power/energy sector. According to the party, its power supply programme would vigorously pursue the expansion of electricity generation and distribution up to 40,000 megawatts in four to eight years. The party would also work assiduously at making available power from renewable energy sources such as coal solar, wind and biomass for domestic and industrial use, wherever they are visible.

In the year 2020, President Muhammadu Buhari led Federal Government, sequentially launched a roadmap for the nation's power sector.

Without going into specific concepts or approaches contained in that move, the roadmap which according to government sources form a part of the outcome of meeting President Muhammadu Buhari held with a German Chancellor, Angela Merkel on August 31, 2018, will have Nigeria partner with the German



Benin and Kaduna to Kano, 330KV DC 62KM line between Birnin Kebbi and Kamba, Lagos/Ogun Transmission Infrastructure Project, Abuja Transmission Ring Scheme, and Northern Corridor Transmission Project. Our agreement with Siemens will transmit and distribute a total of 11,000 Megawatts by 2023, to serve our electricity needs. Mr. President concluded in that speech.

Today, the President Buhari administration is gone but Nigerians are still waiting for the actualization of his promise and reassurance.

Certainly, while I believed and still believe in the current Federal Government's effort to ensure stable electricity in the country, the truth must be told to the effect that the whole gamut of failures is standing on the tripod of corruption, policy summersault and lack of sincere political will/desire by the nation's handlers to engage best minds to help get the answers and deploy the resources we need to move the sector in the right direction while achieving the result we need as a nation.

This piece further holds the opinion that at the most basic level, it is evident that what Nigerians need is result not new Act, assurance or reassurance; they want to see and enjoy stable electricity supplied at a very reasonable tariff regime. Most importantly, President Tinubu must not fail to remember that if the present experience becomes superficially similar to traumatic past memories, it can yield incredible power over emotions and can trigger among Nigerians the same fear responses evoked by the original disappointments. # JIFORM Lauds GIZ, Seeks Partnership With NGC On Media Training

The Journalists International Forum For Migration (JIFORM), has lauded the German Development Cooperation (GIZ) on its support for capacity building for journalists covering migration..

It also called for partnership to sustain the effort through the Nigerian-German Center for Jobs Migration and Reintergration (NGC).

The commendation was contained in the report of the recently concluded two-day workshop on sensitization, strategy, and reportage on irregular migration and trafficking in persons organized by the JIFORM for journalists supported by the NGC between 22nd – 23rd, May in Abuja.

NGC is a product of close partnership between the GIZ and the Federal Ministry of Labour and Employment's Migrant Resource Center (MRC), supporting the Programme Migration Development (PME) being implemented by the GIZ GmbH on behalf of the German Federal Ministry for Economic Cooperation and Development (BMZ) in Nigeria as part of support for the voluntary return and sustainable reintegration.

Dr Ajibola Abayomi, the President of the JIFORM in a statement while commending the NGC said: "The JIFORM greatly appreciates the NGC, and GIZ for the support. The echoes of the training have continued to vibrate within the editorial rooms of media houses as select-journalists have been turning in reports and stories to justify the capacity building engagement.

"While the JIFORM cherishes this newly consummated working relationship, we remain committed to tackling issues of human trafficking and irregular migration both in Nigeria and beyond. We shall continue to partner with the relevant actors to build capacity for journalists.

"Going by the evaluation of migration

activities in Nigeria, we are requesting continuous engagement of journalists at intervals through knowledge sharing workshops on different focal areas to further strengthen relationships with the NGC targeted at improving migration management" Ajibola requested.

The JIFORM president noted that the NGC's efforts through support and oneon-one advice on employment, business, vocational and educational perspectives in Nigeria between December 2017 and December 2022 were very impactful on many Nigerians.

Record shown that the in Nigeria, the PME has provided over 282,000 individuals support measures to the returnees and the local population, provided almost 60,000 individual consultations, placed over 30,000 persons in employment apart from the over 42,000 business start-up measure, over 133,000 qualifications measures and over 1600 psychosocial supports.

Ajibola, added that the NGC's support for returnee Nigerian- migrants over the years in conjunction with the International Organization for Migration (IOM) was a project worth building upon by the Nigerian government.

Parts of the recommendations at the JIFORM workshop were that the Federal Government should to negotiate decent jobs with the employers of labour in Europe, Asia, America, and other parts of the globe through a well-coordinated regular migration pathway preferably under the watch of the Ministry of Labour and Employment in order to de-market irregular migration and human trafficking markets from the country.

Media houses were urged to encourage more investigative stories on migration while the federal government was also advised to approve arm bearing unit for the National Agency for Prohibition of Trafficking In persons (NAPTIP) to enable the agency effectively contained



some notorious human traffickers.

It was also recommended that the Economic and Financial Crime Commission (EFCC) and other government agencies should track illicit funds being raised by human traffickers while the proceed should be plough back into the rehabilitation of the victims.

The JIFORM is a non-profit body with over 300 journalists covering migration across the continents since 2019 and has organized a series of local and international capacity-building for journalists and other stakeholders. It's headquarters is in Lagos, Nigeria. In 2021, it initiated the annual African Migration Summit held in Ghana in partnership with Nekotech Center of Excellence, Accra, the West African Media Migration Summit in Lome Togo and held its 3rd Global Migration Summit in Toronto, Canada in October 2022.

The body in collaboration with the City University, New York City, US between November 2-4, in Brooklyn hosted an intercontinental migration summit. The JIFORM 4th Global Migration Summit on Migration is slated for October 2-14 in Toronto.

# Youths' Lack of Hope in Nigeria

**J**UST recently, I was in the midst of some young women doctors who were lamenting how they couldn't get work in government hospitals and also how they couldn't get residency to specialise.

They now work in small private hospitals that they don't regard as much, since their aim is to specialise, especially in gynecology.

"The irony is that some state governments sponsor medical students abroad but when they return, they refuse to employ them, in spite of complaints that there are few doctors in government hospitals. The fact is that they don't want to spend money on their salary. But if these young people go abroad, they are accused of being unpatriotic."

"I studied out of passion, but the Nigerian government has disappointed me," one said.

But then, there were stories of their friends that work in government hospitals with poor pay.

Therefore when the outgoing speaker of the House of Representatives, Femi Gbajabiamila, said many young Nigerians have lost faith in the country, he couldn't be more apt.

Speaking on Wednesday at the valedictory session of the ninth House of Representatives, he said, "Too many of our young people have lost faith entirely and are choosing in droves to seek their fortunes and their futures in other lands."

"We are losing some of our best and brightest, and if we don't act now, the consequences of this loss will shortly become painfully evident," he added.

It is not however strange to hear such lamentations from leaders, some may even proffer solutions to many problems facing the country, but implementing them is another matter altogether.

While the youths are eager to work and contribute to the progress of their own country, they get the shock of their life at the reality on ground. Some are armed with the best results imaginable but are roaming the streets jobless, while some make do with any job to make ends meet. At the end, some blame our educational system that it is based on theory with no practical skills, yet these best brains that cannot get work here may get job abroad in their field of study and excel there. And that is when Nigeria may lay a claim to them, while if they had been here, their brains and talent would have been wasted. "We should do away with corruption and give opportunity to those that deserve them. We should not accept a situation where there are so many qualified young

people to fill vacancies, but the vacancies are not filled for years, or filled with ghost workers that usually happen from the top officials to steal government's money."

The irony is that some state governments sponsor medical students abroad but when they return, they refuse to employ them, in spite of complaints that there are few doctors in government hospitals. The fact is that they don't want to spend money on their salary. But if these young people go abroad, they are accused of being unpatriotic.

"I have to take care of myself, my family and my parents apart from extended family members, so I have to look for where to make money. I cannot spend many years studying rigorously and expect to be paid peanuts," a young doctor said.

In any case while these best brains are disenchanted and feel betrayed by Nigeria, politicians are getting a lot of money as salary and allowances and God knows what else. They and their families live in opulence, even those that didn't have money before they got into office are suddenly transformed.

So it is not as if the system is hostile to everyone, some get the upper hand and not necessarily for having the best brains.

To bring sanity into the system is to have the will to do so and do it. How come you train doctors but you cannot employ them or if you employ them, you keep them redundant in some cases?

We should do away with corruption and give opportunity to those that deserve them. We should not accept a situation where there are so many qualified young people to fill vacancies, but the vacancies are not filled for years, or filled with ghost workers that usually happen from the top officials to steal government's money. Gbajabiamila also said, "The government must ensure that the economy is healthy, vigorous, growing and that all Nigerians will have equal opportunities to succeed through their labour, hard work and ingenuity," Maybe. # Straightening The K-leg Of June 12, Thirty Years Later

oday is exactly 30 years after the June 12, 1993 presidential election which were annulled by the Ibrahim Babangida military regime.

On June 18, six days after the election, my media colleague and brother, Kayode Komolafe, came to my house with a copy of the full election results being uploaded by the electoral commission.

Businessman and friend of Babangida, Chief Moshood Kashimawo Abiola, had won the election with 58 per cent. Then, on June 23, 1993, Babangida announced the annulment of the election, claiming there had been votebuying. The annulment of an election generally perceived to be the freest and fairest in the country's history, set off six years of bloody resistance against continued military misrule.

A narrative gives a lot of credit to politicians for that glorious resistance which led to civil rule on May 29, 1999. This does not reflect the complete history of that struggle. There were actually three eras of that war corresponding to the regimes of Babangida, Shonekan and Abacha, and the political class was virtually absent in the first two.

The civil movement whose expression vibrated in the voice of towering lawyer, Alao Aka-Bashorun, was convinced that the military was merely deceiving the populace with a bogus transition programme. After a layer of presidential hopefuls had been swept away by military fiat, Abiola and Bashir Tofa were allowed to contest the June 12 election. While Abiola and his group thought they could persuade the military to de-annul the election, the civil movement which had started off in 1990 as the National Consultative Forum, NCF, transformed into a broad national coalition of anti-military forces which included student, youth, professional, market, community and civil society organisations. It was renamed the Campaign for Democracy, CD. Its transition leadership passed from Aka-Bashorun to the medical doctor, Beko Ransome-Kuti.

The CD began mobilising for mass protests across the country to force the military out. But it had two challenges. The first was how to contain the murderous military and minimise the inevitable casualties. The second was how to persuade the political class that did not want to confront the military, not to side the regime. To overcome the second challenge, CD leaders, including Beko, Olisa Agbakoba, Frederick Fasehun, Femi Falana and I held meetings with Abiola to get a commitment that even if he would not support the nationwide protests, he should at least not denounce us.

to reclaim it with bloodshed. Two weeks later, we asked Nigerians to sit at home, and the nation's streets were deserted.

The continued defiance by the populace, forced the Babangida regime to hand over to a military contraption called the Interim National Government, ING, headed by Ernest Shonekan.

Its primary purpose was to organise new elections supervised by the compromised military. But Abiola said the June 12 election was like a derailed train; so until it was cleared, no other train could use the tracks. He turned to the CD to stop the new election process. Beko, Fasehun and I met Abiola's representative, Senator Bola Ahmed Tinubu in his office. It was decided that I coordinated the disruption of the ING's voters registration and review exercise which was necessary for the planned election. We succeeded in doing so across the country and the tottering ING which was later declared illegal by the courts, just needed a push to collapse. But Abiola disagreed with our plans to employ the mass to force the ING out and install him. The alternative he went for was a military coup by alleged pro-June 12 Generals like Oladipo Diya, Chris Ali and Abacha.

We disagreed with the coup and after he met new Head of State, Abacha with Diya and Tinubu as witnesses, we met and warned him to stop his support for the new regime, including his agreement to provide it credible politicians as ministers. But he told us that Abacha was a dwarf, and to greet a dwarf, one had to bend down to his level. It was after it became clear that Abacha and his gang were not going to de-annul the June 12 election and swear him in as President in accordance with their understanding, that the politicians joined the struggle to oust the military from power. It was in that process the National Democratic Coalition, NADECO, coalesced.

NADECO itself had origins in the meetings of the CD and old experienced politicians led by Chief Alfred Rewane with Chief Anthony Enahoro as Deputy. Others included Chiefs Ayo Adebanjo, Ajise and Cornelius Adebayo. After Rewane was murdered in his Ikeja GRA residence where we used to meet, Enahoro led an expanded group and we began meeting mainly in Abiola's house with Alhaja Kudirat Abiola as hostess. Despite Abacha's murder of Kudirat, and many like Enahoro, Dan Suleiman, Wole Soyinka and Tinubu forced into exile, the forces that would see the backs of the military had been born.

Let me on this day, pay tribute to two virtually unacknowledged heroes of the democratic struggles. Prince Ademola Adeniji-Adele who was crucial in keeping Abiola safe when the military dictatorship declared him wanted, better dead than alive; and who contributed funds to keep the streets alive for June 12. His undoing was that he later joined the Abacha transition programme. Then there was Chief Rasheed Abiodun Gbadamosi, economist, writer and an assumed apolitical industrialist who when the goons closed in on Abiola, and people were afraid to give him shelter, took the June 12 presidential election winner to his Victoria Island home. One night, when it appeared his home might be compromised, Gbadamosi got Abiola to climb the fence and shelter in the adjacent premises which he also owned. My salute to these heroes and heroines and hundreds like Bagauda Kaltho who lost their lives in the struggle for democracy in Nigeria.

The protests were overwhelming across the country. In Lagos where we hoped to get some 50,000 protesters, the streets were clogged with millions of people.

The Babangida regime panicked and ordered its Army Chief, General Sani Abacha, to take back the streets by force. Abacha led a long military convoy into Lagos which opened fire on all human beings in sight beginning with youths who were playing football in Apakun/Toyota, Oshodi. That July 6, 1993, the Nigeria Medical Association compiled a figure of 118 corpses brought to the general hospitals in Lagos. They had gunshot wounds with most shot in the back which indicated they were running away when shot. Despite these huge losses and the arrest of many, including Beko and Gani Fawenmi, we continued the protests. Tragically on the day of the massacres, Abiola denounced us in a public statement. He said his mandate was given without bloodshed so he did not want

# Nigeria Air and Hadi Sirika: Understanding the Failure of the Buhari Administration

NE of the clearest symbols of the failure of the Buhari Administration was former Minister of Aviation, Hadi Sirika, trying to pool the wool over the eyes of Nigerians presenting a hastily repainted Ethiopian Airline plane chartered for the trick at high cost to claim that he had delivered on his mandate of delivering Nigeria Air before the end of his mandate. The tragicomedy was not funny because Nigerians knew about the billions spent on the project with nothing to show for it. Maybe the big question was why was he reappointed to deliver on this mandate when he had been given the opportunity in the first term of the administration but had failed miserably?

"Part of the problem was that the same Minister Hadi Sirika had refused to inaugurate all the governing boards of the parastatals in the aviation sector despite repeated admonishing from the President, the APC party chairman and the Central Working Committee of the ruling party. He therefore singlehandedly run the entire aviation sector. This meant that he was all powerful and it pleased him that he was master."

For his failure, he was promoted from junior to senior minister in 2019 and his "empire" carved out of the Ministry of Transport so that he would have sole authority on the matter. The signal was clear, the reward for failure under Buhari was promotion.

It would be recalled that in September 2018, Hadi Sirika's Nigeria Air project was suspended by the Federal Executive Council (FEC), dashing the hopes of many Nigerians that would have loved to see a Nigerian Carrier that we could proudly call ours to ferry us around the world and make a lot of money as British Airways, Emirates, Air France, etc. are making out of our resources. We know the difficulties of government ownership of airlines and what led to the liquidation of Nigeria Airways in 2004 so when Minister Hadi Sirika announced in December 2015 that his strategic objective as Aviation Minister was the establishment of a private sector successful national airline for Nigeria, I put him on my "I like" list. With the suspension of the project and the knowledge that it was all Hadi Sirika's fault, I feel bitter because he could have succeeded if he had consulted

widely and planned well. Instead, he conducted one of the most opaque attempts to establish a project in Nigeria with no information, almost no consultations and absolutely no transparency. His second failure is even more painful even if it was expected.

I have followed the airline issue closely and noticed hat between December 2015 and July 2018, Minister Hadi Sirika on numerous occasions assured Nigerian that the project was on course but he never gave any details on what was being planned. I noticed that a lot of aviation stakeholders were asking question on what the plans of the minister was but there was no response. It became clear that for him, the airline was his personal project and he did not see the need to discuss with stakeholders and create a consensus on the best strategy to adopt.

Given the total information blackout from the Minister, a lot of speculations arose that he was planning to use the assets of Arik and Aero Airlines taken over by AMCON to start the new line. Others speculated that he was begging Qatar Air and/or Ethiopian Airways to come and set up an airline for us. Speculation became the sole mode of engagement because the minister refused to engage with anybody.

It was only in July 2018 at the Farnborough International Air Show in the United Kingdom that Hadi Sirika announced that the name of the proposed new National Carrier is 'Nigeria Air' and that the proposed national airline would be unveiled before the end of 2018. Then came the bombshell - government would invest \$300 million in the new venture and own only 5% of it. With great fanfare, he then launched the logo of the airline for which he had paid some foreign company \$600,000 and multiple criticisms arose. The most effective, I recall, was the tweet by Mustafa Chike Obi, former Managing Director of AMCON who tweeted out on 21st July 2018 - why was Nigeria paying \$300 million for only 5% of the new carrier while Air France/KLM had paid \$286 million for 31% share of Virgin Atlantic? 

# If Obafemi Awolowo Were President Bola Tinubu

HIEF Obafemi Awolowo, affectionately called Awo, was the programmatic politician who had change as mantra and believed that politics must serve the mass of the people. His philosophy of governance was encapsulated in the slogan: Life More Abundant (LMA).

"Awo would have started by stating the rationale for his contesting the presidency, repeating the fundamentals of social welfare and why the people are entitled to the basic needs of life. If there are obstacles to achieving these, he would state them and explain how his administration intends to overcome them. He would relate his past services and political alliances to the future he hopes to take the country, and invite the people to share his dreams."

In turn, his followers had so much trust in him that some lost their lives in the streets while defending his legacy when he was imprisoned from 1963 to 1966. Some of his followers so revered Awo that they swore he sometimes appeared in the moon. On such occasions, the faithful crowded the streets to catch a glimpse of him in the moon.

Awo brought so much development to the Western Region when he was the Premier from 1954-1959 that his administration became the yardstick by which other regions were measured in the First Republic.

Progressive politics in Nigeria was championed during the colonial times by Herbert Macaulay who challenged the British colonialists and defended the people against bad governance. Awo came to symbolise that progressive trend in Nigerian politics. However, despite his best efforts, he never became president which was why when he passed away in 1987, Emeka Ojukwu described him as the "best President Nigeria never had".

President Bola Ahmed Tinubu is one of the politicians who identify with Awo. He tried to immortalise him, among other ways, by transforming the detention facilities in Lekki, Lagos where Awo was held into a museum, library and foundation. As President Tinubu was sworn in on Monday, May 29, 2023, I imagined what Awo would have said if he were in the former's shoes. Awo would have started by stating the rationale for his contesting the presidency, repeating the fundamentals of social welfare and why the people are entitled to the basic needs of life. If there are obstacles to achieving these, he would state them and explain how his administration intends to overcome them. He would relate his past services and political alliances to the future he hopes to take the country, and invite the people to share his dreams.

"Awo would have announced plans to reduce the cost of fuel, make local refining of petroleum products a cardinal principle, ordered the arrest and immediate prosecution of those who profiteer from fuel subsidy, including the various companies and persons who the House of Representatives Inquiry of 2012 established to have fraudulently received subsidy payments."

Right from the podium, he would declare free education for all Nigerian children; how and when the current 18 million out-

of-school children would be in school and a plan to eradicate illiteracy in the country. Awo would have announced free health services for all Nigerians and an integrated rural development. He would have rolled out time-specific plans for mass employment based on his programme of production; the same way his Action Group party built the industrial base of the Western Region by developing industrial areas such as in Ikeja, Yaba and Apapa, and linking some by railway with the Lagos Ports.

Pensioners would have been assured that pension would be a first-line charge and that the elderly would not regret old age.

Awo would have announced which type of loans to take and which would be rejected as well as probe all loans taken in the last two decades with a view to recovering misappropriated funds and jailing the culprits.

He would have announced an end to budget padding and legislators awarding contracts to themselves in the name of constituency projects.

Awo would have announced plans to reduce the cost of fuel, make local refining of petroleum products a cardinal principle, ordered the arrest and immediate prosecution of those who profiteer from fuel subsidy, including the various companies and persons who the House of Representatives Inquiry of 2012 established to have fraudulently received subsidy payments. Apart from the recovery of stolen public funds, he would have ordered the recovery of so-called bad debts, the repayments of trillions of naira used to bailout banks, paid to privatised electricity companies, owed by private businessmen and indefensible tax exemptions. Also, he would have ordered that fraudulently privatised public entities should be recovered. "Awo would have announced definite steps to restructure the country and ensure that all nationalities, no matter how small,



would have a sense of belonging. He would commend the actions of Tinubu when as Lagos State governor, he created new local governments in the state which he styled development centres. Awo would announce plans to make local governments real governments and not mere centres for elites sharing the country's funds."

On foreign policy, he would have let it be known that Nigeria is once again taking its pride of place in Africa with an Africancentred foreign policy, and, that it would be no satellite to any power. Alongside mass housing, Awo would also have announced mass new prisons and expansion of some current ones as his administration would make crime, punishment and social justice, a principle of state policy.

This would entail eliminating ministers of state who are mere spare tyres for actual ministers, and merger of functions such as those of the presidential spokesman and information minister. Indeed, where the three arms of government - the Executive, Legislature and Judiciary - have their individual spokespersons, it is incongruous for a separate person to be appointed to speak for 'government'. He would have announced the decision to merge the Police, Civil Defence, Economic and Financial Crimes Commission, Independent Corrupt Practices and Other Related offences Commission, Federal Road Safety Commission and the Vehicle Inspection Office.


