#### **CSO Commends President Tinubu For Returning Hajj Commission To VP Office**

ndependent Hajj Reporters (IHR), a civil society organization that monitors and reports on Hajj and Umrah activities in Nigeria has commended Nigerian President, Bola Ahmed Tinubu for returning the National Hajj Commission of Nigeria (NAHCON) to the office of the Vice President.

President Tinubu gave the approval on Tuesday shortly before traveling to Paris, France to attend a global financial pact summit.

IHR in a statement on Friday, signed by its National Coordinator, Ibrahim Mohammed saya the decision is a welcome one because it will free the commission from unnecessary bureaucracies and provides efficient time management in the implementation of hajj policies.

" It is our belief that returning NAHCON to the office of the Vice President, which is in line with its establishment act will afford the commission the opportunity to fast track their operations with little or no delay," the statement said.

The CSO also said it is particular delighted that the commission is returning under the supervision of the current vice president, Kashim Shettima, a man, it says that has a track record of doing well for Hajj pilgrims from Borno state while he govern the state for eight years.

"The Vice President had always taken special interest in the Hajj affairs of Borno state and was always personally involved in ensuring that pilgrims from the state perform Hajj in a state of tranquillity. He always ensure that everything needed by the pilgrims are provided and on time.

"It is our belief that the VP will replicate this and do more at the National level, which will in turn see Nigerian pilgrims enjoying the best of services they pay for,," the statement said.

#### **Detectives Sweep Lagos Traffic** Robbers, Cultists, Apprehends 32

fforts of the Lagos State Police ✓ Command at ridding the state of criminal elements have recorded further boost following the arrest of no fewer than 32 suspected traffic robbers and cultists. Various offensive weapons which include hammer, axes, locally made double-barrel, twenty-two live cartridges, two expended cartridges, two 9ml live cartridges and a locally made pistols were recovered from the suspects.

Eleven out of the suspects, alleged to be traffic robbers, were apprehended by operatives attached to Badia Police Station, led by the Divisional Police Officer CSP Ayoola Olawole.

They include Kasim Ibrahim, 20, Sharafadeen Isiaka ,25, Kingsley Okpolo ,42, Toheeb Dauda, 19, Al-Amin Ahmed ,19, Waheed Fisaur, 19, Ariyo Taofeek, 20, Quadri Azeez ,22, Ibrahim Ajomagberin ,27, Ibrahim Ali, 29 and Babagana Ulama, 24.

According to report, the suspects were caught in the act while attacking motorists under the Ijora bridge leading to Apapa Wharf.

The Lagos State Police Command Spokesperson SP Benjamin Hundeyin who confirmed the arrest at the Command Headquarters Ikeja on Thursday, said they will be arraigned in court immediately after the

Commenting on the suspected cultists, Hundeyin, who paraded the suspects on behalf of the Commissioner of Police Idowu Owohunwa disclosed that eight were arrested at Ipakodo in Ikorodu area of the state. He identified them to include Akinwale Abiodun 31, Shola Salawokara, 36, Adewunmi Adeniyi, 33, Ganiu Gbadamosi, 37, Nojim Kasamotu ,32, Abraham Abuba ,39, Agoro Ariyo ,18 and Awotehinde Sikiru, 39. Hundeyin explained that

three others were nabbed in Oshodi area of the state, with one identified as one Oluwatosin Adebimpe, 31, popularly known as Seventy, arrested in Itire area of Isolo.

Identifying the two others

as 39-year-old Razak Agbabiaka and 32-yearold Saheed Olaolokun, the police image maker hinted that investigations showed that the suspects have been operating across the state and environs and causing unrest for a period of time. The police spokesperson hinted that the Commissioner of Police had charged the police tactical units to take battles to the doorsteps of cultists, which led to the arrest of three notorious cultists in the Isolo area of the state. He also disclosed that the tactical unit of the command arrested another set of suspects in the Magbon Area of Badagry, adding that one of them identified as, Ademefun Jamiu, 27, is a cultist in Abattoir.

#### **Lagos Police Recovers Stolen Vehicle** In Kaduna, Apprehends 2 Receivers

Two receivers of stolen goods were also said to have been arrested in connection with the crime. The breakthrough, was consequent upon a discreet and intelligence investigation by the detectives which led them to Kaduna, where vehicle

It later turned out that one of the robbers is actually a security guard employed by the owner of the car stand," he said.

"On the day of the robbery, he was off-duty. He, however, connived with one other to come and rob the place leaving the

security on guard seriously injured while they took away the Toyota Hilux', Hundeyin explained.

Rising from its quarterly review meeting on Saturday, the Network said they are building alliance with the government to ensure that government reinvest the money they are collecting from the citizens back to the system in form of development so that the citizens can feel the impact.

The network is made up of c i v i 1 s o c i e t y organizations, organized private sector, individuals and media partners that has been engaging issues related to Tax Justice.

The network has been

advocating for equity and inclusive prosperity that will foster social and economic justice through an equitable and fair tax system that holds public officials and service providers accountable.

Coordinator of the Network, Simeon Olatunde, in his remarks, noted that the essence of the meeting was to discuss issues around tax and other related matters and what they have done in previous months and plan for the next quarter of the year in the interest of the citizens. He added that the meeting was also meant to provide opportunity for members to learn, review and deliberate on what has happened and the way forward, have a better understanding of how the network works and get acquainted with the new Finance Act; especially for new members.

"There is need to restrategize on how to

engage and learn more about taxation, know who we are and what we are supposed to do to support the government for the benefit of the citizens." Simon said.

Speaking on taxation and its purpose, Obafunso Rahman, Immediate past Chair of Charter Institute of Taxation of Nigeria, Kaduna District, said paying tax is a way of citizens contributing to the running of government for their own benefits.

He emphasized that every citizen must pay tax because every expenses by the government is drawn from taxes, adding "every citizen must contribute to government through payment of tax for the development of public goods and services.

"This money is what government use for services like security which every other aspects of the economy is hinged on. It is also used to develop infrastructure in education, health and other sectors. Also invested in businesses to generate employment.

"Evading tax therefore, means that government can not take care of the livelihood of the citizenry. And if you evade tax, you can be punish for it."

On his part, Chinedu Bassey, who spoke virtually from the Network's Abuja office, urged the Kaduna team to synergize with the state tax administrator and ensure that the relationship is very cordial for better results.

"You need to constantly be reeducated on issues of taxation, get acquainted with tax laws and policies, keep abreast with data on taxes so that when government is taking any decision about taxes, you will know why they are doing it and what to do about it". He advised.

#### CP Warns Public To Be Vigilant As 2 Suspects Are Arrested For ATM Card Swap In Kaduna

peratives of the Kaduna State Police Command have arrested two men for allegedly swapping the Automated Teller Machine (ATM) card of an unsuspecting victim.

A statement signed by the Police Public Relations Officer (PPRO), DSP Mohammed Jalige, dated Friday June 13, 2023 informed that following the development, the Commissioner of Police has charged the general public to be careful with their ATM cards.

"On the 12th June, 2023 at about 1340hrs, a woman reported that on the 10th June, 2023 at about 0715hrs, she went to Jaiz Bank located at Ali Akilu Road Kaduna to make a financial transaction using her Automated Teller Machine (ATM).

"In the course of the said transaction an unknown person dishonestly collected her debit card linked to her Jaiz bank account with a view to assisting her, instead intentionally swapped the debit card and escaped," it said.

According to the statement, few minutes later, she received two debit alerts with a total sum of four hundred and four thousand Naira (N404, 000.00k) from her bank.

During investigation, operatives of the State Intelligence Bureau, Kaduna Command arrested (1) Paul Agu Daniel, and (2) Mike Ogah both male of various addresses in Kaduna State and they voluntarily confessed to the alleged crime.

Investigations also unravelled that the two




suspects had defrauded one of their victims the sum of nine hundred and forty eight thousand Naira (N948,000.00k) using his fidelity ATM card.

The suspects are currently assisting the Police in investigation with a view

to arresting their other criminal accomplices.

#### Court Reinstates NIA DG, Dauda

he court of appeal Abuja division on Thursday, reinstated the former Director General DG, National Intelligence Agency (NIA) Mohammed Dauda.

Delivering the judgement, Justice Peter Ige said the evidence leading to the dismissal of Dauda was frivolous and lacking in merit.

The judge also resolved all the contentious issues against NIA in favour of Dauda who is a respondent in the suit.

He then ordered that his salaries and entitlements since the day of dismissal from office be paid.

The appellate court also gave an order that the sum of N1million be paid to Dauda.

Justice Ige held further: "Dauda should be allowed to retire in service in accordance with the stipulated laws."

"There is no evidence before the court that shows that the respondent has constituted any risk or breached any law.

"The appellant appeal is hereby dismissed for lacking in merit and the Industrial Court judgment is hereby affirmed,"

Dauda it will be recall acted as the head of security agency from

November 2017 to January 2018, when he was replaced by an aide to President Muhammadu Buhari,

Dauda had spent just few months on the job before he was removed.

Dissatisfied by his unjust r e m o v a l, D a u d a challenged his removal in court, saying his dismissal from service did not follow the due process and was wrongful.

He argued that in contravention of the law, no Special Management Staff of the Disciplinary Committee (SMSDC) was set up to investigate the charges against him, and he was not given any fair hearing afterwards.

In an earlier judgement delivered by Justice Olufunke Anuwe, the court had ordered the reinstatement of Dauda as the head of National Intelligence Agency and payment of salaries and entitlements from March 2018 till date after it found that his dismissal fell short of the NIAAct.

In the judgment, it was held that, under the agency's rule, the appropriate committee to investigate disciplinary cases against management staff is the management staff disciplinary committee, "not the special management staff disciplinary committee."

ollowing the brutal killing of eight farmers by suspected members of the Islamic State of West African Province (ISWAP) in Muna, Shuwari, Tamsu Ngamdu and Burum Kaywa communities in Mafa and Jere local government areas of Borno State few days ago precisely on Thursday, Governor Babagana Unara Zulum paid condolence visits to the villages to sympathize with the families of the victims and assured them that his government will intensify efforts to see that the remnants of the Boko

Haram insurgents are delt with.

"We are going to have a meeting very soon, we are going consider deploying more troops to deal with the situation. We are also going to re-establish Agro rangers to include military personnel and other security agencies to give cover to our farmers.

"Food insecurity is worse than the insecurity itself. So we will do everything possible to ensure that our people go to their farmlands. They have to be allowed to go to their farms by 6am and come back by 5pm. We are going to discuss with the

military to ensure that they are allowed to farm", Zulum said.

One of the father of the victims, Baana Abur said, "I lost two of my sons in the incident. They went out to fetch us firewood but unfortunately only to hear that they were shot dead by Boko Haram insurgents at Siriri Kare village.

"The insurgents tied their hands before shooting them on their heads and left one of them to go back home to report that the rest were shot dead", Abur said and started crying.

Another farmer who lost his brother, Ibrahim Muna said, "They went out in the morning to their farm, on their way back home they decided to fetch firewood at Siriri Kare village, where they were intercepted by Boko Haran insurgents around 1 pm on Thursday and they were shot dead by the boko haram insurgents but we could not find their corpses until 10 pm.

"This rainy season, we have prepared to expand our farming activities, but unfortunately it seems the boko haram insurgents want to resurface again, after the relative peace we are enjoying", Ibrahim said.







#### Global Peace Foundation Tasks Religious Leaders On Trauma Care, Social Cohesion, Nation Building

he Country Director, Global Peace Foundation Nigeria (GPFN), Reverend John Joseph Hayab, has called for the collaboration of religious leaders with the foundation towards enhancing the sustenance of peace in Nigeria.

He noted that religious leaders have a role to play in nation building, urging them to rise to the occasion and use their God-given platforms to provide care, preach social cohesion and contribute to peaceful coexistence in the country. The Country Director spoke at the Catholic Resource Centre, Durumi Abuja, during a one-day conference on "Trauma Care, Social Cohesion and the Role of Religious Leaders as Agents of Nation Building", in commemoration of the 10th priestly anniversary of Fr Stephen Ojapah MSP, the Nigerian KAICIID Fellows collaborated with Global Peace Foundation Nigeria, Cardinal Onaiyekan Foundation for Peace, the Interfaith Mediation Centre and O-Trauma Victims Initiative.

He felicitated with the priest and identified with all victims of the numerous traumatic experiences in the country, particularly in the hands of bandits, kidnappers and terrorists.

Hayab lamented that people have lost touch of their common humanity and that it is only by embracing their common humanity that true and lasting peace can be found, stressing that it was the reason why Global Peace Foundation Nigeria started preaching that human beings are members of one family under God, irrespective of any differences.

Rev. Hayab stressed the need for interfaith to collaborate in the quest for social cohesion and nation building, calling on religious leaders to collectively confront and address the challenges being faced by the society by providing shelter for the traumatized people to lean

Hayab added, "Trauma and other security challenges faced by people in our societies are human experiences not religion, it requires religious collaborations to tackle them. It is unfortunate that religion, ethnicity and other lines of divide have encroached into our humanity with detrimental effects, faithful of all religions should collaborate to ensure sanity in the society."

He called on religious leaders and CSOs to continue in their efforts of collaboration and building a network of peace builders in order to salvage the nation and urged that peacebuilding engagements should go beyond town hall meetings to the grassroots and local communities to promote love, peace, tolerant, respect and civic responsibilities among rural dwellers.

In his remarks, Bishop Matthew Hasssan Kukah noted that virtually all Nigerians are traumatized considering that they live in a traumatize d environment, saying that Nigerians are challenged with mental health at various stages and the need for a support system from both the government, CSOs and anyone who can provide it.

According to him,, "the sense of community has been suspended; fundamental issues like trust have become scarce commodities largely because of what the society has become."

He called for the aggregate of interest of values for the state to resolve all contradictions, stressing that banditry is one of the most terrible things that has happened to the nation with priests being targeted by kidnappers in the country as the church is in solidarity with the nation in its battle with insurgency. He called on all victims to retain their state of sanity and put bitterness behind them.

Fr. Stephen Ojapah, a member of the Interfaith Dialogue Forum for Peace (IDFP) and a fellow with the King Abdulla bin Abdul-Aziz Centre for Cultural and Interreligious Dialogue (KAICIID), thanked people for attending his 10th priestly anniversary and the unfortunate incident of his kidnap and the terrible experience of about 30 days with the dreaded bandits.

CAPH, Yusha'u Abubakar, said a lot has been happening with governments enacting laws to regulate various sectors which are not entirely in the interest of the citizens and that it is important that UNESCO set guidelines for regulating digital platforms.

He noted that it has become imperative for a standard to be put in place to regulate the growing digital space, hence the need for the community consultation.

Yusha'u, emphasized the need for local communities to make inputs into the guidelines to enable them take ownership of it.

He said the theme was "Safeguarding freedom of expression and access to information: guidelines for a multistakeholder approach in the context of regulating digital platforms".

In his presentation on data protection and the UNESCO guidelines, the facilitator, Leslie Dongh, said the policy is not different from what the communities are not used, but that the difference was that guidelines are global standard for regulating digital platforms.

According to him, it is in the interest of the citizens to make a well articulated inputs into the document so their rights can be protected. He noted that understanding

the data protection policy and the digital platforms regulating guidelines is very important for every user.

Leslie, emphasized the need for content regulation which he said is in the overall interest of the citizens if their input are added.

He also emphasized on the right of Civil Society Organizations to plays a critical role in understanding the nature of, and countering harmful content and behavior online, as well as monitoring and reporting on government

laws, policies, and regulatory actions that impact human rights.

According to him, the Media and fact-checking organizations also have a role in promoting the enjoyment of freedom of expression, the right to access information, and other human rights, while performing their watch-dog function.

In his closing remarks, the moderator of the session, Joshua James, thanks the participants for the kind of capacity they exhibited in attending to the questions and providing suitable answers and the way they conducted themselves throughout the period of the meeting.

He urged them not to relent in supporting policies and laws formulation since they are the representatives of their communities.

#### **Court Remands 9 Ex Oyo State PMS Chairman, Auxiliary Allies** In Prison Over Alleged Robbery, **Attempted Murder**

\*Adjourns case to July 26

n Oyo State Magistrate court, sitting in Iyaganku, Ibadan on Friday, remanded nine allies of the former Chairman of Oyo State Park Management System (PMS), Mukaila Lamidi Auxiliary for alleged conspiracy, armed robbery, attempted murder and unlawful possession of firearms.

The nine suspects were arraigned by the Police on a 16-count charge before the Iyaganku Magistrate Court. According to the Police, the arraigned suspects are, Olaniyi Abiodun, Kamoru Yusuf, Odunayo Ismaila, Kolawole Joshua, Oladosu Kunle, Fatai Abidemi, Oluwoke Akanbi, Sarafadeen Adewale, and Tirimisiyu Odunavo

The charge sheets read in part, "That you, (suspects) and others now at large on 29th May 2023 at about 2:00 pm at Governor Seyi Makinde"s residence, Ikolaba area, Ibadan in the Magistrate Court District did conspire together to commit felony to wit armed robbery and, thereby committed an offense contrary to and punishable under section 6 (B) of the robbery and firearms (Special Provision) Act Cap R 11 Vol 14 Laws of the Federal Republic of Nigeria 2004."

They all pleaded not guilty to the charges.

Defense counsel, Barr J. D. Olaniyan during the arraignment of the suspects argued that the Magistrate Court lacks jurisdiction to hear the case considering the charges leveled against them. Barrister Olaniyan prayed the Court to remand the suspects at Agodi Correctional Centre, pending the time that the case would be assigned to a competent court of law for hearing.

"This Court lacks jurisdiction to entertain the case with the nature of the charges which ranges from attempted murder to armed robbery. I, therefore, pray the Court to remand them at Agodi Correctional Centre for accessibility and convenience", he said.

Barrister Olaniyan added, " This will make it easier to their counsels to prepare their defense as well bail application."

Magistrate, S.H. Adebisi in his ruling said the Court lacks jurisdiction to hear the case as the charges ranges from conspiracy, and armed robbery to attempted murder which is a capital offense.

Magistrate Adebisi then ordered that the nine suspects be remanded in prison and subsequently adjourned the case till July 26, 2023.

rice of livestock and other animals are affordable to buyers at Kano local markets, where the dealers decried lack of patronage due to the present global economic

Our correspondent who visited some local markets reports that there are adequate animals from small to bigger ones, but lack of adequate money remains a great issue to buyers.

At Badume Market in Bichi Local Government Area, prices of rams, goats, sheep and other small animals were very affordable, where an average ram costs from N30,000 to N120,000, while a he goat costs from N10,000 to N30,000, while she goats and sheep range between N20,00 to N40,000 according to the size and health status of each

At Dambatta Cattle Market, our correspondent gathered that a healthy calf costs from N50,000 to N200,000 while an average cattle was sold at N10,000 to N300,000 where large bulls cost between 300,000 to N600,000 depending on its size.

Similarly, birds like hens, cocks turkeys and fowls were sold between N1,000 to N4,000, while ducks and turkeys were being sold from N5,000 to N7000 depending on their sizes.

At Kofar Na'isa where they sell camels, the price differed from other livestock because of their size and meat quantity.

Most of the dealers expressed that although there is no money at hand, people have tried their best in buying some animals for Eid-el Kabir festivity, which is an annual event that needs special organisation.

The suspect was said to have developed hatred for the deceased because he caught him three times when he stole his animal feeds and he was asked to return them through the intervention of their Mai Anguwa.

Yusuf the suspect, did not stop there, but went ahead to the cassava farm of the late Hashimu situated at his backyard with intention to steal and his wife saw him and alerted the community.

As luck was not on his side, he openly promised to eliminate Hashimu and his wife.

In order to accomplish his evil mission, the suspect Yusuf Yahaya Magaji went to late Hashimu's house around 8.30pm on Wednesday and accomplished his devilish mission by stabbing him twice and left him lying in pool of blood.

Luck ran out of him as members of the vigilantes chased him and arrested him.

When they brought him



back to the community, he confessed what he did and they handed him over to the Saye Divisional Police headquarters.

Despite efforts to save the life of Hashimu at the hospital by the family, it was too late as he gave up on Thursday night and was buried according to Islamic rites on Friday at about 9.30am.

### Sapele Technical College And Imperatives Of Funding Education In Delta State

f there is any reason as to why Elder Sheriff Oborevwori-led Delta State Government must pay disciplined attention attention to funding education in the state, it is the recent news report that the senator representing Delta Central Senatorial District of Delta State, Chief Ede Dafinone, recently, paid an unscheduled visit to Sapele Technical College, the second oldest technical college in Nigeria, where he bemoaned the present state of dilapidation of the institution.

The development apart from vindicating well meaning deltans that persistently advocate for proper funding of education in line with UNESCO budgetary requirement, also painful is the lawmaker's description as worrisome the current state of disrepair of the college, noting that Sapele Technical College, aside being the second oldest technical college after Yaba Technical College in Nigeria, is the first technical school in Delta, and it is owned by the state government but has been without power for the past two years, while its workshops for practical is in complete disrepair.

Regrettably, instead of tackling the kernel of issue elicited by the senator, i have in the past few hours of the publication watched pro-state government commentators underline that the Senator, is a member of the opposition party, The All Progressive Congress (APC), and therefore, his judgments were more political than factual, adding that the school is not as bad as was painted. I have also seen others argue that this is not the time to hold our state governor accountable for such an ugly scenario as he is new and just settling down. To others, the only remedy for this problem is simply to encourage parents to accept fate as across the world, education is neither easy nor cheap to fund.

Without a doubt, the immediate past administration in the state has done appreciably well for the sector. Take, as an illustration, Delta state under Governor Okowa's first term in office witnessed the

renovation/reconstruction/const ruction of over 5,000 classrooms. He also incubated, nurtured and brought into existence three universities to cater for the academic yearnings

of the people of the state. Evidence also abounds that as a result of the work of the Technical and Vocational Education Board in conjunction with the supervising Ministry of Basic and Secondary Education in the state, six technical colleges in Agbor, Sapele, Ofagbe, Utagba-Ogbe, Ogor and Issele-Uku have been fully rehabilitated, well equipped and fully functional. Consequently, Delta is the first State in the country to have all of the courses offered by its technical colleges accredited by the National Board for Technical Education.

However, even though my previous opinion articles, commentaries and interventions favored or supported policies and decisions of the Delta State government, (past and present), the truth is that the current state leadership is bound to face confusion in their minds if the present reality at Sepele and other schools is allowed unaddressed.

Why the state governor needs ample courage to tackle the present challenge created by poor funding of education in the state is that while the Sapele case exists in the open, many others may in a covert/subtle manner be in that condition. If the Sapele experience is a challenge, others may be a crisis.

Take as an illustration, a few months ago, the pictures of the sorry state of Oyoko Primary School, Abavo, Ika South Local Government Area of the state went viral.

The disturbing pictures showed visibly distressed structures, dilapidated classrooms laced with fallen ceilings, windows and doors. Going by the pictures and accompanying commentaries, it cannot be characterized as an overstatement to describe such a scene' as deplorable dehumanizing, troubling, in bad light, bracingly in contravention of international best standard and most importantly, a reality that all well meaning Deltans including our dear governor should worry about.

Similar to the Sapele description by the Senator, the Oyoko disturbing pictures also showed visibly distressed structures and dilapidated classrooms laced with fallen ceilings, windows and doors. Going by the pictures and accompanying commentaries, it cannot be characterized as an overstatement to describe such a



'scene' as deplorable, dehumanizing, troubling, in a bad light, bracingly in contravention of international best standards and, most importantly, a reality that all well-meaning Deltans, including our dear governor, should worry

More touchingly, that such a 'learning environment' still exists in the state could be considered a sure sign that the state did not learn any lesson from the ghastly experience recorded a few years ago at Okotie Eboh Primary school, Sapele area of the state or may have allowed such experience go with political winds.

Surely, it is our collective responsibility to ensure that our schools work and our children are properly educated at the right time. But in this particular case, if the state fails to do the needful, it will again dispatch another sign of a government unmindful of the fact that our children should enjoy the right to education as recognized by a number of international conventions. Most importantly, not taking action to address the situation will simply mean our youths/nation by extension is faced with a bleak future.

To change the narrative, the state government must openly admit that there are large number of youths in the state that are knowledge/education hungry and daily project vividly and openly their potential, character, behavior, performance skills and talents that need to be nurtured in a conducive environment and fairest fees. And achieving this objective of giving them proper education will among other demands require the state government's sincere recognition of the right to education as a human right, and practically uphold Nigeria's membership of a number of international conventions, including the International Covenant on Economic, Social and Cultural Rights where the right is respected.

In a similar vein, the state should

make an effort to increase state budgetary allocation for education as education is the bedrock of development. That 'with sound educational institutions, society is as good as made -as the institutions will turn out all rounded manpower to continue with the development of the society driven by well thought out ideas, policies, programmes, and projects.

The State Governor urgently needs to find a new approach to demonstrate that he truly loves education, especially as any developmental plan in the state without youth education delivered in a well-structured learning environment and fair fees will amount to a mere waste of time and effort. Taking such action will in the opinion of this piece offer him an edge over others in the leadership corridor. This is the way to go.

## Re: Mohammed Dauda Unmasking The Face Behind Frivolous NIA Petitions: My Right Of Reply

et me start by stating that I am a patriotic Nigerian, who, as a loyal and dedicated officer of the National Intelligence Agency, NIA, has never done and will never do anything detrimental to National Security and Integrity of Nigeria. I must confess that, Nigeria: my dear country has done so much for me, for which I have also put in my best, in service throughout my career in the Public service. I have no grudge whatsoever against the NIA or the Government as institutions. I owe alot to my country.

In the last four years or there about, since I left the service of the NIA: albeit unceremoniously, I have been under tremendous pressure from friends and well-wishers, to counter the propaganda being orchestrated by media hirelings of the leadership of the National Intelligence Agency (NIA), against me. But, knowing that, they were mere attempts to cover up the crass ineptitude, nepotism, impunity, tyranny and administrative rascality and impunity, that is taking place at the nation's apex Intelligence agency, I often did not find it necessary to respond to some of the vile allegations.

Although it is an open secret that, the NIA has been suffering bad press, following my removal as the Ag. Director General and my subsequent purported dismissal from the NIA, I find it rather strange, that I am being painted as the culprit behind the negative media, to the extent that I have been branded a saboteur of National Security, for choosing to remain silent in the face of all the vilifications. An issue that the FCA, have cleared me thoroughly.

It is a universal truism, that, when lies are repeatedly told and allowed to fester for too long, without any form of exposure, challenge or contradiction, some gullible minds are bound to begin seeing and believing such lies, as being the truth. It is in the face of this fact, and the continuous recirculation of these falsehood, that I have chosen to reluctuntly respond to some of the fallacies being repeatedly circulated in the media, to the effect that, I have been the masked face behind petitions, or write-ups that pose security risks. Sometimes silence is not golden, especially when it is about protecting ones integrity and countering falsehood.

I take particular exception to one of such unprofessionally scripted piece, entitled: "MOHAMMED DAUDA: UNMASKING THE FACE BEHIND FRIVOLOUS NIA PETITIONS", co-authored by one Ismaila Iliyasu and Ekenna Ellis Ezenekwe. Both characters in the said piece do appear to be hack writers. In the said write up, the authors claimed to have undertaken a painstakingly discreet investigation, and interviewed people who are knowledgeable and authoritative on the subject matter, even as they further claimed to have laid their hands on UNIMPEACHABLE documents.

As a professional; with a verifiable record of tremendous outing, and as a former boss at the NIA, I must confess that I was least impressed, with what I read, as being the accounts of what the writers claimed they discovered. As a matter of fact, that piece was the shabbiest piece of investigation I have ever seen: may be, next to the doctored findings of the so-called investigative panel that sat and recommended for my dismissal. If they are indeed NIA Staff and that is the kind of intelligence they give this country to use in policy planning and direction, then we are in serious problem.

It should be embarrassing to whoever wrote the script and gave them to adopt as their finding, that even records of events which are public knowledge, could not be accurately reflected, especially the claim that, I was appointed as Nigeria's Ambassador to Chad by President Muhammadu Buhari. Apparently trying to garnish their seeming ignorance, they wrote, "a crucial post in view of our two countries' close cooperation in the fight against insurgency, he gladly accepted the appointment, even though there were other, more worthy people that President Buhari could have appointed".

As far as I know, being the appointee in question, and as far as the records show, I was appointed Nigeria's Ambassador to Chad by former Pres. Goodluck Jonathan in May, 2014. Pres. Buhari could not have appointed me in May 2014, one year before he became the President of Nigeria. At the time of my appointment, I was the D1, Regions at the NIA headquarters: effectively the third in rank, after the then DG, Amb. EO Oladeji and Amb. Ayo Oke. Each time the two were out of town, I had been the one in charge of all operations at the NIA headquarters. There was no other person above me. I will be correct to therefore say, that, nothing could have been further from the truth, in trying to say there were others more worthy of being appointed.

I wish to place it on record that, I had protested the earlier appointment of a female Ambassador, who was lower than me in rank to a neighboring French speaking country before me. I was only pacified with the explanation that, the lady, who had failed her Deputy Directorship exams, once, at the time, was

appointed on the insistence of her lover, a former NSA, as a consolation prize, after he failed to get Presidential approval to appoint her as the DG, or even one of the two DDG's. I also did not understand their concept of worthiness, but it could not have been worse than that of someone who left the NIA as a relatively junior officer, under controversial and shady circumstances, having failed promotion examinations three times consecutively. The same exams that I passed at the first sitting. How this "more worthy" guy rebound, dubiously, through the back door, as Head of the Agency, is still inexplicable. May be this abracadabra, or 'government magic' according to late Fela will be unraveled someday.

The two so-called investigators also claimed to have found out that I emptied the vaults of the NIA, by moving \$44 million to another location, without due authorization and before proper audit of our accounts, immediately I was sacked. I recall that, in exhibiting their crass ignorance of the workings of the NIA and the circumstances

surrounding that action, a particular analyst, apparently also a hireling of the NIA leadership, had even tried comparing the movement of that money, to a situation in the Central Bank of Nigeria, where the Governor moves money out of the CBN after his or her sack.

As I earlier explained in one of my responses to the National Assembly's inquiries on the \$44million, I wish to restate that I moved the money to the office of the National Security Adviser, for three reasons, for safe keep, after Gen Jaafaru, who was sent purposely to NIA, to safe guard the controversial money(which was not actually part of our budgetary allocation), was suddenly withdrawn back to ONSA, and also to create a witness out of it, being the supervisory Office of all Security Agencies, under the law. I knew that to be a big risk, but given the circumstances I found myself in, where highly placed individuals: including those who eventually determined my fate, showed unreserved interest in siphoning the money: by asking me to make available parts of it for their personal uses, I felt a compelling urge to save public funds, by taking it away from the reach of these people (even if temporarily), who were to take charge of the agency following my exit.


It also seems that, the authors of that so-called investigative findings, were not conversant with the story of how the matter got to the National Assembly, and possibly through the National Assembly into the public domain. Let me state, that, I did not go to the National Assembly on my own volition, neither did I write a petition as they claimed, rather, I was invited(subpoenaed), by a committee of the House on National Security and Intelligence via an invitation letter Ref. No. NASS/HR/8/CT.80/IV/325, of 18th of January, 2018.

Signed by a member of the Committee, Hon. Usman Danjuma Shiddi, the invitation, under the heading "NEED TO INVESTIGATE THE ALLEGED CARTING AWAY OF \$44 MILLION FROM NATIONAL INTELLIGENCE AGENCY (NIA), I was directed to unfailingly appear before the committee, with all relevant documents relating to the issue, on 29th January, 2018 at 1pm.

Let me state for the avoidance of doubt, that, there had been serious pressures mounted on me not to appear before the committee, by people I had mentioned in my earlier report, before another investigative agency, about the \$44 million in question. I even received several threats, but I eventually honored the invitation and made my presentation on oath, before the committee, after which, i was asked to submit 17 copies of my presentation to the Committee. Whatever became of the report I made, was never known to me. It is therefore very unfair and most uncharitable to accuse me of leaking my presentation (which they called petition), to the media or to the public: whichever was the case.

Permit me to place it on record that, I did not write any petition to the National Assembly. I did not leak the contents of my presentation before the Committee to the press or the public, neither did I ever release documents or postings. As a matter of fact, I do not have access to any NIA documents, since my removal in 2018, and I could not have leaked what I did not have. I have been subjected to all sorts of media trials, ostensibly sponsored by the NIA leadership, through sponsored articles and reports: thereby subjecting me to further psychological tortures. The facts about what was happening in the NIA was deliberately shielded from the Government, making its decisions prejudiced against me, just as some public perception has been poisoned against me.

In seeming further display of their ignorance, or out of sheer mischief, the sponsored authors opined that, I acted for only one



month as Ag. Director General of the NIA. I was there for 54 eventful days from 7th November, 2017 to the date I effectively handed over. But even if I had acted for only one day, no one said, I was removed for incompetence, corruption or ineptitude, or that the person that they were in a hurry to bring, as my replacement, was better or more qualified than me. The records of what I did in the agency and their impact on the Agency and its Staffers is a story for another day.

Iliyasu et al also wrote that my appointment was not backed by any formal correspondence in the form of a letter from the Presidency. That is a fact. But just like all my predecessors, appointments of DGs have been seamless, for almost 36 years of the existence of the Agency, at that time. The most senior person automatically steps in. A letter of confirmation usually follow later. It is therefore not an anathema, that I was directed to assume leadership via electronic or verbal message, like others before me. I recalled the same situation with Amb. Uche Okeke, who later served for eight years as DG, I was one of those who conveyed a similar verbal message to him, while he was the Ambassador in Romania, to come down and take charge, following the retirement of his predecessor, Amb. Preware. In the almost 40 years of the existence of the NIA, it was the first time that "the goal post was shifted in the middle of a game". Just to accommodate an imposter, whose only qualifications is being the President's Brother.

No one brings a disgraced failure, through the back door to head the NIA. It is the first time that someone who was never a Director or an Ambassador, was brought out of forced retirement to lord it over bona fide Directors and Staff of the NIA. May be it is the same game plan that they were preparing for the FORMER RECHARGE CARD seller.

They accused me of shunning the disciplinary committee set up by the present DG to probe me. As an intelligence officer, who has vast contacts within and without the NIA, I was aware that the said disciplinary committee now legally declared illegal, by all the Courts, had a preconceived mission, which was to recommend for my dismissal and to rubbish my career. Looking at the assemblage of the distressed hatchet men coopted to be on the committee (including a convicted self confessed criminal, who stole and refunded more than N500m from Falcon Eye Project, at the ONSA), coupled with the fact that it negated laid down rules as contained in the NIA establishment Act(CAPS 278), 1986, I decided not to glorify their findings by giving it a semblance of legitimacy and fairness, by attending.

The coinage, Special Management Staff Disciplinary Committee(SMSDC), was not only strange to our procedures at the NIA, but a negation of the law, just as the assemblage of its members completely fell out of the provisions of the National Securities Act (CAPS 278), 1986: which governs such matters. The Act does not give any retired Directors any role in pure administrative schedules at the NIA, to wit recruitment, vetting or discipline, neither does the NSC Act, obliges the agency to continue footing bills for medical checkups, children's' school fees, family burials and many others, of officers long after their disengagement, as is presently being done, in addition to hundreds of thousands of Dollars, being shared to Traditional Rulers and family and friends all over the Country, all in the futile efforts of the DG to legitimize, what is illegitimate and Lauder his badly soiled corruption ridden image.

I will draw my conclusions on this matter by referring to the judgment of the Hon. Judge of the National Industrial Court,

### Healing Nigeria in The Spirit Of Adha

his was first published on July 26, 2021 after the Eid-el-Kabir of that year. I find it still relevant and important, with a little tinkering in dates to come now. Next week, Muslims the world over will celebrate the eid-uladha or the "big eid" or "big Sallah". We are, however, more interested in its meaning, implications and bearing on us as a nation. We need to look at spiritual milestones, hoping to find the seemingly elusive panacea for our ills.

Eid means feast, festival or celebration, while adha loosely means "sacrifice" (animal sacrifice), "offering" or "oblation". It so got its name because it commemorates Prophet Ibrahim's (AS) devotion to Allah (SWT) and his readiness to sacrifice Ismail, his son, for His love.

The Qur'anic story has it that Ibrahim (AS) experienced a dream in which God ordered him to sacrifice his beloved son, Ismail (AS). At first, he was skeptical, and believed it was the trickery of the cursed devil. After experiencing the dream the following night, he then understood that it was a message and a command from Allah (SWT). Without hesitation, he prepared his son for the sacrifice. Ibrahim (AS) loved his son dearly, yet this was no obstruction to honouring his duty as instructed by Allah (SWT) and thus proving his full submission to Allah (SWT).

Ibrahim (AS) took his son to the top of Mount Arafat, and in his hands, he had a knife and a rope. Upon arrival, he mentioned the dream to his son Ismail (AS) and made him aware that Allah (SWT) has decreed for him to be a sacrifice and, in obedience, his son Ismail (AS) accepted what God commanded of him. Ismail (AS) asked that his hands and legs be tied to avoid struggling during the sacrifice and that his father should blindfold himself to avoid witnessing his suffering. However, as Ibrahim (AS) began performing the sacrifice,

It is a sacrifice in selfimmolation that can only be compared to the myth of the Thornbird in the fictional book, Thorn Birds, a 1977 bestseller by Colleen McCullough. She set the story in Drogheda, a town that does not exist in Australia. In the front matter of the book, the myth is set out thus: There is a legend about a bird which sings just once in its life, more sweetly than any other creature on the face of the earth. From the moment it leaves the nest, it searches for a thorn tree and does not rest until it has found one. Then, singing among the savage branches, it impales itself upon the longest, sharpest spine. And, dying, it rises above its agony to out-carol the lark and the nightingale. One superlative song, existence the price. But the whole world

stills to listen and God in His heaven smiles. For the best is only brought at the cost of great pain... Or so says the legend. The spirit of eid-ul-adha teaches us to sacrifice ourselves for God. Ismail (AS) was part of Ibrahim (AS), do not forget. By sacrificing his son, he was sacrificing himself as well. Nigeria, now more than ever in its history, n e e d s countrymen who are ready to sacrifice for its existence. We should frown at a situation where leaders will call on us to change while they indulge in the perfidies associated with our leaders of

#### Will There Be Another CABAL?

OW that there is a new government, my bet is that Nigerians would be asking themselves the question of whether there would be a new cabal in power and its possible composition. This is because there is a passionate and widespread belief that for each regime, there is a powerful informal group outside the government that pulls the strings acting as puppet master. Such groups are usually known as cabals. The most famous cabal in Nigerian political narratives is the "Kaduna Mafia", which was said to have been the power behind the throne under military

The power and reach of the cabal are said to have been greatest under the Buhari administration. I still remember my amazement on 24th June 2019 when hundreds of demonstrators stormed the Defence House, an annex of the Presidential Villa, calling on President Muhammadu Buhari to: "take full control of government from the hands of those they described as <cabal> as his second term in office begins" (Daily Trust, 25 June 2019). The protesters under the aegis of Concerned APC National Stakeholders (CANS), carried placards with inscriptions such as 'Abba Kyari Must Go', 'PMB Must Take Charge of the Government', 'We Need Fresh Ideas Not Recycling Men and Women Who Have Spent Over 40 Years in Government', among others.

The convener of the protest was one Dr Symeon Chilagorom who explained their action as follows: "Our demand is a simple one; the people of this country elected Muhammadu Buhari as their President, not Mamman Daura, not Ismaila Funtua, and definitely not Abba Kyari. Only President Buhari has our mandate to govern over the affairs of this nation. In light of that, we are simply asking that

President Buhari should take back control of his government and begin to walk his talk by delivering on the promises made during his campaign" (Daily Trust, 25 June 2019).

It is about leading corporations and those who control them, key members of the political elite, the militaryindustrial complex. i.e. the main stakeholders in American capitalism who plan, plot and strategise to protect the system. I doubt that is what we are talking about in the Nigerian context."

Their key argument was that they want the President on "the driver's seat not passenger's seat" so the cabal should allow him govern. It would be great if Dr Symeon Chilagorom could tell us now whether they succeeded in getting President Buhari rather than the cabal to run his second term government.

The narratives on cabals are deeply rooted in Nigeria's political economy. The country runs a rentier state that relies on substantial external rent derived from petroleum exports. The creation of wealth is carried out by a small workforce that produces and sells the petroleum while an even smaller group takes decisions on who makes money out of the extraction of rent. Essentially, the government has been the main recipient of external rent and both politics and economics operate on the basis of who gets access to the rent. The country's political economy therefore created the structural basis for shadowy players to emerge and play significant roles.

As is well known, the rentier state is oriented away from the conventional role of providing public goods that have been extracted from the people through taxation, it is a provider of private favours through the allocation of rent derived from petroleum. Petroleum exports which accounted for only 10% of export earnings in 1962 rose to account for between 80 and 90% of total export earnings over the past few decades.

One of the questions that is posed about Nigerian politics is whether twenty-four years of democratic rule has started producing a new class of political and economic power players without connection to military rule. Why are critical political moments in Nigeria always marked by top politicians dashing off to Minna and Abeokuta for consultations with the generals. Have former state governors for example been able to transform themselves into strong and autonomous players in their domains?

Alternatively, has the practice of almost complete wiping out of legislators at each general election made it difficult to grow and sustain the power of godfathers and cabals? How does the growing economic power of Nigerians entrants into the Forbes list of the wealthiest people in the world translated into political power? Finally, are

the networks ethno-regional or national?



The Nigerian rentier State model has also collapsed with the severe limitations that have emerged over extracting and selling petroleum. There is very little rent to distribute and mounting debts could easily lead to bankruptcy. This is a critical time and any government focused on sharing would discover that criminals inside and outside government are pocketing the rent. Combatting corruption and building state capacity should be the focus of governance.

## African peacemakers: Rescuing Europeans From Mutual Slaughter

SEVEN African leaders stunned the world on June 16 and 17, 2023 when they went on a peace mission to warring Ukraine and Russia.

The reaction from many in the West was that of contempt; how is it the place of lowly Africa to intervene in a war of Europeans? "When Ukrainian President Volodymyr Zelensky on Friday told the African leaders that he is not interested in peace and is confident of resolving issues militarily, is anyone fooled that his faith is in the decimated Ukrainian armed forces? Is anybody in doubt that the war in Ukraine is an international one with the military from various countries, including America, Asia and Europe, engaged? Are we to pretend that since those armies are not fighting under their countries' flags, then they are not on the battle field?"

In fact, Poland tried to scuttle the mission by detaining for 30 hours the aircraft carrying the protection unit of President Cyril Ramaphosa, leader of the delegation. Its claim was that the security men carried "dangerous goods" (weapons). Did they expect them to carry candies? The protocol all over the world is for the paper work for the weapons to be submitted; but Poland declined.

Eventually, the aircraft which also had a dozen journalists on board, could not join Ramaphosa as Hungary barred it from using its airspace. These are clear indications that some European countries do not want peace.

The United States had also tried to scuttle the peace process by its Congress insisting that sanctions be imposed on South Africa for being a member of the Brazil, Russia, India, China and South Africa (BRICS) economic initiative and promising to allow President Vladimir Putin, on whom it had imposed unilateral sanctions, to attend the BRICS meeting in South Africa without any consequences.

The reaction of some in Africa was one of self-denigration: how can African leaders think of making peace among Europeans, especially when the Pope, the United Nations and China had

failed? Some, in trying to portray the African leaders as jobless busybodies, asked: what is Africa's business? I will tell you what our business is by retelling a true story.

The European countries in search of territories, and to exploit the world's human and natural resources, went on a voyage to colonise the rest of the world.

"Those who argue that Africa has no business initiating peace in Ukraine are like occupants of a multiple storey building who claim that it is not their business if an occupant on the ground floor decides to blow up his flat." As is often the case with the greedy tortoise, they came close to blows, and in 1884, met in Berlin to agree on how they would steal the resources of other peoples without fighting themselves. But greed has no limit, so on July 28, 1914, they commenced an All-European War. Since there were no persons to mediate, the Europeans were left on their own and at the end, 16 million human beings were killed in what they beatified as the First World War.

Despite the Europeans proclaiming that the First World War was a "War to end all wars", they were back at another endless slaughter from September 1939. This time, some 85 million human beings were killed. They christened this slaughter, the Second World War. In each of these wars, genocide was a side menu. In the first, Armenians were the main victims, while in the second it was six million Jews. In all these, innocent Africans, Asians and Latin Americans were killed as they were forced to fight for both sides.

So today, with the same countries engaged in another slaughter, is it logical for anybody to ask what the concern of Africa is?

If the senseless war in Ukraine were not brought to a quick and peaceful end as the African leaders are trying to do, is anybody in doubt that all humanity would be affected and that part of the war would also be fought on African soil as it happened in the Second World



War?

Did those querying the business of Africa in pushing for peace listen to Putin when the African peace ambassadors asked him if the Russian nuclear weapons recently deployed to Belarus would be used? He had retorted that in case of a "threat to the Russian statehood", they would be used. He emphasised: "In that case, we will certainly use all the means that the Russian state has. There should be no doubt about that." So, is Africa to do nothing

in the face of a possible Third World War in which nuclear weapons will be used or do people think all these is a joke?

He noted that religious leaders have a role to play in nation building, urging them to rise to the occasion and use their Godgiven platforms to provide care, preach social cohesion and contribute to peaceful coexistence in the country.

The Country Director spoke at the Catholic Resource Centre, Durumi Abuja, during a one-day conference on "Trauma Care, Social Cohesion and the Role of Religious Leaders as Agents of Nation Building", in commemoration of the 10th priestly anniversary of Fr Stephen Ojapah MSP, the Nigerian KAICIID Fellows collaborated with Global Peace Foundation Nigeria, Cardinal Onaiyekan Foundation for Peace, the Interfaith Mediation Centre and O-Trauma Victims Initiative.

He felicitated with the priest and identified with all victims of the numerous traumatic experiences in the country, particularly in the hands of bandits, kidnappers and terrorists.

Hayab lamented that people have lost touch of their common humanity and that it is only by

embracing their common humanity that true and lasting peace can be found, stressing that it was the reason why Global Peace Foundation Nigeria started preaching that human beings are members of one family under God, irrespective of any differences. Rev. Hayab stressed the need for

interfaith to collaborate in the quest for social cohesion and nation building, calling on religious leaders to collectively confront and address the challenges being faced by the society by providing shelter for the traumatized people to lean

Hayab added, "Trauma and other security challenges faced by people in our societies are human experiences not religion, it requires religious collaborations to tackle them. It is unfortunate that religion, ethnicity and other lines of divide have encroached into our humanity with detrimental effects, faithful of all religions should collaborate to ensure sanity in the society."

He called on religious leaders and CSOs to continue in their efforts of collaboration and building a network of peace builders in order to salvage the nation and urged that peacebuilding engagements should go beyond town hall meetings to the grassroots and local communities to promote love, peace, tolerant, respect and civic responsibilities among rural dwellers.

In his remarks, Bishop Matthew Hasssan Kukah noted that virtually all Nigerians are traumatized considering that they live in a traumatized environment, saying that Nigerians are challenged with mental health at various stages and the need for a support system from both the government, CSOs and anyone who can provide it.

According to him,, "the sense of community has been suspended; fundamental issues like trust have become scarce commodities largely because of what the society has become."

He called for the aggregate of interest of values for the state to resolve all contradictions, stressing that banditry is one of the most terrible things that has happened to the nation with priests being targeted by kidnappers in the country as the church is in solidarity with the nation in its battle with insurgency. He called on all victims to retain their state of sanity and put bitterness behind them.

Fr. Stephen Ojapah, a member of the Interfaith Dialogue Forum for Peace (IDFP) and a fellow with the King Abdulla bin Abdul-Aziz Centre for Cultural and Inter-religious Dialogue (KAICIID), thanked people for attending his 10th priestly anniversary and the unfortunate incident of his kidnap and the terrible experience of about 30 days with the dreaded bandits.

In any case I have no reason, at all, to fight my Country Nigeria or it's people, just because I disagreed with what I see as a gross injustice, by the former administration. Governments come and go, but the Country remains.

The circumstances that trailed my appointment, and the stormy relationship I had with some very powerful people in Government, over my refusal to avail public funds for their personal uses and my eventual removal and replacement with funds, gave me the impression, that, my remaining as the DG of NIA was a threat to some selfish quests. I was so easily removed for no reason at all, because I had no godfather, working in a Government which is averse to being incorruptible, as I wanted to be. But I leave judgment for posterity.

I know as a matter of fact that all the falsehood being bandied about me shall definitely crash, in the fullness of time. In the meantime, my candid advice to the management of the NIA and indeed the sponsors of the callous campaign of calumny against my person, to employ professionalism in handling all matters, and not rely on the mischievous opinions of hirelings, in the desperate attempt to change the flowing narrative about the saga, arising from my purported dismissal.

I will respond to other matters subsequently; now that I have decided to finally open up, if only to correct the erroneous impressions being created about the matter. Truth has only one color but falsehood has to be garnished in so many forms in addressing issues bordering on injustices and attendant deficiencies in the NIA, as it is.

I remain a patriotic, loyal and dedicated Nigerian, always willing to salvage my country from the corruption that is eating deep into our national fabric.

### 3 Feared Dead From Delta Police, Robbers Gun Duel

\*Firearms, cartridges recovered

hree suspected armed robbers have met their waterloo in a shoot out with police operatives in Delta State, New Nigerian Newspapers has learnt.

Two firearms which include one pump action gun, a cut to size locally made gun and eight live cartridges were reportedly recovered from them.

Our correspondent gathered that the deceased were neutralised by operatives attached to "B" Division Warri by the DPO SP Bolarinwa Alabi, on 22nd June 2023 at about 10. 20am during the gun duel.

The suspected hoodlums were said to be operating in an unregistered black Toyota corolla car along Ugborikoko/Giwa-Amu airport road Warri before they were engaged in the shoot out by the operatives. The Delta State Police Command Spokesperson DSP Bright Edafe in a release on Friday, said the suspects sustained fatal degree of injuries and gave up the ghost while being taken to the hospital.

":On 22/6/2023, at about 1020hours, operatives attached to 'B' division Warri led by the DPO SP Bolarinwa Alabi, acting on a distress call about an armed robbery operation along Ugborikoko/Giwa-Amu airport road Warri, that armed hoodlums were operating in an unregistered black Toyota corolla car, the team raced to the scene where the hoodlums on sighting the advancing police team fired gun shots at the Policemen and the team retaliated, engaged them in a serious gun duel during which three of the hoodlums were fatally wounded while other members of the gang escaped with bullet injuries. "The injured suspects gave up the ghost while they were being taken to the hospital. Exhibit recovered includes one cut-to-size locally fabricated gun, two live cartridges, an unregistered black Toyota corolla car, and eight different vehicle keys. Manhunt for the other fleeing suspects is ongoing", Edafe said.

In a related development, Edafe said one pump action gun and six live cartridges were recovered in a bag a bag abandoned by a suspected hoodlum on sighting police operatives. According to him, the operatives of Response Squad (RRS) were on visibility/confidence building patrol along Asaba-Benin Express Road by Issele Asagba, when they sighted the man with a sack bag pretending to be waiting for a vehicle.

He said, "On 22/6/2023, at a bout 1030hours, operatives of Rapid Response Squad (RRS) while on visibility/confidence building patrol along Asaba-Benin Express Road by Issele Asagba, sighted a suspicious looking young man with a sack bag pretending to be waiting for a vehicle.

"As soon as the operatives highlighted from their vehicle, the suspect took to his heels abandoning the sack bag, he was chased but he escaped. Upon searching the abandoned bag, one pump action gun and six live cartridges were recovered. Effort is on to arrest the fleeing suspect.
