Project Director Roselyn Ode stated on Monday in Zaria, that the training programme is in partnership with the Kaduna State Government and aimed at improving the

effectiveness of the exercise among the girls. Ode explained that the project is to present some of the girls that they have trained in batches for the past year to showcase the impact of the work the

organization has done. She said the organization is open to partnership with any agency to replicate the same to reach and impact more on the critical mass adolescent married girls in the country.

She noted that their training was able to inculcate the spirit of "I can do" to learn and initiate business skills with their clients to enable them to succeed.

The Project Director explained that the

empowerment component code-named A360 program provides a holistic system where adolescent married girls access skills of their choice.

"Out of the 2,011 adolescent married girls that we have trained, over one thousand have already established their businesses while 200 have upskilled and expanded their businesses.

"The adolescent married girls were trained in the areas of; Poultry farming, Skin Bags, fishponds, Soap making, scents, Blankets, and Cakes among others.

"The long-term impact was for married Adolescent Girls to have improved agency and financial resources to lead the lives they desire and the ability to make and act on decisions that involve the control over and allocation of financial resources, financial independence, and owning a sustainable business of their own," Ode said.

"The Adolescent married girls were also Supported to improve their livelihoods and economic outcomes, going beyond access to contraception to support girls' empowerment holistically towards sustained human capital development," Ode said.

Dr. A'ishatu Sadiq, Director of Health Kaduna State, said, "We were a little bit worried at the beginning because of the cultural limitations and the plurality of the environment."

She said the response from the community leaders and traditional Institutions was s u p p o r t i v e a n d encouraging.

Princess Adenike Akindele, who was on a courtesy visit to the Emir of Zaria and a special guest at the event respectively commended SFH for the training.

She said her NGO is also gathering information to offer support to the less privileged because Government alone cannot be able to it alone," Princess said.

### Stakeholders Applaud Tinubu, Demand Disbanding Of Federal Universities Councils

takeholders and experts in the education sector have applauded President Bola Tinubu's approval for the immediate dissolution of all boards, and Councils of all Federal Government's parastatals and Corporation.

While they said the action was a timely positive decision, they also insisted that all Governing Councils of Federal Universities across the country must be included. Some of the experts noted that the universities councils should not be considered in the exception clause, derived from the Third Schedule. Part 1, Section 153 (i) of the 1999 Constitution of the Federal Republic of Nigeria as amended.

Although in the past there may have been pressure from other groups to exclude university councils which must be vacated.

Dr. Abednego Silverstone, an educational researcher, argued that a relevant provision in the Act establishing the Councils, also supports the idea of sacking them, in an event they are " found to be incompetent and corrupt ".

Silverstone urged the President to remain resolute and intentional in addressing the obvious challenges affecting university system and standard of education in Nigeria.

Investigations show that due to political patronage, m a n y unqualified persons were appointed into

the governing Council of most of the Federal

It was also revealed that many of the Councils members were going outside their mandate, and were interfering with dayto-day running of Universities, thereby hampering progress with inordinate conflicting interests.

An insider source, who pleaded anonymity, called on the President to sack the Councils and reconstitute them, appointing only those with proven track record and can add value to the



The source disclosed that Governing Councils of most of the members in Councils, have not made any significant contributions towards the growth of education, simply because they are hugely bereft of relevant knowledge.

The source added, that if the President is interested in proffering lasting solutions to the problems of education in Nigeria, he should beam his searchlight on the governing council, as most have become springboard for corruption.

" Many of the people appointed into the

most Universities, do not many Universities have requisite knowledge and technical expertise to contribute meaningfully to the development of the systems.

" Great majority of them, were political errand boys, who were simply emplaced in the positions as reward from their political benefactors.

" The President should start sanitising the education sector from the councils. He should appoint only technocrats with high pedigree and people that have cognate experience and can help the system to grow, "

o fewer than two persons have been killed, while one was abducted in Ivo Local Government Area of Ebonyi State.

It was gathered men suspected to be Fulani herders yesterday, also killed Ohanaeze Ndigbo youth leader's father during the attack at Ishiagu Community in Ivo Local Government Area of Ebonyi State.

While narrating his ordeal,the National Youth leader of Ohanaeze Ndigbo, Mazi Damian Okafor stated that the Suspected Herdsmen Lunched the attack on Sunday which claimed two lives including his father.

"Suspected herdsmen

attacked Ishiagu community again, killed my father, one other person and abducted one", he said.

Reacting to the incident, the Police Public Relations Officer (PPRO) in the state, SP Onome Onovwakpoyeya who confirmed the incident, explained that it was carried out by suspected Fulani herdsmen, from where two lives were lost, while others sustained injuries.

`Two persons were reportedly killed by suspected Fulani herdsmen.

One was shot in the head through his windscreen and the other murdered in his farm with his throat cut," PPRO said.

### **NSCDC Boss Removes Rivers**

he Commandant General of the Nigeria Security and Civil Defence Corps (NSCDC) Dr. Ahmed Abubakar Audi has ordered the immediate removal of the Rivers State Commandant of the Corps, Micheal Ogar, over a face off between the Command and members of the Nigeria Union of Petroleum and Natural Gas Workers (NUPENG).

Similarly, he directed him to hand over the affairs of the Command to his Deputy, pending the deployment of a substantive State Commandant.

Consequently, Audi has constituted a high-powered investigation panel to look into the circumstances leading to the clash between the two bodies.

It would be recalled that members of the Rivers State chapter of NUPENG had last wednesday blocked the entrance of Rivers State Command of the NSCDC, located at Olu Obasanjo way, GRA, Port Harcourt.

The Director public relations department of the Corps CC Olusola Odumosu who made the disclosure in a statement on Sunday, said the NSCDC Commandant General expressed shock at the action taken by NUPENG which painted a surprising scenario and an unwarranted contradiction

to the ideals of the Corps. It reads, " A high-powered investigation panel has been constituted by the Commandant General (CG), of the Nigeria Security and Civil Defence Corps (NSCDC), Dr Ahmed Abubakar Audi, mni, OFR, to look into the circumstances leading to the blockage of the entrance of Rivers State Command of the NSCDC, located at Olu Obasanjo way, GRA, Port Harcourt, Rivers State, by the Nigeria Union of Petroleum and Natural Gas Workers (NUPENG) on Wednesday.

" The committee headed by the DCG in charge of Operations, Dauda Mungadi, is to objectively investigate the role played by the State Commandant and members of the command Anti-vandal team in the crisis.

" In the same vein, the CG ordered the removal of the Rivers State Commandant,

Micheal Ogar, and directed him to hand over the affairs of the Command to his Deputy, pending the deployment of a substantive State Commandant.

"He expressed shock at the action taken by NUPENG which painted a surprising scenario and an unwarranted contradiction to the ideals of the Corps.

" Dr Audi noted that, humility and integrity in service delivery is the watchword of the Corps, as such, any breach of trust or suspected compromise by any personnel will not be treated with kids gloves.

"I have constituted a high powered committee to carry out full scale investigation into the incident in Port Harcourt.

"Nigerians are fully aware that we are the lead agency in protection of critical government assets and infrastructure.

"Therefore, under my watch, no act of indiscipline, compromise or sabotage would be condoned from anyone within and outside the Corps.

"I have given the committee a marching order to ascertain the role played by either of the parties and anyone found guilty would be severely dealt with in accordance with the provisions of the law.

" Recall that the CG recently summoned Niger Delta State Commandants to Abuja, to charge them on the need to rejig their anti vandal units in line with Mr President's order to stop oil theft and other criminal activities within the sector.

" He expressed confidence in the ability of of the committee to carry out unbiased investigation and appealed to members of the public and all interested stakeholders to await the  $o\,u\,t\,c\,o\,m\,e\quad o\,f\quad t\,h\,e$ investigation and proposed recommendations.

" The CG assured that NSCDC will continue to sanitise the oil sector by waging war against oil thieves and illegal oil bunkerers sabotaging the nation's economy.

":He urged all critical stakeholders to continue supporting the Corps in its renewed fight against oil theft by giving credible information that may lead to the arrest of all nefarious individuals involved in sharp practices within the oil industry".



### Southern Kaduna Leaders Renew Calls For Gurara State

#### \*Allege el-Rufai encouraged genocide, impoverishment of area

hile decrying the alleged roles played by the immediate past Governor, Malam Nasir el-Rufai in subjugating its people, the Southern Kaduna Leadership Council (SKLC) has demanded that a recommendation of the 2014 National Constitutional Conference which agreed that Gurara State should be carved out, be implemented.

SKLC made the appeal in a statement signed by its chairman, Mr Ishaya Dary Akau, made available to our correspondent on Monday June 19, 2023.

"We hereby wish to let the nation and international community know of the heinous plans and to draw the attention of the President of the Federal Republic of Nigeria to the 2014 National Constitutional Conference where it was agreed to create Gurara State from the present Kaduna State and to invite the President to activate the demand which has gone through the constitutional process of obtaining the consent of two thirds of the 36 Houses of Assembly in the Federation.

"The nation and international community should know that the Southern Kaduna region was recorded to have above 3,000,000 people by 2006, and present projections show that there are now above six million people in the area," the group

They explained that the total land size of Southern Kaduna is above 26,000 square kilometres.

"Southern Kaduna is larger in population than 21 states and larger in land size than 26 states in Nigeria. There are 58 ethnic groups in Southern Kaduna, with similar culture, traditions and beliefs.

"The Southern Kaduna people are requesting for protection from the Government of Kaduna State, the Federal Government of Nigeria, the African Union and the United Nations. We call on the international community, to constitute a visitation panel to a scertain the genocide orchestrated and supervised under the Islamist regime run by Nasir el Rufai as Governor of Kaduna State between 2015 and 2023," they said.

According to them, propaganda by certain disgruntled elements in their midst has had the tacit support of government.

"The Southern Kaduna Leadership Council, and indeed the people of Southern Kaduna will not use the statements of Nasir eil Rufai to determine how we live and relate with Muslims, settlers or visitors to Southern Kaduna.

"We are a peaceful people and will follow peaceful and lawful means in pursuit of our goal of surviving as a people under the regime of hostility and hate instituted and handed down as a legacy by Nasir el-Rufai in Kaduna State. However we will not fail to tell our people to defend their lives, lands and heritage.

"The Southern Kaduna Leadership Council, desirous of developing harmonious and peaceful relations with all the citizens and people of Kaduna State, call on the present government not to follow the path of their predecessor," the statement said.

According to the statement titled, "Nasir el-Rufai's Viral Video and His Eight Years of Misrule in Kaduna State" the Southern Kaduna Leadership Council (SKLC) said that it held its regular meeting on the 17th June, 2023, and considered several important matters, including the speech by Mal. Nasir el-Rufai, the immediate past governor of Kaduna State, delivered to some religious clerics.

"The SKLC noted that the video of Nasir el-Rufai's speech has gone viral and has made public certain issues that have hitherto remained in the domain of conjecture and hypothesis among Nigerians generally, but which we the victims of el-Rufai's actions have lived and experienced over a period of eight years.

"That Nasir Ahmad el-Rufai set out deliberately to misinform the Nigerian Public and the world, and waged false propaganda amongst certain religious circles, to the effect that the people of Southern Kaduna who are mainly Christians did not vote for the APC.

"The voting figures cast in Federal, State and Local Government elections in Kaduna State between 2015 and 2023 bear testimony to the fact that Nasir el-Rufai deliberately deceived those in the APC who are not Muslims of his actions.

"The system of governance by exclusion practiced by el-Rufai was deliberate against the people of Southern Kaduna.

"That el-Rufai picked a Muslim deputy from Southern Kaduna to spite the Christian majority for not supporting the APC. The most insidious aspect of this elRufai Islamist agenda was his claim that he extended such a Muslim-Muslim system to the presidential election in order to extend the scope of "Islamic subjugation" across the length and breadth of Nigeria within twenty years," they said.

SKLC said that from the above and many more revelations by el-Rufai in his now viral video, they and the people of Southern Kaduna as a whole conclude as follows:

"The impoverishment of our people arising from the total neglect of the area in 8 years, and the deliberate destruction of farmlands, crops, plantations and forests, harvests and food stocks, in an orgy of terrorist violence were deliberate actions in pursuit of subordination of the people of Southern Kaduna to el-Rufai's implementation of jihadism in Kaduna State.

"That the incessant killings and maiming of our children, women and youth, and the burning of our homes and destruction of our villages and communities from 2015 to 2023 was part of a strategy for "Islamic dominance" by the government of Nasir Ahmad el-Rufai in Kaduna State.

"That the assassinations, murders, kidnappings, arrests and imprisonment, and removal of indigenous Southern Kaduna traditional rulers, and the balkanization of our chiefdoms to create emirates out of districts under our traditional leaders, was part of an undeclared jihadist campaign being surreptitiously waged by Nasir el-Rufai as Governor of Kaduna State.

"The removal of our traditional leaders and imposing foreign ones on the people of Southern Kaduna has been calculated to change the structure of traditional leadership in the region, and create conditions facilitate creation of new settlements of foreigners and change the demography of the area for el-Rufai's "Islamic Dominance".

"That while the people of Southern Kaduna paid taxes to government, as Governor of Kaduna State Nasir Ahmad el-Rufai made sure our people were not entitled to the benefits derivable therefrom, in the regime of crass discrimination and marginalization institutionalized under his administration.

"False statistics have been churned out to show "settlements" of foreigners as "indigenes" of Southern Kaduna. Consultants from "Islamic States" were recruited to carry out "Settlement Surveys" in Southern Kaduna, which "showed" that there were "more" Fulani settlements in Southern Kaduna than the existing settlements of the indigenous communities.

"To justify these false statistics Fulani terrorist gangs began attacking, destroying and removing the existing settlements. Without our consent, our lands were given to the foreigners with the intention of growing their population in 20 years to outstrip that of the indigenous people.

"Just before the now postponed 2023 National Population and Housing Census, thousands of Fulani herders were taken into Southern Kaduna, where they went into the forests and plantations grown by our communities, and began hanging clothes and bags of belongings on the trees, which would then be counted as "Houses" belonging to Fulanis during the planned census."

#### NDLEA Apprehends 2 Qatar Based Drug Kingpins, Destroys 30.9 Hectares Of Hemp Farms In Delta, Edo and Ondo

wo Qatar based Nigerian drug kingpins have been nabbed by operatives of the National Drug Law Enforcement Agency (NDLEA) over alleged involvement in drug trafficking.

This occurred just as the agency said it destroyed 30.9 hectares of canabis (Indian Hemp) farms in Ondo, Delta and Edo states within the .past week.

The arrest of the duo drug kingpins, identified as Eyah Celestine Nnamdi alias Murphy) and Ugwuoke Peter Oluchukwu followed the interception of their methamphetamine consignment at the Murtala Muhammed International Airport (MMIA), Ikeja, Lagos.

The Director of Media and Advocacy of NDLEA, Femi Babafemi in a statement yesterday, disclosed that Ugwuoke was apprehended on June 9 during the outward clearance of Qatar Airways passengers at the departure point, Terminal 2 of the Lagos Airport.

According to the statement, the Narcotics officers discovered that the suspect was travelling to Doha with an Ivorian international passport with the name Hien Narcisse.

" A further scrutiny of his black carry-on luggage led to the discovery of a false bottom concealment of two parcels of crystalline substance that tested positive to meth weighing 1.00kg.

": Preliminary investigation revealed that the suspect is a Nigerian who had gone to obtain an Ivorian passport for his travels.

" He confessed that he travelled to Qatar in August 2022 and returned from the Arab nation about two months ago to perfect arrangement for the movement of the drug consignment.

";A further probe led

operatives to discover that his Qatar-based senior partner in the trade simply identified as Murphy was lurking around in Eziani, his home town in Nsukka LGA, Enugu state.

"A prompt deployment of NDLEA operatives on June 10 to Eziani community led to the arrest of 'Murphy' whose true identity was later discovered to be Eyah Celestine Nnamdi, who had lived in Indonesia for some years before relocating to Doha, Qatar", Babafemi stated.

Meanwhile, a total of 30.9 hectares of cannabis farms were destroyed in Delta, Edo and Ondo in the past week.

In Delta, 18 hectares of cannabis farms were destroyed on Monday, June 12 in Umuchime village, Ogume, Ndokwa West LGA by NDLEA operatives supported by soldiers.

Four suspects arrested on the farms include two men and two women: Kingsley Atuola, 40; Okikiolu Adekunle, 44; Osai Doris, 40, and Ublenu Joy, 28.

In Edo State, operatives on Wednesday, June 14, stormed Awakpa forest in Owan West LGA where they arrested Malachy Amaechi; Nanmua Peter; Ojo Momoh; Afam Luke and John Danladi who were apprehended inside a hut located on 2.5 hectares of cannabis farm, which was destroyed and 102 kilograms of the substance a 1 r e a d y h a r v e s t e d recovered.

Another farm measuring 1.294870 hectares was also destroyed with the three farms razed totalling 3.978217 hectares.

Okwu said though he agreed with Agbakoba on the other decisions taken by the Tinubu presidency, there was no need for Yakubu's sack at this material time.

He was of the view that "despite the shortcomings

we witnessed during the 2023 general elections, it was one of the best elections ever conducted in Nigeria history.

"In the same election conducted by Yakubu, we had sitting governors lose elections across the country; we had popular National Assembly members lose election. This did not happen before in the country's election.

"We are not making excuses for the lapses during the elections, but it is wrong to totally disparage the efforts of the commission.

"There is no perfect election in any part of the world, even the United States, which prides itself as the capital of world democracy."

Okwu further advised that any attempt to remove Yakubu at this time was ill-timed, stressing that "aggrieved candidates are before the election tribunals ventilating their anger; how then can we remove the INEC chairman on whose table the bulk stops?

"Yakubu should be allowed to remain as the INEC helmsman at least pending the conclusion of the cases."

He further advised that efforts should be made to improve on the gains made during the 2023 general elections.

The Director General of the Agency, Prof Fatima Waziri-Azi gave the hint at a stakeholders meeting in Benin.

The Benin Zonal Commander Mr. Nduka Nwanwene, alluded to the assertion at a 3-day Training and Capacity Development Orientation on Standard Reporting Template for members of the TIP Media Corps and Officers of Press and Public Relations Unit held at GolfView Hotel, GRA, Ikeja, Lagos, supported by FIIAPP/ A-TIPSOM, funded by European Union.

He added that NAPTIP has rescued and sheltered no fewer than 17,753 human trafficking victims compromising

females, 4. 727 males and 8,935 children as at May 2022.

In Mali, he disclosed that no fewer than 2 0 , 0 0 0 Nigerian women and girls are trapped, living in shanties, in mining areas, where they are s e x u a 1 1 y exploited.

He further disclosed that many victims of human trafficking who returned to Nigeria from Libya have had their kidneys or other vital o r g a n s harvested in the

countries to which they were trafficked without their knowledge.

The Zonal Commander explained that the victims were usually served drinks laced with drugs before organ harvesters take advantage of them, adding that most of the victims only knew when they were assisted back

to the country by International Organisation for Migration.

He added that many Nigerians had lost their lives through organ harvesting by the cartels who deals in the clandestine business.

According to him, Nigerians and other nationals in Oman, Saudi Arabia, Qatar, Libya, Lebanon and Malaysia's food and drinks are always sedated and their organs such as Kidney, Pancreas are harvested, while corpse of those whose hearts, liver and bile are harvested are thrown into the desert for wild animals to feast on them.

A source who confirmed the killings to New Nigerian said, "So far, we have confirmed that eight persons were killed during the attack last night in Rawuru community in Barkin LGA. What we don't understand is that before the attack took place, some soldiers came to the village in the afternoon. We also saw them in the night."

He explained that the villagers were attacked leading to the killing of the victims who were in their homes, wandering how the assailants carry out the attacks successfully

w i thout being apprehended by the soldiers and the security agents who are also within the community.

He described the attacks as one too many called for an investigation into the activities of the personnel of the Military Taskforce deployed to maintain peace in Plateau communities.

He lamented that a total of 276 persons had been killed in different communities in the past month following the persistent attacks with over 30,000 persons now being displaced.

According to him, they have the mass grave sites where deceased bodies were buried for those that care to go round and see for themselves, saying that thirty thousand (30,000) IDPs were scattered in Mangu, Panyam, Mangu Halle, Yilpo (Sabon Gari)

Fan in Barkin Ladi, Maikatako in Bokkos, Marish in Bokkos, Bukuru in Jos-South and a lot in Jos North local government areas of the state.

He said children at Primary, Secondary Schools and some students of tertiary institutions in the affected Local Governments have missed their examinations in the Junior NECO Exams set for JSS 3, the ongoing Senior Secondary School Examination and the Tertiary examinations due to forceful migration of their people to various places as IDPs president stated.

He expressed delight that their Plateau ethnic brothers that have been supportive of their people and regretted the silent position of SEMA and NEMA which before now were known for their quick response in time like this, stressing that until now, they have not felt their presence.

He called on SEMA to work in accordance with their constitutional responsibilities and attend to the 30,000 IDPs scattered across the state.

Publicity Secretary of the All Progressives Congress (APC) Comrade Timi Frank yesterday, pleaded with President Bola Ahmed Tinubu not to allow former and serving top officials appointed by ex-President Muhammadu Buhari alleged to have abused their offices to escape justice.

Frank who made the call in a statement in Abuja, listed those that deserve to be guests of the Department of State Services (DSS) and the Economic and Financial Crimes Commission (EFCC) to include former Minister of State for Petroleum Resources, Timipre Sylva, former Minister of Aviation, Senator Hadi Sirika, former Attorney- General for the Federation and Minister of Justice, Abubakar Malami and Group Chief Executive Officer (GCEO) of Nigerian National Petroleum Company Limited (NNPCL), Mele Kyari.

Others are former Minister of Humanitarian Affairs, Disaster management and Social Development, Sadiya Umar Farouq, former Managing Director of the Nigerian Ports Authority (NPA), Ms. Hadiza Bala Usman (now appointed Special Adviser to President Tinubu on Policy Coordination), former Comptroller general of the Nigeria Customs Service, Col. Hammid Ali, Director General and Chief Executive Officer of the Nigerian Maritime Administration and Safety Agency (NIMASA), Bashir Jamo, former Managing Directors and Sole Administrators of Niger Delta Development Commission (NDDC) as well as former and immediate past Service Chiefs appointed by Buhari.

Frank, who is the United Liberation Movement for West Papua (ULMWP), Ambassador to East Africa and the Middle East, said: "Nigerians know how agencies managed or still being managed by these former and present government officials were run in the most opaque and corrupt manner. The President has no choice but to demand accountability on behalf of the people.

"The suspension and arrest of the Governor of Central bank of Nigeria (CBN), Godwin Emefiele and Chairman of the Economic and Financial Crimes Commission (EFCC), AbdulRasheed Bawa have been hailed by Nigerians but this is just a tip of the iceberg; the President must not let his anticorruption drive stop with these

two individuals.

"Those that must be investigated and prosecuted are still running free out there and the earlier they are rounded up and made to face the law for economic sabotage, the better for this country. Besides, some of them have already found their way into the present administration like Ms. Hadiza Bala-Usman.

"There is further intelligence that others like her are currently lobbying cabal around Tinubu to get a soft landing or better still find their way into the administration by way of appointment."

Frank, who is the United Liberation Movement for West Papua (ULMWP), Ambassador to East Africa and the Middle East, insisted that failure to arrest and prosecute these suspects known to have used their offices for selfish gain would show that the President Bola Ahmed Tinubu's administration is only out to witch-hunt Emefiele and Bawa now under DSS custody.

He insisted that that ex-officials like Sylva need to answer questions on alleged identity theft, sale of oil blocks, marginal oil fields and refineries. Siriki needs to tell Nigerians the whereabouts of Air Nigeria and monumental funds spent on it so far.



On her part, Sadiya Umar Farouq needs to tell the DSS and EFCC how money voted for social investment programme especially school feeding were expended.

### UN Allocates \$20m To Scale Up Emergency Response On Food Security, Nutrition Crisis In North East

he United Nations has allocated US\$20 million from the Central Emergency Response Fund (CERF) and the Nigeria Humanitarian Fund (NHF) to urgently ramp up the humanitarian response to the worsening food security and nutrition crisis in north-east Nigeria.

In support of government's efforts, some \$9 million in CERF funding and a complementary \$11 million NHF allocation will go towards a coordinated multisectoral response aimed at preventing a deterioration to famine or famine-like conditions.

According to a statement issued and signed by Ann WERU, Head, Public Information, OCHA Nigeria, and made available to journalists in Maiduguri on Monday, almost 700,000 children under five are likely to suffer from life-threatening severe acute malnutrition (SAM) in Borno, Adamawa and Yobe (BAY) states in 2023. This is more than double the number of SAM cases in 2022 and four times the number of cases in 2021.

More than half a million people in the BAY states are also projected to face emergency levels of food insecurity – one step away from famine, from June to August which is the peak of the lean season, according to the March 2023 Cadre Harmonisé analysis.

The lean season also coincides with the rainy season, when the incidence of acute watery diarrhoea, cholera, malaria and other diseases increases, aggravating the precarious situation of malnourished children

"Extremely high rates of acute malnutrition and deaths are predicted unless there is a rapid and significant scale up of humanitarian assistance," warned Mr. Matthias Schmale, the Humanitarian Coordinator for Nigeria.

"Government, donors and the international community must make urgent funding available to protect the lives and future of vulnerable children in north-east Nigeria," the statement said.

The bulk of the CERF allocation, \$6 million, will go to the World Food Programme for food security interventions (including food and voucher assistance) for 95,000 extremely food-insecure people in three garrison towns of Borno State.

Some \$2 million will go to the UN Children's Fund for the prevention and treatment of acute malnutrition (including providing ready-to-eat

therapeutic food and Tom Brown solutions (a nutrient-rich locally produced supplementary food).

Also, \$1 million will go to the Food and Agriculture Organization for seeds, tools and other agricultural livelihood support to boost local production of nutritious foods to build resilience.

Most of the NHF funding (\$11 million) will go towards improving access to clean water and sanitation hygiene, and nutrition (including reactivating, sustaining and scaling up the bed capacity at stabilization centres and scaling up outpatient therapeutic feeding programmes).

The rest of the funding will go to healthcare (including the integrated management of childhood illnesses and complicated SAM cases), and to protection services with a focus on gender-based violence, child

protection and mine action. The NHF aims to allocate 50 per cent of funding to eligible national partners on the frontlines.

The alarming food security and nutrition crisis is primarily the result of years of protracted conflict and insecurity which continue to prevent many people from growing the food they need or earning an income to procure food.

On May 18, humanitarian organizations appealed for a prioritised \$396 million of this year's Humanitarian Response Plan (HRP) appeal for a multisectoral response to the lean season food security and nutrition crisis.

While the CERF and NHF funds will help jumpstart this response, combined they represent less than five per cent of the required funding.

#### CSO Salutes Exemplary Patriotism, Cooperation Of Hajj 2023 Air Carriers

ndependent Hajj Reporters (IHR), a Lcivil society organization made up of Nigerian journalists who monitor and report activities in the Hajj and Umrah industry, has saluted what it describes as the "Exemplary Patriotism" and full cooperation shown by airlines selected by the National Hajj Commission of Nigeria (NAHCON) for this year's pilgrimage.

NAHCON had selected seven Airlines including Max Air, Azman, Air Peace, Aero Contractors, Ari Air, Value Jet and Saudi based Flynas for the airlift operations of Hajj 2023.

Payments to these airlines for the airlift exercise was agreed on United States Dollars as is the norm in international travels.

A statement released Saturday by IHR, signed by its National Coordinator, Ibrahim Mohammed said it is aware that based on the agreement reached with the Airlines, NAHCON was expected to pay at least 50% of the total amount due to them ahead of the commencement of the airlift of intending pilgrims.

"We are aware that after receiving all deposits from across the states, FCT and the armed forces, NAHCON had gone ahead to deposit these monies into its accounts at the Central Bank of Nigeria (CBN)

"The normal practice is for the apex bank to provide the dollar equivalent of monies deposited based on the approved official rates for disbursement by NAHCON to meet its obligations. However, we are sad to note that in spite of repeated appeals, the CBN could not provide the needed foreign exchange equivalent not just before the commencement of airlift on May 25, but almost 3 weeks after.

"It is, however, gratifying to note that after receiving assurances of payment whenever the USD is made available, the airlines have gone ahead to not just offer full services, but is so far doing a wonderful job. Over 50,000 pilgrims have so far been airlifted to Saudi Arabia by the airlines who are yet to get the needed funds from Nigerian authorities.

"This is most commendable and patriotic," the statement said.

IHR also noted that following relentless efforts of various stakeholders and coupled with recent change of leadership at the CBN, the necessary authorisation have been received and NAHCON is set to get the due amounts for disbursements.

"We urge all concerned to ensure everything that is needed to be done ahead of the second leg of the airlift that is expected to begin immediately after the Hajj rites is done" IHR said.

### Governor Inuwa Flags Off Sales, Distribution Of Subsidised Fertilizer For 2023 Farming Season

\*Restates Commitment To Supporting Agricultural Activities, Ensuring Food Security In Gombe State

#### \*Announces 25% Subsidy On Market Price Of Commodity

overnor Muhammadu Inuwa Yahaya has flagged off the sales and distribution of fertilizers for the 2023 farming season.

Performing the ceremony at Lawanti Farm Service Centre in Akko Local Government Area, the Governor said the commodity will be sold at the rate of N19,000 per bag, against the market price of about N26,000 to alleviate the financial burden on the farmers. According to a statement signed

by the Director-General (Press

Affairs)
Government House Gombe,
Ismaila Uba Misilli, made
available on Monday, he said
that the timely distribution of the
subsidised fertilizers for this
year's cropping season is aimed
at boosting agriculture and
ensuring food security in the
state and beyond while creating
wealth and providing
employment opportunities for
the teeming populace.

The governor said "the government has procured 160 trucks (5000 MT) of fertilizer at the cost of Two Billion, Eight Hundred and Thirty-Seven Million, Five Hundred Thousand Naira (N2,837,500,000.00)", an addition of about 35 trucks from the quantity distributed last year. To ensure the commodity reaches its intended beneficiaries, Governor Inuwa explained that his government has put in place an effective framework for the sales and distribution of fertilizers across all the 114 political wards of the state to ensure that the commodity reaches the real farmers at the grassroots. Governor Inuwa said his

administration is mindful of the high price of fertilizers in the market which adversely affects the farmers and reduces the overall contribution of the sector in the economic development of the state.

"We understand that the high cost of fertilizer and other farm implements can be a significant barrier to our farmers. That's why we are working diligently to make these essential inputs available at reduced prices to alleviate the financial burden on our farmers. Our aim is to empower our farmers with the essential resources to enhance crop yields, improve soil fertility, increase profitability, and achieve sustainable agricultural practices".

The governor explained that his

government has engaged in different projects and programmes to revamp agriculture in Gombe with the state keying into many agricultural initiatives at both state, regional and national levels to boost productivity.

"Government has also secured an NG-cares intervention on the provision of fertilizer and agrochemicals to our farmers free of charge. We also collaborated with the Federal Ministry of Agriculture and Rural Development FMARD in training farmers on the maize and yam value chain in which the beneficiaries were provided with relevant inputs as starter packs.

"We are also embarking on agricultural extension services and awareness campaigns on modern farming techniques, soil management, and sustainable agriculture for Gombe farmers to get the necessary tools and information to make informed decisions and embrace practices that benefit both their farms and the environment", he added.

"I would like to assure you that we have put measures in place to ensure that the procured fertilizer reaches the grassroots. This informed my approval of the distribution method that captured adequately our small, medium, and large-scale farmers. To ensure smooth and hitch-free distribution of fertilizers, I have directed the Ministry of Agriculture and Animal Husbandry to deliver the fertilizer to all our 114 political wards across the State".

Announcing the price for this year's fertilizers, Governor Inuwa said, the commodity will be sold at the price it was sold last year despite the increase in the market price of the commodity.

"Last year, we sold the fertilizer at 19,000 Naira per bag; we still maintain that price." He said, adding that, each bag of fertilizer is subsidised at the rate of 25%.

He appealed to the farmers to cooperate with those assigned with the responsibilities of sales and distribution across the state for the success of the exercise.

He cautioned them against diversion or any form of mismanagement of the commodity, adding that the law will take its course on anybody found wanting.

The governor restated his government's commitment towards mitigating farmer-herder conflicts in the state through the setting up of conflict

prevention and dispute resolution committees in all the eleven local governments of the state, the efforts that he said have so far recorded tremendous success in bringing harmonious and peaceful coexistence between herders and farmers which has significantly increased crop and animal productivity in the state.

He maintained that Gombe State is largely an agrarian state with over 8 0 % of its population engaged in Agriculture. "Supporting this sector is therefore crucial to economic development, food security, and s u s t a i n a b l e livelihood for our people", the governor noted.

He used the occasion to thank local farmers for their contribution towards the growth and resilience of the agricultural sector in the state, urging both farmers and herders to live in harmony with one another and avoid

infringing on others' properties and rights for peace to reign in Gombe state and the nation.

The governor pledged continued support to the agricultural sector, promising to address the shortage of manpower in the agricultural sector, thereby improving farming productivity. Earlier in his welcome address, the Director, Planning, Research and Statistics in the Ministry of Agriculture, Dr Ibrahim Yakubu Usman thanked Governor Muhammadu Inuwa Yahaya for giving the agricultural sector in the state the attention it deserves, explaining that since the inception of this administration, the governor has been consistent in providing all the needed funds and necessary support for agricultural development in the

Dr. Ibrahim specifically noted the establishment of Farmer-



herder Prevention and Settlement of Disputes committees, annual vaccinations against transboundary animal diseases, procurement and distribution of fertilizers, agrochemicals, farm equipment, building livestock infrastructures among others as some of Governor Inuwa's keen intervention in Agricultural sector towards making the state self-reliant and agricultural hub in the Northeast Subregion.

#### 'Women Wahala!'

OMEN trended this week and not for a good reason, rather as a butt of a joke and the 'problem' of polygamy, with comments emphasising 'women wahala.' No thanks to the wives of the Speaker of the House of Representatives, Tajudeen Abbas, at his inauguration on Tuesday where one pushed away the other for space.

"In any event some may assume that this sort of rivalry happens only where the husband is wealthy or is a high office holder, but the reality is that even where the husband is so poor that the wives have to scrounge to feed their children, they still engage in rivalry."

While nobody will deny that there are undertones between co-wives even where there are seamless cohesion, but even where there is strong rivalry, some would not show it in public. They would present a friendly mien between themselves and pick up their quarrel when they go back home.

This should be more so for wives of public officers, especially in the full glare of cameras at his swearing in! And to make matters worse in this age of social media where things that would not be noticed before are now amplified to high heavens. This may cause remorse, disappointment from their loved ones, embarrassment from some quarters and their husband would not be happy.

Just imagine if he is a governor, only God knows what would happen in the state, with the position of the First Lady.

I recall that many years ago, two wives of one governor competed vigorously at attending functions, but at least they attended different ones therefore there was no clash; only that the state television was full of the news of the functions.

It was like a bazaar, each wife with her entourage, making people and clerics to complain. One cleric asked the governor to call them to order. They were turning government into something else, but that was before the coming of the social media, allowing them to get away with it. Perhaps that is why some governors with two wives don't encourage the office of the First Lady or the title, if you like, even though the first wife ought to be the First Lady. But where the second wife or third or fourth, as the case may be, is more assertive, she may try to take over the position. Where the first wife may not really care and would like to leave it, her relations and friends may instigate her not to allow the co-wife to usurp her position. Meanwhile they may be doing it for themselves.

If care is not taken, a problem may arise where there would be different camps of the wives fighting on their behalf.

In any event some may assume that this sort of rivalry happens only where the husband is wealthy or is a high office holder, but the reality is that even where the husband is so poor that the wives have to scrounge to feed their children, they still engage in rivalry.

It all boils down to how to getting the affection and attention of the husband whether he is rich or poor, though there is higher stake if he is a governor or a speaker, so you cannot afford to be sidelined and treated as if you too are not his wife. After all, you hold the same position, whether he has spent forty years with the first wife and one year with you, you are both his wives.

To mitigate rivalry, some men keep their wives in separate houses, but surprisingly it doesn't prevent bitter rivalry and quarrels if they meet somewhere. For example, they may meet at the occasion of their husband's brother's wedding.

Some would avoid the meeting at all cost; they attend occasions on different days where possible.

If wives are living in the same house, they know the whereabout of the husband, at least if he is at home, but if they live in different houses one wife may suspect that he is always at the other wife's house even if he is not. And if they suspect him of having a girlfriend or wanting to bring another wife, they can rally together and confront the challenge.

Though taken as a joke, as 'women wahala', it is a serious matter where men as leaders in their homes should be firm and not allow their wives to wash their dirty linen in public.

Women as mothers should have more restraint and not engage in open rivalry with their co-wives in public. They should set good examples for their daughters. Enough of this wahala!

### Senator Bulkachuwa and the "Go to Court Syndrome"

N his valedictory address to the Senate, "distinguished" former member, Adamu Bulkachuwa, has confessed to influencing the decisions of his wife, Zainab Bulkachuwa, while she was serving as a judge and President of the Court of Appeal. Mr. Bulkachuwa, an 83-year old chieftain of the ruling APC, who represented Bauchi North senatorial district in the 9th Senate, confirmed infringing on: "My wife, whose freedom and independence I encroached upon while (she) was in office, and she has been very tolerant and accepted my encroachment and extended her help to my colleagues," he said.

"The 2023 elections were contentious and acrimonious. Many citizens believe for whatever reasons that the elections were not free and fair. A lot of Nigerians are therefore looking up to the judiciary to deliver justice in the election tribunals currently sitting. The Bulkachuwa confession would shake their belief. It is for this reason that it would be unwise for the National Judicial Council to remain aloof on the matter."

The former Senate President, Ahmad Lawan, realised the old man was making dangerous revelations of their secret practices in public and stopped him saying: "Distinguished, I don't think this is a good idea going this direction. It is not a good idea, please." It would have been great to hear examples he might have given on how they perverted the course of justice.

Very few Nigerians would have been surprised to learn that such behaviour happens. What the episode does is to confirm what we know. It is not for nothing that the joke during this election season is that after you have been rigged out, you would be told go to court and get justice. It is not a joke but one of the deepest concerns of Nigerian citizens about the sharp decline in the delivery of justice in the nation's judicial system.

The President of the Nigerian Bar Association, Yakubu Maikyau, in his comments on the matter correctly asserted

that the statements were clearly admissions by the Senator that he did attempt to, and/or actually perverted the course of justice, which makes him liable to be investigated and prosecuted even on his admission. That this came with a huge negative impact on the integrity and the independence of the Judiciary can only be an understatement.

Unfortunately, the National Judicial Council (NJC), which met on 14 June 2023, did not take a stand on the matter, arguing through an official that the judge in question has already retired so no disciplinary measures can be taken against her. They are yet to understand the basic issue that the integrity and independence of the Judiciary is in question due to widespread belief, based on credible allegations, that very many judicial officers soil the reputation of the judiciary through decisions based on pecuniary rewards, political, ethnic and religious influences making nonsense of the entire judiciary. In such a context, lame excuses to justify inaction is not the way to go.

"In Nigerian parlance, Jankara judgement refers to a judicial outcome that has been procured illegally. It draws its meaning from a Lagos market that was notorious at one time for selling fake products. Sad is the country where law enforcement and judicial decisions are assumed to be for the most part based on injustice – bribes, corruption, peddling influence and/or blackmail."

A senior lawyer and former President of the Nigerian Bar Association, Olisa Agbakoba, has called on the Inspector General of Police (IGP) and the Chairman of the Independent Corrupt Practices and Other Related Offences Commission (ICPC), to immediately invite Senator Bulkachuwa for interrogation and proceed to prosecute him accordingly. It is indeed important that strong action should be taken on the basis of this confession.

Premium Times reports that in the waning days of her headship of the appellate court in February 2020, Justice

Bulkachuwa shared her four-decade experience w i t h journalists in Lagos. Specifically, she denied an allegation that she took a six billion naira bribe: "There was a time w h e n allegations were flying around that I was given N6 billion, and I laughed. So, if I was given N6 billion, do you think I would still be here?" she wondered. The jurist went on to distance her judicial duties from her husband's political life. After her

husband's comments, it is now difficult to believe her because if she indeed betrays the ethics of her profession based on spousal influence, why not for financial reasons.

The 2023 elections were contentious and acrimonious. Many citizens believe for whatever reasons that the elections were not free and fair. A lot of Nigerians are therefore looking up to the judiciary to deliver justice in the election tribunals currently sitting. The Bulkachuwa confession would shake their belief. It is for this reason that it would be unwise for the National Judicial Council to remain aloof on the matter.

They must become more active and denounce and expose the corrupt ones amongst them. On Wednesday, President Bola Tinubu suspended the chairman of the Economic and Financial Crimes Commission (EFCC), Abdulrasheed Bawa, from office for "weighty allegations of abuse of office levelled against him." It would be recalled that last month, the immediate-past governor of Zamfara State, Bello Matawalle, accused Mr Bawa of demanding \$2 million as a bribe from him, an allegation he denied. He was in turn accusing Mr. Matawalle of organising a N70 billion fraud as governor. In 2021, Mr Bawa took over the helms of affairs at the commission under similar circumstances when his predecessor, Ibrahim Magu, was suspended from office by then-President Muhammadu Buhari, over allegations of corruption. This is the predicament of Nigerians – are there public officials who are not corrupt? Indeed, some commentators attribute Mr. Bawa's suspension to his previous efforts to investigate the current President for corruption three years ago.

# The United States' Recurring Memory Loss in Diplomacy

OUR archenemies of the United States (US) met variously in its Latin American 'backyard' this week. It was the five-day Iranian President Ebrahim Raisi's visit to Venezuela, Nicaragua and Cuba. No, the quartet did not make themselves enemies of the US, it was the latter which at various times had dictated to those countries, that designated them as such.

"First, Saab, is a moral burden on the US. During the Covid-19 pandemic when virtually all countries in the world including the US needed aid, Saab was on a mission to Iran to buy urgently needed food and medicines for Venezuelans. On June 12, 2020, his plane touched down in Cape Verde to refuel. He was abducted by the authorities on the instigation of the USA for the 'crime' of trying to buy food for his starving compatriots when the almighty US had ordered that no country carries out any transaction with Iran.'

All four are under the unilateral sanctions of the US which punishes any country that dares befriend them. So, only the independent-minded and strong countries maintain trade relations with them.

The US also punishes the quartet if they dare trade amongst themselves. In 2020, the US ordered the seizure of four Iranian vessels with 1.1 million barrels of fuel bound for Venezuela. The US said the ships must be seized because they violated the unilateral sanctions it had imposed on both countries. It was a show of might over right. So, the defiant visit this week by the Iranian President and the various sanction-bursting agreements the four countries signed, is a declaration that they are not ready to abide by the dictates of the US.

Raisi was defiant throughout his tour. At the start of his June 12 visit, he said the four countries h a v e "a c o m m o n enemy...common interests and we have common enemies." He added in reference to the US and its allies: "They do not want the two countries, Iran and Venezuela, to be independent"

To these declarations,

Venezuelan President Nicholas Maduro responded: "We are on the right side of history and together we will be invincible." Both sides signed agreements on various fields including oil, defence, technology, energy, maritime and medicine.

Raisi on Wednesday told Nicaraguans: "There is a great geographical distance between Nicaragua and Iran and the Latin American region, but our hearts are very close and our goals are also very close (we) share a common history of struggle, of resistance, of revolutions, of combat against a common enemy."

In Nicaragua, both countries signed agreements including one on a bi-national commission before the Iranian President flew to Cuba, the country that gave the world unforgettable international radical leaders of the 20th century like Ernesto Che Guevera and Fidel Castro.

A common thread between Venezuela and Iran with its ends flapping in the US is the case of Alex Saab, a Venezuela Ambassador currently on trial in Miami, USA.

First, Saab, is a moral burden on the US. During the Covid-19 pandemic when virtually all countries in the world including the US needed aid, Saab was on a mission to Iran to buy urgently needed food and medicines for Venezuelans. On June 12, 2020, his plane touched down in Cape Verde to refuel. He was abducted by the authorities on the instigation of the USA for the 'crime' of trying to buy food for his starving compatriots when the almighty US had ordered that no country carries out any transaction with Iran.

The ECOWAS (Economic Community of West African States) Court, was ashamed of the role of Cape Verde in not only detaining an ambassador with diplomatic immunity but one on an urgent humanitarian mission. It ordered its Member country not just to effect the immediate release of Ambassador Saab, but also pay him a \$200,000 dollar compensation. But Cape Verde betrayed the African brotherhood and the spirit of its biological son, Amilcar Cabral who fought for the brotherhood



of humanity before being murdered by Portuguese security agents. Under US pressure, Cape Verde handed over the ambassador to the US which flew him to Miami for a controversial trial.

Now, the US is part of the human race that accepts and enjoys diplomatic immunity. In its 'Diplomatic and Consular Immunity: Guidance for Law Enforcement and Judicial Authorities,' the Department of State, in accepting diplomatic immunity as sacrosanct, wrote "International law, to which the United States is firmly committed, requires that law enforcement authorities of the United States extend certain privileges and immunities to members of foreign diplomatic missions and consular posts." Its reference is to the Vienna Convention on Diplomatic Relations and the Vienna Convention on Consular Relations.

So, the Ambassador Saab case was ordinarily a straight forward one; all he needed was to tell the American court that he is an ambassador which under the American constitution and obligations, grants him

immunity from prosecution in any US court.

After long delays including denying Saab medical treatment for his post-cancer treatment, family and consular visits, he had his day in court. That he had been an ambassador of Venezuela since 2018 could not be controverted but the US Government said it does not recognise the Venezuelan Government headed by President Nicolas Maduro which had appointed Saab an ambassador. For the US, the Maduro government does not exist!

This submission of the Biden administration exposes the American government as either being utterly dishonest or suffering from dementia.

Given the age of the US establishment and its increasing inability to come to terms with the unfolding global reality, it is certain that it is suffering from recurring diplomatic memory loss. Let me demonstrate this with facts of interactions between the Biden and Maduro governments in 2022 alone.

In March 2022, President Joe Biden dispatched a top-level US diplomatic delegation to Caracas which held meetings with the Maduro government. The White House delegation composed Juan Gonzalez, the National Security Council Director for the Western Hemisphere, Roger Carstens, the special presidential envoy on hostage affairs and Ambassador James Story, the US Ambassador to Colombia who

oversees the American Venezuelan Affairs Unit.

In June, 2022, President Biden again sent a special delegation which included Roger Carstens and Ambassador James Story to meet with the Maduro government. President Maduro confirmed the presence of the US delegation and directed it to meet National Assembly President Jorge Rodríguez. Maduro had said the meeting was to "give continuity to the bilateral agenda between the government of the United States and the government of Venezuela."

Then on Saturday, November 26, 2022, President Biden eased some of the oil sanctions against the Maduro government. Under it, the US Treasury authorised Chevron oil to resume 'limited' oil production in Venezuela under the supervision of the Maduro administration.

These are facts. But the Biden government could not seem to recall these events and the US court concurred. It ruled that: "At the time he was arrested, Saab Moran truly was no diplomat at all."

Venezuelan Congress head, Jorge Rodriguez, said of the ruling: "If the United States, or in this case, this judge, takes that decision, which is an atrocity, no diplomat in the world will be safe from now on."

But who cares; at least not the American establishment that is striving so hard to stand the world on its head?

Delta Police Busts Car Snatching Syndicate, Recovers 7 Vehicles, 16 Engines, 8 Gear Boxes, Others

olice detectives in Delta have bust a vehicle theft and vandalisation syndicate, recovering a total number of seven vehicles, 16 vehicle engines, eight gear box and 15 motor batteries.

Two motorcycle engines suspected to have been stolen were reportedly recovered from the suspected syndicate.

The vehicles were said to have been recoverd from parks in Asaba, Warri, Ugheli environs by the hoodlums.

Our correspondent gathered that two suspects were arrested in connection with the crime by police operatives attached to Ugheli Division led by the DPO and supervised by the Area Commander ACP Adebayo Ademola on 15th June, 2023 while acting on credible intelligence.

Identified as Phillip Ekugbe and Onome Erikefe both of Ekpan community Effurun, the duo were alleged to specialize in snatching of vehicles from Warri and environs, take them to Ughelli where they disassemble and sell them in parts.
