The projects commissioned are School of Nursing and Midwifery, remodeled and expanded General Hospital, five number 1.4km Jikan Shehu Internal Access road, 5km Maigari Gwadebe GRA road a component of 11km Kontagora-Tegina approach road, Col. Sani Bello Housing Estate and Rice Mill Processor, all in Kontagora.

Speaking on the School of

Nursing and Midwifery, Governor Abubakar Sani Bello explained that it is expedient to establish the school to produce qualified health personnel that would fill the gap of manpower in the health

The governor commended the management of the school for their hard work as they have started graduating students and promised to inform the next administration of their challenges, as presented for positive response.

He said as a Senator-elect of Niger North, he will support the institution in everyway possible.

At the General Hospital Kontagora which was

established about 79 years ago, the governor disclosed that as his place of his birth, it has suffered neglect for decades due to the growing population of the town and needed to be upgraded to meet the growing demand in healthcare service.

He explained that the former 250-bed space capacity hospital which has now been remodeled, expanded and equipped to 500-bed space capacity will serve the people of Kontagora and neighbouring states of Zamfara and Kebbi.

On the road projects, the governor said they were reconstructed to provide easy movement for the people as well add value to

their properties.

At the Col. Sani Bello Housing Estate, Governor Sani Bello explained that the project suffered several years of set backs haven been initiated about 12 years ago.

He however, expressed delight that it has been completed and would benefit the people.

Ogun Guber: NNPP Heads For Appeal Court, Says Tribunal Judges Erred

he New Nigeria People's Party (NNPP) has appealed the ruling of the Governorship and House of Assembly Tribunal sitting in Abeokuta, in a petition brought before it by the party over the omission of the party's name on the ballot papers used in conducting the 2023 gubernatorial election.

NNPP in the Appeal filed before the Court of Appeal sitting in the Ibadan Judicial Division stated that it was appealing the ruling because, the judges that heard the case erred in their judgement.

In the appeal on the suit

EPT/OG/GOV/01/2023, the NNPP Counsel, Barrister I D Izunya (Esq), informed the Court of Appeal that it was dissatisfied with the unanimous judgement by the three judges and thus

appealing the judgement. NNPP while reiterating its position as contained in the petition EPT/OG/GOV/01/2023, of April 15, 2023, averred that: "The learned justices erred in law when they unanimously held that by article 27.18 (iii), (v) and (vii) of the constitution of New Nigeria Peoples Party (Hereinafter called NNPP) the National Legal Adviser of NNPP cannot take over the appellant case, brief another counsel and debrief the counsel on record, Mr. Peter I Ogah from further representing the party.

"That by Article 27.18 (iii), (v) and (vi) of the constitution of NNPP the National Legal Adviser of the Party is empowered to attend to all litigations and legal defence on behalf of the party at all levels, including its organs and coordinate the activities of Legal Advisers at all levels on legal matters affecting the party", it added..

NNPP added, " That the learned counsel on record, Mr. Peter I Ogar being engaged to represent the appellant by an organ/branch of the appellant is by virtue of the constitution of the appellant under the control and supervision of the National Legal Adviser of the appellant."

"That section 36 of the

1999 constitution (As amendlooked) 2018 provided and recognised the right of the appellant to debrief and brief another counsel at any time of the proceeding. The learned Justices of the tribunal erred in law when they allowed learned counsel. Peter I Ogar to successfully withdraw the appellant's petition and dismissed same when the provisions laid down by the Electoral Act, 2022 for the withdrawal of Petition has not been complied with".

The party stressed further,

"Section 30 (1) (a) & (b) of the Electoral Act, 2022 clearly provides that before leave for withdrawal of an election petition can be granted each of the parties, in this case all the respondents shall produce an affidavit stating that no agreement or terms of any kind has been made and no undertaking has been entered. That the withdrawal of the appellant petition was done without the affidavit required by electoral Act". "The learned Justices of the tribunal erred in law when they allowed the learned counsel to move motion for withdrawal of the appellants petition despite a protest letter of un-authorization of withdrawal of petition dated 27th day of April, 2023 and filed on the 29th day of April, 2023 written

"That the appellant name is on the petition and not the lawyer's name. That the appellant is the litigant and the person whose name appeared on the process of the court and therefore the Chief Executive Officer and driver of her case who drives and determines what and how the case should proceed".

NDLEA Apprehends 17 Suspects Over llicit Drug, Firearm In Ogun

o fewer than 17 suspects are now in the net of the National Drug Law Enforcement Agency (NDLEA) in Ogun State over alleged possession of illicit drugs and firearm.

Our correspondent reliably gathered that the suspects were apprehended during a raid carried out at four different drug joints.

The State Commander of Narcotics, NDLEA, Ibiba Odili, in a release said the joint operation was carried

35 Artillery Brigade of the Nigeria Army, and the Nigeria Security and Civil Defence Corps.

According to her, the suspects were caught in possession of 2.5kg of cannabis sativa commonly known as marijuana.

She added that the operatives also recovered 1.5kg of the same substance that was abandoned and a pistol gun.

"The operation uncovered a locally-made pistol along with three cartridges, underscoring between drug trafficking and illicit firearms.

"Also, during the second phase, which resulted in the arrest of one suspect, 63 grams of cannabis sativa was seized while two drug users were apprehended.

Additionally, a seizure of 1.1kg of abandoned cannabis sativa further disrupted the drug trade in the area.

"In the third and final phase of the operations, two drug users were apprehended while a seizure of 500 grams of was recorded.

"The cumulative impact of all three phases revealed a chilling reality: a total of three suspects were apprehended, along with 14 drug users. The combined weight of the confiscated cannabis sativa amounted to a staggering 6.2kg abandoned and seized,' Odili said.

Lagos Siege: Confusion As DSS, EFCC Trade Words Over Office Space

*EFCC says siege inconsistent with synergy expected of agencies *DSS insists service only occupying its facility

he Economic and Financial Crimes L Commission (EFCC), yesterday alleged that agents of the Department of State Services (DSS), barricaded entrance to its office located on 15 Awolowo Way, Ikoyi in Lagos.

A statement titled, "DSS' Siege on Our Lagos Office Shocking - EFCC" signed by Wilson Uwujaren, the commission's Head, Media & Publicity, said that the siege is inconsistent with the synergy expected of agencies working for the same government and nation, especially when there are ongoing discussions on the matter.

"The operatives of the Lagos Command of the Economic and Financial Crimes Commission, EFCC, arrived at their office on No. 15 Awolowo Road, Ikovi, this morning, May 30, 2023, to be denied entry by agents of the Department of State Services, DSS, who had barricaded the entrance with armoured personnel carriers.

"This development is strange to the Commission, given that we have cohabited with the DSS in that facility for 20 years without incident.

"By denying operatives access to their offices, the Commission's operations at its largest hub with over 500 personnel, hundreds of exhibits, and many suspects in detention have been disrupted.

"Cases scheduled for a court hearing today have been aborted, while many suspects invited for questioning are left unattended. Even more alarming is that suspects in detention are left without care, with grave implications for their rights as inmates," EFCC said.

They warned that the siege has wider implications for the nation's fight against economic and financial crimes.

But in a swift reaction, the DSS denied laying siege on EFCC office.

A counter statement titled, "DSS NOT IN A FIGHT WITH EFCC OVER LAGOS PROPERTY", signed by

Public Relations Officer Department of State Services National Headquarters Abuia, Peter Afunanya, said that the service is only occupying it's facility.

"The attention of the Department of State Services (DSS) has been drawn to some media reports that barricaded the EFCC from entering its Lagos office. It is not correct that the DSS barricaded EFCC from

entering its office. No. It is not true. The Service is only occupying its facility where it is carrying out its official and statutory responsibility.

"By the way, there is no controversy over No 15A Awolowo Road as being insinuated by the Media. Did the EFCC tell you it is contesting the ownership of the building? I will be surprised if it is contesting the ownership. Awolowo Road was NSO headquarters. SSS/DSS started from there. It is common knowledge. It is a historical fact. Check it out.

"There is no rivalry between the Service and the EFCC over and about anything. Please do not create any imaginary ones. They are great partners working for the good of the nation. Dismiss any falsehood of a fight," DSS

irector-General of the National Biosafety Management Agency (NBMA), Dr. Agnes Asagbra has said that the agency will resist any attempt to derail Nigeria's progressive biosafety

Dr Asagbra who was receiving the visiting Executive Director of AATF, Dr Canisius Kanangire, said that she will continue to collaborate with likeminded stakeholders in modern biotechnology to ensure that Nigeria's leading position in the continent on biosafety is not compromised.

A statement signed by the Communication Officer, AATF, Alex Abutu, made available to our correspondent yesterday, said that the Director General assumed duty on May 2nd 2023, following the retirement of Dr Rufus Ebegba, who served for eight years as the pioneer Director-General of NBMA.

"I understand the agitation on the minds of most stakeholders. Indeed, Dr, Ebegba laid a solid foundation in the regulation of Modern Biotechnology in Nigeria and Africa in general, Dr Asagbra said.

Dr Ebegba ensured that an adequate level of protection in the field of safe transfer, handling, and use of genetically modified organisms (GMOs) resulting from modern biotechnology, she added.

"Under my watch, the Agency will not rest on these laurels or lower the standard already set. No, we will definitely strive to consolidate on all that has been put in place and strengthen the areas of weakness," Dr Asagbra

Food Security: NGO Donates Seedlings Worth Millions Of Naira To Southern Kaduna Farmers

By: AUSTINE AGBO EMMANUEL, Kaduna ollowing the need to access sufficient, safe and nutritious food that meets the dietary needs of citizens, a nongovernmental organization (NGO), When In Need Foundation has donated seedlings to Southern Kaduna farmers.

The Chief Executive Officer of the foundation, High Chief Chetachi Nwoga Ecton flagged off the distribution in Kwoi, on Saturday, explaining that the only way to fight hunger is to farm.

According to her, agriculture remains the major tool to tackle poverty, poor diet and economic challenges in contemporary society, adding that Nigeria will become a better place if they can embrace the practice of both subsistence and mechanized agriculture.

Chetachi further stressed that the gesture is a way of giving back to the society especially to the good people of Ham Chiefdoms, adding that she has done it in three other states.

She said, "It's my little bit of good in the world to assist in the area of hunger and we have done this in three different states.

"The only way we can decrease hunger is to encourage local made goods. We cannot do everything but we can assist in every little ways possible.

The more you plant the more you have. If you eat all now, you lost all but if you plant, we can have enough tomorrow. Many chiefdoms will benefit from this intervention."

The seedlings donated by the foundation include, 13-bags of 100kg rice, 33-bags 75kg of maize, 16-bags of 75kg soya beans, 9-bags of 75kg black and white beans, Okro 3-bags of 50kg, 2,800 tubers of yam and 30-bags of fertilizer.

Although the actual amount spent was not disclosed, however it can be deduced from the current market price that the project is worth millions of Naira.

In his remarks, the monarch of Jaba Chiefdom, Kpop Ham, Dr. Jonathan Danladi Gyet Maude (JP, OON) said Chetachi is a blessing to the world.

He stressed that he is not surprised at her gesture, because she is his favorite adopted seed and therefore, has no choice to do otherwise, but to imbibe the good culture and character of the Ham people.

He promised that his people will seize the golden opportunity to plant the seeds for both home consumption and commercial purposes, while assuring that the community will continue to embrace farming even as agriculture remains the panacea for sustainable growth and development.

Delivering a paper at the event on the topic, "The challenges of southern Kaduna and the need for intervention, the guest speaker, Prof. I. K. Auta said that lack of unity in the region is one of the weapons against the Ham people.

CP Williams stated that the 78 suspects were arrested in possession of sophisticated firearms, 724 cartridges, assorted charms, 33 mobile phones, and a cash sum of about N3,450,000 million Naira Only.

"Sequel to the above, on Tuesday 30/05/2023 in a strategic intelligence coordinated raid around his location at Diamond Hotel, Alakia-Isebo, under Egbeda LGA, (78) Seventy-Eight suspected hoodlums who had perfected plans to unleash mayhem at the early hours of today at Major parts of the Metropolis were arrested in possession of sophisticated firearms, (724) Seven Hundred and Twenty-four Cartridges assorted charms, (33) Thirty-three Mobile Phones, and a cash sum of about (N3.450.000) Three Million Four Hundred and Fifty Thousand Naira Only", he said.

CP Adebowale added, "In addition, during the raid sophisticated firearms were recovered inside the hotel rooms and in the trunk compartment of parked vehicles within the hotel.

"Worthy of note is that,

Governor Inuwa Takes Oath To Begin Second Term In Office

*Says "We"ll Bequeath A Better Gombe State That Will Become A Source Of Pride To Future Generations And A Model To The Rest Of The Country". *Gives account of stewardship in last 4 years

ombe State Governor, Muhammadu Inuwa Yahaya has been sworn for a second term in office at the Pantami Township Stadium. Also sworn in is the Deputy Governor of the State, Dr. Manassah Daniel Jatau.

The Chief Judge of the State, Justice Halima Sadiyya Mohammed administered the Oath of Office on both the Governor and his Deputy at a colourful ceremony that attracted thousands of people from within and outside the State.

I'm his special address, the Governor recalled that four years ago, he took the oath of office as the 4th civilian governor of State wherein God gave him the wisdom and courage to deliver his campaign promises which led to his successful re-election.

Governor Inuwa Yahaya revealed that in the next four years, his administration will focus on Economic Empowerment and Job Creation, saying his government will continue with ease of doing business policies so as to consolidate the position as the most business-friendly state in Nigeria.

"These policies are designed to foster conducive business environment, attract investments, and stimulate economic growth. We shall also train and upskill our youth, invest in ICT skills and innovation, and harness our agri-business potentials in order to enhance food security and create employment opportunities".

On Education and Human Capital Development: the Governor said his administration will continue with the ongoing upgrades of school infrastructure, provision of instructional materials and improving the capacity of teachers and administrators.

"We are committed to expanding access to education, particularly for out-of-school childen, girl-child and other marginalized groups, through various initiatives like the Adolescent Girl Initiative for Learning

and Empowerment (AGILE). We are also committed to enhancing vocational and technica1 education to align with the needs of the rapidly evolving job market, particularly the agriculture, energy and oil and gas sectors which are fast taking shape in Gombe State, especially with discovery of oil and gas at Kolmani".

In respect to Healthcare and Social Welfare: the Governor said "We are going to leverage on Go-

Health and GSPCHDA to strengthen healthcare systems and infrastructure in order to ensure accessible and quality healthcare services for all. We shall Improve the capacity of our healthcare professionals by investing in training and capacity building, as well as partner with FG and other relevant stakeholders to implement social welfare programs that support vulnerable groups and alleviate poverty".

Speaking on Infrastructural Development; the Governor affirm that his administration will consolidate on the existing achievements by investing in the development of critical infrastructure such as roads, bridges, water supply, and electricity.

"We shall improve our rural and urban transportation networks, and investing in climate-friendly and sustainable projects. Urban renewal and redevelopment, especially in the State capital and the local government headquarters will be pursued vigorously in order to ensure decent living and also attract the much-needed investment in hospitality and tourism".

On Good Governance and Accountability: "We shall sustain the principles of people-driven, needs-based and participatory governance by improving our open government policies which enabled us to become one of the top 7 states in the country in the 2022 Transparency and Integrity Index. The efficient use of public resources through plugging leakages and reducing wastage will foster a culture of meritocracy and inclusivity in governance, thus improving the efficiency of the system".

Governor Inuwa Yahaya appeal to the citizens of the State for continued support,

a c t i v e engagement, and constructive feedback in order to succeed as It is only by coming together as one united people that his administration can transform the aspirations of the people into tangible realities.

He expressed confident that, with continuous support and prayers, the state will overcome its challenges, seize emerging opportunities, and create a future that is brighter and

more prosperous for every resident of Gombe State.

The Governor expressed gratitude for the trust the people of the state placed in him, saying their unceasing outpourings of support, prayers and goodwill will continue to inspire him towards building a better Gombe State, that will become a source of pride to future generations and a model to the rest of the country.

"As the saying goes, 'the reward for doing well is the opportunity to do more.' Your decision to once again trust me with your votes represents a resounding vote of confidence on our first term performance. Like I said during the campaigns, our excellent record speaks for itself. It offers our people a clear choice between progress and retrogression, hope and despair".

Governor Inuwa Yahaya noted that since elections are over, the business of governance must continue apace, just he call on stakeholders across partisan divides to join hands and move the state forward.

The Governor said on his part, he will continue to be just and fair to all, irrespective of political, ethnic, religious and sectional affiliations noting that the collective interest of Gombe State supersedes all other interests and considerations.

"Over the past four years, we overcome many challenges. We lost loved ones, including hardworking officials, close associates and loyal supporters. We shall continue to remember them because they form part of our success story today. We also made significant strides in advancing the development agenda of Gombe state by investing in critical sectors such as education, healthcare, infrastructure, civil service, agriculture, energy, water supply, environment and sanitation".

Governor Inuwa Yahaya explained that his administration revamped the

education sector, through the construction and renovation of over 1440 classrooms across the State; and mopped up of over 350,000 out-of-school children.

"We also upgraded 5 secondary schools to mega-school standards and constructed 4 special schools (to take care of special needs). We recruited 1,000 teachers, and strengthened vocational and technical education through various partnerships like the IDEAS (Innovation in Development and Effectiveness in Acquisition of Skills), which is a World Bank-assisted project".

According to the Governor, the efforts by his administration led to a number of positive outcomes, including a sharp increase in the percentage of candidates in public schools who passed the WASSCE with 5 credits or above including Maths and English from 28% in 2019 to 73% in 2021 and 78% in 2022.

On healthcare, the Governor explained that his administration ensured the provision of a fully functional primary healthcare center in each of our 114 political wards; upgraded the State Specialist Hospital in Gombe; and currently doing same at the General Hospitals in Bajoga and Kaltungo. This, he said, is in addition to a 200-bed general hospital in Kumo is being constructed and a brand-new 600-student capacity school of nursing technology.

"Our administration also established the Gombe State Contributory Healthcare Management Agency (Go-Health) in order to provide affordable healthcare for the vulnerable. So far, 35,116 beneficiaries have been rolled and are getting proper service. We also established the Gombe State Hospitals Management Board to provide leadership and direction to the administration of our hospitals, as well as the Gombe State Medical Consumables and Wholesale Supply Agency which aims to checkmate the menace of substandard and inadequate supply of medical consumables in the state".

The Gombe state Governor said in order to jumpstart economic activities and create jobs, his administration hosted the first-ever Gombe State Investment Summit which attracted billions of naira in local and international investments.

"The establishment of the ease of doing business council in the state also helped us to come first in the Presidential Enabling Business Environment Council (PEBEC) ranking in 2021 and 2022. Our drive to support small businesses and boost local economy helped us to provide over 500million-naira MSME grant, and empowered 1000 small business-owners and 500 artisans. The Bubayero Microfinance Bank was recapitalized with 764 million naira in order to meet regulatory requirements and facilitate microlending support to small businesses".

"Our commitment to invest in durable infrastructure and housing remain rock solid. To this end, we constructed over 700km of urban and rural roads under the Network 11-100 project which aims to connect the nooks and crannies of our state with serviceable road networks. The Phase One of the 1000-hectare Muhammadu Buhari Industrial Park is nearing completion. Already,

industries have started springing up to take advantage of the facility. We have also completed the Gombe Mega Motor Park in order to provide a befitting motor park to our people. Over 1000 homes are being constructed with the help of the Family Home Funds and the NEDC in order to reduce the housing deficits and ease its burden on our people".

He said the ongoing rehabilitation, upgrade and expansion of the Gombe Regional Water Supply Scheme has reached an advanced stage as his administration have also built and rehabilitated over 600 boreholes across the state through various initiatives like RUWASSA and SURWASH.

"Our administration has ensured timely procurement and distribution of subsidized fertilizer. This year, the fertilizer distribution exercise will commence on 15th June, 2023 in order to enable our farmers take advantage of the early planting period. We also ensured the provision of assorted seedlings and farm implements to farmers, as well as timely annual vaccination campaigns against major communicable diseases affecting livestock".



Governor Inuwa Yahaya remarked that while land administration has consistently remained a challenge in the development process, his administration established the Gombe Geographic Information System (GOGIS) as well as the Gombe State Urban Planning and Development Authority (GOSUPDA) In order to ensure efficiency in land administration and sustainable urban development.

"In this regard, we also created new layouts and standardized existing ones, including the new Shongo Gardens layouts, as well as the verification and restoration of the BAP4 layout".

"In order to revitalize our civil service, the Bureau of Public Service Reforms was established so as to institutionalize necessary reforms. Promotions and other benefits are being implemented in both the state and local government service. In addition to being among the first states to implement the new 30,000-naira minimum wage, we also paid over N7.9 billion in gratuity liabilities inherited from the previous administration, while ensuring timely payment of monthly pensions to our retirees".

He explained that his administration is committed towards improving

Transparency and Accountability in Governance. To this end he said the Gombe state Government under his leadership ensured a people-driven budget consultation process, timely publication of budgets and audited accounts, as well as compliance with the World Bank-led State Fiscal Transparency, Accountability and Sustainability framework (SFTAS) of which Gombe is among the best performing states nationwide.

Governor Inuwa Yahaya said his government repositioned the Gombe State Internal Revenue Service, leading to automation of revenue collection procedures and improvement in revenue performance.

"The maintenance of harmonious working relationship between the executive, the legislature and the judiciary is very fundamental to the success of every democratic setting. Our actions and activities are always tailored towards preserving and respecting the independence of the legislature and judiciary. Similar treatment is also extended to our local government councils, in order to ensure their financial independence and administrative autonomy".

"Our administration has adopted a threepronged approach to dealing with youth unemployment, climate change and insecurity. Through our Gombe Goes Green (3G) program which targeted the planting of 4 million trees, we are able to engage 27,000 youth in the program, providing them with job opportunities and mitigating climate and environmental degradation which induced farmer-herder conflicts and its attendant consequences. We also recruited 500 youth under the Gombe State Security, Traffic and Environmental Corp (GOSTEC) to protect our environment, bolster local security and enforce traffic rules".

He said in his administration's commitment to promote security, stability and peaceful co-existence, the Gombe State Government established the Ministry of Internal Security and Ethical Reorientation and introduced 'Operation Hattara' to support and complement the efforts of security agencies.

He added that the State Government also embraced local stakeholders to ensure coordinated and proactive response to security challenges, and convened the first-ever Gombe State Security Summit in order to boost local security and foster regional cooperation.

"It is noteworthy that these achievements were recorded despite domestic and global economic headwinds especially the Covid-19 pandemic and the global economic meltdown. It is gratifying that our administration was able to wither the storm and deliver strong performance which earned us local and international recognitions and accolades. While there is still much work to be done, we must build upon our achievements so as to reach greater heights".

overnor Nasir Ahmad el-Rufai of Kaduna State has said that the incoming administration of Senator Uba Sani is lucky to have a working document to key into on his first day in office.

THE NIGERIAN IDEAL

My Fellow Citizens,

stand before you honoured to assume the sacred mandate you have given me. My love for this nation is abiding. My confidence in its people, unwavering. And my faith in God Almighty, absolute. I know that His hand shall provide the needed moral strength and clarity of purpose in those instances when we seem to have reached the limits of our human capacity.

This day is bold and majestic yet bright and full of spirit, as is our precious nation.

As a nation, we have long ago decided to march beyond the dimness of night into the open day of renewed national hope.

The question we now ask ourselves is whether to remain faithful to the work inherent in building a better society or retreat into the shadows of our unmet potential.

For me, there is but one answer. We are too great a nation and too grounded as a people to rob ourselves of our finest destiny.

This nation's journey has been shaped by the prayers of millions, and the collective sacrifices of us all.

We have endured hardships that would have made other societies crumble.

Yet, we have shouldered the heavy burden to arrive at this SUBLIME moment where the prospect of a better future merges with our improved capacity to create that future.

To the surprise of many but not to ourselves, we have more firmly established this land as a democracy in both word and deed.

The peaceful transition from one government to another is now our political tradition. This handover symbolizes our trust in God, our enduring faith in representative governance and our belief in our ability to reshape this nation into the society it was always meant to be.

Here, permit me to say a few words to my predecessor, President Muhammadu Buhari. Mr President, you have been an honest, patriotic leader who has done his best for the nation you love. On a more personal note, you are a worthy partner and friend. May History be kind to you.

For many years, Nigeria's critics have trafficked the rumour that our nation will break apart, even perish.

Yet here we are. We have stumbled at times, but our resilience and diversity have kept us going.

Our burdens may make us bend at times, but they shall never break us.

Instead, we stand forth as Africa's most populous nation and as the best hope and strongest champion of the Black Race.

As citizens, we declare as one unified people devoted to one unified national cause, that as long as this world exists, NIGERIA SHALL EXIST

Today, Fate and Destiny join together to place the torch of human progress in our very hands. We dare not let it slip.

We lift high this torch so that it might shine on every household and in every heart that calls itself Nigerian. We hold this beam aloft because it lights our path with compassion, brotherhood, and peace. May this great light never EXTINGUISH.

Our administration shall govern on your behalf but never rule over you. We shall consult and dialogue but never dictate. We shall reach out to all but never put down a single person for holding views contrary to our own.

We are here to further mend and heal this nation, not tear and injure it.

In this vein, may I offer a few comments regarding the election that brought us to this juncture. It was a hard fought contest. And it was also fairly won. Since the advent of the Fourth Republic, Nigeria has not held an election of better quality.

The outcome reflected the will of the people. However, my victory does not render me any more Nigerian than my opponents. Nor does it render them any less patriotic.

They shall forever be my fellow compatriots. And I will treat them as such. They represent important constituencies and concerns that wisdom dare not ignore.

They have taken their concerns to court. Seeking legal redress is their right and I fully defend their exercise of this right. This is the essence of the rule of law.

Over six decades ago, our founding fathers gave bravely of themselves to place Nigeria on the map as an independent nation.

We must never allow the labor of those who came before us to wither in vain but to blossom and bring forth a better reality.

Let us take the next great step in the journey they began and believed in.

Today, let us recommit our very selves to placing Nigeria in our hearts as the indispensable home for each and every one of us regardless of creed, ethnicity, or place of birth.

My supporters, I thank you. To those who voted otherwise, I extend my hand across the political divide. I ask you to grasp it in national affinity and brotherhood. For me, political coloration has faded away. All I see are Nigerians.

May we uphold these fitting and excellent notions as the new Nigerian ideal.

My fellow compatriots,

The Nigerian ideal which I speak of is more than just an improvement in economic and other statistics. These things are important; but they can never convey the fullness of our story. Our mission is to improve our way of life in a manner that nurtures our humanity, encourages compassion toward one another, and duly rewards our collective effort to resolve the social ills that seek to divide us.

Our constitution and laws give us a nation on paper. We must work harder at bringing these noble documents to life by strengthening the bonds of economic collaboration, social cohesion, and cultural understanding. Let us develop a shared sense of fairness and equity.

The South must not only seek good for itself but must understand that its interests are served when good comes to the North. The North must see the South likewise.

Whether from the winding creeks of the Niger Delta, the vastness of the northern savannah, the boardrooms of Lagos, the bustling capital of Abuja, or the busy markets of Onitsha, you are all my people. As your president, I shall serve with prejudice toward none but compassion and amity towards all.

In the coming days and weeks, my team will publicly detail key aspects of our programme. Today, permit me to outline in broad terms a few initiatives that define our concept of progressive good governance in furtherance of the Nigerian ideal:

The principles that will guide our administration are simple:

- 1. Nigeria will be impartially governed according to the constitution and the rule of law.
- 2. We shall defend the nation from terror and all forms of criminality that threaten the peace and stability of our country and our subregion.
- 3. We shall remodel our economy to bring about growth and development through job creation, food security and an end of extreme poverty.
- 4. In our administration, Women and youth will feature prominently.
- 5. Our government will continue to take proactive steps such as championing a credit culture to discourage corruption while strengthening the effectiveness and efficiency of the various anti-corruption agencies.

SECURITY

Security shall be the top priority of our administration because neither prosperity nor justice can prevail amidst insecurity and violence.

To effectively tackle this menace, we shall reform both our security DOCTRINE and its ARCHITECTURE.

We shall invest more in our security personnel,

and this means more than an increase in number. We shall provide, better training, equipment, pay and firepower.

THE ECONOMY

On the economy, we target a higher GDP growth and to significantly reduce unemployment.

We intend to accomplish this by taking the following steps:

First, budgetary reform stimulating the economy without engendering inflation will be instituted.

Second, industrial policy will utilize the full range of fiscal measures to promote domestic manufacturing and lessen import dependency. Third, electricity will become more accessible and affordable to businesses and homes alike. Power generation should nearly double and transmission and distribution networks improved. We will encourage states to develop local sources as well.

I have a message for our investors, local and foreign: our government shall review all their complaints about multiple taxation and various anti-investment inhibitions.

We shall ensure that investors and foreign businesses repatriate their hard earned dividends and profits home.

JOB

My administration must create meaningful opportunities for our youth. We shall honour our campaign commitment of one million new jobs in the digital economy.

Our government also shall work with the National Assembly to fashion an omnibus Jobs and Prosperity bill. This bill will give our administration the policy space to embark on labour-intensive infrastructural improvements, encourage light industry and provide improved social services for the poor, elderly and vulnerable.

Agriculture

Rural incomes shall be secured by commodity exchange boards guaranteeing minimal prices for certain crops and animal products. A nationwide programme for storage and other facilities to reduce spoilage and waste will be undertaken.

Agricultural hubs will be created throughout the nation to increase production and engage in value-added processing. The livestock sector will be introduced to best modern practices and steps taken to minimize the perennial conflict over land and water resources in this sector.

Through these actions, food shall be made more abundant yet less costly. Farmers shall earn more while the average Nigerian pays

INFRASTRUCTURE

We shall continue the efforts of the Buhari administration on infrastructure. Progress toward national networks of roads, rail and ports shall get priority attention.

FUELSUBSIDY

We commend the decision of the outgoing administration in phasing out the petrol subsidy regime which has increasingly favoured the rich more than the poor. Subsidy can no longer justify its ever-increasing costs in the wake of drying resources. We shall instead re-channel the funds into better investment in public infrastructure, education, health care and jobs that will materially improve the lives of millions.

MONETARY POLICY

Monetary policy needs thorough housecleaning. The Central Bank must work towards a unified exchange rate. This will direct funds away from arbitrage into meaningful investment in the plant, equipment and jobs that power the real economy.

Interest rates need to be reduced to increase investment and consumer purchasing in ways that sustain the economy at a higher level.

Whatever merits it had in concept, the currency swap was too harshly applied by the CBN given the number of unbanked Nigerians. The policy shall be reviewed. In the meantime, my administration will treat both currencies as legal tender.

FOREIGN POLICY

Given the world in which we reside, please permit a few comments regarding foreign policy.

The crisis in Sudan and the turn from democracy by several nations in our immediate neighbourhood are of pressing concern.

As such, my primary foreign policy objective must be the peace and stability of the West African subregion and the African continent. We shall work with ECOWAS, the AU and willing partners in the international community to end extant conflicts and to resolve new ones.

As we contain threats to peace, we shall also retool our foreign policy to more actively lead the regional and continental quest for collective prosperity.

Conclusion

This is the proudest day of my life. But this day does not belong to me. It belongs to you, the people of Nigeria.

On this day, Nigeria affirms its rightful place among the world's great democracies. There, Nigeria shall reside forever.

The course of our past and the promise of the future have brought us to this exceptional moment.

In this spirit, I ask you to join me in making Nigeria a more perfect nation and democracy such that the Nigerian ideal becomes and forever remains the Nigerian reality.

With full confidence in our ability, I declare that these things are within our proximate reach because my name is Bola Ahmed Tinubu, and I am the President of the Federal Republic of Nigeria.

My First Term In Office Knowledge, Exposure, **Experience Has Prepared Me For A Smooth** Second Term - Gov Makinde

overnor Seyi Makinde on Sunday, declared that his first term in office knowledge, exposure and experience has prepared him for a smooth sail in the second term.

The governor said this at a Thanksgiving Service held at the Sword of The Spirit Ministries, Precious Cornerstone University Campus 1 (PCU), Garden of Victory, Olaogun, Old-Ife, Ibadan to mark the end of his first term and part of activities for the inauguration of his second term in office.

He stressed that all he achieved in his four years first term could be be said to have been achieved within two years after narrating how he spent time trying to settle down into governance when the COVID-19 pandemic lockdown slowed down activities again.

"In 2019, at the inauguration, I made a pronouncement that I will be paying salary at 25th of every month. I made the decision before reading the handover note. And we have paid for 49 consecutive months. When I read the handover notes, I wondered who will help me drive the vision to fulfil that mission. It took me time, say close to six months to figure out what is where and who is doing what, but I can bet, there

The governor stressed, " You have to organise congresses and all the rest and we were on that from September or October 2022 to March 28, 2023 when I was re-elected forward second term, so I discounted that period of about 6months again because I do not have undivided attention to serve the people of Oyo State within that period.

"So whatever we have been able to achieve, now you will agree with me that we

that within two years. OAU Student's Death: Court Sentences Proprietor, Two Hotel Staff To Death By Hanging

n Osun State High Court sitting in Osogbo yesterday, sentenced the owner of Hilton Hotel, Ile Ife, Dr Rahmon Adedoyin and two staff of the hotel to death by hanging over the murder of an Obafemi Awolowo University (OAU) Ile-Ife, Master student ,Timothy Adegoke.

Osun State Chief Judge, Justice Adepele Ojo in her judgement, found Adedoyin and three of his staff guilty of murder and conspiracy.

Justice Ojo stressed that

the prosecution confimed Adedoyin and his staff killed Adegoke and tried to conceal the situation.

The court pointed out that the circumstantial evidence available to the court, pointed to the killing of Adegoke while being a guest at the hotel owned by Adedoyin.

Justice Ojo declared that Dr Adedoyin's decision not to enter the witness box did not help him, as the circumstantial evidence had shifted the burden of proof on him.

The Chief Judge of Osun State noted that Adedoyin's

Sodomy and the Society

WO days ago, I watched transfixed by horror as one woman narrated in a Hausa television station the story of how one man sexually abused her young son, Hassan.

The woman who is a food seller, said the man didn't show any remorse; in fact, he pretended he didn't know the boy. The man also abused her son's friend, Hussaini, whom he would call and give something like sweet to take near tea café (mai shayi).

"It is believed that sexual abuse of minors or child molesters have always been around but they carried on because people were afraid to challenge them by raising the issue. They were afraid of stigma or they buried it if the molester was a family member, or if the molester was from a wealthy family or an influential member of the community."

When the man was brought in a car to the area and one of the boys was asked to identify him, the boy started crying that they should not allow the man to get down because he said he would kill him if he told anybody what he was doing to him.

In any event, after threats from the man and his friends or hangers on, the woman prevailed and the case is now in court.

However, what would cause you to have goose bumps was when the boy also narrated his ordeal. His face was blurred to protect him. He appeared to be about ten years old.

According to the woman, Hussaini's mother refused to seek justice, saying she has left him to God. "I urged her but she refused," she said.

This is a very sad and disturbing story. In fact, there were some graphic details that indicated the man might be sexually abusing these children for ritual purposes, such as to get rich as those engaged in this despicable act are suspected of doing.

The story exposes the rot in our society where there is a cover-up of a well-known child abuser.

If you are poor and don't have influence, you would be threatened and intimidated to drop the case and let bygone be bygone.

Where the man used to go and call Hussaini and give him sweet should have raised suspicion. A man who is not related to a small boy to always be calling him aside and give him something to eat is not right, after all, what is his business with a small boy?

But as usual, people look the other way, maybe innocently, but some may be aware of the man's habit and chose to keep quiet.

There are many such cases you hear now and then, but it is time such offenders are severely dealt with to send a strong message that their behaviour would not be condoned.

It is believed that sexual abuse of minors or child molesters have always been around but they carried on because people were afraid to challenge them by raising the issue. They were afraid of stigma or they buried it if the molester was a family member, or if the molester was from a wealthy family or an influential member of the community.

Even in those days, it was however believed only girls were sexually abused, not boys!

Days were when young mothers were warned to protect their small daughters from such abuse, but now it must include young sons as well.

Imagine all those small almajirai roaming about. They can fall into the hands of such child molesters and their lives may never be the same again. And their parents sent them to Qur'anic schools far away from home, where young girls would never be sent, as they cannot be exposed like that and they need to be protected. Well, the young boys have become vulnerable too.

"It takes courage and determination for Hassan's mother to seek redress for her son against a powerful man. If the offender is sent to prison, it may also make Hassan feel that he has some hope in the society, that the society has not completely abandoned him."

Due to more awareness, people are reporting such cases now. They are encouraged that keeping silence would make the offenders go on committing the offence, blissful in the knowledge that people would rather die than report the abuse because of stigma and so on.

Human right groups take such cases to help the vulnerable people to seek justice. The way the media report the cases where the offenders are made known to the public also helps.

In folklore and in a bygone era when traditional rulers held sway, offenders of some crimes were banished from the community. Nobody can banish anybody now; however such molesters should be kept in prison as an official 'banishment' from decent society.

How about Hassan and Hussaini who were abused and introduced to this horrific aberration early in life? How would they see life, how would they view other men? How would they view the society that doesn't protect them?

It takes courage and determination for Hassan's mother to seek redress for her son against a powerful man. If the offender is sent to prison, it may also make Hassan feel that he has some hope in the society, that the society has not completely abandoned him.

In this regard both small girls and boys should be diligently watched over. You cannot be too careful.

Flagrant Abuse Of Office By Renegade NDLEA Operatives In Kaduna

ood morning members of the Press. We have been reluctant to toe this line, but when all peaceful avenues have been exhausted, we are left with no option but to address you, hoping that as the Fourth Estate of the realm, you will help us inform the nation about our despair and anguish.

We are specifically referring to the abduction, dehumanization and the subsequent illegal detention of our brother, Abubakar Shuaibu.

This brazen display of criminality and irresponsibility started early this month when my brother Abubakar Shuaibu received a text message from an NDLEA junior operative by name Fahad Marwa on the 13th of May 2023.

The text reads: "Doctor is Fahad Marwa please call me very important". The text was received at 6:22pm on that fateful day. Abubakar Shuaibu and

Fahad Marwa, along with Suleiman Marwa eventually met and they told him that they had codeine worth N50,000 for sale, if his friend, Jonathan Emmanuel popularly known as Jesse (currently on the run) was interested.

This face-off finally led to a physical brawl between Abubakar Shuaibu and the Marwa brothers, alongside Jesse and their friends in the military.

The fight unfortunately resulted in serious injuries for Suleiman Marwa. Few days after, Abubakar Shuaibu was persuaded to go and apologise to the mother of Suleiman Marwa at their residence at Zuba Close, Shooting Range.

As soon as he entered the house, Suleiman Marwa's brothers swooped on him and inflicted serious injuries on him.

Despite this turn of event, our elder brother Ismail Shuaibu and I visited Suleiman Marwa in the hospital Amal hospital located at Kinkinau, Tudun Wada where he was receiving treatment.

Most importantly gentlemen of the Press, the medical bills incurred by Suleiman Marwa was settled by one of the parents of the boys involved in the fight. Ismail Shuaibu also led one of our uncles to the Suleiman Marwa's residence and once again, apologised to the mother.

Gentlemen of the press, these youths have been friends for years and their attempt to arrest Jesse or extort money from him was not authorised by their organization as far as we are concerned.

In the course of the fight between Suleiman Marwa, Fahad Marwa and my brother Abubakar Shuaibu along with his friends, our Nissan Frontier vehicle was damaged; all four tyres were punctured with knives and the car body massively dented.

We all thought that bitter lessons have been learnt by all those involved in the fracas.

Unfortunately, on Saturday 27th May, 2023 at about 6:20 pm, our brother Abubakar went out to buy bread, and their so-called NDLEA operatives especially Fahad Marwa and Suleiman Marwa organized mobs, since they could not face him physically and launched physical

assault on him.

In addition to that, they abducted him and hid him at the family house of the chairman NDLEA, Brig. Gen. Buba Marwa at Zuba close, Shooting Range.

Our brother, Abubakar Shuaibu was severely brutalized by these thugs masquerading as NDLEA operatives in the presence of their biological mother.

It should also be noted that Ishaku Marwa, one of the Marwa brothers personally barricaded the gates purposely to stop any possible form of help from godly neighbours.

After inflicting injuries on him, they invited their brother, Musa Marwa also known as Kawu, another NDLEA operative attached to the Special Patrol. Kawu illegally took him to the NDLEA office at Katuru road and detained him. Thereafter, Kawu ordered the seizure of Abubakar Shuaibu's two phones where he left them for safekeeping as at when he was maliciously attacked; an infinix Note20i and an iPhone XR from a shop known as "container" located at Shooting Range. All efforts to secure his release were thwarted by Kawu and other NDLEA operatives, who claimed they were acting on the orders of the State NDLEA commander.

We are indeed perplexed that in today's democratic order, a security operative acting illegally (not on official duties) could harass, intimidate, brutalize, abduct and detained a citizen of the Federal Republic of Nigeria.

We are appealing to all true mothers, brothers and parents to come to our aid and expose the atrocious crimes being committed by these outlaws hiding under the canopy of the respected and indefatigable chairman of the NDLEA, Brig. Gen. Buba Marwa. We call on the Gen. to rein in these characters before they shatter his hard-earned reputations and achievements. We are also calling on the Human Right Commission and other Human Right Organizations to rally round us and other oppressed citizens of Kaduna State and Nigeria.

It was yet to be ascertained what could have informed the irrational act of the attackers as at time of filing the report.


Following a distress call, it was learnt that officials of the Lagos State Fire and Safety Service mobilised to the scene to put off the inferno.

His legacy will live on through the impact he made on the lives of many," the statement noted.


Blessing Nigeria tremendously was purely designed for purposes and reasons best known to Him.


