

Arewa Youth Forum Condemns Fresh Petrol Price Increase Says palliatives management shouldn't end up like past govts

frontline group from the North, Arewa Youth Forum (AYF) has advised President Bola Ahmed Tinubu to ensure his palliatives aimed at cushioning the effect of fuel subsidy removal, reaches the right people, while condemning the increase in pump price of Premium Motor Spirit (PMS), popularly known as petrol.

AYF expressed this in a

statement signed by its National President, Comrade Ahmed Mohammed Zagi, made available to newsmen in Kadunà on Tuesday July 18,2023.

"We are becoming concerned with the controversy the planned palliatives of the Federal Government following petroleum subsidy removal is getting, only to receive a shock today, with the increase of price of petrol to over N600.

Customs Impounds 31 Firearms, Assorted Ammunition, Cartridges Within Two Weeks

he acting Comptroller General of the Nigeria Customs Service (NCS) Adewale Adeniyi has disclosed that a total number of 31 firearms have been intercepted within the first two weeks of July 2023.

Similarly, assorted ammunition, cartridges of various brands were recovered during the period in review.

A deniyi, who made the disclosure at a press briefing at the headquarters of the Federal Operations Unit (FOU) Zone "A"Ikeja on Monday, attributed the success to the re-strategisation of operations and keying into the matra of renewed hope aimed at facilitating legitimate trade by officer and men of the Customs.

He stated that some of the recoveries were made during a joint operation in collaboration with the Nigeria Police, the Department of State Security, the National Drug Law Enforcement and Administration, and the Customs Intelligence Unit at the Ports.

While giving a breakdown of the interception, the Customs Boss hinted that ":On the 5th of July 2023, during a joint operation with the Nigeria Police, the Department of State Security, the National Drug Law Enforcement and Administration, and the Customs Intelligence Unit at the Ports Terminal and Multi Services Limited Command, a thorough physical examination of a 40ft container was conducted.

"The examination revealed the concealment of 10 dangerous arms and various rounds of live ammunition inside plastic drums.

" The details are: (a) 3 new Pump Action rifles and one new unit of

an armed rifle (b.) 6 new different makes of pistols.

 Onenew millennium G2 pistol.
 Onenew sarsilmaz SAR-9X pistol.

(3) One new Lugger Security-9 pistol.

(4) One new Taurus Banbridge G3C pistol.

(5) One new SCCY CPX-2 pistol, and

(6) One new Taurus (63 pistol)c. 14 empty

live ammunition". Adeniyi added that

two suspects identified as Mr. Shokunbi Olanrewaju, a clearing agent with

Shooler Global International Ltd and Mr Joseph Nwadiodor, who was expected to take delivery of the container, are currently detained in connection with the seizure.

"Similarly, within the same period, the Tincan Island Port Command of the Service, while acting on credible intelligence; a 1x40ft container was also subjected to 100% physical examination with the relevant security agencies at the ports.

" The physical examination uncovered 18 arms, packets of cartridges and rounds of live ammunition inside plastic drums. The details are: (a.) 6 different makes of pistols

(1) Two (2) Sar9 Sarsilmarz Pistols

(2) One (1) Ruger American Pistol And

(3) Three (3) Taurus G3c – Bainbridge Pistols).

Speaking further, he said, " Again, during a routine patrol along Owode/Ajilete Axis of Ogun State by officers of the Joint Border Patrol Team Sector 2, on Wednesday 12 July 2023, intercepted an unregistered Toyota Camry loaded with six sacks of charcoal, which was used to conceal three (3) pump action riffles with 174 live cartridges.

" The driver of the vehicle, who knew the content he was conveying vis-a-vis the attendant consequences of his action before the law; jumped into the bush and escaped arrest.

":In summary, a total of thirtyone (31) rifles were intercepted within the first two weeks of July 2023".

The Acting Comptroller General of Customs hinted that investigation into the seizures is inconclusive, adding that the outcome of the investigations together with the seizures will be handed over to the appropriate authorities for further investigation and prosecution.

He emphasised that the Illicit arms obtained by non-state actors have boosted the proliferation of small arms and ammunition across the country.

According to him, this accounts for the increase in violent kidnappings, robberies, and mass killings in society.

"Let me state at this point that the Service has re-strategized its operations, while our officers have raised their levels of professionalism, and have keyed into the mantra of renewed hope aimed at facilitating legitimate trade. In doing this, we are assuring all compliant traders and importers that they have nothing to fear.

"We have re-injected new tactics to tackle the economic and security menace caused by recalcitrant importers and their agents. The Service's human resources and logistics are collectively harnessed to combat and prevent economic sabotage", the Customs Boss stressed.

Adeniyi however implored importers and agents to be patriotic by making sincere declarations, and to be properly guided by the import/export prohibition lists. I

The CGC also urged the public to see security as a collective responsibility, just as he added that the agency will appreciate information of illegal importation and cross border movement of dangerous weapons used to create mayhem in the country.

he Permanent Secretary, Oyo . State Ministry of Education, Science and Technology, Mr. Adeniyi Olusanjo on Monday, hinted that the remaining over 1.5 million out-ofschool students in the state are to be mopped up and brought back to school

Mr Olusanjo dropped the hint while speaking at the opening of a two-day training programme for School-Based Management Committee (SBMC) on Community-Driven Development Approach held at Lagelu Grammar School's Hall in Ibadan

He disclosed that the over 1.5million remnants of the out-of-school students absorbed into various public schools under the 2017 to 2022 Better Education Service Delivery for All (BESDA), will be mopped up and brought back to the classrooms under the BESDA-Additional Funding

By; BAYO AKAMO, (AF)-Transforming Education System at State level (TESS) programme.

The Permanent Secretary maintained that the BESDA-AF-TESS project " is aimed at reducing out-of-school students through physical infrastructural project and training of teachers for improved teaching practices and learning outcomes". Mr Olusanjo pointed out that the programme was targeting mopping up the remaining 1.5million out-of-school students after those that have been successfully returned to classrooms under the BESDA within 2017 and 2022, adding that the State enjoyed the privilege of been selected by the Federal government and donor agencies like the World Bank and GPE because of the success achieved by the State under the BESDA programme. He stated that the

1.5 million figure covered students from far and neighboring States and countries that have come to Oyo State to to enjoy the State's free education policy.

"The TESS programme we are starting now is targeting mopping up the remaining 1.5million pupils that have been identified to have taken residence in Oyo State from far and neighboring States and even beyond the borders of Nigeria, due to the benefits derivable from the State's free education system", he said.

The Permanent Secretary added, "Having noticed the success of BESDA within 2017 to 2022 in Oyo State, the World Bank, federal government and GPE decided to pick Oyo State, Adamawa State and Katsina State for the new project, which is to deliver the needed equitable access to outof-school children in Oyo State."

Speaking , Oyo State Coordinator of BESDA-AF-TESS, Dr. Bamidele Odekunle declared that the roles of the SchoolBased Management Committee was very germane to the success of the new project.

He stressed that the training, superintendent by the Oyo State Community and Social Development Agency (OYCSDA), was to prepare t h e representatives of the benefiting SBMCs for the work ahead, urging participants to note all the aspects of the training so as to have a seamless implementation.

Members of the School-Based Management Committee (SBMC) include School Heads, representatives of teachers, males and females representatives of pupils, males and females representatives of traditional leaders, old pupils and students, Parents, Teachers Association (PTA) representatives, Youths representatives, artizans, community-based organizations, c o m m u n i t y representatives and faithbased organizations.



Police Testifies How Zaria Veterinary Drugs Supplier Aids Kidnapping

By; SANIALIYU, Zaria olice Investigative Officer (IPO) narrated to Kaduna State High Court sitting at Dogarawa, Zaria, how Idris Mustapha (a.k.a Idi Mai-Zomo) was arrested in connection with alleged kidnapping at Zaria.

Inspector Abu Isa of Criminal Investigations Department (CID), Kaduna State Police Command testified as Prosecution witness number three (PW 3) in the case filed by the state against Idris Mustapha, (a.k.a Idi Maizomo) and Isah Ibrahim.

Earlier, counsel for the prosecution, Dari Bayero, told the court that the case was slated for continuation for hearing and their remaining witnesses were ready.

Bayero who is the Solicitor-General of Kaduna State, led Insp. Abu Isa who told the court that prior to Oct. 11, 2021, he was attached to the Force Intelligence Bureau. He added that the bureau was handling cases of kidnapping, armed robbery and banditry.

Isa said a suspect, Umar Adamu was arrested on October 11, 2021 in connection with a case of kidnapping which occurred at the National Leprosy and Tuberculosis Training Centre, Saye Zaria.

He said the suspect, Umar Adamu mentioned the name of Idris Mustapha as a veterinary drugs and logistics supplier to their gang leader, Isah Ibrahim (a.k.a. Isa Gudale or Isa Dan-Wasa).

"We arrested Mustapha on Oct. 11, 2021 and brought

him with information of potential targets for kidnapping, where he (Mustapha) obliged," the witness said.

The witness added that the defendant told the police that he took gang leader to the house of Auwal Mohammed (popularly known as Auwal Custom) at Nagoyi area and two other farms in Zaria.

He added that the said gang leader came with other members and kidnapped four people at the house of Auwal Mohammed.

The prosecution counsel, Dari Bayero applied to tender the statement of the defendant before court and the defense, Baba Mohammed opposed application on the grounds that the statement was obtained under duress.

The prosecution said Section 37 subsection 7 of the Kaduna State Administration of Criminal Justice Law 2017 allows the judge to take note of the opposition and rule at the hearing.

The defense counsel again, said Sections 29 subsection 1 and 2 subparagraphs A and B Section 29 subsection 3 of the Evidence Act provide for trial within trial to prove the allegation coercion.

The Presiding Judge, Justice Abdulkadir-Sabo Mahmud, of High Court No. 3 adjourned the matter to Oct. 2, for trial within trial.

It would be recalled that Idris Mustapha, a.k.a Idi Mai Zomo, and Isah Ibrahim are standing trial for two count charges, bothering on kidnapping.

The defendants were accused of kidnapping Ibrahim Yakubu, Yusha'u Sani, Abdallah Mohammed-Awwal (aged 5 years) and Aisha Mohammed-Awwal (aged two and half years), all residents of Nagoyi area in Zaria Local Government Area on Jan. 28, 2021. The defendants were also accused of collecting N14 million ransom before the release of their victims. The offence contravenes sections 247(1) and 246(c)of Kaduna State Penal Code Law No.5 of 2017.

narchy is currently looming at the Abuja Market Management Limited (AMML), one of revenue generating agencies of the Federal Capital Territory Administration (FCTA) as sacked Managing Director, Alhaji Abubakar Faruk stormed his former office with the backing of the Police and locked out the new acting Managing Director, Engr. Abbas Yakubu.

It would be recalled that the embattled former managing Director, Alhaji Abubakar Faruk, was allegedly suspended by the immediate past FCT Minister, Malam Muhammad Bello, but he subtly obtained a restraining Court order and has been allegedly scheming to retain his appointment with the help of some Northern oligarchy.

It was gathered that his argument was predicated on the fact that his appointment letter was not tenured and therefore, cannot be removed unceremoniously from office.

This argument was said to have been sustained by him, because of some vested interest that have empowered him over the years.

Notwithstanding this facts, Faruk's employment was terminated by Mr. Abubakar Maina on behalf of the AMML's shareholders vide a letter dated July 17 and signed (AICL) the supervising agency over AMML.

Trouble ensued on Tuesday Morning when the sacked Faruk stormed AMML's office, located in Gudu District of Abuja, with some Police officers and locked the MD's office, insisting that nobody will access it and take possession of same. It was also learnt that following the chaos created by such anachronistic action, the staff members have remained apprehensive, not knowing what fate will befall them.

Staff members of AMML also complained that the officers that came with the sacked MD, harrased and c r e a t e d s e r i o u s psychological trauma for them.

While authority of the Federal Capital Territory Administration (FCTA) are yet to comment over the abnormalities, the management staff of A M M L have been summoned to Durumi Police station, where the issue is trying to be resolved.

Confirming the unfortunate incident, AMML's Public Relations Officer, Innocent Amechina said, " he locked his own office. Yesterday the shareholders of AMML decided to relief him of his job as the MD and it was made known to everybody. But surprisingly, that resolution was supposed to take effect from today, he came with four policemen, locked his office and also changed the lock.

Zulum Provides Temporary Site For Take Off-of FCE Gwoza

By; SADIQABUBAKAR, Maiduguri Borno State Governor, Babagana Umara Zulum has granted approval for the use of a Government Secondary School as temporary site for the take-off of a newly established Federal College of Education (FCE) Gwoza.

Zulum gave the approval during an assessment visit to the temporary site, located along Gwoza-Mubi highway in

Gwoza town.

The site is at Vile, a community in Gwoza town, Headquarters of Gwoza Local Government Area.

The new school is the first of its kind in the state and a Federal College of Education since the state was created in 1976.

It would be recalled that most of the 36 states and the FCT each has federal University, federal polytechnic and federal college of education but Borno State had been without a Federal Polytechnic and Federal College of Education until they were established by the Buhari administration.

Zulum who has similarly facilitated the take off of a Federal Polytechnic sited in Monguno town, Monguno LGA of the state before doing same for the Federal College of Education in Vile, Gwoza.

The governor during his trip to Gwoza on Saturday, gave a directive for the immediate rehabilitation of the GSS Vile to serve as the temporary site of the Federal College of Education to commence operations.

It would be recalled also that Zulum's administration is known for complementing the efforts of the Federal Government through provision of facilities as necessary requirements for the take off of federal institutions to function effectively in Borno State.

The political lifestyle of Boss is more of a party man. Over the years, he has been a man with a strong fraternity to party politics.


He is one Nigerian who defined his brand of politics within the context of political party affinity. Once he discovers himself in one, he dies by its principles and its ideologies.

he Council of Arewa Chiefs, Lagos State, has called for the immediate and unconditional release of Sarkin Hausawa of Lagos and Chairman of the Council of Chiefs, Alhaji Aminu Idris Yaro with his wife by the Department of State Services (DSS) describing the detention "an unlawful detention".

The council noted that he be granted immediate access to legal representation, medical attention and family members, saying that in the alternative, present him for cognizance by a competent court of law in accordance with the provisions that invalidate the indefinite detention of persons without trial.

A statement issued and made available to New Nigerian in Kaduna on Monday by the Yerima Shettima, the Jarman Lagos, said, "Traditional rulers will first need to be accorded commensurate respect, their emasculation, maltreatment and harassment has to be ended and

their revered place of respect assured before we can place any hope in them to do anything meaningful in the community." It added that while the Council of Arewa Chiefs is very much aware of the obligations on every Nigerian to assist government agencies and institutions in the all-important fight against corruption within the laws of the land, and in building a nation united around the values of justice and honest enterprise, it nevertheless shall remain firm in the belief that security agencies are as much deserving of respect in the same manner the traditional institutions demand to be respected.

According to the statement, the Council of Arewa Chiefs and Arewa Community in the South-West as well as every decent Nigerian and institution in Nigeria can without a doubt attest to the Sarkin Hausawa's credibility, leadership, sacrifice, statesmanship, patriotism and unwavering commitment to the interests of the people of Northern Nigerian in the South, and citizens of Nigeria as whole, stressing that he is as well known never to lower the bar where the interests of the North, the unity and security of Nigeria, or the welfare of all citizens are involved.

The Council said it was concerned that the DSS might typically be used to hunt down respected leaders of community using terrorism fight as smoke screen, stressing that it does not dispute the prerogative of the DSS and any security service in the country to invite any person it deems useful for any of its investigations, but found the detention of the Sarkin Hausawa incommunicado and beyond the lawfully allowed 24 hours by the DSS, repugnant to the sensibilities of the traditional rulership system, the Arewa community and the Council of Chiefs.

A i d a m e n b o r s a i d Investigation into the incident began when one Mr. Oluwole, a car dealer alleged that the sum of One Million, Five Hundred Thousand naira paid into his United Bank of Africa (UBA) account was stolen by cyber criminals overnight.

"A forensic analysis of the UBA statement of account of Mr Oluwole revealed a certain Palmpay account EL-SAEED YUSUF 9133771898 received a sum of N200,000 from the N1,500,000 stolen from the account of Mr Oluwole and the balance sum used for online purchases

"Zenith bank account, SAMPSON ONYENEBE received the entire $\aleph 200,000$ from the Palmpay account of EL-SAEED YUSUF while another account, JOHN Y O B G D A D D 7 0 2 5 1 2 8 5 7 4 a t FIRSTMONIE equally received other sum from EL-SAEED YUSUF Palmpay account"

"Sampson Onyenebe who was arrested in Owerri, Imo state claimed that he met Maxwell Lakoju aka Ifa Dollar on Facebook in 2022 and they discussed and agreed on how Maxwell would assist him with metaphysical power for wealth"

" A m o n g o t h e r requirements for the process, Sampson Onyenebe paid several thousands of naira through an account belonging to David Adejumo and he also handed over Automated Teller Machine (ATM) c ards, Personal Identification Numbers (PINs) of about Eight (8) bank accounts belonging to himself and his wife to Maxwell"

"The arrest of David Adejumo led to the arrest of Maxwell Lakoju in Auchi, Edo State. Both suspects confessed to obtaining the bank accounts and its details including the ATM cards by courier from Sampson and his wife"

Hajj: Saudi Arabia Deserves Praise, Not Condemnation - IHR

ndependent Hajj Reporters (IHR) has said that it is aware of the challenges faced in this year's Hajj exercise, owing to recent change of policy by Saudi Arabian authorities regarding service provision to the guests of AR Rahman.

These challenges raised a lot of issues by Hajj participating countries which were widely reported by the media, but IHR in a statement signed by its national coordinator, Ibrahim Muhammed said, "It is sacrosanct that pilgrims deserve to be served commensurate to services paid for.

"However, serving over 2.3 million pilgrims by p r o v i d i n g a c c o m m o d a t i o n, transportation, feeding, medical services and guidance in the same place, at the same time r e q u i r e s m u l t i departmental support and c o per ation of all concerned.

The statement also said that most Hajj participating countries have blamed Saudi based services providers for the epileptic services rendered this year especially during the five days stay at Mashaer. "While, we acknowledge the grievances, we must also acknowledge that the Kingdom of Saudi Arabia deserves commendation for her efforts in catering for increased demands of providing basic services for pilgrims all year round. "Every year, officials at the Kingdom under the able leadership of the Custodian of the Two Holy Mosques, King Salman Bn Abdulaziz and the Crown Prince and Prime Minister, Mohammed Bn Salman, put on their thinking caps and design policies that will make Hajj better than previous years'.

"They always undertake review of the immediate past Hajj operation and identify all areas of challenges and then come up with policies that will address these challenges, that is why countries witness new policies almost every year, it is aimed at making the Hajj easier and better for the guests of Allah.

"5- to 10 per cent service failure does not amount to total failure deserving of complete condemnation," IHR said. More importantly, the Kingdom indirectly admitted this year's operational lapses when for the first time, the Minister of Hajj and Umrah released the 2024 hajj calendar of event a week after 2023 hajj subjecting the allotment of tents to first to be ready basis.

The CSO also said there is probably no country in the world that can do what the Saudis are doing regarding the running of Hajj and Umrah, adding "We ask Allah SWT to continue to bless them and give them more wisdom and energy to continue serving his guests in the best way possible. "Finally, we wish to recommend that authorities in the Kingdom consider carrying along Hajj participating countries while planning for upcoming Hajj operations. "The suspect was said to have dashed inside the room only to come out with a hot water kettle and poured it on Endurance's body.

"The victim tried to run away from the suspect, but he was dragged into the house while Esther poured the whole hot



water on her"

"The victim was immediately rushed to the Health centre in the town but later referred to General Hospital, Alade Idanre, where she is still receiving treatment"

Narrating her nerve-racking ordeal, Endurance explained that though she usually works on the suspect husband's farm, said there was nothing between them than a master and labourer relationship, saying "no strings attached"

She explained, "Esther called me from where I was learning tailoring to come and collect the palm oil her husband is owing me because I also work as a labourer for some farmers in the town.

" I rushed out of my oga's shop excitedly to the place, not knowing that the call was just to lure me to her own shop where she was selling food, to pour hot water on me for the offence I did not commit,"

It was, however, gathered that police from the state command arrested Esther, who is said to be nursing a month-old baby, and subsequently charged before the Magistrate court in Idanre and was remanded at the female correctional centre, Surulere, Ondo, till July 17, 2023.

On his part, the husband of the suspect, Sunday Godwin, who denied having any affair with Endurance, said he only engaged her as a farmhand on his farm.

He added "i was surprised with this development, and I have been paying for the victim's treatment at the hospital since the incident happened."

Tension As Niger Delta Ex-agitators Warned Ndiomu, Reject Incessant Disappearance Of MacIver's Name On PAP Database

here is palpable tension in the Niger Delta region as the Chairman of the Niger Delta First Phase Exagitators' Leadership Forum, Bayelsa State Chapter, High Chief. Charles Kurobo, has raised the alarm that the Presidential Amnesty Programme (PAP), has delisted the running mate to the candidate of the All Progressives Congress (APC) in Bayelsa State from its payroll.

According to him, the investigation of the forum revealed that the Interim Administrator of the PAP, Gen. Barry Ndiomu (rtd), without any reasonable course directed that all the entitlements of the APC Guber running mate, Great Joshua MacIver, who was the first to embrace the amnesty

program with over 200 followers, should be withdrawn. Several attempts to reach the amnesty office for comments proved abortive at the time of filling this report, however, the ex-agitators have said that they may be forced to resort to extreme measures to resolving the anomalies since efforts to make the PAP boss see reasons with them has continued to fall on deaf ears.

The group said that the height of the controversy is when the PAP claimed that Great Maciver, a major critical stakeholder of the first phase ex-agitators who surrendered arms alongside his foot soldiers numbering well above 200 from his own personal and have remained camp beneficiaries of the programme with their ID Card numbers and monthly stipends is no longer part of the programme.

The statement that was issued in Yenagoa by Kurobo read "sequel to appeals and complains concerning the style and gross lack of integrity of the Presidential Amnesty Program (PAP) office under the current administrator, we are writing to notify the National Security Adviser (NSA) of the lingering controversies between the office and its beneficiaries.

Palliatives: As NASS Gets N70bn, Poor Masses N12bn, What About NYSC Corps?

s hunger is crushing Nigerians to death and t h e F e d e r a l Government is implementing the sharing formula of the N819bn supplementary budget for palliatives, Nigerians groan as National Assembly (NASS) takes the lion share of the money, while 12 million Nigerians get N8,000 for six months.

The prizes of foodstuff soar and people suffer after the subsidy removal, youth corps members posted to various states to serve the country are suffocating of hunger as N33,000 cannot afford their transportation and feeding with the current inflation index.

While NASS is sharing the palliative money, nothing is said about the welfare of youth corps members that dedicate their strength and vigour to serve the nation. 400,000 youth corps members are annually posted to various states to serve the people and the nation, hence as unemployed, need succour at this time of economic hardship to survive, and their situation should be considered.

Even in a response to the sharing formula of the 12 billion Naira by the National Social Safety Nets Coordinating Office (NASSCO), there was no mention of corps members among the beneficiaries of the palliatives.

Despite the fact, not only the youth corps members face the hardship of the time, the masses do, as the present hunger hunts Nigerians.

How painful could this be, when a father is crowded by his wife and three children, the second child of three years old said to the father, "Daddy I am hungry, I need food ... I will die of hunger." And the helpless father bursted into tears, without mincing words, sluggishly and staggering, went outside the room crying profusely like a baby? That was a true story. For a bitter truth; Nigerians are living a hellish life, they helplessly watch their loved ones dying of diseases because of poverty and hunger, amidst the subsidy removal.



Many families, even children of tender age eat only once a day. Poverty has taken over the affairs of Nigerians as we surrender to its wickedness. Nothing is easy and cheaply accessible in Nigeria, life has become unbearable and very expensive, that only less than a quarter of the population can Food prizes have skyrocketed and nothing is cheaply affordable to satisfy the venomous hunger. One can wonder how the price of sweet potato become unbearable. A portion of N200 after two months is now N1,000, maize flour jacked to N1,000. In fact all food items have jacked up and the prizes are soaring. Hunger has destroyed hope, ambitions have become empty and Nigerians' visions lies on survival. Poverty becomes the devil among the saints, while poverty gives birth to crime and criminal life is becoming tougher and suffocating. How can maximum security be achieved in the peak of banditry, kidnapping and insurgency? Subsidy removal, even though good for Nigeria, the effect is devastating because no premeasures were taken to address the post challenges.

poverty, others cannot eat three meals a day, National Assembly members didn't opt to sacrifice anything for Nigeria's development amidst the fuel subsidy hardship.

In less than two months the 469 National Assembly members proposed 140% salary, 70 billion Naira palliative, proposed N40bn for cars, N24bn for accommodation, N110bn allowances for wardrobe, newspapers, kitchen, domestic staff and travelling for themselves. Even though NASS got N328.1bn in the 2023 budget and collects the highest salary than all government workers in Nigeria, they always seek and ask for more. While the 469 National Assembly members are voted to represent the voters, they argue most about their interests and represent themselves than the citizens. But, if the National Assembly

members and the President should prioritize the voters' interests and work accordingly, there will be no: political thuggery, political dogs, political beggars, political warfare and venomous hunger in the land. But, unfortunately, politicians can do anything to get power for unlimited

afford the conditions. Only few are exceptional from the heat of the moment, after the subsidy removal, civil servants have become the true servants of hunger, marketers and traders are eating from their capital. Almost, all Nigerians are living a deficit life. Inflation is trending, while schools have become expensive for students to bear. People now give collateral of their goods, items and working tools to collect food for their families. Marriage have become flexible because of poverty and hunger among loving couples.

While Nigerians are in abject

Aboru, Aboye: Attacks on Africa's Highly Tolerant Traditional Religion

HE firestorm among some Christian leaders in Western Nigeria over the lyrics of a new song by Gospel artist, Tope Alabi, is in its fourth week.

She had sang in Yoruba that she is "Aboru Aboye" which translates to "I am a sacrifice which God has accepted." This caused an uproar with some Christian leaders accusing her of introducing traditional religion idolatry into Christianity. They claimed that 'Aboru Aboye' is the language of Ifa priests, so she is promoting indigenous religion to the detriment of Christianity.

"Those sitting in judgement over Tope Alabi, and she sitting in judgement over others, remind me of the admonition in the Gospel of Matthew: "Do not judge, or you too will be judged. For in the same way you judge others, you will be judged, and with the measure you use, it will be measured to you. Why do you look at the speck of sawdust in your brother's eye and pay no attention to the log in your own eye...You hypocrite, first take the log out of your own eye, and then you will see clearly to take the speck out of your brother's eye."

The charge is led by Funmi Aragbaye, Chairman of the Board of Trustees of the Gospel Musicians Association of Nigeria (GOMAN), who in finding Alabi guilty of heresy declared: "Tope Alabi believes she is above everyone and God... She doesn't belong to anyone; she is neither here nor there. The current state of the country is why many act the way they do. People take God for granted for being so merciful. Many people today are just worshipping God with their mouths; it doesn't come from their hearts."

Aragbaye, popular for her 1990's hit: 'Mo Gbo Ipe Olorun (Divine Call) added: "Most people preaching do not know what they are preaching about. They emerged from nowhere onto the scene."

the basic knowledge that all peoples have their own cultures and religions. So, when new religions come or rise, they usually borrow from the local language. For instance, the Hebrews called God Yahweh, Elohim, Adonai, Tzevaot, Shaddai, while the Romans Latinised Yahweh as Jehovah. All these have found their way into Christianity. The Izon call God 'Oyin', among other names. The Hausas call Him Ubangiji, while the Igbo call him Chineke

(Creator of the Universe), Chukwu or Olisa.

The Yorubas call the Almighty by various indigenous names but the most popular being Olorun (Owner of the universe) and Olodumare. Odu, means pot and mare means inexhaustible. Noted philosopher, Professor Sophie Oluwole, explained that Olodumare, which Yorubas irrespective of religious inclinations call God, literally means: "the man who has the pot that is not exhaustible. In English, it means Almighty; everything is within it."

So, why would the religious leaders who condemn Alabi, accept Olodumare but reject Aboru Aboye when it is the same Yoruba language?

Ironically, Evangelist Tope Alabi is no different from her traducers; she is no less a fanatic. When in 2021, rising gospel artist, Adeyinka Alaseyori, released a hit song: 'Oniduro Mi', meaning that the Almighty is my Guarantor who never fails, Tope Alabi roundly condemned her for alleged unChristian conduct.

In claiming divine inspiration, Alabi

Explaining the tenets of her religion, she said: "God has shown each individual what they will do to succeed and enter paradise...God knows the heart of every human being and it depends on your mind and communication with your Creator. I know that God answers prayers; it depends on how you pray to Him."

In this, she is showing a deep understanding of faith, tolerance, a high sense of civility and gumption, and a superiority of position. As the Yorubas say: your character is what portrays your religion.

While some religious adherents try to impose their faith on other people and even incinerate human beings for alleged religious infractions, others show good examples. Perhaps the most tolerant and even-handed political leader in the country today is the immediate past Minister of Interior, Ogbeni Rauf Aregbesola. In his eight years as Osun State Governor, he elevated the indigenous religion to the same pedestal as Islam and Christianity. At state functions, prayers were offered in the three religions, and he attended the main indigenous religious festivals in the state, including the Osun-Oshogbo, the Iwude Ijesha and the Olojo Festival in Ile-Ife. His administration also introduced a public holiday, the 'Isese Day' for adherents of indigenous religion. So, we do not lack good examples. Like Chinua Achebe wrote in Things Fall Apart: "You will have what is good for you and I will have what is good for me. Let the kite perch and let the eagle perch too. If one says no to the other, let his wing break."

General Superintendent, Apostle Adeboye Ajakaiye of the Cherubim and Seraphim Church, also joined the fray: "I know the devil twists the things of God for his own use... These days, you can't distinguish a Christian from the world in all ways, from dressing, talking, use of worldly vibes in Christian songs, dancing, etc." Tope Alabi has in the last few days risen to her own defence that Yoruba language is used by people of all faith. Just as Hosea said: "My people perish

from lack of knowledge" (Hosea 4:6), so are those attacking Alabi lacking in

attacked the young artist: "God is

beyond being a guarantor to Man...when we receive heavenly inspiration to sing, there are some deliberations we must have with the Holy Spirit before we can bring out such a song. If we keep singing the gospel just as the Spirit-inspired, there is the possibility that we all will be singing absurdly. As gospel singers, God has given us the brain to digest, chew, and fully comprehend the inspiration given to us before we bring it to life."

Jos-based peace advocacy group, operating as Conference of Plateau State Peace Builders Network (COPPEBN), has hailed the internal military outfit, in Plateau State, Operation Safe Haven (OPSH) for its recent prompt action in quelling what could have been an escalated crisis in the state by neutralizing three notorious bandits.

Flood: Ondo Assembly Calls For Sensitization Of Residents Against illegal Waste Disposal

To this e n d, the Ministry of Environment is summoned to appear before the House on Tuesday, 25th of July, 2023 in order to brief members on its disaster prevention plan for this year".

"Also, we call on government and other relevant stakeholders to take proactive measures on disaster prevention, mitigation, response and rehabilitation of affected citizen".

"The Clerk of the House is mandated to write to Federal Emergency Management Agency (FEMA), State Emergency Management Agency (SEMA) and other relevant stakeholders sensitising them to the plights of affected people and the need to come to their aid".


