Security operatives attached to the INEC headquarters later chased Udeze out of the venue of the meeting and Omoaje who is the authentic national chairman of the Action Alliance took over the seat prepared for the party.

Udeze was said to have breached all security arrangements made ahead of the meeting as he was not cleared by the security

Udeze had been suspended and subsequently expelled from the party by the National Think Thank Committee of the party for various alleged offences.

Reacting to the development, the national chairman of the party, Dr Omoaje hailed the security agents in the matured manner at which the matter was handled.

He warned Udeze to desist from his lawless acts and stop impersonating as a member of the AA or an official of the party, just as he called on all security agencies to put their search light on Udeze henceforth, stressing that he had since seized to be a

Coalition Exonerates Fed Poly Nasarawa Rector Of Abuse Of Office, Corruption **Allegations**

coalition of 52 anti-corruption Lorganizations, operating as Justice and Equity Forum (JEF), has exonerated the rector of the Federal Polytechnic, Nasarawa, Dr. Abdullahi Alhassan Ahmed, over its National President, allegations of corruption Barrister Morgan and abuse of office, leveled Gbadamosi and Secretary, against him by some civil society organizations in recent times.

The group explained that it exonerated the rector after it carried out its independent probe into the activities of the rector in the institution and discovered that he has not done anything contrary to his official mandate.

It said the allegations of enrichment, abuse of office, and primitive acquisition of wealth leveled against the rector were mere imagination of his accusers.

To this end, the group

which gave the rector a clean bill, also passed a vote of confidence on him, "for his pragmatic, accountable, and transparent leadership qualities since he assumed office in the prestigious institution."

In a statement, signed by Dr. Amaka Olisah, the Justice and Equity Forum, called on members of the public to disregard the allegations against the rector as they have been found to lack substance.

JEF said its findings showed that the faceless groups who accused the rector were sponsored by some persons to give him a bad name and also extort money from him.

JEF further called on the EFCC to Investigate and prosecute the fake organization to server as deterrent to others.

Strike: Coalition of CSOs Disagrees With NLC, Says it's Counter Productive

*Want NLC to negotiate with FG instead

Coalition of Civil Society y Organisations on Wednesday, cautioned Nigeria Labour Congress (NLC) against the planned indefinite nationwide strike action in view of the long term gains of fuel subsidy removal by President Bola Ahmed Tinubu-led administration.

In a recent development, NLC gave the Federal Government a seven-day ultimatum to reverse all perceived anti-poor policies, including the recent hike in the pump price of petrol, or face an indefinite nationwide strike from August 2.

Consequently, NLC directed all affiliates to commence mobilisation of workers and civil society allies for a mass protest across Nigeria.

But the Coalition disagree with NLC's decision, saying that any form of nationwide strike by the labour unions now, will not only compound current economic hardship faced by the masses, ,but also be counter productive and a catalyst for impending chaos.

The Coalition of Civil Society Organisations in a statement jointly signed by the Chairman Secretary, Comrade Muhammad Usman Ali and Comrade Markus Bulus, appealed to Nigeria Labour Congress to rather call for an emergency meeting with the Federal Government to discuss and resolve areas of concerns on the issues of fuel subsidy removal and other perceived harsh government policies affecting the Nigerian workers.

The statement further reads, "We believe the Tinubu-led government has demonstrated that it can listen to the plight of labour unions and should the government fail to

meet demands after the meeting, NLC is free to embark on the planned long-lasting strike and mass protest.

"But we want to remind NLC that President Bola Ahmed Tinubu is just 57 days in office as President. With the collosal damages done to economy by previous leaders, which are beyond imagination, he needs some time to correct them.

"On the other hand, we urge NLC to work together with the FG to ensure that monies saved from subsidy removal are monitored and judiciously used to better lots of workers and Nigerians instead threats of strike."

While defending the removal of subsidy, the Coalition asked NLC to consider that removal of subsidy has stopped smuggling of petroleum products; stopped payment of homongous a mount money to fraudulent businessmen and made products available at filling stations.

It also said removal of subsidy will ensure private sector participation in the importation of petroleum products; ensure the ready availability of petrol at all times for all Nigerians with no diversion by marketers and curb the greed for higher profits and sabotage by a few players in the oil industry, which will positively affect the economy.

"We hope that soon the competition in the industry and market forces will drive

down the price of petrol in the long run as witnessed in the telecoms sector for the benefit of Nigerians; permanently banish queues from petrol stations." It added.

However, the Coalition commended President Tinubu for bolds steps taken so far to change the course of governance in the country.

2023 Polls: Mahmud Struggling To Repair Battered Image Of INEC - CUPP

oalition of United Political Parties (CUPP), an umbrella of opposition, has slammed the chairman of the Independent National Electoral Commission (INEC), Professor Mahmud Yakubu, following his admittance that there were glitches in the course of the 2023 general elections

CUPP expressed this in a statement signed by its National Secretary, High Chief Peter Ojonugwa Ameh, made available to our correspondent on Wednesday July 26, 2023. "It is obvious and noticeable how Mahmud is running up and down in an attempt to try to repair the battered image of the commission and by

extension his reputation as well.

"There is total lost of public confidence in the commission so therefore, if the commission goes ahead to conduct a self examination through a non transparent process of reviewing the elections," the statement said.

CUPP warned that if the commission continues with the purported self review process, then it will amount to nothing in the eyes of the general public.

"The commission cannot review itself without the elements of biase, so if Yakubu Mahmoud is interested in reviewing the 2023 general election, the right thing to do is to set up an independent commission of inquiry to investigate and examine the unverifiable claims of

the commission that there was a glitch, their terms of reference should include but not limited to the following;

* Make known to the public the Nature of the glitch and what caused it.

* Names of those in charge as at the time it occurred.

We need to know that this was not a deliberate attempt by members of the commission to undermine the integrity of our election by subverting the right of the people to vote and elect theirs leaders through a free, fair and credible process," CUPP said.

According to the statement titled, "INEC planned purported review is an obvious attempt by the commission to hide behind one finger" CUPP

explained that if the commission is truly concerned about credibility, then setting an open independent public inquiry on the glitches that the commission claimed undermined the integrity of 2023 Presidential election is the best way to go.

"The suspicion and lack of public confidence in the election is so overwhelming that INEC review will not elicit the kind of public trust needed to either justify what happened or uncover the fraudsters within the commission that deliberately thwarted the process by which Nigerians could have established a credible election process," the statement pointed out.

11 States Left Out As Tinubu Submits Ministerial Nominees To NASS

The long awaited ministerial nominees forwarded to the National Assembly (NASS), yesterday, had 28 names on the list, with 11 states completely left out as at time of filing this report

Our correspondent reports that the states yet to be captured on the list sighted, are, Adamawa, Bayelsa, Gombe, Kano, Kebbi, Kogi, Lagos, Osun, Yobe Nasarawa, and Zamfara.

Reasons why they are yet to be captured is still sketchy, however, it was gathered that leadership tussle in Adamawa All Progressives Congress (APC), may be responsible for the absence of a nominee from the state, although, there have been speculations that Senator Aisha Binani was expected to be named.

From the list sent to NASS for screening and approval, 28 ministerial hopefuls, including those from opposition parties was sighted.

The list includes immediate past governor of Rivers State, a chieftain of main opposition, People's Democratic Party (PDP).

Also captured, is Mr. Waheed Adebayo Adelabu, who contested the March Gubernatorial elections In Oyo State under another party, Accord.

Also featured prominently on the list are two North West immediate past governors, Nasir el-Rufai of Kaduna State and Badaru Abubakar of Jigawa.

vernor Uba Sani rof Kaduna State has warned the 14 newly sworn-in Commissioners in the state against flamboyant lifestyles and launched a government-owned Trust Fund for the support of vulnerable, underserved populace.

Speaking during the swearing-in ceremony which attracted a very large crowd of enthusiastic citizens, the governor said his administration has finally taken shape to bring succour to the citizens of Kaduna State, especially the poor, underserved and vulnerable.

Uba Sani said the state is in a period of emergency that calls for BELT TIGHTENING. "We must take firm measures in Kaduna State to cut down on the cost of governance. We must, as political leaders, show our people the way. We must avoid ostentatious lifestyles. We must not be telling our people to make sacrifices while we are busy living in opulence," he said.

Saying the Commissioners were carefully selected to drive his administration's SUSTAIN Agenda, Uba Sani said Commissioners must also use the old cars. We must collectively make sacrifices. If we lead by example, our people will follow and support us.

The Governor seized the opportunity of the swearing -in to touch on some burning national issues as they affect Kaduna State and certain measures he has decided to take to better the living standards of citizens of Kaduna State.

marks a major "It milestone in the journey of our administration. Those who made it to the cabinet were considered based on their proven track records, skills and competences, as well as dedication and commitment to the service of Kaduna State," he said.

"I stated that the Commissioners are joining our administration at the most challenging time in the history of our country. We are confronted with serious economic challenges.

"These challenges require the taking of extraordinary measures. It is for this reason that the President B o 1 a Tinubu Administration has taken some hard, painful, but necessary decisions like the removal of subsidy on fuel," he said.

Uba Sani his administration is already matching words with action in Kaduna State and vowed to continue to use the old cars inherited from the previous administrations in Kaduna State.

"I signed my first Executive Order on Tuesday, 25th July 2023. It is on "Financial Inclusion in Kaduna State". We are committed to improving the lives of our citizens, especially the poor, underserved and vulnerable.

"A Committee will be set up to develop a Framework for the Establishment of the Trust Fund. I will donate 50% of my salary to the Trust Fund for the next two years. This is part of my sacrifices

He charged the Commissioners to adopt the inclusive approach to leadership, build a team and see everybody as important.

Syndicate Member Caught Stealing Onboard Ibom Air Lagos-Abuja Flight

suspect, Ogeneochuko David, identified as a member of a large syndicate specializing in stealing onboard aircraft has been apprehended in Ibom Air for allegedly taking another passenger's laptop from his bag in the overhead cabin.

A statement signed by the General Manager, Marketing and Communication of Ibom Air, Aniekan Essienette and made available to New Nigerian in Uvo yesterday, said that the incident occured on Wednesday, during the boarding of Ibom Air flight Q1300 from Lagos to Abuja.

According to Essientette, the owner of the laptop upon noticing that his laptop was stolen from his bag, drew the attention of the crew members who immediately swung into action the possession of the suspect, David. line with its corporate policy, has "The owner of the laptop, who suspected the movement of the said Mr. David within the aircraft, decided to check where his laptop was kept and immediately realized the item was no longer there. He raised the alarm by notifying the crew members accordingly.

"A search was immediately instituted, which led to about half an hour delay, and the laptop was found with Mr. David. He was immediately offloaded and handed over to the Federal Airport Authority (FAAN) Aviation Security (AVSEC) for further investigation, who then handed him over to the Police for further investigation. Governor Zulum, on Wednesday in Maiduguri, held an emergency security meeting at the Government House and thereafter, briefed journalists.

"I have summoned this emergency security council meeting to address the emerging security threat that is bedeviling the Maiduguri metropolis and parts of Jere Local Government Area, with a view to coming up with additional implementable strategies to guarantee the needed peace and security"

Zulum began.

"Intelligence reports before my office from different sources, have indicated increasing activities of youth gangsterism operating in some parts of the state capital and Jere Local Government. This syndicate specialized not only on phone snatching in broad daylight, robbery and possession of locally made weapons, but has now graduated into the killing of innocent lives, including security operatives," the governor declared.

Zulum, who was deeply concerned about the escalating violence expressed Government's determination to restore peace and ensure the safety of all residents.

Kaduna Governorship: Tribunal Admits BVAS Machines From Ashiru, PDP As Exhibits

bout 316 Bimodal Voters' Accrediting System (BVAS) machines were presented and admitted as exhibits at the ongoing sitting of the governorship election petition tribunal led by the Justice Victor Oviawe-led panel on Tuesday in Kaduna.

At the resumed hearing on Tuesday, the BVAS machines were admitted as exhibits based on the subpoena served on the Independent National Electoral Commission (INEC) to bring before the court, the said items as applied by the 1st and 2nd petitioners; Isa Ashiru and the People's Democratic Party (PDP) through their counsel, Samuel Atung (SAN).

the court on behalf of the Commission, (INEC) made a written statement on oath before the registrar of the tribunal on the 25th day of July, 2023 to present BVAS machines of 19 Local Government Areas of the state.

In his deposition before the court, the Commission was subpoenaed on Duces Tecum (to tender) and Duces Tecum Ad Testificadum (to tender and testify) and demonstrate how the machines were used to collate election results in the state at the last gubernatorial poll.

Zubairu, who is a staff of INEC at the ICT/ Voters' Research Department. testified that the results on the Irev was the true reflection of the votes cast during the 18th March, election in the state.

Ashiru, however, in one of his prayers before the tribunal alleged that he and his party, (PDP), won the governorship election going by the lrev results.

Zubairu, who is a witness also added that the BVAS machines cannot be tampered with, either before, during or after the election, just as he explained to the court that each machine has its unique identity number.

The witness, while demonstrating, use of one of the machines, told the tribunal that polling unit 050 of Makera Ward in Kaduna South LGA had 715 total voters registered, but only 107 voters were accredited for the election. In his defence, earlier before the tribunal granted the application of the 1st and 2nd petitioners'

counsel for the witness to demonstrate; using the BVAS machines, Chief Duro Adeyele (SAN) who is the counsel to the Kaduna State Governor. Uba Sani, objected to the admissibility of the BVAS machines through the witness.

The counsel also argued that the witness' deposition did not state that the witness (Yusuf Zubairu) would open and demonstrate the BVAS machine before the tribunal, saying, "demonstration of BVAS' machine is not in the witness' statement."

In his counter, the Ashiru and PDP's counsel explained that the Commission was subpoenaed to (Duces Tecum Ad Testificandum) tender and demonstrate the machine before the court.

Breach Of Rights: A'Ibom Court Awards N20.1m Cost Against Applicant

High Court sitting in Uyo, Akwa Ibom State has ordered one Sampson Silas Udoh to pay twenty million, one hundred thousand Naira (N20.1m) to two of his nieces for breaching their fundamental rights by stopping them from inheriting their late father's property.

The Court presided over by Justice Ntong Ntong gave the order on Wednesday July 26, 2023 in a judgment delivered in a suit brought by Mr. Sampson Silas Udoh, an indigene of Itiam Etoi in Uyo Local Government Area of the state for the enforcement of his fundamental rights against his nieces.

In the suit filed 16th August, 2022, are the respondents, Mrs Bakabasi Victor James and Miss Ndantiabasi Isaac Silas, as well as Mr. Williams Ubetem, the Investigating Police Officer, IPO attached to the State Police Headquarters, Ikot Akpan Abia and the Commissioner of Police, Akwa Ibom State Command.

According to the Court, "the main contention of the applicant is that his nieces being female children of his late elder brother, Mr. Isaac Silas Udoh, should not inherit their father's property" because they are women, while the respondents said their father built his own house on his own land between 1976 and 1980, which they live from birth till date without any problem, until they attempted to appropriate the inheritance and their uncle unleashed mayhem on them."

Justice Ntong Ntong in a one hour judgment described the action of the applicant, "as obnoxious and repugnant to natural justice, equity and good conscience" stressing that "the maltreatment is opprobrium, offensive and unconstitutional".

He said it was high time "paramount rulers, clan heads, village heads and community leaders in Akwa Ibom State came to terms with the facts that female children have equal stake with their male counterparts to inherit their parents properties."

The Court said, "the first and second respondents acquired their father's property at Isaac Silas Udo Obot's compound, Nung Udoetok Ibom Adia Abasi of Itiam Etoi, Uyo, a fact contained in exhibits canvassed in their counter affidavit in the minutes of the peace meeting and property sharing agreement of Udoetok Ibom Adia Abasi Family, dated 11th January, 2019." Justice Ntong held that "the applicant cannot be allowed to take advantage of the vulnerability of his nieces just because they were born girls and women into their family."

He said "from the totality of credible evidence before the Court, the Police and other respondents did not and are not likely to encroach or infringe upon the rights of the applicant. Instead it was the applicant that infringed upon the fundamental rights of his nieces, with impunity, which cannot be allowed to stand."

The Court also held that "the application for the enforcement of the applicant's fundamental rights has failed woefully in its entirety and dismissed same with cost of total sum of twenty million, one hundred thousand Naira payable to the 1st and 2nd respondents at ten million, fifty thousand Naira, each."

Migrate To Flexible Teaching, Learning Modalities, Provost Tells Tertiary Institutions

Professor Faruq Haruna Abdulrashid, Provost, Federal College of Education, Kontagora, stated this while delivering a keynote paper at the annual International Conference organized by the Faculty of Education, Ahmadu Bello University (ABU), Zaria.

He said these strategic actions have to be continuously assessed, modified and enhanced to respond to volatile, uncertain and changing scenarios in times of crisis. According to him. teaching and learning continuity amid the pandemic and beyond requires an analysis of the parameters by which the University operates from the perspective of the stakeholders..

Professor Faruq noted that

the disruption of COVID-19 and possible future pandemic in the educational system is of great magnitude that Universities have to cope with at the soonest possible time.

He advised Higher education institutions to develop a resilient learning system using evidence-based and needbased information so that responsive and proactive measures can be instituted. The keynote speaker said, coping with the effects of COVID-19 in Higher Education Institutions demands a varieties of perspectives among stakeholders.

"Consultation needs to includes the administration who supports the teaching and learning processes, the students who are the core of the system, the Faculty members who perform various academic roles and others who shares the responsibility of learning to the completion of the educational requirements of the students".

"In the context of the

pandemic Universities have to start understanding and identifying medium term and long- term implications of this phenomenon on teaching, learning, students experience, infrastructure, operations and staff".

"Scenario analysis and understanding of the context of each University are necessary to the current challenges they are confronted with".

Professor Faruq said, educational system must prepare to develop plans to move forward and address the new normal after the

Gov Makinde stressed "Well, in front of me today, we have three commissioners being sworn-in from Oyo Federal Constituency. So, if you say one commissioner per constituency, Oyo Federal Constituency has three. So, when people do these analyses, I wonder why."

The governor noted that contrary to the notion that administrations are often lax and non-committal during second terms, his government is looking to leave a strong legacy in the state and that it would not let the people of the state down, adding that the appointment of the new political office holders "is a call for more w o r k . S o m e o f t h e commissioners worked with me during the first tenure and some of you already know how I work and nothing is going to change".

"Some people have said that the second term administrations are usually very lax because they are not looking for anything. Well, we are looking for a strong legacy to give back to Oyo State. So, we are not going to let our people down".

Disobedience To Court Orders: Arewa CSOs Plan Massive Protest Against DSS

*Say failure to release individuals granted bail by court would see mass mobilization to Yellow House

mobilize their members to come out in numbers and match to occupy premises of the Yellow House for a peaceful protest demanding the unconditional resignation of Mr Yusuf Magaji Bichi, Director General of the Department of State Services (DSS).

Its Chairman, Adamu Aminu Musa, in a statement made available to our correspondent yesterday, explained, "The Arewa Civil Society Organisations will be compelled to mobilise members under it's umbrella to come out in numbers and match to occupy premises of the yellow house for a peaceful protest demanding the unconditional resignation of Mr Yusuf Magaji Bichi, Director General of the Department of State Services (DSS)."

It lamented the DSS continuous attack on the Judiciary by defying several court orders, illegally holding Nigerian citizens in detention, thereby violating their fundamental human rights. It noted that the secret service on the 10th of June, 2023 arrested Mr Emefiele in Lagos, held him in detention for over a month without charging him to court or releasing him, stressing that after arraigning him before a judge he stills remain in detention, and in connection to Emefiele's case, Alhaji Aminu Yaro and his wife, Sa'adatu Yaro

were also arrested since 12th of July, 2023 and have been in detention too, all against their fundamental human rights.

The statement noted that two separate Judges, Justice Nicholas Oweibo and Justice Edward Okpe have presided over the cases in Lagos and Abuja on 25th of July, 2023 and have both granted bail to Mr Emefiele and his subsequent remand in Nigerian Correctional Service and immediate release of Alhaji Aminu Yaro and his wife but regretted that an order restraining DSS from arresting or administering any inhuman or degrading treatment on the couple in the interim was issued.

Despite legal interventions, the statement said that the DSS has strong blatantly thrown deaf ears to the orders given by the court, refusing to release them, saying that it is a violation of human rights, maltreat and abuse of Nigerian citizens whom they ought to protect.

The statement regretted the dehumanisation of Nigerians by DSS under Bichi as very alarming and disturbing and called for help from all and sundry, the intervention of Amnesty International and National Human Rights Commission to look into Bichi's activities with the view to saving innocent Nigerians from further degradation.

Ebonyi: USAID--IHP Interventions, Welcome Development, Says Health Expert

ollowing the media tour to some USAID IHP facilities across Ebonyi State, the medical officer in charge of Ezzamgbo General Hospital, Dr Nwambeke Ogbonna has lauded the efforts of media practitioners in the state for engaging in such a selfless task to ascertain the level of support programmes, activities and interventions carried out by USAID IHP to assist primary and secondary healthcare centres in the state have received.

Dr. Nwambeke, described the tour as a welcome development, saying it will go a long way to evaluate the support and activities of USAID IHP in the 212 supported facilities.

He applauded IHP for the unimaginable support, intervention, and achievements in all parts of the state's health facilities, saying that many lives have been saved, especially those of women and children under five, who are mostly vulnerable.

According to Dr. Nwambeke, before the intervention of IHP in Ebonyi State health facilities, the situation of the hospitals was not conducive for patients as they lacked basic medical facilities to discharge their jobz effectively, but with their numerous support and activities, there is a positive change in the health sector of the state.

The situation of this general hospital was not really comfortable before USAID IHP interventions came to assist us, we lacked maternal and child healthcare services, family planning, nutrition, health education, trainings and retraining on service delivery, etc.

"Before IHP interventions, all these things were in a low end, but since they came, there are positive changes as we now have maternal and child healthcare services, family planning, nutrition, health education, trainings and retraining on service delivery. They have implemented so many programmes in our facilities, which we have never had in the past.

'USAID IHP has provided f a m i l y p l a n n i n g commodities, surgical check list, working tools and job aids are part of what they brought and so many others. 'It has helped us to carry out efficient diagnosis and treatment. The situation now is fair, even though we are

not yet there,' Dr Nwambeke explained.

The health expert further called on the government to urgently intervene to rescue the health sector in Nigeria, as there is massive brain drain across the country, since most medical personnel have left the country to seek greener pastures, saying that despite the interventions of USAID IHP, there is a need for more health workers that will do the job.

'All over Nigeria, there is massive brain-drain in health sectors. Health workers are leaving in droves for greener pastures. Despite USAID IHP interventions, we still need more health workers to do the job. If you provide all the commodities and there is nobody to make use of it, it is definitely not going to work. "Gradually we are getting there; as you entered here, you saw only one doctor and a total of five nurses. We are waiting for government to recruit more health workers because the manpower is grossly inadequate.

'Most pregnant women do come for antenatal care, but end up having deliveries outside our facility because we lack midwives.

'The major challenges on the ground are manpower needs, capacity building, and other key health facilities to make the job easier," the expert said.

Tearing at the Seams: Nigeria Loses Belief in the Common Good

6 6 If most of our leaders are bandits covered up in fine agbada and flying around the world with our stolen money, there is no surprise that there is no anger or rage against the petty thieves stealing a manhole cover or a copper cable to sell and feed their families. When there is no confidence that those who occupy public office have a commitment to defending the common good, then amoral behaviour becomes the standard. The path to political repair must therefore involve a gradual improvement in the competence and integrity of the country's political leadership."

IN these strange times, the story of the Nigerian State is daily written in the crime pages of our newspapers and broadcasts. One set of stories that is emerging repeatedly is the dismantling and theft of the country's infrastructure. This week, it was reported that thieves have removed and stolen the recently installed airfield ground lighting systems at the domestic runway (18L/36R) of Murtala Muhammed International Airport (MMIA) in Lagos. The runway lights are critical because they help pilots to do landing and take-off safely at night, or in low visibility conditions. As these are highly specialised lights with specific use on runways, the thieves must have access to security zones and have knowledge of where they can sell them. It was only in November 2022 that the runway was reopened for 24 hours flight services after the successful installation of the ground lights. Last week, some of the road fittings installed on the newly inaugurated Second Niger

robbers. Specifically, the metal expansion joints are removed and sold as scrap metals by the robbers. This problem has been on-going in Lagos for years where similar joints and metal reinforcement for bridge safety are regularly removed and sold compromising the integrity and safety of the bridges. Railings and crash barriers from manholes meant to reinforce bridges from vibrating, as well as protect vehicles from falling from the bridge are also removed

In Lagos and Abuja, it is very dangerous to walk at night or while it is raining because manhole covers are systematically removed and sold

off by thieves. One has to be eternally careful not to fall into such dangerous pits all over the roads. These manholes protect sewer or maintenance holes; cable access or inspection chambers, and are the top opening to an underground utility vault, which is used to house an access point for connections, inspection, valve adjustments or performing maintenance on underground and buried public utility and other services including water, sewers, telephone, electricity, storm drains, and even gas. By removing the covers, such vital municipal services are often compromised.

"Of course, people are conscious that law enforcement agencies who have policing responsibilities are not doing their work and are sometimes paid off by the robbers to facilitate the theft. The real problem is the collapse of civic space and consciousness that the common good has to be protected not just by law enforcement agencies but also by the entire society. Nigerians have lost the sense of the protection of community and society. Nigerian society has also become very amoral and notions of ethics, good behaviour and respect for others have disappeared."

The government therefore finds itself in an unwinnable race in which the covers are continuously stolen as soon as they are replaced. Also last week, the Borno State Government banned collection and sale of scrap metal upon discovering that most of the socalled scrap is government property stripped from classrooms, offices and stores. The same week, two trailer loads of rail track and metal plates were arrested in Nasarawa as robbers were simply dismantling and selling off the rails.

Another dimension is the theft of electricity cables from the network. Regularly, electricity supply is disrupted because cables have been removed and sold. Copper cables are apparently in high demand because the feed a significant jewellery industry all over the country. The removal of such cables makes the already catastrophic electricity supply in the country mush worse.

Over the past few years, a number of metal smelting industries have developed in Nigeria and it seems that to maximise profits, they work with metal thieves stripping the country's infrastructure to make their products. The real tragedy of such action is the threat they pose to public safety as bridges might collapse due to removal of m e t a 1 reinforcements and the railways are forced to close to stripping of the rail tracks.

A lot of these thefts are in broad daylight and people sit and watch as infrastructure meant for their welfare are dismantled and sold at great risk to their lives. Those dismantling metals from bridges may one day be victims of fallen bridges themselves and yet they remain in the business and their neighbours simply watch them. Of course, people are conscious that law enforcement agencies who have policing responsibilities are not doing their work and are sometimes paid off by the robbers to facilitate the theft. The real problem is the collapse of civic space and consciousness that the common good has to be protected not just by law enforcement agencies but also by the entire society. Nigerians have lost the sense of the protection of community and society. Nigerian society has also become very amoral and notions of ethics, good behaviour and respect for others have disappeared.

The core of the problem is the general rise of criminality in Nigeria. Experts indicate that there are over six million small arms and light weapons in Nigeria in the hands of bandits, militants, jihadists, secessionists and kidnappers. They are all engaged in criminal activities against both state and society. Security agencies are completely overwhelmed and have become either onlookers or co-conspirators in these criminal activities.


The constitutional injunction that the State shall provide for the security and welfare of Nigerians has become meaningless. and natural resources. Nigeria's main revenue source is petroleum and now it is public knowledge that a significant part of the production is stolen by criminal cabals who can only work if they have protection from people in government and security agencies.

If most of our leaders are bandits covered up in fine agbada and flying around the world with our stolen money, there is no surprise that there is no anger or rage against the petty thieves stealing a manhole cover or a copper cable to sell and feed their families. When there is no confidence that those who occupy public office have a commitment to defending the common good, then amoral behaviour becomes the standard. Onward Western Soldiers, Marching to Third World War

HE gathering of 32 European countries and their North American first cousins in Lithuania under the North Atlantic Treaty Organisation (NATO) is the clearest indication yet, that they want to put humanity on the path to another World War.

British Prime Minister, Rishi Sunak, made a truthful summary of the July 11-12, 2023 NATO Summit in little Lithuania, one of the first bolts to loosen from the defunct Union of Soviet Socialist Republics, which led to its collapse. He said what the summit achieved was to strengthen the military alliance, put it in its most combat-ready form since the Cold War, work out its "comprehensive war-fighting plans", scale up defence production to "boost our stockpiles" of weapons and reaching a minimum defence spending of two per cent.

He also celebrated the full membership of Finland which has a 1,340-kilometre border with Russia, the longest by any European Union member. This means that NATO is fully peeping into Russia, and Finland would soon warehouse NATO weapons.

Sunak added with glee: "...And very soon we'll be doing the same with Sweden. We are stronger with them by our side... and in time we will be stronger with Ukraine as a NATO ally too."

In reiterating British commitment to the military defeat of Russia in the Ukraine War, the British leader announced: "Together with our G7 partners we have agreed to provide the long-term bilateral security commitments that Ukraine needs."

The more recent commitments of the United States (US), for instance, was President Joe Biden's Friday, July 7, 2023 announcement to provide Ukraine with cluster bombs which represents perhaps the most dangerous escalation in the war. This move further shuts the doors against peaceful negotiations to end the war in Ukraine.

Cluster bombs are bombs that disperse and scatter huge number of minibomblets over wide areas some of which fail to explode on impact and thus become like landmines, lying in wait for years after a war, to explode when stepped upon by innocent civilians.

Since cluster bombs are 'steel rain' designed to fall on targets spread over wide areas, it means they do not have an accuracy and can therefore hit unintended targets such as civilian populations. The US military documents, reveal that the CBU-97 cluster bomb, for instance, "provides multiple kills per pass" against a wide range of tanks, armoured

personnel carriers and other vehicles. Cluster bombs are weapons and crimes against humanity.

"Biden, in this dangerous escalation of the war in Ukraine, claims that Ukraine has assured him that the cluster bombs would not be used against Russian territory. So, against what will it be used? Ukrainian territory? Does it make sense for Ukraine to use these dangerous weapons against its own territory when it knows that like mines, they can remain concealed and unexploded for years? If Biden thinks the rest of us are so thick-headed as to believe such assurances, are the Ukrainians so silly as to plant mines they would be unable to detect on their own territory?"

These bombs are so dangerous that 111 countries, including NATO members: Germany, UK and Canada, have signed and ratified the Convention on Cluster Munitions, banning its use, production and stockpiling.

The US last used them 20 years ago when in April 2003, in collaboration with the UK, it fired about two million cluster bombs, most of which were called Dual-Purpose Improved Conventional Munitions, in Iraq.

The outcry against the US was so much that on March 11, 2009 President Barack Obama signed into law a permanent ban on nearly all cluster bomb exports by the US.

Biden, this July 8, in rationalising his decision to supply Ukraine with cluster bombs said: "This is a war relating to munitions. And they're running out of that ammunition, and we're low on it and so, what I finally did, I took the recommendation of the defence department to—not permanently—but to allow for this transition period, while we get more 155 weapons, these shells, for the Ukrainians." The logic in Biden's argument is that if the US also runs low on cluster bombs, it can supply Ukraine with nuclear weapons.

Biden, in this dangerous escalation of the war in Ukraine, claims that Ukraine



has assured him that the cluster bombs would not be used against Russian territory. So, against what will it be used? Ukrainian territory? Does it make sense for Ukraine to use these dangerous weapons against its own territory when it knows that like mines, they can remain concealed and unexploded for years? If Biden thinks the rest of us are so thick-headed as to believe such assurances, are the Ukrainians so silly as to plant mines they would be unable to detect on their own territory?

In continuing in Biden's illogical decision, his National Security Adviser, Jake Sullivan, said: "We recognise that cluster munitions create a risk of civilian harm from unexploded ordnance... But there is also a massive risk of civilian harm if Russian troops and tanks roll over Ukrainian positions and take more Ukrainian territory and subjugate more Ukrainian civilians because Ukraine does not have enough artillery." Silly rationalisation.

Ukrainian President, Volodymyr Zelenskiy, who is sure to liberally use the new weapons, responded excitedly that the new package is a "timely, broad and much-needed defense...that (would) bring Ukraine closer to victory over the enemy". He added that: "The expansion of Ukraine's defence capabilities will provide new tools for the de-occupation of our land and bringing peace closer."

The tragedy in all these is that Russia will respond in like manner and the world will get closer to a new World War in which all, including nuclear weapons, would be game.

Sunak's reminder that from all practical purposes, Sweden, the dove of Europe, has become a member of the hawkish NATO alliance following the successful bribing of Turkey to drop its objections, is a sad one.

It also refused to be aligned during the Cold War. Most importantly for us in Africa, when big powers like the US and UK shored up the evil racist and Apartheid regimes that held down our people in Zimbabwe, Namibia and South Africa, Sweden stood by the oppressed. It also refused to join its European and American brothers in supporting the on-going Israeli genocide against the Palestinians. Equally, it supported the Saharawi against re-colonisation by their Moroccan neighbour.

The Swedes also gave humanity Olof Palme, one of the most compassionate, thoughtful and reliable leaders the world has ever produced. In his assassination on February 28, 1986 when he was Prime Minister, Olof Palme became a true martyr and symbol of peace in a highly fractured world. In Sweden joining NATO, Olof Palme will be turning in his grave.

FIFA Women's World Cup 2023:

Falcons Bank On Winning Mentality To Overwhelm Matildas

By; AYO OJEDOKUN, Lagos igeria and Australia will set alight the Lang Park in Brisbane/Meaanjin on Thursday night in what is one of the most-anticipated clashes of the group stage at this ninth edition of the FIFA Women's World Cup finals.

With the maximum three points from their opening match against Republic of Ireland in Sydney on 20 July, the Matildas know they have a fight on their hands against nine-time African champions, Super Falcons, who refused to bow to Olympic champions Canada in Melbourne the following day.

The Super Falcons know only a win will be good enough to stand them in good stead for a place in the Round of 16, as only the two top-placed teams in each of the eight groups will make progress in a tournament that has welcomed 32 teams for the first time ever.

"Of course, it is the World Cup. You have to accept the fact that you are going to play the best teams in the world and you have to be alive to that responsibility and face it with your full chest," team captain Onome Ebi told thenff.com after the tournament draw that was conducted in Auckland, New Zealand in October 2022.

On Tuesday, Ebi reiterated the position of the Super Falcons: "We will go in there and play to win. There are no two ways about it. Only three points will be good enough for us."

Ebi says their five-match unbeaten streak is one of the callipers that will keep the girls going strong on a turf much more familiar to their opponents and in front of dozens of thousands of a partisan crowd at the Lang Park. Before the draw with Canada, the Super Falcons had pipped Costa

Club 8-1 before the World Cup. Nigeria is one of only seven countries (the others being USA, Brazil, Germany, Sweden, Japan and Norway) to have featured in every single edition of the FIFA Women's World Cup finals since the competition was launched in 1991. Australia missed the inaugural edition in China, but have been at every other final


"This man is our Dangote, he made himself available to the common man, he is a passionate philanthropist who is all the time
