Grandpa In Oyo Police Net For Selling Day-old Grand Daughter for N700,000

*5 others arrested at Abia Baby factory, suspected armed robbers, cultists nabbed in Ibadan

grand father identified as M o n d a y Chukwuka is now in police net for selling his one-day old grand daughter for N700,000.

Briefing journalists in his office at the Oyo State Police Command headquarters, Eleyele Ibadan on Saturday, Oyo State Commissioner of Police, CP. Adebola Hamzat said the grand father was arrested in his hideout in Ibafo area of Ogun State.

CP Hamzat stated that men of the Oyo State Police command were informed of the incident on July 10, 2023 after which they swung into action.

"On 10th July, 2023, an actionable intelligence report was received by a team of Police Operatives attached to the Command Monitoring Oyo State about

the "harvesting of a day-old baby girl" from her teenage mother, identified as Sarah Chukwuka in Oyo town and sale of the girl child to a criminal cartel that operates a baby factory in Abia State", he said.

CP Hamzat added, " upon intelligence led interview, Monday, who is the biological father of the teenage girl who gave birth to the day-old baby girl, confessed to the crime and explained in details how he took the baby from her mother (his biological daughter) as soon as she gave birth under the pretext of handing over the baby to someone who would take good care of her."

"The suspect further explained in details, how he moved the day old baby to Abia State where he sold her to the owner of a baby factory located at Obehi, Okwa West in Abia State at the rate of Seven Hundred Thousand Naira (N700,000.00)."

CP Hamzat stressed further that "Investigation activity was extended to Abia State and in the process of a coordinated raid on the baby factory, a female suspect identified as Popoola Bunmi and four other accomplices whose names are Chinwedu Peter, Chidinma Blessing, Chuckwu Christopher, and Favour Chukwu were all apprehended in connection with the criminal activity."

According to CP Hamzat, "Bundle of new birth certificates and some equipments being used for baby deliveries were equally recovered from the factory, adding that the suspects as at the time of apprehension were unable to give any satisfactory explanation about the parentage of the babies recovered from the factory."

Speaking with journalists, Monday said, "I decided to

sell the baby because I cannot afford to take care of my teenage daughter and the baby and I used the money (N700,000) to rent a shop and buy goods."

Also, the mother of the teenage baby, Mrs. Sarah, said, "I was not aware that my husband wanted to sell the baby, he only told me that he wanted to give the baby to someone to nurture her and return the baby after two years."

The suspected buyer of the baby, Favor Chukwuka said, "I bought the baby following a request from a couple (name withheld) who are childless, I was given just N50,000 as my own share the job."

Other suspected criminals paraded by the Command include armed robbers suspects, suspected cultists, some hoodlums that specialized in stealing cars, and notorious criminal receivers among others.

Consider Ministerial Nominee From Kaduna Central Or South, APC Chieftain Advises Tinubu

former Chairman of the All **▶**Progressive Congress (APC) Caucus in Kaduna State, Alh. Ahmed Tijjani Ramalan has appealed to President Bola Ahmed Tinubu to consider a ministerial nominee from Kaduna Central or Kaduna South to replace former governor, Nasir el-Rufai, for inclusiveness.

An open letter to Tinubu yesterday, Ramalan said, "The ministerial position should go to Zone 2 or Zone 3 where persons and politicians of high caliber are well placed to take such a position in view that both el-Rufai and Governor Uba Sani are from Zone 1."

He called on President Tinubu to look critically into the sharing of political positions in Kaduna State, saying that the overconcentration of political offices in one zone is not auguring well for the APC in the state.

He explained that before 2015 when the APC took Kaduna State by storm from the PDP, which had held sway for 16 years, there had been equity in sharing the spoils accruing according understanding by politicians and other stakeholders in the state.

According to him, based on the gentleman agreement, when the office of the governor goes to one, naturally the deputy governorship position should go to the or 3rd Senatorial

He added that for a delicate

balance, the Ministerial position usually went to the remaining Senatorial zone to achieve inclusiveness and complete representation in the state, stressing that it means all the 3 Senatorial zones were fully represented at both the state and federal levels.

He said that after the former governor failed to make the ministerial list, it is said that he or the governor has forwarded the name of a certain Jaafaru Sani from Kubau Local Government Area, saying that it is still in Zone 1 as a possible replacement as is the same zone that birthed the present Governor and the said kith and kin of el-Rufai.

According to him, given that the politics of the APC in Kaduna State is not only about El-Rufai or anyone else but the entire members o the party and the People in the State.

He observed that the political isolation of Zone 3 has not in any way helped the fortunes of the APC and peaceful coexistence in Kaduna and decried that the people of Kaduna State had a raw deal from the anti-people and impoverishment policies of the el-Rufai style of totalitarian and destructive leadership.

He prayed that by the letter appealing to His Excellency, the APC National Chairman to act swiftly to ensure that the concerns of the APC followership act promptly to allay the fears of the people of Kaduna State and the Unity of APC in Kaduna State.

Ministerial Nomination: Governor Uba Sani Cautions Media Against Fake News

he Governor of Kaduna State, His Excellency, Senator Uba Sani has called on media houses, social media users, and macro-blogging sites to desist from spreading false and unverified information as this could mislead readers and cause unnecessary tension in the polity.

The governor gave this advice, while fielding questions from members

of the press on his recent meeting with President Bola Ahmed Tinubu and his alleged rejection of a certain individual proposed by his predecessor, Malam Nasir el-Rufai to replace him as a ministerial nominee.

According to a statement signed by his Chief Press Secretary, Muhammad Lawal Shehu on

August 12, 2023, Governor Sani stated categorically, "The only thing that is true in the story is that I met with the

President. Every other thing is false and a conjecture to create friction between me and Malam Nasir el-Rufai. At no time did we discuss the issue of replacement."

Further emphasizing the importance of responsible reporting, Governor Sani urged media outlets to be cautious and avoid becoming tools for mischief-makers who specialize in spreading falsehoods and divisive narratives.

While commending media

houses and bloggers who consistently ensure due diligence in reporting factual stories, Governor Sani reminded members of the press of their duty as the fourth estate of the realm.

"In these days of clickbaits and fake news, it is imperative for traditional and new media platforms to maintain their integrity by sharing balanced and verified stories that will be useful in moving the nation forward," the Governor said.

s the failure of Senate to confirm the **L**ministerial nomination of the former governor of Kaduna State, Mallam Nasir el-Rufai, continues to generate controversy, an Islamic human rights organization, the Muslim Rights Concern (MURIC), has told President Bola Ahmed Tinubu to save the North-West alliance which gave him victory at the polls by ensuring that el-Rufai gets the ministerial appointment.

MURIC made its stand known on Sunday August 13, 2023 after an emergency meeting of its Central Think Tank (CTT) held in the evening of the previous day. A statement signed by the Executive Director of MURIC, Professor Ishaq Akintola, after the meeting

reads: "The Central Think Tank (CTT) of the Muslim Rights Concern (MURIC) met vesterday to consider the circumstances surrounding the failure of Senate to confirm the nomination of the former governor of Kaduna State, Mallam Nasir El-Rufai, as a minister.

"CTT considered the issue a

President Bola Ahmed Tinubu victory during the 2023 presidential election. Furthermore, CTT regards the non-confirmation of Mallam Nasir el-Rufai's ministerial nomination as a big threat to future alliance between the North and the South-West. The North may not hobnob with the South-West again if the champion of the North-South alliance is shabbily treated.

"CTT also noted the huge contribution of Mallam Nasir El-Rufai who persuaded the Northern political elite, particularly the twelve Northern governors, to allow power to go to the South. It was observed that the monumental power shift of 2023 was a fulfilment of a 2019 agreement. It was therefore an act of honour while El-Rufai is seen as the icon of Northern integrity.

"CTT affirms clearly, emphatically and unequivocally that it behoves the South as represented by President Bola Ahmed Tinubu to reciprocate the North's noble stand by walking his talk, particularly his open offer and public invitation to Malam el-Rufai to join his cabinet. The story of Tinubu's invitation to el-

"It has become necessary to jog the President's medulla oblongata today because the North has exhibited integrity by keeping its promise on power shift to the South. It therefore, behoves the South to reciprocate, to manifest decorum, decency and dignity, particularly with the 'Omoluabi virtue' for which the Yoruba are well known.

"Tinubu has a duty to protect the good name of the Yoruba people in particular and the whole South in general. Besides, a promise is a promise in Islam and Tinubu is a Muslim. Allah says in the Glorious Qur'an 'And fulfill the promise, surely (every) promise shall be questioned about.' (Qur'an 17:34). Allah also said, 'O you who believe! Fulfill your pledges.' (Qur'an 5:1).

"The good relationship and the bond between the North and the South-West must not be allowed to break. 2027 is around the corner. Even 2031 is already knocking and politicians are already doing their calculations. The North supported Tinubu because they found him to be credible. He must not do anything capable of diminishing that credibility.

"el-Rufai is the gem of the major setback to the North- Rufai to join his cabinet is collection and everybody

knows it. He is a performer. He is cerebral, iconic. If it is true that the president himself already hinted el-Rufai to set the machinery in motion for the energy sector, the president is morally bound to walk his talk regardless of all other encumberances.

"Records show that there are precedents. Festus Kevamo was cleared in spite of Senate's earlier objection. Something made Senate change its mind. Ex-President Olusegun Obasanjo got this same el-Rufai cleared despite Senate's opposition in 2004. el-Rufai withdrew having read between the lines. He will still do it for the sake of Nigeria if the president's body language conforms.

"Criminality, dishonesty, fraud, impunity, lack of patriotism and other Nigerian problems spring from a wrong mindset. They will all disappear or at least be reduced to the barest minimum if the leadership sets the pace. Islamic scholars North and South who nurtured the North-South alliance are watching. All men and women of conscience are keeping vigil. Nigeria holds its breath and shivers. The buck stops at Mr. President's table."

Wildfires: Death Toll Rises To 90, Thousand Others Missing In U.S. State Of Hawaii

Bevan, noted that seven LGAs in Kaduna State have attained the Open-Defecation-Free (ODF) status, expressing optimism that the state will attain state-wide ODF status before the 2025 deadline.

The Commissioner of Health, Ummah K. Ahmed, Commissioner of Business Innovation and Technology, Patience Fakai, Deputy Chief of Staff, James Kanyip, alongside other senior Kaduna State Government officials attended the meeting, held at the Deputy Governor's Council Chambers.









OYSADA: 965 Farmers Get Agricultural Inputs In Oyo State So Far

farmers in Oyo State have so far, benefitted from the distribution of agricultural inputs by the state government

The benefitting farmers are from 12 local government areas of the state, namely, Iwajowa, Kajola, Iseyin, Ibarapa, Ibarapa North, Ido, Saki East, Oorelope, Olorunsogo, Oriire, Ogbomoso South and Surulere.

Speaking with journalists on Thursday during the distribution of farm inputs to 90 farmers in Ido Local Government Area, Oyo state Coordinator for Nigeria COVID-19 Action Recovery and Economic Stimulus, (N-Cares) Result Area 2, Mr. Kolawole Adewumi Bamigbola, said the distribution is geared towards boosting food production in the state.

Mr Bamigbola who gave the breakdown of the beneficiaries in Ido Local Government Area as 90, comprising 80 cassava farmers and 10 tomatoes farmers, said, "each of the cassava farmers received 20 bundles of cassava cuttings, two bags each of NPK fertilizer and one liter of herbicide, while each of the ten tomatoes farmers received 25 sachets of tomatoes seeds, one and half bags of fertilizer, one liter of preemergence herbicide and one liter of post-emergence of herbicide."

He stressed further that 100 farmers received agricultural input in Eruwa, Ibarapa East Local Government Area and that each of the 80 cassava farmers in the local government area received 20 bundles of cassava cuttings, two bags of NPK fertilizer, and one liter of herbicide, while each of the 20 maize farmers in same local council received 10kg of maize seeds, two bags of NPK fertilizer, as well as one liter of pre and post-emergence herbicides.

In Aiyete, Ibarapa North Local Government Area, no fewer than 60 farmers comprising 30 cassava farmers and 30 maize, received agric input.

Addressing the beneficiaries shortly after the distribution of the inputs to the farmers, C hairman, Ido Local Government Area, Hon. Sherif Aderemi Adeojo lauded Governor, Seyi Makinde for his vision towards ensuring food sustainability across all the geo political zones of the state.

Hon Adeojo stressed that the agricultural input given to the farmers are part of the programmes set aside by the state governor to support the farmers affected by the COVID-19 pandemic, saying, "we have to appreciate our able governor, Engr. Seyi Makinde for supporting our farmers with these agricultural inputs which I believed will boost the farm products of the respective

beneficiaries at the end of this farming season.

" I want all the beneficiaries to make good use of their inputs as this will not only boost their products but also compliment the efforts of the state governor toward ensuring food security across the length and breadth of the state.

"We are farmers in Ido Local Government Area and we have school of farmers right here in our secretariat where we train our farmers on the new innovations of farming and mechanized ways of farming, and I want to assure all of you that are yet to be members of this school that we will register you free of charge and we shall continue to carry you along on the benefits we have for farmers in our capacity at this local governments level.

"For those of you that benefit from today's distributions, please make good use of them, and for those of you that are yet to benefit from the kind gesture of the state governor, I'm using this opportunity to appeal to you to please relax, your time will soon come, I want to remind you all that our talk and do Governor has again promised to assist another set of 10,000 farmers across the state, this according to the Governor Makinde is one of the palliatives set in motion to cushion the effect of the fuel subsidy removal, so I believe you will all be captured in the next phase of the distribution."

James however, disclosed that close to 500 booklets of the passports are yet to be collected, just as he urged applicants to keep to their appointment dates for capturing and collection.

"As a take away from the 60th Anniversary Celebration of the service, the command has produced reasonable number of passports, as at the time of filing this report the passport office has produced between February and July, 38,613 booklets.

"Many applicants are yet to collect their produced passport and the service is using this opportunity to call on anyone who was captured a month or two ago and others with very cogent reason giving and were captured for health and medically related issues or other urgency that is proven and confirmed have being produced awaiting collection.

" he Comptroller James Sunday PCC after his visit to the passport office advised the Passport Control Officer Audi Maisudan a Deputy Comptroller to step up action in the area of feedback and reaching out to applicants whose passports are already produced to come and collect it and those with issues to be notified to enable them resolve their issues to clear pending cases and get the passports produced.

" As a Command we are enjoining applicants

At the resumed hearing on Thursday, the 3rd

respondent, the All Progressives Congress (APC) closed its case by tendering six sets of documents without calling any witness.

Meanwhile, Ashiru's lead counsel, Oluwole Iyamu (SAN) opposed to all documents presented by APC to the tribunal.

The Justice Victor Oviweled panel adjourned the proceeding for the adoption of final written addresses.

Obaseki, Oyegun, Oronsaye Harp On Importance Of Well Trained Public Servants

he prestigious John Odigie Oyegun Public Service Academy (JOOPSA) in Benin City, Edo state, was on Saturday, commissioned.

The gigantic complex is named in honour of the first executive governor of Edo State, Chief John Odigie Oyegun, who on August 12, 2023, marked his 84th birthday anniversary.

The governor who thanked all those that attended the formal inauguration of JOOPSA which he noted, is an institution built to transform public and civil service delivery and bridge the knowledge gap of Edo public servants.

According to Governor Obaseki, "the ability of a government to execute it's policies is largely is dependent on the quality and ability of it's public servants. That is why from the beginning of our Administration the transformation of the public service of our State has been given priority.

"It' was clear in my mind that it will be impossible to deliver on the mandate of our Administration without a strong and effective Public and Civil Service. Unfortunately, the public service we met was very weak in several areas. It's processes and procedures has become blurred because they were manual and therefore the civil service sluggish and prone to corruption and environment hazardous, offices without proper toilet facilities.

"Welfare of workers was terrible and wondered why the civil servants themselves allowed their situation to deteriorate to such an extend. Nothing like performance Management, nothing was done strategically and criteria for promotion was never merit based. You must belong to society to be considered and training and human capacity development



was relegated.

"It is now important to change the narrative if we are to succeed to reposition Edo for sustainable, socio economic growth".

He further noted that in the last six years his administration has taken a holistic approach to revamp the public and civil service in Edo State to enable it function effectively and efficiently.

"Edo State transformation and enhancement projects in the public service which we call Edo Steps has resulted in significant and unprecedented improvement in the capacity of the public servants to delivered optimally.

"Today, the public service in Edo State is the most digitalized public service in Nigeria, with over 5,000 computer and fiber optic connection across offices in the State. By September 1st 2023, Edo State would have achieved a paperless governance environment which will make us

the first state to achieve these feats. I will be the last governor to work with physical files in the state.

"The offices of our public servants in Edo State are the best they can be and well equip with State of the art facilities which can be compared to any you can fine in the world with 24/7 electricity and fast internet connectivity.

"We have taken the welfare of our public servants as a priority because we know that if you don't pay people properly, and take care of them you should expect high productivity from them. The don't joke with the welfare of of our workforce as we ensure that all working with us have heath insurance as you don't need to pay for treatment.

"We have fully funded contributory pension scheme, which we started 1st of January 2017 and the scheme I am told that the savings in that scheme is

approaching N10 billion as we will not have a situation when people retired you don't have money to pay them".

Obaseki said in order to curb and deal with the human capacity deficit in the civil service, his administration embarked on setting up JOOPSA as a centre of excellence to train and build the capacity of public servants to enable them perform optimally.

The celebrant, Chief John Odigie Oyegun who recalled the honour done the late first Nigeria female senator, Franca Afegbua and granting of automatic employment to first class graduates who are of Edo indigenes, by the state governor, Mr. Godwin Obaseki, said he is so proud and fulfilled to have had a special building named after him while he is still very much alive.

Oyegun who also narrated his journey in the civil service and how he rose to the position of Super Permanent Secretary, said though his stay was short having retired at the age of 48, added that a leader must be focused and ready to take risk.

He commended the state governor for laying a solid foundation that will stand the taste of time, stressing that the governor is the man who envisage the future.

But in his keynote address, former Head of Service of the federation, Mr. Stephen Osagiede Oronsaye, said his suspension as the then head of service to the federation was unconstitutional.

Mr. Oronsaye said he stepped on many toes while serving as the HoS in a bid to reform the civil service and that he has no regret for all that he did.

He disclosed that without a motivated workforce, no administration can deliver on its mandate hence academy like JOOPSA is needed.

How We Invest In Farming To Maintain WASH Facilities - Kaduna Community

g u w a n S a r o , a Community in Hunkuyi Ward of Kudan Local Government Area of Kaduna State last Wednesday, revealed how they were able to sustain Water Sanitation and Hygiene (WASH), facilities in their community for four years.

United Nations Children's Fund (UNICEF), in collaboration with Kaduna State Rural Water Supply and Sanitation Agency (RUWASSA), with funding support from UK's Department for International Development (DFID), now FCDO, under the Sanitation, Hygiene and Water in Nigeria (SHAWN II) programme, provided the community with WASH facilities such as borehole, toilets, hand washing facilities as well as measures to keep their community clean.

The SHAWN II programme was UNICEF's major strategy to help Nigeria attain Open Defecation Free (ODF), status before 2025. On Wednesday, UNICEF Nigeria, Chief of WASH, Dr. Jane Bivan, paid an assessment visit to Kaduna State, where she met with different stakeholders

in Igabi and Kudan LGAs.

During an interaction with WASH Committee at Saro community, on how they were able to sustain projects within their area, the committee Secretary, Muawiyah Jafar, disclosed that every year, they invest into farming and use the proceeds to maintain the facilities.

According to him, "since inception we agreed on a levy of N20 weekly per household within the community and N500 monthly for those who are directly connected to the water tank.

"This way, we were able to raise some money and we invested it into farming of rice and maize and every year, we continue to reinvest the profits back to farming and keep some for the maintenance of the facilities."

Muawiyah, added that since the SHAWN II project was introduced to their community a lot of things have changed, as the rate of illnesses has drastically

reduced, thanking UNICEF and other partners for making water available in their community and also supporting them to make their community clean.

The Chief of WASH, at the end of her tour, commended the various communities and stakeholders for their sense of hygiene and how they were able to keep the facilities after a long time.

"Am really impressed with the level of sanitation and hygiene in this LGA. From what I have seen and what I have heard from the commitment of the committees, the Chairman, and the local leaders, the coverage is really high.

"Everybody has toilets, it's fantastic that this LGA is open defecation free, now we really need to keep up the momentum to make sure we maintain this and ensure it doesn't fall back. We can promote the coverage that happened in this LGA to every other LGAs so that we can promote sanitation across the state." She said.

Dr. Bivan, noted that the idea of investing into farming to sustain the WASH projects is fantastic, but however advised them to also use part of their fund to expand water access by connecting more households to the water source.

District Head of Hunkuyi, Haliru Mahmoud, appreciated UNICEF and RUWASSA, for the support they gave that enabled them to be able to educate and sensitive their people on the dangers open defecation and benefits of good hygiene.

During the visit, the Chief of WASH, along with Director General, RUWASSA, met with Commissioner for Local Government and Chieftancy Affairs, Kudan LGA Chairman and his cabinet, District Heads of Hunkuyi, Leader of Kyaudai Community in Sabo Gari Ward, WASHCOMs, Community Volunteers Hygiene Promoters (CVHP), Toilet Business Owners (TBOs), of both Ugwan Saro and Kyaudai communities. She also visited the In-charges of Mando and Rigachikun, Primary Health Centres as well as held a meeting with WASH stakeholders in the state.

The protesting health workers said they need adequate security measures in place to ensure safety of both patients and health workers.

Recall that armed robbers on Tuesday night, invaded the institution's health center, recently relocated from UNIUYO main campus to Town Campus along Nwanibaroad, Uyo.

Some of the patients who narrated their ordeal to our correspondent, said the hoodlums stormed the post natal ward on Tuesday night and carted away phones and other valuables belonging to both patients and health workers.

"Two of them came into the post natal ward with guns, threatening to shoot if we fail to surrender our valuable items. They took our phones and monies, they also removed some amount of money from the hospital drawers. Three others were outside the health center.

"When the nurses heard their initial threats, they ran into the delivery suites, locked themselves in, and we the new mothers were left bare for the robbers.

"i am however, thankful to God that the idea to steal new babies was not part of their agenda. They took our handbags, emptied them and later threw them into nearby bushes". One of the patients who just delivered a baby narrated

One of the health workers who pleaded anonymity told our correspondent that UNIUYO security unit was contacted as soon as the hoodlums stormed into the premises of the health center, but response only came after the robbery had long been concluded.

The health worker therefore, appealed to management of the institution to step up modalities to strengthen internal security in the campus, especially around the health center to avoid compounding health cases for patients.

Efforts to reach the Director of Information, University of Uyo, Mr Udoro Ekpo was unsuccessful as he neither picked his calls nor respond to text message.

When contacted, the Police Public Relations Officer (PPRO), SP Odiko Macdon confirmed the robbery incident and suspected a link between a suspect just lynched at UNIUYO gate on Friday afternoon and the hoodlums who invaded the health center

The PPRO who however, condemned jungle justice, pledged the command's resolve to get to the root of the robbery incident

a d u n a State Governorship Election Petition Tribunal on Friday, adjourned till September 4, after all parties closed their cases in the petition marked EPT/KD/Gov/4/23.

In the said petition, the gubernatorial candidate of the People's Democratic Party (PDP), Isa Ashiru accused the Independent National Electoral Commission (INEC) of non-compliance to the Electoral Act and corrupt practices during the last gubernatorial election in the state.

The petitioners had closed their cases after calling no fewer than 21 witnesses and tendered several documents to back their case.

The INEC, being the first respondent also opened and closed its case without calling

any witness.

Governor Uba Sani who is the 2nd respondent, earlier said he had 30 witnesses to defend his victory, but, ended up closing his case on Friday without calling any witnesses.

"We have 30 witnesses and they are ready, but we have no reason to call any," Duro Adeyele, (SAN), counsel to Gov. Uba Sani told tribunal.

At the resumed hearing on Thursday, the 3rd respondent, the All Progressives Congress (APC) closed its case by tendering six sets of documents without calling any witness.

Meanwhile, Ashiru's lead counsel, Oluwole Iyamu (SAN) opposed to all documents presented by APC to the tribunal.

The Justice Victor Oviwe-led panel adjourned the proceeding for the adoption of final written addresses.

Bloodbath As Bandits Kill Over 100, Sack 59 Villages In 3 Taraba LGAs

o fever than 100 persons have been massacred in Takum, Ussa LGAs and Yangtu Special Development Area of Taraba State within 12 months by alleged gunmen identified as herders and 59 village settlements sacked by the marauding herders.

Emmanuel Ukwen, President General Kuteb Worlwide, who spoke at the weekend on the wave of attacks on Kuteb Communities of Takum, Ussa and Yangtu and the latest attack on Tuesday claiming three lives, lamented the wanton killing of innocent people and destruction of property worth hundreds of millions of Naira.

According to Ukwen, "killings became pronounced in the past few months as over 100 persons have been killed within 12 months, the latest being the attack of Tuesday where over 3 of our people were butchered to death by these herders.

"The killings began when a suspected herder took his cattle into one of our brother's farm, our brother accosted the herder who in turn drew out his matchet and attacked him. Our brother died as we were taking him to the hospital. Since then, the herders have been attacking from one village to the other. As we speak at least 59 villages have been sacked." Ukwen revealed.

Investigations revealed that the following villages have come under heavy attacks with many villagers losing their lives and property, Tati, Fawen Simta, Bassan, Muji 1, Muji 2, Tukog, Tati, Kumbo, Ucha, Nyido, Rimamnyang Nyido, Kwentam 1 Lagos, Kwentam, Rimamndeyati, Alaha, Kpambo Puri, Ripaenchin, Urerimam, Kpamshibe, Pangtso, Rubur Nyim (Jenuwa Kogi), Rikwenboi (Kwari), Acha Nyim, Sati Tsingnya, Rikwentwen, Rikwenmbakun Fikyu Nyim, Fikyu Ndukwe, Rikwentumum, Kando, Kijwaen, Kongkaen, Sik and Kakum.

Ukwen also stated that villages like Mbiya 1, Mbiya 2, Tamiya, Rikumcwo, Waeshong Rufu, Lumpa, Mbiya, Kabsi, Bura, Jwunyim, Waesi, Shienda (Kpambo yashe) have been sacked.

Others also hit by the wave of ruthless invasion are, Acha Sabka, Mzunki, Jenuwa Rikya, Jenuwa Nyifiye, Jenuwa Ribasi, Jenuwa Ruwa, Rukur, Urerimam, Utobrimam, Titih, Kutika, Fangta, Paenko and Fukrum.

Speaking with one of the villagers who survived the attack in Bura, Takum Local Government Area, who pleaded anonymity, the victim alleged "that the gunmen usually come in the night in their numbers armed with dangerous weapons.

"There is a army barracks here in Takum but it seems they have been overwhelmed. The IDP camps have been displaced. As I speak with you now, there is no IDP camp in Takum, the gunmen have invaded and scattered all of them," he said.

Confirming the situation in Takum and others, the Police Public Relations Officer, Usman Abdullahi maintained that, "there is security challenge in Takum, but the Commissioner of Police is on top of the matter as our men have been

mobilized to the affected areas."

The Taraba PPRO however, insisted that the police was never overwhelmed and that there are "no IDP camps in Takum because most of the affected persons are farmers who left IDP camps for their farms and not that they were attacked by gunmen."

Reports say PPRO Abdullahi had earlier confirmed the number of deaths in Tuesday attack in Kunkwa village of Yangtu Special Development Area as three.

The victims, whose names were given as Rimamskep Atenji, Andekwab Ashasim and ElKannah Akyara, were reportedly killed by the bandits on their way to the farm.

Stakeholders in Takum, Ussa and Yangtu who pleaded anonymity maintained that the Federal Government must redouble efforts via deployment of more troops to arrest the situation and ensure lasting peace.

NRM Chieftain Refutes Claims Party Endorsed APC's Ododo, Opens Can Of Worms

ational Financial Secretary of National Rescue Movement (NRM), Reverend Emmanuel Olorunmagba has reaffirmed the stance that anyone in the party who claims they have endorsed All Progressives Congress (APC's) gubernatorial candidate, Alhaji Usman Ododo, for the Kogi State November 11 governorship election has scammed him big time!

The affirmation came in reaction to a response of Mallam Bala Abdulgafar Dirisu, whom he referred to as "the mere governorship ticket placeholder, who erroneously assumed that he has acquired the status of a Kogi State gubernatorial candidate for National Rescue Movement (NRM).

Idrisu Bala of National Rescue Movement (NRM) on Saturday July 29, 2023, convened a press conference at Nigeria Union of Journalists (NUJ) Secretariat in Lokoja Kogi State with some people he claimed to be from five different political parties, announcing that they have a dopted the APC's gubernatorial candidate, Jsman Ododo on behalf of their party.

Then Idrisu Bala responded, titling it, "Reverend Olorunmagba can't Speak For NRM, We Stand By Endorsement Of Ododo." Again, Olorunmagba insists that the so called endorsement remains a scam that there was no time and at any level, did NRM ever discuss the endorsement of Ododo, let alone agreeing to endorse him.

He further said that the response by Bala Idrisu, is not only full of lies and deceitful manipulation, but also laden with concocted name calling in his (Idrisu's) usual manner.

"For he finds it difficult to sustain intelligent discussion that exposes his errors, without retorting to threats and name calling.


"However, I will not descend with him into the mud, but will address the lies and the deceptive manipulations he loaded his response with. "And this will be the

Or is Bala now the National Chairman of the party or BoT chairman to have arrogated such "all-in-all power" to himself? The answer is capital NO!

"Secondly, Mallam Bala Abdulgafar Dirisu was only a mere placeholder to quickly fill the gubernatorial space just to beat the deadline of INEC submission, so that if the party later gets a credible governorship candidate, he will be replaced based on the decision of the National Working Committee of the party through an NMC meeting. But funny enough, he started feeling like authentic governorship candidate of the party and without any kind of meeting with other members of the National Working Committee and without even consulting with the NWC he went to Lokoja to claim to have endorsed APC gubernatorial candidate, Usman Ododo, on

behalf of the party. "Again, I ask, is Bala Idrisu now the all in all of the 47 members of the National Working Committee of the party? We know that the answer is capital NO! It's of note that even Kogi State Executive Committee was not carried along. Our investigations reveal that he only did the backyard business with just two people who erroneously assume they are the "all in all in NRM". Yet he falsely claimed that it was the decision of the

Bala Idrisu was said to have, deceptively claimed as follows, "Before the Kogi State chapter of the NRM endorsed, Ododo, all the party members met and the decision was unanimous. Our resolution was forwarded to the national secretariat of our party which finally gave it's blessings."

"The statement above by Idrisu is total falsehood. The fact is, there was no meeting where such was discussed. Even the Kogi State Executive Committee was not carried along. In fact, most of the members of the National

state executive only read of it for the first time when the news of the so called endorsement got to social media; apart from the three of them doing the backyard business.

"I put it to Mallam Bala Abdulgafar Dirisu that either at national or state level, he should give the date of the so called meeting he claimed. Present an evidence of the notice of the purported meeting. List the names of those present at the so called meeting (since there must be a quorum for a meeting to hold). Where is the venue of the meeting and who took the minute of the imaginary meeting? According to our constitution, these are the requirements before a meeting can hold.

"The fact remains and I reaffirm that, there was no meeting of NRM where such so called endorsement was discussed let alone agreed upon.

"Thirdly, Idrisu referred to a current and substantive National Financial Secretary of the party NRM as "the estranged National Financial Secretary of the National Rescue Movement (NRM)". Well, if there is anyone in doubt he/she can check the profile of the party national officers directly from INEC website then you will see clearly, boldly and unambiguously that Reverend Emmanuel Olorunmagba is listed as the National Financial Secretary. So I don't need to dwell on this. As it's obvious that he (Bala Idrisu) doesn't even know the meaning of the word, 'estranged' he used, he might have heard it somewhere and decided to borrow the word.

"Fourthly, on the claim of Idrisu that, "Olorunmagba is not residing in Kogi State. He is mostly in Kaduna State and knows nothing about Kogi politics." The question to him (Bala Idrisu) is that, as he Idrisu is also resident in Abuja, does he assume that Abuja is now the capital of Kogi State, or is Abuja where Bala Idrisu is living now part of Kogi State?

"The truth is that Idrisu is an Abuja politician and I am more on ground in Kogi State than he is, as I do travel to Kogi State periodically, more than him and get involved more in Kogi State

'And to further expose how he has not been on ground in Kogi State, in the last election held on 25 February, 2023. Idrisu contested Senate position for Kogi West compromising seven (7) Local government areas, while I contested for House of Representatives Kabba-Bunu/Ijumu Federal Constituency, comprising two local government areas. The total votes I got in the two local government areas were more than the total votes he got in all of the seven local government areas he contested, put together. The records are there for anyone to verify. Then who is more at home now when it comes to Kogi State politics?"

Rev. Emmanuel added that it's time to start opening the can of worms over the scam played out and tagged endorsement.

"Initially, I didn't want to open the can of worms, but since Bala is pushing and dragging the issue, I will start opening them. For each response to him, I will open one. "In stage-managing the so

called endorsement, Bala Idrisu and his partners in their usual 'arrangee' characteristics, had to deceitfully arrange for someone to come to claim to be representing Boot Party, and that he is from Kogi State. And the fact is that the person so arranged, is not even a member of Boot Party and he is not from Kogi State. Funny enough, at the end of the so called endorsement, from the money said to have been given to them for the so called endorsement, the share of the money that supposed to be for Boot Party resulted in serious fight. The person who was used to claim to be representing Boot Party was reported to have insisted that since he took such risk, he should get a loin share of the money for Boot Party. But Idrisu and his partners felt otherwise and wanted to collect all the money for Boot Party and just drop peanuts for the person they used. The fight was said to be so serious, to the extent that Bala Idrisu and his people had to frame them up to DSS to arrest those who felt they should not be used and dumped; as they refused to release the money to Bala and co, due to the argument on the sharing formula. They were said to have been arrested and that they had to bail themselves from DSS net.

"This can be clearly confirmed from the DSS office in Lokoja, Kogi State," he said.

The Kogi born NRM chieftain stressed that he decided to give the above scenario to show Bala Idrisu and two others in NRM, "that we are well furnished with adequate information of the scam called endorsement. And more of this kind will still be exposed in my subsequent response as long as they continue to drag the issue.

"I believe that the National Publicity Secretary of our party, NRM in person of Mr. Sola Afuye who I know will always stand on the side of the truth, will also address this issue as time goes on," he concluded.



Since then, nations have tinkered with various forms, some of which developed into an absolute monarchy (absolutism), limited monarchy (constitutional monarchy), direct democracy and representative democracy. Others are dictatorship, oligarchy, totalitarianism and theocracy.

The presidential system of governance, on which we based our 1979 constitution, and first practised in governance that year, is modelled after the American system.

The presidential system is based on a tripod – the executive, legislature and judiciary, with the head of government, called the president, leading the executive branch. It is both a democratic and republican system of government with fixed tenures for elected officials.

The presidential system of government is seen as democratic because the electorate directly elected the president and is, therefore, directly answerable to the people. There is also effective control by the president and also quick decision-making and execution of government policies.

Another advantage is the stability it offers because of the fixed term of office and where to locate responsibility for any acts of commission and omission.

While we can say it has such advantages, the presidential system tends to degenerate into a winner-takes-all 'dictatorship' with individual liberties taken away, citizens' rights trampled upon and views of political opponents suppressed.

Other disadvantages include the very difficult processes for change of government before the expiry of tenure, even if the president's policies are not favourable to the people as well as the thin line between national and partisan issues.

There may also be a strained relationship between the executive and legislature, where the president may refuse to assent to bills from the legislature while the legislature, generally multi-party in composition, may not cooperate with the president in some of his policies. Then, there is the possibility of distraction and loss of focus by the executive, who may be consumed with the ambition of winning the next election.

Another type Nigeria has tried is the parliamentary system of government. Parliamentary democracy is the system in which the executive derives its democratic legitimacy from the

confidence the legislature has in it, typically a parliament, and is also held accountable to that parliament. In a parliamentary system, the head of state is usually a person distinct from the head of government. This is in contrast to a presidential system, where the head of state often is also the head of government and, most importantly, the executive does not derive its democratic legitimacy from the legislature. The head of government here is elected to power through the legislature. One of the disadvantages of this system is that the government can be unstable. The prime minister is elected by the majority party and can be removed at any time if the majority party loses confidence in that person as a leader.

Another form is the semi-presidential or dual executive system of government in which a president exists alongside a prime minister and a cabinet, with the latter being responsible for the legislature of a state.

The Economist Intelligence Unit, though, does not see Nigeria as practising any of the above. In its Democracy Index of 2016, it rated Nigeria's as a "hybrid regime".


In its definition, a hybrid regime is a mixed type of political regime that manifests based on an incomplete democratic transition. Hybrid regimes combine autocratic features with democratic ones; they can simultaneously hold political repressions and regular elections. The term "hybrid regime" arises from a polymorphic view of political regimes that oppose the dichotomy of autocracy or democracy. Hybrid regimes are characteristic of resource countries (petro-states). Such regimes can be stable and tenacious.

Furthermore, hybrid regimes pay attention mainly to the decorative nature of democratic institutions (elections do not lead to a change of power, different media broadcast government point of view, the "opposition" in parliament votes the same way as the ruling party, etc.), from which it is concluded that authoritarianism is the basis of hybrid regimes, however, hybrid regimes also imitate dictatorship, while having a relatively lower level of violence.

We also have direct democracy or pure democracy, which is a form of democracy in which people decide on policy initiatives directly. This differs from the majority of currently established democracies, which are representative.

Switzerland is the closest state in the world having a direct democracy where citizens may challenge any law voted by the federal assembly. Switzerland's Executive, Judicial and Legislative institutions are organised on federal, cantonal and communal levels. Switzerland, unlike many other European states, does not have a president or a prime minister, and the country's citizens are at the pinnacle of power.

Its legislature is made up of the National Council and the Council of States. The Council of States consists of 46 members who represent the cantons. After every four years, the citizens of Switzerland



vote for 200 members to constitute the National Council.

The two chambers of parliament undertake legislative duties and their sessions in parliament are open for citizens to attend. Any citizen can challenge any law or amendments proposed by the federal assembly.

Six members constitute the Executive branch – the Federal Council of Switzerland. They engage in what we can term a collective presidency and are elected by parliament. Each of these members leads a federal department (ministry). The country's seven departments are Finance and Economy, Education, Internal Affairs, Defence and Sports, Energy, Traffic and Environment, and Justice.

The question here is whether the forms of government it has had have served Nigeria well. We have experimented with the parliamentary system. Though the army scuttled it midterm, even then Nigeria was already in deep trouble and wobbling as a nation.

We then went through the journey of nationhood under the military jackboots and yet again returned to representative democracy that was also scuttled and we found ourselves back in the stranglehold of the military.

Our current democratic journey is the longest in our nation's history. From the short-lived Abbey Westminster form

bequeathed to us by our colonial masters to another short-lived presidential system in the Second Republic, adopted because America was the bastion of democracy, we have come thus far and we have the belief it would last.

However, cries of marginalisation rend the air. Placing partisan interests above national interests is the order of the day; divisions along ethnic and religious lines have set in and the struggle for power and its retention have taken a "do or die" dimension, affecting the neutrality of the judiciary, the last hope of the common man.

By the day, the gulf in communication between the average Nigerian and his representative in government widens so much it seems they live in two separate worlds with nothing in common, perhaps except religion and tribe or party and town

Can we continue this way? Is it the fault of the system? Should we scout for a better system? Should we look inwards? Will a system in tandem with our inner being be the answer to our multifaceted and evergrowing problems as a nation? Perhaps we have been imposing on ourselves systems that are alien to us, to our culture, to our souls. We shall be examining this issue ahead, God willing.

Police Apprehends Self Kidnapper, Suspected Robbers, Cultists, Recovers Firearms Cartridges In Delta

middle-aged man who faked his own kidnapped for ransom and believed to have kidnapped his brother and wife, has been arrested by police operatives in Delta State.

He was reportedly apprehended at the spot where the sum of N1.3 million was earlier paid as ransom for the release of his elder brother and wife who died in the custody of kidnappers.

Our correspondent gathered that the suspect, identified as Eseoghene Ezekiel Obeje was arrested by police operatives attached to Oreropke Division, led by the DPO, CSP Paul E. Oboware at Odovie community Ughelli North LGA.

Prior to his arrest, Ezekiel, 28, was said to have called his elder brother, having been released after the payment of the ransom that he (Ezekiel) has been kidnapped and a ransom of N500,000 is being demanded, which was paid into his account.

The Delta State Police Spokesperson DSP Bright Edafe who made the disclosure in a

release on Sunday, said the arrest of the suspect was based on a marching orders by the Commissioner of Police CP Wale Abass to the DPO.

It reads, ":The Command has been investigating the murder of one Regina Ogana 'f' who was kidnapped alongside her husband and other members of her family on 02/08/2023.

":The Command received another distress call from the husband of the deceased that one of his brothers Eseoghene Ezekiel Obeje 'm' aged 28 made a suspicious call to him that he was kidnapped and that the kidnappers were demanding a ransom of Five Hundred Thousand Naira only (#500,000) and Money was transferred into the said Eseoghene's account as his ransom.

":The Commissioner of Police CP Wale Abass gave a marching order to the DPO Oreropke Division to embark on an intelligence-led investigation and ensure that the perpetrators are arrested.

":Consequently, on 11/08/2023, at about

1145hrs acting on technically generated information, operatives of the Divisional Anti-Crime Patrol team led by the DPO CSP Paul E. Oboware stormed Odovie community Ughelli North LGA and arrested the said Eseoghene Ezekiel Obeje at the same spot where the sum of One Million Three Hundred Thousand Naira (#1,300,000.00) was earlier paid as ransom for the release of his elder brother and husband of the deceased.

":Investigation revealed that the said Eseoghene is a member of Eiye confraternity, he faked his own kidnapped and is also suspected to have masterminded the kidnap of his brother and other family members which led to the death of Regina Ogana. The suspect is in custody and investigation is ongoing":

In a related development, Edafe said ":On 10/08/2023 at about 2130hrs, operatives of Rapid Response Squad (RRS) acting on a complaint received via petition, stormed Issele-Azagba community Aniocha North LGA, where one Igwe Uche 'm' aged

29yrs, Victor Agogozia 'm' aged 30 yrs, Afam Okoro Victor 'm' aged 30yrs, all residents of Issele-Azagba were arrested and upon search of the suspects, one locally made cut-to-size pistol, one single barrel gun, one live cartridge were recovered. Suspects and exhibits are in custody and effort is being intensified to arrest other members of their gang.


NNPP Extends Ogun Caretaker Chairman's Tenure By 3 Months

Of What Value Is Sanusi's visit And **Meeting With The Leader Of The Junta?**

write to advise that President Bola Tinubu streamlines his policy thrust and direction on the Niger Republic imbroglio to achieve the desired outcome as quickly and as cheaply as possible. As made abundantly clear, the policy objective of ECOWAS is the restoration of constitutional government in Niger; but the means of attaining this objective is being muddled up by flurry of unwarranted activities and persons.

ECOWAS gave an ultimatum which came along with punitive measures of economic sanctions, closure of borders, imposition of no-fly-zone and cutting off of power supply against Niger. But the response coming in from Niamey indicates neither the ultimatum nor the punitive measures shook the resolve of the junta in retaining power.

The regime seems undeterred! With such a resolve from Niamey, Abuja obviously has boxed itself in a corner as it became obvious that the punitive measures and threats of military action will not work. Hence the president then took the right approach that guarantees success - i.e. diplomatic dialogue!

He formulated a high and more sophisticated practical political/diplomatic approach to the issue, using the common historical denominator binding the communities of the Sahel for centuries as a means to achieving peaceful resolution of the crises. He rightly employed the services

of respected leaders, former Head of State Gen. Äbubakar AbdulSalaam and the revered traditional ruler, the Sultan of Sokoto, to undertake and implement the necessary diplomatic errand and mediation with the junta in Niger.

This highly placed envoy went and initiated discussions with the junta with great success. It returned and briefed the president on the next move forward.

Then all of a sudden, out of the blues, we saw pictures of the 14th Emir of Kano, Mohammad Sanusi II, along with the Emir of Damagaram in Niger Republic, surfacing with the head of the Nigerien iunta.

So what is the meaning of Sanusi's visit and meeting with the leader of the junta? By his own admission, he went there not on behalf of the president and government of Nigeria or on behalf of ECOWAS because already the Gen. AbdulSalam

envoy is still in place. He said he went there on his own initiative, thereby making the entire affair a freefor-all game.

This, certainly, does not portray the government in good light. Although he said government knew of his going, but how did he get into Niger given that government has officially closed both the land borders and air space?

This means that the borders are only closed on certain categories of people, making gibberish of the border closure policy. Even at that, did he inform his traditional leader, the Sultan, knowing that the latter is an official envoy of government on what was taking him to Niger?

I do not know, but I doubt it. If he did not, then it is an inexcusable fault. Since he was neither sent there by government nor unlikely to have informed the Sultan before going, his trip is therefore a breach of both state and traditional protocols. With all due respect, for him to have returned and briefed the president on the outcome of his private visit also tells so much on the lack of a clear cut

direction of government on this

I wonder what value Emir Sanusi's visit to Niamey will add in the resolution of the problem, other than further complicating things for government. Has the 14th Emir convinced the junta in Niger to relinquish power to the deposed President Bazoum?

Other than seeing the head of the junta and having a photo session, did he attain any milestone more than what the AbdulSalsm team attained? The answers to these questions are certainly in the negative! So what is the value of the visit to government? I bet nothing! For the value of it, the visit should not have been sanctioned by government in the

first place. Now what is the power? Or are they to go into only making the wrong choices president lost confidence in them! There is definitely a dearth on good advice in the presidency!

Then again things became further grimmer when the president yesterday received members of Nigerian Council of Ulamas, enjoining them to mediate with the Nigerien junta. With all due respect, one will have to ask - how? How are they going to mediate? Are they to go and meet the junta and talk to them to relinquish power? Or are they to meet their counterparts in Niger and admonish them to go talk to the junta to relinquish

For me, the best way forward is for the government to stick strictly to the Gen. AbdulSalam envoy already constituted and is at work. It is guaranteed to scale through and deliver the needed results. Any other thing will only cause confusion and portray the government as lacking in clarity and direction.
