

Don't be politically biased in fighting corruption, Accountant tasks Tinubu

member of the Anti-corruption Team Committee of Association of National Accountants of Nigeria (ANAN), Mr. Ishola Moses Abiodun has tasked President Bola Ahmed Tinubu not be politically biased in dealing with corruption cases in the country.

He made the disclosure during an interview with Newsmen at the 28th Annual National Conference of Association of National Accountant of Nigeria (ANAN) held in Abuja yesterday.

Mr. Abiodun who was also the Chairman of ANAN Kwara state chapter said " I can see that the crop of personalities and technocrats that President Tinubu is working with now i am confident he will not disappoint Nigerians.

" The President should not be politically biased about this issue of fighting corruption because just like the former president said if we don't kill corruption, corruption will kill us. Therefore, he needs to eradicate corruption totally in the corridor of the government.

The Expert also applauded President Tinubu for the removal of the fuel subsidy in the country arguing that he has blocked the cabals who are siphoning the country funds through fuel subsidy.

" Our people are dying of hunger and it's not easy in the country today talking about the hike in transportation, even if you're earning good salary today the minimum wage cannot satisfy the basic needs of a family.

Speaking on the theme of the Programme: 'The Accountancy Profession and the Changing Dynamics of the Ecosystem' Mr. Abiodun summoned that as Professional body we need to play crucial roles to be transparent in rendering services.

He said " as Accountants if we're upright in our offices almost half of the problems in the country will be solved because no money can come out in public offices without the Accountants approving it.

he commercial motorcycle operators commonly called Okada, in Kogi State capital, Lokoja yesterday, embarked on strike as they alleged that passengers accuse them of being responsible for their missing genital organs in the cause of transacting business with them.

Their displeasure with the unscrupulous passengers was made known by their state Chairman, Malam Umar Muhammed who vented their anger while interacting with newsmen in Lokoja yesterday.

He said that the image of Okada operators in down town Lokoka has been smeared by poverty stricken passengers who cannot afford to pay the transport fares charged by his members due to the economic hardship only to check criminally cause them of the crime.

According to him, several innocent Okada riders have been attacked by some of these fraudulent passengers who were unable to pay for their fares as they resort to branding them as responsible for their missing organs of production.

He said that passengers carried by the Okada riders labeled them of mysteriously harvesting their manhood after the transaction has been done and the passengers have no means of fulfilling their own part of the bargain leading to name calling and beating.

"Some of the passengers when they don't have money to pay, they raise alarm that their manhood is missing so that they will not pay and instead of them to take the issue to the police they take laws into their own hand and beat up the Okada commercial rider, only for the people to say that there manhood has returned back to their body", he said.

He therefore, called on the security agents and the state government to look into the issue with the aim of avoiding any problem that could lead to state of anarchy.

Represented by Deputy Director of institute, Professor Sani Yusuf said, the institute will continue to partner with women groups for more engagement.


Prof. Ikani warned the beneficiaries to imbibe the spirit of maintenance culture to enjoy the benefits for a very long time.

mongst the grounds upon which the candidate of the Peoples Democratic Party (PDP), in the last presidential election, Alhaji Atiku Abubakar, is seeking an overturn of the judgment of the Presidential Election Petition Court is its failure to take into cognisance the "Doctrine of Legitimate Expectation" regarding the failure of INEC to conduct the election in accordance with its own guidelines and the Electoral Act, 2022.

The doctrine of Legitimate Expectation was first developed in English law as a ground of judicial review in administrative law to protect a procedural or substantive interest when a public authority rescinds from a representation made to a person.

In Nigeria, the doctrine of legitimate expectation demands that a public authority shall respect and apply its stated position or sustained practice in exercising its powers on members of the public.

However, Atiku in his Notice of Appeal dated September 18, and filed by his lead counsel, Chief Chris Uche, SAN, submitted that the failure of the tribunal to apply the said doctrine is enough ground for the apex court to set aside the entire decision of the lower court

Specifically in ground seven of his Notice of Appeal, the former Vice President submitted that, "the lower Court erred in Law when it failed to nullify the presidential election held on February 25, 2023 on the ground of noncompliance with the Electoral Act 2022, when by evidence before the Court, the 1st Respondent (INEC) conducted the election based on very grave and gross misrepresentation contrary to the principles of the Electoral Act 2022, based on the "doctrine of legitimate expectation".

While pointing out that the Electoral Act 2022, made the use of Bi-modal Verification Accreditation System (BVAS) and INEC's Results Viewing (IReV) portals mandatory in the conduct of the 2023 general elections, adding that, INEC through its Chairman, Professor Yakubu Mahmood, publicly gave guarantees, undertakings, clear and unambiguous representations to candidates and political parties, that polling

units results were mandatorily required to be electronically transmitted or transferred directly by the Presiding Officers, he argued that, "there was no evidence before the lower Court that the 1st Respondent altered its aforesaid Guidelines and Regulations to remove the said requirement of electronic transmission of the results of the election directly from the polling units to the 1st Respondent's Collation System".

It is the submission of Atiku that, INEC "conducted the said Presidential Election based on the gross misrepresentation to the Appellants and the general voting public that the Presiding Officers were going to electronically transmit the results of the said election directly from the polling units to the 1st Respondent's Collation System.

He added that, "Contrary to the a b o v e u n a m b i g u o u s representations, undertakings and guarantees, the 1st Respondent neither deployed the electronic transmission of election results nor the electronic collation system in the said election, sabotaging the raison d'etre for the enactment of the new Electoral Act 2022 and the introduction of the technological innovations.

"Rather than hold the 1st Respondent (INEC) as a public institution accountable to the representations that it made pursuant to its statutory and constitutional duties which created legitimate expectation on the part of the Appellant's, the lower court wrongly exonerated the 1st Respondent of any responsibility by holding that the use of the technological innovations to guarantee transparency was not mandatory".

It was the appellant's further position that the February 25 poll was "conducted based on very grave and gross misrepresentation and was therefore oppressive to the Appellants and thus not free and fair, and not in accordance with the principles of the Electoral Act 2022, and not protected by the presumption of regularity, as well as the preamble and the fundamental objectives and directive principles of State Policy of the Constitution of the Federal Republic of Nigeria 1999 (as amended) adopted by the lower court.

"The grave misrepresentation

negated the legal presumption of official regularity in favour of the 1st Respondent.

Besides, Atiku told the apex court that INEC as a public institution is not above the law, and not entitled to breach its own regulations with impunity, after clear and unambiguous representations upon which parties have placed reliance and entitled to legitimate expectation.

"The said election ought to have been nullified by reason of the said gross misrepresentation by a public institution based upon the "doctrine of legitimate expectation" as applied by the Supreme Court as a policy Court...."


Accusing the tribunal of bias, the appellants stated in grounds 34 that the "lower Court erred in law in its use of disparaging words against the Appellants in its judgment evincing bias against the Appellants as Petitioners and thereby violating their right to fair hearing and occasioning grave miscarriage of justice.

The justices in their verdicts, while discountenancing the arguments and contentions of the Appellants used expressions such as 'ludicrous' (page 721 of the judgment), 'clever by half' (page 557 of the judgment), 'dishonourable practice' (page 507 of the judgment), 'smuggle' (page 557), 'fallacious' (page 721 of the judgment); 'foul play' (page 560 of the judgment), 'cross the line of misconception' (page 644 of the judgment); 'collect evidence from the market' (page 765 of the judgment); 'those who are not used to reading preambles' (page 726 of the judgment); 'hollowness in the argument of the Petitioners' (page 727 of the judgment); etc.

It is the position of the appellants that the choice of words and expressions by the lower court shows the lower Court's contempt and disdain for the Appellants.

"The lower court failed to use civil, modest, moderate, and temperate language that is befitting of the exalted position of the court in line with the Revised Code for Judicial Officers of the Federal Republic of Nigeria, promulgated by the National Judicial Council.

"The words against the Appellants in the judgment evince a disposition in the mind of the lower court that was far from objective, which approach



demonstrated bias and infringement to the Appellants' right to fair hearing.

"The Appellants were entitled to approach the Court for the ventilation of their grievances, which court was set up as the Presidential Election Petition Court, solely to receive petitions arising from the presidential election.

"The right to present an election petition in respect of a presidential election is a right granted by the Constitution of the Federal Republic of Nigeria, 1999 (as amended) and the Electoral Act 2022, which right the Appellants merely exercised. "The use of the said words and expressions substantially affected the lower court's consideration of the Appellants' case, peremptorily striking out their witness statements on oath, their exhibits, their pleadings, and discountenancing the evidence of their witnesses, and thus occasioned a grave miscarriage of justice", the appellants submitted.

Recall that the five-member panel of the tribunal had on September 6 upheld the declaration of Tinubu as the winner of the February 25 presidential election.

The panel in a unanimous

decision held that Atiku, as well as other petitioners against the February 25 presidential election, were unable to substantiate their allegations against the poll conducted by the Independent National Electoral Commission (INEC).

Specifically, the panel led by Justice Haruna Tsammani in their judgments held that, the documentary and oral evidences presented before them could not prove claims of irregularities, corrupt practices, noncompliance amongst other claims for which Atiku had asked the court to void Tinubu's election.

Dissatisfied, Atiku claiming that the lower tribunal erred in law in affirming the outcome of the February 25 poll, has amongst others asked the Supreme Court to set aside the entire decision of the tribunal.

Atiku, in addition, prayed the apex court to after voiding Tinubu's election, declare him as the authentic winner of the poll. Atiku, who came second in the poll, is claiming that he and not Tinubu actually won the majority of the lawful votes cast at the election, but the electoral umpire, however, manipulated the process in favour of Tinubu.

Mohbad: Police Vows To Unravel Cause Of Death, Sets Up Investigation Cmttee

he Lagos State Police Command has vowed not to leave any stone unturned in unraveling the cause of the death of a talented hip-hop artiste Ilerioluwa Oladimeji Aloba popularly known as mohbad, who died Tuesday last week.

The cause of his death has remained unknown as different accounts of circumstances surrounding the demise.

Consequently, the Inspector General of Police Kayode Egbetokun has directed the Lagos State Commissioner of Police Idowu Owohunwa to set into the matter to unravel the cause of his death.

Determined to unearth the cause of death, Owohunwa has begun the Investigation with the setting up of a 13- man Investigation committee.

Addressing the media on Monday while constituting the committee, the Commissioner of Police, Idowu Owohunwa acknowledged that the death of the musician has elicited loud responses and controversies,

adding that everything possible within the ambt of the law will be done to unravel the cause of the death.

He hinted that the Governor Babajide Sanwo-Olu and the IGP have shown commitment and support for the matter.

Owohunwa therefore called on bloggers and social media handlers to desist from posting whatever information at the custody that can assist in the cause of Investigation on the social media, but to the committee.

The Police Commissioner assured that all piece of information will be harnessed and filtered, just as he called on the general public to volunteer information to aid a speedy unraveling of the circumstances leading to the death of the 27year-old singer.

He said all allegations, insinuations and comments including videos on social media would be investigated, while adoption the best practices on homicide matter.

2023 International Day: Practicalise Peace, **GPFN Country Director Urges Nigerians**


*Kaduna PDP Chairman demands inclusiveness in appointments, provision of infrastructure



According to them, the wild allegations and ethnic profiling which have become the hallmark of the SDP's campaign in Kogi State, "are capable of compromising the peace and security of the electorate, officials of the Independent National Electoral Commission, election observers and other candidates in the state."

The CSOs said they came to this conclusion after painstakingly monitoring campaign strategies of various political parties participating in the November 11 gubernatorial elections in Kogi, Bayelsa and Imo states.

They pointed out that it was necessary to nip these activities in the bud to forestall possible security breaches and utterances that may provoke ethnic disaffection and electoral violence during the off-season polls.

The communique was signed by the Director of Research and Data Analysis of the coalition, Dr. Jaiyeola Isiaka, and jointly presented to the media, in Abuja on Thursday.

"The State's Police Commissioner recently had reason to caution the same SDP candidate as published by many media platforms not to drag him into the politics of the wild allegations he has been making which have the potential to overheat the

state prior to the election," the coalition said.

On how Bayelsa and Imo States have been faring since their campaign activities began, the communique said, "In Bayelsa State, the signs of security concerns are already surfacing but not so serious. The tone of campaign language between the two leading candidates of the APC and PDP is becoming more accusatory and volatile. Security

agencies must monitor the supporters of both leading candidates of APC and PDP in order to forestall any serious breakdown of law and order before, during and in the immediate aftermath of the election. Possibility and rate of violence is 35%.

The results are projected as follows: APC: 30% of the total votes to be cast; PDP: 40% of the total votes to be cast; Others: 30%.

"Imo State: The incumbent who is the candidate of the APC is a strong contender in this election. The influence of incumbency, among other things, are likely to work in his favour, all other things being equal. However, opposition Parties in the state are gathering significant momentum, especially the Labour Party.

"Our projections are as follows based on independent reports by organizations based in the state - APC: 35% of the total votes to be cast; PDP, 25%; and LP, 30%.

"Kogi State: Based on the reports of the Kogi State delegates at this conference and our research, the upcoming



100 Days Of Uncommon Leadership And Interventions At The Red Chamber: The Akpabio Model

President of the 10th Senate, Godswill Obot Akpabio, has always cut the figure of a determined and purpose-driven leader wherever the mantle of leadership falls on him since his burst into the political limelight in Akwa Ibom State as Commissioner in charge of three different ministries in 2002.

It was that emblematic assertiveness and affable disposition that made most Nigerians celebrate his emergence as the President of the Senate in a keenly-contested election on June 13, 2023, with majority of the people concluding that the emergence of the two-term Senator would be a great blessing to the National Assembly, the Presidency of Asiwaju Bola Ahmed Tinubu and Nigeria as a whole

One hundred eventful days down the line, that conclusion about the Akpabio Senate Presidency has not only been justified, it has also proved unassailable, with several decisive and nationalistic steps taken by the National Assembly lending credence to the absolute confidence reposed in Senator Akpabio, first by his party, the All Progressives Congress (APC) and then by his colleagues and Nigerians.

Akpabio's very first day in office, seemed to have reechoed the words of the first man on the moon, Neil Armstrong, who said his landing on the moon on July 20, 1969, was one small step for a man but one giant leap for mankind.

His emergence on the 13th of June, 2023 as the President of the 10th Senate was seen as a great step for the All Progressives Congress (APC), but a giant stride for Nigeria, the turf where Akpabio has remained a shining star and leading light for over 16 years.

Having served as commisioner for six years in three key ministries, as governor for two terms, Chairman of the Peoples Democratic Party Governors' Forum, (PDPGF), Senate Minority Leader as a first timer and later Minister Niger Delta Affairs before his eventful re-election as Senator in March 2023, after he had stepped down as presidential aspirant to support the aspiration of now President Bola Ahmed Tinubu, Akpabio has bestridden the Nigerian landscape as a political colossus and made great marks on its sands of time.

The vast experiences acquired in all these offices would bring a whole lot of good to the National Assembly, the Federal Government and Nigerians in general and this was the main reason his aspiration for the office of the President of the 10th Senate got the endorsements of the Presidency, the leadership of the APC and the 63 Senators who ensured that 'Godswill' was done on June 13 and they were not wrong going by the actions and achievements of the Akpabio Senate Presidency in the last 100 days.

In the aftermath of the election of the Senate leadership, Senator Akpabio brought his wealth of experience to bear on the constitution of Senate Committees



and the appointments of Committee chairmen such that the usual ruckus often associated with the exercise in previous National Assembly sessions was unheard of

In Godwill Akpabio, the Senate has had a sturdy leader, who is providing leadership by patiently coordinating the different tendencies within the Red Chamber by ensuring stability and it is exciting that this is just the beginning.

It is therfore not a surprise when Senator Basheer Lado, Convener of the APC Non-Serving Senators, commended Akpabio for his exemplary disposition in the composition of Senate Committees, stating that "the strategic composition reflects a remarkable display of leadership, inclusivity, and commitment to the overall progress and welfare of our great nation."

Even Akpabio's major challenger for the office of the President of the Senate, Abdulaziz Yari, noticed that selfless leadership traits in Akpabio, when he publicly described him as a selfless leader, when he dropped the gavel against the wish of the leadership of the Senate on the Senator Adams Oshiomhole face off with some Senators.

The Akpabio-led Senate had also displayed a rare disposition of nationalism quite early into the Akpabio Senate Presidency when it was confronted with a looming challenge occasioned by the removal of fuel subsidy by the President and the threat of a mass protest by the Nigeria Labour Congress and Trade Union Congress.

Represented by Senate Chief Whip, Ali Ndume, the Senate leadership was unequivocal about its commitment to ensuring that the system continues to run smoothly and that the interest of workers and the generality of Nigerians are respected by the Executive arm.

In what would go into the history books as one of the most impactful interventions that thawed the ice of the Federal Government-Labour Union face-off, the Senate had asked for Seven days to wade into the crisis and in those Seven days, the warring parties were, indeed, able to reach a compromise and avert what would have been the mother of all protests.

The Senate under Akpabio, apart from intervening in the NLC, TUC and FG industrial face off, it also played a major role in bringing to an end the strike and planned public protest by the members of Nigeria Association of Resident Doctors (NARD). In the same vein, Senate moved vehemently against the planned increment of electricity tariff by DISCOS in the wake of the removal of fuel subsidy, through a well endorsed motion which saw to the stoppage of the tariff increase.

It is also interesting to note how the Senate President oversaw a seamless and smooth screening and confirmation of ministers, who will work with President Tinubu to bring about the Renewed Hope Agenda promised Nigerians. Unlike previous screenings, where thoroughness and excellence were sacrificed on the altar of partisanship, Senator Akpabio ensured that he guided the Senate to offer qualitative screening while not hurting party loyalty and other democratically-lawful tendencies associated with such screenings.

When it was time for confirmation, the Senate leadership demonstrated an uncharacteristic courage in ensuring that the screening was not a mere academic exercise, as it also went ahead to turn

down some nominations based on findings from the screening exercise. In the end, only 45 of the 48 nominations sent by the president were confirmed by the Senate. That is the kind of courage for which Akpabio has been renowned over the years.

Everywhere he had been, Akpabio's penchant for etching his name in gold and emblazoning his excellent leadership identity on the hearts of the people has become a major credential that makes those who believe in him insist on him as the go-to man whenever tough leadership decisions are to be made.

Never one to shy away from taking initiatives in the interest of his people, what the former Governor of Akwa Ibom State started by redefining governance in Akwa Ibom and setting a major template for governors in terms of infrastructure development and people-centric leadership has become an identity that weathers all storms.

Also emblematic for the President of the Senate is his burning desire to make Nigeria work.

Even when he had to take personal risks, as was the case when he was the Minister of Niger Delta Affairs and he had to visit Tompolo in the creeks, to broker peace in the interest of the nation, Akpabio has remained the shining example of courageous leadership.

While campaigning to occupy his current position, he had promised Nigerians that the National Assembly under his watch would work for Nigeria and Nigerians and would rubber stamp anything that would be in the interest of the generality of Nigerians. His disposition and handling of the affairs of the Senate in the last 100 days has shown that he is not in anyway prepared to deviate from that solemn pledge to Nigerians.

As the President Tinubu administration goes on, the Presidency and, indeed, Nigerians can look forward to a stable, purposeful Senate that will work hard on its own end of the bargain to ensure the success of the Renewed Hope mandate of the President.

But there is something else they should look forward to; they should expect a courageous Senate leadership, one that will put the Executive arm on "its toes" in the overall interest of the Nation.

In Akpabio, Nigerians have a fearless leader, who will put his feet down when need be for the common good of the Nation; an uncommon leader, who will achieve uncommon feats as President of the 10th Senate.

His first 100 days in office have proven that much.

Lagos Police Arrests 3 Over Murder Of Ogun Senator's Aide, Recovers 3 Firearms, Ammunition, Army Wears

he police in Lagos have eventually arrested the suspected fleeing killers of late Sani Adeniyi, a personal assistant to Senator Solomon Olamilekan, representing Ogun West Senatorial District of Ogun State.

Three firearms which include one Brownie pistol with three rounds of live ammunition, one Beretta pistol with three rounds of live ammunition, one locally made cut-to-size pistol with six live cartridges, six expended cartridges, military camouflage vest, military jungle hat, military holster, jungle boots and one Red Honda CRV with reg no EKY 276 JD, also hijacked from a yet to be identified victim were recovered from them.

The suspects, identified as Fred Azeez Okunnu 43, Lucky Idudu Micheal, 33 and Adedigba Segun, 26, were said to have been apprehended after weeks of long painstaking, diligent and discreet intelligence and investigative sets of actions.

The Commissioner of Police Lagos State Police Command Idowu Owohunwa, made the disclosure while parading the suspects Monday at the Command headquarters in Ikeja,

His words, " Operatives of the Lagos State Police Command have arrested three notorious suspects behind the dastardly murder of Mr Adeniyi Sanni which occurred between 1am

and 2am on August 5, 2023 robbery.

" The arrest of the suspects one Fred Azeez Okunnu 'm' aged 43, Lucky Idudu Micheal 'm' aged 33 and Adedigba Segun 'm' aged 26 follows weeks-long painstaking, diligent and discreet intelligence and investigative sets of actions.

" Items recovered from the suspects are one Brownie pistol with 3 rounds of live ammunitions, one Beretta pistol with 3 rounds of live ammunition, one locally made cut-to-size pistol with 6 live cartridges, six expended cartridges, military gear (military camouflage vest, military jungle hat, military holster, jungle boots), and one Red Honda CRV with reg no EKY 276 JD, also hijacked from

While shielding light on the activities of the notorious gang, Owohunwa said, "Investigation revealed that this gang which is being armed by one Alhaji (based in Benin Republic) specializes in robbing motorists of their unregistered vehicles. The gang have been successful in five previous

On its modus operandi, he said, " Their modus operandi includes stationing one gang member some meters from Berger bus stop to spot unregistered vehicles.

" The spotter then calls his gang



somewhere around Berger bus stop to inform them of the approaching vehicle. Once they stop their victim, they request for the vehicle custom papers, as they would need to clear security and customs checks.

"In this incident, after seeing the papers, they insisted on taking their victim to their base. Once they entered the vehicle, it dawned on Mr Sanni that they were robbers.

" He called out for help, which made the robbers shoot him thrice and further stabbed him.

"They dropped his corpse by the

roadside and drove to Kuto, Abeokuta where they cleaned up the blood stains in the rear seats of the vehicle and later same night proceeded with the vehicle to the border town of Chikunda in Kwara State where the criminal receiver took delivery of the car".

On why they put on military wears, the Police Commissioner explained that the suspects adopted the use of military fatigue to beat checkpoints.

Owohunwa also hinted that further investigation has revealed that the said Alhaji has

other cells operating across the country.

On efforts to arrest the said Alhaji, Owohunwa said, "Being a transnational crime, the Command is involving the Interpol for the apprehension of this criminal receiver and financier".

It would be recalled that Adeniyi was gruesomely murdered by some gun men suspected to be soldiers of the Nigeria Army on 5th August, 2023 along Ojudu Berger area of Lagos at about 1.00am.
