### APC, PDP claim victory

onfusion has trailed the ruling of the Kadunà State Governorship election petition tribunal as the ruling All Progressives Congress (APC) and main opposition People's Democratic Party (PDP) are both claiming victory. This follows the verdict delivered via zoom in Kadunà yesterday, where two justices declared the election inconclusive, while ordering a rerun, while one upheld the victory of the APC at the March 18, 2023 polls.

Governor Uba Sani in a statement signed by his Chief Press Secretary, Muhammad Lawal Shehu, lauded the tribunal for its verdict, which he described as a welcome development.

## Ensure Release Of Abducted Corps Members, NUJ Urges FG, DG NYSC

he Akwa Ibom State Council of Nigeria Union of Journalists (NUJ) has expressed resentment over continue holding in captivity of corps members by suspected bandits from the northern part of Nigeria.

Recall eight prospective corps members of Akwa Ibom State origin were kidnapped over six weeks ago by unknown gunmen along Zamfara-Sokoto Road while traveling to place of primary assignment in Sokoto. NUJ during its September Congress in Uyo on Wednesday, resolved with a call to federal and state governments, Director-General of the National Youth Service Corps, NYSC, and relevant security agencies to ensure the release of eight abducted corps members unhurt. The position of union came under the State of the Nation as captured in agenda for the day's business.

Congress also worried with bitterness the recent resurgence of motorcycle operations within Uyo metropolis, which Congress noted has led to a rise in criminality within the capital city, and therefore, called on security agencies to halt the drift. It also lent concern over the menace of erosion at Nung Ukot Itam and Ekit Itam in Itu local government area of the state, and called on the state government to intervene in order to save lives and property in the communities. The union decried the continued refusal of Akwa Ibom State Environmental Protection & Waste Management Agency, AKSEPWMA, to cover the drains on Abak Road, a development that has exposed pedestrians to serious danger.

Congress was also worried over blocked gutters in Uyo metropolis and urged AKSEPWMA to double its efforts in this direction while also called on AKROIMA to urgently address the embarrassing and rising cases of potholes in the state.

Congress applauded the state governor, Pastor Umo Eno for what members described as his commitment to the completion of the Auditorium Project at NUJ Press Centre in Uyo and solicited more partnership to enable the Union do other projects.

Congress congratulated the new executive of the state chapter of

#### Lagos Taskforce Set To Impound, Prosecute Owners Of Vehicles Parked On Road, **Unapproved Spaces**

he Lagos State Taskforce has sounded a note of warning to Night club owners in the state against parking their vehicles and that of their customers by the road setback and walkways meant for pedestrians passage.

This was made known by the Chairman of the Agency, CSP Shola Jejeloye at the Headquarters, Bolade Oshodi where he received some representatives of Cubana Hut and Grill Night Club, Ikeja

Jejeloye decried the spate and manner in which vehicles of attendees of night clubs park by the road side and sometimes occupy multiple lanes meant for road users and then cause traffic gridlock. He addressed them on the plans of the taskforce to nip this problem in the bud and put a final stop tothis avoidable acts.

"This meeting was called to appeal to you again to warn your customers. Provisions and laid down guidelines have been made known by State Government as to how and where to park vehicles especially in residential areas like Ikeja GRA but you find some night club owners willfully directing their customers to park right on the road and walkways, thereby inconveniencing other Lagosians. This is the

highest form of insensitivity and we will put a stop to it."

One of the representatives of the Night Clubs present, Mr. Daniel Akabiro who also double as the Facility Manager for Cubana hut and grill stated that they carry out their activities according to the limits of the law and ensure that parking of vehicles are according to the stipulation of Lagos State Parking Permit Authority (LASPPA). He promised to relay the warnings of the State Government to the necessary stakeholders in the industry and ensure that Night Club owners tow the line of best practices in parking of their vehicles.

According to a release by Gbadeyan Abdulraheem, Director, Press & Public Affairs of the Agency, the Chairman further urged them and other operators across the state to desist from parking haphazardly while carrying out their personal business. He said that any night club that cannot accommodate its customers should find an alternative to do so.

"Lagosians have every right to utilize every amenity provided by the State Government and we will ensure that those rights are not deprived of them by Nigh club owners. Customers of these entities should have ther vehicles parked at the authorised parking spaces approved by the Lagos State Government"

Jejeloye stated that this is the third in the series of meetings called to appeal to night club owners to tow the line of best practices and provide a parking space for their customers. He however said that anytime from now the Agency will move in to compel compliance.

He warned anyone whose vehicle is seen parked illegally that such vehicles would be impounded and the owner prosecuted according to the provisions of the law.

He concluded that Shobo Arobiodu, Isaac John to connect with Oduduwa Crescent and other streets around the area have become impassable for motorists due to the indiscriminate parking, hooliganism, thuggery and illegal markets operating around the axis. All these infractions will be checkmated soonest.

#### **Subsidy Palliative: Nigerian Railway** Introduces Express Passenger Train

igerian Railway Corporation (NRC) has disclosed its intention to introduce Mass Transit Express Passenger Train service between Apapa in Lagos State and Kajola in Ogun State.

The Express Passenger Train will run on standard gauge railway line.

Deputy Director, Public Relations of NRC, Mr. Yakub Mahmood, said the initiative is part of federal government's measures to cushion the effect of the petroleum subsidy removal to the barest minimum on the citizenry. "This was disclosed by the Director of Operations of the corporation Mr. Akin Osinowo on behalf of the Managing Director Engr.

Fidet Okhiria," the DDPR wrote in a Press release titled, "Railway Introduces Apapa-Kajola Express Train."

The stopping stations for the Apapa-Kajola Express Train include Mobolaji Johnson, Agege, Agbado and finally Kajola, Mahmood stated.

The management of Nigerian Railway Corporation expressed hope that "this train service will surely reduce the hardship experienced by commuters, especially those plying Apapa to Kajola route."

The corporation appealed to passengers to ensure that they obtain tickets at the designated stations before boarding the train.

# Atiku To Tinubu: You Can't Hide Under Privacy Law \*Asks judge to speed up process to beat time limit

he candidate of the Peoples Democratic Party (PDP), in the last presidential election, Alhaji Atiku Abubakar, on Wednesday, told President Bola Ahmed Tinubu, that he cannot use the excuse of privacy law to stop the release of his academic records from the Chicago State University (CSU).

Atiku, who stated this in his reply to Tinubu's objection to the order of Magistrate Judge Jeffrey Gilbert, maintained that Tinubu's objection was incompetent and lacking in merit.

According to the former Vice President, all the grounds of objections raised by Tinubu against the execution of the lawful order of the magistrate court were resolved by Justice Gilbert after listening to parties. Recall that the court had on September 19, held that Atiku's

application for discovery outweighs Tinubu's plea for protection under the privacy law. Tinubu had, amongst other grounds, for the denial of Atiku's request submitted that Judge Gilbert erred in directing the CSU to release documents bordering on Tinubu's Diploma certificate, transcripts and admission letter amongst others. But Judge Gilbert pointed out

that the case of Atiku has merit as it has to do with Tinubu's qualification for the 2023 presidential election, which he (Tinubu) won.

Dissatisfied, Tinubu last Thursday begging a Federal High Court presided by Judge Nancy Maldonado to delay the enforcement of the order till Monday, September 25, when he would formally file his objection.

At Monday's proceedings, Tinubu had, amongst others, argued that the granting of the order violates his right to privacy and breached the US law regarding the release of academic records.

Specifically, Tinubu had argued that what the discovery Applicant seeks is intrusive because educational records are private and protected from disclosure under the Federal Educational Records and Privacy Act, 28 U.S.C. § 1232(g) ("FERPA").

But Atiku, in his latest move, argued that the law of privacy pleaded by Tinubu to stop the release of his academic records was not relevant in this instance. Atiku's lawyer, Angela Liu, in her reply, pointed out that the FERPA and analogous state laws do not create an independent privilege for educational records and cannot serve as a shield

against a court-issued subpoena. According to the applicant, "the assertion of a privilege or privacy interest under FERPA is a nonstarter; the statute does not give individuals any enforceable rights", adding that, "FERPA does not provide a privilege that prevents the disclosure of student records."

Moreso, Atiku argued that Tinubu cannot plead protection when he "has placed its educational records at issue, ECF 40 at 25-26 (explaining that Intervenor put his diploma at issue by submitting it to INEC and Tinubu's records have already been introduced into the Nigerian proceedings, including by Tinubu himself, and widely published in the media".

Stating further that through various proceedings, Tinubu has submitted his own educational records for consideration by courts and indeed by the public, Atiku submitted that Judge Gilbert correctly decided that the balance of the Intel discretionary factors weigh in favor of granting the discovery.

"The Objections are meritless." Apparently justifying the need for Tinubu's contentious academic records to be released, Atiku insisted that a mechanism exists in the Supreme Court of Nigeria to admit fresh evidence. He cited Supreme Court Order 2,

which reads in part, "A party who wishes the court to receive the evidence of witnesses (whether they were or were not called at the trial) or to order the production of any document, exhibit or other thing connected with the proceedings in accordance with the provisions of Section 33 of the Act, shall apply for leave on notice of motion prior to the date set down for the hearing of the appeal.

"The application shall be supported by affidavit of the fact on which the party relies for making it and of the nature of the evidence or the document concerned.

"It shall not be necessary for the other party to answer the additional evidence intended to be called but if leave is granted the other party shall be entitled to a reasonable opportunity to give his own evidence in reply if he so wishes".

While stating that his application is a straightforward Section 1782 application, Atiku submitted "Contrary to Intervenor's inflated rhetoric, Applicant is not seeking "to conduct a fishing expedition into Intervenor's private, confidential, and protected educational records.

"Rather, Applicant seeks to test (1) the authenticity and origin of twelve (12) pages of documents (including two very different diplomas) that purport to have been issued by CSU (the "CSU documents")—all of which have already been submitted to the Nigerian courts and widely published in the media; and (2) the basis for CSU's categorical assertion that Tinubu received a B.S. degree in 1979, given discrepancies between information in the CSU documents and information in his affidavit submitted to INEC.

"If, as Intervenor asserts, he graduated from CSU in 1979—and the CSU documents are authentic copies issued by CSU—there is no reason why he should oppose the limited discovery Applicant seeks.

"For the foregoing reasons, the Court should overrule the Objections in their entirety.

"If the Court overrules the Objections, Applicant respectfully requests that it enter an order requiring production of documents no later than October 2, 2023, and the deposition scheduled no later than October 3, to allow time for transcripts to be finalized, and the discovery obtained to be sent to Nigeria (which is six (6) hours ahead) by October 4 so that such evidence may, in turn, be filed with the Supreme Court by October 5, which is when Applicant's Nigerian counsel intend to submit any new evidence to the Supreme Court", he said.

# Labour Party Lagos Assembly Member Loses Seat To APC

he House of Assembly Election Petition Tribunal sitting in Lagos has sacked the lawmaker representing Amuwo – Odofin Constituency I, Foluke Osafile, elected on the platform of the Labour (LP) and declared Folorunso Olusegun of the All Progressives Congress (APC) popularly called Ola Western, as winner of the March 18 polls in the state.

It faulted the Independent National Electoral Commission (INEC) for declaring Osafile, who contested on the platform of the Labour Party (LP), winner of the polls after reviewing petitions and defense presented before the three-man panel by parties and candidates that contested the election.

The court ruling came barely a week after she was appointed by Speaker of the House, Mudashiru Obasa, as the chairman, House committee on Wealth Creation and Employment.

The development was confirmed by Lagos APC chairman, Cornelius Ojelabi, and Osafile, through statements released on their official social media handles after the judgement.

Osafile, who rejected the tribunal judgement, disclosed that he would be heading to the Appeals Court to reclaim her mandate which was gotten through the ballot.

She said: "By now, I believe it must have come to your k nowledge the new development as related to our electoral case at the tribunal that did not go in our favour earlier today.

"While the judgement is unacceptable by all standards and as far supreme court precedent is concerned, I want to appeal to all our esteemed supporters across the constituency to maintain the same law and order that we are known for over the years as peace loving people. I will like to assure you all that the tribunal judgement will be appealed and we shall get the appeal court judgement in our favour.

"I will continue to perform my legislative duties as enshrined in the constitution while the appeal judgement last. This is mandate of the people and we will see that the right thing is done", Osafile added.

On the part of Ojelabi, the party chairman described the judgement as the actualisation of the APC aspirations before the 2023 election in the state.

He said: "It is 40/40 for APC at the Lagos State House of Assembly. Earlier today, I received the joyful news of Hon. Folorunso Olusegun (Ola Western) of Amuwo – Odofin Constituency I winning at the Election Petition Tribunal sitting in Lagos State.

"Congratulations to the good people of Amuwo – Odofin and all progressives across the state", he added.

people of Kaduna State. I also thank the people of the state for widely believing in me and the PDP.

"Also, given the ruling of the Kaduna state election tribunal, it has become necessary to share with our teaming supporters, the true position of the ruling.

"On the preliminary objection, the tribunal, based on the majority of 2:1 judges upheld the preliminary objection of the respondent to the effect that the application for pre-hearing was done prematurely i.e. before the service of the last set of petitioners' reply to the 2nd respondent's reply to the petition was served.

"How

ever, the law enjoins the tribunal, as a trial court, to proceed to pronounce on the merit of the substantive suit so that in the event the court of appeal finds that the trial tribunal was wrong in its decision on the preliminary objection, it would have the benefit of pronouncing on the decision of the tribunal in the substantive matter.

"Accordingly, the trial tribunal finds merit in the aspect of the petitioner's case relative to the margin of win between the two leading candidates.

"The tribunal by a split decision of 2:1 accordingly, nullified the election of the governor of Kaduna state, ordered that the Certificate of Return be retrieved and fresh elections be conducted in some polling units in 4 LGAs and the outcome thereof be reckoned with before the declaration of the winner of the governorship election in Kaduna State.

I want to again thank the people of the state while urging them all to remain law abiding while we pursue the appeal process.

"One thing I can assure the good people Kaduna state is that I will pursue this mandate you freely gave me to its logical conclusion and by the grace of God, victory on our side," he declared.



#### Eze Ndigbo Of Ibadanland's Death, A Personal Loss - Olubadan

move to its permanent site so TETfund which has enlisted the Polytechnic for intervention can begin to do the needful.

Responding Governor Muhammadu Inuwa Yahaya expressed gratitude to both visitation panels for writing their names in the annal of history pertaining the growth and development of institutions of higher learning in particular and the state in general.

Represented by the Secretary to the State Government, Professor Ibrahim Abubakar Njodi the Governor stressed that his administration was deliberate in setting up the panels in order to have a bird side view of where and how the state government can intervene in order to enhance effective teaching and learning in the various institutions of higher learning across the state.

Governor Inuwa Yahaya noted that visitation panels are a necessary ingredient in the administration of higher institutions and therefore assured members that the state government will carefully study the reports and implement same within available resources.

"In the first place no one forced us to set up the panels; so be rest assured that the state government will work with your findings and implement your recommendations in order to make teaching and learning in our institutions of higher learning more effective", the Governor assured.





The statement stressed that the meeting which lasted for several hours, was called by the University management, after several agitations by the students union for a reduction of the initial charges approved by the University.

Vice Chancellor of the University Professor Adebayo Simeon Bamire announced that the charges initially announced have been reduced as follows:

"For the students in Humanities, the initial sundry charges of N89, 200 for returning students have been reduced to N76,000 while the new students in the Humanities, the initial fees of N151,200 have been reduced to N131,000.

"For those in the Sciences and Technology, the initial charges of N101,200, for returning students is now N86,000 while the new students in the same Faculties will now pay N141,000 instead of the initial N163,200.

"The returning students in the Pharmacy and College of Health Sciences will now pay N109,000, instead of N128,200. The new students in the same Faculties will now pay N164,000 instead of the initial charges of N190,000."

The statement added that the University management has agreed that the payment can be in two equal installments.

It stressed that the University portal is now open to students for payment.

#### Diphtheria Claims 453 Lives Mostly Children In Nigeria, **UNICEF** Raises Alarm

\*Deploys 9.3m doses of diphtheria vaccines to Kano, Bauchi, Borno, Yobe, Katsina, Kaduna, Jigawa

he UNICEF representative in Nigeria, Dr. Rownak Khan on Wednesday, raised the alarm over the outbreak of severe Diphtheria, particularly among the children in Nigeria.

UNICEF Nigeria in a statement made available to journalists, called for urgent need for widespread vaccination to curb the spread of the

According to Dr Khan, "the outbreak has so far resulted in over 11,500 suspected cases, more than 7,000 confirmed cases, and claimed the lives of 453 people, mostly children.

It stressed that, "most cases are children aged between 4 to 15 years who have not received even a single dose of the vital vaccine, laying bare the urgency of the vaccination situation in Nigeria.

"UNICEF is providing urgent support to the Nigerian government in its efforts to combat the outbreak. A crucial part of this support includes the procurement of vaccines to support the government's response".

Dr Khan added, "So far, on behalf of the government, UNICEF has deployed 9.3 million doses of diphtheria vaccines to affected states including Kano, Bauchi, Borno, Yobe, Katsina, Kaduna and Jigawa.

"Of these, four million doses have been dispatched to Kano, the epicentre of the outbreak. Another four million doses of vaccines are being procured and will be handed over to government in the coming weeks."

He stressed further, "The devastating impact of this diphtheria outbreak is a grim reminder of the importance of vaccination. Nigeria is home to a staggering 2.2 million children who haven't received even a single dose of vaccine - the second largest such cohort in the world.

"We must collectively take urgent actions to drastically reduce this number. Every child deserves protection from preventable diseases. This is not negotiable".

UNICEF Nigeria then called on partners, stakeholders, and the international community to rally together to ensure that every child in Nigeria is reached with life-saving vaccine, emphasizing the importance of strengthening routine immunization, community engagement, and health systems to avoid similar outbreaks in the future.

He maintained that, "to respond effectively to the outbreak, UNICEF Nigeria needs to raise an additional US\$ 3.3 million until the end of the year".

# My Rejoinder To The Cable Story: "Ex-FIRS Boss Nami Approved N11bn 'Suspicious' Payments After His Exit

y attention has been drawn to a mischievous story by the Cable Newspaper claiming that I made approvals of over N11 billion after taking my pre-retirement leave. Nothing can be further from the truth. The entire story was sensationally written with mischief that took the ordinary events of my work out of context with the intent to tarnish my image.

First and foremost, I want to categorically state that after my exit as FIRS Executive Chairman, I made no such approvals as claimed in the report.

Fundamentally: It is important to note that no payment was made by the Service after the announcement of my preretirement leave as claimed by this story. An approval for payment in the Service is one step of a journey to payment. It is the custom that when a new Executive Chairman resumes office, he would review, validate and make final authorisation before any payments can be made.

It is important to note for the record that all decisions reached and extant liabilities/ commitments of the Service during my stay in office are contained in the handover notes I made

available to my successor, Mr. Zacch Adedeji. He is fully briefed on everything. For clarity the items listed in the Cable Newspaper Report were part of the N16 billion outstanding commitments contained in our handover note.

The N5 billion paid to Joint Tax Board was paid to fund the activities of Presidential



Committee on Tax and Fiscal Policy Reforms two months before I left office. It was paid after we received a letter to that effect from the office of Mr. President signed by Zacch Adedeji himself.

The report maliciously attempts to portray a picture that I hurriedly left the country on September 16th after these so called

"suspicious approvals" were made. Again, nothing can be further from the truth. If I traveled out of the country on the 16th of September, how then did I attend the handover ceremony with Mr. Zacch on the afternoon of Monday 18th September 2023? That handover ceremony was covered by the media, and can

be cross-checked.

It is disappointing to see the Cable, a revered online newspaper attempt to sensationalise events that took place in the ordinary course of my work in office, making them seem as if they were done in bad faith.

I want to categorically state that every decision I made within the time of my stay in office was within the ambit of the law and within the lawful powers I exercised then as Executive Chairman.

I inherited only N1.4 billion in the purse of the FIRS when I assumed office. I left N129 billion in the purse of the Service when I left.

peratives of the Rivers State Command of the Nigeria Immigration Service (NIS) have been charged to discharge their duties in a humane manner.


