Speaking on the sidelines of the flag off, Gerida Birukila, UNICEF Chief of Kaduna Field Office, said the beauty of having the trucks is people are able to have access to healthcare facility without traveling far

"The beauty of the trucks is that they are able to go to people who are not able to get to the health facility because is too far from them. So for now we are prioritizing communities that are five kilometers from the PHCs.

"You can imagine a pregnant woman traveling 10 to 15 kilometers, which is not possible, this is one of the major reason for

Lawyer Advises Journalists To Consider Public Safety while Reporting

Tournalists have been urged to consider the legal and security implications to themselves and to the general public in their reportage of sensitive issues.

A lawyer, Eze Chinagorom Ndubuaku made the call in Abakaliki capital of Ebonyi State.

He spoke during a one-day training for journalists in the state, organized by Ikenga Media & Cultural Awareness Initiative (IMCAI) publishers of Ikengaonline Newspaper.

The workshop was organised with the support of the Wole Soyinka Centre for Investigative Journalism and John MacArthtur Foundation.

Mr Chinagorom, an Assistant Superintendent of Police working in the Legal Department of the Police on Ebonyi State, noted that the decision to disclose information and accept the risk of news coverage should be carefully considered, weighing the benefits against the potential risk and red flags associated with the information. He advised against reports that may lead to breakdown of law and order or worsen existing crisis.

He urged Journalists to evaluate whether the dissemination of the information could cause harm to innocent individuals or negatively impact their lives.

According to him, "If it puts others at risk, it may not be worth the risk of news coverage.

"If the information puts individuals or their loved ones at risk of physical harm or jeopardize their personal safety, it may not be worth the risk of news coverage.

"Also, Journalists should consider whether the

information is of significant public interest or importance. If it is trivial or irrelevant, it may not be worth the potential risks associated with news coverage", he said.

He further urged journalists to be mindful of the source of the information and the motive for presenting them with the information.

He warned against relying on information from politicians and politically exposed individuals who may have ulterior motives.

He said, " If the information comes from unreliable or unverified sources, it should be treated with caution. Journalists should verify the credibility and accuracy of their sources before relying on them for reporting.

"If the information is based on unverified or unreliable source, it may not be worth the risk of news coverage, as it could damage one's reputation or credibility", he said.

The lawyer also warned Journalists to be wary of legal implications in order not to run foul of the law.

He said, "If the information is illegal; or involves illegal activities, it is important to carefully weigh the potential; consequences of news coverage including potential legal actions or repercussions.

"For instance, Section 12 (1) (a) and (b) of Ebonyi State Internal Security Enforcement and Related Matters Law 2009 criminalizes Causing Extreme Fear and Threat to Life by use of letters, phone calls and other electronic methods.

"Section 14 of the same law criminalizes false information. The Cyber Crime (Prohibition Prevention etc) Act, 2015 criminalized Cyberstalking, Cybersquatting and Cyber Terrorism. The Evidence Act

2011 alongside some consequential amendments now allows electronically generated evidence during proceedings", he said.

Mr Chinagorom further advised journalists to also consider whether the information violates any ethical guidelines or principles.

"If it involves invasion of privacy, breach of confidentiality, or harm to vulnerable individuals, it may not be worth the risk.

"Overall, playing it safe during news coverage is essential for journalists to protect themselves, their sources and the public interest while maintaining their credibility and adhering to legal and ethical standards", he added. The workshop had in attendance journalists from various national and local media houses in the state.

APC To Gov Makinde: Account For FG N5bn, Other Palliative Items Donated To Oyo State

he All Progressives Congress (APC) in Oyo State on Tuesday, demanded details of funds and food items donated to the state by the federal government as palliatives to cushion the effects of hardship on the people of the state.

APC expressed this in a statement by its Publicity Secretary, Comrade Olawale Sadare, made available to newsmen in Ibadan.

The party in the statement lashed out at the PDP administration in Ovo state for deliberately withholding information relating to the receipt, distribution and management of funds and food items delivered to

Oyo state government as the share of the good people of the state

Oyo APC stressed that "virtually all the states of the federation have declared the receipt of, at least, two billion naira out of the five billion which federal government has earmarked as funds to be paid to the poorest of the poor through the states".

"Last week, neighbouring Osun and Kwara states acknowledged the payment of the sum of two billion naira to their purse but Gov. Makinde kept this away from the public knowledge", it said.

APC added, " For about six weeks now, the whereabout of the three thousand bags of rice which Gov. Makinde got


from Abuja remains unknown to the people of the state and there are indications that these have been allegedly diverted the same way they did with Covid-19 relief materials presented by federal government, corporate organizations and individual philanthropists".

"We also put it to Gov. Makinde to explain the reason behind his order on local government council Chairmen to allegedly transfer (to the state government account) the two tranches of N56 million paid to their council accounts between August 16 and 18 this year by the federal government as the shares of the third tier of government"

The party alleged further that " The 33 local government councils in the state got a total of N3.696b but they could not utilize a dime from the funds for the purpose which the money was meant to serve."

"It is evident that the orchestrated Palliative Committee set up by Gov. Makinde about four weeks ago was just to fool the public as the committee would not have anything to do in the long run.

We won't be surprised though if the state government released would be a few bags of rice and noodles to the Committee in the coming days and ask them to distribute same to few PDP members just to create an impression that the target population of poor people in the society have benefitted.'

LASTMA Disclaims Towing Van Driver Nabbed Stealing Vehicle With LASTMA Logo

he authority of the Lagos State Traffic Management Authority (LASTMA) has distanced itself from a towing van operator that allegedly stole a car, using a towing van with LASTMA logo.

It described the suspect named Adejumo Fatai as an impersonator that uses fake LASTMA identity card and fake towing franchisee's sticker.

The Agency in a statement by the Director, Public Affairs and Enlightenment Department Mr. Adebayo Taofiq disclosed that the said driver of the towing vehicle was not an official of the Lagos State Traffic Management Authority LASTMA.

It reads, "The attention of the Lagos State Traffic Management Authority LASTMA has been drawn to a video circulating on social media alleging the use of LASTMA Towing van to steal a vehicle as early as 6am at Somolu area of Lagos.

Subsidy Removal: Gombe Govt Approves N10,000 Increment in Workers' Salary

he Gombe State Government has announced an increment in workers' salary by N10,000 across board to cushion the effect of fuel subsidy removal.

Briefing newsmen in Gombe, the Deputy Governor, Dr. Manassah Daniel Jatau said it was part of the measures taken by Governor Muhammadu Inuwa Yahaya to reduce the economic impact of the subsidy removal on workers.

He said that Gov. Inuwa Yahaya is concerned about the welfare of civil servants and residents of the state through various interventions since the COVID-19 pandemic.

He said since the fuel subsidy removal, the state government had taken measures towards cushioning its effects on citizens of the state by distributing palliatives to 30,000 beneficiaries with the target of reaching out to 420 000 across the state.

According to him, the N10,000 is for both the state and the local government workers in the state, and it will take effect from August, 2023.

"We have also noted with sympathy the difficulties

workers are passing through as a result of the economic meltdown and therefore decided to bring interventions by way of payment of N10,000 each on a monthly basis, effective from the month of August, 2023.

"This shall include all workers in the state and Local Government payrolls," he said.

When asked how long the increment would last, he said the "N10, 000 does not have a time limit for now".

The deputy governor commended the contributions of the workers in the state, describing it as the engine room of the administration and implementation of government policies.

Jatau urged the workers to reciprocate this gesture by being law-abiding and supporting policies and programmes of the government while urging other residents who were yet to benefit from the palliatives to be patient.

"I call on all residents of the state especially those who are yet to benefit from the palliatives to be patient as we shall continue to consider bringing more interventions in the nearest future within available resources," he said.

According to her, "because we have worked in integration, we gave the government technical support and also gave financial support to enable this to take off.

"The government is providing over 90% of the cost because the workers and drugs mobilization are all by the government but they provided a conducive environment where we were able to also share our

expertise in integration outreaches.

"We have added screening for malnutrition, HIV screening, and other several things that can be done at the primary health centre level and we have seen that within two months, we have been able to reach 25% of the zero dose children. Kaduna has around 94,000 zero dose children and we have reached 25% of that number because of the trucks."

Earlier, Governor Uba, who was represented by his Deputy, Hadiza Balarabe, said apart from the mobile trucks being able to boost healthcare services and enhance the

wellbeing and survival of Kaduna citizens in hard to reach communities, they will also serve as a vital tools for the ongoing disease surveillance while strengthening basic clinical services, referrals and linkages.

He added that trucks will offer a range of services, from maternal, newborn and child health interventions, radiology services and all laboratory diagnosis of ailments such as malaria, HIV, hepatitis B and C, tuberculosis and many more.

"Our administration is committed to taking all necessary steps to make significant progress towards achieving

universal health coverage. Our vision is to build and strengthen enhanced health system that is adequately equipped, well staffed with comprehensive, accessible and affordable services and that is oriented to deliver distanced standard of care.

"To this end, we undertook an innovative approach to better our state's healthcare system. Among the initiatives we took, we have procured state of the art mobile diagnostic units which will facilitate the provision of quality diagnostics services to our far to reach, hard to reach and other underserved communities" the Governor said.

Katsina Police Arrests 3 Notorious Kidnappers, Others, **Recovers Arms Ammunition, Fake Naira Notes**

atsina State Police Command has arrested 14 suspected criminals who specialize in committing various crimes ranging from kidnapping, defrauding and banditry in the state.

Police Public Relations Officer (PPRO) of the Command, Assistant Superintendent of Police (ASP), Abubakar Sadiq Aliyu paraded the suspects before journalists on behalf of the State Commissioner of Police, CP Aliyu Abubakar Musa at the Command headquarters in Katsina.

On the arrest of three suspected notorious kidnappers and the recovery of three rounds of 7.62 MM ammunition, ASP, Sadiq Aliyu said on different dates and times in the month of April 2023, the command succeeded in arresting the following:- a 30 years old Haruna Mohammed; Yahaya Alhassan, 28 years old; Idris Isah, 30 years old all of Jigawa state and Zuhairu Umar, 25 years old of Turaki village, Baure local government area of Katsina State.

Assistant Superintendent of Police Sadiq Aliyu said the suspects were all members of a suspected notorious kidnap for ransom syndicate.

He explained that, on "1st of October, 2022, the suspects conspired with three other suspects, namely, (1) Rago, (2) Garba Margododo, and (3) Idris, all of Ringim in Jigawa state, now at large, to attack the residence of one Alhaji Sidi Usman, m, of Unguwar Rai village, via Baure LGA, and kidnap his wife along with her three (3) month old baby."

He said upon received of the report, Police detectives promptly swung into action and succeeded in tracking and arresting the aforementioned suspects. adding that, in the course of the investigation, suspects confessed to the commission of the offense, as three rounds of 7.62mm live ammunition were recovered in their possession.

On the arrest of the suspected notorious arm bandit, ASP Aliyu said it was on August 28, 2023, at about 1730 hours, the command succeeded in arresting a 30 years old Lawal Alhaji Idris of Shuwaki village in Faskari Local Government Area who terrorized the area and

confessed to the commission of the offense and mentioned the following as his cohorts, Tsoho Danfulani, Miyalla Danfulani, Zaharaddini Danyaro all of the same address now at large.

He said the suspect, Lawal Alhaji Idris in his revelation to the Police confessed to being the mastermind behind the

kidnapping of one Alhaji Hussaini of Shuwaki village, Faskari local government area in the process of which one person was shot and killed and also attempted to kidnap one Alhaji Musa of Gidan Dan Gwamna village and stole beans.

The Spokesman of the Katsina State Police Command reiterated that, effort is on with a view to arresting other fleeing members of the syndicate. However, on the arrest of ten suspected fraudsters and the recovery of one hundred and forty - four (144) pieces of suspected counterfeit Naira notes.

ASP Abubakar Sadiq Aliyu disclosed that, on August 28, 2023, at about 0800 hours based on credible information, the command succeeded in arresting Alhaji Ali Yau, aged 67 years old, Alhaji Alhassan Suleiman, aged 35 years old, of Kwarbai Quarters, Zaria Local Government Area, Kaduna State, Bello Abubakar, aged 58 years old, of Dogon Rimi, Kamba Local Government Area of Kebbi State and Aliyu Usman, aged 35 years, of Bakin Kasuwa quarters, Kankia Local Government Area of Katsina State.

ASP Sadiq Aliyu mentioned other suspected fraudsters as, Uzaifa Ishaq, age 48, of Dorayi, Kano State, Kabir Ibrahim, age 40, of Bakin Kasuwa Quarters, Kankia local government area,

Babangida Abdullahi, aged 40, of the same address, Nasiru Mani, aged 48 years, of Malamawa village, Matazu local government area, Mansur Abubakar, age 55, of the same address, and Ukashat Sulaiman, aged 25 years old, of Mai Hausawa quarters, Kamba local government area Kebbi

Assistant Superintendent of Police, Abubakar Sadiq Alivu emphasized that, the suspected notorious fraudsters specialize in defrauding unsuspecting members of the public using counterfeit currencies.stressing that, nemesis caught up with the suspects when credible information about their activities in a house situated at Bakin Kasuwa quarters, Kankia local government area was received.

olice Academy, Kano has announced the death of cadet Sulaiman Jika after a briefillness.

A statement from the police officers' training institution signed by the Pubic Relations Officer ((PRO) of the academy, ASP Hussain Suleiman, a copy of which was made available to our correspondent on Sunday September 3, explained that the young cadet, studying computer science complained of ailment before he was rushed to the academy's medical facility.

The statement added that cadet Jika, a native of Adamawa State was discharged from the clinic after he was certified fit by medical doctors on call.

"On 29th August, 2023, the young cadet sought medical attention at the Academy Clinic due to an ailment.

"Following a diligent course of treatment and his gradual recovery, he was certified fit and discharged

by the Medical Doctor on call the next day, and tasked to return at regular intervals for checks which he adhered to.

"However, fate took an unforeseen turn. On 2nd September 2023, he was once again admitted to the clinic for further examination and care following a complaint of restlessness.

"Though his vitals were normal upon examination and all necessary medical steps were taken, we regrettably report his untimely passing.

"The Commandant of the Nigeria Police Academy, AIG Sadiq Idris Abubakar, extends his deepest condolences to the grieving family, friends, and loved ones of Cadet Sulaiman Jika.

Kwara Begins Distribution Of 250,000 Bags Of Rice Palliatives In First Phase

*It's a token of empathy for our people, says Gov *Committee says working with various stakeholders, communities to ensure fairness

wara State Government on Wednesday, flagged off the distribution of rice palliatives to the most vulnerable persons in the state, with the committee saying it would share at least 250,000 10kg bags in the first phase.

In what was an attempt to ensure non partisanship, fairness and equity, Governor AbdulRahman AbdulRazaq on August 22, inaugurated the 12-person committee to coordinate the distribution of the palliatives purchased with the N2bn so far received from the Federal Government.

At the flag off of the distribution in Ilorin, the state capital, the Governor said the palliatives are only a show of empathy with the people as more sustainable initiatives are being implemented in phases.

He was represented by the Speaker Kwara State House of Assembly Engr Yakubu Danladi Salihu.

The Governor said: "This is only a fraction of what we have done to identify with the people at this very critical moment of our national life. Palliatives are a stop-gap measure to cushion the effect of the removal of fuel subsidy on the most vulnerable among us.

"Over the last few weeks, our government has rolled out different palliative measures to support the people in the formal and informal sectors. Also, we had earlier distributed the five trucks of rice we received from the Federal Government. We acknowledge the limits of this distribution in terms of the reach.

"Today, we are flagging off the distribution of the first consignments of rice we purchased with the N2bn so far received from the Federal Government. We are distributing at least 250,000 10kg bags of rice in this phase.

"Beneficiaries will be identified on a nonpartisan basis by the committee of eminent Kwarans. This committee has continued to consult with different blocs of our communities as well as evidence-based registers of vulnerable people domiciled with key agencies of government such as the health insurance, primary healthcare agencies, as well as the World Bank. Distribution will be done in accordance with the timetable and logistics of the committee.

"For me, the most important aspect of today's event is not the quantity or the sheer reach of the grains to be distributed. The most significant thing is the spirit of empathy that is behind what we are doing. The government at all levels empathises with the people across all social strata of our society. We are committed to taking every step possible to help the people cope with the inconveniences of this time.

"Huge investments are being made to boost the manufacturing sector, strengthen local production of food through commercial agriculture, local production of CNG and electric vehicles, and mass employment for young people in different aspects of the economy.

"We are a resilient people. I have no doubt that we will emerge from this tough situation much better and stronger as a nation.

"On that note, I have the honour to flag off the distribution of these palliative. I urge our people to trust the committee to do justice to the assignment, bearing in mind that the whole essence of this modest effort is to show concern to the plight of the people, especially the most vulnerable among us."

The event was attended by members of palliative committee and beneficiaries of the first batch, including representatives of Persons living with disabilities; WOWICAN; Marketmen and women group; Hausa community; Igbo Community; South-south community; Youth Council; NANS; Youth CAN; Orphanage; NUT; NUJ; TUC; FOMWAN; Nonindigene community; NURTW; NLC and Artisans groups.

The committee chairperson CP Ebunoluwarotimi Adelesi said the flag off marked the beginning of the exercise, which would see the palliatives being taken to all the 16 local government after agreeing the modalities with all the stakeholders and interest groups.

"The committee has the mandate to distribute approximately 250,000 bags of 10kg rice and advise the government on effective deployment of the N1bn worth of maize from the Maize Reserve (SMR) through the Central Bank of Nigeria (CBN) for Livestock Farmers across the state," she said.

The committee has since started its assignment by directing Director of Personnel Management (DPM) of the local government area to collaboratively work with Primary Healthcare Development Agency in a bid to generate a list of potential beneficiaries and vulnerable indigenes across the nooks and crannies of the state, she added.

CP Adelesi explained that the exercise targets as many vulnerable persons as possible, promising to deploy multidimensional and allencompassing leadership acumen in making sure that the palliative items get to the targeted vulnerable across the three senatorial districts of the state.

In their separate responses, representative of Persons with disabilities Alfred Oluwole; representative of FOMWAN Hajia Bilqees Oladimeji; representative of WOWICAN Mrs Kehinde Awe; and the President, Kwara State Artisans Congress Alhaji Jimoh Adeshina applauded AbdulRazaq for this initiative aimed at cushion the effects of fuel subsidy.

"We know the cost of a bag of rice in the market today. So, we thank the Federal and the state government for this initiative. We really appreciate our able and unique Governor for his passion in improving the welfare of the citizenry," Adeshina said.

"We are grateful to the state government for following the step of the federal government for this bold initiative. We're very grateful."

Anthrax: Oyo Govt. Seals Pharmacy Operating Illegal Vet Services

yo State Government on Monday, sealed a pharmacy supermarket and bakery in Ibadan for allegedly operating an illegal veterinary pharmacy and engaging in veterinary clinical services.

The state Commissioner for Agriculture and Rural Development, Barrister Olasunkanmi Olaleye while sealing the premises, said the owner violated the Oyo State Veterinary Practicing Premises Registration Regulation 2018, Oyo State Private Veterinary Premises and Veterinary Premises and Veterinary Establishment law, 2017 and Animal Diseases Control Act, 2022.

According to the Commissioner, the Pharmacy, was operating an

illegal veterinary pharmacy and engaging in Veterinary Clinical Services and that this can put the health of members of the public in danger. Speaking through the Deputy Director, (Monitoring), Dr. AbdulRrazzaq Lawal, the Barrister Olaleye said the move was in line with the Oyo State



Government efforts to curtail and prevent the outbreak of diseases, adding that government would not relent in its effort to ensure safety of lives

and properties.

The Commissioner pointed out that sealing of the premises the move was not to witch-hunt anybody but to ensure sanity in the veterinary service delivery in the state.

" We discovered through our surveillance that the owner of the premises is operating an illegal veterinary pharmacy and engaging in Veterinary clinical services without registration with the Veterinary Council of Nigeria and Oyo State Ministry of Agriculture and

Rural Development which is against the law, using of unapproved location for sale of Veterinary products as well as treatment of sick animals that can put post health risk to humans, as their customers can contract zoonotic diseases from the location", he said.

Barrister Olaleye stressed that Oyo State Government would not allow any person or group of persons' selfish interests put the entire state in danger of contrasting diseases from animals.

He then Barrister enjoined the public to support the government's effort in preventing outbreak of diseases. He also advised all unregistered veterinary premises to register according to the law.

She added that, It is historic and they've rich culture through the traditional institutions and traditional heritage, while as the government, they are the custodians of culture and tradition, so they were there to celebrate with their youth and people that speaks Hausa language across the world.

She said, "today, we have witnessed a lot of things ranging from the Hausa traditional clothing, the foods that are being taken, all the instruments for farming, because we have rich farming history in Kaduna State, as well as major producers of food in the country.

"We have seen the display of the blacksmith that if you are not from them, you cannot exercise the blacksmith work, just as the display of fire which the blacksmith touches with his bare hands. So if you are not from the family, you can not practice it because it is a Hausa tradition that one can see it as magic, but it's not.

"From the things we have seen like the traditional food produced, a lot of the youth are not aware of it because most of our women cannot prepare it, while it is a rich culture that we have read in the past through the history of the Northern novels of Hausa extraction like Ruwan Bagaja, Magana Jarice and all the story telling from our elderly people that have been

telling us, and now we came here to see it as a reality show.

"This is a very fantastic event that is historical and kaduna state government will always support such advancement culture, whereas anywhere we see any advancement culture, we will partake in it. We also have creational programmes that has to do with culture and traditions in the state which will happen very soon." Haj Rabi noted

According to her, Hausa Day can only be improved by showcasing talents such as the projects that the various group of people have exhibited at the event and the media will publicize the activities which most of our nowadays kids will be seeing on televisions or on social media but coming down to see it in reality is very interestingly and will make them to partake because they wouldn't like to be left behind without bringing culture hence culture is the way of life of people.

"It is compulsory for them to know their culture and to identify with it, so we should be proud of our culture because Hausa is a very diverse culture which is being separated across African Nations. I don't think if there's any language that is being spoken across the globe like Hausa because even in Nigeria, there are more than 50m people speaking Hausa because it is a very easy language to speak while it has every dialect and figures," the commissioner said.

While responding to journalists at the event, Dr. Nuhu Umar, Director General, Centre For Development Hausa Literature, and organizers of this year's Hausa Day Celebration in Kaduna State, disclosed that they deemed it fit to encourage people to know their culture, tradition, history, trade and leadership which is why they organized the event.

He added that people will now, see and hear the Hausa tradition and Hausa places such as the famous Hausa Bulu riding and trade, such as the blacksmith work, the normal traditional Barbing (Wanzanci) that has no equivalent in English language to be quoted, and also showcases of food, farm implements and other things.

Dr. Nuhu said, "the most important thing is celebrating days like this brings all stakeholders together so that they will sit down together to analyze and review challenges and proffer viable solutions to the challenges such as the insecurity in the Hausa land.

"When you talk of Hausa, you talk of Hausa land, you talk of the Hausa's and the language, while all this are facing one or more very threatening challenges, and by the grace of God by coming together here, we believe everyone is happy because this is our first event of this nature and next year by the grace of God, we will see how we are going to improve in this aspect," he submitted.









NDLEA Busts Transnational Drug Cartel, Uncovers Strange Illicit Drug Concealed In Semovita, Dry Pepper Packs

7 arious quantities of Illicit drugs including nitrous oxide, popularly known as laughing gas have been intercepted by operatives of the National Drug Law Enforcement Agency (NDLEA) at the Murtala Muhammed International Airport, MMIM, Ikeja, Lagos.

The intercepted drugs, which include ephedrine, and skunk were said to have been concealed in semovita packs and dry pepper being shipped to South Africa and Kenya through the airport, by members of Transnational Drug Trafficking Organizations (DTO).

This was contained in a statement made available to journalists yesterday by the Director Media and Advocacy of the agency, Femi Babafemi.

He disclosed that some members of the syndicate were promptly arrested, with their mansions raided and their luxury vehicles

According to the statement, "Through credible intelligence, NDLEA operatives on Friday 25th August intercepted a notorious drug trafficker, Suleiman Babatunde Oba who is a member of a cartel distributing Cocaine, Heroin, Methamphetamine and Ephedrine between Nigeria, Brazil, Ghana, South Africa, Mozambique, and Europe. " He was arrested while attempting to board a Rwanda Air flight to South Africa with two boxes loaded with ephedrine sealed in semovita packs.

"The recovered substance is a precursor chemical and active ingredient in the production of methamphetamine".

In his statement, Suleiman who holds a South African passport, married to a South African lady and has lived there for over 20 years, identified Hakeem Babatunde Salami who equally lives in Lagos and South Africa as the head of the drug ring.

A follow up raid in the house of Salami located at 75 Wosilatu Dawodu Street, Ijesha, Aguda area of Surulere, Lagos on revealed that he had fled the country on the same day Suleiman was arrested.

The synthetic substance was discovered concealed in a bag hidden in a Ford Edge SUV, which was part of three units of used vehicles and motor parts in the container.

In related development, I byn Sokoto, operatives on Tuesday 29th August arrested two male suspects: Nafiu Arzika, 30, and Jamilu Aminu, 35, with 330kg skunk, while another suspect, Ismaila Razak, 38, was nabbed with 34.5kg of same substance and 9.5 grams of methamphetamine on Saturday 2nd September at



Olodo area of Ibadan, the Oyo state capital.

Across the states and the Federal Capital Territory, Abuja, NDLEA Commands intensified the Agency's War Against Drug Abuse, WADA, advocacy campaigns to schools, worship places, palaces and local communities among others.

For instance, the sensitization lectures were conducted at Holy Trinity Gospel Church, Ogbomoso, and for Muslim faithful at Jammatul Nasirul Islam mosque, Ilorin; members of the Association of Hair Stylists in Ado Ekiti; leaders of road transport

union in Abeokuta; traders at Kwata market, Awka; pregnant women at primary health care centre, Bonny; Dekara district palace, Babana community in Borgu LGA and at Noorul Huda Islamiyya School, Kafin Maiyaki.

FWF in a statement made available to newsmen in Ibadan by its National Coordinator, Comrade Andrew Emelieze also expressed the forum's full support for the two days national warning strike from Tuesday 5th to 6th September, 2023, over issues of government alleged insensitivity to the plight of workers and the citizenry at large.

The forum demanded that government should pay up all outstanding arrears of salaries, promotions, duty tour allowances (DTA) owed the federal workers and particular attention to the arrears of salaries of federal university workers in Nigeria.

According to the forum, " as federal workers, we are also badly affected by the economic crisis visited on Nigerians as a result of the hike in the pump price of petrol, all in the name of subsidy removal", adding, "we had earlier written to the federal government to adjust our wages automatically inline with the existing economic realities but that has fallen on deaf hears"

" It is over three months now that fuel subsidy had been removed and fuel has equally been increased twice by over 300%, with a price shift from \aleph 187 to over \aleph 620 but salaries have remained the same. Federal workers within this period have gone through excruciatingly tough times. It has been stories of mass suffering and life has been made almost meaningless to the federal workers", it said. FWF added, "Everything has been nauseating and hunger is now a way of life among the federal workers. As a matter of fact, federal workers have been financially embarrassed as against the provisions of the general order of the federal civil service rules and regulations. Federal government workers are no slaves, we therefore query this pathetic situation and call on all federal workers to ensure that the two days warning strike is successful".

" We urge the federal government to meet up with the demands of labour. We demand also that government pay up all outstanding arrears of salaries, promotions, duty tour allowances (DTA) owed the federal workers and particular attention to the arrears of salaries of federal university workers in Nigeria".

The Forum stressed, " Henceforth, federal workers will no longer tolerate any oppression of federal workers anywhere and we shall not hesitate to join any workers group in solidarity strike when oppression is noticed; our attention here is drawn to the plight of our colleagues in the federal universities".

" We at the Federal Workers Forum are in full support of the call by the Nigeria Labour Congress (NLC) for a two days national warning strike from Tuesday 5th to 6th September, 2023 over issues of government insensitivity to the plight of workers and the citizenry at large".

*Says Tinubu govt lacks legitimacy

"It's an insult to say that Tinubu is the only African president that Biden has chosen to meet on the sidelines of UNGA when they know his legitimacy deficit and the fraudulent election that brought him as president.

"For me, even if they want to discuss Africa affairs, they can discuss with any other legitimate African leader within the continent.

"However, it is clear the only reason they are seeking this meeting is to protect their selfish interests and it is for this type of unbecoming action that the US is now trying former President Donald Trump.

Frank who is the Ambassador of the United Liberation Movement for West Papau (ULMWP), to the East Africa and Middle East, added:

"It is disheartening to note that at a time when everyone is eagerly waiting on the outcome of the Presidential Election Tribunal, the US will seek to play to the gallery by inviting Tinubu as the sole African leader Biden wishes to meet at UNGA.

He urged Biden to rescind his invitation to Tinubu pending the

ruling of the Presidential Election Petition Tribunal on the suits challenging the legitimacy of the President.

He said: "The USA should know that any other African President can collaborate with them for mutual benefit provided they legitimately hold power in trust for the people.

"Why is President Biden in a hurry to meet Tinubu at UNGA other than to protect US interest in the West African sub-region, especially in view of recent military coup in Niger Republic and the reports of a putsch in Gabon.

"We are curious as to the true intent of the proposed meeting save for divide-and-rule-system employed

by developed countries in their relations with African countries, otherwise there is no need for this hurry to meet Tinubu until the courts have decided the true winner of the Nigerian Presidential election.

"The US must allow the Nigerian judicial system to determine the legitimacy or otherwise of President Tinubu before it seeks to discuss sensitive issues with him concerning the West African sub-region.

"This is very crucial and necessary as anything otherwise will seek to legitimize an illegality at a time when Nigerians are eager to see to a final closure on this matter.



"Again, need we say that this kind of bestowal of recognition on illegitimate administrations by America and other western powers is responsible for new incidences of coups in the African subregion?

Delta Police Harvests Firearms, Recovers AK-47, Fabricated Pistol, Pump Action, Cut-To-Zize Guns

riminals in.Delta State have yet suffered another defeat, losing no fewer than seven firearms and seven live ammunition to police operatives in the state.

Four out of the firearms, which include one AK-47 rifle, a pump action gun, two locally made cutto-zize guns and seven rounds of 7.62mm ammunition were recovered from suspected hoodlums, while the others were from suspected cultists.

The Delta State Police Command Spokesperson DSP Bright Edafe, who made the disclosure in a statement on Monday, said the weapons were recovered from three different operations in the state.

While giving the breakdown, he said, ": On Wednesday, August 16th, 2023, at about 4.00pm, based on credible intelligence gathered over the activities of some criminal elements operating within Warri, Udu, Koko and proximate environs, the DPO Ekpan Division, CSP Aliyu Shaba, led the Surveillance Team and trailed the hoodlums to their hideout located at Aladja Grammar School in Aladja Town Udu Local Government.

" However, upon sighting the police, the hoodlums took to their heels; a search was conducted immediately around the uncompleted building and a sack bag was found. Upon searching the sack bag, the

following items were recovered: one AK47 Rifle, one magazine loaded with seven (7) rounds of 7.62mm Ammunitions, one English pump action gun with three (3) live cartridges, and two cutto-size Double Barrel Gun. Efforts are on top gear to identify and arrest the said hoodlums.

" In a similar occurrence, on the 20th of August, 2023 at approximately 3: 09pm. the DPO Ekpan received a phone call from one Alhaji (name withheld) of Warri Sapele Road. It was revealed that some group of persons were sighted suspiciously within the yard.

" However, the civilian The recovered firearms

security/operatives in the yard flashed their torchlight on the suspected criminals who immediately fled and abandoned a sack. Upon close look into the sack, two locally made single barrel guns, all detachable with 18 live cartridges. The DPO detailed the men of the division



to the scene, where firearms and ammunition were recovered and registered as exhibits. Efforts are on to trace and identify the hoodlums who are still at large.

" On 26/8/2023, at about 6: 00am, a police patrol team attached to 'C' division Asaba in a combined effort with vigilantes

> while on patrol around second Niger bridge sighted a young man carrying a sack bag, the suspect on noticing the police took to flight leaving behind the sack bag. When the bag was searched, one AK-47 rifle was recovered and effort to arrest the fleeing suspect is ongoing.

In an earlier development, on 20/8/2023, operatives of the Command De-coy squad acting on credible intelligence gathered on the activities of one Godfrey Tietie, a notorious cultist who has been terrorizing Oghara and environs, the operatives stormed his premises in a covert operation and arrested the said Godfrey Tietie a.k.a "Don Baby" of Oghara Town in Ethiope West LGA Delta State. The 40-year-old male suspect was arrested at Ogorode Road by Texaco in Sapele and upon search, a locally made revolver pistol was recovered from him.

" Investigation revealed that the suspect is a member of Aiye confraternity and is also suspected to be a gun runner who supplies guns to cultists in Sapele, Oghara, and environs. Investigation is ongoing.

Meanwhile, the Commissioner of Police Delta State, CP Wale Abass has urged members of the public particularly parents and guardians to pay close attention to their wards and discourage them from engaging in cultism and other vices.

Stressing that crime does not pay Abass vowed that the command will do all it takes to ensure that crime does not thrive in the State.

The Commissioner of Police also appealed to members of the public to help the police with any useful, timely, and credible information that will help the command eradicate crime in the state.

stakeholders recently bid the the Executive Secretary of Kaduna State Emergency Management Agency (KADSEMA), Muhammed Mu'azu Mukaddas, farewell as he exits the agency.

Some of the staff who could not hold their tears during a valedictory meeting organized in his honour, recount the fatherly role he played in their lives during the 21 months they worked with him.

They described him as a teacher, a team player and a rare professional whose unique style of leadership took the agency from near zero level to a professional and productive disaster management organization that brought Kaduna State to second top in Nigeria as adjudged by disaster management experts.

According to them, he was

so open that he related with everyone more like colleague and friends than mere subordinates. They therefore, promised to emulate his style of leadership and wished him a more successful carrier as he assumes his new responsibility at the Community and Social Development Agency (CSDA).

The administration of former Governor el-Rufai appointed Mukaddas as Executive Secretary KADSEMA in November 2021 to transform the agency into a professional emergency management organization; To correct anomalies and strenghten the system.

He has been re-appointed by His Excellency Governor Uba Sani, as the General Manager of Kaduna State Community and Social Development Agency, a Government / World Bank Programmr of Cooperation.

Mukaddas, who became emotional while responding to the commendations, expressed gratitude to all the staff and stakeholders for their cooperation and support in his sojourn. He advised them to strive to further improve themselves so as to remain competitive at all times. He asked for their forgiveness as he may have stepped on toes in his bid to entrench good governance. He added that it was in the



best interest and progress of the agency. He urged them to support the incoming ES as they supported him.

Mukaddas appreciated former Governor Nasir Ahmad el-Rufai for the confidence reposed in him and entrusting him with leadership of the agency. He equally thanked Governor Uba Sani, for appointing him to lead Kaduna State Community and Social Development Agency. He pledged to extend same level of commitment to achieve results for Kaduna State.

He, appreciated donor agencies and other stakeholders for their technical and funding support to KADSEMA.

"Gratitude to stakeholders, donors and KADSEMA colleagues for their unending commitments and zeal to ensuring safer and resilient communities in Kaduna. Together, we achieved so much within Emergency Management Cycle; Strengthened the agency's system; Gained trust / expanded partnerships with International Development Partners and Donors; Developed Capacities across MDAs et al, within these past 21 months". He said

Under his leadership, aside the disaster management tasks, KADSEMA, practically became a capacity development ground for Ministries,

Departments and Agencies. Mukaddas personally built capacities of 1,366 personnel across the state MDAs, Kashim Ibrahim Fellowships (KIFs), Department of State Services (DSS), Central Bank of Nigeria (CBN), KADVIS and the Local Emergency Management Committees (LEMCs) on Emergency Preparedness and Response (EPR), in 2022 and 2023.

The agency also established collaborative relationships with donor organizations such as United Nations Children Funds (UNICEF), United Nations Development Programme (UNDP), World Health Organization (WHO), Victims Support Fund (VSF), Plan International, Care Nigeria and Lagos State Emergency Management Agency (LASEMA), and regained trust of old relationships with Christian Aid and Cooperazione Internazionale (COOPI).

KADSEMA, became more proactive in preventing and mitigating disaster rather than responding to emergencies with the review of the Risk Analysis Map and Multi-Sectoral Contingency Plan.

On 28th March 2022, Mukaddas led humanitarian actors on a search, rescue and evacuation operation post attack of the Abuja – Kaduna AK9 train when 9

passengers were killed; 26 severely injured; 68 abducted. The incident was described as a national disaster.

One of his first achievements in office was the creation of the Local Emergency Management Committee (LEMCs) in all 23 LGAs of the state, which now serves as first responders in communities.

The agency also established an Emergency Operation and Coordination Center (EOC/ECC) with memberships from SEMA, National Emergency Management Agency (NEMA), the Red Cross, Nigeria Security and Civil Defence Corp (NSCDC), relevant MDAs and CSOs to periodically review goings-on and emerging threats. The committee met bi-weekly under his leadership.

A tactical team comprising SEMA, NEMA, Fire Service, Red Cross, Security agencies, LEMCs and divers, was also set up. The team is responsible for search, rescue and evacuation actions and it is coordinated by the State Fire Service.

A Multi-Agency Coordination with composition drawn from senior Directors of relevant MDAs to handle strategic decision making was also established and led by the ES Mukaddas.

Need To Repeal The Act Setting/establishing Medical And Dental Council Of Nigeria

he last five years have been quite horrific for foreign trained medical students who completed their studies and returned to Nigeria to practice.

In particular, some sections of the country that are making efforts to bridge the wide gap between their health needs and human resource availability, have been hard hit by the "massive failure" in the so called "assessment examination" being conducted by the Medical And Dental Council of Nigeria (MDCN).

It is a controversy generating issue that an examination slated to confirm that a candidate has undergone a training of many years to graduate as a doctor, has been turned into sessions of traumatic affliction by the MDCN, saddled with the responsibility typical of most things Nigerian.

It is disheartening to learn that the fees for sitting for the examination has been hiked by over 80 per cent within the last couple of years and the centralisation of conducting the examination has no regards for logistics and security burden/risk on the participants.

It is evident to state that the recent untoward development in the conduct of that assessment examination is undoubtedly, hampering the availability of medical doctors in states using their meagre resources to send their young people outside our shores for medical training and qualification.

Unfortunately and typical of our political leadership in the North, nobody seems to be paying attention to the deliberate efforts to frustrate that noble gesture of some states and parents sacrificing their fortunes to train their wards.

Therefore, in the interest of fairness, promoting transparency, erasing intervention of sentiments and other considerations that are inimical to the unique steps being taken by some states to produce enough



manpower in the medical fields and in order to create a balanced platform devoid of prejudice, the needful has to be considered. The act establishing MDCN should be repealed with immediate effect.

Members of the National Assembly from the affected states should remember that they were elected to serve, protect and advance the interests of their constituents and they should take a leading role in this matter.

Repealing of MDCN Act should be the first assignment of the 10th Assembly and in its place, the following recommendations are proffered:

4) It is also recommended that the current council be compelled to produce detailed results of the last examination conducted at Ibadan on 12th and 13th of July, 2023 and the results be

made public with participants' performance in all the subjects they sat. A Court case is being instituted in this regard.

5) This issue should be pursued by our Representatives in the National Assembly with the urgency needed and the Council be placed on suspension until satisfactory outcome is received on the outcome of last assessment examination.

Our states are being deliberately denied progress in producing medical doctors arising from plans by some office holders who are bent on converting every opportunity to serve into an opportunity to wreck. Therefore it is poignant at this time on this matter to say "to thy tent oh Israel!"

Resurgence Of Coups In Africa And The Panacea

In the past three years, at least eight African countries have witnessed military coup d'états. This is coming when it was thought that Africa's democracy had come of age when we were beginning to think that coups had gone for good, consigned to an era in the past when African governments were led by the military.

Coincidentally, all but one of the eight countries were colonised by France. Some of the countries are Mali, Chad, Guinea, Burkina Faso, Niger and now Gabon.

The first coup in Mali was in August 2020, when President Ibrahim Boubacar Keita was overthrown by a gang of Malian colonels commanded by Assimi Goita. The coup came on the heels of antigovernment demonstrations about worsening security, contentious elections for the legislature, and accusations of corruption.

After some pressure, resulting in fruitful negotiations, the junta agreed to hand over power to an interim administration run by civilians to oversee an 18-month transition to elections in February 2022.

However, a clash ensued between the coup leader and the interim president, retired Colonel Bah Ndaw, prompting the junta to stage a second coup in May 2021. Goita, who had been acting vice president, became president.

In Chad, the army seized control of the country in April 2021 when the country's "soldier-king" president, Idriss Deby, was killed in combat while visiting forces engaged in fighting rebels in the north of the country.

However, instead of the speaker of the parliament taking over as stipulated by the country's constitution, General Mahamat Idriss Deby, the president's son, was named interim president. This sparked riots in N'Djamena, the country's capital, but the military quelled it easily.

In 2020, President Alpha Conde changed Guinea's constitution to run for a third term. This caused severe unrest that emboldened the country's Special Forces led by Colonel Mamady Doumbouya to overthrow him in September 2021.

The failure to tame bandits and terrorists, especially Islamist militants, led Lieutenant Colonel Paul-Henri Damiba to oust President Roch Kabore in January 2022. But barely eight months later, Captain Ibrahima Traoré seized power from Damiba to become the country's new leader on September 30, 2022.

On July 26, 2023, members of Niger's presidential guard led by General Abdourahmane Tchiani, an officer once involved in peacekeeping efforts in warravaged countries, seized power from President Mohamed Bazoum to address the "deteriorating security situation and bad governance."

Last week, on August 30, top military commanders in Gabon forcefully abridged President Ali Bongo's third term and annulled the controversial results of the recent election he was declared the

winner of.

When we look at these countries, what we see as a common thread is a long stay in office, fuelled by greed and self-centeredness. Because the sit-tight bug has bitten the leaders, they employ all means foul to remain in office, like constitution amendment, election rigging, imprisonment of opposition members, weakening of opposition parties and suppression of individual freedoms and the press.

They riddled their reign with government corruption, which they employed to weaken all democratic and state institutions and turn those with oversight functions, like the parliament, into rubber stamps.


It is unfortunate, but true, that many African leaders have a warped way of thinking. They assume that they were created to be served; that God created them specially and that without them, their country cannot get anywhere.

We can see such an inordinate desire to hang on to power in Cameroon, where Paul Biya has been at the helm since 6th November 1982. For 41 years, he has held his country by its jugular despite spending most of his time seeking medical care in Switzerland. Uganda is one other country where its leader, Yoweri Kaguta Museveni, has been in power since 26 January 1986.

Congo's Denis Sassou Nguesso has been his country's leader since February 8, 1979, and Equatorial Guinea's Teodoro Obiang Nguema Mbasogo since August 3, 1979, while Eritrea's leader, Isaias Afwerki has been on the saddle since May 24, 1993.

Perhaps this trend will continue as long as those whom God has elevated to such positions continue to see themselves as extraordinary mortals whose death would

cause time to stop in its tracks. They must know that the world would not pause and look back when they drop dead.

Then, the judiciary. Yes, the judiciary could be the panacea. This arm of government is the bedrock of sanity in a nation. Once it is corrupt and, therefore, unreliable, making it no longer a last sanctuary of hope for the traduced, then a nation is doomed. If it was upright, then a nation would get it right because there would be justice for all, which would translate into safety and prosperity for everyone. "A kingdom (nation) can endure with unbelief, but it cannot endure with injustice", said Sheikh Usman Dan Fodio in his book, Bayan wujub Al-Hijrah alal ibad.

In April last year, I wrote here: "Once a nation-state finds itself in such a situation, only a few options are left for it to continue. Sheikh Usman Dan Fodio's ethos for a nation's survival should become a national creed. Its leaders must urgently embrace justice and fairness and the laws of the land must equally apply to king and serf. Then the leaders must truly see leadership as service to the fatherland and not a means for them and their families to aim at owning the land. In his book, Bayan Wujub Al-Hijra, the revered scholar, revolutionary and founder of the

Sokoto Caliphate, said: 'A kingdom can endure with unbelief, but it cannot endure with injustice."

It is also time that African leaders began to see their people as humans who deserve the best in life. All that the average African wants is to feel he counts and that his feelings are respected. He wants an organized society and so he wants his nation's institutions to work. He is also law-abiding, and he understands and respects the law if it covers everyone — high and low.

A look at all the countries in Africa where coups have taken place of late will reveal that not only is the judiciary in bed with all the deposed leaders but also the followers do not seem to matter in the scheme of things.

Again, in April last year, I concluded a writeup with this: "The easiest way to serve the people is to empower them to easily access basic needs. The little money in their pockets should be valuable enough to guarantee that. Once the people can afford basic needs because of leaders' efforts, the crime rate and discontent will take flight. What way is better to empower than to provide work for the majority?"

Kaduna State: A Security Sector On Auto-Drive

he number one pillar in the seven-point SUSTAIN blueprint of The Governor of Kaduna Senator Uba Sani is Safety and Security. It is therefore disturbing that the State Ministry of Internal Security & Home Affairs till now does not have a Commissioner. Equally, the nominee for this very strategic office was not screened at the Kaduna State House of Assembly and was conspicuously not sworn-in at Sir Kashim Ibrahim House.

Furthermore, it is worrisome that getting into the second month after the 60-day deadline for submission of nominees for Commissioner to the Kaduna State House of Assembly, as stipulated in the signed Fifth Alteration (No.23) of the 1999 Constitution (as amended) and swearing-in of Commissioners by the Governor, we are yet to have someone at the helm of affairs in this critical Ministry. The former Commissioner, Samuel Aruwan, now the Administrator of Kaduna Capital Territory Authority, is said to be the overseer multitasking to fill-in the vacuum.

Recently, activities in the security sub-sector have been held with the conspicuous absence of a Commissioner. This was evident at the recent State Security Council meeting and the delegation sent to Ikara Local Government, over the recently reported bandit attack. Other activities under the sub-sector without a Commissioner to drive the process: was the flagging-off of the commencement of the training for 7,000 recruits of Kaduna Vigilance Service (KADVS); and the one-day reflection on Kaduna Direction on Peace-building organized by the Kaduna Peace Commission.

The current security



challenges confronting the State requires someone with the requisite knowledge, capacity, character, experience, exposure and reputation to effectively coordinate and deliver the Governor's vision, as captured in his blueprint, of "a secure, peaceful and united Kaduna. More so, someone that will earn the respect and cooperation of the Federal security agencies in the State. As well as create the enabling

environment for the parastatal under it to effectively function.

As currently, the poor welfare of the KADVS staff/volunteers should give everyone sleepless night due to the nature of their mandatewith some of them armed and hungry. The volunteers that are working under KADFAMA are said to be owed for about 8 months. While it is public knowledge that the other volunteers,

except those assigned to public schools, have also not been paid allowances for years now. The KADVS Law, Part IV, Section 24, particularly, sub-section 3,b, stipulates that - "the funds (of the Service) shall be applied for: payment of allowances to members of the Committee and Staff as determined by the Government."

Interestingly, the Ministry of Internal Security & Home Affairs, according to the 2023

Approved Budget, has an allocation of N8.5 billion. As at the second quarter (half-year), the State Budget Performance Report shows about N4.0 billion has been released a 1 r e a d y, a 47.3% performance. With the highest release of N3.9 billion going to the main Ministry and the lowest release of N8.7 million to KADVS.

Evidently, activities under the sub-sector are ongoing; nonetheless, the absence of a Commissioner remains a challenge. It is our utmost expectations that in the absence of a Commissioner, the recent recruitment of KADVS volunteers was largely on merit and not political patronage - with their background thoroughly checked to ensure people with questionable character are not licenced to cause more harm than good to the society. More importantly, that the government has the fiscal space to ensure both the

old and new volunteers are paid as at when due.

Therefore, we appeal to the Governor to accelerate the process of appointing a competent substantive Commissioner for the Ministry of Internal Security & Home Affairs to reposition the sector in fulfillment of section 14, sub-section 2b, of the Constitution. As anything short of this will call to question the commitment of the Governor to the social contract (SUSTAIN blueprint) entered with the people. Best wishes to the Governor in his effort towards securing the residents (as well as investors and visitors) and bringing durable peace to Kaduna State.

Lets engage, ask the right questions and hold the government accountable.

Palliative: You're For All Adamawa Not PDP Governor, APC Man Reminds Fintiri

loyal member of the All Progressives Congress (APC), in Adamawa State, Mr Hussaini Gambo (Nakura) has accused the Governor of Adamawa State, Rt Hon Ahmadu Umaru Fintiri of selective treatment in distributing the Federal Government palliatives sent for the people of the state.

Hussaini in an interview with our Yola correspondent, said the governor is also out for vendetta and only wants a particular class of people to enrich themselves over the palliatives that are meant for everyone.

"Sir intervene on the palliatives you gave for everyone in

Adamawa, else APC loyalists will never get anything as Governor Fintiri is clearly showing out his colour to give only his political pundits.

"All the committees formed in charge of the distribution there is no APC stakeholder included, even our elective office holders like the state house of assembly lawmakers have been excluded from being the committee.

"How can there be equal distribution? The so-called councillors in charge of the distribution at ward levels are all PDP elected, no none of them is from the APC or any political party. Something urgent has to be done," Hassan said.


