

# Atiku's Aide, Shaibu Unveils '10 Big Lies' By Tinubu's Govt

ormer Vice President Atiku Abubakar's Special Assistant on Public Communication, Phrank Shaibu, has unveilled what he described as "the 10 big lies" that have so far characterised President Bola Tinubu administration.

Shaibu said in a statement yesterday that the repeated lies were evidence that Tinubu's only plan was to use propaganda to deceive Nigerians rather than do any proper work in rescuing citizens from the bottomless pit of bad governance they had been pushed into in the last eight years plus 117 days of the administration of the All Progressives Congress.

Atiku's aide asked Nigerians not to be deceived by the apology issued by the Special Adviser to the President on Media and Publicity, Chief Ajuri Ngelale, and other aides to Tinubu.

He said they were only sorry because they had been caught and not because they were penitent. Shaibu said the fact that Tinubu had more media aides than economic and security advisers was enough to prove that his administration would rely on propaganda as a state policy.

"My advice to the Nigerian media is to always fact-check any claim made by this government as this would help maintain their credibility. If the Tinubu government says it is morning, go outside to verify if

the sun is shining," he said.

Atiku's aide listed the following as "the 10 lies of the Tinubu regime I have compiled so far:

"1. The first lie that was told by Bola Tinubu was in his inaugural speech, where he stated that petrol subsidy is gone. With oil prices now at \$94 per barrel and naira exchanging at N1,000/\$1, the price of diesel has risen to about N1,000 per litre while petrol remains at about N620 per litre. It is obvious to the discerning mind that petrol is now being subsidised, a position which all oil marketers have espoused. Nigerians should not be deceived. Tinubu's claim that there is no subsidy is a lie from the pit of hell, and the fact that they are even hiding the information means there is no transparency, and the money is probably being stolen again.

"2. The second lie told by these charlatans was that the United Arab Emirates had lifted the visa ban on Nigerians immediately and that all Nigerians were free to visit Dubai. This lie was well celebrated by many undiscerning Nigerians whose only crime was to believe the deceptive words of an illegitimate government. UAE authorities later confirmed to CNN that it was all a lie. What a national embarrassment!

3. A third lie told by this deceptive government is that Tinubu was the first African President to ring the NASDAQ bell. It has since been established that Malawian President, Jakaya

Kikwete, rang the bell on September 21, 2011.

4. Another lie was a statement issued by Ajuri Ngelale on August 27, 2023 where US Presidential Envoy and Assistant Secretary of State for African Affairs, Ambassador Molly Phee, was quoted as saying, "President Joe Biden is asking to meet with you on the sidelines of UNGA and you are the only African leader he has requested to meet. It is a mark of his high regard for your leadership." Well, this has turned out to be another embarrassing lie as Tinubu has departed UNGA and never met President Biden.

5. A fifth lie was a claim made by Tinubu on the floor of NASDAQ where he stated that "We have retooled the exchange rate to a reliable, dependable one figure floating of the naira. You are free to take in your money and bring out your money." But this is another lie from the pit of hell. The exchange rate on the I&E Window is about N780/\$1, while the rate at the parallel market is about N1,000/\$1. Besides, foreign airlines still have over \$600m funds stuck in Nigeria. Tinubu, therefore, lied when he said "you are free to take in your money and bring out your money."

6. On August 14, 2023, the Nigerian government said on its official Twitter handle that the Nigerian Air Force struck terrorists gathering at Kurebe in Shiroro LGA in Niger State. The government claimed that the

terrorists were neutralised. Well, Premium Times has now revealed in its latest report that this is nothing but propaganda as those who were killed were innocent civilians. Is it not tragic that the Bola Tinubu administration has now infected the military with its lies? Indeed, once the head of the fish is rotten, the body cannot escape corruption.

7. As part of Bola Tinubu's propaganda programme, the Central Bank of Nigeria said on September 6, 2023 that within two weeks, it would inject \$10 billion into the foreign exchange market to clear the FX backlog. Days after the deadline passed, not a single cent has been injected into the system as the naira continues its free fall. The institution that Tinubu's leadership cannot destroy does not exist.

8. In his inaugural speech, Tinubu said, "As your President, I shall serve with prejudice towards none." But this has turned out to be another barefaced lie. Tinubu has been running a government of the clannish, by the clannish and for the clannish, with all key appointments in every sector going to a section of the country including CBN, FIRS, customs, army, police, immigration while he himself is the petroleum and gas minister. Tinubu appointed 10 ministers from the southwest and only five from the southeast. If this isn't prejudice, I don't

know what it is.

9. Last month, the Nigerian National Petroleum Company Limited claimed they had obtained an Afrexim loan of \$3bn with which it would help stabilise the naira. We raised the alarm that it was all a ruse to deceive Nigerians. Now, we have been justified as the naira is now trading at \$1/N1,000 on the black market, while Afrexim Bank has refused to speak on it. This was just audio money.

"10. Perhaps the biggest scam and deceit of the Tinubu administration was the Student Loan Act, which he signed on June 12. The new law provides loans for students' tuition only. It doesn't cover any other educational expenses. After the law was signed, all federal government schools began increasing school fees. But Dele Alake, the Special Adviser on Media as he then was, said in a statement that tuition in all government schools remains free and that the only fees that were increased were accommodation, laboratory, library and other costs. So if tuition is free and the Students Loan Act covers only tuition fee, that means the Student Loan Act is pointless, and no money will be released. In essence, Tinubu's government has prodded government schools to increase fees while no loans will be given to the students. This is the height of deception and wickedness."

# Female Students Abduction: ACF Calls For Total Eradication Of Banditry, Terrorism

he Arewa Consultative
Forum (ACF) has
charged the Federal
government to eradicate
banditry, kidnapping, and
terrorism bedeviling the country
once and for all, following the
abduction of female students of
the Federal University of Gusau,
in Zamfara state.

In a statement issued by the National Publicity, ACF, Professor Tukur Muhammad Baba and made available to newsmen in Kaduna yesterday, ACF noted with disdain that from the information gathered, the attack at the Federal

University was well planned and executed by the bandits and the female students were their target. ACF expressed concern that there was the conversation heard from one of the female students saying her father called her to come back home, telling her this was the end of her academic pursuit.

The other disturbing scenario, according to the statement, was the conversation of a parent overheard advising admission seekers against coming to the university.

The statement explained, "It is with utter consternation that the Arewa Consultative Forum

(ACF) received news about the abduction of mostly female students of the Federal University Gusau (FUGUS), from their private hostels, at Sabon Gida Village, Bungudu Local Government Area of Zamfara State."

It said although official information about the incident is scanty, relative to the enormity of the incident, personal testimonies from witnesses to the disturbing incident suggest that the attack was well planned, coordinated and executed by the bandits/terrorists.

The statement noted that evidently, the female students

were specifically targeted, and the bandits were at the crime scene fully prepared, saying that efforts to repel the bandits by elements of the Nigerian Army neither deterred nor stopped the bandits from going off with a yet-to-be-fully ascertained number of hapless victims.

ACF condemned the abductions in the strongest of terms, stressing that it is very disconcerting that such a most unfortunate criminal incident is not the first of its kind in memory but it certainly is one abduction far too many to occur in any community in Nigeria, nor elsewhere in the world.

To this end, the statement called on the Federal Government of Nigeria (FGN) to spare no efforts in ensuring that the abducted students are released unharmed forthwith.

ACF also urged the federal government to rejig Nigeria's security architecture and to come up with new multi-pronged containment strategies against security and related existential threats bedeviling schools and indeed all communities.

It said that such new strategies should aim at the total eradication of the scourge of banditry and terrorism countrywide

#### 50% Of Girls In Nigeria Out Of School -UNICEF

he United Nations C h i l d r e n Education Fund (UNICEF), has said that more than 50 per cent of girls in Nigeria are not attending school at the basic education level.

The education manager at UNICEF, Jutaro Sakamoto, stated this in Abuja at the education conference organised by the French Institute in Nigeria.

He said, "7.6 million girls are out of school in Nigeria – 3.9 million at the primary and 3.7 million at the junior secondary level.

Sakamoto further explained that 48 per cent of out-of-school girls were in the North West and North East, saying that gender parity in net attendance ratio was below 1.0 in 10 states, primarily in the North, but is decreasing in 15 states.

The education manager said that 9 per cent of the poorest girls attend secondary school, compared to 81 per cent from the richest quintile.

He lamented that Nigeria accounts for 15 per cent of out of school children globally, stressing that if the situation is not address in Nigeria, they can not solve the situation in the world.

He said those going to school were not being taught well as a result of lack of facilities, pointing out that UNICEF's Education Opportunity for Out of School Children (OOSC) project had been able to make some impact.

# NDLEA Intercepts Laughing Gas Weighing 2,547.2 kg, Other Illicit Drugs In Lagos, Kogi, Abuja, Jigawa, Kaduna Sokoto, Edo

peratives of the National Drug L a w Enforcement Agency (NDLEA) have intercepted over four tonnes of illicit and controlled drugs including consignments of nitrous oxide popularly known as laughing gas, skunk, codeine syrup, methamphetamine and tramadol.

The seizures were made during interdiction operations in Lagos, Kogi, Abuja, Jigawa, Kaduna, Sokoto and Edo States.

The Director, Media and Advocacy of the antinarcotic agency, Femi Babafemi made the disclosure in a statement made available to journalists yesterday.

He said that a total of 1,194 cylinders of laughing gas, weighing 2,547.2 kilograms loaded in two Toyota Sienna buses were on Friday 2 2 n d September intercepted by NDLEA operatives along Okene-Lokoja-Abuja expressway.

According to him, two suspects: Onyebuchi Ikpozu and Kenneth Igwe who were taking the consignments to the nation's Federal Capital Territory for distribution have been arrested and taken into custody.

While one of the Toyota Sienna buses marked KTU 582 HV was conveying 99 cartons containing 594 cylinders weighing 1,267.200kgs, the second bus with registration number FKJ 329 YA was conveying 100 cartons of the substance with 600 cylinders weighing 1,280kgs.

A 48-year-old woman, Mrs. Ugo Eluba was also arrested in Abuja in a follow up operation after 2,400 ampules of pentazocine injection and 100,000 tablets of Exol-5 intercepted in Kogi state were traced to her.

In the FCT, operatives intercepted 977 kilograms of skunk on Wednesday 20th September in a trailer

marked LSR 343 XW, bearing cartons of maggi. The skunk consignment was loaded into the truck at Ipele junction in Ondo state. While 959kgs of the substance were meant for distribution in Sokoto state, the rest was to be d r o p p e d o f f a t Gwagwalada.

Two suspects: Auwal Mohammed and Abdullahi Abubakar have been arrested in connection with the seizure, while two others uspects: Mutari Abdulazeez, 31, and Ayuba Madaki, 28, were also arrested on Saturday 23rd September at Zuba area of the FCT with different quantities of methamphetamine.

methamphetamine, cannabis and 13, 930 pills of tramadol.

In the same vein, Shuaibu Yusif, 27, and Abubakar Hussaini, 20, were on Saturday 23rd September nabbed with 89.1kgs of skunk along Kano - Hadejia road, Jigawa state during a stop and search patrol by NDLEA operatives.

No fewer than 6,000 ampules of pentazocine injection were recovered from a suspect, Usman Musa Sidi, 35, on Monday 18th September along Abuja – Forest road, Kaduna while on his way to Bauchi state.

A follow up operation in Bauchi led to the arrest of the actual owner of the consignment, Dominic Chukwuma, 35, on Tuesday 19th September,

with at least 2.58kgs of Diazepam and 36.55kgs of pentazocine injection recovered from his home. Two other suspects: Inuwa Nuhu and Isiyaku Dahiru Sani were also arrested same Tuesday in connection with the seizure of 49 blocks of cannabis sativa concealed in a black sack weighing 26kgs in a commercial vehicle coming from Ogere, Ogun state to Kano.

While a total of 183kgs of Ghana Loud, a strain of cannabis, were recovered from body compartments of a J5 bus intercepted in Lagos on Wednesday 20th September, operatives in Sokoto, on Tuesday 19th September arrested one Charles Okeke, 44, with 473 bottles of codeine syrup at Unguwar Kosai area of Sokoto.

In Edo state, 365 blocks of compressed cannabis sativa weighing 258kgs were recovered from a Toyota Camry car marked KTU 886 EZ at Igarra, Akoko Edo LGA.

In a massive operation between Monday 11th and Wednesday 13th September, NDLEA operatives stormed thick forests in Ijesha Isu-Ekiti, Ikole Local Government Area of Ekiti state, where they destroyed 40 tons (40,000 kilograms) of cannabis plants covering 16 hectares of farmland.

"Meanwhile, across the country, NDLEA Commands continued

their War Against Drug A b u s e , W A D A , sensitization lectures and a dvocacy visits to worship centres, schools, workplaces, palaces of traditional rulers and communities all through the week.

He disclosed further that the enforcement



## **Southern Kaduna:** FG To Intervene In Ginger Farming Over Fungal Disease

he Minister of Agriculture and Food Security, Senator Abubakar Kyari, has assured ginger farmers whose farmlands and product were recently affected by a strange fungal disease in Kaduna of the Federal Government's intervention.

The Federal Government's assurance for succour comes after few weeks that over two hundred ginger farmlands and produce worth ten billion Naira were destroyed in Southern part of Kaduna State.

The minister who was represented by the Assistant Chief Agric Officer; Federal Ministry of Agriculture and Food Security, Mrs. Rita Agbogo made the assurance of the minister's quick intervention during a visit to the affected farmlands in Southern Kaduna on Thursday.

The representative of the



minister who is the leader of a five-man delegation to Southern Kaduna, reiterated the commitment of the ministry towards finding lasting solution to prevent further occurrence of the disaster and to ensure that the affected farmers are provided with the adequate support.

" We are already feeling the pains of our dear ginger farmers and that is why we are here on the mission of damage assessment. With our visit to some of these farmlands, we have seen to what extent the damage was. We are going to recommend to the ministry what is the best way to help the affected farmers out of the present situation," Mrs. Agbogo explained.

When asked, what could be the cause of the fungal disease, she however said, "as we speak now, we are yet to know the cause of the damage, and that is why we are here with other relevant organisations. We will make research and continue to liaise with these organisations in order to know the cause and prevent future occurrence.

"The cause could be the type of seeds, soil, source of the seeds, and it could be any other factor, but for now, we cannot say what really happened."

While fielding questions from journalists, the National President of the National Of ingeria, Nuhu Daudu commended the minister for his quick response towards finding a long-term measures to prevent future occurrence of what he described as an ugly situation.

Daudu further explained that definitely, the damage will impact negatively on the nation's Gross Domestic Product (GDP).

# Zamfara Governor Summons Security Heads Over Abduction Of Students

"For the women, you have to do a lot of adaptation. The traditional way of cultivation must give way to modern ways of cultivation. We now have dry season farming too and that is to cushion the effects of Climate change. "The use of polythene has to be checked. Right from the home, we should learn to sort out refuse to separate the ones that can be recycled from the ones

#### Police CMR Platform Recovers 89 Stolen Vehicles

he importance of the Nigeria Police Force Central Motor Registry (CMR) platform has been highlighted by the Force Public Relations Officer ACP Olumuyiwa Adejobi, saying it has assisted in combating motor vehicle-associated crimes.

He disclosed that no fewer than 89 stolen vehicles were recovered within five weeks through the platform, due to the swift response of CMR desk officers in collaboration with field operatives.

The Force spokesperson hinted that since inception of the CMR on December 7, 2022, the police has received a total of 8,569 requests from 7,513 applicants, encompassing 8,497 motor vehicles and 72 motorcycles/tricycles.

Out of the figure, according to him 8,466 have been successfully approved, while 103 requests are currently in the processing phase.

Making the disclosure at a media briefing in Lagos on Thursday, ACP Adejobi emphasised that the statistics underscore the dedication of the Police authority to streamlining and modernizing its processes, ultimately benefiting the public and bolstering law enforcement capabilities in Nigeria.

He added that over the past five weeks alone, the CMR platform

has witnessed the registration of 1,244 vehicles, with 234 of them flagged as reported stolen on the platform.

Adejobi also clarified that motor vehicle registration and licensing are within the purview of the Nigeria Police Force as our role is to acquire essential vehicle data for our repository, vital for national security.

While justifying the importance of the platform, Adejobi stressed that the CMR offers profound benefits to various stakeholders within the society.

He assured that Motor vehicle licensing agencies, insurance firms, and other

pertinent entities will experience increased efficiency and productivity with streamlined processes and real-time access to vehicle statuses.

Speaking on the dry season farming, Prof.Ikani lamented that lack of proper maintenance and use, as well as flooding is of serious concern.

The director said the Giant of Africa Nigeria is known for, is because of agriculture, but since the discovery of crude, Nigeria lost focus on agriculture.

#### Law Professors Pick Errors, Condemn Kano Governorship Tribunal Judgment

he Kano State
Governorship
Election Petition
Tribunal on Wednesday
sacked Governor Abba
Yusuf of the New Nigeria
Peoples Party (NNPP) while
declaring the candidate of
the All Progressives
Congress (APC), Nasiru
Gawuna, winner of the
election.

The Independent National Electoral Commission (INEC) had declared that the NNPP polled 1,019,602 votes to defeat the APC with its candidate, Mr Gawuna, who scored 890,705 votes. The NNPP candidate thus won with a margin of 128,897 votes.

The APC had filed a petition challenging the election of Mr Yusuf. The three-member panel of judges led by Oluyemi Asadebay delivered the judgement on Wednesday virtually. The court invalidated over 165,663 votes printed in favour of NNPP.

The court deducted the invalid votes stating that the ballot papers (165,663) were not stamped or signed and were therefore invalid.

But perusing the judgement, some legal experts have picked professional and indicting errors in the judgement prepared by the panel.

Professor of Law, University of Ibadan, Professor S O Adegoke highlighted that the panel clearly showed sentiment and emotion in support of the APC in the language used in the judgement.

According to him, quoting the judgment, "I use this opportunity to condemn the gang of Red Cap wearers who like a violent and terrorist cult chased us out of Kano and put us in the fear of our lives. We believe that only Allah is the giver ot power. Those who believe in Allah must bow to his will and submit to the authority of Governmental power. Resort to anarchy, violence and killing can never be a source of lawful power. Threatening to put Honourable Judges in the danger of their life as done in Kano by some disgruntled bandits parading as politicians is hereby condemned.

"Every Judge worth his salt will always abandone and ignore any form of threat to stand by justice and pronounce justice. This Tribunal in the lead judgment have pronounced justice and we stand by justice. I concur with the lead Judgment and commend my lord the Chairman for delivering this judgment under the threatened fire and brimstone by bitter losers. There is always another day for politics. I am in no doubt that the security Agencies know and are aware of those who removed their eyes from their case and put it on the Judiciary. They are also aware of those who extended the threat further by declaring that they will kill the Judges. This threat must not be swept under the carpet.

"Instead of some Kano politicians to be allowed to use banditry and violence to abort Democracy in Kano State, justice will be used to stop them from destroying Democracy in Kano and upward, we do not want Anarchy and terrorism as being promoted in Kano State and as threatened by them".

One could be forgiven to think the judgement was prepared by card carrying members of the APC, the language used clearly showed malice against the NNPP and it is by far the most unprofessional judgement I have seen in my 38 years in this profession, Professor Adegoke stated.

Echoing Adegoke's submission, the Acting Head of Department, Law, University of Maiduguri, Professor Tijjani Buba also added that mentioning Nasiru Gawuna as a petitioner in the judgement when he is not, is clearly a case of gross unprofessionalism and hostility.

Also quoting the judgment on page 222, "It is hereby determined that the Petitioner, NASIRU YUSUF GAWUNA having scored a majority of lawful votes and having met the constitutional requirement, is hereby declared the winner of the election and returned elected as the Governor of Kano State", stated that, it's a disgrace to the law profession.

"I think the people who wrote that Tribunal judgement have a motive to disgrace the law profession and cause grace disrepute. It is the only explanation for this shameful narration as a judgement. I urged the National Judicial Council to investigate this issue as a matter of urgency", The university don concluded.

#### Kogi: Bello Slams N5bn Suit On Natasha Over Comments In Media

overnor Yahaya Bello of Kogi State has filed a N5 billion suit as damages against the state central Senatorial district candidate, Chief Natasha Akpoti-Uduaghan at the State High Court, Lokoja.

The suit number HCH/16/2023 and backdated to the 6th of February 2023, might not be unconnected with a matter that occurred in November last year. Gov Bello's 34-page lawsuit, sought, among other things ,to claim that the defendant (Natasha) should pay the said

sum to him for defamation of character and libel over her interview on Arise TV that was aired on 4th November 2022.

In addition to the N5 billion claim, Natasha is being requested to publish a retraction and tender an apology in five national dailies including personal statements on Arise TV, AIT, Channels and NTA.

The suit also seek a perpetual injunction restraining the defendant and whosoever connect, affiliated with her as an associate, privy, agent, etc. from making defamatory words or statements against the claimant either on social media, print

media, television, radio, etc.," the court document partly read. It could be recalled that Natasha Akpoti Uduaghan made appearance on Channels TV, AIT and Arise TV in October 2022 in her defence after the Kogi State Government called for her arrest in connection with sponsoring terrorism in Nigeria.

General in New York, Ambassador Lot Peter Egopija, Governor Inuwa highlighted the immense potential of Gombe State and its readiness to tap into global opportunities.



## The Gates To Hell Were Opened Long Ago

HE WORLD gathered this week under the umbrella of the United Nations to talk peace, security and socio-economic justice, but hawks circled and beneficiaries of a skewed world sat silent in cold complicity.

However, two pieces of good news seeped through. The first is that Turkey and Greece, two neighbours whose conflicts began in May 1919, met on the side-lines of the UN conference on Wednesday at the Turkish House in New York. The bigger picture is that if both countries agree on full reconciliation, it might reflect on divided Cyprus. That country split in two in 1974 when Greece backed a military coup and Turkey retaliated by invading Cyprus in support of Turkish Cypriots.

It was the 78th Session of the United Nations General Assembly (UNGA), and even as the world on Thursday, September 21, complemented the UN objectives by marking the International Day of Peace, the voices for conflict were sounding more strident.

As world attention was turned to the UN stage, Azerbaijan and Armenia went to war in the disputed Nagorno-Karabakh territory which has been the source of unending conflicts since 1988. This time, the war lasted 48 hours, September 19–20, 2023. However, before the gathered Heads of State could raise an eyebrow, Russia had moved in to secure a ceasefire. But the crisis remains as Nagorno-Karabakh is peopled by 120,000 Armenians in a territory inside Azerbaijan.

Simultaneously, Canada and India were engaged in a spat as the latter suspended visa issuance to Canadians, expelled a Canadian diplomat and advised its citizens to avoid travelling to that country. The current disagreements began on Monday when Canadian Prime Minister Justin Trudeau claimed that there were "credible allegations" of Indian official involvement in the June assassination of 45-year-old Canadian Sikh, Hardeep Singh Nijjar.

The second good news was that the United States (US) and Iran who are virtually on war footing, made some goodwill gestures. The former released \$6 billion in seized Iranian assets while the latter released in exchange, five American prisoners held in Iran.

The disagreements are likely to further degenerate as Canada is being challenged to provide proof of its allegation. There are about two million people of Indian origin in Canada who might be affected if the disagreements fester.

Lula, a former labour leader, lamented that: "The destiny of every child born on this planet seems to be decided while they're still in their mother's womb. The part of the world where their

parents live, and the social class their family belongs to, will determine whether or not that child will have opportunities throughout life."

Those released include businessman, Siamak Namazi, imprisoned since 2015, Morad Tahbaz and Emad Shargi, held since 2018. The identities of the other two were not disclosed. So, the tradition was established. Now, as the host country, the US speaks next.

US President Joe Biden spoke about continuing the war in Ukraine with no talk about peace because: "Russia alone bears responsibility for this war."

Some have rationalised the attacks as justified on the basis that the mercenary Russian Wagner forces are involved in the Sudanese Civil War.

Nigeria's President Bola Tinubu lamented that: "Failures in good governance have hindered Africa. But broken promises, unfair treatment and outright exploitation from abroad have also exacted a heavy toll on our ability to progress." He added: "We welcome partnerships with those who do not mind seeing Nigeria and Africa assume larger roles in the global community."

How does that justify Ukraine attacking the African continent? Zelensky has no right extending the theatre of Ukraine's war with Russia to the African continent. But no country, whether European or African sought to call Ukraine to order. Rather, they sat listening to Zelensky raging about terrorism, "weaponising" food, and, rather than seeking peace, about the illusion of militarily defeating Russia.

Turkish President Recep Tayyip Erdogan whose country is playing a balancing act on world stage talked about humanitarian crises, economic problems, conflicts, and social tensions worldwide, concluding that: "Peace has no losers."

South Africa President Cyril Ramaphosa spoke for peace, women empowerment, equal access to healthcare, education, economic opportunities and the need for inclusive, democratic, and representative international institutions. He advised: "Leaving no one behind — that is the duty that we all have."

Nigeria's President Bola Tinubu lamented that: "Failures in good governance have hindered Africa. But broken promises, unfair treatment and outright exploitation from abroad have also exacted a heavy toll on our ability to progress." He added: "We welcome partnerships with those who do not mind seeing Nigeria and Africa assume larger roles in the global community."

President Paul Kagame of Rwanda whose country has witnessed genocide, bemoaned: "Today, there is no sign of ongoing conflicts ending anytime soon. Innocent lives are left alone to carry the burden of this instability. That is a profound injustice."

The problem is that most of those who gather at the UNGA making speeches they don't believe in, are irredeemable sinners whose actions would lead to the gates to hell being opened wider.

UN Secretary General António Guterres, who also spoke to the world leaders at a high-level summit on climate change, painted a picture of the universe thus: "Horrendous heat is having horrendous effects. Distraught farmers watching crops carried away by floods. Sweltering temperatures spawning disease." He concluded that: "Humanity has opened the gates to hell." But I do not think the gates to hell, have just been opened; they were opened over six decades ago when nuclear weapons were introduced and allowed to proliferate.

By 1986, there were over 70,300 nuclear weapons in the world. The good news is that by 2019 these had been reduced to 13,890. The bad news is that you don't need more than 100 to set the world firmly on the path of self-immolation. So, while climate change is a deadly path, mass hunger and poverty is deadlier, but nuclear weapons are the deadliest and fastest. The challenge is, even after the gates to hell have been opened, how does humanity avoid it?

# Kano Tribunal's Decision: A Simple Mob Job

he decision from the Kano State Governorship Election Petitions Tribunal to sack Governor Abba Kabir Yusuf and declare the candidate of the All Progressives Congress (APC), Nasiru Gawuna, winner of the March 18 governorship polls is simply an elaborated conspiratorial scheme masterminded by Abuja-led mob and unjustly executed by the three-man-led tribunal.

Reliable sources confirmed that the tribunal-led supervision of the ballots was rigged and did not bring on board the INEC or the NNPP in supervising the alleged 165,663 votes that needed to be signed, stamped, or

#### Halima, The Blind Chef

HE STORY of Halima Jibril Usman and her video in the kitchen was very impressive. She was in her uniform and a chef's cap. Born blind, the young woman in her early 20s is a student of Kaduna State University. She said she wanted to become a journalist and to become a famous chef as well.

She said her passion for cooking started since she was a child as her mother encouraged her to do household chores.

The automatic thought when people see a blind child is that he would end up being a beggar and a burden to his parents and the society. This mindset should be done away with. Some are not happy when offered alms since they are not beggars, though even those that offer don't mean to disparage them.

She uses her phone to learn recipes and advertises on social media platforms. Due to her condition, people are curious and want to buy the food directly from her to make sure she is the one cooking the food. She however has somebody to help her.

The vogue now among young women is to be a cook, create a name mostly with 'kitchen' attached to it and advertise online. Some are invited to television stations for cooking programmes. Halima also goes with the trend, and 'BLIND KITCHEN CREATIONS' is written on her cap and 'THE BLIND CHEF' written on her uniform.

Her story will give parents with children with disability hope and will encourage the children to believe that they can achieve what they want to do. That it is possible and therefore be self-reliant, employ others and help others as well.

The automatic thought when people see a blind child is that he would end up being a beggar and a burden to his parents and the society. This mindset should be done away with. Some are not happy when offered alms since they are not beggars, though even those that offer don't mean to disparage them. But this is because of the cultural mindset that a person with disability is a destitute in search of 'coins' thrown at him/her, so to speak, in order to survive.

The way universal education is said to be compulsory for every child in Nigeria, it should be as well for the physically challenged children. They should not be neglected and forgotten as if they don't count because they are the children of ordinary people.

The case of Halima is however among the few lucky ones, with education, supportive parents and equipped with a big modern kitchen to ply her trade.

There are many in special schools that may not have such opportunity or support at home, though the fact that they have the opportunity to attend the school is enough. They learn mobility; how to move around among other things. And they have their ambitions as well.

The way universal education is said to be compulsory for every child in Nigeria, it should be as well for the physically challenged children. They should not be neglected and forgotten as if they don't count because they are the children of ordinary people. The children of the wealthy with such conditions are taken to school, even sent abroad or teachers are engaged for them at home.

Those that beg in the street are many! Even in Abuja, you see young blind boys and girls with their parents begging. They should not be consigned to a life of begging without any future.

Halima has proved that apart from learning she could excel and compete with anybody in other field, her blindness notwithstanding.

Taking them to school may however be a challenge unless the community and religious leaders are co-opted into the scheme. It is not easy for those that are used to begging and don't have any contact with formal education to accept to go to the school, especially boarding schools.

One man told me that he once saw a blind child begging in the outskirts of Abuja. He wanted to talk to him and take him to the school for the blind. The man spoke only few Hausa words and instead of him to explain his intention to a Hausa person to talk to the boy and see his parents, he approached the boy directly and the boy took to his heels, probably afraid that the man meant to harm him.

Another interesting thing about Halima's story is how she is using her phone to do something positive as young people are advised to do instead of using them in ways that would not benefit them.

All hope is not lost! Halima has proved that apart from learning she could excel and compete with anybody in other field, her blindness notwithstanding.

#### Law Professors Pick Errors, Condemn Kano Governorship Tribunal Judgment

he Kano State Governorship Election Petition Tribunal on Wednesday sacked Governor Abba Yusuf of the New Nigeria Peoples Party (NNPP) while declaring the candidate of the All Progressives Congress (APC), Nasiru Gawuna, winner of the election.

The Independent National Electoral Commission (INEC) had declared that the NNPP polled 1,019,602 votes to defeat the APC with its candidate, Mr Gawuna, who scored 890,705 votes. The NNPP candidate thus won with a margin of 128,897 votes.

The APC had filed a petition challenging the election of Mr Yusuf. The three-member panel of judges led by Oluyemi Asadebay delivered the judgement on Wednesday virtually. The court invalidated over 165,663 votes printed in favour of NNPP.

The court deducted the invalid votes stating that the ballot papers (165,663) were not stamped or signed and were therefore invalid.

But perusing the judgement, some legal experts have picked professional and indicting errors in the judgement prepared by the panel.

Professor of Law, University of Ibadan, Professor S O Adegoke highlighted that the panel clearly showed sentiment and emotion in support of the APC in the language used in the judgement.

According to him, quoting the judgment, "I use this opportunity to condemn the gang of Red Cap wearers who like a violent and terrorist cult chased us out of Kano and put us in the fear of our lives. We believe that only Allah is the giver of power. Those who believe in Allah must bow to his will and submit to the authority of Governmental power. Resort to anarchy, violence and killing can never be a source of lawful power. Threatening to put Honourable Judges in the danger of their life as done in Kano by some disgruntled bandits parading as politicians is hereby condemned.

"Every Judge worth his salt will always abandone and ignore any form of threat to stand by justice and pronounce justice. This Tribunal in the lead judgment have pronounced justice and we stand by justice. I concur with the lead Judgment and commend my lord the Chairman for delivering this judgment under the threatened fire and brimstone by bitter losers. There is always another day for politics. I am in no doubt that the security Agencies know and are aware of those who removed their eyes from their case and put it on the Judiciary. They are also aware of those who extended the threat further by declaring that they will kill the Judges. This threat must not be swept under the carpet.

"Instead of some Kano politicians to be allowed to use banditry and violence to abort Democracy in Kano State, justice will be used to stop them from destroying Democracy in Kano and upward, we do not want Anarchy and terrorism as being promoted in Kano State and as threatened by them".

One could be forgiven to think the judgement was prepared by card carrying members of the APC, the language used clearly showed malice against the NNPP and it is by far the most unprofessional judgement I have seen in my 38 years in this profession, Professor Adegoke stated. Echoing Adegoke's submission, the Acting Head of Department, Law, University of Maiduguri, Professor Tijjani Buba also added that mentioning Nasiru Gawuna as a petitioner in the judgement when he is not, is clearly a case of gross unprofessionalism and hostility.

Also quoting the judgment on page 222, "It is hereby determined that the Petitioner, NASIRU YUSUF GAWUNA having scored a majority of lawful votes and having met the constitutional requirement, is hereby declared the winner of the election and returned elected as the Governor of Kano State", stated that, it's a disgrace to the law profession.

"I think the people who wrote that Tribunal judgement have a motive to disgrace the law profession and cause grace disrepute. It is the only explanation for this shameful narration as a judgement. I urged the National Judicial Council to investigate this issue as a matter of urgency", The university don concluded.



#### Kano's Governorship Electoral Outcome:

## Recalling The 2019 Edition

N WEDNESDAY, the Kano State Governorship Electoral Petition Tribunal sacked Abba Kabir Yusuf of the New Nigeria Peoples' Party (NNPP) as governor after deducting 165,663 votes from the total votes he scored during the election. The threemember panel of judges led by Oluyemi Asadebay ruled that the ballots containing the votes were not certified by the Independent National Electoral Commission (INEC).

Despite the tribunal's ruling, Mr Yusuf will remain in office until the appeal court and possibly the supreme court gives a final ruling on the matter. I have not studied the judgement so I would make no comments on subtractions that go only in one direction but the outcome is concerning to many in Kano.

Meanwhile, the Governor of Kano State, Abba Yusuf, has rejected Wednesday's judgment of the tribunal sacking him as governor and announcing the candidate of the opposition All Progressive Congress (APC), Nadir Gawuna, as the winner of the 18th March election. At a press conference late Wednesday, Mr Yusuf said that based on the feedback from his legal team, the judgment was marred by human imperfections and misapplication of the law, thus, he will seek justice at the Court of Appeal.

Meanwhile, Governor Yusuf has appealed to residents to maintain peace while vowing to use all legal means to reclaim his mandate. It appears that the outcome was no surprise to the NNPP who have been murmuring about a compromised tribunal and praying for God's protection. There is no information that I am aware of about the tribunal being compromised so they should be assumed to be acting only on the basis of legal arguments and NNPP should focus on the legal issues.

I would like to use the opportunity of this outcome to recall the contentious 2019 outcome that gave Abdullahi Ganduje a second term in office because the concern of many is that some electoral outcomes do not emerge from the democratic system.

"The Independent National Electoral Commission (INEC) has declared the governorship candidate of the All Progressives Congress (APC), Abdullahi Ganduje, winner of the Kano State governorship supplementary election held Saturday 23rd March, 2019. Governor Ganduje was trailing the PDP Candidate, Abba Kabir Yusuf, at the end of the first election held on March 9, 2019 by a significant margin. In the supplementary election held in 28 out of the 44 local government areas of the state, Ganduje won by scoring 45,876 votes to Yusuf's 10,239 thereby upturning the result in his favour. The State Returning Officer, Professor Bello Shehu,

announced that Governor Ganduje scored a total vote of 1,033,695 while Abba Yusuf polled 1,024,713 given the winning margin of 8,982 between the two major candidates. This was a surprising result as in places where PDP was far ahead, the tides turned and the massive results emerged for the APC.

"As an observer, I had noticed during our rounds that the massive presence of thugs had depressed voter turnout so how did the 32% voter turnout during the previous election scale up to turn the tide. I asked an Assistant Presiding Officer [APO] to recount what he saw happen in his polling unit. For his security, this traumatised student of Bayero University does not want his name or polling unit revealed.

"The APO recounted that his involvement was through Bayero University who had asked students interested in being ad hoc election staff to fill forms, he did and was selected and posted to Nasarawa Local Government. He took part in the Presidential/National Assembly as well as the Governorship/State House Elections and had very good memories of both. He was charged with the smart card reader, which worked well and only those voters who were authenticated were allowed to vote in the two previous elections. He said the whole process was free and fair and he felt he was playing an important civic role for his country.

"For the supplementary elections, he had reported to Gama Tudu Primary School, his Registration Area Centre (RAC) which was also the Ward collation centre at 7.30 pm on Friday, 22nd March, 2019, that is the night before the election time as directed by INEC. All ad hoc staff comprising most students and youth corps members were expected to spend the night there. He recalls there was a large number of policemen and civil defence corps personnel and they felt safe initially. Their trauma, he said, started at 10 pm that Friday night when mobile policemen came into the school and ordered the

youth corps and student ad hoc staff out of the premises without any explanation. They refused to go out and they were tear gassed out. It turned out it was simply an exercise of verification that they were the genuine names on the list. After the verification, the were allowed back in. He said they got very confused why they were tear gassed for a simple verification exercise because they would a verification exercise. "At midnight, they realised the school was

completely surrounded by thugs armed with clubs, swords and machetes. No one could sleep he explained. At 7.30am, that is Saturday morning, the day of the election security personnel escorted them to their respective polling units and had to set up surrounded by thugs. The first rule set by the thugs was that no cameras or cell phones must be used by anybody. Clearly, they did not want images of what was happening to be recorded he explained. He said he felt so harassed that he took his phone to a nearby house and

requested that they keep it for him. Trouble started at 11am when the thugs attacked and they all ran away with their materials. Subsequently, the thugs were cleared temporarily by the police and they returned and voting resumed. By 1 pm however, the thugs took over control of the voting process with police complicity who were present throughout. The thugs threatened to kill the ad hoc staff if they refused to cooperate. By this time all the PDP agents had been chased out. According to him the result of the polling unit was fabricated in the following manner:

First, the thugs came with 200 already thumb-printed ballot papers and stuffed them in the ballot box.


Secondly, they took out the ballots already thumb-printed for PDP during the polling and thumb-printed them again to turn them into spoilt ballots.

Thirdly, he was forced to sign additional ballot papers which the thug's thumbprinted for the APC.

Finally, the ad hoc staff were forced to record the compromised results on result sheets and they were taken to the INEC office.

"The APO explained he worked under duress because his life was threatened. He said they were held hostage by the thugs and were not allowed to go out to look for food to eat and his next meal came 24 hours later only after he got home. His conclusion is that he would never participate in any other election in any capacity for the rest of his life. SAD. It would be great if other ad hoc staff could write up their stories."

# Kano Guber Tribunal Judgement Can't Stand - NNPP Chieftain

APC Candidate was sacrosanct". He stressed, "Our party, the NNPP has about 26 members in the House of Assembly while APC has 14. So where has the Tribunal's derived the victory it gives the APC Candidate"?,
