Family Planning: FHANI Hails Uba Sani, Demands Cash Backing orried by the situation in some parts of the country, Pan-Yoruba socio-cultural and political organization, Afenifere yesterday, called on the federal government and security agencies in the country to rise up to combat the rising cases of insecurity, particularly kidnapping, in recent times.

Afenifere in a statement by its National Publicity Secretary, Comrade Jare Ajayi, emphasized that the federal government should urgently address the 'political, economic and ideological factors' identified by spokesman of the Department of State Security DSS), Mr. Peter Afunaya, as being responsible for recurrent incidence of kidnapping and banditry.

The Pan Yoruba socio a 13-year-old student by an

cultural and political organization maintained that this latest call became imperative in view of rising kidnap cases in Lagos, Ogun, Kwara and some other parts of the country.

Afenifere cited the cases of the armed robbery attacks at two commercial banks in Ikere, Ekiti State last Wednesday, resulting in the death of three Amotekun security personnel as well as the killing of Mr. Taiwo Oyekanmi, a director of finance in Ogun State, on November 29, 2023 in Abeokuta by armed robbers as some of the recent examples.

"Reports have it that seven people were kidnapped, while one person was killed last Monday at Fidiwo on Lagos-Ibadan Expressway. This came in the wake of the kidnap of Miracle Adereti Kolawole, a 13-year-old student by an

Katsina Governor Disburses Cash, Farm Implements Worth Over N1.7bn To 148,000 Vulnerable Families

overnor Dikko Umaru Radda has disbursed cash grants, farm implements and inputs worth over N1.719 billion to 148,000 most vulnerable and poor families in the state.

A statement by the Chief Press Secretary to the Governor, Ibrahim Kaula Mohammed said the funds and farm implements were disbursed under the second tranche of the Katsina State COVID-19 Action Recovery and Economic Stimulus Programme.

A mong the farm implements disbursed by the governor include, ruminant goats, power tiller, groundnut oil extraction machines, breeds of chickens and fish among others.

Governor Radda who launched the programme at the Local Government Service Commission in Katsina Metropolis said among the 148,000 men

and women who benefitted from the scheme, 6,100 were selected from 20 local government areas, with each getting 50,000 Naira.

According to Governor Radda, 43 village areas from across the 34 local government areas of the state would receive 12 million Naira each as grants for the execution of community development projects.

He said the projects would include water supply, renovation of schools and healthcare centers, depending on their needs. Governor Radda added

that 1,170 farmers were selected to receive farm inputs and implements worth 142 million naira. This he said was in addition to another set of 12,250 farmers also selected to receive goats, spices of fish and some implements worth over 763 million naira to boost their income.

Governor Dikko Radda said the government has

recently approved another 500 million naira to s u p p o r t t h e implementation of its programme in the state.


He explained that, another 145 million naira was also approved by his administration for the Community and Social Development Agency (CSDA) towards implementation of the livelihood and support to eight local governments not captured among some of the beneficiaries of the "KT CARES programme." Governor Dikko Umaru Radda urged the managers of the programme to ensure its successful implementation. emphasizing that, his determination to ensure government support reached the rural communities who constitute about 80 per cent of the electorates in the state

Earlier in an address of welcome, the Chairman Steering Committee who is also the state Commissioner of Budget and Economic Planning, Alhaji Bello Kagara appreciated the firm commitment of Governor Dikko Umaru Radda for driving the economy of the state.

According to him, the setback recorded by the programme in the past and the support of the Governor made it possible for achieving the success so far recorded.

On his part, the National Coordinator of the NG-Care programme who spoke through the State Coordinator, Alhaji Shuaibu Aliyu, lauded Governor Dikko Radda for his giant steps in kicking poverty out of the boundaries of the state through implementing the disbursement of NG CARE programmes.

Professor of Agricultural Geography, Professor Ibrahim Yusuf El Ladan spoke at length on guidelines on safe and sustainable utilization of the grants and assets under the NG-CARE.

(NDLEA) to rid the state of
drug and substance abuse,
a statement said on
Thursday.

Dubbed "Operation Gbailumo," the special operations commenced on Monday and will run for three weeks.

Operation Gbalumo will focus on several key areas, including raiding known drug hideouts and black spots, conducting targeted patrols in high-risk areas, monitoring illegal drug trafficking activities, and raising awareness about the dangers of drug abuse through community engagement programs.

It was said that the exercise would protect the state from influx of illicit drugs and drug-related activities, particularly in major towns and cities, before and after the festive period.

Speaking at a press conference held on Wednesday at the NDLEA Kwara Command headquarters in Ilorin, Special Assistant to Kwara Governor on Drug Abuse Prevention and Control, Hon. Aileru Olamilekan Mikail reiterated that the collaboration is part of the renewed effort of Governor AbdulRahman AbdulRazaq-led administration to maintain peace and security in the

"The festive season is a time for celebration and joy, but unfortunately, it is also a time when drug peddlers and users tend to become more active," he said.

"We will not allow our state to be used as a haven for drug traffickers or a breeding ground for drug abuse. This is why we have provided every necessary supports through a partnership with the NDLEA to launch this special operation. We urge the public to support the government and the security agents for the success of the operation." Aileru urged residents and visitors to the state to

visitors to the state to cooperate with law enforcement officials during the operation. He also said any suspicious activity or information about drug peddling or use should be reported immediately to the nearest NDLEA office or security agency.

On his part, NDLEA Commander Kwara Command, Mohammed Bashir, CN, commended the state government for its proactive approach and support to the agency. He pledged the command's unwavering commitment to the success of the operation.

"We have deployed a significant number of personnel across the state and we are prepared to work tirelessly to ensure a peaceful and drug-free festive season for everyone," the Commander declared.

While addressing journalists, Senior Special Assistant on Security Matters to Kwara Governor, Muyideen Aliyu, also highlighted the governor's commitment to providing a conducive environment for the security agencies to carry out their duties and maintain peace and security in the state.



Timi Frank Urges Police, DSS To Probe Wike, Others Over Alleged Killing Of DPO, Diversion Of \$300m, N9bn

Frank, on Sunday, called on the Inspector General of Police, Kayode Egbetokun and the Director General of the Department of State Services (DSS), Yusuf Magaji Bichi, to urgently investigate the Minister of the Federal Capital Territory (FCT), Nyesom Wike, over alleged complicity in the murder of a Divisional Police Officer of Ahoada Division in Rivers State, Bako Angbashim.

Angbashim, a Superintendent of Police, had led his men to raid criminal hideouts in the Odemude community in Ahoada West Local Government Area of the state on September 8, when a dreaded cult group led by Okpara ambushed them, opened fire and eventually captured Angbashim, decapitated his body and filmed their action.

His killing attracted nationwide condemnation with the police high command, the Federal and the Rivers State Governments ordering an investigation and immediate arrest of the suspects.

Frank made the call in a statement in Abuja while reacting to a claim by a member of the House of Representatives, Boma Goodhead, representing Asari-Toru Federal Constituency of Rivers State, that Wike was complicit in the killing of the DPO.

Goodhead had at a protest rally in Rivers State in support of Governor Siminilaye Fubara, accused Wike and some federal lawmakers of masterminding the killing of the DPO.

She also claimed that the Governor of Rivers State had caused the diversion of

\$300million given by Nigerian National Petroleum Company Limited meant for Ogoni cleanup and N9billion from the Internally Generated Revenue (IGR) of of the state.

According to Frank, the investigation has become necessary to determine the veracity or otherwise of the claims by Goodhead against Wike and two federal lawmakers from the state.

He also called on President Bola Ahmed Tinubu to set up a judicial panel of inquiry to unravel the killing of the DPO in order to ensure justice for the dead.

According to him, "If the President fails to take action or do the right thing, by arresting Wike and setting up a judicial panel of inquiry, I demand that every murder suspect in Nigeria that is already in prison or that is being tried should be set free.

"This is because nobody is above the law and we are all Nigerians. So we expect equal justice for all Nigerians."

Frank also urged Wike to resign his position as minister and submit himself for probe over the alleged murder of the DPO and masterminding the diversion of \$300million given by the NNPCL for Ogoni cleanup and another N9billion from the IGR of Rivers state.

He insisted that since Wike always claim to be a man of integrity, submitting himself to the security agencies like Goodhead had promised to do on the matter would further vindicate him.

He insisted that all federal lawmakers whose names were mentioned by Hon Goodhead in the killing must also be investigated.

He said: "The investigation must not be done in secret. It must be thorough and the findings made public because Hon



Goodhead has offered to reveal further details when invited by any of the security agencies concerning the allegation.

"Justice must be given to the family of this police officer who was killed. This is not the time to protect or hide anybody.

"We are calling on the National Human Rights Commission and the International Criminal Court to take up this matter and invite the Honourable Member who made this allegation to hear her out and thereafter take up the case to ensure that Wike is held accountable for the death." He also called on the Economic and Financial Crimes Commission (EFCC) to investigate the alleged diversion of \$300million from Rivers State's IGR.

unknown gang while returning home from school on Friday, December 1, 2023 in Ikotun area of Lagos as confirmed by Afonka Police Station in Egbeda, Alimosho, Lagos", it said.

Afenifere added, "Towards the end of October, sundry abductions took place in Ikotun, Okota, Ejigbo, Alimosho, Egbeda, Agege, Amuwo Odofin areas of Lagos according to published reports.

"Lagos State Police Public Relations Officer, Benjamin Hundeyin, according to BusinessDay, said that the police are aware of the situation and is taking decisive actions to round up the criminals".

"It is therefore, a matter of serious concern that a few weeks into the yuletide period, commuters on the highway have to travel with trepidation for fear of being attacked."

Afenifere noted that kidnap incidents are not limited to the metropolis or major highways alone, going by abductions that took place in parts of Oke-ogun, Oyo State in recent times. Some of such places were Saki, Okaka, Otu, Komu and in Offa in Kwara State, among others. Similar reports have been reported in parts of Ogun, Ekiti, Ondo and Osun States in addition to the

ones in the central and northern parts of

The Pan Yoruba body then called on President Bola Tinubu to address the political, economic and ideological factors mentioned by Afunaya, saying, the political, economic and ideological factors mentioned by Afunaya can be addressed by " urgently allow states and local government areas to establish police services and be in total control of the services with enhanced welfare for the personnel as well as deployment of modern technology for security purposes."

"Second is to ensure quicker

dispensation of justice so that those arrested for banditry can be tried with dispatch. The third thing to do is to take urgent steps at easing the socio-economic hardships in the country so that the people can be more empowered and for them to have more faith in the country and its government".

Afenifere maintained further "
The fourth thing to do is on the side of the government and the people. This involve deradicalizing the bandits in a manner that they would realize that what they are doing are self-destructive. It also requires the enlightenment of the people to

stop covering up known criminals in their midst."

It stressed that "But for this to be effectively done, the people need to be sure that their own life would not be endangered for exposing perceived criminals. As is known presently, those who tip security agents off of suspected criminals are exposed to danger as the criminals sometimes go after them on being told of who exposed them".

Afenifere added, " in other words, our security agencies need to put their own houses in order for the security steps they are taking to be effective". Afenifere spokesman concluded.

Delta Police Bans Fireworks, Warns Against Use Of Fireworks In Delta

he Delta State Police Command has banned the sale and use of fireworks, knockouts, firecrackers, and other pyrotechnics in the state.

The State Commissioner of Police, CP Wale Abass, on Friday warns that the fireworks, crackers and knockouts poses a threat to State security and should be avoided.

This was discussed in a statement signed by the state Police Public

Relations Officer (PPRO). DSP Bright Edafe, on Friday afternoon to journalists in the state.

According to the statement, "In his remarks, CP Wale Abass admonished that the usage of fireworks (knockouts) is capable of causing nuisances, which further generates undue anxiety, fear, and an unnecessary disruption of public peace. "Additionally, CP Abas warned against the hazardous consequences of its use, noting that it could give room to diversions that might give criminals the chance to continue their crimes and endanger residents.

"The CP warned in strong terms that any dealer or resident who fails to abide by the ban, when caught, would be made to face the wrath of the law. On this note, parents and guardians are urged to monitor their wards and curtail their use of knockouts during Christmas and New Year celebrations.

"CP Abass urges the good people of Delta State to be vigilant and security conscious as he reaffirms the Command's commitment and willingness to protect the life and properties of residents during the Yuletide season and beyond".

2023: FG Might Pay N600bn As Electricity Subsidy - NERC

he federal government in 2023 might have to pay N600bn as electricity subsidy, the Chairman/CEO of the Nigerian Electricity Regulatory Commission (NERC), Engr. Sanusi Garba, has disclosed.

He made the disclosure at the ministerial retreat on the Integrated National Electricity Policy and Strategic Implementation Plan on Tuesday in Abuja. According to him, the increase is despite the government's annual subsidy being reduced from N528bn in 2019 to N144bn in 2022.

He added, "the Service-Based Tariff (SBT) was instrumental to the reduction of tariff subsidies but the financial burden of tariff subsidies from 2015-2022 stood at NGN2.8tn."

He explained that the sector's insufficient enduser tariffs, poor DisCo collections, and revenue shortfalls, have served as a threat to investments and the sector's viability.

The Minister of Power, Adebayo Adelabu, while speaking, said there is the need to create another company from the Transmission Company of Nigeria (TCN) to strengthen its effectiveness in transmitting power from generating companies to electricity distribution companies.

The minister lamented that the use of ageing and dilapidated infrastructure by the TCN has made it unable to transmit enough power needed, while also decrying the dismal performance of TCN in the

By; AMOS TAUNA, electricity supply industry, as the way out of the inefficiency is to balkanise it into two.

He noted that in the Nigerian Electricity Supply Industry (NESI), the transmission subsector has been identified as a critical weak point in the value chain lately, a view widely shared, and to align with the Electricity Act, 2023 and the industry's demands, it's time to restructure the Transmission Company of Nigeria (TCN) into two entities: the Independent System Operator (ISO) and the Transmission Service Provider (TSP).

The restructuring, he believed must synchronise with the evolving landscape of State Electricity Markets, addressing calls for the decentralisation of the national grid into regional grids interconnected by a new higher voltage national or super-grid.

He explained that the nation now generates over 98 per cent of electricity through renewables as against the 70.5 per cent generated last year.

As of 2022, he stated that 70.5 per cent of the nation's grid electricity was generated by thermal plants, 27.3 per cent from hydro, whilst solar and other power plants made up 2.2 per cent, adding that the good news is that over 98 per cent of the feedstock powering electricity generation in the country are transition or clean fuels, as Nigeria ramps up capacity to generate more electricity through renewable means such as solar, hydro, wind, bioenergy and others.

Minister Pledges Support For Capacity In Health Sector

Activists Fault Buhari's Use Of Military Force In Truncating EndSARS

igerian human right activists Dabiraoluwa Adeyinka Honey and Ifeanyi Okoye have, in different interviews, blamed ex-president Muhammadu Buhari for truncating a peaceful protest across the 36 states with a military action that became historical.

Honey and Okoye spoke on the current state of the country as well as why the ex-president should be called to answer queries on the instruction of the military action as well as all he knows about the protest that went south.

"I would be very honest and this is a constructive explanation from my end. First and foremost, there was an administration in power at that time and ex-President Muhammadu Buhari was the head of that administration. I know for sure that no country's military act without the approval of the number one citizen, in person of the president, so the number one and only person that should be held responsible for the EndSARS incident which continues to resonate amongst Nigerian youths and has become a stigma, is no one else but expresident Muhammadu Buhari, " Honey began.

Supporting Honey's submission, Okoye, who is calling for ex-Army Chief, Tukur Buratai's trial, said, "Many people talk and say Governor Sanwo-Olu should not be exonerated but I, Comrade Ifeanyi Okoye, can tell categorically that the governor was never in charge of the security apparatus until we have a state police because we still run a federal police system and central military system with the C-in-C still the president and the



to answer several plaguing questions as to why." In the same vein, Honey, an

entrepreneur and construction expert exonerated the Lagos State Governor, Babajide Sanwo-Olu but insists the whitepaper document recommendation by the panel he set up to look into the EndSARS activities should be implemented.

"Breaking it down now, I was in Lagos and it was tough, there was chaos, Lagos was like the leading state and we have Babajide Sanwo-Olu, whom I saw on two occasions visiting Buhari with our demands but what went wrong, I can not explain. In fairness to Mr Sanwo-Olu, I also saw him trying to engage us on a few occasions but my issue was when the order was given by the then administration, he could have interjected because we are in a democratic state and not a military state. Governor Sanwo-Olu tried his best but he could have done more. The aftermath of EndSARS saw him visiting the victims, organised a panel and the panel concluded its submission with a whitepaper document but he's now referring us to the Federal Government. Sadly, the past administration won't do anything again and the current administration might not be able to do anything because they are just in the system. We are not saying we want to hold Sanwo-Olu responsib; le but what we are saying is that there should be an implementation of the whitepaper document. Even President Bola Ahmed Tinubu's administration can re-write the story of EndSARS to give hope to the Nigerian youth and that is because the Nigerian youths

Adding to Honey's submission, Okoye said, "Governor Sanw-Olu set up a panel that came up with a whitepaper document and despite all that efforts, the recommendation of the panel in the document is yet to be implemented. The military men, the errant police officers, who necessitated the protest, and many more should be brought to book. Till date, neither the military officers nor the SARS operatives have been brought to book for their actions. In the same vein, the Chief of Army Staff or the ex-President have not been tried for their involvement in the military action that occurred in Lagos." Okoye rounded off saying the EndSARS protest and the outcome has re-awakened the political consciousness of the Nigerian youth.

He further maintained that this was seen in the outcome of the last general election.

"EndSARS remains a sad one and it's something that awakens the political consciousness as regards the quest for good governance and demanding accountability from our leaders in terms of creating and implementing workable policies. I would gladly say that the outcome of EndSARS brought about the sub-consciousness of young people. The reality is that the outcome of EndSARS wasn't what we bargained for and this was evident in the last election. The movement created a subconscious political awareness in young people but as much as that, many young people are disappointed with the process. It's not yet Uhuru, it's a time to build on the gains of the last election and build the momentum."

Kaduna 2024 Budget: CALPED

Frowns At 13% Allocation To Health

he Coalition of Associations for Leadership, Peace, Empowerment and Development (CALPED), has decried the percentage allocated to the health sector by the Kaduna State Government in its 2024 draft budget.

This was expressed in a communique jointly signed by its Programme Officer, Governance & Advocacy, Seth Luke and Head of Leadership, Governance and Advocacy, Yusuf Ishaku Goje, made available to our correspondent at the weekend in Kaduna.

"The reality of deficits in the health systems prompted the African Heads of State and Governments to promise to allocate at least 15% of their annual budgets to the health sector in what is now known as the 'Abuja Declaration' in April 2001.

"The last administration adhered to this commitment, we therefore, call on this administration to sustain the Abuja Declaration by ensuring at least 15% of annual spending is allocated to the health sector. This is because according to the draft budget made public by the Planning and Budget Commission a day before, the sector got about 13%, even though the speech by the Honorable Commissioner mentioned 15%," CALPED said.

The group said that the Inflation rate in the fiscal assumptions is unrealistic and does not speak to the current realities, the inflation rate is projected at 23.6% for 2024 as against the 27.33% published on the NBS website, thus planning for development should be based on realistics data.

"The projected economic growth rate is overambitious looking at the economic instability occasioned by different factors such as insecurity. It is important to note that the International Monetary Fund (IMF) recently downgraded Nigeria's economic growth forecast for the year 2023 to 2.9%. This should be reconsidered and reviewed to ensure it is more realistic. "The 2024 total draft budget is N35.3 billion (8.35%) higher than the MTEF recommended budget size. This means that the Government would have to borrow more to finance the deficit or shortfall. Debt servicing has continued to

impact negatively on critical

infrastructure and service delivery as money allocated for debt servicing annually is gradually competing with capital expenditure. This trend should be checked by both the Executive and the Legislature, "the communique said.

It noted that the 2024 draft budget increased by N81 billion (21.7%) from the 2023 budget.

" It is good for the government to spend more on its citizens. However, there is a need for clear and effective strategies to enhance revenue generation using the appropriate fiscal policy instrument that would enhance the revenue generation systems and processes. This should focus more on expanding the revenue sources not increasing tax rates.

"The State government should accelerate the review and approval of the Sector Implementation Plan (SIP) to ensure adherence to policy-budget linkage and result-based monitoring & evaluation. Ideally, the sector's budget should be drawn from their various SIPs.

"The approved MTEF (2024-2026) macroeconomic framework recommended exchange rate of N750 should be adhered to, as appears to be more realistic considering the risks factors identified," CALPED advised.

The communique explained that, "Key overhead cost (some of which we have identified amounting to N7.7 billion) should be reviewed and considered for reallocation to strategic priorities.

"The viability of the proposed loan from Afri. Exim Bank should be reconsidered to ensure guarantee for accessing the loan. If not it should be dropped and a supplementary budget initiated when the loan is 100% guaranteed.

"A percentage of the allocation for social investment programmes should be allocated to the take-off of the Social Security Administration to ensure better coordination mechanism and value-formoney.

"The Equity Funds Basic Health Care Provision F u n d s (B H C P F) Counterpart Funds should be released adequately and timely to ensure more vulnerable groups are enrolled," the coalition further advised.

The ongoing International conference at DUFUHS, which started on 12th Dec.2023, witnessed participants from all parts of the world who registered for the 3

Speaking on the theme: "Public Health Teaching, Research and Services in Africa in a Post-Pandemic Era", the Vice Chancellor of David Umahi Federal University of Health Sciences, Prof.Jesse Uneke while presenting his address, welcomed the participants to the 4th International Conference on Public Health, stating that the University has engaged with the global best practices to ensure public health teaching, research and services in the institution.

The vice chancellor who was represented by the Provost of the University, Prof.Esther Ajuruchukwu appreciated the participants for their commitment and

timely response to the 4th International conference, saying that the institution has made concrete and excellent efforts to provide all the human and material resources needed to ensure the success of the conference.

Also speaking, the Chief Medical Director of David Umahi Federal Teaching Hospital(DUFUTH), Prof. Agwu Uzoma in her address, said that the conference is timely as public health teaching, research, and service is so significant and relevant because of the role it plays in our contemporary society. She applauded the efforts of the vice chancellor in ensuring that the institution gives out the best in public health teaching, research, and services to the students and the general public.

One of the keynote speakers, Prof. Williams Brieger of the Department of International Health, Johns Hopkins Bloomberg School of Public Health, USA while making his presentations on the topic, 'Pandemics: Lessons for Public Health Teaching, research, and Service in Africa ' stated that based on assessment after the Ebola and subsequent --19 outbreaks in West Africa, that there were

low levels of preparedness of government and public health institutions to mitigate and control these diseases. He explained that these epidemics exposed major weaknesses in the capacity of most African countries to cope.

'In particular, there was not only poor logical capacity for testing and treatment but also low staff/training" William Brieger said.

He outlined major outbreaks between 2014--2023 in Nigeria including Ebola(2014), Meningitis, monkeypox, yellow fever(2017), Lassa fever, measles, monkeypox (2022), Polio Reemergence(2016) lessa fever(2019), Cholera(2021), and Meningitis, Cholera, Diphtheria(2023).

Prof. Williams explained that our public health training, research, and service institutions are challenged while addressing the routine needs of the population because pandemics and outbreaks take these challenges to another

Speaking on HIV--AIDS as one of the earliest recognized pandemics, Prof. Williams said HIV had a zoonotic origin. but later took on a life of its own, saying that scientific and public recognition of the problem was difficult in the easy days not just because of lack of technology, but also due to cultural taboos. In his words: While preventive measures were promoted, public acceptance was poor, and response to testing was deterred due to lack of effective instruments but being managed better now that key lessons about pandemic abound".

He also spoke on Regional Ebola Response and Collaboration, BBC Analysis for COVID-19 Response in Oct. 2020, amongst other lectures.

Other notable speakers include Siobhan Fitzpatrick from the World Health Organization, and Ms. Oyeronke Oyebanji from the London School of Hygiene and Tropical Medicine, United Kingdom.

Also expected are, Dr. Uba Nwose of the School of Health and Medical Science, University of SouthernQueen's Land, Toowoomba, Australia, Dr Daniel Umezurike from Federal University Teaching Hospital, Abakaliki amongst others.



UITH Experts Begin Intensive Research On Alzheimer's Disease

Alzheimer's disease.

The New Nigerian Newspaper reports that the programme is under the African Dementia Consortium (AfDC).

The project is entitled:
"Recruitment and
Retention for Alzheimer's
Disease Diversity Genetic
Cohorts in the Alzheimer's
Disease Sequencing
Project Consortia
(ADSP)".

One of the experts, a prominent researcher in UITH, Prof. Kolawole Wahab, of the Department of Medicine, has researched on various diseases, including stroke, and delivered a paper in his inaugural lecture titled: "In the Quest for a Masterstroke for Stroke'. Speaking on the project at a meeting organized for Community Advisory Board members and Research Team in Ilorin, Wahab explained that the project is an international study on Alzheimer's Disease".

According to him, Nigeria is one of the country of research where extensive research would be carried out in various cities including, Ibadan, Lagos, Zaria, Ilorin and Abeokuta among others.

Wahab described Alzheimer's disease as a brain disorder that gets worse over time.

According to him, the disease is characterized by changes in the brain that lead to deposits of certain proteins.

He said: "Alzheimer's disease causes the brain to shrink and brain cells to eventually die. It is the most common cause of dementia, which causes a gradual decline in memory, thinking, behavior and social skills". The expert lamented that these changes affect a person's ability to function.

Wahab pointed out that the disease is a huge burden in Africa especially in Nigeria, couple with the fact that there are no data to show the exact number

of sufferers.

"Its a common degenerative disorder, one can loose cells in the brain and we see them in the community.

"We are however, not seeing cases because of the different interpretation giving to the disease and fear of stigmatisation," he

He explained that it is a disease common with the aged population, as their brain is degenerating and unable to handle information.

The expert who teaches in the Faculty of Clinical Sciences, College of Health Sciences of the University of Ilorin underscored the need for building capacity to get more data on the disease in Africa, most especially in Nigeria.

Similarly, the expert disclosed that a corresponding research is also taking place in the United State, to study Alzheimer's disease on Latino and African-American population.

"This information will then be compared with those collated in Africa and see difference in manifestation. There is need to look and find if there is genetic disposition.

"The data that is realised will help to find cure for the disease and see ways of personalising medication early in life," he said.

Also speaking, Prof Uthman Mubashir, the Cimmunity Engagement Coordinator of the programme explained that the role of community advisory board is to assist the team in building community trust for participation in the research.

According to him, they are also expected to create community awareness, facilitate community outreaches and also assist in public relation purposes among others.

Mudashir who is a public health expert in the UITH emphasized on the importance of the programme, adding that data collated from various subjects committed to the research will be beneficial to humanity.

Financial Inclusion Insurance A Policy Tool For Addressing Poverty In Nigeria - Prof Yusuf

Nigerian scholar has advocated f i n a n c i a l Inclusion in Nigeria's i n s u r a n c e s e c t o r, describing it as a major policy tool for addressing poverty in the country.

Professor Tajudeen Olalekan Yusuf, a Professor of Risk Management and Insurance Awareness, expressed the view while speaking on the topic, "Marketing Insurance for Financial Inclusion in Nigeria: Gaps and Opportunities," at an allinclusive mass media workshop on insurance awareness.

The event which took place in Lagos was organized by Insurance Publication Limited in collaboration with Centre for Financial Journalism.

According to Yusuf, the need for financial inclusion in Nigeria is an urgent one that is underscored by available evidences.

While emphasizing that governments and insurance regulators have to worry about insurance penetration and contribution to Gross Domestic Product (GDP), Yusuf said that the real challenge is the insurance practitioners who have to develop products that will effectively address those massive protection gap.

The professor said, "Financial Inclusion is a broad terminology that refers to decisions and a ctions taken to democratize finance by ensuring that every individual and corporate entity has access to financial products and services irrespective of their net-worth, size, gender and/or location."

Yusuf pointed out that central to financial inclusion is the removal of barriers to access that reduces exclusion and, in

the corrollary, enhances inclusion.

He stressed that financial inclusion has become more important in a world of increasing inequality and inequity in both income and wealth distribution. "It has therefore become a major policy tool for addressing poverty and intervening at the bottom of the pyramid," he declared.

Yusuf said that according to Micro Insurance Network (MIN) finding, inclusive insurance is targeted at about 6.5 billion people worldwide who are vulnerable to sickness, job loss, business premises destruction or damage by flood or fire.

He highlighted that the real concern is about the 1.8 billion people in the world who are very poor that do not have enough food to eat.

"Add to this another 4.7 billion people that are not extremely poor but are highly vulnerable and that make up the figure of 6.5 billion people that are generally referred as low income, emerging insurance customers and bottom-of-the-pyramid," the Risk Management professor elaborated.

"There is a huge gap

between losses to life and property that are insured and those that are not. This is known as the protection gap," the facilitator stated. He explained that Micro Insurance is a subset of insurance, adding: "It aims to protect low-income people against specific risks, and its target market is the low-income demographies."

He noted that the term Micro Insurance is relatively new, and highlighted that one of its objectives is to help increase the penetration in the Nigerian population, especially the low-income class who shy away from insurance.



Family Planning: FHANI Hails Uba Sani, Demands Cash Backing

*Says family planning not only moral imperative, sound economic decision

hile appreciating the K a d u n a S t a t e Government for its commitment towards supporting family planning, a group, the Family Health Advocates in Nigeria Initiative (FHANI) has advocated for cash backing of allocated funds.

This was expressed by FHANI at a press briefing in Kaduna yesterday.

Speaking, Secretary of FHANI, Benjamin Yunana Maigari said that the Uba Sani-led Kaduna State Government has recognized the critical importance of family planning.

"I wish to appreciate the Executive Governor of Kaduna State Senator Uba Sani and his government for recognizing the critical importance of family planning in promoting the well-being and empowerment of individuals and families. It is a fundamental right for every person to have access to comprehensive family planning services and information, enabling them to make informed decisions about their reproductive health.

"In light of this, I am pleased to announce that the Kaduna State Government in it's proposed budget has taken a decisive step towards strengthening its commitment to family planning, by its decision to significantly increase the budget allocation dedicated to family planning initiatives from 6,800,000 for 2023 programming to 70,000,000 in 2024 and has decided to make it an MOU with UNFPA through the State Primary Health Care Board to dedicate a counterpart funding with the economic number 23010222 and the amount of 608,396,619.51 in the proposed 2024 budget," he said.

He explained this increased budget allocation will enable the state expand the reach and availability of family planning services.

"It will also support the provisions of such commodities and Consumables to PHCs and general hospitals that provide essential reproductive health services across the state.

"Furthermore, the increased funding will also contribute to the monitoring, training and capacity building of healthcare



professionals, ensuring that they are equipped with the knowledge and skills necessary to deliver high-quality family planning services," FHANI said.

According to him, "We believe that investing in family planning is not only a moral imperative, but also a sound economic decision. By empowering individuals and families to plan and space their pregnancies, we can reduce maternal and infant mortality rates, improve child health, and promote economic stability and sustainable development.

"The government's commitment to increasing the budget

allocation for Family Planning shows the government is development focused and people oriented. Family Health Advocates in Nigeria Initiative FHANI wishes to appreciate the Kaduna State Government and to also call on the Kaduna State government to cash back the 250,000,000 earlier approved by the previous administration and also cash back

"it's commitment in the 2024 budget. FHANI will keep supporting the state government for improve health care services and will not relent in it's advocacy for the release and cash backing of funds allocated for Reproductive Health services in the state".

FHANI further aappreciated the state government for maintaining and surpassing the Abuja declaration of 15% budgetary provisions to health. FP2030, which Nigeria is a signatory also mandated member states to allocate 1% of it's health budget to Family Planning.

"We are calling on the Kaduna State House of Assembly as it's approved the budget to look into the FP2030 commitment," he appealed.

IPAC Chairmanship Candidate Facing Criminal Charges

key contender for the post of the national chairman of the Inter Party Advisory Council (IPAC), Alhaji Yusuf Mamman Dantalle is currently facing criminal charges at the Federal High Court, Lokoja over alleged possession of arms.

Findings revealed that the State Security Services (SSS) had in October, 2021 dragged Dantalle before the Federal High Court, Lokoja.

Dantalle who is the national chairman of Allied People's Movement (APM) was alleged to have been caught with a pistol and other dangerous weapons at Ayingba in Kogi State sometime in 2021 and the case is still pending before the Federal High Court, Lokoja

Despite the criminal charges hanging on him, Dantalle is contesting the IPAC national chairmanship position against the national chairman of Action Democratic Party (ADP) Engr Yabagi Yusuf Sani.

Although it is not clear as at press time whether or not the IPAC's electoral committee will clear Dantalle, but the chairman of the committee, Barr Dan

Nwanyanwu told our correspondent on phone that he has no position on the candidature of Dantalle.

Nwanyanwu said it's not in his purview to take a decision on the eligibility of any of the contestants vying for any of the positions,

stressing that his duty is to serve as an umpire for the election. He said, "as an umpire in the election, it is not my duty to determine w h o is qualified to contest and who is not qualified to contest. I am an umpire in h forthcoming election of IPAC and my duty is to conduct election and not to take position on who to contest and who not to contest."

However, findings by our correspondent revealed that the State Security Service had in October 2021 instituted a case against Dantalle and the case is yet to be adjudicated by the court.

The statement of offence prepared and signed by Mr Olanrewaju Yahaya, the Principal Legal Officer in charge of Discipline and Legal Services, State Security Service in Kogi State indicates that Dantalle committed the offences with an accomplice who is currently at large.

The statement marked LKJ/FHC/61/21 reads "that you Yusuf Mamman Dantalle, Male, (49 years old), on 4th October, 2021, at Anyigba, Dekinn Local Government Area of Kogi State, within the jurisdiction of this court was arrested with Barreta

Pistol with serial number 215RR95042, without license, thereby committed an offence.

"That you Yusuf Maman Dantale in October, 2021, at Anyigba was arrested, with nine live rounds of ammunition, without license, thereby committing an offence.

"That you Yusuf Maman Dantale in October, 2021, at Anyigba was arrested, with nine live rounds of ammunition, without license, thereby committing an offence," it added.

He was alleged to have carried out the offences with one Abdul Oye who is currently at large.

When contacted, Dantalle confirmed that the matter is still before the court, saying that he is presumed innocent until the contrary is proved.

He refused to make further comments on the matter, claiming that it is still before the court and he has not been found guilty

Why We Should Stop Going To Court After Elections (2)

n the first part of this write-up, we saw how in 1983, the National Party of Nigeria (NPN), afraid of defeat, capitalised on Shehu Shagari's perceived likeability and reversed the election timetable and started with a vote for the president.

They relied on what they christened the "bandwagon effect" to commit monumental electoral fraud to win, calling it a "landslide" victory, which opponents and critics derisively described as a "moonslide".

We also saw how in 2003, the same fear of losing, the threat from General Muhammadu Buhari's foray into the presidential race, an altercation with his deputy, Atiku Abubakar, and knowing how weary his party and governors were of his dictatorial tendencies, made Obasanjo reverse the election timetable to start with his. Filled with paranoia, he assumed that he would be sacrificed once others won their elections, and so he engineered the reversal of the order of the elections.

Obasanjo calculated that the governors and the party structure would of necessity fight for him to win because his defeat would also signpost theirs. And they knew him well enough: if they allowed him to lose the election, he would make sure every one of them would lose theirs. The National Assembly easily became accomplices because the arrangement also favoured their political survival. Plus, he had introduced the politics of "Ghana-Must-Go."

We also saw and were impressed with the way they dispensed with election petitions within a month. We read how an election was held in August and the petition hearing started in the first week of September at a special tribunal that gave judgement within a week. The appeal to the Supreme Court was decided on the 26 of the same month and the swearing-in of the president took place on October 1. Judgement in the petition by Chief Olu Falae against the election of General Olusegun Obasanjo in 1999 was also delivered within a month.

Starting the elections with that of the president was reversed in 2003 by Obasanjo. But another aberration that got accepted was the prolonged election petitions that, in some instances, went beyond a year.

Apart from further dividing the voters for and against the litigants, election petitions invariably freeze government activities and put voters in limbo while they await the verdict. Struggling for legitimacy at the courts makes the respondents lame-duck.

Apart from the voters and process of governance that are affected, election petitions ought to be done with before inauguration, otherwise, the process will be unfair to three sets of people: the petitioner fighting an incumbent who has

a lot of resources at his disposal; the judge who will adjudicate in a matter concerning he who appoints him and the incumbent who, based on human instinct for self-preservation, will use the powers inherent in the office to trample over the system and win.

But perhaps the urge to go to court may be whittled down if the electoral commission is truly independent, not just in name. Therefore, the way its management team is appointed and how it can be unbundled should thoroughly be considered.

Having said all this, there are still those who hold the opinion that the presidential system may not be the best for us. The parliamentary system, to them, is cheaper with little room for contentions. Also, it demands greater accountability from those in office.

There is also a school of thought that believes the high financial return in politics - by fair or foul means - is what makes some politicians consider winning elections a do-or-die affair. To this school of thought, our politics and governance need to be demonetised and the winner-takes-all syndrome jettisoned.

Beginning with the last, they opine that the money spent on maintaining political officeholders is too much and pulling the nation into penury. They, however, contend that that may not be the case if we look inwards and get to be levelheaded.

A ready example is how each senator - Nigeria has 109 of them - will be bought a vehicle worth \$\frac{N}{160}\$ million. Worse is that the vehicles are foreign-made, causing capital flight. Buying foreign cars instead of locally assembled ones should no longer be acceptable for those holding public office. If we prefer foreign brands, why don't they come here and set up assembly plants?

Legislative work could be made a parttime job attracting sitting allowances, and all political office holders must have

Nigeria's interest uppermost in their minds.

For instance, those who have their children in private schools should not determine the affairs of public schools. How can one be in charge of education but send his wards to private schools or abroad?

Anybody who will administer education must have faith in what the government is doing to improve the sector which he superintends. They should not permit anybody who cannot sacrifice for the state to gain from the state. However, no harm if they want to eat their cakes and have it, but as public officers, they should

be made to contribute a certain amount to an endowment fund at the level of their office (a local government officer to the local government, state officer to the state and a federal officer to the federal government).

Such a policy should apply to the health sector as well. None of the leaders, together with their family members, should travel abroad for medical reasons, or patronise private hospitals, except in cases of exigency as determined by a competent medical team

Perhaps with these in place and free money no longer an attraction to public office, coupled with patriotism from political officeholders, electoral officers and judges, maybe, just maybe, court cases relating to elections may cease.

Rivers State And The Politics Of Absurdity

ESTERDAY, the Rivers State governor, Siminalayi Fubara, signed the 2024 Appropriation Bill of N800 billion into law. It appeared to be a banal act as had been done by so many other governors.

Rivers', however, is a special drama. He had transmitted the bill to the State Assembly only the previous day. Calling the 4 legislators he submitted the bill to as the State Assembly is a bit of a stretch as the body is composed of 32 members. The court-appointed speaker he works with had dismissed the 27 other members of the Assembly for carpet-crossing the previous day. It would have been silly old type unrealistic comic Nollywood drama has the issue not been such a serious one.

Dokubo, in a viral video clip that went public this week declared that his Ijaw people are angry with the present government because of the on-going crisis in Rivers State. Governor Fubara is Ijaw and Dokubo made it clear that if Wike is allowed to remove him, they would hold the government responsible. Ijaw organisations have come out clearly in support of the governor since the crisis broke out with the implication of a return of militancy if Wike is allowed to succeed in his political ambition of removing his former godson Fubara and installing another governor.

The story started at the end of November when dynamite was used to blow up a part of the State Assembly. It turned out that the recourse to explosives was to stop an attempt by some lawmakers to impeach Governor Fubara. The arson took place the night before the said impeachment would have occurred.

It is not surprising that there have been no concerns expressed by furious citizens or law enforcement agencies about such criminal activity to stop a state organ from carrying out its functions. Following the explosion, the governor indicated that his godfather, Wike, Minister of the Federal Capital Territory, was the brain behind the attempt to remove him from office. Wike told journalists that he was indeed fighting back because the governor he installed was trying to dismantle his political structure in the state and that impeachment is a constitutional route to addressing political problems.

Again, I did not hear screams on how dare a former governor proclaim publicly that he would personally remove a governor who had presumably just been elected into office by a majority of citizens of Rivers State. Where is the anger about disregard for democratic norms? What should we consider to be the legitimacy of the 27 presumably elected members of the State

Assembly who would be instructed by a former governor to change their party affiliation, an act prohibited by the Constitution and they would obey with immediate alacrity?

The core of the crisis is the lack of respect for democratic and constitutional norms. Wike has been a PDP member and since he lost his bid for the presidential nomination of the party, had set up a faction of governors that openly and systematically subverted the interest of his own party. He became the very symbol of the definition of anti-party activities. It was to reward the damage that Wike did to his own party thereby boosting the chances of the ruling APC in the elections that Wike was rewarded with a juicy ministerial appointment. President Tinubu has therefore been a beneficiary of Wike's politics at the state and national

Governor Fubara, having procured judicial recognition of his faction of the legislature from the State High Court proceeded to completely demolish the State House of Assembly Complex and gave his faction a room in Government House to operate from, making a complete mockery of our constitutional order. He claimed the demolition was necessary because engineers had discovered structural defects in the building. The other faction also rented a meeting room in town and the two "assemblies" held parallel meetings yesterday.

Meanwhile, tempers are running very high in the state. The former Niger Delta militant leader, Asari Dokubo, is dragging the federal government into the matter. He called the President Bola Tinubu-led federal government as the worst ever the country has seen. He had previously been one of the most vocal supporters of Tinubu in the country.

Dokubo, in a viral video clip that went public this week declared that his Ijaw people are angry with the present government because of the on-going crisis in Rivers State. Governor Fubara is Ijaw and Dokubo made it clear that if Wike is allowed to remove him, they would hold the government responsible. Ijaw organisations have come out clearly in support of the governor since the crisis broke out with the implication of a return of militancy if Wike is allowed to succeed in his political ambition of removing his former godson Fubara and installing another governor.

In a swift response, the Minister of Information and National Orientation, Idris Malagi, yesterday dismissed allegations that the federal government orchestrated the political crisis in Rivers State. The minister emphasised the



absence of concrete evidence linking the federal government to the crisis, saying: "I've not found evidence to suggest that the federal government is engineering the crisis."

Money, armed thugs, illicit use of the police and the army and manipulation of the judiciary are the elements that define politics in Rivers State. It's a sad story of the negation and subversion of democratic norms. Meanwhile, we watch as the godfathers and their sponsors continue to draw on these resources to intensify the absurd struggle against democracy and constitutionalism.

The problem of course for the federal government is the very cosy ties between Minister Wike and the Tinubu administration suggesting that he is drawing upon "federal might" to remove Governor Fubara.

The core of the crisis is the lack of respect for democratic and constitutional norms. Wike has been a PDP member and since he lost his bid for the presidential nomination of the party, had set up a faction of governors that openly and systematically subverted the interest of his own party. He became the very symbol of the definition of anti-party activities. Convicted Drug Baron Forfeits Multi-million Naira Lagos Mansion As NDLEA Arrests 75-yr Grandma Over Illicit Drugs

convicted drug baron, Okenwa Chris Nzewi, has forfeited a multi-million Naira mansion located at K-5A/2 Road 14, Victoria Garden City (VGC) Estate, Lekki area of Lagos used as clandestine laboratory for the production of methamphetamine to the Federal Government, following his successful prosecution and conviction in court by the National Drug Law Enforcement Agency (NDLEA).

Okenwa, as confirmed by NDLEA spokesman, Femi Babafemi, was arrested along with his associate, Sunny Okeh Ukah on July 30, 2022 and subsequently arraigned on four counts in charge number FHC/L/527C/2022 at the Federal High Court, Lagos.

They both pleaded guilty on 17th July, 2023, while they were convicted and sentenced to four and three years imprisonment each with an option of fine of four million (₹4,000,000) naira and three million (₹3,000,000) naira respectively in addition to community service for four and three weeks each.

His vehicle marked EKY 496 DJ was equally forfeited to the Federal Government.

To further deny him of enjoying the proceeds of his criminal activity, the NDLEA, according to Babafemi filed a civil forfeiture charge against the building used as clandestine laboratory at the Federal High Court Lagos which initially granted an interim forfeiture order that elapsed on 6th December before the final forfeiture on 7th December 2023.

Meanwhile, NDLEA operatives in Lagos on Friday December 25,

arrested a 75-year-old grandma, Mrs. Sekinat Soremekun for dealing in illicit drugs.

At the time of her arrest in Oshodi area of Lagos, Babafemi confirmed, quantities of cannabis and litres of codeine syrup were recovered from her.

The grandma was said to have claimed her son, Segun who is now at large supplied her the illicit substances which she retailed.

In Imo, operatives on patrol along Owerri-Onitsha expressway on Thursday 14th December intercepted a way-billed consignment containing cocaine weighing 2.287kg.

The shipment coming from Lagos was concealed in cellophane condoms, and heading to Port Harcourt, Rivers State. A suspect, Isaac Okoh, 45, has already been arrested. No fewer than 10 jumbo bags of cannabis weighing 100kg were recovered from the ceiling of a dealer, Ibrahim Yahaya, 35, when his house was raided in the Tudun Kofa area of Lafia, Nasarawa State on Friday 15th December while he was also arrested.

At the SAHCO export shed of the Murtala Muhammed International Airport, MMIA Ikeja Lagos, over 1.5 million pills of tramadol 225mg and rohypnol were intercepted in a cargo going to South Africa by NDLEA operatives in collaboration with personnel of the Federal Airports Authority of Nigeria (FAAN).

Two suspects: Bada Olanrewaju Akorede, and Amusan Olufela Sharafadeen have so far been taken into custody in connection with the consignment, which consists: 1,050,000 pills of tramadol 225mg and 510,000 tablets of rohypnol.

At the Federal Capital Territory, FCT Abuja, operatives on Friday 15th December intercepted a consignment of 1, 496 bottles of codeine syrup at A.Y.A area of the city while a suspect, Ozioma Enoja, 31, was arrested in a follow up operation. Another consignment of 400 bottles of the same opioid coming from Port Harcourt, Rivers state was also seized along Abaji-Abuja highway on Saturday 16th December after which a suspect, Bala Ishaq was arrested during a follow up operation at Zuba motor

While 17 bags of cannabis sativa weighing 195.8kg stored in a bush at Gbanke village, Orhionmwon LGA, Edo state were recovered by NDLEA operatives on Wednesday 13th December, antinarcotic officers in Ogun state intercepted two suspects: Edun Olowokou and Tunde Elijah at Alamutu roundabout area of Abeokuta with bags of same psychoactive substance weighing 279kg.

In Borno state, NDLEA officers on Tuesday 12th December arrested Bukar Ali, 29, and Abacha Alhaji Fantami, 20, with 171kg of cannabis at Ngamdu, Kaga LGA, while three suspects: Jamilu Haruna, 22; Mohammed Hassan, 23; and Aminu Umar, 50, were nabbed with 57kg cannabis on Wednesday 13th December at Tsafe checkpoint, Zamfara state, when they were on their way to Zurumi, a village known as bandits' enclave.

At least four suspects: Ezekiel Monday Thompson, 56; Hezekiah Ime, 20; Nsikak Okon Jonah, 39; and Chidi Kalu, 44, were arrested with a total of 121kg cannabis and

His words, "There's need for attitudinal change from Nigerians towards the Police. Most people see policemen as valueless beings and of no use to the society. They see Policemen as what the Igbos called "Ozu".

"It is a thing of joy wearing the colour of the country's security agency, it's a pride to serve ones fatherland. We never had a feeling that it will later turn against us. If it was like this in the past, we wouldn't have love to joined because there were lots of job opportunities then to choose from.

" Today, when you wear the police uniform, the next person sees you as an enemy and that's why they kill policemen anyhow. But if a policeman mistakenly kills someone in the course of discharging his lawful duty, the whole world will call for his head, then the

issue of human rights comes in. But when a policeman is killed, nobody talks about human rights as if policemen do not also have human rights too".

Speaking further, the retired but not tired police chieftain posited that he had no regret serving in the Police Force, saying the job offered him a lot of exposure, experience and respect from the society.

" I feel happy serving my fatherland because the job exposed me to a lot of things and I gained a lot of experiences. The society respects me. When I also pulled out of service, my people received me back home with joy, honoured me and I became an illustrious son. They were proud that I represented them well. The police work offered me the opportunity to travel to many countries. I thank God that " I saw, conquered and returned home alive", retired CSP Adagba enthused.

Asked when is the appropriate time to start preparing for retirement life, CSP Adagba popularly called JayJay, advised all policemen irrespective of rank to start preparing for retirement as soon as they start work.

His words, "Get yourself prepared against your retirement and the preparation starts now. Save for the rainy days".

Stop Consuming Ponmo, National Steering Committee Tells Nigerians

he National Steering Committee on the implementation of the National Leather and Leather Products Policy has called for a halt to the consumption of animal hides and skins, popularly known as ponmo.

The call was made by the committee chairman, Prof. M.K Yakubu, Director-General/CEO Nigerian Institute of Leather and Science Technology (NILEST) Zaria.

According to him, the call for a halt in the consumption of hides and skins (ponmo) became necessary if the moribund tanneries in the country must be

revived for economic growth, wealth generation and employment creation. Prof. Yakubu added that about 7,000 cattle are slaughtered on a daily basis in the Nigerian abattoirs, and the raw hides and skins that ought to serve as raw materials for tanneries are ending up in people pots as delicacy.

"it is only in Nigeria that such a practice is found," he lamented. He is, therefore, of the o p i n i o n t h a t



discouraging the consumption of raw hides and skins will make raw materials available for production of needs such as footwears, bags, wallet, belts upholsteries and many other leather materials".

He however, opined that the consumption of hides and skin as ponmo can be achieved if incentives are provided to producers, processors, and marketers as well as incorporation of other groups to be affected into other forms of livelihood.

The DG also used the occasion to advocate the creation of the Leather Industry Pension Fund.

In his contribution, Mr. Emmanuel Kwaya, Director of Raw Materials Research and Development, added that the leather sector is contributing to quality export, national GDP, and creating employment to teeming unemployed Nigerian youth.

He, therefore, encouraged patronage of made in Nigerian leather products so that it can contribute positively to the nation's economy.

IPAC Election Crucial To Peaceful Electoral Environment In Nigeria - TMG

*Says desire to plant loyalists in every institution damaging quality of democracy

*Says planting, alleged buying judiciary has eroded citizens' trust

s the Inter-Party Advisory Council (IPAC) prepares for its election on Monday December 18, 2023, the Transition Monitoring Group (TMG) has noted the importance of the election to the democratic process and development in Nigeria.

This was expressed in a statement signed by Chairman, Transition Morning Group (TMG)/Executive Director Civil Society Legislative Advocacy Centre (CISLAC), Auwal Ibrahim Musa (Rafsanjani), which called for a fee, credible IPAC polls.

"As the umbrella body of all the registered Political Parties in Nigeria (IPAC) is a critical platform for the promotion and sustenance of free, fair, credible, transparent, acceptable, inclusive and peaceful electoral environment in Nigeria. Yet, Nigerians are not unaware that this critical aim of the conference of political parties have remained a mirage.

"Be that as it may, this important council must not be allowed to become another appendage of some political merchants and corrupt ruling class just as other independent bodies including election management bodies and the judiciary have appeared to become in Nigeria. It is in this light that TMG wishes to draw the attention of the public to the IPAC election, and to state categorically that it is not oblivious of attempts by some desperate political elite especially from the ruling party to plant candidates into the

leadership of the council of political parties in the country," the statement said. It said that, "this unending desire to plant loyalists and people with lack of integrity in every institution of democratic development in Nigeria is damaging to the quality of democracy in the country. While the regime has succeeded in planting loyalists in the National Assembly, which is capable of eroding the democratic principle of checks and balances as Nigerians have widely described the current Assembly as a rubber-stamp.

"Where the regime has succeeded in planting and allegedly buying over loyalists in the judiciary, it has also succeeded in eroding citizens' trust in the judiciary. In the same vein, where the regime has succeeded in planting loyalists as Resident Electoral Commissioners against citizens petition, it continues to deplete citizens trust in the electoral process. Every single selfish action has its wide-reaching consequences on democracy in Nigeria".

TMG warned that attempt to hijack the IPAC election only points to a regime which is bent on eliminating every form of opposition as the inter-party council is expected to present the most critical form of objectivity in the conducts of political parties in Nigeria since the opposition parties have failed woefully in that role.

"It is important to note that the foundation of democracy is anchored on strong

political parties that promote internal democracy through inclusive membership participation.

"The practice of monetizing every elective position in Nigeria is undemocratic and injurious to the growth of the process.

"Even as the attempts to plant loyalists in the leadership of IPAC is noted, TMG wishes to also bring to the public the fact that certain frontline candidates in the election have pending criminal cases in the court of law and wishes to state that it remains baffled that such characters are even allowed to run in this critical election." TMG stressed.

The group said that it is important to note that having an IPAC of people with integrity deficit will leave a damaging effect on the image of the council, hence, they are calling on the members of

IPAC in exercising their votes to ensure that such characters are not allowed into power.

"Also, TMG calls for a transparent electoral process which would give Nigerians the confidence that the Inter-Party Advisory Council has what it takes to entrench internal democracy in the

registered political parties in the country. The December 18th election is one of interest to Nigerians as citizens yearn for political party reform in the country. A credible IPAC election will boost confidence among citizens about the possibility of those reforms," it comcluded.
