The traditional leader who commended KADMAM for its efforts and sacrifices, urged the mechanism to continue in their advocacy until they get results for their efforts.



### 2023 Diaspora Remittances: 90% Did Not End Up In Nigeria - Oyedele

he Chairman, Presidential Committee on Fiscal Policy and Tax Reforms, Taiwo Oyedele, has said that findings have shown that about \$18 billion representing 90 per cent of the estimated \$20 billion Nigeria's diaspora remittances in 2023 did not end up in the country.

The World Bank had estimated that diaspora remittances to Nigeria in 2023 was \$20 billion. Speaking in a panel discussion at the 2024 Economic Outlook and Budget Analysis organised by the Lagos Chamber of

Commerce and Industry (LCCI), Oyedele alleged that more than 90 per cent of the remittances were externalized.

He explained that in their interactions with multinationals, rating agencies and other stakeholders, many of them stated that exchange rate difficulty is more than 50 per cent of all the challenges in Nigeria combined, as far as they are concerned, saying that it is a major issue that the country has to address.

According to him, "And we thought it is going to be an area where we can easily demonstrate how the monetary and fiscal policies can work together. So, to that extent, we have done a sensible amount of work on the fiscal side. And we have been speaking to the Central Bank of Nigeria (CBN). The ultimate objective being that, first and foremost, we think that the biggest problem we have is the fact that we have divergence in exchange rates."

He further explained that the World Bank said for 2023, the country's diaspora remittance was about \$20 billion, pointing out that they estimated that more than 90 per cent of that did not get to Nigeria as they are being externalized.

He said that they have spoken to loads of Nigerians almost everywhere, in the US, UK, and they told them how they send remittance, saying that they used Apps, and they have tried some of those Apps, they used parallel market rates and as one take \$1,000 in New York, and tap on the phone that one is sending \$1,000 to someone, a Fintech, they pay the Naira equivalent in Nigeria without bringing the dollars, unless of course if the source of the money is illicit. Mr Gabriel Idahosa, LCCI

President, earlier in his welcome address, explained that policy reforms by the government, especially the removal of fuel subsidies and floating of the exchange rate, are expected to boost fiscal revenue and contribute moderately to the improvement of the country's growth this year.

The Director General, Budget Office, Ben Akabueze, also stated that one of the challenges facing the nation is that of low public revenue against a growing population, adding that Nigeria has had over three decades of deficit budget.

"The commission should not allow itself to become a tool of political vendetta, blackmail or intimidation against any individual through personal grudges, persecution and campaign of calumny to tarnish the image of certain personalities or any perceived political enemies of the characters hiding behind their executive power to unleash allegations through media for public consumption and sympathy.

"There are groups of people who are allegedly sponsoring such sinister motives against some of the political leaders mentioned in the Punch hatched story on order to tarnish their reputation; those affected are senators Adamu Abdullahi, Danjuma Gone, Rabu'u Musa Kwankwasko, Aliyu Magatakarda Wamakko, Dr. Bello Mohammed Matawalle, Sule Lamido, among others," the communique said.

According to the communique jointly signed by Dr. Usman Sani, (Chairman) and Comrade Yusuf Abubakar Dingiyadi (Secretary), issued at a press conference at the end of the two-day meeting of the groups, EFCC Chairman, Ola Olukoyede should stick to standards.

"While we commend the efforts of the new leadership of the Economic and Financial Crimes



Commission (EFCC) under Mr. Ola Olukoyede in the fight against corruption we have no doubts that the new EFCC boss will stick to the standard of the operation of the commission.

"However, we are dismayed with the recent reports and publication by the Punch Newspaper title EFCC revives 13 ex-govs N772bn fraud cases in which it hurriedly published names of certain political leaders, and individuals with alleged accusations of amassing public wealth illegally without recourse to the due process and rule of law.

"The hurried publication has now become a big embarrassment to them, their families, political associates, and our dear nation in the quest for objectivity, a presumption of innocent, emotional, and moral psyches.

"We think that certain groups of political class because of vendetta or other reasons are cheaply using some media platforms to drag the anti-graft agency image into disrepute to achieve cheap and unpopular political scores," they said.

While however, appreciating EFCC's highly motivated operations and effective fight against crimes and corruption in the country so far, they pointed out that it is pertinent to note that, the new objectives assured by the leadership of EFCC in the fight against crimes and corruption under President Ahmed Bola Tinubu are about to be eroded by certain selfish group of political individuals with access to media and investigations in the commission.

"It is unfortunate that those who have done their best as governors to develop and make progress in their respective states are being ridiculed by some faceless groups through media trials.

"Most painful to see even the serving political leaders are not spared example of Dr. Bello Matawalle who has served Zamfara State meritoriously, honestly, diligently, and transparently, but his name was involved in this conspiracy by some hidden forces with the intention to destroy his good name and service rendered for the progress of his state and the country at large.

"Matawalle was successfully screened, and cleared by the Department of State Security and EFCC many weeks before appearing to the Senate for another screening and subsequently cleared as Honourable Minister of the Federal Republic of Nigeria.

"It's pertinent to note that, those who are putting this campaign of calumny against his personality on media are just afraid of his growing popularity and acceptance, especially as Honourable Minister and political leader in the North West region and Nigeria as a whole," the communique stressed.

The group said, "We are surprised that the same EFCC that cleared and gave him a clean slate will return through the back door to allow such alleged documents to be circulated and

published by the Newspaper. It is like rubbishing the Presidency, Senate, and other security agencies that worked tirelessly to ensure due process before clearing him for ministerial responsibility."

They therefore, advised EFCC leadership to denounce the Punch publication and bring out a bond of assurance by ordering those petitioners, characters who allegedly accused those mentioned by the Punch Newspaper and many others to come out publicly and sign to pay compensation to those accused if after investigation and court process were found in nocent from such allegations.

# Despite Border Closure, Katsina Customs Generates Over N1bn

atsina Area Command of the Nigeria Customs Service (NCS) has generated over 1.132 billion Naira in 2023 fiscal year, despite the challenges of banditry and border closure with neighbouring Niger Republic.

The Command's Controller, Comptroller Mohammed Umar, disclosed this in a statement by the Command Public Relations Officer (PPRO), Superintendent of Customs, Tahir Balarabe while decorating 30 newly promoted Officers of the Command on Friday, January 19,2024 at the Command's Headquarters in Katsina Metropolis.

Comptroller Umar said that, the

1,132,831,484.75 billion naira revenue generated within the period under review was a shortfall from the 2023 revenue target of 1,304,548,912.93 billion Naira given to the Command.

He said despite the border closure, "This figure represents about 87.8 per cent of the revenue target issued. It however indicates an improvement in revenue by N299,110,632.35 from N832,946,852.40 revenue generated in the preceding year 2022."

According to Comptroller Umar, the Command ensured compliance with the border closure directive by strictly adhering and enforcing the principles guiding the border closure. He explained that, the Customs Command in Katsina State, "during the period under review, intercepted 369 contrabands, including used vehicles, tyres, second-hand clothing, vegetable oil, and foreign parboiled rice, among others, with Duty Paid Value (DPV) of N553,339,240.00 in its ongoing anti-smuggling operations."

He reiterated that, the Command under his watch has made significant progress in fostering synergy with other security agencies in the state for intelligence gathering and improved operations within and outside the border corridors.

Comptroller Mohammed Umar noted that, the command has a cordial working relationship with the Katsina State Government, traditional institutions, religious leaders, border communities, and other stakeholders in the trade supply chain and would continue to facilitate trade without compromising economic and national security.

"We could not have achieved this feat without the support of the Comptroller General of Customs Bashir Adeniyi MFR, his Management Team, Officers and Men of the Command, and other Units of the Service," he emphasized.

He disclosed the Thirty (30) Officers decorated in the recently released promotion includes:- One (1) Comptroller of Customs, Three (3) Chief Superintendents of Customs,

Three (3) Superintendents of Customs, Nine (9) Deputy Superintendents of Customs, Ten (10) Assistant Superintendents of Customs I, and Four (4) Assistant Superintendents of Customs II. Comptroller Mohammed Umar charged the promoted Officers to rededicate themselves to work and deliver the Service's constitutional mandate of revenue generation, legitimate trade facilitation, and suppression of smuggling.

"You must ensure you behave as responsible officers wherever you find yourselves by giving your uniform the respect it deserves because so many wish to be where you are today", Comptroller Umar added.

## **Customs FOU Zone C Records Over N5bn DPV In 2023**

#### \*Comptroller Kolade decorates promoted officers

otal seizures worth N5.3 billion in Duty Paid Value (DPV) were recorded by the Nigeria Customs Service (NCS) Federal Operations Unit, Zone "C" Owerri in 2023 fiscal year, N e w N i g e r i a n Newspapers has learnt.

This happened just as 46 promoted officers in the Zone were decorated with their new ranks.

The Zone "C" Comptroller, Kayode Kolade, while decorating the promoted officers, on Wednesday, described the seizures as a result of hardwork, resilience, dedication to duty and commitment of his men and officers.

Some of the items seized, he said, were pangolin scales, foreign parboiled rice, cannabis sativa (also known as Indian hemp), fake pharmaceutical products, tramadol, used vehicles, used tyres, used clothing and explosive raw materials among others.

### **ACF Says Planned Relocation Of CBN Units, FAAN Hatrs To Lagos Plan To Underdevelop North**

renowned Northern group, Arewa Consultative Forum (ACF) has criticized the alleged relocation of key departments of the Central Bank of Nigeria (CBN) and the headquarters of Federal Airports Authority of Nigeria (FAAN) from Abuja to Lagos.

The group expressed displeasure in a statement signed by Prof. T. A. Muhammad-Baba, the National Publicity Secretary of

The statement reads, "The management of the Central Bank of Nigeria (CBN), recently announced plans to relocate some of its key departments from Abuja to Lagos, understandably sparking a wave of anxiety and outcry from many Nigerians, especially Northerners who, obviously would be most adversely affected by the spontaneous exercise.

"The CBN's decision is no means isolated or normal administrative action to fix some logistics problem. Rather, it fits into a disturbing pattern of antagonistic actions often taken by certain federal administrations against the interests of Northern and other parts of Nigeria. The CBN's announcements was followed by another from the Federal Ministry of Aviation's Federal Airports Authority of Nigeria (FAAN) plans to also relocate to Lagos, due to shortage of office space and claim of the volume of air traffic handled by Lagos. The proposed actions of the two agencies, i.e. CBN and FAAN are precipitous and mala fide. Still on the Ministry of Aviation, only 8 of 40 directors recently appointed are from the

"As if deliberately designed to be made public in drip-drip fashion, a leaked letter to the Minister of Aviation from a contractor, AVSATEL, became public, wherein the company sought permission to relocate the project for refurbishing Airport Recue and Fire Fighting Vehicles (ARFF) from Katsina to "the south" or Abuja, but sneakily mentioning Lagos, Ibadan or Enugu. AVSATEL sought to rationalise its suggestion on issues that should must have been in the scope of the works when the company bided for the job but which it clearly ignored then.

"It is easy to ignore such planned actions by the CBN and FAAN (and AVSATEL), but it is impossible to fail to see in them a clear pattern of thinly disguised marginalisation of the North. Nor is the grand strategy entirely new. President Obasanjo's first action in office in 1999, was to order the relocation of the Nigerian Ports Authority (NPA) and the Nigerian Institute of International Affairs (NIIA), from Abuja, the federal capital, to Lagos. Today almost all agencies and institutions responsible for the marine economy and especially the sea ports, are concentrated at Lagos, which retains undisturbed monopoly over port operations and sea traffic in and out of Nigeria, even as Calabar, Uyo and Port Harcourt offer as much if not better facilities.

"When therefore the public condemns such obsession with relocation to Lagos, it is clearly reacting against a disturbing pattern of swindle perpetrated by some federal government officials against sections of the country. Northern Nigeria in particular has long lived under the shadow of these threats and has endured a series of calamities as a result. It was only the successful discovery and exploration of oil along the Kolmani River, in Gombe and Bauchi states, that discredited the propaganda that oil does not exist in the North. The vile propaganda was to discourage the investment of resources looking for oil up North. Sadly, such has also been the case with a number of other federal projects meant to be located anywhere in the North, such as dredging of rivers Niger and Benue (so that the North remains landlocked), Mambila Hydroelectric Dam (Kainji and Shiroro are dams too many to be up North!), grazing reserves for the development of the livestock sub-sector, to list but a few. For decades, certain powerful interests within the Federal Government, who seem scared of the North, have refused to allow the projects to be undertaken.

"Given all of the above and more, the Arewa Consultative Forum (ACF) remains unconvinced that the government agencies trying to relocate to Lagos will be doing so on any noble grounds. ACF calls on the Federal Government of Nigeria, and the National Assembly, to call on those agencies to retrace their steps and apply other honest means of addressing the alleged over-crowding in offices. Against the situation in Lagos, there is plenty of land in the Federal Capital Territory for expansion of office and other infrastructural facilities and such factors should not be used to obfuscate sinister motives.

"Katsina remains the location of the ARFF, as in the original scope of works.

## NDLEA Intercepts Canada, South Africa Imported Illicit Drugs, Arms, Ammunition In Lagos

\*Suspect linked to imported container, nabbed \*Over 5m pills of Tramadol seized in Kano

agle- eye operatives of the National Drug Law Enforcement Agency (NDLEA), have intercepted large consignments of different illicit drugs in Lagos, New Nigerian Newspapers has learnt.

The substances identified as Cocaine and Colorado, a strong strain of cannabis, concealed in containerized household items and vehicles imported from Durban, South Africa and Canada at the Tincan Seaport in Lagos, were said to have been intercepted by operatives attached to special units of the agency.

This was contained in a statement by the Agency spokesman Femi Babafemi, made available yesterday.

According to him, following coordinated intelligence and months of tracking of the containers by three special units of NDLEA, the illicit drugs along with arms, ammunition and sundry military effects were seized during joint examination of the three containers by the agency's officers and their counterparts from Customs Service and other security agencies between Thursday 18th and Friday 19th January 2024.

Some of the agency's sniffer dogs were also deployed to help identify locations and bags used in concealing the illicit items.

Babafemi disclosed that some of the items recovered from the containers include: 1, 274 parcels of Cocaine and Colorado with a total weight of 884.09 kilogrammes; four pistols; 197 rounds of 9mm ammunition, 49 rounds of 7.62mm ammunition, 275 rounds of 5.56mm ammunition, 14 rounds of 9mm ammunition and sundry military personnel effects as well as some chemicals in kegs. With the exception of 32.5kg shipment of Colorado that came in used vehicles from Canada, the rest of the items were found in two of three containers that arrived the Tincan port from Durban, South Africa onboard a vessel marked MSC RESILIENT III and discharged on New Year eve,



31st December 2023.

A suspect linked to one of the containers, UACU 5348336, bearing the 32.5kg Colorado, 41year-old Akara Chibugo has already been tracked and arrested by NDLEA operatives. Two vigilant freight agents and a traveler escaped being roped into two drug trafficking operations by desperate traffickers at the Murtala Muhammed International Airport, MMIA Ikeja Lagos. The two agents were contacted to send a consignment of 1kg cannabis concealed in tins of Milo beverage to Turkey but chose to submit the shipment to NDLEA checks before processing the cargo. The psychoactive substance was later discovered to be hidden inside the shipment.

In the same vein, NDLEA operatives on Friday 19th January arrested one Okosun Paul Punitt, the consignee of a consignment of tramadol concealed in a bottle of dietary supplements, which a staff of Pathfinder International Ltd, Ajuzieogu Mac-Elvis Ugochukwu attempted sending through an intending passenger on Ibom Air to Accra, Ghana at the Lagos airport on Tuesday 16th January. A video of the faceoff between the passenger and Ajuzieogu later went viral after the vigilant passenger suspected the consignment contained illicit substances.

Both Ajuzieogu and the exhibit were later transferred to NDLEA on Thursday 18th January by the Federal Airports Authority of Nigeria, FAAN for investigation. Preliminary findings by NDLEA showed the parcel contained 50 pills of tramadol 225mg concealed in a bottle of dietary supplements.

A follow up operation by the agency led to the arrest of Okosun upon his return from Ghana on Friday. He has in his statement, confirmed ownership of the drug.

In Kano, no fewer than five million six hundred and fifty three thousand (5, 653,000) pills of tramadol 250mg and exol-5 were seized from three suspects. While Nura Abdullahi, 38, and Tahir Muhammad Mukhtar, 42, were arrested at Bacharawa area of Kano with 5, 404,000 pills of tramadol 250mg on Sunday 14th January, Yusuf Umar, 50, was nabbed at Gadar Tamburawa area of the state the previous day Saturday 13th January with 249,000 tablets of exol-5 by NDLEA operatives.

In Lagos, two suspects: Ali Abubakar and Murtala Sani were arrested at Ojodu Berger area on Tuesday 16th January with 110kg of cannabis sativa while 69kg of same substance was recovered from the hideout of a fleeing suspect in Akerele, Surulere same day. Not less than 2, 800 bottles of codeine-based cough syrup were recovered by NDLEA officers on Saturday 20th January during a raid operation at Aleyita FCT, Abuja. The suspected owner of the consignment, Jideofor Sochima is still at large.

While a total of 100,510 pills of opioids were seized from a suspect, Ike Emmanuel, 35, on Thursday 18th January at Dan-Anacha village, Taraba State, NDLEA operatives in Abia state arrested 60-year-old Joseph Isiguzoro, as well as Emmanuel Eugene and Malachi Ndu in parts of Abia state with 34,200 pills of opioids. Isiguzoro was equally found with monetary exhibit totalling Two Million Eight Hundred and Eighty Five Thousand and Forty Five Naira (N2,885,045) only.

The war Against Drug Abuse, WADA, advocacy campaign of the Agency continued in equal measure in schools, markets, worship places and others across the country in the past week. Some of them include: WADA sensitization lecture at Federal University of Technology, Ikot Abasi, Akwa Ibom; Federal Government College, Ijanikin, Lagos; Edusoko University, Bida, Niger state and WADA advocacy lecture at Community Secondary School, Bichi, Kano state, among others.

While commending the officers and men of Tincan, MMIA, Abia, Taraba, Lagos, Kano and FCT Commands as well as the special units of the Agency for the arrests and seizures of the past week, Chairman/Chief Executive Officer of NDLEA, Brig. Gen. Mohamed Buba Marwa (Retd) urged them and their compatriots across all formations of the Agency to remain focused and resolute in pursuit of the corporate goal of winning the war against substance abuse and illicit drug trafficking in Nigeria. He further charged them to maintain the flame of collaboration with other law enforcement agencies and stakeholders in their areas of

### **Supreme Court** Governorship **Judgements**

HE MUCH-awaited end to 2023 election court cases had finally ended for many states in the governorship election last Friday, January 12, 2024. It was a tortuous journey from Election Tribunal to Appeal Court up to the Supreme Court, taking almost a year from the day the governors had been sworn into office on May, 29, 2023.

Winners and losers alike have all suffered, and governance has been affected even though some of the governors tried to work as hard as possible; after all, just because your victory is challenged in court, you still have work to do. Though the opposition mocked some with bitter words calling them administrators, meaning they would soon be removed from office.

To save our democracy, the politicians themselves have a role to play to sustain it, not just by words, which are in many cases empty, but in action too. They have to abide by the rules and when they are defeated in election which they know to be so; they should accept it and prepare for the next election.

However, the attention of the judgment was drawn to the Court of Appeal when the Supreme Court justices used strong words in reversing their earlier judgements, making people to be vindicated by being skeptical of some judgements delivered by the Court of

This is more so where there were earlier judgments by the Supreme Court such as in pre-election matters and even in its own court, yet they went ahead and ruled on it, giving contrary judgement.

In any event, there should be reforms in our electoral laws and matters that were ruled by the Supreme Court should not be ruled again by the lower courts. Those that go against that should be dealt with. We cannot have officers of the law; especially those that sit in judgement, disobey the law as well either because of inducement or whatever.

To save our democracy, the politicians themselves have a role to play to sustain it, not just by words, which are in many cases empty, but in action too. They have to abide by the rules and when they are

defeated in election which they know to be so; they should accept it and prepare for the next election.

They should not go to court to challenge the party membership of an opposition candidate or that he did not obey a High Court order, and on these bases, the court should remove him as governor and declare him winner.

The irony is that they are not disputing that the governor won the election, but they want to pick holes by looking through some sections of the electoral act to take what is not theirs. That is a stolen mandate as far as I am concern.

Though, it is apparent that violence usually happens when the peoples' mandate is taken from the owner and given to another person, the problem is that this culture of impunity involves even those that fought for democracy in Nigeria, but the democracy they practice now leaves much to be desired.

Yet, if it were given to them on these bases, the Muslim ones would quote some verses from the Holy Qur'an or translate it and say, "it is God that gives power to whom He wishes..." But in their heart, they know they have stolen the power and can't deceive people except the gullible. Besides, as Muslims know, God works with what is in the heart, not a show of piety, sympathy and so on.

That is why some people in power with stolen mandates are afraid to go around freely among the people they claimed have loved and voted for them.

So, they should stop wasting time and resources, causing tension and fear of what would happen after court judgements.

Though, it is apparent that violence usually happens when the peoples' mandate is taken from the owner and given to another person, the problem is that this culture of impunity involves even those that fought for democracy in Nigeria, but the democracy they practice now leaves much to be desired.

In this regard, politicians should not truncate the democracy they are so proud of by manipulations and other underhand tactics. And the courts should not be used and allowed to support them.

### Illegal Mining: Kogi Govt Bans Issuance Of Consent Letters To Miners

ack of commitment by illegal miners resulting in incessant crisis, Kogi State Governor, Alhaji Yahaya Bello, has prohibited all traditional rulers in the state from issuing consent letters to miners without approval by the government even as existing consent letters will be reviewed.

The prohibition became necessary as the Federal Government's order revoking some fraudulent miners' licences and those described as " portfolio investors", as such Kogi State has no option than to key into the Federal Government policies and pronouncement to sanitise the sector.

The prohibition order in Lokoja during the stakeholders sensitization and meeting with traditional rulers on issues of mining consent letters and community development agreements over the weekend.

While appreciating the traditional rulers' cooperation and understanding throughout his tenure, Governor Bello charged them to be in complete control over their domains, stressing that they must know all the residents including visitors to their land.

The governor said there are several activities including illegal mining of gold, coal, lithium which if properly channeled through due process would boost state government financially.

He said due to illegal mining, after the exploitation, the became desolate and haven for criminals, where some unwholesome activities are being carried out to the detriment of the society.

According to him, criminals hide under the guise of miners, ending up training and initiating young persons into several criminal activities.

"Land is one of the greatest factors of production ,therefore, safeguarding it is necessary. If caution is thrown to the winds, you' will become an alien in your land. Some communities are already completely displaced ", the Governor warned.

Bello lamented that despite the gains from the crude exploitation of the land, the so called 'investors' were not

contributing to the development of the communities in all aspects of developments.

While he urged the Royal Fathers to have comprehensive list of activities taking place in their lands and waterways, they should also collaborate with relevant government officials in the discharge of any land related activities.

He equally urged the incoming government to sign a new law that will be stringent including tax on miners, before exploiting any mineral from Kogi.

Earlier in his address. Kogi state Commissioner for Solid Minerals and Natural Resources, Engineer Abubakar Bashir Gegu, said the Royal Fathers hold the key to the success or failure of the economy and security administration of the state. Engnr Gegu reminded the Monarchs of their closeness to the grassroots which has enabled them to interact closely with the people, as such they remain the frontline stakeholders in the management of the economic build up, security, peaceful and mutual coexistence in the society and every

community.

He also re echoed the Governor's directive that Traditional Rulers are banned from issuance of consent letters to mining investors without clearance from the Ministry of Solid Minerals and Natural Resources.

The Commissioner said the decision will address the effect of environmental degradation associated with mining activities coupled with security checks, and Community Development Agreement CDA.

The law stipulates that before any company commences mining, it has to submit statutory environmental documents on Environmental Impact Assessment, Environmental processing, Rehabilitation programme, Community Development Agreement. In his goodwill, Chief Solomon Owoniyi, Obaro of Kabba, said the partnership with the Monarchs is timely as there are illegal miners all over the places, and they have been causing a lot of security challenges.

## The North Under Siege: A Rehash

s reporters and analysts, we must inform, based on trends, and where possible, raise the alarm, hoping that those in authority will heed. In 2018, six years ago, that was what I did. And so, this is just a rehash of my article "Insecurity, the North under siege" written on this page on 24 December 2018.

Perhaps those concerned did not read it or they were unmindful because they were safe or just that they did not care. Well, now Abuja is a town gasping for breath from the stranglehold of criminals. Read on:

The Boko Haram insurgents, once touted as 'technically defeated' by no other than President Muhammadu Buhari, are now technically re-surging and giving a bloody nose to our soldiers, killing them and civilians in droves, sacking military bases and villages in the North East and packing away weapons and prisoners of war consisting of soldiers and civilians, especially women to assuage their lust.

The war against the Boko Haramites in the North East seems to be losing steam and one is concerned as to question why. Is it because of exhaustion, war weariness or lack of ideas on how to confront them? Is it the lack of morale among our fighting force? Or lack of weapons coupled with inadequate training? Or is it a bit of all this?

When looked at properly, the Boko Haramites do not have the formal military training our army has, even though some abducted soldiers may be teaching them some military tactics under duress — which may account for their confidence in confronting the Nigerian Army. Because when you look at the videos they release, you do not see them with weapons that are more sophisticated than those of our soldiers.

In the North West, armed bandits, perhaps Boko Haram with a different face, are threatening to take over Zamfara State. The state is almost under their control. They move freely, heavily armed, collect tax from villagers for protection, ransack communities at will, kill, maim and take as many as they can with them for ransom. The bandits can come to a marriage gathering and just demand for the bride and she would be handed over to them. They also abduct women and girls, converting them into sex slaves.

The North Central has become a traveller's nightmare from Rijau to Birnin Gwari and Gwanin Gora to Rijana through Kaduna and down to the suburbs of the Plateau. One travels at one's own risk as even four-star generals are being killed at will. Herdsmen kill every moving object and sack villages, burning everything down to ashes. Kidnappers are also having a field day. Are some of them, especially the herdsmen and kidnappers, another face of Boko Haram getting the much-needed cash.

Hardly can one confidently travel from

one town or village to the next once it is 7 pm. Travelling by road even in broad daylight is embarked upon with trepidation. Journeying by plane is no longer for luxury as for safety.

Our security apparatus possibly needs a total overhaul and assistance from elsewhere. There has to be a synergy between the different actors, modern policing methods and the revival of community policing.

On November 1, 2021, writing under the title, "Of Wachakal Airport, Wastage and the Bandits in Government," I said: "Now one can see how both those who, through corruption, have brought insecurity upon us and the innocent, who find travelling between Abuja and Kaduna safer through the trains, are now jittery because the products of wastage have turned their evil towards the rails."

In October last year, they failed to stop a train after they laid explosives on its tracks. Witnesses say that time, the train hobbled on to its destination afterwards. But five months later, they hit the bull's eye. On the same route, on Monday, March 28, this year, they stopped one heading for Kaduna from Abuja by bombing its tracks and shooting sporadically into it, forcing it to come to a halt. They killed many passengers and abducted dozens. Less than a week earlier, they had stormed the Kaduna airport, killing an official on the runway. Monday's train attack was the second in six months last October.

Since its launch in 2016, the train has presented an alternative means of movement between Abuja, the nation's capital, and Kaduna as the "bandits" had taken over the roads along the route. It was not surprising to see military and police rednecks, top government officials and political holders being driven to the railway stations in convoys of well-armed security men for the 200-kilometre journey by train or being picked up after arrival.

These bandits-cum-Boko Haram number in the tens of thousands but go around in dozens, sometimes more. Unchallenged, they invade towns and villages mostly on motorcycles – and sometimes on horses, and always well-armed.

Just last week, contributing to a debate on establishing a national task force to combat insecurity, the deputy speaker of the House of Representatives, Idris Wase,

cried out over how kidnappers and bandits have taken over his constituency, Wase Federal Constituency of Plateau State.

"Virtually every day in my constituency, I have one kidnap report or the other — every day," he lamented.

We have always seized the opportunity to point out that apart from other parts of the country, "Abuja, the nation's capital, is itself not exempt. Bandits operating in Niger State to the West, Kogi to the South, Kaduna to the North and Nasarawa to the East have sandwiched Abuja and there is a need for a clinical onslaught against them. The Fulani settlements in these areas have to be forensically combed. Quite a few of

the rugas around Kuje, Lugbe, and close to the Nnamdi Azikiwe International Airport are alleged to be used by bandits to store weapons."

Within the town itself, you move at your own risk because hoodlums have taken over major spots. Robbery attacks are recurring decimals in dark places, especially on bridges, wooded spots and pedestrian crossings.

The ever-busy Apo-Maitama expressway and pedestrian bridges and roundabouts at Area One and Wuse Market area to Zone 7 down to Berger and up to the Abuja-Kubwa-Kaduna expressway are some of the major areas frequented by criminal elements, and from City Gate to Gwagwalada is one dangerous habitat of these criminal elements.

However, while the criminals keep upgrading in silence, our security agencies believe in public shows. You see their heads gathering the press and boasting of "formulating" new tactics and acquiring "devastating" weapons to "deal" with criminals and the next day, the criminals continue their business as if to prove they own the narrative.

## **Bodija Explosions:** Security Agencies Still Investigating Incident - Gov Makinde

### \*Says 90% victims discharged from hospitals

yo State Governor, Engr Seyi Makinde yesterday, said security agencies are still investigating the last week Tuesday night explosions at Bodija area of Ibadan.

The governor who made this known in an update on the incident declared that an update on the investigation will be publicised.

Governor Makinde stressed that his "administration remains committed to supporting all victims of this unfortunate incident and ensuring that everyone responsible is brought to book."

He maintained that as at present,

90 per cent of victims of the explosions at Dejo Oyelese area have been discharged from various hospitals and that the death toll so far still stood at five.

" Security agencies are still investigating the incident and an update on their investigation will be publicised", he said.

Gov Makinde added, "Yesterday, the medical team at the Emergency Operations Centre in company of the Honourable Commissioner for Health, visited two of the hospitals where victims from the incident were taken and over 90 per cent of the victims have been discharged".

"The death toll from the incident

currently stands at five persons. The clinical psychologist has commenced counselling for victims of the incident at the Emergency Operations Centre in Ibadan."

Governor Makinde commended the security agencies in Oyo State for maintaining law and order in around Bodija as well as residents who have been complying with directives from these officers.

He stressed further that a clinical psychologist has begun counselling for victims of the incident at the Emergency Operations Centre at the Oyo State Housing Corporation, Bodija, Ibadan and that search

and rescue operations have ended at the Dejo Oyelese Close site of the explosion and that recovery efforts have begun.

Appreciating the Nigerian Society of Engineers, who have begun carrying out structural integrity tests on about 230 properties around the site of the blast, he expressed gratitude Gov Babajide Sanwo-Olu, for releasing the Lagos State Emergency Management Agency (LASEMA) to support Oyo State.

"The operations at Ground Zero have moved from search and rescue to recovery. In his remark at the meeting, Dalori thanked the group for the honour done to him by the new chairmen and councillors.

He charged them to be more dedicated to the interest and needs of the people.

He said" Any politician that want to sustain his or herself in power must take the welfare of the common man as a priority. We often forgets that power belongs to Allah, if we serve the people with utmost dedication, Allah will not forsake us. So when we serve the interest of the people, we are serving Allah. I want to plead with you all to continue to reflect on the teaching of Allah, that we must endeavour to help the poor and the needy.
