

`So, when these revealed faith and other religions are united, it means the whole of Nigeria is united," he explained.



#### AIG Dismisses 2 Officers Over Armed Robbery, Other Misconducts

wo police officers attached to the Zone 2 Police Command headquarters, Onikan Lagos, have been dismissed following their alleged involvement in armed robbery, official corruption and for performing illegal duty.

The Assistant Inspector General of Police in charge of Zone 2 Command comprising Lagos and Ogun States AIG Ari Muhammed Ali, Phd ordered the dismissal of the erring officers identified as AP. No. 279495 Inspector Sunday Adetoye and AP. No. 223521 Inspector Ogunleye Stephen having been found guilty of the offences.

The Zonal Police Public Relations Officer, Zone 2 Command headquarters, SP I'mma Tunni Ayuba made the disclosure in a statement yesterday.

According to the release, the dismissed officers, facing trial for a similar offence, had on November 23, 2023, at about 20.00pm went in the company of three others; two members of Vigilante Group, one Semiu Afisu'M', one Abidoye Femi 'M', and one Charles John 'M' (the driver), to the residence of one Taiwo Monsuru, 'M', and one Akintola Sunday, 'M', at Obada-Oko in Ogun State; armed with 2 SMG rifles and live ammunition, conducted a search without a warrant where they made away with 5 iPhones, 1 Samsung smartphone, 1 Tecno smartphone, and 2 laptop computers.

"Police officers attached to Ifo Division mounted a roadblock after other residents of the apartment informed them of the incident with the description of the vehicle, which led to the apprehension of the occupants of the vehicle without ASP Ajayi Victor 'm' who led the illegal operation and is currently at large.

" The AIG has directed that the dismissed officers be charged to court alongside the civilians involved, while he urges all officers and men of the force to remain professional in the discharge of their duties in accordance with the law, as anyone found wanting will be accountable for his/her action or inaction.



#### Governor Inuwa Visits Tinubu, Seeks More Collaboration

Thursday, met with
President Bola Ahmed
Tinubu at the Presidential
Villa in Abuja.

The governor used the visit to intimate the Nigerian leader on the developments in his state as well as the Northern region.

He also brought the President up to speed with the achievements recorded by the state under his leadership as governor, as suring that his government is ready to put more words into action in order to bring about faster development.

The governor, while interacting with State House Correspondents soon after he met behind closed doors with the President, emphasized the need for more collaboration between the federal and State governments towards bettering the lot of citizens, saying doing so will help a great deal in achieving development in all sectors.

He said: "There were several engagements between us towards the end of 2023 particularly pertaining healthcare and enabling business environment reforms and many more. Without the economy picking and doing well, we will continuously be where we are or even worst of.

"Collaboration of the states and the federal government; in fact including the local governments is very key and fundamental for us because if there is any disconnect, we may not deliver on what we have to do for the people."

Commenting on the importance of agriculture to human development and attaining food sufficiency, the Governor said there is need for farmers to embrace modern techniques in order to boost their production.

"The way it is now, people have to understand that we must modernise. There is need for machine tools, there is need for processing and luckily Gombe is among the States that have been approved to be part of the Special Agric Processing zones.

"We have set up an industrial park where we can process all the raw materials or the agricultural produce that we have in the State. I

think if all States will keyin and work in tandem and work with the federal government, we shall easily reach the desired destination for Nigeria," he added.

Governor Inuwa Yahaya also commented on security challenges troubling some parts of the country.

He however commended

President Bola Tinubu for sending Vice President Kashim Shettima to visit Kaduna and Plateau States, in order to get the details of what transpired at Tudun Biri, as well as Bokkos and Barkin Ladi Local Government Areas. "In my capacity as the Chainman of Northern Governors' Forum, I praise the steps taken by the President in order to get to the root of what happened in these two States and the pledge he made that the right action would be taken to prevent future occurrence of those incidents. Above all, I thank him for the support given to victims or survivors," the Governor stated.

Speaking specifically on the Plateau crisis, the Governor said there is need for a review of the immediate and remote causes in order to find a lasting solution.

"Despite the fact that this

matter has been there for long, it is time for stakeholders to have a round table and tell each other the truth and then take deliberate steps toward loving each other. Before now, the people were living in peace and going about their normal businesses.

"Some of the major issues that seem to allow the problem to persist include issues like farmer-herder clashes, the clamour for indigenes versus settlers. But the world over, if any society or country doesn't welcome visitors, such a nation will not progress. Afterall we here are one and the same family.

"Therefore, we are commiserating with those who lost their loved ones. There should be no reason why anyone should go and kill or take the life of a fellow human being since it is not a war situation. Reprisal attacks have not taken us anywhere so, what we need to concentrate on doing is to understand ourselves and know that we have leaders at all levels whom we can lodge our complaints to. We should imbibe the habit of loving one another and living in peace for the progress of all of us," the Gombe State Governor advised.

# Troops Neutralize 10 Bandits, Rescue 9 Victims In Katsina, Zamfara

he troops of the Joint Task Force North West Operation HADARIN DAJI (OPHD) said it has neutralized 10 terrorists, rescued nine kidnap victims and recovered arms and ammunition including operational motorcycle and communication gadgets in Katsina and Zamfara states during operation.

The troops said the feat was recorded in recent dry season clearance

operations commanded by the General Officer Commanding 8 Division Nigerian Army, Major General Godwin Mutkut. "Notably, on the 3rd January 2024, the combined troops of the OPHD conducted an offensive operation in identified Terrorist enclaves at Batsari and Safana LGAs of Katsina state, neutralizing 10 of the terrorists while others fled with gunshot wounds".

The troops also recovered 1 A K - 4 7 R i f l e,

ammunition, seven dane guns, three locally fabricated guns, and other dangerous weapons as well as communication gadgets, mobile phones and military uniforms while four motorcycles recovered and destroyed. Similarly, on the same day, troops of Operation HADARIN DAJI operating in Zamfara State, conducted a search and rescue operation at Dansadau and Dandalla villages in Maru LGA of Zamfara state. During the operation, nine kidnapped

victims were rescued which includes; five women and four babies. The victims were abandoned by the terrorists who fled after a gun duel with the resilient troops. The rescued victims were immediately reunited with their families at Magami.

The Commander Joint Task Force North West Operation HADARIN DAJI, Major General Godwin Mutkut, commended the efforts of the troops and urged them to maintain the tempo.

### Nigerians, UK Returnees Decry Deplorable Access Roads At Lagos Airport Despite Revenue In Billions On Toll Gates

ome Nigerians alongside
UK Returnees have
decried precarious state
of access roads at the main gate
leading to the local wing of the
Muritala Muhammed
International Airport, Ikeja,
Lagos State despite huge
revenue accruing daily via toll
gates at the airport.

Chief Bolaji Agoro, an oil and gas industry stakeholder told some journalists on Wednesday at the airport, that huge revenue which to him should be between five and seven billions monthly ought to be enough to maintain the roads therein.

He stressed that there was no basis for the deplorable condition of the road to the local wing of the Muritala Muhammed International Airport, Ikeja, Lagos.

"I lodged at a hotel close to one they called Legend hotel. I was there yesterday (Tuesday) and today, Wednesday in readiness for my trip out of Lagos State and observed influx of vehicles in hundreds hourly", he said.

Chief Agoro added, "This shows that we can count thousands of vehicles entering and moving out of this airport after paying certain fees in accordance with the type of vehicles that come in. "A car with four tyres is charged N500; those vehicles with six tyres are paying N1,000 while trucks/trailers are charged N2,000 as toll fees and a number of these vehicles especially the commercial ones can enter several times and are expected to pay at every entry of the four toll gate points".

A returnee, Mr. Clement Fidelis, who sat very close to the first speaker at a lounge in the airport on his part said "despite huge revenues, road to Legend Hotel is deplorable while access roads to Sahara Petroleum tank amongst others have gone so bad with crates everywhere!.

Mr Fidelis stressed, unlike what you see at Gatwick Airport in London, a number of Nigerians entering this Airport are paying cash with no receipt on many occasions fueling speculation that there is big time corruption going on around here.

"The deplorable state of infrastructure, including access roads around the Murtala Muhammed International Airport (MMIA), Ikeja, Lagos is worrisome notwithstanding millions of naira earned daily as revenue from Access Toll Gates/Car Parks," Fidelis added.

Another UK-bound passenger, Chukwu Arinse asked when corruption would become a thing of the past at every sector of Nigerian nation, wondering if the authorities are not aware of the allegations of corruption at the nation's airports.

A trader who simply identified herself as Blessing said President Bola Tinubu and the Aviation Minister, Festus Keyamo need to do a lot to stem the alleged mind boggling corruption going on daily through leakages here.

"Why can't the FAAN utilize the revenue being collected from the toll gates and other facilities, including car parks, to fix roads around the airport?

"Your guess is as good as mine. The Federal Government needs to institute a probe panel like it did at the CBN recently to ensure that FAAN and Concessionaire account for the huge revenue it makes from automated/cash points at access toll plazas, car parks and other commercial activity points around the Murtala Muhammed Airport (MMA), Lagos, as the state of infrastructure; roads and other facilities within the airport – has reached intolerable levels," Blessing added.

Comrade Adeolu Olubisi in his comment called on the CBN to produce automated chips which people can be using to access and pay tolls at the airport, saying "this debit card can be inserted in the 'touch and open machines'. This would reduce if not totally eradicate the fraud of receiving cash from users of the airport.

Olubisi argued that, "if the allegation that between 400,000 to 500,000 vehicles patronize the Airport daily is anything to go by, then Federal Government is losing revenues in billions monthly and annually. The Minister, Mr Festus Keyamo has started very well, let him also beam his searchlight on toll gates and overhaul the entire place for sanity to prevail and revenue to go through the right channels.

A stakeholder in the Aviation sector, Prof Ben Adamu said since roads are not maintained at every location of the airport, the need to call on the authorities to re-introduce strict automated machines with security features to help prevent noticeable leakages at the airport has therefore becomes inevitable.

Adamu recalled a publication by The Nation Newspaper which dwelled and exposed the rot in the airport but which nothing has been done to atleast stem the ugly malfeasance at the airport.

He recalled part of the report, "... because the toll plaza is not fully automated, accounting for the accruals and how they are utilised will be an uphill task", adding, "decrepit state of the road linking the local wing to the international terminal around the Nigerian Airspace Management Agency (NAMA), Centex, the Nigerian Civil Aviation Authority (NCAA) Headquarters Annex toward the private hangars, why is it that FAAN has failed to fix the roads that are unbefitting of our country's gateway."

An insider at the airport who didn't volunteer his name alleged that not less than about 500,000 vehicles ply the route daily with a projected review to be hovering around N250million daily and estimated monthly revenue of about N7.5billion.

His position could not be immediately verified as efforts to get the FAAN officials to comment on the allegations bordering on sleeve around the airport rages, as at the time of filing this report on Wednesday evening.

According to him, the onslaught by operatives of the unit during the period under review yielded the total of seventy-one (71) seizures of 12 different items intercepted at various locations in the zone, which are of grave implications to the health and safety of Nigerians.

"I must also say that the extent of seizures we were able to make during the period is a fulfillment of our pledge that the Unit will ensure full compliance with the FGN directives on closure of all land borders with Niger Republic.

"Remarkably among these 71 seized items was the arrest made on the 15th December, 2023 at about 1400hrs, the operatives of the unit arrested a container truck based on credible intelligence along the Lokoja-

Abuja expressway suspected to be conveying prohibited items. After a 100% physical examination, thirty-seven bales and four (4) rolls of Nigeria Police Camouflage Uniforms alongside other different items were discovered in the truck. Four (4) suspects were arrested in connection with the seizure.

"Considering the nature of the items and its possibility of being utilized for nefarious activities by unscrupulous elements, the seized police camouflage uniforms, the 4 suspects together with the means of conveyance were all handed over to the State Director, Department of State Security (DSS) Kaduna State Command on Wednesday 27 December 2023 for further investigation and possible

prosecution in the spirit of inter-agency collaboration and having obtained necessary approval from the Comptroller-General of Customs," he said.

Speaking further, he said, "It is also pertinent to let you know that the seizures were made in different parts of the Zone with the Duty Paid Value of Four hundred and Six Million, Nine Hundred and Twenty-Four Thousand, Ninety-One Naira, Thirty-Four Kobo (\$406,924,091.34) only.

"The breakdown showed that, due to the positive use of credible intelligence by the FOU, Zone B operatives, Eight (8) used vehicles as well as Two (2) Means of Conveyance were impounded during the period.

"Also as a result of the constant patrol of our operatives, the Unit was able to seize 195 bags of foreign parboiled rice (50kg each), which would have made their ways into the markets, and consumed by the people, despite the hazards, some of such imported grains posed to health," he added.

The Comptroller said that the vigilance of the operatives of the unit during the period, likewise led to the interception and seizure of 877 jerry-cans (25 litres each) of Petroleum Motor Spirit (PMS).

"However, in line with the extant laws and guidelines as directed by the Customs Headquarters, the PMS that were seized have been auctioned and the proceeds remitted to the coffers of the Federal

Government," he informed.

He said that other seizures made during the period include; 240 bales of Foreign Second Hand Clothing, 10 Jerry-cans of Foreign Refined Vegetable Oil (25 litres each), 415 Cartons of Foreign Spaghetti, Macaroni and Couscous, 349 Cartons of Foreign New Shoes (Unisex), 500mg of 3,400 Sachets of Foreign Amoxicillin and 35 Cartons of Foreign Flame Lighters.

"Beyond this, suffice to say that despite the value of the 17 seizures made within the period, as stated above, we are proud to say that the Unit has seized hard drugs and other assorted goods at various intervals in the Year 2023 worth about Four Billion Naira (N4 billion) in Duty Paid Value(DPV) from 1st January to 31st December, 2023. This represents 100% increase in seizures made above total DPV

of #2,345,155,577.38 that was seized in the year 2022. It is also an indication that the operatives of the Unit have up-the-ante in the fight against smuggling in the Zone. "It is instructive to note that the recognition of the renewed effort of the operatives of the Unit led to the Customs Headquarters, giving the Unit a Letter of Commendation earlier in 2023. This development, I must say has contributed to the boosting of the morale of the Officers and Men of the Unit," he said.

The Comptroller therefore, on behalf of all the Officers and Men of the Unit; reiterate his commitment at enforcing the Federal Government Fiscal policies in accordance with Standard Operating Procedure (SOP) as our operatives are battle-ready to carry out our mandate effectively.

Speaking further, he described the media

as key partners in fight against smuggling. "The importance of media in the fight against smuggling cannot be overemphasized because it is a veritable tool for information dissemination and shaping public opinion. I urge you to continue to amplify our efforts for the general public to understand the ills and menace of smuggling to our dear Nation.

"Gentlemen of the press, you can observe a change in the pattern of today's briefing in terms of items to be displayed; most of the seized items were deposited at the various Customs formation across the Zone as enshrined in the Standard Operating Procedures (SOPs) of securing seized items. It is also served as one of the counter measures of securing seizures in case of attacks by smugglers as they (smugglers) are now engaging bandits to attack our operatives while conveying seizures to a long distance.

"I want to use this opportunity, to commend the Comptroller General of Customs, Bashir Adewale Adeniyi, MFR and his management team for their usual support to the Unit as well as appreciate our sister agencies, namely the Nigeria Police, DSS, Military, NDLEA, NAFDAC among others for their collaborations.

"I am also expressing appreciation on behalf of the Unit to the Media, for its support and objectivity in disseminating our efforts in the fight against smuggling, as I urge all well-meaning Nigerians to continue to provide relevant information to the Unit, that would aid in combating smuggling for the benefit of the Nigerian economy," he said.

### **Environmental Activist Writes 7 points** Agenda To Oborevwori

renowned Delta State human rights and development Ladvocate, Comrade Sheriff Mulade, yesterday, said that, "A lot happened in 2023, a year that witnessed vigorous political campaigns and general elections; the birth of new governments at the federal and state levels; withdrawal of petrol subsidy leading to hyper inflation because of hike in transport fares, amongst others."

Comrade Mulade, who is also the National Coordinator of the Center for Peace and Environmental Justice (CEPEJ), also said that, "sadly, the recent and unfortunate massacre of hundreds of innocent Nigerians in parts of the country by terrorists, which further exacerbated the Nation's security challenges.

"Those who made it to the new year have cause to celebrate as life is for the living." According to him, "it is not yet Uhuru, as the economy is yet to recover from the subsidy shocks that have caused severe hardships for many families, worsening the prevailing rate of unemployment in the country, and forcing Nigerians to flee overseas, in addition to the abysmally poor performance of the Naira at the foreign exchange market.

"Oborovweri has been working assiduously to unite Deltans, as well as ushering in a new phase of development to Delta State."

He presented the following 7-point agenda to the governor, which include, "Governor Sheriff Oborevwori should run an all-inclusive government, carrying all Deltans along, irrespective of political, religious or ethnic affiliations, as Delta State is for us all. To further unite the State, all hands must be on deck, while equal opportunities should be given to all Deltans to contribute their quota towards moving the State forward and be wary of political sycophancy.

"The Delta State 2024 Budget should provide for the neglected riverine areas of the State, particularly the Ijaw and Itsekiri areas, where about 80% of the State's resources to fund the 2024 budget will come from. This is due to the fact that for decades now, the people of the coastal areas of Delta State have been grossly neglected in terms of tangible infrastructural projects that are economically viable for sustainable development of the riverine areas.

"If these neglected areas were not adequately captured in the already passed 2024 Budget, a supplementary budget that will accommodate and give sense of belonging to the riverine areas is recommended.

"Delta State must be on the map of progressive States. when she collected the bag of beans, he gave her N1,000 and collected the beans on the spot and then she bursted into tears, asking him if that is what he will do to her.


Upon understanding what

NIDCOM raised the alarm in a statement by its Director of Media, Public Relations and Protocols Unit, Abdur-Rahman Balogun made available to journalists.

In the statement, NIDCOM warned all government Ministries, Agencies, Embassies and High Commissions as well as Diaspora groups to beware of the phoney diaspora groups.

The Commission specifically mentioned a group, Nigeria Diaspora Forum, (NDF) who claimed it has established an office in Abuja for the welfare of Nigerians in the Diaspora.

According to NIDCOM, "the so-called Forum, an arm of Labour Party, masquerading as a diaspora group, is not even registered with the Corporate Affairs Commission.

" We are aware that all registered Political parties including the ruling party, APC, PDP, SDP, NNPP and even LP, etc have diaspora chapters and support groups outside the country and do work to promote and champion

their party ideals", it said.

NIDCOM added, " It is equally sinister that an unregistered body with the Corporate Affairs Commission will fraudulently and boldly announce the setting up of an office to oversee the welfare of Nigerians in Diaspora in Abuja".

" This is no doubt an attempt to fraudulently hoodwink unsuspecting members of the public, ministries, departments and agencies, embassies, high commissions as well as state and local governments".

NIDCOM stressed, "We hereby advise all government agencies at both the federal and state levels as well as the diplomatic community to always double check with NIDCOM the status of such groups as NIDCOM has a data base of all registered diaspora groups".

" NIDCOM is using this opportunity to also remind all that States have diaspora focal persons who are readily available to handle issues relating to their diaspora. NIDCOM is the only Commission mandated by an act of the Parliament to oversee the welfare of Nigerians in the diaspora, in the last four years.

" It has been, and will continue to fulfill its mandate, while also working with genuine Nigerian diaspora groups, associations and individuals".

he National Association of Nigerian Students (NANS), has noted that as the Federal Ministry of Education on Tuesday, announced the suspension of evaluation and accreditation of degree certificates from the Republic of Benin and Togo, it requested that similar measures be taken against home-based institutions running unaccredited courses.

The association enjoined the Federal Government to commence investigation into the activities of the Federal Ministry of Education, National Universities Commission (NUC), National Youth Service Corps (NYSC) and other agencies fingered in the fraudulent activities of obtaining degree certificates from foreign universities.

NANS said that since commended the Federal Government for its quick decision to suspend the accreditation of degree certificates obtained from institutions in Benin Republic and Togo, it is, important for the government to take further steps into investigating the activities of relevant agencies fingered in the fraudulent activities, saying that it is the only way the Federal government can save its face and restore the battered image of the country.

NANS called on the government to beam its searchlight into the activities of tertiary institutions, especially privately owned ones, that are running unaccredited courses.

The statement noted that the institutions, in their fraudulent act, are destroying the education sector and swindling innocent young Nigerians of their money by offering them unaccredited courses, describing the universities and polytechnics offering unaccredited courses as illegal institutions as they want the government to deal with them appropriately.

The statement called on the Federal Government to collaborate with NANS and other student bodies to rid the country of illegal tertiary learning institutions towards repositioning the nation's education sector for better.

### NDLEA Seizes Over 95 Tonnes Of Illicit Drugs, Convicts 237 Offenders In Lagos

To fewer than 95,083.114 kilogrammes, comprising of over 95 tonnes of different types of illicit drugs were seized by the Lagos Command of the National Drug Law Enforcement Agency (NDLEA) in year 2023, New Nigerian Newspapers has learnt. The command also successfully prosecuted and convicted two hundred and thirty-seven (237) defendants with various jail

During the year under review, the Command arrested Nine hundred and nineteen (919) suspects comprising of Seven hundred and ninty-three (793) male and one hundred and twenty-six (126) female that are involved in the illegal drug trade. The Asst. State Commander, Media & Advocacy, ACN Mallum Musa made the disclosure in a statement made available to journalists in Lagos on Wednesday.

According to the statement, the successes recorded during the year 2023 did not end with arrests and seizures but also in prosecuting the offenders.

It hinted that the assets of the convicts were also forfeited to the Federal Government of Nigeria.

These include a property situated at Bode Hamid Olowo Street, Mende Marland Lagos, and14 vehicles that are used for the business of illicit drugs.

" Also, during the year 2023, the Command did not only concentrate on arrests, seizures, and prosecution, but it also embarked rigorously on sensitizations, awareness campaigns and seminars through the War Against Drug Abuse (WADA) initiative of the Hon. Chairman/Chief Executive Officer of the NDLEA, Brg. Gen. Mohamed Buba Marwa (rtd) OFR, CON.

In this aspect, communities, schools, religious bodies, civil societies and organisations were targeted to sensitised them of the danger and consequences of illicit drug trafficking and abuse with the intent of educating them to detect and expose those involved in the trade and also to desist and look for remedy for those who found themselves in the abuse of drugs.

" The successes that were

recorded in 2023 do not just occur on a silver platter. Rather, it was achieved through the cooperations of well-meaning Lagosians, Sister Security Agencies and Corporate bodies that are passionate about the War Against Drug Abuse and care for developmental strides of the State in particular and Nigeria in general. The NDLEA appreciates them as well as the state government for all their support in the achievements.

"'The NDLEA, under the leadership of Abubakar Liman Wali, a Commander of Narcotics (CN), promised to maintain the tempo of the successes gained and will even surpass it in the current year, 2024.

" He is equally soliciting for more support, collaboration, synergy, and understanding so that we all together can tame the tide of this monster called illicit drug peddling and abuse that is ravaging our societies.



In the situation he found himself, the first critical step that needed to be taken was to halt the bleeding. Avenues where the company was suffering serious financial haemorrhage had to be stopped.

People & Organization

The Chief Executive saw the urgent need to also restructure operations to give a new direction of travel. The organisational restructuring helped to refocus the company into a commercially driven business with regional leadership and area office teams given more autonomy to drive the business. Tied to this is the reorientation of staff to understand the critical role they play in the grand scheme of things. It goes without saying that without a dedicated and committed work force all attempts at transformation would not yield the desired

He has ensured that staff entitlements such as salaries, pension remittances and other allowances are paid in due time, a situation which has earned him accolades from the two in-house labour unions. The staff performance appraisal system has been digitized and remodeled to give staff the confidence that they are being properly appraised by there respective line managers. He has also spent time in building new operational processes and rejigging and streamlining existing ones to enhance efficiency in service delivery company wide. Additional operational vehicles and work tools such as computers, furniture, ladders, Personal Protective Equipment (PPEs) were purchased to support staff deliver on their tasks. Motorcycles have also been distributed especially to those staff in remote locations to help reach customers with ease. A plan has been rolled out to begin the phased rehabilitation of offices and provision of internet services to boost staff productivity. Engineering & Technical

The backbone of the success in improving power supply is without doubt, the effort that has gone into the rehabilitation of the large, expansive network. Having the longest spanning network in the country, the challenge of rehabilitation is enormous. However, with a strategic plan that targets substations feeding key customer groups and communities, the task is being successfully managed one injection and distribution substation at a time. Some of the completed projects within the past one year include: a complete replacement of

11KV seven board panels and control room rehabilitation at Dawaki Injection Substation. Replacement of two 33KV Outdoor breakers at Abakpa and Unguwan Boro Injection Substations. Fencing of four Distribution Substations to Kaduna Electric standard (Branded inclusive. habilitation of Kofar Doka Injection Substation and Replacement of 33KV/11KV panels at Zaria. Construction of three Commercial feeders to improve power supply to commercial and industrial customers in Doka, Gusau and Sokoto, Construction of a 33KV feeder dedicated to the Sultan of Sokoto palace at Marina in Sokoto. Installation of fourteen auto reclosers in Sokoto, Kebbi, Zamfara, and Kaduna. Construction of a 33KV feeder to Mothercat Injection Substation in Mando, Kaduna. Replacement of Burnt blue phase of the 2.5MVA 33/11KV power transformer in Gwandu, Kebbi state. Repairs and replacement of over thirty failed Distribution transformers within Kaduna Electric's franchise. Installation of over 10 33KV isolators for network flexibility.

With the dust that trailed the implementation of the National Mass Metering Programme (NMMP) and the Meter Asset Provider (MAP) scheme, it became apparent that urgent steps needed to be taken to sanitize the exercises and restore customer confidence. Under his leadership, NMMP Phase Zero was successfully concluded, and renewed commitment extracted from MAP vendors for a better managed scheme following robust engagements with them. Now, customers who have paid for MAP meters are assured of getting metered within the stipulated time frame. Other laudable initiative successfully championed by the Kaduna Electric helmsman include: Maximum Demand 132KV/33KV meter recertification exercise. 11KV feeder meter recertification exercise. Replacement of all interface meters with AMI compliant meters for easy reading and monitoring. Conversion of feeder meters - 132 KV, 33KV, 11KV - to reflect AMI and AMR possibilities.

from ring Current Transformers (CTs) operated meters to block Current Transformer (CTs) operated type for accurate energy accountability and minimizing losses. Changing non-MD meter type to Power Line Carrier (PLC) type for effective monitoring and accurate accountability and equitable distribution system. Changing of problematic customers with panel meters to outdoor VT/CT arrangement with effective earthing system. Rayhan Rice Mill in Kebbi was connected on to a 2.5MVA transformer to guarantee stable power supply for their operations. The Zamfara state Government House, Yariman Bakura hospital and Zamfara Textiles Limited for 24 hours supply after construction of a dedicated 11KV feeder to service their supply needs. A 2.5MVA transformer serving Baba Rice Limited has been connected to UNTL feeder to ensure supply stability and shore up revenue. Improvement in power supply also saw African Natural Resources and Mines Limited, a subsidiary of Abuja Steel Company agreeing to come on to Kaduna Electric's network where it has been enjoying steady power supply.

In response to customer complaints about sharp practices by some staff, the bold decision to stop sales representatives from directly handing cash was taken. The result has seen customers take ownership of their payments through the many online payment channels available. In addition to Buypower and Irecharge, more third-party vendors including Coral Pay, Ruaban POS, Pay4Power. All cash offices have also been provided card enabled POS devices to ease transactions for customers Customer Service

Realising the significant role of the customer in the value chain, Yusuf has led from the front in directly engaging with customers across the franchise, with appearances on radio programmes to boot. The aim has been to enlighten and educate customers on the need for prompt payments, supporting the fight against vandalism and energy theft and a better understanding of the power ecosystem in the country. While his peers choose to leave this critical function to subordinates, Yusuf has chosen to lead by example. The strategic engagements has also seen him interface with other key stakeholders such as state governments, religious and sociocultural groups, security agencies and youth

From the snapshot of initiatives highlighted, it is evident that in spite of the challenges of customer apathy to payments, pressure from the electricity market and poor revenue inflows, the Kaduna Electric's chief executive is succeeding in repositioning the company onto a sustainable growth trajectory. If the momentum is sustained, surely the company will be soon outpace its peers.

## Ministry Of Humanitarian Affairs and Poverty **Alleviation: One Crisis Too Many**

igerians are hungry for results, the poverty level is rapidly increasing - the inflation rates based on fuel subsidy removal is one of the major drivers taking Nigerians into the poverty hole. The first step in taking Nigerians out of poverty is having strong leadership in the Ministry of Humanitarian Affairs and Poverty Alleviation.

But sadly, it seems there is a crisis in the Ministry. The persistent crisis within the Ministry of Humanitarian Affairs underscores the urgency for a critical review of its leadership. It prompts a crucial question: should the position of Minister be occupied by a core politician or a technocrat with a proven record of strong leadership and results delivery.

An Analysis.

1. Leadership Stability. The recurrent crises suggest a lack of stable leadership within the Ministry. A core politician may bring political acumen, but a technocrat could offer stability and focused expertise in navigating complex humanitarian challenges in Nigeria. We need some quick wins intervention immediately to calm Nigerians' 'poverty nerves' down.

2. Results Delivery. The essence of the ministry is effective results delivery in humanitarian endeavors. A technocrat, with a history of tangible results in similar roles, might bring a pragmatic and resultsoriented approach to address the pressing issues at hand. Especially as Nigerians are finding it difficult to adapt to the effect of the fuel subsidy removal.

3. Specialized Knowledge. Humanitarian affairs demand a nuanced understanding of complex issues. A technocrat with specialized knowledge in humanitarian efforts could



potentially bring a more administration, may bring a engagement, impact, and result tracking, and communicating results.

4. Public Perception. The public's perception of the ministry's effectiveness is crucial. A technocrat leading the ministry might enhance public trust through visible and impactful initiatives, demonstrating a commitment to addressing humanitarian needs.

5. Accountability and Transparency. A technocrat, with a background in governance and

targeted and informed greater emphasis on perspective to the table. accountability and Ranging from needs transparency in the assessment, stakeholder operations of the Ministry. This is crucial for effective resource utilization and public trust. Such as establishing a results delivery dashboard for Nigerians to see what is going on.

6. Adaptability to Changing Circumstances. Humanitarian challenges are dynamic, requiring adaptive responses. A technocrat might demonstrate agility in responding to evolving crises, utilizing data-driven approaches to inform decision-making. To ensure value for money the

ministry's data must speak.

7. Stakeholder Collaboration. Building effective partnerships with local and international stakeholders is paramount in humanitarian work. A leader with a technocratic background may excel in collaborations, leveraging expertise from diverse sources for comprehensive solutions. This will enhance the confidence and trust of both primary and secondary stakeholders - most importantly donor partners. Recommendations

1. Considering the recurring challenges, it is advisable to prioritize competence and experience over political

affiliations in appointing the Minister of Humanitarian Affairs.

2. Nigerians are hungry for results. I said it again! Therefore, this recommendation aims to align the leadership with the specialized nature of humanitarian affairs, ensuring that the focus remains on delivering impactful solutions to those in need, ultimately mitigating the ongoing crisis within the Ministry of Humanitarian Affairs.



#### Katsîna Police Arrests 1,627 Suspects In 2023

atsina State Commissioner of Police, Aliyu Abubakar Musa has said that of the nine hundred and thirty - eight (938) reported major crime cases to the command in the year 2023, a total of one thousand six hundred and twenty-seven (1,627) suspects were arrested out of which eight hundred and fiftyfive (855) cases have been charged to court and are being prosecuted in various competent Courts of Law throughout the

Briefing journalists on the accomplishments of the Command in the year 2023 in his Office at the Police headquarters in Katsina Metropolis, Abubakar Musa said throughout the course of the campaign over two

hundred and fifty-eight (258) suspected Armed Robbers, Sixty-four (64) suspected kidnappers and One hundred and seventy-six (176) murder suspects were arrested.

Also arrested were three hundred and sixty-nine (369) suspected rapists/sodomists while a total number of four hundred and ninety-five (495) suspects were arrested for various other offences.

The Katsina State Police Commissioner, hinted that, the command during the year 2023 succeeded in rescuing one hundred and seventy one (171) kidnapped victims, sixty-seven (67) human trafficking victims, neutralized seventeen (17) suspected kidnappers, and recovered the following exhibits, Twelve (12) AK 47 rifles, over one thousand five hundred

(1,500) live rounds of ammunition, over seven hundred (700+) suspected rustled animals, Twelve (12) suspected stolen motor vehicles and motorcycles, seventeen (17) suspected stolen phones,

Other exhibits recovered he said includes:- Five hundred and sixty-eight (568) sachet of D5 tablets, Twenty three (23) packets of Exzole tablets, four hundred and eleven (411) packets of Rebozel tablets, and five (5) packs of Diezole tablet Quantum of dried leaves suspected to be indian hemp.
