Bodija Explosions Death Toll Now 5 - Oyo Govt

s uneasy calm still reigns at the scene of the Tuesday night Bodija explosions, Oyo State Government yesterday, declared that the number of death in the explosions has risen to five.

This was made known in Ibadan by the Special Adviser to Gov Seyi Makinde on Security Matters, CP Fatai Owoseni (rtd) while speaking on He stressed that two more bodies have been recovered from the scene of the explosions by experts working on the site clearing the debris

"Rescue operation is still ongoing. As of yesterday, we had three casualties but this morning, just about 30 minutes ago, I got information from the security operatives supporting the medical team that two more dead bodies were recovered this

morning," he said.

CP Owoseni (rtd) emphasized that Oyo state government continues to monitor and respond to the situation as investigations into the cause of the explosion are underway and will leave no stone unturned at clearing the affected areas.

"A lot of conversations have been going on, a lot of interfacing with the people so that they will see transparency in what the

government is doing. The security agencies, especially the police, the DSS being supported by the Nigerian Army team EOD Unit as well are putting the bits and pieces of information together to ensure that discreet information is done towards prosecution to ensure that whoever, either directly, remotely connected with that incident are brought to justice."

Insecurity: Gov Dauda Bans Traditional Rulers From Issuing Mining Consent Letters In Zamfara

a m f a r a State Governor, Dauda Lawal, yesterday, signed an Executive Order prohibiting traditional rulers from issuing consent letters for mining across the state.

A statement issued by the governor's spokesperson, Sulaiman Bala Idris, disclosed that the executive order was signed at the Council Chambers, Government House, Gusau to stop one of the worst trends in the fight against banditry.

The statement explained that the order has banned all consent letters for mining, saying that it includes consent letters to individuals, companies, or organisations for mining activities.

Governor Lawal, while signing the order, reiterated that the decision was made due to the severe dangers posed by the rampant issuance of the consent letters

According to him, "Today, in my administration's

resolve to tackle insecurity, I signed an executive order prohibiting traditional rulers from issuing consent letters for mining across the 14 local government areas of Zamfara."

He added that as the Attorney General rightly stated, the mining activities in Zamfara have been identified as a significant factor contributing to the worsening security situation of the state, especially the menace of banditry.

As a responsible government, the statement added that it is crucial that the government takes decisive action to resolve the issue of illegal mining operations that have been contributing to the crisis, stressing that the signing of the executive order is an effort of taking all necessary steps to rectify the problems bedeviling the issuance of consent letters, which have been recklessly abused.

Implement New Minimum Wage Within First Quarter, SSANU Tasks FG

*Insists purchasing power at lowest ebb *Says economy not doing well

he Senior Staff Association of Nigerian Universities (SSANU) yesterday, tasked the Federal Government to honour commitment on implementation of the new minimum wage by the first quarter of the year.

National President of SSANU, Alhaji Mohammed Ibrahim made the call in Ilorin, while speaking with newsmen at the sidelines of the 72nd Zonal Executive Council (ZEC) Meeting held at the University of Ilorin.

Ibrahim while commending the Federal Government for the pronouncement, reminded the government that "the economy is not doing well".

He urged the administration of President Bola Tinubu to hit the ground running in ensuring that the country as a whole receives the needed attention in terms of security and economy.

"Beyond our members, every Nigerian today knows what he is going through, so our members are not coming from the moon, they are also Nigerians.

"The economy is not doing well. It is clear and glaring that the purchasing power is at its lowest ebb and the country is also becoming something else.

"However, we are optimistic that there is a new government and they have come with vigour and displayed that they have what it



takes to do this," he said.

Ibrahim observed that the ZEC meeting is to look at how members are faring in the university and those within the Western Zone of the country.

"We also look at whether or not the government is always looking ving up yo expectations. When we see gaps, we escalate this matter in the level of the zone and the national level and also try to relate with the government by easing friction.

"But where it becomes necessary to hit at the government, we don't mince our words, but we are very peaceful union," he said.

Speaking also, the Vice Chancellor of the University of

Ilorin, Prof Wahab Egbewole advised on responsive and responsible unionism.

He observed that though there can be disagreement among issues, there is need for effective dialogue to reach resolution in spite of differences.

Egbewole commended the university unions, adding that the mandate of any unionism is to focus on members welfare.

He therefore, enjoined SSANU to deliberate on salient issues that will bring about partnership and development of the university system.

"The leadership must be responsible staffers in thier various institutions. The way we work will determine who we are," he said.

The vice chancellor also admonished the union to strategically engage government, not confront them. In his address, the National Vice President (West) SSANU, Dr

President (West) SSANU, Dr Abdulsobbur Salaam, lamented that Nigeria is in a season of confusion, adding that so many things are not right for the nation. He pointed out that salaries of colleagues in Polytechnics and Colleges of Education are better and there is need to confront government on this issue.

Abdulsobbur also reminded that the government of the challenges posed as regard continuous payment through IPPIS.

Earlier in his welcome address, the Chairman of SSANU, University of Ilorin branch, Mr Naheem Falowo, emphasized the role of the union as playing a vital role in the administration, maintenance and development of institutions in Nigeria.

According to him, it is crucial that the University unions come together as a collective force to address the challenges working against members and work towards addressing the challenges, and develop strategies to address them.

High point of the programme was the commissioning of the Secretariat Complex in the university for the benefit of members.

he Edo State Governor, Mr. Godwin Obaseki, yesterday, played host to the Governors of the South-South States for the BRACED (Bayelsa, Rivers, Akwa Ibom, Cross River, Edo and Delta) Commission meeting.

The meeting held at the Edo State Government House, in Benin City, and had in attendance Governors Douye Diri of Bayelsa; Sim Fubara of Rivers; Umo Bassey Eno of Akwa Ibom, and Sheriff Oborevwori of Delta State, represented by his Deputy, Monday Onyeme.

The Commissioners of Budget and Planning from the six states were also in attendance.

The host, Governor Godwin Obaseki, was elected as chairman of the commission at the regional meeting which was held behind closed doors.

Addressing journalists after the meeting, Chairman of the Commission and Edo State Governor, said the meeting which was the first in the new dispensation, became necessary to address and proffer solutions to the critical challenges facing the region.

In a communiqué, Obaseki said the meeting was held at a critical time in the history of Nigeria as the country faces enormous challenges.

He said, "It's against this


background that the South-South region must redefine its place and roles in the economic development of Nigeria and for the benefit of our people.

"The Director General of the Commission made a presentation briefing the members of the work done by the Commission since it came into inception, briefing the Commission of work done in the areas of agriculture, power, education, environment and sports.

"The Council members spoke of the compelling need to collectively accelerate the development of the states and affirmed their support for the imperatives of the South-South economic cooperation and integration as a practical step towards the creation of a zone of economic development.

Arising from this, the council expressed determination and commitment to drive the process for cooperation and integration in the zone and pledged to address the challenges faced by the BRACED Commission.

The communiqué further reads, "Accordingly, the council resolved as follows: To foster regional economic cooperation and integration with a view to a chieving sustainable development through the development of a strong regional economy for the collective benefits of the people of the South-South and invigorate the

process of regional economic cooperation and integration.

"To establish and inaugurate the BRACED Business Council. This Council should endeavor to forge a closer partnership with the business council and utilize it to provide an improved business climate to attract businesses and investors into the region.

"To collectively engage the Federal Government on the development of key infrastructure in the region particularly roads, rail development and the decentralization and

rehabilitation of seaports in the region as well as management of security in the Country at large." He continued: "To engage the NDDC to ensure its activities benefit the BRACED States.

"To direct the Commissioners of Environment and Attorney-General of States to meet on climate issues affecting the States, particularly mangrove swamps.

"To forge a closer and cordial relationship with other regions for the creation of economic corridors that will be beneficial to the region.

"To pledge our commitment to work with the President of the Federal Government of Nigeria to improve the standard of living of the people of the South-South region. The Governors commit to work with and support each other for the purpose of improving the well-being and welfare of the people of the South-South."

Obaseki added, "Finally, we directed the DG to take steps to implement all the decisions that we took today and report back to the Council before our next meeting in March 2024 in Bayelsa State."

US Bureau For Humanitarian Assistance Team To Visit Benue State

Declare Prof Bello Of NNPP Winner Of Taraba Guber Election - Ambassador Ajadi

chieftain of the New Nigeria People's Party (NNPP), Ambassador Olufemi Ajadi Oguntoyinbo on Wednesday, urged the Supreme Court to declare Professor Yahaya Muhammed Bello of the New Nigeria People's Party (NNPP) as the winner of the last Governorship Election in Taraba State.

Ambassador Ajadi in an open letter of appeal to the Supreme Court said this became necessary in the spirit of decency, decorum, discipline and sanity demonstrated in the judgement of Supreme Court on Kano guber tussle. He stressed that the Police, military clash at the INEC office in Taraba state on 20th March, 2023 led to the delay in results' collation of the governorship election, adding that during the collation period, the NNPP sent a written complaint on Wukari Result claiming over voting and results in variance with the results in iRev and accredited voters on BVAS and called for

The NNPP Chieftain stated that during the collation, the complaint was discussed based on the Electoral Act 2022 64(5) for possible review at collation level because the results were alleged to have been doctored and that after lengthy deliberation, the INEC Legal Officer explained that the review will only be done in Abuja after Application for

Stating that the said review was jettisoned in Abuja as the INEC declared Kefas Agbu of PDP as winner without reviewing the result as been applied for by the NNPP, the NNPP Chieftain said based on what transpired at the election, the Supreme Court should declare the party's governorship candidate in Taraba state, Professor Yahaya Muhammed Bello as the winner of March 18. 2023 election.

According to Ambassador Ajadi, Professor Muhammad Ahmad AbdulAziz who was the Returning and Collation Officer in the Taraba Governorship Election in his report said "that election took place in all the Sixteen

Local Government Areas of the state on the 18th and 19th March, 2023; that the results were collated at various levels;

" That the Collation at the State Level started on Sunday 19th March 2023 and ended in the early hours of Tuesday, the 21st March, 2023; that there was shooting between the Police and Military attached to the INEC office on 20th March, 2023 which delayed the collation of results.

"That the collation resumed around 5:00 pm on the same day with a lot of tension; during the collation, we received written complaint from NNPP on Wukari Result claiming over voting and in variance with the results in iRev and accredited voters on BVAS; that during the collation, the complaint was discussed based on the Electoral Act 2022 64(5) for possible review at collation level. That the results were alleged to be doctored. The Electoral Act 2022 64(6) was difficult to be implemented under duress and tension".

"Election must be done in a decent, peaceful and transparent manner that must be acceptable by all, not through the Gun shooting, undue duress and tension as alleged by the Collation and Returning Officer of INEC in the Taraba State", he said.

Ambassador Ajadi added, " It is Worthy of note that electorate have the right to choose their leaders through a transparent electoral process without being under duress and tension as well as getting their results doctored in favour of another interest group or party"

" The Leadership of New Nigeria People's Party, (NNPP) is appealing to the Apex Court to restore the hope of Nigerians in the electoral system and electoral process by giving critical look into the complaints of the good people of Taraba state who lawfully and genuinely voted for Yahaya Muhammed Bello of the NNPP as Governor during the March 18, 2023 Governorship Election in the State. Two Dead, 77 Injured In Bodija **Explosion - Gov Makinde**

*Rescue operation ongoing, Oyo Govt to settle medical bills of victims

overnor Seyi -Makinde Wednesday, hinted that two persons died, while about 77 persons were injured in the Tuesday night explosion at Bodija axis of Ibadan

The governor who dropped this hint in a message twitted on his X platform, said preliminary security Investigations have traced the explosion to illegal miners residing in one of the buildings at Bodija.

"In total, we have 77 injured victims so far, most of whom were treated and discharged, and two fatalities. May their souls rest in peace and may God give their loved ones the fortitude to bear this irreparable loss," he said

The governor added, "Preliminary investigations by the security agencies revealed that illegal miners occupying one of the houses in Bodija had stored explosive devices there which caused the blast"

Vowing to bring to book those found culpable, Gov Makinde said the "medical bills of all victims will be covered by

the government"

The governor also promised to ensure that all "those whose houses were affected are supported to rebuild their lives" and that residents should be calm as rescue operations had already started at the scene of the incident.

"Earth-moving equipment, ambulances, emergency lights, and security were deployed to the scene of the incident. The wounded and injured are being treated and moved to public and private hospitals within Ibadan

"Medical personnel are on

standby at these hospitals to provide all needed assistance to the injured. We have visited UCH to see some of those injured during the incident.

"I urge all residents to please call 615 for any emergencies they may be experiencing at this time and to remain calm and stay away from the immediate scene of the incident to allow rescue operations to be carried out without interference," New Nigerian recalls that Gov Makinde, visited the scene of the explosion Tuesday night.

Minister Orders Relocation Of FAAN To Lagos

The directive of relocation of FAAN headquarters, was contained in a memo sighted by our correspondent titled, "Re: Relocation of FAAN Headquarters From Abuja To Lagos", dated 15th January 2024, signed by Mrs. Olubunmi Kuku Managing Director/ Chief Executive Federal Airports Authority of Nigeria minuted to Director Human Resources and Administration.

It reads, "The Honourable Minister of Aviation and Aerospace Development has directed that the Headquarters of Federal Airports Authority of Nigeria (FAAN) should be relocated from Abuja to Lagos

" Consequent upon the above, you are requested to provide the implication of the relocation to the management".

In a telephone chat with our correspondent, the Director Corporate Communication FAAN, Mrs. Nwosu Igbo -IIjeoma neither confirmed nor denied the directive.

She however, said the agency is working on a statement to be issued soon on the matter.

However, an aviation journalist, and public affairs commentator, Mr. Chuks Iwelumo who spoke on the relocation of the agency back to Lagos described it as a welcome development.

He asserted that the movement of all the Federal agencies in the aviation sector to Abuja during the tenure of the immediate past Minister of Aviation Hadi Sarika was politically motivated.

Iwelumo, a former chairman of League of Airport and Aviation Correspondents (LAAC) noted that Lagos is the hub of Aviation, wondering why the headquaters of its agencies should be moved to Abuja. He hinted that none of the agencies could get a befitting office and residential

get a befitting office and residential accommodation since their movement to Abuja.

His words, "The relocation order of the Headquarters back to Lagos is a well development. They were discussing in on the Aviation Stakeholders platform today.

"I wonder why anybody in his real senses will move the headquarters of the federal agencies in the Aviation Ministry to Abuja, knowing fully well that Lagos is the hub of Aviation.

"Since their movement to Abuja, they couldn't get a befitting residential and office accommodation. FAAN is occupying the former Aviation terminal, NEMA is on rented apartment, including NCAA. When the NAMA office was demolished in Lagos, they moved all the staff to Abuja. Till now, they still have accommodation and office problem".

*Northern Elders Forum Frowns At moves to relocate key CBN Departments to Lagos

Meanwhile, the Northern Elders Forum (NEF) yesterday, frowned at the reported

plans by the Central Bank of Nigeria (CBN), to relocate major departments from the Abuja headquarters to the former headquarters in Lagos.

The NEF, in a statement by its spokesperson, Abdul-Azeez Suleiman, recognized the importance of the departments in question, including Banking Supervision, DBS; Other Financial Institutions Supervision, OFISD; Consumer Protection Department, CPD; Payment System Management Department, PSMD; and Financial Policy Regulations Department, FPRD, as vital components of the CBN.

According to the statement, the affected departments are crucial to the functioning of the CBN.

"Therefore, relocating them entirely to Lagos will only serve to further strengthen the already dominant position of Lagos, while potentially weakening the significance and role of Abuja," the statement added.

While acknowledging the CBN's desire to improve efficiency and effectiveness, the NEF expressed worries over the potential negative impact of

relocating these essential departments on both the institution itself and the nation as a whole.

"The movement would involve increased costs, loss of talent, disruption in operations, reduced coordination, regional economic disparities, impaired economic development in northern Nigeria, and decreased investor confidence in the nation's economy.

"Here are some of the potential consequences::It would require significant financial investment as the CBN would need to allocate funds for setting up new offices, purchasing or leasing properties, relocating employees, and other infrastructural requirements. This would strain the CBN's budget and divert resources away from other essential functions and initiatives.

"The CBN has a well-established workforce in Abuja, including professionals with significant knowledge and experience. Moving key departments to Lagos may lead to a loss of skilled employees who are unable or unwilling to relocate. This brain drain could negatively impact the CBN's performance and efficiency.

"Relocation would lead to a temporary disruption in the CBN's operations. Employees would need time to adjust to their new surroundings, potentially causing delays in decision-making and implementation. The transition period



could result in reduced productivity, inefficient processes, and decreased service levels, further impacting the CBN's effectiveness.

"Moving key departments to a different geographical location would hinder effective coordination and communication with other government agencies in Abuja.

"The CBN, as the nation's monetary authority, relies on close cooperation with other bodies, such as the Ministry of Finance and relevant regulatory authorities. Physical separation may lead to increased bureaucracy and slower response times, negatively affecting policy formulation and execution.

"Shifting key departments to Lagos, which is located in the southwestern part of Nigeria, would exacerbate regional economic disparities. The concentration of such important positions and offices in one region may perpetuate the perception of Lagos as the economic center, potentially marginalizing other regions, especially Northern Nigeria. This could lead to increased feelings of neglect or economic imbalance, creating social and political tensions.

"Relocating key departments away from the nation's capital could send a negative signal to both local and international investors. It may raise concerns about political stability, policy consistency, and the government's commitment to regional inclusiveness. This could lead to reduced investor confidence in the Nigerian economy, ultimately impacting foreign direct investment, capital inflows, and overall economic growth.

"Northern Nigeria already faces various economic challenges, such as poverty, unemployment, and insecurity. Moving key departments away from Abuja would exacerbate the imbalance in economic development between the northern and southern regions. It could hinder the flow of investments, infrastructure development, and job creation opportunities in the north, thereby stifling economic growth and exacerbating the existing socio-economic challenges.

"The NEF finds the broader negative implications of relocating these key departments ridiculous and unacceptable as moving economic decision-making power to Lagos could exacerbate regional disparities, fostering a sense of marginalization among other regions, particularly Northern Nigeria.

"Additionally, this move could hinder the Northern governments' efforts to promote economic diversification and reduce dependence on oil revenue.

"Unacceptably too, the North, which is home to a significant portion of Nigeria's population, would be disproportionately affected by the relocation with reduced access to economic opportunities and financial services further widening the economic gap between Northern Nigeria and other regions, potentially exacerbating social and political tensions." the statement said.

were among those rushed to the hospital from the scene of the explosions, with the victims sustaining various degrees of injuries such as major fractures, chest injuries among others.

The CMD emphasized that all the 11 persons on admission at the hospital are "all clinically stable". and receiving treatment as well.

Prof Otegbayo stressed that the hospital is of the view that all the victims will survive, adding our doctors and nurses and other medical officers are fully on ground to attend to victims of the explosion. "We have been attending to victims of the explosion since yesterday night, we have to recall some of our medical officers on leave as well as those not on duty to come to duty and be attending to the victims", he said

On the impact of the explosion on the hospital, the Chief Medical Director disclosed that 16 buildings in the hospital were affected by the vibration from the explosions.

Prof Otegbayo identified the buildings affected as the School of Nursing, School of

Medical Laboratory, the hospital Museum building, Pathology building, Ogunlesi hall among others, school of Medical Laboratory among others.

Stressing that the doors, roof, ceilings and electric fittings at the affected buildings were brought down, destroyed and badly damaged, the CMD said the hospital emergency unit has been activated and put on alert to accommodate victims from the explosion.

Revenue Crisis: Mkpat Enin Council Leadership Debunks Claim By Deceased Family

he Leadership of Mkpat Enin Local Government Area, Akwa Ibom State has debunked claims that one Samuel Monday Toby died in active service as a tax collector for the council.

Toby, report said that he was attacked in his home for assisting in the enforcement of revenue collection suspension in Ikot Akpaobong market, which led to his death.

His wife, Mrs. Gift Samuel Monday had petitioned the Commissioner of Police over the death of her husband, alleging that her husband's death occurred as a result of his involvement in the suspension of revenue collection in the market.

"His assassination is not far-fetched from his 21st December, 2023, involvement in the enforcement of the Ikot Akpaobong Market revenue collection suspension directive of the Mkpat Enin Local Government Council having been appointed to a s s i s t i n t h e implementation of the directive," she said.

Reacting to the death of the deceased, Secretary, Transition Committee Mkpat Enin LGA, Pastor Amos Afia stated that December 2023 was declared a tax-free month for traders in Mkpat Enin, as such the revenue collection committee was dissolved.

In a release made available to journalists in Uyo on Wednesday, Afia explained that some youths in the Local Government led by Akanimo Bob Ikpe, a Personal Assistant to Governor Umo Eno, and Village Head of Ikot Akpaobong Village, Eteidung Aniefiok Cyril Udom flouted the order by selling unauthorized tickets to traders in Akpaudo and Ukam markets

He revealed that the Council had officially informed Eteidung Udom on the tax-free excise in all the markets in the village, adding that members of the newly constituted Markets/Motor Parks Committee were introduced to the Commissioner of Police, as the authorized persons to collect revenue from January 1, 2024.

He explained that the local government council never engaged the services of Akanimo Bob Ikpe as a revenue officer, but that of Samruf Technical Services Limited whose contract elapsed in December 2023, noting that any such claim by Akanimo Bob Ikpe was illegal.

"On December 11, 2023, after due consultation with members of the Transition Committee, the leadership of the Local Government Council through a press release signed by the Secretary of the Transition Committee, Pastor Afia Amos, declared December 2023 a tax-free month for traders in Mkpat Enin.

"We also announced the dissolution of all standing committees in the Local Government Council including the revenue collection committee.

"Despite the release, radio and social media announcement for the smooth implementation of the tax-free exercise, some Youths in the Local Government led by Akanimo Bob Ikpe, a Personal Assistant to the Governor, and Eteidung Aniefiok Cyril Udom, the village Head of Ikot Akpaobong Village flouted the order by forcefully selling unauthorized tickets to traders in Akpaudo and Ukam markets.

"On December 20, 2023, the village head of Ikot

Akpaobong, Eteidung Aniefiok Cyril Udom, was officially written to, introducing the enforcement team on the tax-free excise in all the markets in the village. In addition, on December 29, 2023, the Commissioner of Police, Akwa Ibom State Command, got a letter introducing members of the newly c o n s t i t u t e d Markets/Motor Parks Committee as the authorized persons for revenue collection from January 1, 2024.

"On December 22, 2023, an unfortunate report that an indigene of Mkpat Enin named Samuel Monday Toby was attacked at his home for assisting in the enforcement of revenue collection suspension in Ikot Akpaobong Market.

"From all the records available in the Local Government Council, there is no record that indicates that the Local Government Council at any point engaged the services of Akanimo Bob Ikpe as a revenue officer.

he Lagos State Commissioner of Police Fayoade Adegoke PSC, mni, has disclosed that the command has nabbed no fewer than 37 suspected criminals within one month.

He also hinted that a total number of 16 firearms including a toy pistol, 72 live cartridges, 75 live ammunition, one expended cartridge, one pistol magazine, six axes, four daggers, five cutlasses, two vehicles, one POS machine, fake vehicle registration plates and various charms were recovered within the period in review.

Fayoade, who made the disclosure Wednesday during his maiden press briefing at the Command Headquarters, Ikeja, stated that the suspects were apprehended for their alleged involvement in varying crimes, which include armed robbery, stealing, cultism and unlawful possession of firearms amongst others.

" The following items were recovered from them: Three

English double barrel gun, One pump action rifle, one reining model 700 rifle, one locally made pistol, Seventy-Four rounds of live ammunition, Sixty-Eight rounds of cartridges, one baretta pistol magazine, Four axes, Three daggers and Five cutlasses.

Lagos Police Arrests 16 Notorious Cultists, Recovers Assorted Firearms, Ammunition, Army Camouflage

t least, 16 notorious cultists are now cooling in police custody in Lagos, including a wanted kingpin alleged to be involved in series of killing.

Identified as Olamilekan Tajudeen (aka Ebila), 38, he was said to have been arrested with one locally fabricated automatic Baretta pistol on January 13, 2024, at about 10.30am by police operatives.

Six others, said to be m e m b e r s o f a confraternity, were also arrested whie planning to retaliate their leader's death on other rival cult members in Ayobo area of the state.

They were identified as one Quadri Mukail, Adedoyin Azeez, Olayinka Ayodele, Orefuwa Olamide, and Anuoluwapo Ojo.

Our correspondent gathered that they were in possession of one berretta pistol with two cartridges and one axe at the time of the arrest.

Five assorted firearms of high calibre were also recovered from two gangs of suspected notorious cultists cum armed robbers by the operatives.

As gathered, four of the suspects identified as Balogun Tola (aka 50), 35, Tunde Oladipupo, 43, Rasa Ridwan, 27 and Abimbola A r o , 29, we r e apprehended in Ikorodu area of the State on 11th

January, 2024 at about 1.00am.

Three English double barrel gun, One pump action rifle, one reining model 700 rifle, one locally made pistol, seventy-four rounds of live ammunition, sixty-eight rounds of cartridges, one baretta pistol magazine, four axes, three daggers and five cutlasses were recovered from them.

According to report, six others named Fatai Ajayi, 25, Samuel Issac, 26, Solomon Kamaldeen, 28, Kenneth Danladi, 29, Etuk Ayanime, 28, and Damilola Oyerinde, 36, were nabbed by officers of the Headquarters 9 Brigade of Nigerian Army on 12th January 2024 at

about 3.00pm.and handed over to the Police.

Alhaji Rafiu stressed that the e-mail sent to Gov Makinde for appeal was dated January 8, 2024 and that there has not been any response till date, saying, Gov Makinde should reach out to the Kaduna State Governor, Senator Uba Sani to immediately look for a way out so that the lives of the victims will not be lost.

"Since our brother and his wife with our young brother have been kidnapped in the middle of the night of December 27, 2023, we have made all efforts to gather the money requested by the kidnappers, which is a hundred million naira but all we could get till this moment is just N30 million", he said.

Alhaji Rafiu added, "for two weeks, the abductors did not call us till they did on Monday, telling us that they gave us till Thursday to come up with the money. We have made public appeal and called on people of means in the society to please help secure the lives of our loved

ones in captivity, friends, extended family members have reached out, but we are still far to the figure demanded, which is hundred million naira and we have only today left".

FG Workers Suffering In Silence - FWF

*Wants all outstanding wage award arrears paid within next 14 days

7 orried by their plight, the Federal Workers Forum (FWF) on Tuesday, alerted that the Federal Government workers in the country are now suffering in silence.

Raising the alarm in a communique signed by the forum's National Coordinator, Comrade Andrew Emelieze issued at the end of an online meeting to evaluate the existential conditions of the federal workers in Nigeria, FWF noted that it "has been a tale of harrowing experiences from the federal government workers in Nigeria"

According to the forum, " It has been a tale of harrowing experiences from the federal government workers in Nigeria", adding, "The workers have been suffering in silence. Federal government workers are frustrated and sorrowful".

" Live has been made meaningless and hellish since the removal of subsidy on petrol. The daily rising cost of living has made everything worthless resulting in monumental hardship being visited on the workers", it said

FWF added, " After intense and critical discussions concerning the living conditions of the federal workforce. The general submission is that the federal workers have been shortchanged, cut off from acceptable social life and our family structure has been badly affected, since the removal of fuel subsidy.

The government had promised a palliative package through a wage award meant to mitigate against the sufferings caused by the subsidy removal. Unfortunately, the wage ward is not paid promptly".

FWF stressed further The purpose of putting up the wage award has been defeated, as most workers only got paid just once in September, and are being owed three months arrears of payment, gradually getting to the fourth month now", adding, " The federal government has derailed in the payment of

wage award to her workers".

The Forum maintained, " It is getting to the fourth month that most of the federal government workers have not received any wage award", saying, "The payment of the wage award has been staggering, while a very few just got the second month, out of the six months promised from September 2023, majority of the federal government workers are yet to collect the October, November and December arrears.

" It is so bad that protest letters against the non implementation of the wage award has emanated from the military and paramilitary.

Workers are fed up, the sufferings is unlimited. It is as if government want to deliberately torture the federal employees.

"Workers have gone borrowing in order to continue surviving. What is more surprising is the response by the Tinubu led Federal government pretending that all is well while the federal workers are starving ".

FWF in the communique

stated that it resolves that * All the outstanding wage award arrears be paid within the next fourteen days, * That the government should investigate the delay in the payment of wage award, which we see as an act of corruption.

* That all outstanding promotion arrears and many other pending arrears owed workers be paid.

' That all pending arrears owed the federal universities workers be paid.

That salaries be paid latest 28th of every month.That the federal government look into and implement our earlier demands concerning free education to the dependants of all federal government workers in all federal government owned schools across all levels.

"That the federal minimum wage should not be less than three hundred thousand naira (300k)

That all federal government workers be ready to react at the expiration of the two weeks ultimatum giving to the federal government if our demands are not met."

Handling down the warning in Ibadan while addressing IBEDC Management during his working visit to Ibadan, the Minister said it is the responsibility of the electricity distribution companies to provide transformers, poles and cables to communities within their areas of coverage.

Chief Adelabu declared that President Bola Tinubu frowns at the situation where communities would be forced to purchase transformers poles and cables by electricity distribution companies.

The Minister maintained that the President Tinubu led administration will not tolerate a situation where communities will be

" We don't want to hear news of communities buying transformers, cables and poles for themselves again. The federal government frowns at it. You see what we have done in Kaduna. You are not number one, two or three, you are struggling to be number four on the rating", he said Chief Adelabu added " it is the responsibility of the distribution companies to provide transformers, cables and poles to communities so that power supply can improve".

" A situation where communities buy transformers, cables and poles must stop. I know that you have these centers but how effective are they to ensure that customer complaints are attended to. As a minister, I don't want to hear news of communities being asked to purchase electric transformers, cables and poles", Chief Adelabu

stressed, " If the consumers are paying for the electricity, then it is the responsibility of the distribution companies to provide these items.

There must be improvement in power supply".

He noted further, "That is what the government planned to do. People should not pay for darkness. When people have a 24-hour power supply, they can pay double for electricity because you have saved them the money to power generators".

Poverty Alleviation In Nigeria, A Dashed Hope

he World Bank's Nigeria development update, titled, 'Turning the Corner: From Reforms & Renewed Hope, to Results,' in December last year stated in unambiguous terms that

poverty rate in Nigeria had increased to 46 per cent in 2023, representing 104 million poor Nigerians.

However, highlights of the 2022 Multidimensional Poverty Index survey had revealed that: 63% of persons living within Nigeria, representing 133 million people are multidimensionally poor.


In general, the incidence of monetary poverty is lower than the incidence of multidimensional poverty across most states If the country.

In Nigeria, the poverty alleviation measures implemented so far have focused more on growth, basic needs and rural development approaches.

The country's previous military and civilian governments in the country approached eradication ir alleviation if poverty though key programmes through Operation Feed the Nation, Green Revolution, Better Life for Rural Women and Family Economic Advancement.

Indeed poverty eradication will be achieved by expanding employment opportunities, and also by making life more affordable for low income households thus reducing vulnerability by increasing the asset base and strengthening social security and the social wage.

The Social Protection Policy for Nigeria commonly called NSIP which President Buhari administration started in 2016 and gave priority attention to, is an umbrella policy framework that incorporates related social agenda paradigms intended to reduce poverty and provide a life of dignity for all citizens.



The NSIP was intended to check poverty, improve capacity and put money in the hands of the poorest and the mist vulnerable in the country. Under President Muhammadu Buhari, the NSIP has successfully implemented and executed four programmes aimed at addressing the negative effects of poverty and promote economic development.

The NSIP programmes are Home Grown School Feeding Programmes, GSFP;

Government Enterprise and Empowerment Programme, GEEP; N-Power, National Social Safety Net Programme, NASSCO; and the National Cash Transfer Programme, N-CTP otherwise called 'Trader Moni'.

In a regrettable twist on the impact of the lives of poverty stricken and vulnerable nigerians after almost 7 years of a success, President Tinubu recently suspended the work of NSIP. Though the reasons are not far fetched, this action

will go a long way in easing poverty level among Nigerians.

Nigeria's President recently suspended the country's Minister of Humanitarian Affairs and Poverty Alleviation and Mrs Halima over the use of private bank accounts for ministry's financial transactions in the government's social welfare programme.

Betta Edu and Halima's actions have resulted in the President ordering a

"thorough investigation" of all ministry's financial transactions," including the entire framework of Nigeria's s o c i a l i n v e s t m e n t programmes.

President Bola Tinubu was elected last year after promising to rid Africa's most populous country of chronic corruption and extreme poverty. His government said the suspension follows his commitment "to uphold the highest standards of integrity, transparency and accountability" in how Nigeria's resources are managed.

Meanwhile, sequel to President Bola Tinubu's sixweek suspension of the four (4) programmes under the National Social Investment Programmes Agency, NSIPA President Tinubu has approved the establishment of a Special Presidential Panel, to immediately undertake a comprehensive review and audit of existing financial frameworks and policy guidelines of the social investment programmes with a view to implementing a total re-engineering of the financial architecture of the programmes with detailed modification to procedures guiding the programmes' implementation moving forward.

The Special Presidential Panel, which is comprised of ministers representing strategic sectors and will ensure a multi-disciplinary approach to the reform effort, is made up of the following members:

However and regrettably too, the hope of Nigerians being saved from the threats of poverty will continue to elude them and something must be done urgently to save the country from the consequences of increased poverty in the land.



FG Commercializes TELA Maize Varieties

he Federal government has approved the commercial release of transgenic insect resistant and drought tolerant maize varieties, known as TELA maize.

The approval was granted by the National Committee on Naming, Registration and Release of Crop Varieties, Livestock breeds/Fisheries (NCNRRCVLF) headed by Prof Olusoji Olufajo at its 33rd meeting at the National Centre for Genetic Resources and Biotechnology (NACGRAB), Ibadan.

The four varieties approved by the NVRC are, SAMMAZ 72T, SAMMAZ 73T, SAMMAZ 74T, and SAMMAZ 75T.

Accordingly the new maize varieties are drought tolerant and are resistant to stemborer and fall armyworm resulting in yield advantage of up to 10 tonnes per hectare under good agronomic practices.

The national average for similar hybrids is 6 tonnes per hectare. The varieties are suitable for Rain Forest, Guinea, and Sudan Savannas.

Stem-borer reduces maize production in several countries in Africa, while fall

armyworm can destroy up to 20 million metric tons of maize in Africa each year, enough to feed 100 million people.

The release and registration of the four varieties followed environmental release approval in October 2021 granted by the National Biosafety Management Agency (NBMA).

Also the development of the improved varieties was led by the Institute for Agricultural Research (IAR) Samaru, Ahmadu Bello University Zaria through the TELA Maize Public-Private Partnership coordinated by AATF.

The TELA Maize Project is currently being implemented in five countries – Ethiopia, Kenya, Mozambique, Nigeria, and South Africa.

Prof Ado Yusuf, Executive Director, IAR expressed satisfaction with the release of the new four maize varieties saying, IAR is very proud of its scientists who are addressing the maize productivity challenges in the country and beyond.

These varieties have undergone thorough research and have been developed using the tools of biotechnology over several years of continuous testing and revalidation.

Dr Canisius Kanangire, AATF's Executive Director, said, "the release of TELA Maize in Nigeria will contribute to food and nutrition security in line with the Federal Government's Agricultural Transformation agenda.

"AATF reaffirms unwavering commitment to addressing challenges faced by farmers across the continent."

Professor Garba Sharubutu, the Executive Secretary, Agricultural Research Council of Nigeria (ARCN) said the approval of the TELA Maize variety in Nigeria is a critical milestone that confirms the potential of biotechnology in ensuring food and nutrition security, and improved livelihood of farming households in Africa

Prof. Mustapha Abdullahi, Director-General, National Biotechnology Development Agency (NABDA) celebrated the release saying that, with the advent of TELA Maize, farmers will reduce the use of pesticides on maize to the bare minimum which is beneficial to humans, livestock, and environment.

Dr Sylvester Oikeh, the TELA Maize

Project Manager celebrated the decision by Nigeria by calling on other countries in Africa to act for farmers.

"I am encouraged by this decision by the Federal Government of Nigeria that reflects their commitment to the needs of formers"

He congratulate the scientists for their hard work and dedication that has seen the product getting closer to farmers and look forward to other countries making similar decisions for the good of the farmer, he said.

CSO To Tinubu: Halt Moves To Replace Companies Awarded Contracts By Works Ministry

n Abuja based civil society organisation, Collective Action Against Corruption has raised the alarm over plots by the ministry of works to shortchange some contractors awarded road construction jobs by replacing the names of their companies with different ones without plausible reasons.

It was gathered that the ministry awarded contracts each for some road construction to some indigenous companies after the ministerial tenders' board had duly certified the contracts and all the necessary processes including payment of remita and certification by the BPP, but the ministry is allegedly planning to change the names of the companies.

The CSO through its spokesman, Bala Ibrahim, said information at its disposal showed that the ministry has concluded plans to change names of the companies awarded the multibillion Naira contracts in different parts of the country to preferred companies, some of which have ties with

some vested interests.

They insisted the action runs contrary to the provision of the procurement act and urged the ministry to read the act.

"Documents at our disposal showed that after letters of award had been issued with all the processes required by law completed, with a no objection certification from the Bureau of Public Procurement, the ministry is set to change the names of companies already awarded the contracts"

The CSO described the move as unfair, unfortunate and runs

contrary to the clamour for a level playing field in conduct of government business even as it questions the rationale for the action and wondered why the previous companies were not told right from the bidding process if indeed, they lack the requisite skills to deliver the job. While urging the ministry to urgently reverse the planned name change, the CSO harped on the need for transparency in the conduct of government activities.

It appealed to the president to urgently intervene and halt what it described as sheer deliberate attempt to contravene rules and procedure in the conduct of government activities assuring that should the ministry proceed with the change; it would be compelled to seek legal redress. When contacted the newly posted Permanent Secretary said he was not aware and referred our reporter to seek clarification from the minister, even though findings showed that that the permanent secretary was the signatory to letter for change
