Katsina Governor Moves To Revive 2 Songhai Farms Established By Shema

overnor Dikko Umaru Radda of Katsina State will revive two moribund Songhai Farms in the state. The two Songhai Farms' Centres were established by the administration of the former governor of the state, Barrister Ibrahim Shehu Shema at Makera Village attached to Zobe and Mairuwa Dams in Faskari and Dutsinma local government areas respectively.

Governor Radda in a statement by his Chief Press Secretary, Mohammed Kaula gave the assurance when he led some top functionaries of the State Government and Dr. Salisu Ingawa, the former chairman Songhai Farm Centre to the Songhai Farm in Porto-Novo, Benin Republic, on Friday.

Speaking after touring the Porto-Novo Songhai farm, the Governor bemoaned the decay of the two Katsina Songhai models and pledged to resuscitate them, the reason he added necessitated his visit to Governor Dikko Radda, however, said "We want to copy the concept here. Because it is here that our students were trained back then. About 60 of them, specifically. As we are here now, we have seen everything. And by the time we return, we can be able to revive our Songhai farm centres.

"Because that is the only way our teeming youths can benefit from the investment that was put in place. A lot of tax-payers money were used to establish the centres. And it was conceived in such a manner that it can be useful, in terms of developing the economic fortunes of our Katsina state, and Nigeria in general," he said.

Radda further noted that he and his delegation are particularly interested in learning about the management structure of the Porto-Novo Songhai farm centre, in order to effectively manage the moribund centres in Katsina.

"We want you to advise us accordingly on how to run the centre. And if possible, we can enter into a partnership on running our Songhai farms. This will entail that you help us develop it for a certain period of time, before our people take over," he reiterated. While taking Governor Radda and his delegation round the farm, Father Godfrey Nzamujo, the founder of Songhai Farms, commended the Katsina Governor and his vision to revamp the Songhai farms in the state.

Anambra 2025: You're Scared Of Me, Ubah Tells Soludo

🕇 enator Ifeanyi Ubah, representing JAnambra South Senatorial District, has alleged that Governor Chukwuma Soludo's recent actions against him stemmed from fear. Ubah, who is a chieftain of the All Progressives Congress (APC) told reporters on Monday January 29, in Nnewi, that since declaring his intention to vie for the 2025 governorship election, Soludo has persistently targeted him. However, he pledged that he would do only four years if given the opportunity by the people of Anambra, while advising Soludo to concentrate and give the people the good governance he promised them instead of being afraid of his shadows.

Police Nabs Cafe Operators For Defrauding 300 Kaduna Varsity Students Of N60m Tuition Fees

he Coalition of United Political Parties (CUPP) has expressed reservations on the role of the Independent National Electoral Commission (INEC) as By-elections hold across the country tomorrow.

This was expressed in a statement signed by National Secretary, CUPP, High Chief Peter Ameh, made available to our correspondent vesterday. "CUPP is in trepidation that INEC is beginning to constitute itself as an arm of the ruling All Progressives Congress (APC). We are at a loss, and find it extremely hard to hazard any guess as to the reason for its removal of PDP from the ballot, only, but to make it an easy ride to victory for APC candidates," it said.

According to the statement titied, "INEC AS AN OBSTACLE TO N I G E R I A ' S DEMOCRACY" CUPP frowned at the alleged denial of People's Democratic Party (PDP), the chance to field candidates in Plateau.

"The Coalition of United Political Parties (CUPP) has observed with great dismay the ignoble role the Independent National Electoral Commission (INEC), is about to play in the forthcoming bye elections in Plateau North

Senatorial District by denying the People Democratic Party (PDP) the right to contest as a party in the elections.

"INEC has hinged its refusal to manifest PDP on the ballot papers on a judgement of the Election Panel of the Court of Appeal that has already been discredited by the Supreme Court as miscarriage of justice, unjust and obnoxious, on the grounds that the Court of Appeal had no jurisdiction to entertain a pre election matter.

"At no point was PDP barred from representing its candidates for any by election, and as a matter of convention, a by election is meant for those who had participated in the earlier election," CUPP said.

The coalition added that, "With this development, the majority of people of Plateau North Senatorial District will b e disenfranchised by denying them the opportunity of choosing the candidates they overwhelmingly voted for in the February, 2023 National Assembly election".

CUPP therefore, used the opportunity to put Nigerians on notice and at alert on the ignoble and obnoxious behaviours of INEC past and present that is capable of undoing our democracy.

Federal Workers Say FG Not Sincere With Payment Of Minimum Wage, Bonus, To Shut Secretariats From Monday

*Says no extension of 14 days ultimatum to FG *Demands solidarity from CSOs

Forum (FWF) on Monday, alerted that the Federal Government is not been sincere with payment of wage award and the quest for a new national minimum wage for workers. Raising the alarm in a communique issued at the end of an online meeting of the forum, signed by its National Coordinator, Comrade Andrew Emelieze, FWF said there will be no extension of its 14 days ultimatum to the Federal Government.

The forum noted that, " Government has been speaking with different lips. We have reviewed the situation at hand as regards the payment of the wage award to federal government workers, the new minimum wage and the state of the nation.

" It was generally agreed that the federal government has not been sincere with the payment of the wage award and the quest for a new national minimum wage", it said.

FWF added, " Government has been speaking with different lips. At a time, government claimed that it will clear all the outstanding arrears of the wage award owed and at another time, the Accountant General of the Federation (AGF) has come to give reasons why government cannot pay the wage award.

"Most workers only got the September payment and most of the federal workers are now being owed four months wage award arrears. Most unfortunately, the purpose of putting in place the wage award has been defeated".

According to the forum, "The question has been that if government is treating the issues of 35,000 Naira wage award for federal workers this way, then there is no hope of the actualization of a living wage for the Nigerian workers within this period". The forum noted, "Workers

have endured this hardship enough and we have decided that there shall be no extension of the 14 days ultimatum", saying, " we are left with no other option other than to call out all our members out to exercise their constitutional rights to protest against the mass suffering faced by workers". FWF stressed, "If after seven days, government fails to respond, the protest will lead to a total shut down of all federal government secretariats nationwide from Monday, February 5th ,2024", vowing, ". We will not take any flimsy excuse for not paying the wage award as put by the AGF neither are we going to tolerate the staggered payment as done before nor accept part payment of the wage award again".

It maintained that the " protests is continuous until all outstanding wage award is cleared.That workers nationwide gather infront of all federal government secretariats nationwide and

occupy it.

The communique reads further:

"That wherever possible in all MDA's, especially in federal government higher institutions, protest should also go on. That all federal government workers should take this call as a matter of duty and not betray the struggle. We shall all assemble for the peaceful protest and demonstrations.

"We call for the solidarity of the civil society and the mass populace to join us in this struggle against oppression. Together we will resist hardship and mass suffering on the land. We are using this opportunity to call on the federal government to pay all that is owed the federal workers else the protest shall continue. Workers have suffered enough. We are ready for the protest. No going back, mobilization is in top gear. No retreat no surrender. Forward ever backward never.

Katsina Governor Receives 35 Abducted Persons Rescued By Troops *Introduces free medicare to victims of bandit attacks

overnor Dikko Umaru Radda of Katsina State has received 35 abducted Persons rescued by troops of the Nigerian Army recently kidnapped by armed bandits in Tashar Nagulle and Nahuta in Batsari Local Government Area of the state.

Chief Press Secretary to the Governor, Ibrahim Mohammed Kaula said in a statement, that the victims were rescued and handed over to the governor at the

Katsina State Government House by the Commander, 17 Brigade of the Nigerian army, Brigadier General O.A. Fadairo.

Speaking at the occasion, Governor Radda thanked the "Almighty Allah for rescuing the victims without any casualty from the security operatives or the hitherto abducted civilians."

The governor maintained that success was being recorded in the fight against banditry and many terrorists in the state have been killed, with their camps dislodged

and a lot of weapons recovered through the joint efforts of security operatives in the state.

While commending the efforts of the Army and other security operatives, Governor Radda reiterated that, his administration would deal with Persons 'romancing' with terrorists in the state.

Governor Dikko Umaru Radda said the state government has also introduced free medicare to victims of bandit attacks, and allowances to security

agencies, as well as educational support to those who lost their parents during violent attacks of terrorists.

Governor Radda donated "One hundred thousand (100,000) Naira each to the 35 rescued persons for them to revive their normal business when they arrive home."

Earlier, Brigadier General O.A Fadairo, said the victims were rescued at Dumburum Forest after an intensive gun battle between soldiers and the bandits.

SPANCI To Gov Makinde: Don't Present Staff Of Office To Olakunle As Alamura of Amura

human rights group, Save The Poor and Needy Charity Initiative (SPANCI) yesterday, advised Governor Seyi Makinde not to present staff of office to Deacon Samuel Oladejo Olakunle, as the Alamura of Amura land in Orire Local Government Area of the state.

SPANCI in a petition addressed to Gov Makinde, signed by its President, Comrade Yemi Ezekiel Bello alleged that Olakunle is standing a criminal trial in suit No: MI/1047C/2023 at Magistrate Court in Ibadan.

According to the SPANCI President Oyo State Government has prosecuted and arraigned Olakunle in a magistrate court in Ibadan after he refused to appear for interrogation and investigation on some criminal allegations bothering on land grabbing, sponsoring hooligans and thugs.

Comrade Bello noted that the Oyo State Ministry of Local Government and Chieftaincy Matters is aware that Olakunle has pending criminal cases against him in the court and pending petition before the ministry.

"Urgent petition against an act of unlawful upcoming presentation of staff of office as traditional ruler to deacon Olakunle Oladejo Samuel as the Alamura of Amura land Orire local government Ikoyi Ile Oyo state, an act that can lead to perversion, prevention, obstruction and defeat of cause of justice in suit number: MI/1047C/2023", it said.

SPANCI added, " We have being reliably informed and have also confirmed from our clients Pa Thomas Ademola Bamigbala and Chief Adeoye Akinpelu the Onilodo of Ilodo and instructed by them to write this letter so that their rights might be protected".

"Our client said the ministry for local government already knows that deacon Oladejo has pending criminal cases against him in the court and pending petition before the ministry and also referred to them from the state's real property protection and anti land grabbing task force bothering on the real alamura of amura title between him and Pa Moses Ajani".

It stressed further "We believe that the administration of his Excellency, Engineer Seyi Makinde is a very noble and justice serving administration and will never be involved in illegality and also the office of honorable Commissioner for local government and chieftaincy matter should not be involved in any act that can lead to perversion, prevention, obstruction and defeat of cause of justice as the honorable Commissioner is a law abiding and God

fearing personality per excellence" SPANCI emphasized ""We also know that it is wrong for state government to prosecute someone and also select for coronation or presentation of staff of office to the same person standing criminal trial in court of law as this will be a bad precedent", adding, "We therefore humbly refer the state through the ministry for local government and chieftaincy matters to the state's taskforce on real property protection and anti land grabbing for verification of our claim since his case file is with them".

"We also humbly request for immediate removal of Deacon Olakunle Oladejo Samuel, the self acclaimed Alamura of Amura from those who will be presented with the staff of office.on Friday 2nd of February 2024 just two days more in the interest of justice and not politics.

Governor Inuwa Opens New Vista Of Investments Into Gombe

Gombe State Governor, Muhammadu Inuwa Yahaya Wednesday, made the first move among the subnationals in Nigeria to source for green bond funding to execute his environmental friendly projects.

A statement signed by the Director-General (Press Affairs) Government House Gombe, Ismaila Uba Misilli, made available yesterday, said that the governor met a broad spectrum of investors, investment experts, stock brokers and array of capital market players to source for the green bond funding window as a means of consolidating his investment drive into Gombe State.

The meeting at the Nigerian Exchange Limited (NGX) is a precursor to the second edition of the Gombe State Investment Summit tagged Go-Invest 2.0. which is billed for November 2024 in the Gombe State capital. Governor Inuwa Yahaya said he led his team to the NGX to showcase to the whole world the potential in Gombe State and invite investors over.

"We need this funds to engage in viable projects that are ecofriendly, sustainable, and in conformity with international policy on climate change. It is also to invest in eco- friendly projects that will contribute to the well being of the citizens and minimize the impact of climate change on their livelihoods.

"We shall be expanding the frontiers of our afforestation programs which our administration has been prosecuting under the Gombe Goes Green project. In addition, we will also pursue the solar energy project which has helped Gombe State tremendously since we embarked on solar energy as an alternative source of power in Gombe State. "We are expecting to raise N30 billion, but we will do it in tranches. We are sourcing for N15b for now and when we see how well that is doing, we can now come back. He explained that Gombe is an agrarian economy with over 70% of the population actively engaged in the sector, adding that " we will expand the agricultural sector potentials with more funding".



Governors' Forum is very optimistic of his success at the NGX. He said, " I'm sure from the acceptance we have received from the investors and feelers from the exchange floor we are sure of meeting our target".

"We are at the centre of North East Nigeria, we are relatively peaceful and infact number one in peace and cordiality in Nigeria. We have every cause to invite investors to Gombe State because we can guarantee the safety of the investors and their investments, he added.

"We are currently leading Nigeria in the ease of doing business, winning it back to back in 2021 and 2022; we run a very transparent government devoid of bottlenecks. We are digitally compliant and our procurement processes are very open and seamless", Inuwa Yahaya told the investors. t least, eight hitherto blind children at the weekend smiled home in Lagos, regaining their sight as they benefitted from the free eye surgeries programme offered by the state government.

The expedition was part of a compassionate initiative aimed at addressing blinding eye conditions in the community.

In a statement on Sunday. the Director, Public Affairs Ministry of Health, Tunbosun Ogunsanwo said that the successful surgical expedition took place at General Hospital, Odan, Lagos on January 26, 2024.

He attributed it to a collaborative effort between the Lagos State Government, the Consulate of the People's Republic of China, and the Chinese Community and Enterprises in Nigeria.

Ogunsanwo hinted that the program aimed to bringing light into the lives of residents, particularly children, by restoring their sight.

Speaking during his visit to the beneficiaries, the Permanent Secretary, Lagos State Ministry of Health, Dr. Olusegun Ogboye expressed the outreach's focus on ensuring a brighter future for children with cataracts. Hoodlums Reign Terror In Akwa Ibom, Police, Four Others Killed *Governor reads riot act

By; PATRICK TITUS, Uyo t least five persons have been confirmed killed gruesomely within last month (January) in Uyo, the Akwa Ibom State capital by unknown gunmen.

The last which occurred on Wednesday, where a police officer, Inspector Osang was murdered at his residence, has made residents to become apprehensive of who may be the next target.

Osang it was learnt, was serving at C Division of the Nigeria Police Force in Uyo before the tragic incident.

Although, facts surrounding death of Inspector Osang, was still in mystery as at when this report was filed, a source who spoke under anonymity, said, the incident occured at about 8:30 pm.

According to the source, the assailants which numbered over 10 stormed the residence of their victim located on a lane linking Enen Afaha and Afaha Ube, in Uyo metropolis to reign havoc; shooting while residents and passerbyers scampered for safety.

The State Police Public Relations Officer (PPRO), Odiko MacDon confirmed the incident saying, the Command has received the news of the murder of the police personnel describing it as very unfortunate. According to him, "We have received that information and it is an unfortunate situation.

"Already, an investigation is ongoing and we are committed to ridding the streets of criminal elements.

"Again, we are not deterred and we are committed to ensuring that, criminal minded persons will account for their actions" M a c D o n , a P o l i c e Superintendent said.

When our reporter visited the area yesterday morning, people were seen in clusters, discussing the unfortunate incident while fear of unknown was feasible.

It would be recalled that the latest killing is the fifth of such incidencts in January, just as it was rumoured that another person was killed Tuesday night and body dumped around Ikot Oku Junction along the outskirts of Uyo.

The two incidents occurred after a young lady, was also murdered penultimate Sunday night and the dismembered body tucked in a Ghana-Must-Go bag, dumped by the roadside at Nwaniba Road, Uyo.

Similarly, a woman was reportedly killed at the Banking Layout of Sir Udo Udoma Avenue, two weeks ago.

Earlier, one Samuel Monday Toby, a revenue collector for Mkpat Enin Local Government Area of the state was killed at his residence.

Meanwhile, the state governor,

Pastor Umo Eno has read riot act to criminals in the state, warning that, no criminal should test the resolve of his administration on security matters and go free.

Oyo Govt Ready To Control, Eradicate Neglected Tropical Diseases - Health Commissioner *Says untreated NTDs can lead to disability, death

y o S t a t e Commissioner for Health, Dr. Oluwaserimi Ajetunmobi on Friday, disclosed that the state government is ready to control, eliminate and eradicate Neglected Tropical Diseases (NTDs)

Dr Ajetunmobi who said this in Ibadan while addressing journalists at a press briefing on 2024 World NTD Day held at the Conference Room of the Ministry of Health, Agodi, Ibadan, hinted that NTDs if not properly treated could lead to disability and stigmatization hence, there is need for serious awareness on the diseases from all the critical stakeholders.

A c c o r d i n g to D r. Ajetunmobi, Neglected Tropical Diseases are group of diseases that are largely found in tropical areas of the world, particularly in area where access to clean water sanitation and essential medicine is scarce, saying, "NTDs if untreated, could lead to disability and s t i g m a t i z a t i o n.

Onchocerciasis (River Blindness) if not treated could lead to loss of sight, while Schistosomiasis (SCH) and Soil Transmitted Helminthes (STH) can result in anaemia.

"The long-term effects of some NTDs can be catastrophic, which can lead to loss of life. The devastating effects of NTDs on our people cannot be over emphasized, hence the need for all to come together to combat the diseases", she said

Dr Ajetunmobi added, " Our action is to raise the profile of NTDs, the suffering they cause and to gather support towards their control, elimination and eradication, in-line with programmatic targets set out in the World Health Organization (WHO) 2023 NTD road map which includes decreasing the number of people requiring intervention for NTDs by 90 per cent".

The Commissioner stressed that Oyo State Government has embarked on proactive measures through innovation and intensify disease management,

preventive chemotherapy by distributing anthelmintic medicines, mass drug administration of praziquantel to school aged children, vector control through mass spraying of insecticides, veterinary public health, provision of safe water, sanitation and hygiene, among others.

"This year, the world NTD Day theme seeks to continue the momentum from previous years and carry through the thread of taking NTDs out of isolation, identifying opportunities for integrated action on NTDs and the continued call for investment in NTDs. NTDs programmes strengthen health systems by increasing access to hard-to-reach people and training community health workers who provide a first line primary healthcare, everyone has a key role to play by bringing renewed attention to NTDs, building political will and mobilizing resources and putting individuals and communities at the center of the response.

" We can collectively generate the attention and

resources needed to deliver against the elimination of NTDs in Oyo state, that is the reason why Oyo state government also joins the global community to celebrate the 2024 world NTD Day."

Executive Secretary of the state Primary Healthcare Board, Dr. Muideen Babatunde Olatunji while speaking, said the state government has been playing a central role in implementing policies, allocating resources and coordinating efforts to control and eliminate these diseases in the state. According to Dr Olatunji in 2023 alone, Oyo State Government release over N27 million to support NTDs programme activities in the state, including drug distribution, public awareness campaigns among other activities. "The NTD unit of Oyo

"The NTD unit of Oyo state Primary Health Care Board is saddled with the responsibility of carrying out all the control strategies through safe and cost-effective preventive chemotherapy (PCT) in collaboration with the willing NGOS."

Troops Clear ESN, **IPOB** Camps In Imo, Neutralise Kidnappers

oint troops have cleared several camps of the proscribed Indigenous People of Biafra (IPOB) and it's militia arm, Eastern Security Network (ESN) along Umulolo-Umukele-Amousu and Agbobu in Okigwe Local Government Area of Imo State.

The security operatives are made-up of troops of the 82 Division of the Nigerian Army, Navy and Air Force in conjunction with the Nigerian Police and Nigerian Security and Civil Defence Corps (NSCDC).

Acting Deputy Director, 82 Division Army Public Relations, Lt.-Col. Jonah Unuakhalu, disclosed this in a statement on Friday, saying the troops stormed and destroyed hideouts of the terrorists despite encountering several Improvised Explosive Devices (IED).

He said the troops also cordoned-off and searched several buildings used by the terrorist group.

According to him, during the search, signs of the terrorist's activities, occultic and acts of cannibalism by the group were discovered.

"The troops also destroyed the IED making factory of the terrorists, adding that the troops recovered rank badges of two policemen that were kidnapped along Enugu-Port Harcourt Road.

"Other items discovered include Biafran currencies. fake US Dollar bills, Biafran Liberation Army T-shirts, Military kit bags, cables used for IED detonation and axes. "Two suspects were arrested and also burnt policemen corpses were discovered for proper burial." In another development in Owerri metropolis in Imo, troops on night patrol thwarted a kidnapping attempt by some suspected IPOB/ESN terrorists. The 82 Division spokesman said that the

troops engaged the criminals in a gun duel forcing them to abandon the victim.

He stated that troops recovered one AK 47 rifle and magazine, a G-3 rifle with mounted magazines and the vehicle used by terrorists.

Unuakhalu said, "Furthermore, in a bid to strengthen cordial civilmilitary relations and create a peaceful society, the General Officer Commanding (GOC) 82 Division of Nigerian Army, Maj.-Gen. Hassan Dada, visited Isiuzo-Amufu community in Enugu State on January 24, 2024.

"The GOC, who addressed the people of Isiuzo-Amufu community at their village square, advised the community on the need to cooperate and assist the military to put an end to the insecurity of the community and the region at large.

"He assured the people of his commitment to end the herders and farmers clash and youth restiveness within the region.

The GOC he said, met with other security agencies in the council area and enjoined them not to relent on the ongoing collaborative efforts and synergy of information gathering and sharing with the military for improved security within the community and South-East."

Unuakhalu said that the GOC appreciated the incredible cooperation of other security agencies for the success achieved so far. "The GOC wishes to enjoin the good people of the South-East to support and continually provide timely, reliable and credible information through the Emergency Line '193' by pressing 2. "The Nigerian Army will continue to protect lives and property of the good people of the South-East as it carries out its constitutional roles within the ambit of the law," he added.

he Bishop, Ibadan North Anglican Diocese, Rt. Revd Williams Aladekugbe has tasked the Federal Government and the Oyo state government not abandon victims of the old Bodija, Ibadan explosion in the middle of the way.

In a statement at the weekend to symphatize with Gov Seyi Makinde, the people of Oyo State and victims of the explosion, Rt Reverend Aladekugbe called for thorough investigations into explosion

The Bishop stressed that there is the need for both the federal and state levels should ensure investigation is thorough and timely concluded and that the government should ensure that victims of the explosion are not left stranded in the middle of the way.

Lauding President Bola Tinubu and the Federal Government for providing support to the state with a vow to fishing out those behind the act, the Bishop urged residents within the immediate and external areas of the incident to see it as an opportunity to show love, care, and affection in the spirit of brotherliness and honor to God.

Rt Reverend Aladekugbe while emphasizing that the Church has before and after the incident remained committed to praving for Gov Makinde, and Ovo state, noted that despite the human and material lost,

there is still room for thanking God, adding, despite the magnitude of the blast, the level of casualty is unbelievable low, saying who would have questioned the Almighty if the fatalities had been more.

Commending Gov Makinde for the effort at providing succour to the victims as well as ensuring the impact is minimised, he prayed comfort to the families of the bereaved, speedy recovery to all victims still struggling to survive.

Rt Reverend Aladekugbe assured that the Church will not fail in its duties of praying and pleading the cause of the victims and less privileged, the Diocesan said the Church will be willing to provide the necessary support to the government and victims should the need be. A personal message sent to the governor shortly after the incident by the Bishop reads in part, "Your Excellency, greetings. This is to sympathise with your Excellency and government of Oyo State on the unfortunate incident of last night. May God comfort the families of the bereaved, grant speedy recovery to all victims still struggling to survive.

EEDC Explains Reason For South East Drop In Electricity Supply

he Enugu Electricity Distribution Company (EEDC) has hinted that current drop in electricity supply availability to its network in South-East is due to low power generation caused by gas constraint to the thermal generating companies.

Head of Communication of the organization, Mr Emeka Ezeh, said in a statement in Enugu on Saturday, that the development has resulted to low generation.

According to him, the low generation has led to reduction in the quantum of daily megawatt hour (MWH) of energy allocated to distribution companies nationwide.

He disclosed that consequently, the Transmission Company of Nigeria (TCN), which is the company's primary source of power supply, is constrained, as they only transmit what is generated and have resorted to System Load-shedding to forestall possible system collapse.

"This situation has equally impacted on

the quality of service to our customers, as we are contending with very low energy allocation wheeled to us by the TCN for distribution to our customers.

*A situation that has left us load-shedding available power to ensure it goes round. *We seek the understanding of our esteemed customers on the fact that we can only distribute what is allocated to us, and that this situation is beyond us and that it is not peculiar to EEDC," he said.

The EEDC spokesman said that the company hopes that the situation would be addressed soon so that normal distribution would return.

"EEDC is committed to providing improved services to her esteemed customers," Ezeh assured.



Police Commissioner, CP Olatoye Durusinmi who disclosed this while parading them at the command headquarters, Uyo on Friday, said criminal elements in the state have not shown repentance.

"As we strive daily to keep the state safe, criminal elements too have continued to try to penetrate their nefarious acts.

"This January alone, 79 criminal elements have been arrested for various crimes.

"The greatest achievement within the last one month is the arrest of 10 confessed kidnappers, who were planning to unleash mayhem on the state and recovery of four AK Riffles.

"On Jan. 16, 2024 about 3:45pm, operatives of Ibiono Ibom Division, relying on credible intelligence stormed I b i a k u I k o t O k u community forest, where over 15 heavily armed suspects were camping and engaged them in gun "Some of the suspects absconded with bullet wounds while four of them were arrested and one AK 47 riffle recovered.

"Swift follow up of operation by the Anti-Robbery Unit of the command led to further arrest of six suspects and the recovery of three more AK 47 riffles," Durosinmi said.

According to CP Durosinmi, the suspects were arrested for various crimes ranging from murder, kidnapping, armed robbery and cultism.

He said the suspects who came from neighbouring states to cause havoc in A k w a I b o m, h a v e confessed that they were planning and monitoring to kidnap an expatriate i n v o l v e d i n t h e construction work along Calabar-Itu Highway.

The Police Commissioner concluded that the suspects would be charged to court as soon as investigations were concluded.

He thanked the people of Akwa Ibom and solicited for cooperation and information to ensure criminal elements were arrested.

The commissioner commended other security agencies for cooperation, collaboration and support to keep Akwa Ibom safe.

NCAA Suspends Mattini Airline Services

The licence of Mattini Airline Services Limited, the private jet operator whose aircraft overshot the runway on Friday at Ibadan Airport, has been suspended by the Nigeria Civil Aviation Authority (NCAA).

The private jet overshot the runway with 10 persons onboard, while firefighters and rescue officials from the Federal Airports Authority of Nigeria (FAAN) were immediately deployed to the scene. In a statement, the NCAA declared that the licence suspension was with immediate effect, pending the outcome of investigations into the incident.

Before the incident at 11am, the Challenger CL 601 aircraft, registered as N580KR and operated by Mattini Airline Services Limited, departed from Abuja to Samuel Ladoke Akintola Airport in Ibadan.

While emphasising its commitment to ensuring the highest standards in the aviation sector, the regulatory body announced its intention to conduct a comprehensive safety and economic audit of all private jet operations in Nigeria. Michael Achimugu, the Director, Public Affairs and Consumer Protection, NCAA, issued a statement saying it enlisted the Nigerian Safety Investigation Bureau to conduct a thorough investigation into the Ibadan Airport incident.

The NCAA has initiated an economic inquiry into the aircraft's operation, specifically concerning the terms and conditions of the PNCF as detailed in its documents, while the NSIB is conducting the safety investigation.

The statement said, "In the meantime, and in accordance with Sec 32 (4) of the Civil Aviation Act 2022, the NCAA has also suspended the PNCF of Mattini Airline Services Limited with immediate effect." NCAA said it would subsist until a determination is made that the conditions of the PNCF have been adhered to, saying that NCAA has further initiated a safety and economic audit of all private jet operations in Nigeria.

NCAA, however, assured the traveling public of its utmost commitment to safety and the entrenchment of global best practices.

Alleged Cyberstalking: Court Grants Bayelsa News Blogger, Saint Mienpamo Bail

ustice Emeka Nwite of the J Federal High Court, Abuja, has granted bail to the Bayelsa based news blogger and owner of the Naija Live TV, Mr. Saint Mienpamo Onitsha.

Mr. Saint Mienpamo Onitsha, was charged to the Federal High Court, Abuja on alleged charges of Cyber stalking in suit n u m b e r FJC/ABJ/CR/492/202 3 and between the Inspector-General of Police as Complainant and Mienapamo Onitsha Saint as defendant.

He was later remanded in Kuje Correctional Centre, following his arraignment.

At the hearing on bail application, the Prosecuting Counsel,

Victor Okoye Esq, who apposed the bail application being sought, however raised doubt on the area of jumping of bail. The Defence Counsel, Benjamin A. Ogbara Esq, argued that despite the opposition put forward by the prosecution, which to him is unfounded, the court has the discretional powers to admit bail.

The presiding Judge, Justice Nwite, after listening to the submissions of the prosecuting counsel, Victor Okoye Esq and the Defence Counsel, Benjamin S.Ogbara Esq. admitted bail to Saint Mienpamo Onitsha, pending the determination



And I am granting the defendant bail in the interest of justice."

Among the conditions of bail include the payment of N10 million and two sureties and that one of the sureties shall possesses a landed property within the jurisdiction and the document to the landed property must be verified by the Deputy Registrar of the court.

"Also, the second sureties must be a responsible citizen of this country and that both counsel together with the sureties must each deposit two copies of their recent photographs with the Deputy Chief Registrar of the court " That the residence of the sureties must be verified and confirmed by the registrar of the court." Justice Emeka Nwite however, adjourned the case to March 19, 2024 for trial. It would be recalled that a Federal High Court sitting in Abuja had on November 2, 2023, ordered that the Bayelsa news blogger, Mr Mienpamo Onitsha Saint, be remanded at the Kuje Custodial Centre, over alleged defamation and cyber stalking against the Interim Administrator of

the Presidential Amnesty Programme (PAP), Major General Barry Ndiomu (Rtd).

The defendant was also accused and is standing trial on a three-count charge bordering on alleged willful libel, threat, causing danger and insult against the PAP Interim Administrator.

According to reports, when the charges were read to him at the commencement of the hearing, the accused person however, pleaded not guilty.

The charges read in part, "That you Mienpamo Onitsha Saint of Imiringi Road, Yenagoa, sometime Group that vote of no in September 2023, within the jurisdiction of this honourable court did knowingly and intentionally sent a message/post by means of computer system network via your Facebook page 'Mienpamo Onitsha Saint' that vote of no confidence on Ndiomu as Amnestv Delegate strangled to death by Ndiomu Boys in Abuja which you know to be false, for the purpose of causing annoyance, inconvenience, danger, insult, injury, criminal intimidation, ill will and

Widow Cries For Help, Accuses Late Husband's Siblings of Victimisation

37-year-old widow, Mrs **L**Chinenye Okonkwo has appealed to the Anambra State Government and human rights organisations to assist her in recovering her late husband's property from his siblings.

Chinenye during a news conference on Saturday, alleged that her late husband's siblings encroached into their land, carried the blocks for their proposed building and sent her and her five childre on exile.

She said that the Umuodilogu village kindred and the widows' organisation under Sir Emeka Offor Foundation tried to settle the matter but to no avail.

"My Late husband, Linus Okonkwo showed me the boundary of his land before his death in 2017 at age of 45. He also molded blocks for a four bedroom flat.

"But his siblings, Boniface and CY Okonkwo are trouble makers. They sent me away asking me to go remarry and they will consider my children when they are grown.

"They even threatened to kill me if they see me in the family compound. I'm currently living in a rented apartment with my kids. I'm struggling to pay both house rent and children's school fees.



"I'm appearing to the state government and wellmeaning Nigerians to help me recovering my late husband's property from

his siblings. Also speaking, Mrs Ogechi Izuka, Leader of the widows' organisation said they reported the matter to the International Federation of Women Lawyers (FIDA), Awka, and the culprits had been served papers.

"Unfortunately, our NGO, does not have the right to interfere in family affairs. There is a limit we can go. We can only resort to protest or demonstration if the matter is life threatening.

"We want both the government and members of the public to intervene to serve as deterrent to others who may be planning similar actions on other widows. We want this to be the last," she said.

In his remarks, Mr Francis Okafor, Chairman, Umuodilogu kindred, said they frown at and strongly condemn actions of the widow's brother-in-law.

"We have been trying to amicably resolve the matter in-house, but it escalated when Boniface and his team resorted to violence, the first of its kind in our kindred.

"They even threatened to kill one of our kinsman for defending the widow," he said.

Justice Emeka Nwite also stated that despite the argument put forward by the prosecution counsel on the possibility of the defendant to jump bail, "there is no concrete evidence before the court to buttress the assertion.

Revd Goodluck Bayagbon of God's Grace Ministry, Warri, delivered a message encouraging Christians to lead exemplary engineering and sports, had his promising future cut short by an alleged attack from fellow students. Despite the passage of time, the pain of Sylvester's loss remained fresh, and the family's determination echoed beyond their community. The tragedy turned into a rallying point against bullying and violence in schools, prompting a united demand for reforms.

Sylvester Oromoni Jnr, born on December 4, 2009, tragically passed away on November 30, 2021, allegedly due to torture by senior students at Dowen College, Lekki, Lagos State.

The family, dignitaries, and well-wishers gathered on Saturday, January 27, 2024, to bid farewell and mourn the untimely demise of the young scholar

Is Nigeria In Another Round Of **Olu Falae's SAP Medicine?**


ost, if not all Nigerians are of the firm belief that Finance Minister, Olu Falae's medicine of Structural Adjustment Programme (SAP), introduced during the era of military Head of State, General Ibrahim Badamasi Babangida in July 1986 is the foundation upon which the present economic crisis of the country was laid.

Undoubtedly, the IMF-World Bank economic policy packages embodied in the structural adjustment programme, SAP provided an overt encouragement to the fostering of an unregulated, dependent capitalist development model, while allowing only a supportive role for the government in a refurbished economic environment of highly reduced government ownership and control of enterprises.

Since SAP came into being, inflation has assumed a doomsday scenario from 5.4% in 1986 to 40.9% in 1989. Nigeria's annual inflation rate in November 2023 was 28.9%.

The principal price of SAP measures Nigerians are paying today, include faulty external debt management strategies, removal of subsidies on petroleum products and fertilizer, privatization and commercialization, trade liberalization, and interest rate deregulation. This SAP-induced inflation has resulted in adverse income redistribution, leading to increased personal insecurity among other evils.

The pressure by IMF and the World Bank first reared its ugly head on the Nigerian government when General Muhammadu Buhari was military head of state way back in 1984. Considering the evils associated with SAP and its likely consequences on the economy and Nigerians, the then head of state. General Muhammadu Buhari refused to adopt the IMF-World Bank economic medicine to float the Naira and other packages embedded in SAP. Much later when he was elected in 2015 and sworn into office as Nigeria's civilian President Muhammadu Buhari had expressed skepticism over decision to float the Naira in line with request of IMF and the



World Bank.

In an exclusive interview in 2016 with Al jazeera TV, Buhari did explain why he was going against the IMF and their call for him to float the Naira. Buhari knew that Nigeria would not survive another SAP.

As President, Buhari while speaking to business leaders, said that he doesn't like the returns he gets from the Central Bank of Nigeria (CBN) on the pressure to devalue the Naira against the dollar. "How much benefit can we derive from this ruthless devaluation of the Naira,? I'm not an economist neither a business man, I fail to appreciate what is the economic explanation," Buhari quickly added.

Recalling the might of the Nigerian currency in 1985, former President Buhari said, "Naira was strong until my removal in 1985".

Speaking at a meeting with members of the Council of Retired Federal Permanent Secretaries during his first tenure as President, Buhari told the high level technocrats that he resisted the pressure from the International Monetary Fund and World Bank to devalue the currency and remove fuel subsidy. He insisted that he was yet to be convinced that the vast majority of ordinary Nigerians would derive any tangible benefit from a devaluation of the naira. The president said he still held the conviction that motivated his principled resistance to devaluation in his first tenure as military Head of State. "When I was military Head of State, the IMF and the World Bank wanted us to devalue the

naira and remove petrol subsidy but I stood my grounds for the good of Nigeria.

"The naira remained strong against the dollar and other foreign currencies until I was removed from office in August, 1985 and it was devalued.

"But how many factories were built and how many jobs were

Gender Based Violence A Silent Menace Consuming Women, Children

By; AUSTINE EMMANUEL, Kaduna t has been said that, "there is no love in violence even as reasoning is weak where violence reigns." The rising cases of Sexual and Gender Based Violence, (SGBV) particularly against women and children have become a thing of serious concern in recent time.

World Health Organization (WHO) defines Sexual and Gender Based Violence (SGBV) as any sexual act, attempt to obtain a sexual act, or other act directed against a person's sexuality using coercion by any person regardless of their relationship to the victim in any setting.

WHO also refers to sexual and gender based violence as a major public and clinical health problem and a violation of women's human rights that is rooted in and perpetuates gender inequalities. WHO also noted that, globally one in three women experience physical and/or sexual violence in their lifetime, mostly by an intimate partner.

SGBV on the other hand is violence committed against a person because of his or her sex or gender. It is forcing another person to do something against his or her will through violence, coercion, threats, deception, cultural expectations, or economic means. Although the majority of victims and survivors of SGBV are girls and women, boys and men can also be harmed by SGBV, especially male children. (United Nations High Commission for Refugees, UNHCR)

Global index report also reveals a growing trend in SGBV, with rising cases recorded in times of crisis, disasters, banditry and the global 2020 COVID-19 pandemic lockdown. In 2020, approximately 47,000 women and girls were killed worldwide by their intimate partners or other family members; over 1.7 million Sexual and Gender-Based Violence (SGBV) complaints received in 2021 in Nigeria, and about 401 women lost their lives in 2022 as a result of the endemic.

SGBV can happen in both private and public spheres and it affects women disproportionately, even as it can be sexual, physical, verbal, psychological or socio-economic and it can take many forms, from verbal violence and hate speech on the internet, to rape or to



implementation of those laws as panacea to discourage perpetrators.

Over the years, many governmental and Non Governmental Organizations have lend their helping hands to see that this menace is addressed to the barest minimum. For instance, in 1996 a feminist organization BAOBA for Women's Human Rights was established to ensure that the rights of women and girls become an integral part of everyday life. We also have the International Federation of Women Lawyers, (FiDA) amongst several organisations championing the course of SGBV in other to uphold the sanctity of women and the girl child as they are more vulnerable to societal attacks.

Also, In 2016, the former Minister of the Federal Capital Territory and two term Governor of Kaduna state, Mallam Nasir el-Rufai established the first Sexual Assaults Referral Centres, (SARC) under the Ministry of Human Services and Social Development (MHSSD) located at Gwamna Awan General Hospital, Kakuri, to provide psycho-social counseling, forensic examination, medical treatment and legal services for victims of sexual assault.

The SARCs is a multi-sectoral with all the

since inception in 2016 to December, 31st 2023, with the highest figure from Kafanchan Center, at 3,420.

The Kakuri Centre, established in 2016, said that they had recorded a total of 944, while Tudun Wada and Zaria established in 2019 recorded 1177 and 1195 cases respectively. The Kafanchan Centre was also established in 2019.

Speaking extensively with the Pilot Manager, Salama Sexual Assault Referral Centre (SARC) Kafanchan, Kaduna during a courtesy visit to the Centre, Mrs. Grace Yohanna Abbin, narrated that men are also assaulted but in rare cases compare to the female folks.

In her words, Mrs Grace said, "out of the 3,420 cases recorded, 491 men were abused, while 2,949 women were assaulted by their husbands and boyfriends, out of which 98 adults were victims of rape".

She also stressed that the Kafanchan Centre in collaboration with the Ministry of Justice, Kaduna state have been able to get justice for some survivors, meanwhile the Pilot Manager lamented that some cases could not see the light of the day because they lack evidence as a result of late reporting especially cases that are related to Sexual Assaults.

thesame country but were brought back home through same intervention.

The Executive Director, BAOBAB for Women's Human Rights, Bunmi Dipo-Salami, who spoke to this reporter described women as an integral parts of the human society and had experience different types of SGBV both in the past and present.

Salami said that the endemic has a huge negative impacts on the life of women and the girl child as most of them could not get to their full potentials as a result of emotional and psychological trauma, added that going forward, BAOBAB would deepen engagement with the media, expand the Male Allies against Violence against Women and Girls (MAA-VAWG) and the Volunteer Outreach programmes to more states across the six geo-political zones.

"BAOBAB was established in 1996 and it became a legal entity in 1998. It exists to promote, protect, and defend the

rights of women and girls in Nigeria. The organisation believes that through mobilisation, advocacy and provision of access to information, women and girls would become aware of their rights and seek redress whenever those rights are violated.

"Similarly, engagement with relevant stakeholders within communities to advocate the rights of women, capacity enhancement of women and men to improve knowledge and change attitudes that are detrimental to the progress of women, as well as partnering with duty bearers and gatekeepers, including government institutions, traditional and faith leaders are essential for the elimination of discriminatory practices that hinder women and girls from actualising their full potential.

"Over the years, BAOBAB's advocacy intervention initiatives have Enabled a better understanding of the rights of women living under Muslim laws in Nigeria, ensured that men take the lead in mobilizing other men against genderbased violence with the Male Allies against Violence against Women and Girls Programme (MAA-VAWG), ensured the breaking the silence at the national level on issues of violence against women particularly on sexual violence, contributed to building an effective and stable but growing volunteer outreach team in many states across the country, improved the capacity of journalists to report cases of violence against women and girls from a gender-awae perspective, amongst other interventions." "We will sustain the momentum through constant and consistent engagement with community heads and faith leaders and deepen the engagements with state and non-state actors who have mandates that support the protection of women and girls from SGBV to ensure they continue to share best practices and strategize to overcome the challenges they encounter in the course of their intervention activities. Experts over the years, have decried the surge in the number of reported cases, particularly in Kaduna state where different measures are believed to be put in place to prevent, curb and punish offenders. Enough Of Killings In Nigeria - Ooni *Says Ekiti Obas killings by gunmen absolutely unacceptable

By; BAYOAKAMO, Ibadan oni of Ife, Oba Adeyeye Enitan Ogunwusi has declared that the killings of the two Obas in Ekiti State by gunmen is absolutely unacceptable, and that enough is enough of killings in the country. Ooni Ogunwusi in a statement by his Director of Media and Public Affairs; Otunba Moses Olafare, said it is time for government both at states and federal levels, to show practical capacity in the area of security management and operations.

The Ooni who is also the Co-Chairman, National Council Of Traditional Rulers of Nigeria (NCTRN) described the killings of two traditional rulers in Ekiti State by gunmen on Monday as "a pure sacrilege and deliberate display of criminal audacity to undermine the government's security control capacity.

" We cannot continue like this. Several of our school children are still languishing in the undetected incarceration of these heartless terrorists. A party state chairman in Lagos State was a victim recently. What about the recently abducted school children in Ekiti State? Six sisters in Abuja not too long ago, with one of them killed. Similar cases across the country. Who is safe in this country again? Enough is enough", he declared. Ooni Ogunwusi added, "The time should not be later than now for Government both at states and Federal levels to show practical capacity in the area of security management and operations".

"The traditional rulers in Nigeria must be motivated with statutory community policing policy needed to work officially with government as we remain the closest leaders to the people, we know the traditional techniques to get rid of all these unfortunate situation".

Ooni Ogunwusi stressed, " We are no cowards and we are ready to rise to the occasion defend our traditional land. Get us statutorily involved and see that what we inherited from our respective ancestors are still intact and real."

He stressed that there is the need for the federal government to expedite thorough investigations into the killings of Onimojo of Imojo-Ekiti, Oba Olatunde Samuel Olusola and Oba David Babatunde Ogunsakin, Elesun of Esun-Ekiti.

"Assassinating traditional rulers in cold blood! This is absolutely unacceptable to us. If this could happen to the traditional rulers, what would then become hopes for their common subjects who look up to them for local security interventions? This is a pure sacrilege and it is a deliberate display of criminal audacity to undermine the government's security control capacity.

" This reprehensible act has not only robbed us of noble leaders but has also left a scar on the fabric of our unity and peaceful coexistence as a nation. Government must stop at nothing to ensure the perpetrators are arrested and made to face justice"

Tasking the federal government to prioritize the establishment of community policing across the nation as the recent spate of killings and kidnappings of traditional rulers and school children across the country, the Ooni stressed that the development highlights the urgent need for a robust, community-oriented security system, saying community policing, with its emphasis on local involvement, will be helpful to enhance intelligence gathering, deter criminal activities, and ensure the safety of Nigerians.

While urging the Gov Oyebanjiled state government and President Tinubu-led Federal government to expedite thorough investigations into this barbaric act and ensure that the perpetrators face the full wrath of the law, Oba Ogunwusi commiserated with families of the deceased Monarchs, the people of Imojo-Ekiti, the people of Esun-Ekiti, the government and Ekiti State council of Obas and Chiefs,
