Rescue Mission As Zamfara Govt Begins Payment Of Backlog Of N13.4bn Gratuities

n an effort to rescue the economic situation and the people of Zamfara State the government under the leadership of Governor Dr. Dauda Lawal, has commenced the payment of the backlog of N13.4 billion in gratuities to retirees in the state.

The state government established a committee to authenticate retired civil servants' data to pay off the gratuity debt accumulated from 2011 to date.

In a statement issued on Saturday, the spokesperson of the Governor, Sulaiman Bala Idris, revealed that retirees who have been owed gratuities since 2011 have finally started receiving their payments.

The statement added that the backlog of gratuities accumulated over the years is now being cleared, and payment has commenced since Thursday.

"The state government has taken a significant step towards addressing the outstanding debt of gratuity owed to retirees, which comprises death gratuities, retirement gratuities, and contract gratuities.

"Governor Dauda Lawal set up a committee to validate and authenticate retiree data to settle the debt of gratuities that has accumulated since 2011.

"After validating the data of retired civil servants, the government discovered that the total amount owed from state and local governments is 13.4 billion Naira.

"The committee has already gone far with the authentication of data submitted by local government and state pension commission and physical verification of beneficiaries.

"Retired state and local government employees who were verified have begun receiving their gratuity payments since Thursday.

"The government would ensure that all retirees are authenticated and paid their gratuities without any difficulties.

"The Zamfara State Government is fulfilling its promise to serve the people of Zamfara by rescuing and rebuilding the state for the better."

SAfER: Oyo Govt To Disburse Additional N340.2m To 1,227 Farmers - Sheikh Akeugbagold

he Chairman, Agric Credit Corporation of Oyo State (ACCOS), Sheikh Taofeek Akeugbagold on Thursday, hinted that the state government is to commence disbursement of N340.270 million to eligible crop farmers across the seven zones of the state.

Addressing journalists on the progress of the SAfER programme, Sheikh Akeugbagold hinted that the disbursement commenced from Friday, February 9, 2024.

Sheikh Akeugbagold maintained that the project has been non-partisan as it is available for the generality of legitimate farmers and would-be farmers of the state including the youths that were trained by the state government under the YEAP programme.

According to him, in view of the present economic hardship in the country, the corporation has been given a marching order to better the lots of the peasants most importantly in the area of agriculture.

Breaking down how funds for the 4th batch will be disbursed across the various zones of Ovo State as from Friday 9th February, 2024, he said, Ibadan I would be undertaken by Bank of Agriculture. Ibadan.75.950m for 269 beneficiaries while Ibadan II would be handled by Onibuore Microfinance Bank ,N132.250m for 474 beneficiaries.

"Oyo: Bank of Agriculture, Oyo N24.50m for 87 beneficiaries. Oke-Ogun I: Ifedapo beneficiaries Microfinance, N 26.270m for 93 beneficiaries. "Oke-Ogun II: Bank of Agriculture, Iseyin, N13.450m for 53 beneficiaries", he said. Sheikh Akeugbagold

According to the House, the late Na'Abba was praised as an influential Speaker of the House of Representatives between 1999 and 2003, saying that on account of his courageous, dynamic, outspoken pursuit of legislative independence and revolutionary approach to running the House as Speaker within the period.

Madaki further explained that Na'Abba as Speaker, embarked on a number of measures to ensure the independence of the legislature, not limited to profound scrutiny of the budget framework, making robust adjustments where necessary; strengthen House Committees: fashioned out a cohesive, inclusive, mutual, thinking and participatory house; and regulate debate on the state of the nation.

Sheikh Atere stressed that all intending pilgrims who had paid the deposit of N4.5million or below as earlier announced by the board are now to complete it to the sum of №4.9million on or before Monday 12th February fixed for the deadline.

The Oyo State Pilgrims Welfare's Board (Muslim Wing) Chairman said anyone who still has an interest in making the spiritual journey with the

According to Sheikh Atere, intending pilgrims could make their payments through any of the designated bank accounts of the board.

Court Slams Life Imprisonment On 32-year Old Man For Raping Minor

nbelievable but true that a 32year-old man, Akaninyene Sunday Ekwere could find pleasure in raping a 4-yearold girl in Ikot Ibritam, Oruk Anam Council Area of Akwa Ibom State, an ugly incident that earned him life imprisonment by

Ekwere, a trader on engine oil, electrical appliances and recharge cards, reportedly lured the minor to his shop where he defiled the innocent girl, who is the last child in a family of five.

The mother of the victim discovered the bruises around her private part when she bathed her prompting her parents to report the matter to the Police.

In his confessional statement, Ekwere, who hails from Ikot Ibritam and a neighbour to the victim, said he saw the minor playing outside the compound and invited her to his shop, where he rubbed vaseline oil on her private part and raped her. In his judgment, the Judge, Nkereuwem Obot of Akwa Ibom State High Court sitting in Ikot Ibritam, Oruk Anam said Akaninyene Ekwere does not deserve to live in the midst of sane people as he is dangerous to society. Obot found the accused

guilty and sentenced him to life imprisonment. The convict who is popularly called "Doctor"

pleaded with the court to have mercy upon him as he is a married man.

Under the Violence Against Persons (Prohibition) Laws, 2020, rape carries life imprisonment in addition to the name of the victim being entered in the register of sex offenders in the state.

FGM: Over 200m Women Victims, 4.4m At Risk, UNFPA Raises Alarm

he United Nations Population Fund (UNFPA) at the weekend, alerted that more than 200 million women have undergone Female Genital Mutilation (FGM) with 4.4M women and girls at risk.

Representative of UNFPA, Madam Uzoma Ayodeji made this known while speaking at a programme to commemorate the International Day of Zero Tolerance for FGM 2024 held at the Jericho Nursing Home, Ibadan.

She stressed that there is the urgent need for stakeholders to intensify to prevent the 4.4million women and girls from being at the risk of FGM.

Madam Ayodeji stressed at the programme themed, 'Her Voice, Her Future: Investing in Survivor' that UNFPA, "is putting in more efforts towards ensuring the prevalent rate in Oyo State will decline further.

" More than 200 million women have undergone FGM and 4.4 million women and girls will be at risk if efforts aren't intensified. UNFPA is putting in more efforts to ensure the prevalent rate in Oyo State will decline further", she said.

Madam Ayodeji added, "This year's theme is investing in survival led movement to amplify the voice against FGM. We want to ensure that this shame is removed from the faces of women and girls".

The Director, Centre for C o m p r e h e n s i v e P r o m o t i o n o f Reproductive Health Prof. Oladosu Ojengbede while speaking at the programme said more importance should be placed on survivors.

Prof Ojengbede stressed, "it is the voice of the survivors that people want to hear for the benefit of people yet unborn.

"The effect of preventing FGM is part of the motivation we have to continue to do the work we are doing." he said.

Prof Ojengbede added, "It is not just to talk about it at a point in time and it ends, I hope today will be another day to reeducate the mind to support the movement against FGM".

The Chief Medical Director (CMD) of Jericho Nursing Home Ibadan, Dr Bashir Kasika said, "we have the sexual assault referral centre here and we all understand that it covers every sexual related issues including FGM."

Dr Kasika while thanking UNFPA and CCPRH for holding the event at the nursing home, stressed "our doors will always be remain open to you and every survivor whenever you are in need of us."

The programme themed 'Her Voice, Her Future: Investing in Survivor Led Movement to End FGM' is aimed at encouraging survivors of FGM to speak up to further enhance the fight against FGM in Oyo State and Nigeria at large.

he Executive Director National Animal Production Research Institute (NAPRI) Shika, Professor Abubakar Hassan has said that 70 per cent of the Institute's budget is spent on the purchase of livestock feeds.

Hassan made this known while interacting with journalists in Zaria, adding that presently, their major challenge is how price of grains is skyrocketing in the country.

He said, the institute is

working towards solving the challenges in its efforts to overcome those issues.

According to him, "livestock is one of the main transformation agenda of the food security programme of which poultry is one, small, large ruminant, diary and beef production."

He said, to meet the demands, the institute has established five out stations of which Damaturu outstation in Yobe State is for Livestock Value Chain and that of Gwada in Niger State is for poultry production.

He added that the Talatan Mafara outstation in Zamfara State is for Sokoto Gudali Cattle production and small ruminants production in Edo State and swine production outstation is in Otukpo, Benue State.

Professor Hassan said to achieve all this, more funding needs to be provided and it will assist the institute to meet the demands of the majority by at least 80 per cent.

The Executive Director added that the outstation need to improve on the existing structure because

they were old as Institute's Headquarters.

He expressed concerns, "despite farmers are now aware of how to keep livestock, but yet we are not meeting the demands that will make the prices of animal commodities to come down for people to afford it."

The Chief Executive assured that they want to expand their production of day old chicks to meet up the demands that is why the outstations were established as a replica of the NAPRI headquarters,

Frequent Changes In NDDC Board Bane Of Projects Delivery - Stakeholders

esolution reached at a two-day Retreat for B o a r d a n d Management of the Niger Delta Development Commission (NDDC), has identified the frequent changes in the Governing Board of the Commission as one of the factors accounting for the challenges in projects execution and delivery in the development of the region.

To remove the blockage, participants at the retreat called on the Federal Government to ensure the current board completes its tenure, while also advocating continuity in succeeding boards to ensure sustainability of the commission's projects.

Captured in a communique issued at the retreat which ended at the weekend in Ikot Ekpene, Akwa Ibom State, the participants identified the need for proper synergy, collaboration and coordinating framework between the Ministry of

Niger Delta Development, State Governments in the regions, the NDDC and development partners.

Noting procurement as the heart of governance and one of the government activities most vulnerable to corruption, they called the Board and Management of the NDDC to effectively discharge their responsibility to manage the Procurement process involving all stakeholders, without sacrificing the core objectives as provided under the Procurement Act.

The retreat took a cursory look into the need for the urgent release of all outstanding statutory contributions of the Federal Government to the NDDC fund, as the non-release of these funds has significantly hampered the ability of the commission to deliver on its mandate.

It also pointed out the need for some form of financial autonomy for the NDDC outside the Treasury Single Account (TSA) regime in view of the peculiar construction window of the Niger Delta region.

This autonomy is hope to encourage the process of getting the commission take advantage of traditional credit sources in completing its projects and deliver real impact and sustainable development to the long-suffering people of the region.

Given the mandate as

enshrined in the Act 2000, NDDC should establish clear, measurable, achievable, relevant and time bound (SMART) goals that the Commission would demonstrably commit to and deliver upon, fostering increased public trust.

In the same way, he leadership of the Commission have been tasked to consistently demonstrate their commitment to ethical principles, through their decisions and behavior.

It also stressed the need for

the development of key governance policies and procedures to promote clarity of roles and minimize discord on the Board, as well as defined reporting framework covering key stakeholders and transparency.

Gathered on theme, "Renewed Hope: A New Era for Vitality, Peace & Development", participants commended the 7th Governing Board and Management for the full-scale engagement of key stakeholders that the Retreat presented.

It was the first-time former Chairmen and Managing Directors of the commission were invited to be part of the Commission's Board & Management retreat.

The communique was signed by the the Chairman of the Governing Board, Mr. Chiedu Ebie and Managing Director/Chief Executive Officer, Samuel Ogbuku among others.

Katsina Govt Disburses Over N4bn Schools Improvement Grants

atsina State Government has began the disbursement of its 4,054,795, 838 billion Naira School Improvement Grants to 150 select primary schools in the state.

The event was flagged off by the state Governor, Dikko Umaru Radda at Shagumba Primary School in Batagarawa Local Government Area under a programme tagged, "Transforming Education System at State Level (TESS)". Governor Radda said the benefiting schools were selected based on certain

criteria, including level of dilapidation, number of Pupils in catchment communities close to the school and dearth of water, sanitation and hygiene facilities.

He disclosed that, School Based Management Committees (SBMCs) are responsible for utilisation and management of the funds. advising the benefiting committees to ensure judicious utilisation of the funds, for the purpose for which they are disbursed.

Governor Dikko Radda directed that, any of the recently-recruited public school teachers in the state, who rejected the initial posting, should resign his or her appointment, noting that, "this

is to allow many others waiting for the opportunity to take up the appointment."

He also directed the Ministry of Basic and Secondary Education, SUBEB Education Secretaries, and Coordinators of Zonal Education Quality Assurance, to double efforts in ensuring teachers attend their lessons promptly.

He emphasized that, any insubordination among teachers and other staff should be reported to his office and the state government would not take it lightly on any teacher that absconds from duty without any cogent reason.

Governor Dikko Umaru Radda called on education stakeholders, especially community members to ensure regular visit of their catchment schools to monitor lessons delivery and teachers attendance as well as report any incident of truancy and absenteeism of teachers.

Coordinator of TESS, Hajiya Binta Abdulmumini said their program would ensure that several Katsina out-of-school children return to school.

NDLEA Apprehends Pregnant Woman, Insurgents' Drug Supplier, 22 Others In Eight States

t least 24 suspected drug dealers and traffickers are now cooling their feet in the custody of the National Drug Law Enforcement Agency (NDLEA), amongst them, a pregnant woman and a supplier of drugs to insurgents.

The suspects were said to have been arrested during major interdictions in eight states across the country.

The drug supplier, a 42-year-old man, was said to be taking thousands of concealed opioid pills to insurgents' enclave in Banki area of Borno State, a sixmonth-pregnant lady, a mother of three children and three other women.

Their arrests led to the seizure of over 7,609 kilograms of assorted illicit drugs in Borno, Nasarawa, Anambra, the Federal Capital Territory (FCT), Kano, Ondo, Edo, and Lagos State.

The Director, Media and Advocacy of the NDLEA, Femi Babafemi made the disclosure in a statement made available to journalists yesterday.

He said, "The bulk of the seizures was made in Nasarawa State, where NDLEA operatives acting on credible intelligence on Sunday 4th February, intercepted a truck marked Lagos JJJ 64 YC conveying 367 jumbo bags of cannabis sativa weighing 4,037 kilogrammes from Akure, Ondo State to be delivered at Shabu area of Lafia, the state capital.

"Three suspects: Shuaibu Yahaya Liman, 35; Monday Audu, 33, and Linus Samuel, 42 have been arrested in connection with the seizure.

"The following day Monday 5th February, operatives in Abuja, FCT arrested the duo of Jibrin Shuaibu, 23, and Prosper Innih, 17, with 169 bags and 80 blocks of compressed cannabis sativa weighing 1,961.5kgs concealed in a truck with registration number Ogun WDE 557 XC.

"The truck was intercepted during a stop and search operation along Abaji – Abuja highway on their way from Uzeba to Dei-Dei, FCT".

In another operation by NDLEA operatives in Abuja on Tuesday 6th February 6, a suspect, Abdulhameed Dauda, 27, was arrested with 89kgs of the same psychoactive substance loaded into his truck in Owo, Ondo State to be delivered at Gwagwalada in FCT.

On the same day, operatives also intercepted another driver, Hassan Ade, 30, transporting 696.5kgs of the same substance

loaded in Idoani, Ondo State state to be delivered at Gwagwalada and Dei-Dei in FCT

A follow up operation led to the arrest of a mother of three children, Mrs. Joy Chukwuka, 42, linked with the consignment. In Ondo State, apart from the seizure of 633.5kgs of cannabis at Eleyere, Ogbese in Akure North LGA, NDLEA operatives also recovered 59 jumbo bags of same substance loaded in a truck marked GAD 287 XA heading to Northern part of the country.

According to Babafemi, detergents were sprayed on the cannabis bags ostensibly to suppress the odour of the psychoactive weed, while 192 packs of table water were loaded on top to conceal the illicit consignment.

He added that not less than 187kgs of same substance were seized by operatives at Sapele road, Benin, Edo State, while in Kano, NDLEA officers on Monday February 5, arrested 58-year-old Bashir Attahir in Bachirawa area of the state with 216,000 pills of tramadol 250mg.

"Another suspect, Ejike Moses Nmenme, 47, was nabbed the following day Tuesday 6th Feb with 25,190 capsules of tramadol and different quantities of rohypnol and codeine syrup along Emir road, Sabon Gari area of the city while the duo of Yusuf Abdullahi Musa, 35, and Yusuf Musa, 28, were nabbed at Gadar Tamburawa, with 1,000 ampoules of tramadol injection on

Thursday 8th February.

'In Borno state, a 42-year-old suspected supplier of illicit drugs to insurgents in Banki, a border region between Nigeria and Cameroon, Ahmad Mohammed was arrested by NDLEA operatives on Friday 9th February at Bama check point.

"When his luggage was searched 20,000 capsules of tramadol were recovered from him while on his way to deliver the opioid consignment in the border town. "A six-month pregnant woman,

Amarachi Akaolisa, 25, and another lady, Ifeoma Iheanyi, 21, were among six suspects arrested for dealing in illicit substances in Oraifite and Umuni-Evili, Aguleri, Anambra state.

"Others nabbed include: Okwuchukwu Chukwuka; Onyedika Ngwu; Ekene Hyginus and Nzomiwu Ikechukwu. Recovered from them were over 6 kilograms of cannabis, tramadol, diazepam and codeine syrup in raids conducted NDLEA operatives between Tuesday 6th and Thursday 8th Feb in parts of the state.

"In Lagos, two ladies: Boluwatife Adebayo and Omolade Fola Adebayo were among suspects arrested during raids in parts of the state on Saturday 10th February.

"While Ogah Sunday Adole and Boluwatife Adebayo were arrested at Agidingbi, Ikeja, in connection with 220grams of cannabis, 10.6 litres of codeine syrup, and other psychotropic substances, Omolade Fola Adebayo was nabbed at Ijesha with various quantities of cannabis, codeine syrup, rohypnol and molly", the statement further read.

The anti-narcotic agency's spokesperson disclosed that Commands across the country balanced their drug supply reduction operations with War Against Drug Abuse (WADA), advocacy campaigns to schools, markets, worship centres and communities.

Over 10,000 Northerners Lose Sources Of Income As Enugu Govt Demolishes Ugwuoba Cattle Market

- Traders lament only one day notice was given before demolition
- Insist market developed with personal resources

raders operating at Ugwuoba Cattle Market, KM 54/55 Enugu-Onitsha Express Way, Ugwuoba, Oji-River LGA, Enugu State are lamenting losses, following the demolition of the business environment by the Enugu State Government.

This is as they alleged that over 10,000 traders of Northern extraction doing business at the market have lost their sources of livelihood.

The demolition of the market, said to have been established in 1995 by Cattle Dealers And Butchers, New Nigerian was reliably informed, took place on Saturday February 10, 2024 after only two days notice was handed down to the businessmen.

Among the people said to have established the market, are, Alhaji Buba Garba Dankasa (Sarkin Zango), Cattle Dealer, and Abubakar Saleh (Sarkin Pawa), Butcher.

Garke Ungoba Market, also known as Enugu Market, is one of the prominent markets in Nigeria.

It is located in the city of Enugu, which is in the South Eastern part of the country. The market has a rich history that dates back many years.

The market has been a vital hub for trade and commerce in the region for centuries. It has served as a place where people from different communities come together to buy and sell goods, exchange ideas, and interact with one another.

Over time, the market has evolved and grown to become a major economic center in the region. It has played a crucial role in the development of Enugu and has contributed significantly to the local economy.

Meanwhile, a memo written by concerned stakeholders ahead of the demolition, reads, "It's sad to announce

to you today that Enugu State Government wants to demolish this historical market where more than 10,000 individuals are feeding their families and the majority of the community living there and making business are Hausa people, and this incident comes along without any notice or notification to vacate from the premises and the demolition is set to take on Saturday 11th of Feb. 2024,

"We are appealing to our core northerners who have been trying to see they make difference in the lives of those who are not strong enough to fight this injustice.

"It's with this we calling on the humanitarian general, Sen Engr Rabiu Musa Kwankwaso to please come for our rescue as it's his habit to see he makes this difference into humans life."

Meanwhile, traders of the Ugwuoba Cattle Market and natives of the locality were said to have cried out to the state government over the activities of criminals and illicit drug dealers in the market and environs.

They however, heaped the blame on the huge number of shanties and local lodges that houses criminal elements, prostitutes, and dealers in illicit drugs s u c h a s I n d i a n h e m p a n d methamphetamine (Mkpuru mmiri) on indiscriminate allocation/sale of lands to strangers by some indigenes of the area.

The traders and natives made the call while speaking with newsmen at the weekend, over claims that the market might be a hibernating ground for criminals, who operate in Enugu and Anambra states.

Chairman of the Cattle Market, Abubakar Sadiq, identified illicit drugs and prostitution as major issues in the

stabbing each other to death under the influence of drugs.

'Most of these people are taking 'Mkpurummuri'. After taking that substance, they ended up fighting. Unfortunately one of them died.

"On 20th November, Umar Garba Yakubu, under the influence of drugs, stabbed Safiu Mohammed from Taraba State to death. Safiu's people wanted to retaliate, but with the intervention of the executives and the police, we arrested the situation and Umar was arrested and handed over to the Criminal Investigation Department (CID) of the Police. He is in jail now.

"Another one happened on 4th December when one Yusuf Adamu from Gombe State was stabbed by a person that I don't know his name.

"But with the help of security, we arrested him and handed him over to the security operatives. That one was also under the influence of drugs too.

"The major problem causing insecurity here is drugs. They transact in and take drugs here. So that is the cause of insecurity in this place.

"Aside from that, we have some areas that accommodate criminals. This is at the extension of the market. The market is too large. There are places where they sell alcohol and prostitutes are there too. These attract criminals.

" I could remember the last time there were people who kidnapped someone in Anambra State, but they came and hid here. Those places are under Gariki, but we (the executive) don't have control over them because the land was given to them by the indigenes.

"Each time we complain to them, they tell us that it is their land and that we cannot tell them what to do with their land. But in the eye of the government, everywhere here is Gariki,"

Vice Chairman of Ugwuoba Cattle

Market and an indigene of the town, Shedrach Ezeani, also collaborated on the issues raised by Sadiq.

"I represent the Amachala family, owners of this place, in the Gariki executives. We are here working together with the executives and the market authorities.

"The issues we have in terms of security is that there are too many hoodlums around this Gariki. Our chairman tried many times, through the local government, to at least reduce them. But people from outside Ugwuoba come in and reside by the side of this market. That is the problem we are facing here.

"From 2004 we used to collect rent around Gariki suburb, not the main Gariki. We didn't have problems then.

"But some years later, some boys said they don't want family owners of the land to collect the rent and they said let every individual manage his own portion of land. So, many started giving portions of land to unknown persons. From then, hoodlums gathered around there.

"Government should come in because the Gariki Market does not have the capacity to do this. If you ask anybody, he will tell you that this is my father's portion of land. Those shanties and unregulated lodges are not doing good for this place.

According to him, "people hide there in the name of Gariki and do all sorts of things. They invite lodgers from unknown destinations. Criminals will join them to lodge. That is the problem we are having. The government has to take action and control them,"

When contacted, the state Commissioner for information, Aka Eze Aka, said he was not disposed to talking to our correspondent on the issie, saying "i am not in the condition of talking to you now please" he said.

AYCF Tasks EFCC On Fairness, Professionalism

he Arewa Youth Consultative Forum (AYCF) has said that it has closely observed the events unfolding in Kogi State since the inception of the current administration and noted with utter perplexity and concern, the unrelenting disturbances created by certain interest groups, specifically the continued persecution of former governor Yahaya Bello.

It also averred that the embers of this persistent intimidation and harassment of the former governor were ignited and incessantly fanned by the Economic and Financial Crimes Commission (EFCC), under the pretext of conducting a fictitious investigation into unsubstantiated and baseless allegations against him.

In a statement issued by the President General of the forum, Alhaji Yerima Shettima, he said, the forum finds these actions wholly unacceptable and called on the EFCC to act in a fair and unbiased manner.

He posited however, that the AYCF believes that there is a limit to such tolerance, stressing that matters have now reached a point where silence becomes complicity and inaction is no longer an option, adding that the forum is compelled to caution the EFCC to be more professional and unbiased in the discharge of its functions.

"We urge the EFCC to eschew the temptation of serving the dubious political interests of some unscrupulous power mongers. It is essential for the EFCC to regain its credibility and adhere to the principles of fairness, justice, and integrity in all its dealings.

"The AYCF believes in the principle of the rule of law and expects that individuals, regardless of their political affiliations, should be treated with respect and given a fair opportunity to defend themselves against any allegations. It is in the interest of justice and the preservation of fundamental human rights that we call on the EFCC to conduct its investigations in a fair and unbiased manner". Shettima restated the commitment of AYCF to fostering peace and unity in Northern Nigeria and therefore called on all stakeholders to support the AYCF's stance in urging the EFCC to embrace fairness and professionalism in the discharge of its responsibilities.

Extortion Is A Criminal Offence, Gombe CP Warns Officers

*Says those found wanting will face wrath of law

he Gombe State Commissioner of Police, Hayatu Usman has warned his officers to desist from extorting innocent civilians.

CP gave the warning during his farmilarisation visit to Nafada and Bajoga Police divisional headquarters, saying it is important for officers to maintain high standard and professionalism.

He said it is part of his duty to go round all the divisions to see for himself, the level of their commitment, more especially in the area of community policing.

In Nafada Division, the commissioner urged police officers not to take sides in the forthcoming local government election, saying their duty is to protect the lives and property and also to make sure there's security.

According to him, from the reports received from the DPO, Nafada is safe and crime free, charging them not to relent on efforts, thereby giving room for hoodlums that will use the opportunity to cause problem.

He explained that the acute shortage of manpower is all over, but assured of looking into the matter, adding that when the recent recruitment is concluded, more officers would be posted to the command to bridge the

He added the shortage of manpower will not deter them, since they have cordial working relationship with hunters, vigilante and the PCRC.

He said that the synergy and good working relationship between Police, and sister agencies is commendable, calling on them to maintain same. In his remarks, the PCRC Chairman of Nafada Local Government Area, Umar Muhammad Baraya, said that in Nafada, they have no problem because they assisted the police who worked closely and commended the Area Commander Bajoga, ACP A.S Giade and the DPO for their kind support.

At the emirate, the Emir of Nafada, Muhammad Dadum Hamza appealed to the commissioner for Police outposts in Barwo Wunde, Barwo Nasarawo and Guduku, saying that Nafada has eight districts and they have inadequate police officers.

The royal father also requested for the rehabilitation of Police barracks to accommodate more officers when posted to Nafada, adding that the barracks were blown up by Boko Haram nine years ago.

He also charged hunters and vigilante not to take laws into their hands, but after apprehending suspects, they should take them to the police and even the police has no power to flout laws, but it is the duty of the court, explaining that the police is only to investigate and charge suspects to court.

Alhaji Yakubu Mohammad Kwairanga the 4th, commended the Commissioner of Police for promoting community policing that has brought everybody close to the police.

Kwairanga promised to give maximum support and work together with the police, while appealing to the commissioner for additional police officers to safeguards them from kidnappers.

Responding, CP Hayatu Usman said that with the police officers on ground and hunters that assist them, he assured the emir that they will be protected.

Bodija Explosion: Three Persons Arrested To Face Prosecution - Oyo Govt

he Special Adviser on Security to Governor Seyi Makinde, CP Fatai Owoseni (rtd) has disclosed that Oyo State Government is to prosecute three persons in connection with the Bodija explosion.

CP Owoseni (rtd) said this on Tuesday, while addressing a press conference at the Governor's Office shortly after the presentation of the report on Bodija explosion to the Oyo state government.

According to CP Owoseni (rtd), the three persons have been identified in connection with the cause of the unfortunate incident and that the identified persons will face prosecution based on the investigation carried out.

He pointed out that Oyo State Government would bring the perpetrators to book, adding that the government would check on the immigration status of all the people of interest since a majority of them are from Mali.

"We have been able to report that the swiftness with which security was deployed to the epicentre had so far successfully made the state to fully secure the environment", he said.

The Special Adviser added, " And with the security that was provided, the state has also been able to prevent untoward happenings, especially opportunistic crimes that hoodlums always take advantage of such situations to carry out". "We would recall that an emergency situation centre was put in place by the governor, and was located at the premises of Oyo State Housing Corporation, Ibadan".

CP Owoseni (rtd) maintained, "The EOC has so far collated information, data of things that happened there and some of the data collated include census of the respective houses and the fatalities that were affected including the extent of losses suffered".

"As of 6 p.m. on Friday, 3rd of February, which was the 18th day of the incident, a total of 335 affected persons registered at the emergency situation centre including 16 companies or business operators, churches,

mosques, three schools and the UCH also approached the centre to report on their losses".

CP Owoseni (rtd) stated that the street where the explosion happened " is Aderinola Street and not Dejo Oyelese Street, as earlier widely reported, adding that the epicentre of the tragedy is No. 8A and No. 8B".

The Special Adviser emphasized that the losses reported also include " fatality, injuries of various degrees, damages ranging from total collapse and submerging of houses, houses that suffered collateral damage and the ones that suffered minimal damages."

Speaking further, CP Owoseni (rtd)

stated that the character of the explosive is known as "Water Gel Type Based Explosive" and that the explosion was triggered by an electric spark and that a Closed Circuit Television in one of the affected houses gave footage of how the incident happened.

Also speaking, the Head of the Emergency Operation Centre, Prof. Temitope Alonge, said 80 victims in total were managed across various hospitals following the incident but that only five patients are on admission as of the time of the press conference, and that four of the patients are being treated at the University College Hospital (UCH) and are at various levels of recovery, while one patient is at the Redeemers Hospital being managed for a spinal cord injury.

Stressing that most of the cases at UCH will likely be discharged within the next one week, Prof Alonge said that some of the affected victims that experienced medical disorder such as respiratory illness had been treated, while those with symptoms suggestive of Post Traumatic Stress Disorder are being attended to by clinical psychologists from UCH, led by Mrs. Funmi Olowa.

The report, which comprises findings of the Medical, Security and Engineering Teams, was submitted to the governor on Tuesday, at the Executive Chamber of the Governor's Office, Secretariat, Agodi, Ibadan.

Power, Chief A debayo Adelabu in conjunction with the Ministry of Petroleum Resources (Gas) has set up a ministerial committee towards resolving the crisis in the nation's power sector.

The committee will c o n s i s t o f representatives from the two ministries, gas suppliers, the Nigeria Electricity Regulatory Commission (NERC) and stakeholders in the electricity value chain sector.

Speaking on Thursday at a meeting with foreign development partners operating in the country, Chief Adelabu s a i d F e d e r a l government with its transformation master plan under the power ministry will improve power supply across the nooks and crannies of Nigeria.

" When we resumed here, we spent the first

three months to diagnose and investigate issues that have affected development in the power sector and why the sector is still at the level it is today and the factors militating against the turnaround that is envisaged in the sector", he said.

Chief Adelabu added, "We consulted, we engaged all the stakeholders. At the end of the diagnosis and investigation, we had a full understanding of the situation.

"We discovered that most of the problems in the sector are not all technical or engineering-related, it actually has to do with liquidity, funding, structural or operational issues which anybody, that has the commitment, could resolve".

The Minister stressed further, "Though they are simple issues, they are in multiples, complicated and permeates all the sectors

in the value chain.

"We met as a team to provide practical solutions and came up with a timing template on those issues that can be resolved in the short term, mid term and those that can be resolved on the long haul and we capped these activities up in December, last year when we had a ministerial retreat where we had the various stakeholders, cutting across the value chain, in attendance".

The minister maintained, "We had serious discussions that lasted three days where we came up with what we have to do. We are focused on providing workable solutions to the various issues."

Emphasizing that the main problem of the sector is liquidity and funding, the Minister noted that the sector " is supposed to generate - funding if allowed to operate a commercial model whereby all the costs attributed to generation of power,

transmission and distribution of power are recovered through the tariff while the operators are given a good mark up.

" All which leads to a cost reflective tariff which is how the sector is supposed to operate. With this, there would be sustainability of the sector. There would be c o n t i n u i t y i n p r o d u c t i o n, transmission would be s e a m l e s s w h i l e distribution would be impeccable".

Stressing that the sector is not allowed to charge cost reflective tariff, Chief Adelabu said, "Government promised subsidy which is not a problem, but that is when government does its own part with timely release of money."

Governorship Candidate Laments Religious Politics In Plateau

he governorship candidate of the All Progressive Congress (APC), in the 2023 election in Plateau state, Nentawe Yilwatda, has blasted politicians for taking advantage of religion to achieve their political gains in the state. In 2003, he stated that David Jang was tagged as an Islamic candidate when he was in the ANPP, stressing that the same thing happened to Pauline Tallen in 2011 when she contested for the governorship.

He added that in 2015, the same thing happened to Simon Lalong and the same thing happened to him in 2023, saying that it is the normal culture of Plateau politics that some people must tag somebody to have an Islamic outlook just for political reasons.

Once politics is over, he explained that that person becomes a saint, observing that the politics of Plateau State carry the same pattern.

The funny aspect, according to him is that people are not wise enough to understand that some people are using politics to ensure that a good candidate doesn't emerge, adding that they used religion as a basis for presenting their candidates to the public.

He said that he had accepts the Supreme Court's judgment in good faith, describing it as the will of God.

Preliminary investigations revealed that the victims were kidnapped on February 6, 2024 from their village at Masuku in Shiroro Local Government Area of Niger State.

The victims were rendered medical attention by medical team of the Division and reunited with their families.

The General Officer Commanding 1 Division NA and Force Commander Operation WHIRL PUNCH, Maj Gen Valentine Okoro commended the troops for success.

Ebonyi: FGM Practices Reduced Drastically In Afikpo LGA - Opinion Leaders

*Say offenders are liable to pay fine

*Allege Nurses Involvement In FGM Practices

Pollowing the long time education and enlightenment against Female Genital Mutilation (FGM) in Afikpo LGA of Ebonyi State, stakeholders in the area have expressed satisfaction over the drastic reduction in the practice of FGM in the area, saying that offenders are liable to pay fine if found guilty.

They also alleged that some nurses are also encouraging the practice but the age-grade system and NGOs are monitoring their activities to stop any form of abuse.

In an interview with the women coordinator of FGM in Afikpo LGA of Ebonyi State, Mrs. Chinyere Okogwu, explained that FGM practices in the area has been reduced drastically from over 70% to less than 20% as a result of the efforts and support from religious institutions (Christian and Traditional) to stop the obnoxious practices because of its harmful nature to human health.

According to the women leader, the religious institutions have played significant roles to stop FGM practices across the communities in Afikpo LGA.

Mrs. Okogwu further explained that, in an effort to stop FGM completely, the traditional institution more especially the age-grade system have placed a fine of fifty thousand Naira against anybody caught in the practice, adding that there has been sensitization campaign, workshops, rallies to churches, markets, and other public places to create awareness for people to know the negative effects.

She also noted that the Christian religious leaders have also done a lot to support the fight by checkmating such practices during child dedication to know wether the baby is cut or not, and also telling the members about the consequences over the baby.

She alleged that there are still pockets of such practices being carried out and supported by nurses secretly in some health centres, but the age-grade system and stakeholders are currently monitoring their activities.

'After the open declaration to stop FGM in 2019, at Afikpo Local Government Area, there are still few cases of such practices. FGM is almost off, we have few or minimal cases. But generally, female



genital mutilation has been reduced "The problem we have now, is the health drastically in our LGA. "The problem we have now, is the health facilities; the traditional birthday

"Before now, we used to have up to 70% cases of FGM but now, you can't get up to 20% of it in our localities. The religious institutions are cooperating with us because we work extensively with them. The religious leaders (Christians) are also monitoring the female babies brought for child dedication, and if any of them is cut, the parents will be sanctioned.

"They have church committees responsible for that in various denominations. Indeed, they are really cooperating. For the traditional institution, the age grade system in Afikpo have a law prohibiting such practices and anybody found guilty is liable to pay fifty thousand Naira. The women wing of this age grade, are also fully involved in sensitization campaign against FGM.

"The problem we have now, is the health facilities; the traditional birthday attendants are no longer practicing FGM. It is the nurses that are trying to encourage it and the age grade system has started visiting health facilities to checkmate what they are doing."

Also speaking, the President General of Ohaisu Community Development Association, Dr.Jaspa Okoro said that there is a standing law by the House of Assembly which prohibits FGM practices in Ebonyi State, noting that certain measures of punishment are outlined against offenders.

"Series of NGOs have been coming to Afikpo to engage community leaders with workshop and seminars on how to stop FGM.

'Some who indulged in such practices said they don't want their female children

to be wayward and promiscuous and that it has been an age-long practice from their great grand parents and can't be changed like that.

"The people are responding to the campaigns against FGM, but some people in rural areas are still finding it difficult. We have government and mission hospitals mostly in our town but at the rural areas, the people are still patronizing traditional birth attendants.

"Presently, 50% achievements have been recorded. It is a gradual process, it will soon faceoff."

He also advised the people to abstain from such practices in order to have sound health more especially for their female children.

Responding, the traditional ruler of the area, HRH Ezeogo Ewa Elechi, said in the past 12 years under his watch, a lot has been done to stop FGM in Afikpo LGA

He noted that both government and NGOs have carried out sensitization campaign, workshops and seminars to educate they people on the dangers of such practices.

He expressed satisfaction over the improvement in the healthcare system, saying that open declarations have been done where many people denounced such practice.

"A lot has been done to stop FGM in the past 12 years in Afikpo LGA because rallies, demonstrations, sensitization, among others have been done to this effect. Open declarations have been carried out in an open field where the practitioners surrendered.

"The campaign against FGM is a continuous process because it may not stop at once. FGM is a bad practice which started long ago, but is gradually reducing because of the efforts put in place to stop it. I am happy that our healthcare system is also improving and more medical attention are being giving to they people.

"Those indulged in such practices said they don't want their female children to be promiscuous, but today, they have retraced their steps.

"Presently, they are responding to the continued education and enlightenment; they have become powerful tools to stop FGM," he said.

Ganduje's Emirates Should Be Abolished

hen the British conquered Nigeria, they appropriated the Emirate institution and used it to rule the people. Most of the Emirate dynasties of the Sokoto Caliphate across northern Nigeria were about a century old at the time of the British conquest. Their legitimacy was based on the Jihad led by Shehu Usman Danfodio and his followers from 1804 to 1807.

In Kano, the Sullubawan Dabo Dynasty was founded in 1819 when Sarkin Kano Ibrahim Dabo, their patriarch ascended the throne. The dynasty survived a civil war that was fought between 1893 and 1894. Yusufawa faction, were the victors and the Tukurawa led by Sarkin Kano Tukur (1893-1894) were vanquished.

Galadima Yusuf was the leader of the Yusufawa. He died in Garko before the victory but he bequeathed that Aliyu Babba should succeed him. And Alu as he was popularly known became Sarkin Kano (1894-1903). Galadima Yusuf is the great great-grandfather of Governor Abba Kabir Yusuf.

During the colonial rule 1903 to 1960 the British retained the dynasties in most of the Emirates and Kano was one of them. In the last two hundred years, three individuals posed the greatest threat to Sullubawan Dabo Dynasty two colonial officers: Palmer and Cargill and Governor Abdullahi Umar Ganduje (2015-2023).

Palmer changed the dynasty in Daura and he also threatened the Sullubawan Dabo when his subordinate Cargill was the Resident of Kano Province. Fortunately for the dynasty, Temple became the Resident and he reversed the trajectory in favor of Sarkin Kano Abbas (1903-1919). One hundred years later Governor Ganduje, the son of a Village Head, by identity a lower aristocrat and client of the Yolawa Clan decided to delegitimize the Sullubawan Dabo Dynasty. He subjected its authority to positive law.


Governor Ganduje used the State Assembly to enact a Law that repudiated the pre-colonial claim of the Sullubawan Dabo Dynasty. This dynasty was established as a result of the Jihad of the followers of Shehu Usman Danfodio.

He used the Kano Emirates Law to create new Emirates and Dynasties from the Kano Emirate established by the Jihad of Shehu Usman Danfodio. The Law even appointed Kingmakers for the five new Emirates it created. Therefore Governor Ganduje is pretending to be Danfodio II. But are his actions legitimate based on the Constitution of the Federal Republic of Nigeria?

Emirates and other traditional institutions are claims by those who inherited the precolonial institutions. It was based on those claims that the colonialists used the Emirs and bequeathed them to the Nigerian State. They are regulated by customs of the people. Their authority is vested on families or dynasties. The Nigerian State continued to recognize such authority. Nigeria became a Republic in 1963 when it ceased to be under the Sovereignty of Her Majesty the Queen.

A Republic cannot create a monarchy. Therefore no component of the Nigerian State can create one as Governor Ganduje did with his creation of five Emirates.

Governor Ganduje (2015-2023) decided



to create five Emirates in Kano State when he signed Kano Emirates Law 2019, amended it 2020 and amended it again 2023. This is a clear indication of the lack of comprehension of the Emirate traditions. The Principal Law and its subsequent amendments violate the Constitution of the Federal Republic of Nigeria 1999 as amended. This is because they bestow privileges based on birth by restricting certain public offices to some families and denying other citizens the right to aspire for such offices. No one has the right to restrict any public office established by positive law to any families. This is an act of denial of fundamental human rights of citizens to aspire for any public office.

Chapter II of the Constitution Section 17 clearly states that "(2) In furtherance of the social order- (a) every citizen shall have equality of rights, obligations and opportunities before the Law;". Ganduje's Law established Emirs and Kingmakers as public officers it is in clear violation of this section of the Constitution because it restricted the offices to a few families or descendants of few individuals.

This law also violates Section 42: "(2) No citizen of Nigeria shall be subjected to any disability or deprivation merely by reason of the circumstance of his birth". This Law denies other citizens the right to become Emirs or Kingmakers because of birth status since they are not privileged descendants of those pronounced by the law.

The Kano State Emirates Council Law also violates the Sarauta customs of Kano. Section 4 of the Kano State Emirates Council (Amendment No. 2) Law 2023; "(50) The Descendants of Sarkin Gaya Abubakar Sayyadi, Sarkin Rano Isau and Sarkin Karaye Sulaiman Nadoji are the only persons eligible to be appointed Emirs of Gaya, Rano and Karaye in case of any available vacancy".

As stated earlier, the Emirate owes its legitimacy to the Jihad of the followers of Shehu Usman Danfodio. The Emirs of Kano appointed the persons mentioned in this after the Jihad because of the support of their various clans to the Jihad campaigns and the Emirate institution. But they were not the only ones appointed to the position of Chiefship of their areas.

In fact the Jobawa, Jallubawa and Yalligawa Clans led by Mallam Bakatsine, Mallam Salihu Dattuwa (a student of Shehu Danfodio with the same status as Shehu Abdullahi, Shehu Muhammad Bello and Gidado Dan Laima) and Salihu Dan Lawan respectively liberated Gaya. They appointed Muhammadu Hatsahir of the Zakirawa Clan and he reigned for twenty-eight years (1809-1827) and was succeeded by

Ahmadu BaHodiye of the Torankawa Clan during the reign of Sarkin Kano Ibrahim Dabo (1819-1846), who also appointed Abubakar Sayyadi (1827-1844) from the Kurawa Clan.

Out of the fourteen 19th century Chiefs of Gaya only three belonged to the Kurawa Clan, the Shirawa had four, Zakirawa one, Torankawa one, Jobawa one, Barebari one and Fulanin Kila one. So on what basis did the Kano Emirates Council Law restrict the Emirship it created? This certainly has no precedence in Kano Sarauta custom.

Karaye tradition gives good explanation for the appointment of Chiefs from different clans. According to the History of Karaye written before the creation of Ganduje's Emirates: "It is claimed by (Kadiri 1971) that the impact of the political strategy of succession developed by the leaders in Kano known as "the Doctrine of Shigege" was interesting in Karaye since none of the first four Fulani rulers in Karaye was succeeded by either his son or kinsman.

These four rulers of Karaye under Fulani dispensation were Nadoje, Kyecca, Tabari and Kwasallo". This trend of alternation continued up to the post-colonial period, when Sarkin Karaye Abubakar II (1981-1998) from the Torankawa Clan succeeded Sarkin Karaye Abubakar (1969-1981) from the Sullubawa Clan (see Ibrahim Garba Karaye and Philip James Shea History of Karaye ABU Press 2013, pp. 73 and 112-124). So why did Ganduje's Emirate Law restrict its Karaye Emirship to only one lineage?

The Kano Emirates Council Law (Amendment Law 2020, fifth schedule section 9 (2) (g) 1) created offices of Kingmakers and assigned them to descendants of individuals violating Kano Sarauta customs, which were reformed by the Jihadists in the 19th century. Only the position of Sarkin Bai remained in one lineage since the Jihad, that of Mallam Dabo Dambazau. Mallam Abdurrahman Goshi and Mallam Jibril were leaders of the Yolawa Clan and their descendants have never been separated until the law signed by Governor Ganduje whose ancestors were clients of the Yolawa.

In the case of Jobawa and the title of Makama no one has ever separated the descendants of Mallam Bakatsine, Mallam Saidu and Mallama Habiba they all held the title before the law signed by Governor Ganduje. So what is the purpose of that law if not to cause acrimony within closely interrelated families.

Sarauta like any other aristocratic tradition has hierarchies. In Kano Sarauta since the 19th century the Sullabawan Dabo lineage is the royalty followed by Hakimai or titled chiefs who are the nobility. The village heads and territorial chiefs belong to the vassalage class. The official biographer of Sarkin Kano Alhaji Ado Bayero made this distinction: "But even within the sarakuna or ruling class there were gradations. Two sub-classes were distinguishable. The first was what, for lack of a better term, one would call the higher aristocracy. This comprised members of the royal family, those of hakimai and other important titled officials who dealt directly with the Emir. The second was the lower aristocracy, comprising members of the families of village and ward heads" (Omar Faruk Ibrahim Prince of the Times: Ado Bayero and the Transformation of Emiral Authority in Kano Africa World Press 2001 pp. 206).

The late Sarkin Rano in the book he wrote before his elevation to Emirship in 2019 confirmed the loyalty of Rano chiefs to Sullubawan Dabo (See Tafida Abubakar Ila History of Rano Sahato Press not dated pp. 28-29). Even the nobility and the vassalage have hierarchies. In the 19th century Emirate the precedence or hierarchy was as follows: Galadima, Madaki, Wambai, Alkali, Makama, Sarkin Dawaki Mai Tuta, Sarkin Bai, Ciroma and Dan Iya followed by others. For the vassalage, "their rank order and official designations were as follows: Sarkin Jahun, Sarkin Bebeji, Sarkin Fulanin Sankara, Sarkin Shanono, Sarkin Kunci, Sarkin Dambatta, Sarkin Rano, Sarkin Dutse, Sarkin Gaya, Sarkin Karaye, Sarkin Birnin Kudu and Sarkin Fulanin Jaidanawa" (see Adamu Mohammed Fika Kano Civil War and the British Over-rule Oxford University Press 1978 p. 53).

Governor Abdullahi Umar Ganduje through the Kano State Emirates Council Law created Emirates and designated descendants of inferior aristocrats as Emirs. But this was not all. He compelled descendants of nobles to pay homage and be subordinated to these inferior aristocrats using State instruments of intimidation and coercion thus violating the Sarauta custom. For example Makaman Kano who was number six in Kano Sarauta hierarchy, was subjected to humiliation by subordinating him to Sarkin Gaya who was number 46 before the creation of the new Emirates.

Ganduje's Emirates should be abolished because their creation violates both the Constitution and the Sarauta custom. Kano Sarauta should revert to 2019 before this law. It should continuously negotiate its status based on the reformed traditions of the 19th century for claimants as agreed since the colonial conquest. Using Positive Law to regulate Sarauta is a recipe for abolishing Sullubawan Dabo Dynasty as the Kano Emirates Council Law clear demonstrates.

Bukar Abba Ibrahim: The Man Who Touched My Life (1)

"He had a good heart, see where he died."

"To live in hearts we leave behind is not to die." - Thomas Campbell

Solution Daga Allah sai talaka," (meaning service to the poor after that to God) was his campaign slogan. Bukar Abba Ibrahim was a man whose life was spent in service to the people. This was reflected more in his method of governance that was skewed towards empowering the people.

When Yobe State was created in 1991, the state itself was rural and Damaturu, the state capital, was not better than a big village.

Elected on the platform of the Social Democratic Party (SDP), he became the state's first democratically elected governor and was in office between January 1992 and November 1993 when the late General Sani Abacha sacked the democratic contraption of that time. He came back, though, in 1999 where he served for two terms under the flag of the All Peoples Party (APP).

A first-class brain and an excellent quantity surveyor graduate of the prestigious ABU, Zaria, he was a one-time commissioner of works in the old Borno State. He deployed his knowledge and administrative acumen to build structures in the young state of Yobe.

With a style of leadership that can be defined as laissez-faire, he allowed his appointees freedom to make decisions, believing that those invested with responsibility must be responsible people.

Through this method, he built over three thousand houses that accommodated both public and private sector workers, as well as roads, schools, hospitals, clinics and factories that bring in revenue to the state.

Amongst his projects spread across the state are the Yobe Flour Mills Company, Potiskum; Fertilizer Company, Gujba; Printing Press, Damaturu; Polythene/Sacks Industry, Damaturu; Dofarga Spring Water Company, Gulani, and a modern abattoir in Damaturu.

Others are the Yobe State University; School of Nursing, Damaturu; College of Health Sciences, Nguru; College of Legal and Islamic Studies, Nguru; Yobe State Polytechnic, Geidam; College of Agriculture, Gujba, and the Yobe Mosque and Islamic Centre (Mosque and School), Damaturu.

No wonder many call him the father of modern Yobe.

However, Bukar Abba will be remembered for his simplicity and humility, and his love for people.

He was never one to shun a person who sought his audience regardless of that person's low standing in society. It was not uncommon to see him discussing heartily with beggars, invalids or the physically challenged. Whoever he interacted with came out with their dignity intact because of the rapt attention he accorded them.

Perhaps, this was a result of his guiding principle of life, being an avowed welfarist who had Malam Aminu Kano as his ideal. He not only had a son named after him, but till he died he wore the dara (Aminu Kano's type of red cap).

Many people got the surprises of their lives when they saw him in events they deemed beneath their status to grace. He would be seen in the house of the lowest of commoners, if invited, for a wedding or naming ceremony. And he was equally at home with the haves as he was with the have-nots.

In 1999, his first official outing was to our house at Ben Kalio, in Damaturu, to attend the wedding Fatiha of my younger sister, Ya Aisa, named after the mother of the late Baba Shehuri, a great friend of our late father.

He had great respect for our father, the late Alhaji Sulaiman Gimba Ahmed, who died on 8 January 2013. This made the late Emir of Fika, His Royal Highness Alhaji Abali Ibn Muhammadu Idrissa, delegate him to go to the governor and intercede on behalf of his people.

The Bolawa were seen as die-hard Peoples Democratic Party adherents because of their notable sons, the late Malam Adamu Ciroma and Adamu Maina Waziri, who were founders and torchbearers of the party. In any case, the Bolewa, except for recently, had always been politically centrist. They were with the late Sardauna of Sokoto's Northern Peoples Congress (NPC) and later with the National Party of Nigeria (NPN).

And so some influential people in Bukar's government started posting the Bolewa civil servants to the state's equivalent of Siberia, which necessitated the late Emir to send our late father, who was at Government College, Maiduguri, earlier than the governor, to him for a truce. And everything normalised thereafter.

During his tenure as governor, especially between 1999 and 2007, his main running mate, to borrow from the late Governor of Kano, Sabo Bakin Zuwo, was Adamu Maina Waziri, a prince of Fika and doyen of the Peoples Democratic Party (PDP) in the state.

The late Bakin Zuwo had a running battle with the late Abubakar Rimi as they belonged to two different factions of Malam Aminu Kano's Peoples Redemption Party (PRP). And when Zuwo was contesting for the governorship of Kano and was asked by pressmen who his running mate was, he

mistook that for a competitor, like someone he was running a 100-metre dash against. He quipped, "It is that boy, Abubakar Rimi."

I recall a day in February 2003 when Bukar Abba asked me if I thought Adamu Waziri would be a good governor for Yobe State. The question took me by surprise because I had gone to see him on another matter entirely apolitical, being a journalist.

I was in the Government House sitting room at about 8 pm and just a few guests were there hanging around. I recall one security man telling me to go because it was late, an advice I ignored. Then Bukar, whom I believe saw me on the CCTV monitor, sent for me. And I was taken to his bedroom! That was a great honour. He was sitting on his bed while I sat on the carpet in front of him.

After initial greetings, he asked why I was there late. Done with that, he asked me about a marriage I was to contract that month and asked me how much the dowry was. When I told him, he laughed heartily and said "Why is it this much, or is it because she is Fulani?" He got up and went to a wardrobe where he

counted the amount and gave it to me.

Then the bombshell: "Do you think Adamu Waziri will be a good governor for Yobe?" he asked me.

Gubernatorial elections were to be held in the next two months and Waziri of the PDP was a threat.

My mind went into a spin. I thought he was trying to trap me. Something told me that he had asked because there was this political misconception in Yobe that every Babole was regarded as a PDP loyalist and, therefore, would vote for the party. He (Bukar) did not even know that, at that moment, I was more with Tijjani Musa Tumsah who was not exactly politically chummy with Waziri. Four years earlier, I had given my vote to Nasiru Hassan Yusuf, who was contesting for the House of Assembly in Bukar Abba's party.

But knowing him to be a straight forward man who believed people telling him something were truthful, I gave him an answer from deep within my heart, an answer I believed in.

Religion For Peace – Part Two: Reflections Of Cardinal Onaiyekan

ARDINAL Onaiyekan is insistent in the book that although we Nigerians pride ourselves as being very religious and we claim that our religion is for peace, our nation is full of violent conflicts, sometimes said to be due to, or related to, religion. It is a tragic contradiction we must resolve.

How can we make sure that we retain our religious convictions and at the same time ensure that religion plays its true role as an asset for peace, not a liability? Is it true that religion brings peace, or is it a myth? We often say that religion, in itself, is all about peace and goodness, while the evil actions giving it a bad name come from other factors that have nothing to do with religion. Two such suggested factors are ignorance and greed.

God the Almighty does not need to be defended by us. It is we who need his protection and provident care. Those who go to war and kill in religious wars do so in the human interest.

If humanity is to survive, we need to look more deeply into the relationship between God, religion and humanity. We can learn a lot from the record of history, he argues. Perhaps the most important lesson we can learn from the past is how not to repeat the errors that have brought so much calamity to the human race. We must now have the courage to look towards a future where religion facilitates good relations not only between God and humanity, but also among human beings living in fraternity and reconciled diversities, in peace and harmony. For this to happen, we need to revive and stress some eternal truths that we often prefer to ignore or neglect.

Here are a few of them:

We must distinguish between God and religion, no matter how lofty we think our religion is. Only God is eternal, absolute and unchangeable.

While there is only One God, there are many religions, none of which can or has totally captured the nature of God. We can grasp only what he has revealed to us. But he will always remain a mystery beyond our full understanding.

Religion is important as a structure available for man to regulate his relationship with God, individually and in community.

God the Almighty does not need to be defended by us. It is we who need his protection and provident care. Those who go to war and kill in religious wars do so in the human interest.

Cardinal Onaiyekan is one of the rare members of the clergy that respects African Traditional Religions. He argues that: "We should not forget that in Nigeria, the African Traditional Religion is a foundation of all our religious identities. It is the foundation for every one of us before we became one thing or the other. There are some basic religious values in our African traditional religion, which we share, which are the same as what we meet in both Islam and in Christianity. For example, the idea that there is one God, the creator of heaven and earth; a God who is good, a God who is father, a God who will judge whatever you do; that this world is not our home, that we are only passing through. We believe in prayer; we believe in sacrifice and we believe in certain basic moral norms, including truth, goodness, kindness, and forgiveness. In one way or the other, these are all found in our African Traditional Religions, which we have taken up into our various new faiths.

The first article of faith of the Christian creed is "I believe in One God, the Father Almighty, Creator of Heaven and Earth." We hear the same from our Muslim neighbours, for whom the oneness of God is the most important truth of their faith. If this is so, we wonder why our people at times behave and speak as if there is more than one God. How else do we explain it when a Christian says with conviction that the God of the Muslims is different from the God of the Christians? We hear the same thing from some Muslims. If we cannot sincerely affirm our faith in One God, on what basis can we ever start talking to and relating with each other?

considering the long years of occupation and oppression of Palestinian Arabs.

The hostilities did not start on October 7th. He adds that although the Bible says, "an eye for an eye, a tooth for a tooth", what is happening has gone beyond that and all limits have been crossed. There has to be limits to vengeance. He adds that in the midst of the tragedy, some religious leaders are turning what is a sad human tragedy into a religious game.

We see this in our country. Some Muslim leaders claim that what is happening is an attack against Muslims, forgetting that there are Palestinian Christians in Gaza who are being bombed and whose ancestral homes and churches have been turned to rubble. Then on the other hand are some misguided Christian fanatics who see biblical justification from the Old Testament prophets, for example, Amos 6: 1-8, for crimes against humanity that cannot but be also crimes against God. Incidentally, they do not know, or they forget, that the same Amos has worse things to say about Israel itself in Amos 2: 6-16

They further presume that in the Israeli-Arab standoff, the Christian has to be on the side of the state of Israel against the Arabs, not knowing that the few but significant, often neglected and ancient



indigenous Christians in this crisis situation are to be found mainly among the Palestinian Arabs of Gaza and the West Bank, not among the Jews of Israel.

Cardinal condemns the position of the United States government which continues to block every attempt to impose a ceasefire through a Security Council resolution. He asks: "if Christian values no longer mean much, what about our common humanity? Is it that the world has not moved beyond the logic of "might is right" even in the 21st century?

The Civilian Coups In Senegal, Guinea Bissau, And ECOWAS Ambivalence

HERE are civilian or constitutional coups in Guinea Bissau and Senegal, yet the regional body, the Economic Community of West African States (ECOWAS) is pretending otherwise. It appears interested only in military coups, not those carried out by its bosses in the Heads of State Summit.

Yet, the ingredients of a coup are present in both countries where the constitution is subverted, the President assumes dictatorial powers, parliament is illegally banned as is the case in Guinea Bissau or emasculated as in Senegal, and the judiciary is under siege to do the bidding of the President.

Then it praised Sall: "The ECOWAS Commission salutes President Macky Sall for upholding his earlier decision not to run for another term and encourages him to continue to defend and protect Senegal's long-standing democratic tradition." Incredible! First, it was not in Sall's place to decide not to run for a Third Term; it is a constitutional limit.

Guinea Bissau, when it was one country with Cape Verde, produced Amilcar Cabral, one of the greatest Pan Africanists in history. Tragically for Africa, on January 20, 1973, Cabral at 48, was assassinated in Conakry, Guinea in a conspiracy linked with the PIDE, the secret service of then colonial master, Portugal.

However, the African Party for the Independence of Guinea and Cape Verde, PAIGC, which he led, survived, and led the country to independence. But the country has been plagued by violence and coups leading to Cape Verde breaking away on January 20, 1981.

On December 20, 2019, retired General Umaro Sissoco Embalo, a former Prime Minister, defeated the PAIGC candidate, Domingos Simoes, in a disputed presidential election.

In May, 2022, President Embalo carried out a constitutional coup by dissolving parliament citing "persistent and unresolvable differences" with the parliament. Rather than ECOWAS sanctioning him, it elected Embalo, two months later, as the Chair of the Authority of Heads of State and Government of ECOWAS!

On June 4, 2023, the opposition coalition, the PAI Terra Ranka, led by the PAIGC, swept the parliamentary elections. But President Embalo refused to allow it function.

On December 4, 2023 Embalo again dissolved the parliament, claiming the Speaker, Domingos Simoes, wants to overthrow him. He also put the Supreme Court0 and its president under armed

siege, forcing the latter to "resign".

Despite these civilian coups by a man who was the sitCourt0hairman0 of ECOWAS, the regional body has kept mute in cold complicity. But ECOWAS will yell, if there is a military coup.

Senegal is the only West African country fortunate to have escaped a military coup. A 2012 attempt by President Abdoulaye Wade to run for an unconstitutional Third Term, was resisted, and

Macky Sall was elected. In turn, Sall decided to run for an unconstitutional Third Term which in June 2023 led to street protests with 16 killed. Sall backed down, but got opposition leader Ousmane Sanko out of the race by getting him convicted.

However, as the February 25, 2024 presidential election approached, Sall decided on February 3, to extend his stay in power by indefinitely postponing the election on the basis that there is a dispute over the candidates list.

This ECOWAS statement which "...encourages him (Sall) to continue to defend and protect Senegal's long-standing democratic tradition", unfortunately presents Africans as idiots. This is because Sall, rather than defending and protecting the democratic tradition, is actually, endangering it. In fact, Sall is the greatest danger to democracy in Senegal. But the issue of the presidential candidates

of political parties is the business of the party, electoral body and the courts, not the President of the country.

Unfortunately, ECOWAS, which has a reputation of chasing shadows, would not tell Sall the truth or defend constitutional rule. Rather, it same day, sanctioned Sall's illegality by accepting the postponement. In its Saturday, February 3, 2024 statement, ECOWAS accepted the postponement and tamely appealed to the Sall Gang to "expedite the various processes in order to set a new date for the elections".

Then it praised Sall: "The ECOWAS Commission salutes President Macky Sall for upholding his earlier decision not to run for another term and encourages him to continue to defend and protect Senegal's long-standing democratic tradition." Incredible! First, it was not in Sall's place to decide not to run for a Third Term; it is a constitutional limit.

Also, Sall actually shed the blood of Senegalese who protested against his initial attempt to run in violation of the



constitution. So, a serious ECOWAS, rather than praise him, ought to demand that he answers for the murder of prodemocracy Senegalese on the streets.

This ECOWAS statement which "...encourages him (Sall) to continue to defend and protect Senegal's long-standing democratic tradition", unfortunately presents Africans as idiots. This is because Sall, rather than defending and protecting the democratic tradition, is actually, endangering it. In fact, Sall is the greatest danger to democracy in Senegal.

Then after renewed street protests, the Senegalese Parliament met on Monday, February 5, 2024 on the indefinite postponement. During sitting, security forces removed, by force, parliamentarians opposed to the postponement. Then rather than restore the electoral calendar, what is left of that parliament, endorsed Sall's decision to illegally extend his tenure, by postponing the presidential election by ten months. This, of course, might be an initial date as it can always be postponed.

In 2016, following Gambian presidential election, there was a dispute between incumbent President Yahya Jammeh and opposition leader, Adama Barrow. ECOWAS on January 19, 2017 sent a regional military force, the ECOWAS Mission in Gambia, ECOMIG, to force Jammeh out. It was tagged 'Operation Restore Democracy'. Rather than be concerned about the nondemocratic postponement and its implications for democratic governance, ECOWAS, the next day, issued another of its pathetic statements.

Where even the United States, which is not known to be a Sall antagonist, declared that the Senegalese National Assembly vote "...cannot be considered legitimate given the conditions under which it took place", ECOWAS chose to be silent on the undemocratic process. Rather, it took refuge in bland sermons, reminding "...the population and the political class of their responsibility to maintain peace and stability in the country".

To show the ECOWAS mindset and its lack of principles, it ended its second statement with a pledge to "...take all necessary steps to support the government and people of Senegal in their efforts to sustain the country's democratic tradition". How can ECOWAS pledge to support the subversive Sall government in Senegal that has no regard for democratic cultures, the will of the people and their human rights?

So, if tomorrow, such a government is overthrown, ECOWAS will be shouting about democracy and the sanctity of the constitution when it is actually in connivance with the Sall regime to subvert the constitution and democracy in that country.

Kogi **Terminates Appointment** Of Revenue

he Kogi State Government has announced the immediate termination of appointments of all consultants charged with the onerous task of revenue generation to the coffers of the state government.

he Permanent Secretary, Federal L Ministry of Agriculture and Food Security (FMAFS), Mr. Temitope Peter Fadeshemi has said that the number of men living on less than 1.90 U.S. dollars a day in the country has reached around 44.7 million, while the count was at 43.7 million for women.

He added that overall 12.9 per cent of the global population in extreme poverty was found in Nigeria as of 2022, which makes the level of poverty in Nigeria to be very alarming, while an estimated population of 88.4 million people in Nigeria are living in extreme poverty.

The Permanently Secretary expressed this on Wednesday in Maiduguri, at the flagging off of employment and training organized by the Federal Ministry of Agriculture and Food Security, Department of Agricultural Extension Devices in collaboration with the Federal Minister of Budget and National Planning.

According to him, FMAFS organized the training for employment and distribution of agriculture input to 243 beneficiaries for the National Poverty Reduction with Growth Strategy (NPRGS) held at FMAFS Green House Maiduguri.
