### Gunmen Kill Man, Abduct Wife In Plateau

Gand killed a middle-aged man, Sule Gwamnati, in his family house in the early hours of Friday in the B o k k o s L o c a l Government Area of Plateau State.

A source said that after shooting Gwamnati in the Mai Katato community where his family house is located, the attackers, s u s p e c t e d t o b e kidnappers, abducted his wife, Blessing, and took her to an unknown destination.

He explained that G w a m n a t i w a s immediately rushed to a hospital in Jos and died a few hours after arrival. Ketas Mallal, the Chairman of Community Peace Observers in Bokkos, confirmed the attack on Gwamnati's resident on Friday.

He explained that, "in the early hours of Friday, one Sule Gwamnati (native) was shot twice by some criminals who kidnapped his wife, Blessing Sule. The victim later died at JUTH after treatment started."

A c c o r d i n g t o th e chairman, the incident was reported to security agents in Bokkos who assured them that an investigation into the incident was ongoing.

The spokesman for the Police, Alabo Alfred, said the command is aware of the incident in Bokkos.

### Katsina Governor Goes After Foodstuff Hoarders, Warns Of Consequences

overnor Dikko Umaru Radda of Katsina State has issued Food Security (Promotion) Order, effectively prohibiting illegal hoarding of food and essential commodities within the state.

The order according to his Chief Press Secretary, Mohammed Kaula sends a clear message that, the State Government would not tolerate practices that, threaten the well-being of residents in the State.

The order, however, defines food commodities as including staple grains like rice, millet, maize, sorghum, cowpeas, and groundnuts. "Hoarding these items will now be punishable," the governor said.

Governor Dikko Radda explained that, the contravention of this Order by any person shall render :- "(i)The person and/or corporate entity in such contravention is liable for prosecution under Section 114 of the Penal Code Law of the State.

(ii) The place used for the hoarding of the commodity shall, by warrant issued by the Court, be liable to be broken into, and the commodity be sold to the public at a controlled price.

(iii) The proceeds of such sale shall be subject to determination in accordance with the prevailing laws on proceeds of crime."

Consequently, the governor said to ensure effective enforcement, the order establishes a dedicated "Task Force" consisting diverse group of individuals who would be responsible for:- (I) Identify food commodity hoarders within the State; (ii) Engage with stakeholders on food prices in the state; (iii) In collaboration with Security Agencies, arrest and prosecute violators of this Order and (iv) Control the buying and transporting of food commodities within and outside the state, including international borders. "Similarly, (v) to do all other things incidental or necessary for the enforcement of the provisions of this Order." Governor Dikko Umaru Radda emphasized the collaborative nature of the initiative, said, "We call upon all citizens, traders, and stakeholders to join us in this fight against food insecurity.

# Crisis Tears Enugu IPAC Apart, As Two State Exco Emerge

Enugu State Inter-Party Advisory Council (IPAC), on Thursday, held its election amid crisis, leading to the emergence of a parallel executive committee enthroned by one of the factions.

The parallel exco was controversially elected at the state headquarters of the Independent National Electoral Commission (INEC), in Enugu, after majority of the members from various political parties staged a walkout during the exercise.

The process commenced peacefully until it got to the process of accreditation for voting. However, a sharp division among members of the group regarding the IPAC electoral guidelines led to hot exchanges among members despite appeals by the electoral committee chairman, Uchechukwu Ogbonna for the exercise to continue. The development, led to a standoff, which lasted for more than three hours, prompting the electoral committee chairman to announce a suspension of the exercise until 3 pm. When the members reconvened, the group led by the incumbent chairman, Hon. Godwin Alor who were in the majority, staged a walkout, while the group led by Hon Innocent Ezeoha participated in the

controversial exercise.

Explaining to newsmen why he and his group decided to boycott the election, Alor said that the IPAC electoral guidelines was not followed by the electoral committee, saying, Article G, stipulated that only the state chairmen can vote but in a situation where the chairman is not available, he should give an authorisation letter to his representative.

According to him, the guideline for the election was violated by the PDP delegate, who came to represent the party chairman without the required letter, adding that he remains the chairman of IPAC in the state, pending when a proper election is conducted.

The state IPAC chairman, accused the electoral officials from the IPAC headquarters, Abuja, of

told me that he is not a lawyer and can't be IPAC legal adviser. He said anybody that wants to use his name should inform him before signing any form.

"Other chairmen, like Ugo Agballa of the All Progressives Congress (APC), Omeje of the ADP and many others submitted their letters one week before the previous date and the election was shifted to accommodate everyone, but the PDP didn't submit any letter.

"They just went to cyber cafe this afternoon and printed a letter. I know Nnamani's signature and that's why they refused to show me the letter.

"Secondly, there is a court order restricting IPAC from holding the election nationwide. The national chairman has just called us that no election should be held. We also submitted chairman of IPAC in the state.

Other exco members of the group included, Elvis C a j e t h a n C h i n a -Zamugwoke of ZLP who emerged as the Deputy Chairman; Afamefuna Samuel of the APP Secretary, while Aliyu Adamu Muhammad of NNPP got the position of Deputy Secretary.

Also elected by the group are, Chukwuma Stella Nneamaka of ADC, Financial Secretary; Ezeah Magnus of SDP, Treasurer; Ikeh Kenneth Odoh of APM, Organising Secretary; Ugwu Chiedozie Louis of NRM, Publicity Secretary and Augustine Nnamani of PDP as the Legal Adviser. Speaking with newsmen, Nnamani described the election as free, fair and credible, saying he would carry everyone along, promising to run a transpa e n t administration. Addressing journalists at the end of the exercise, the electoral committee chairman, Uchechukwu Ogbonna, said that the disagreements which threatened the conduct of the state IPAC polls was a practical demonstration of democracy, where everyone was allowed to air his or her views. He said that the electoral committee held the election in compliance with the organization's electoral guidelines.

"By working together, we can ensure that everyone in Katsina has access to the food they need," Governor Radda explained.

# Family Business: NDLEA Arrests Female Lawyer, Spouse, Mother, Herbalist, Others Over Inherited Illicit Drug Cartel

family of four, their herbalist, salesgirl and one other have been apprehended by operatives of the National Drug Law Enforcement Agency (NDLEA) over alleged engagement in illicit drugs business, New Nigerian Newspapers has learnt.

The family, which comprises of a female lawyer identified as Adaobi Nweke, 36, her mother, Mrs. Ngozi Nweke, 65, Chukwudi Abel, 33, Amarachi Paul, 18, all members of the family, were said to have been arrested alongside Emeka Nkemefola, 36, boy friend to the lawyer, Dike Okpara, 43, herbalist to the family and their 22-year-old salesgirl, Blessing Jonathan for holding forth to the illegal drug business inherited from their late father.

Our correspondent gathered that the suspects were nabbed in Abia, during a joint raid operation between the NDLEA and men of the State Homeland Security at 23 Arochukwu street, Umuahia around 11pm on Wednesday 14th February 2024. The Director, Media & Advocacy of the agency, Femi Babafemi who made the disclosure in a statement yesterday, noted that investigations revealed that members of the family had long been in the illicit drug business passed on to them by their now late father, Jonathan Nweke. He hinted that various quantities of Cocaine, Heroin, Methamphetamine, Loud, Cannabis Sativa and precursor chemical with a total weight of 1.670kg as well as N578,400

monetary exhibit were recovered from them as at the time of the arrest.

Babafemi, who also disclosed other achievements recorded by the Agency across the country, said attempt by a 25-year-old Uber driver, Joshua Henry to deliver a consignment of 26.2grams of Loud picked in Abuja to a customer in Keffi, Nasarawa state on Monday 12th February was thwarted by NDLEA operatives who intercepted him.

He stated further, " In the same vein, 54-year-old Dada Adedara was on Wednesday 14th Feb arrested at Dan Bare area of Kano State with 468 blocks of cannabis weighing 246.4kg. Same day, operatives in Ogun state arrested the duo of Kafayat Junaid and Sakirat Osoanu with 13kg cannabis sativa.

"In Kogi state, a suspect, Charles Chike, 45, was arrested by NDLEA operatives in a hotel in Lokoja on Friday 16th Feb. with 290 blocks of compressed cannabis weighing 116kg. " The exhibit was concealed in the boot of a blue Honda Accord car marked Abuja ABC 853 SL, which took off from Ekiti state enroute Abuja. Not less than 227kg of same substance was recovered from Atoshi camp, Emure -Ile, Owo LGA, Ondo State, while two suspects: John Jonathan and Emmanuel Alex were arrested. " While acting on intelligence, operatives in Edo state on Wednesday 14th Feb. intercepted a consignment of methamphetamine coming from Onitsha, Anambra state to Lagos, in a Toyota Sienna bus marked Anambra NZM 347 ZL.



" The meth consignment weighing 0.966kg was concealed inside a cassava made local food item, African salad popularly called "Abacha". The driver of the vehicle, Afamefuna 10.5kg cannabis, 13.5 grams of diazepam and 2.9 grams of tramadol tablets. Another suspect, Yaro Bala, 27, was arrested on Thursday 15th Feb. with 50.5kg cannabis during a of Government Day Secondary School, Tudun Saibu, Soba LGA, Kaduna state; students of Community Comprehensive Secondary School, Obinagu, Udi LGA. Enugu state and students of Government Girls Secondary School, Garo, Kano state." While commending the officers and men of the MMIA, Abia, Nasarawa, Edo, Kogi, Kano, Ogun, Ondo and FCT Commands of the Agency for their outstanding feats in the past week, Chairman/Chief Executive Officer of NDLEA, Brig. # How Deployment Of Hunters In North-East Helped Reduce Crime - Hammanjoda

he Nigerian Hunters and Forest Security Service (NHFSS) has said that massive recruitments and deployments of hunters in the North-East region of the country has helped tremendously to battle as well as reduce forest crime in the region.

Speaking exclusively with our correspondent, the Zonal Commander North-East Zone, ACG Haruna Umaru Hammanjoda Furo, said hunters now battle criminal elements, which he described as bigger animals in the forests.

He said over 50,000 hunters now ensure that the six states in the North East zone are protected from insurgents who commit crime and run into the bushes and forests for cover and hunters have ensured that Bauchi, Bornu, Adamawa and other states in the region have forests devoid of kidnappers den, armedrobbery gangs and other daredevils.

The North-East ACG of the Nigerian Hunters and Forest Security Service (NHFSS) who disclosed that about 400 hunters were recently recruited in Yobe State, said Bauchi State Governor, Senator Bala Mohammad, has been assisting hunters 100%.

He said just last week, the governor doled out N110 million to hunters in the 20 local government areas of the state.

He also said that Governor Mohammad has donated about 17 Hilux Utility Vehicles and over 300 Defense Corps and others, hunters have been able to flush out bandits and other criminal elements from the

forests in Bauchi State. In Bornu State, ACG H a r u n a U m a r u H a m m a n j o d a F u r o revealed that Bornu State Governor Professor Zulum had borrowed a leaf from h i s B a u c h i State counterpart.

He said Professor Zulum, has donated about 30 operational vehicles and motorcycles to hunters to enable them to function effectively in the state.

According to him, Adamawa State Governor, Amadu Fintiri gave hunters 21 operational Hilux for the 21 local government areas of the state, while Taraba State Government also assisted hunters with operational vehicles, adding that hunters have not reneged in ridding the North-East zone of wilder animals in the forests (human criminal elements) which he said is their core mandate.

ACG Haruna Umaru Hammanjoda Furo however, advised governors of the South East states to emulate what their counterparts in the North East are doing through the hunters to fight forest crimes.

He said Nigeria is one united nation and that there should be freedom of movement any day any time, contrary to the sit-athome scare imposed on the region by faceless outlaws. omen of Awgu Local Government Area of Enugu State, where an eleven years old househelp, Miss Happiness Nwafor, was recently violently brutalized with hot knife and electric iron by her madam, hails from, have placed a one million Naira bounty on the perpetrator, Adachukwu Cukelu Okafor, who has been declared wanted by the police.

It would be recalled that same. women, had last week Wednesday, staged a peaceful protest in Enugu, demanding justice for the victim, who was tortured with hot knife and electric iron by her Madam who equally mutilated different parts of the minors body, including her vagina.

This is coming barely 48 hours after the federal Ministry of Women Affairs and Social Development, via the Minister, Uju Kennedy Ohanenye announced a bounty of two million Naira on the perpetrator

The women said anybody who avails the police, Anambra State Government, or other relevant authorities with necessary information that could lead to the arrest of the perpetrator, will smile home with one million Naira from them. The perpetrator, who hails from Anambra State and resides in the commercial city of Onitsha, where she perpetrated the barbaric act, was said to have accused the victim of fondling the private part of her eight year old daughter while bathing her.

Briefing newsmen on Thursday under their platform, Umuada Awgu Progressive Association otherwise known as Umuada Awgu Global, its president/Founder Ambassador Chinemerem Anyi, accompanied by other members of the body, said it beats the organization's imagination that almost three weeks after the woman perpetrated the evil act, the police is still saying that she is still at large.

They posited that going by the manner the matter is being handled by the Anambra State Police Command, the organization is beginning to smell a rat, adding that they are giving the police 48 hours to apprehend the perpetrator or incur the full wrath of the women who she said, are heart broken over the barbaric act.

According to Anyi, the Awgu. women have been resisting the temptation of taking the laws into their hands over the matter as civilized people, but warned that such calm disposition should not be taken for granted or weakness.

"Today, we are here gathered for this important press briefing over the recent brutalization of our daughter, Miss Happiness Nwafor by her wicked Madam.

"We are using this media briefing to call on the butcher woman to better submit herself to the police, or other relevant authorities, because no matter where she is, she will be fished out," the group said, vowing that the organization would not rest on its oars until justice is served on this matter.

# Lassa Fever Outbreak: 10 Feared **Dead, 25 Others Infected In Ebonyi**

By; MKPUMA **ENYINNA.Abakaliki** ollowing an outbreak of Lassa Fever in Ebonyi State, 10 persons have reportedly lost their lives, while 25 others are infected.

The local government areas affected include Onicha, Ikwo, Ezza North, Ebonyi, Izzi, Ohaukwu, Abakaliki with Hausa quarters and Nkaliki residential areas recording the highest number of cases.

According to the Disease Surveillance Notification Officer, Ministry of Health, Mr. Orogwu Sampson, the state recorded 53 cases last year, while 36 people lost their lives, adding that from January 4 to February 16, 2024, about 25 people have been infected including two healthcare workers with 10 deaths recorded.

While he said that the disease cuts across all ages, he noted that out of the 25 confirmed cases,16 people are men, whereas nine are women, disclosing that those who died comprised: a pregnant woman, two children, men and women. "Other LGAs apart from, Onicha, Ikwo, Ezza North, Ebonyi, Izzi, Ohaukwu, Abakaliki with Hausa quarters and Nkaliki residential areas that have not recorded a case so far may be because they have not reported not that it doesn't exist there".

He said that the treatment is free and urged people to go for early detection, early presentation and treatment to avoid further loss of lives.

On his part, the State Epidemiologist, Dr. Ogbonna Nwambeke enumerated the efforts of the state government together with the partners such as WHO, Breakthrough Action Nigeria, UNICEF among others to reduce the ugly menace and called for provision of logistics to increase surveillance and community engagement against risk factors.

Dr. Nwambeke advised people to stop bush burning, avoid eating rats and not to touch the surface an infected person

has touched as well as maintain high level of personal and environmental hygiene like covering their food and utensils properly.

He appreciated the state government for giving them large volume of Personal Protective Equipments (PPEs) to give to health workers at National Obstetrics Fistula Centre to ensure that their own health workers are alive to save others.

It is worthy to note that Lassa Fever is a hemorrhagic illness that occurs every dry season in Ebonyi State, but the outbreak is different this year as it started so early.



### Bullion Go-Neat Petitions Police Over Alleged Defamation, False Information Against Products

#### \*Accuses Reuben Abati, Chioma Chukwunedu, Naira Metrics, EA Team

Bullion Go -Neat Global Manufacturing Company Limited has petitioned the Commissioner of Police, Federal SARS, Adeniji Adele, Alagbon, Lagos State over alleged defamation and spreading of false information against its products.

In the petition made available to journalists yesterday, signed by the Company's Legal Representatives, Isaac Izunya (Esq) of Izunya Izunya and Co, the company said the alleged false reports involve its product, Coco Samba Milk and Chocolate Flavoured With Herbal Extract, which they claimed was intercepted and seized by German Customs due to its being unsafe for human consumption.

The petition titled, "Petition Against Reuben Abati, Chioma Chukwunedu, Naira Metrics and EA Team", alleged them of the offences contrary to Section 24 (2) (c) and Section 25 (1) of the Cyber Crime Act 2015, as well as Section 375, 376, and 125 of the Criminal Code Act".

Bullion-Go-Neat Global Limited, a registered manufacturing company in the petition, accused Chioma Chukwunedu and her associates of utilizing media platforms, specifically E A Team and Nairametrics, to disseminate falsified and untrue information about its product, Coco Samba Milk and Chocolate Flavoured With Herbal Extract.

The company maintained that the alleged false reports involve its product, Coco Samba Milk and Chocolate Flavoured With Herbal Extract, which they claimed was intercepted and seized by German Customs due to its being unsafe for human consumption.

According to the legal representatives, the suspects in the defamation acts include, Mr. Reuben Abati who allegedly actively participated in the generation, diffusion, and circulation of false information on the products on various social media platforms.

The company contends that the malicious intent behind the false news is to cause substantial damage to its business reputation, affecting customers confidence, thus leading to economic losses.

According to the petition, the suspects are accused of violating Section 24 (2) (c) and Section 25 (1) of the Cyber Crime Act 2015, as well as Section 375, 376, and 125 of the Criminal Code Act.

The legal representatives emphasize that the alleged actions of the suspects have caused substantial economic and reputation losses to Bullion-Go-Neat Global Limited.

The petitioner urged the Commissioner of Police to investigate and prosecute the suspects, emphasizing the need for decisive action to restore lost confidence, goodwill, integrity, and reputation for the affected company.

He cited relevant legal provisions, including Section 351 of the Criminal Code, which holds individuals publishing defamatory matter, knowing it to be false, liable to imprisonment.

The legal representatives call on websites such as Reuben Abati's blog, Nairametrics, Opr. News, and "Our Heritage Reporter," along with other media that carried the news, to produce evidence from the German laboratory to NAFDAC if indeed they have published factual information.

# Boko Haram: Borno Has High Maternal, **Neonatal Mortality Rates - Commissioner**

\*UNICEF donates medical supports wort 300,000 US dollars for women, children health needs

he Borno State Commissioner of Health and Human Services, Professor Baba Malam Gana has said that the state unfortunately, is one of those in Nigeria with very high indices of maternal and neonatal mortality rates as a result of the Boko Haram insurgency.

He also added that, "at any time, we have over 400,000 women who are pregnant. We have 1.5 million women of childbearing age and we have children under five who are quite substantive in number to about 1.2 million.

Professor Gana stated this on Thursday, while receiving essential medical equipment and kits worth 300,000 US dollars donated by the United Nations Children Fund (UNICEF) at the Central Stores Maiduguri.

He also thanked UNICEF for its regular interventions and expressed Governor Babagana Unara Zulum's appreciation to

UNICEF for its laudable support always, since the inception of the insurgency to date, saying, "It is my singular honour and privilege to be here today in the Central Stores of the UNICEF and appreciate on behalf of His Excellency the Executive Governor of Borno State, Professor Babagana Umara Zulum, gratitude and appreciation for the generous donation by UNICEF.

"This donation is apt and acknowledgeable. I would like to recall the generosity of UNICEF in terms of assistance to Borno, especially in the insurgency period, which has resulted to loss of 45% of our healthcare facilities.

"Some of them were partially damaged. Our health facilities were destroyed by the insurgents. And it has led to loss of a lot of health personnel. Some were kidnapped, some were killed, and some have suffered from post operational stress disorders. And that' left us in a very callous and political

situation.

"But with the assistance of the UNICEF. brought some succour to our people. And I'm sorry to have to tell you that Nigeria is in the bottom in terms of such indices of maternal mortality and mortality, which is something that UNICEF stands very strongly for in order to change it. They have looked into these up to date and donated equipments which we know, will not only furnish some of our primary healthcare but also even our secondary care facilities.

"Where women who are delivering would have benefited from this premise donated is quite substantial. And we're very grateful to UNICEF, and all the donors around the world for considering us which is worth 300,000 US dollars.

"I can assure the Chief of Field Office, Maiduguri, Borno State that our Executive Governor, Professor Babagana Umara Zulum is somebody who is transparent, who is workaholic and is known for his judicious use. of funds and equipments which has earned him across the country a lot of awards and you have seen for yourself, how many healthcare facilities are currently being built including building of institutions, health Center, s and even building some nursing schools.

"We need more resources for health centers, hospital General Hospital and water supply facilities in collaboration since 2001 where health this year has 15% budget allocation and

# Ibom Oil/Gas Corporation **Bill Will Drive Sectoral Investment - CHRAN**

Bill for a Law to establish the Ibom Oil and Gas Corporation and for Other Purposes Connected Thereto, when passed, will enhance investments and create wealth in oil and gas sector of Akwa Ibom State.

The Director, Center for Human Rights and Accountability Network (CHRAN), Otuekong Franklyn Isong, flanked by the Secretary, Barr Christopher Ekpo, and other members made the observation during a chat with journalists in Uyo on Wednesday.

The bill which has passed through the second reading in the State of Assembly, is sponsored by Prince Ukpong Akpabio, member representing Essien Udim State Constituency and the cosponsors by other members.

Isong, who commended the sponsors of bill, described the bill as long overdue in the state, being one of the top crude oil bearing states in the country.

CHRAN, a civil society group lauded the Bill on its objectives, which include engaging in oil and gas upstream activities, including exploration, drilling and production, investing for the purpose of participating in oil and gas bid rounds and seeking the allocation of marginal oil fields

Others include, acquiring old and new exploration and drilling prospects and prospecting abandoned oil wells in Nigeria and overseas; optimising the benefits of the petroleum policies of the federal government; liaising with federal government agencies or private and multinational companies to deliver petroleum products to Akwa Ibom state in the most effective and cost efficient manner. Investing in downstream oil and gas activities including gas processing businesses, petroleum products retailing, gas retailing, gas pipelines

deployment, acquisition of petroleum products tank farms and other distribution facilities, and investing in refineries, petrochemical processing or other production

processes. CHRAN also noted that the Ibom Oil and Gas Corporation, envisaged in the Bill would create employment for the teeming unemployed Akwa Ibom indigenes, generate revenue for the state and serve as a vehicle for economic growth and regeneration while harnessing and consolidating the huge oil and gas potentials of Akwa Ibom State.

"The beauty of the Bill is that, it will provide for both upstream and downstream activities by the Ibom Oil and Gas Corporation. In that wise, CHRAN believes that the acquisition of petroleum products tank farms and other distribution facilities, envisaged in the Bill, will go a long way to ensure the availability of petroleum products in the

State.

"The foresight of the sponsors of the Bill reflects in the provision in the Bill for expansion of the Ibom Oil and Gas Corporation to make for investment in existing companies or consortia and acquisition of old or abandoned oil wells and exploration and drilling facilities in the country and overseas." CHRAN, stated.

The group advocated for support for the Bill by all members of the Akwa Ibom State House of Assembly, the Executive Arm of the Akwa Ibom State Government and indeed, all Akwa Ibomites to ensure a quick passage of this important Bill and timely assent to the Bill by the Governor of Akwa Ibom State, in due course. # Customs FOU Zone 'B' Seizes Items Worth Almost N2bn In One Month

ustoms Service Federal Operations Unit (FOU) Zone 'B' has within a month, made seizure of various items with Duty Paid Value (DPV) of almost two billion Naira.

This was disclosed by the Comptroller FOU Zone B, Dalha Wada Chedi during a press briefing on Friday at the zonal headquarters in Kaduna.

"The Total Duty Paid Value (DPV) of the Seizures made within the period under review is One Billion, Nine Hundred and Seventy-Five Million, Six Hundred and Six Hundred and Fifty-Seven Thousand, Eight Hundred and Sixty-Five Naira and Ninety-Six Kobo(#1, 975,657,865.96) only," he said.

According to him, the seizures were made between January 1 to February 16, 2024,

#### covering a total of 27 items.

"I am pleased to welcome you to the Federal Operations Unit (FOU) Zone 'B' to brief you on the anti-smuggling feat of the Unit from 1st January to date.

"The operatives of the unit have for the period under review remained resolute in the fight against smuggling thereby making several seizures of 27 different items ranging from used foreign shoes, foreign parboiled rice, Second hand clothing, expired milk and juice powder, among others.

"On Wednesday, 24 January 2024 at about 2200hrs, the operatives of the unit intercepted One (1) truck conveying One Hundred and Seventy-Nine (179) Bags of Tiger Nuts (50Kg each) based on i n t e l l i g e n c e a l o n g Maigatari/Malamfatori/Birniwa axis of

Jigawa State," he said.

According to him, on February 3, 2024, the operatives of the Unit arrested three (3) trucks along Gumel-Kano road in Jigawa State.

"The arrest was made following information shared by the intelligence network of the NCS-Headquarters, Abuja on the suspicion that they were conveying prohibited items.

"Hundred per cent (100%) physically examination was conducted at the premises of Kano/Jigawa Command and the Three (3) trucks were found to contain 5076 Cartons of Foreign soap, 703 bales of Foreign second-hand clothing, 925 cartons of macaroni, 320 bales of foreign textiles and 12 Jumbo sacks of foreign used shoes," he informed.

The comptroller explained that two

suspects were arrested and detained at the Kano/Jigawa Command in connection with the seizures and they have been granted administrative bail pending the outcome of the ongoing investigation.

"Also on 11 February 2024 at about 2200hrs, the operatives of the Unit acting on credible intelligence along Tsafe-Funtua Road in Zamfara State intercepted One (1) truck on the suspicion of improper importation.

"Further examination revealed that the truck was conveying 75 cartons of expired foreign jolly juice powder and eight sacks of foreign expired milk powder that were found to have expired since 2019 thus unfit for human consumption.

"The expired milk was concealed with sacks of dried hides & skin. These are expired, unused and contaminated items

which if not intercepted by our operatives would cause havoc to the society in general.

"Other items seized within this period are: 237 Bags of Foreign Parboiled Rice (50Kg each), 1837 cartons of foreign spaghetti, macaroni and couscous, 1707 jerry-cans of premium Motor Spirits (PMS) 25 litres each, 3459 cartons/sachets of Amoxicillin, Artesunate, 500 Mg, 35 cartons of flame lighters, 2089 cartons of foreign dates, 142 cartons of YES Cigarrettes, 810 pieces of foreign used tyres, many vehicles deposited at various Customs formations in the Zone, among others.

"It is important to mention that the foreign dates and the Tiger-Nuts by their nature are edible and perishable goods would be auctioned in line with the provisions of Paragraph 15 (b) of the Schedule of the Nigeria Customs Service Act No. 35, 2023.

"These unprecedented seizures were made as a result of contravention of several sections of NCS Act 2023 and breach of extant Presidential directives on border closure.

"It is a fact that things are difficult for common men in this country, despite this; smugglers are adding to the suffering of the citizens by smuggling these expired and unhealthy items that are injurious to health and wellbeing of the people.

"The Unit is an enforcement arm of the Service that will continue to arrest situations that may harm the citizens of this country. I want the general public to know that the personnel of the NCS are Nigerians too and we share in their pains at this critical time," he said.

Speaking further he said, "However, the operatives of the unit will not relent until smugglers are out of business. We will not be tired in our twenty-four hours and seven days round the clock enforcement drive to suppress smuggling.

"In addition, I enjoin the general public to be on our side in fighting the menace of smuggling which undermines government goal for revenue generation and aims at compromising the health of unsuspecting Nigerians. This is a fight that we all must give priority to for the president to succeed and deliver on the renewed hope agenda to Nigerians.

"I want to use this medium to thank the Comptroller-General of Customs, Bashir Adewale Adeniyi MFR and his management for their morale boosting leadership and encouragement to our Officers and Men towards achieving our mandate," he said.

The drugs and expired milk were handed over to the National Agency for Food, Drugs, Administration and Control (NAFDAC) for further investigation.

NAFDAC representative, Asst Director North West Zone, Dr. Paul Faruna after the handing over, said that he appreciates the gesture from Customs.

He thanked then for the collaborating and was optimistic that the synergy between the two agencies will be sustained.

"They have assisted us in so many ways to curb fake drugs," he added.

He advised Nigerians against purchasing fake or expired drugs, urging the general public to always report such cases as their identities remain protected.











# **Plots To Destabilise Alia's Administration By Abuja Forces Uncovered, Benue Govt Cries Out**

Benue State Government has said that there are devious plans by forces in Abuja comprising some members of the National Assembly from Benue to destabilize Gov. Hyacinth Alia's administration despite all the positive developments recorded by the administration within eight months.

In a statement by the Chief Press Secretary, Tersoo Kulas, the State Government said that it has smelt this on many fronts, particularly, following the torrent of divisive concoctions sponsored in the media by these same agents of underdevelopment, who are not comfortable with the massive positive development in the state.

The State Government while reacting to series of attacks in the media by some members of the National Assembly from the state, described their actions as unfortunate. # Payment Of Gratuities: Gov Lawal **Rekindles Hope Of Helpless Retirees**

dream of every retired civil servant is to get his gratuity paid to him before his death. Thousands of retired civil servants both at the states and the federal government level have died before they could get their gratuities, while thousand others are still in a waiting list and have no hope of getting this last entitlement.

Many state governments have stopped paying the gratuity, despite persistent pressure being mounted on them by the retirees and the organized labour unions.

Infact, some state governors do not consider payment of gratuity to retired civil servants as a right but rather a privilege.

This wicked attitude of non payment of gratuity has put many retired civil servants into serious difficulties and hopelessness.

Many of them have died of hypertension, while those who have survived the situation have been paralyzed and could no longer fend for their families. In Zamfara state, payment of gratuity has been suspended for the last 10 years or more, as such, the administration of Governor Dr. Dauda Lawal inherited a backlog of gratuity which stood at N13.4 billion.

The past administrations made several false promises, more especially during the electioneering campaigns without fulfillment. However, with the coming of Governor Dauda Lawal as the fifth democratically elected Governor, retired civil servants who have lost hope are now smiling and their dream of spending their gratuities is becoming a reality. Although, Governor Dauda Lawal did not promise to settle the backlog of gratuity owed to retired civil servants during his campaign, he decided to pay them in order



to alleviate their suffering. Out of magnanimity, Dr. Dauda Lawal directed the ministry of finance to commence the payment of the backlog of N13.4 billion gratuities to retired civil servants in the state. The state government had established a committee to authenticate the retired civil servants' data to pay off the gratuity debt accumulated from 2011 to date. After validating the data of retired civil servants, the government discovered that the total amount owed from

state and local governments their gratuities without any outstanding debt of gratuity

was 13.4 billion Naira. The committee has already gone far with the authentication of data submitted by local government and state pension commission and physical verification of beneficiaries.

Retired state and local government employees who were verified have begun to receive their gratuity payments since Thursday. Similarly, the government would ensure that all retirees are authenticated and paid

#### difficulties.

The retirees who have been owed gratuities since 2011 finally started receiving their payments and many of them are now jubilating and praying for the success of Dr Dauda Lawal's administration.

The backlog of gratuities accumulated over years is now being cleared and payment has since commenced.

The State government has taken a significant step towards addressing the

#### **Ibom Oil/Gas Corporation Bill Will Drive Sectoral Investment - CHRAN**

By; PATRICK TITUS, Uyo Bill for a Law to establish the Ibom **L**Oil and Gas Corporation and for Other Purposes Connected Thereto, when passed, will enhance investments and create wealth in oil and gas sector of Akwa Ibom State.

The Director, Center for Human Rights and Accountability Network (CHRAN), Otuekong Franklyn Isong, flanked by the Secretary, Barr Christopher Ekpo, and other members made the observation during a chat with journalists in Uyo on Wednesday.

The bill which has passed through the second reading in the State of Assembly, is sponsored by Prince Ukpong Akpabio, member representing Essien Udim State Constituency and the co-sponsors by other members.

CHRAN, a civil society group lauded the Bill on its objectives, which include engaging in oil and gas upstream activities, including exploration, drilling and production, investing for the purpose of participating in oil and gas bid rounds and seeking the allocation of marginal oil fields

Others include, acquiring old and new exploration and drilling prospects and prospecting abandoned oil wells in Nigeria and overseas; optimising the benefits of the petroleum policies of the federal government; liaising with federal government

agencies or private and multinational companies to deliver petroleum products to Akwa Ibom state in the most effective and cost efficient manner.

Investing in downstream oil and gas activities including gas processing businesses, petroleum products retailing, gas retailing, gas pipelines deployment, acquisition of petroleum products tank farms and other distribution facilities, and investing in refineries, petrochemical processing or other production processes.

CHRAN also noted that the Ibom Oil and Gas Corporation, envisaged in the Bill would create employment for the teeming unemployed Akwa Ibom indigenes, generate revenue for the state and serve as a vehicle for economic growth and regeneration while harnessing and consolidating the huge oil and gas potentials of Akwa Ibom State.

"The beauty of the Bill is that, it will provide for both upstream and downstream activities by the Ibom Oil and Gas Corporation. In that wise, CHRAN believes that the acquisition of petroleum products tank farms and other distribution facilities, envisaged in the Bill, will go a long way to ensure the availability of petroleum products in the State.

"The foresight of the sponsors of the Bill reflects in the provision in the Bill for expansion of the Ibom Oil and Gas Corporation to make for investment in existing companies or consortia and acquisition of old or abandoned oil wells and exploration and drilling facilities in the country and overseas." CHRAN, stated.

# Bukar Abba Ibrahim: The Man Who Touched My Life (2)

damu Maina Waziri is one politician most people misunderstand. He is one man who does not suffer fools and, unlike the typical politician, he shoots from the hip, the reason some saw him as "crude". His word is his bond; and if you asked him for a favour that he can grant, he would tell you, and if he promised, he would deliver. But if he wouldn't, he would not bat an eyelid in telling you no.

This is not the kind of leader Nigerians want. Nigerians prefer the man who will tell them, "Ah, we did it for others, why not you? Come tomorrow" and they will make you waste a year on "come today, come tomorrow". Opponents capitalised on Waziri's perceived "naivety" to inject his fear into the hearts of their followers.

Nonetheless, I gave him (Bukar) what I believed was an honest answer. I said, "I believe anybody who comes out to aspire to be a governor has good intentions and therefore would be good."

Though I still believe so for Yobe, I doubt if it applies to the national level, considering the catastrophe Nigeria saw between 2015 and 2023.

Meanwhile, I will leave Bukar's response to my answer between the two of us with God as a witness - where it has been all this while.

Apart from the irony of Bukar having a son who used to be a Waziri die-hard, they cracked jokes and taunted each other whenever they met.

Waziri told me the hilarious story of how they once met on a plane and Bukar pointed at his leg and said, "Adamu, if you want to be governor, come and hold on to this leg," to which Adamu retorted, "That leg is like the leg of a grasshopper; the grasshopper flies off, leaving its leg with the person who holds it."

And he could be practical. In 2007, knowing I laid my neck on the political guillotine having played an active role in the bid of Tumsah (who was his Commissioner for Agriculture when he first governed Yobe) to be governor on the platform of the Action Congress of Nigeria, Bukar, knowing the politics of Yobe, thought the new governor may not be friendly to me. So he called me to his home in Maitama and said something like: "Forget politics and think of survival; follow (your brother) Adamu Waziri." Waziri was a minister as his party was in government at the centre. Even though as a journalist covering the state I interacted with Bukar Abba, my first one-on-one encounter with him was during the campaigns for the 1993 presidential elections in which Chief MKO Abiola stood as a candidate in his party, the SDP. The Nigeria Labour Congress (NLC), Yobe branch, had set up a political commission of five, with Comrade Bashir Abubakar Sadik (Barry White) as chairman and me from the Nigeria Union of Journalists (NUJ) as secretary. Our job was to go around the state and sensitise NLC-affiliate unions on the need for peaceful, free and fair elections, but most importantly on the need to mobilise for the SDP candidate because the party, being "a little to the left", was more in tune with labour.

Comrade Baba Usman Sambo, then NLC state secretary, facilitated our meeting with Bukar. He easily welcomed us, told us a lot of political stories and then gave us an SUV from the Government House carpool and some other necessary logistics.

When General Abacha struck, he had a last encounter with us, the press. I recall telling him, "It is not the people of Yobe that rejected you. Whenever you come back, we will vote for you again." And so it happened.

Never a man of vanity, the glitters of the world hardly take his attention. Baba Ba'aba, who was his long-running secretary to the state government and his permanent secretary when he was a commissioner, told me the story of how he went to Sherrifson, a trendy supermarket in Maiduguri, to buy modern furniture to replace those in Bukar's sitting room while he was away on a trip.

He said the moment Bukar entered the sitting room and saw the change, he just smiled and said, "Baba kenan!"

He said, "Bukar dan kawye ne", not derogatorily but in admiration and awe. Explaining further, he said Bukar would come and meet people sitting under a tree and he would just remove his gown and sit on the ground with them. He was indeed an embodiment of humility.

And he kept those he knew around him. When he was in the Senate and I was an editor with Leadership newspaper, he would call me to arrange the press for him if he had anything to say. Likewise, when his late daughter got married, he gave all the adverts to me.

Earlier when he was governor, I was given an appointment with the Yobe Broadcasting Corporation after coming first in a rigorous examination and interview conducted for 53 of us, but the appointment was rescinded, because of local politics, on the excuse that "it was given in error."

When I told him about it after some months, Bukar told me he would instruct them to absorb me if I wanted. I thanked him but declined. Even though he had never shed tears in his life, he was full of empathy and generosity. In one of the weekly briefings he held with the press every Wednesday before Executive Council meetings, he confessed to having never shed tears in his life, no matter what he did. He thought, or was told, that there was a problem with his tear glands! He loved the press. His time was a golden age for the local press because he encouraged them to blossom. During his time, there were about five local newspapers - the highest number among the northeastern states. There was Yobe News, later changed to The Mark,

published by Sanusi Oladipo, who came as a Youth Corps member but found a home in Yobe and went on to marry another 'corper', Imabong. Three children they gave birth to in Yobe are now university graduates.

We also had Newsray of the late Campbel Ori, who later started a Hausa version called Hakika; Pioneer Administrator, later became City News, and finally, Sky News, of Yusuf Mammai, Rural Front of December Gboru, The Nest of Martin, The Finder of late Akpan and I published The Informant, combined with its Hausa version, Mafadi. Under my leadership, the Yobe State Newspaper Publishers' Association from time to time interacted with him and he made sure all adverts we published were paid. We lapped on his benevolence and always did adverts for local governments and MDAs without even their asking, which were always paid from the SSG's office. The way we were treated made some local publishers from other Northeastern states join us and in 2006 we formed the North East Publishers Forum (NEPF) with me as pioneer chairman and Mr Freedom Haslon, publisher of News Now, from Adamawa State, as pioneer secretary. In 2005, my late wife, Lami Fatima

Babare, came home from work looking sad. She was an English language lecturer at the Federal College of Education (Technical), Potiskum. The reason for her mood was that her colleagues were going to Hajj that year and she was the odd one out. They were either married to big guns or had fewer demands on their salaries and so could afford to pay for the pilgrimage.

I had no one to go to, to make her dream come true except Bukar. And so I wrote a letter to him, requesting a Hajj slot and went to Damaturu on a Wednesday (it was much easier to see him as a journalist). I waited until he had finished discussing with the press in the chamber and then I went to him and dropped the letter in front of him and, without a word, turned and left.

Not quite five minutes later, his police orderly, ASP Kingimi, rushed out with the letter and handed it over to me with his signature of approval.

And so my wife went to Makkah, I became a hero in her eyes, and our marriage hit a new purple patch. And all of that courtesy of Bukar Abba Ibrahim, the man who touched my life and those of many others in Yobe and across Nigeria. May Allah accept his soul into al-Jannat fid daus.

IHR also recalled that before the 2023 Hajj, some disgruntled elements had created a website and shared the links to unsuspecting members of the public alleging that the Crown Prince of Saudi Arabia was sponsoring thousands of people from Nigeria to Hajj free of charge. " An online fact checker pesacheck, traced the internet protocol address link to a location in Oyo state in Nigeria. "Also, while the national coordinator of this group was in Saudi Arabia for pre-Hajj preparations visits, a lot of people kept calling him to verify

the authenticity of Saudi Arabian recruitment of Hajj volunteers from Nigeria to assist in this year's Hajj. According to them, the information was broadcast in earlier statement regarding the recruitment of Hajj volunteers from Nigeria.

"Just yesterday, NAHCON was compelled to issue another

and they need not be drawn into refuting fake news all the time to the detriment of the more important tasks before them. IHR also said it is worrying that this and many such incidences has diplomatic implications during Hajj because Nigeria, which has the fifth largest contingent, plays a vital role in Hajj operations in Saudi Arabia. "While we commend the commission for quickly issuing statements denving the nonexistence of recruitment of Nurses, they should begin to track and arrest all those who use Hajj as a cover to perpetuate fraudulent practices", IHR said.

that reports and monitors Hajj and Umrah activities, has called for the arrest and prosecution of all persons who manufacture, publish and circulate unverified and misleading information about recruitment of staff into the National Hajj Commission of Nigeria (NAHCON) as well as enlistment into Hajj 2024 National Medical Team.

In a statement yesterday, IHR recalled that NAHCON recently issued a statement to debunk a fake news item about recruitment of Nurses for the the Mosque urging those who are interested to apply through a certain foundation.

"Our findings revealed that a female founder of the so-called foundation went to convince the Imam of a Mosque in Kaduna that she was tasked with the job of recruiting Hajj volunteers seeking the assistance of the Imam to help broadcast the news which he obliged.

"After discovering that the lady had no such opportunity, the Imam quickly made a counter announcement withdrawing his disclaimer of a number being used by scammers to call people claiming to be calling from NAHCON," it said.

It added that releasing statements by NAHCON over fake news is becoming a recurring trend and as such, they urged the commission to have all those behind the ignoble messages arrested and prosecuted. This we believe will serve as a deterrent to others.
