

The appointment according to a statement is with effect from the March 2024, in the first 1, instance.



# **Fish Out Killers Of Army Personnel In Delta, Prayer Group Urges FG**

embers of a prayer group V Lunder the aegis of Prayer & Support 4, the Nigerian Armed Forces and other security agencies, have condemned the gruesome killing and mutilation of the bodies of some officers and men of the Nigerian Army who went for a peace mission at Okuama community in the Bomadi Local Government Area of Delta State.

The convener of the group, Ambassador Mary Abayomi Fatile who condemned the act, called on the Federal Government and all necessary stakeholders to look into the gruesome killing of the military personnel, insisting that the government must fish out the murderers and ensure that they face the wrath of the law.

The group in a statement signed by Amb. Abayomi Fatile, strongly condemned the act, noting that the troops of 181 Amphibious Battalion were on a peace mission to the Okuama community where they were surrounded by some youth and killed.

The group listed those affected to include the Commanding Officer of the 181 Amphibious Battalion Lt Col , two majors, one captain & 12 soldiers.

Ambassador Abayomi Fatile emphasized the universal desire for peace and freedom among nations and their citizens.

Despite the gravity of the situation, no meaningful action or statement has been issued in the four days since the incident." she emphasised. The Convener's question

regarding the hope for peaceful coexistence among Nigerians is poignant and underscores the deep-seated apprehension resulting from such incidents. If the military, entrusted with maintaining security and stability, is not immune to such violence, it raises significant doubts about the prospects for peace and security for all Nigerians. The group emphasized the importance of respecting and properly treating the personnel of the armed forces, recognizing them as fathers, uncles, and brothers who protect the nation. They highlighted the need for Nigerians to unite and collaborate as they did during the nation's cup in Cote D'Ivoire to tackle the challenges of insecurity, kidnapping, and other vices.

Ambassador Abayomi Fatile emphasized the significance of offering prayers and love to the

armed forces during this period of insecurity, acknowledging the sacrifices they make by being away from their families for extended periods.

She called upon the federal government, legislators, state governors, and traditional rulers to address the issues at hand and ensure that the perpetrators are appropriately punished to deter others.

Furthermore, Amb. Abayomi Fatile expressed condolences to the families of the deceased personnel and extended prayers for the souls of the fallen soldiers.

She also conveyed sympathies to Chief of Army Staff Lieutenant General Taoreed Lagbaja and Chief of Defense Staff General Christopher Gwabin Musa, while fervently hoping that such tragic events do not reoccur in the future.

### **Governor Raises Alarm Over Criminal Activities Of Scrap Dealers In Ebonyi**

**By; MKPUMA ENVINNA, Abakaliki b** o n y i State Government had vowed to put in place enabling laws to checkmate clandestine activities of scrap dealers in the state.

Governor Nwifuru dropped the hint while swearing in the chairman and members of the Revenue Appeal Commission, in his Office, Ochoudo Centenary City, Abakaliki on Wednesday. The governor while regretting that residents of the state have incurred huge economic losses owing to criminal activities of some of the scrap dealers, maintained that the State can not fold its arms and watch the criminals cash out on the hard earnings of Citizens.

"There is no uncompleted building in this City that they have not stolen the wires, everything, they are now deroofing houses because they are looking for aluminum and they are not even paying taxes."

The governor also cautioned the appointees against indiscriminate taxation of the less privileged persons selling their farm produce in local markets and charged them to go for big time property owners and business moguls.

"I have told the revenue service, I don't want you to go to the village markets and be taxing vegetable sellers, I have said it times without number.

"It is a big challenge to us because it is not showing the electorate that they have a Government. "I don't see reasons why we should be taxing people who are selling what they got from their farms, leaving those who have benefitted from the government and have investments that ought to be paying revenue to the state." He said.

Governor Nwifuru called on the chairman and members of the Revenue Service and Appeal Commission to go about their duties with human face to improve the internally generated revenue of the state and not step on the toes of the people.

"I don't want shouting, I don't want closing people's shops, you have to look at the people's shops and tax them based on what they have, everything is all about negotiations." He

warned.

The governor also warned p e o p l e a g a i n s t indiscriminate siting of markets in areas not approved for such activities by government saying such ventures are bound to give way for government development plans.

"There is no city that everywhere can be market, if it is not a plaza or shopping mall, you cannot open shops along the road." He added.

On - be half of the appointees, the chairman, Chief Augustine Nwankwegu thanked the governor for finding them worthy to serve and assured that they would work hard to improve the revenue status of the state and increase ease of doing business.

# **Nigeria Must Stop Judges, Lawyers From Deciding Election Winners - Mutfwang, Falana, Others**

igeria must ensure that true winners of elections emerge before swearing in, Plateau State Governor, Caleb Mutfwang and human rights activist Femi Falana and others have said.

They spoke separately at the Haske Satumari Foundation annual colloquium with the theme, "Electoral And Judicial Reforms: The Imperatives on Nigeria's Democracy, Governance, Leadership and its selection processes," held at the Yar'Adua Centre Abuja on Thursday.

Plateau State Governor Mutfwang who was shocked by various court pronouncements that came up as a result of the 2023 election petitions, said since leadership has become crucial, it will be unfashionable to allow the judges and lawyers to decide the true winner of election.

"Our leadership recruitment is a fraud. Some of us get into positions of leadership simply by the mercy of God. Not because of fat Bank account.

"We must develop rules that are clear and transparent. Our process is far from being transparent. To strengthen democracy, electoral reform is important.

"Also, comprehensive judicial reforms became expedient because every election circle had its legal regime.

"For the judiciary, there is an urgent need to safeguards its independence and integrity. What we witnessed is partisan interference," Mutfwang said, adding that the judgment that came out as a result of the 2023 elections petitions, even professors of law became confused with the legal jurisprudence.

"Both the lawyers and the judges must up their game. Time has come when lawyers must tell their clients "you have a bad case. Judges and lawyers should not determine who wins the election," Mutfwang added.

He said injustice in the electoral process starts from constituency delineation adding that the country must have a way of resolving it.

Speaking on democracy in Nigeria, Mutfwang said while he doesn't believe in throwing the baby and the bath water, added that military rule will never be inclusive and democratic but a government of few people by few people.

"We can't afford to return to the dark days of military rule. We didn't have a clean constitution in 1999. Falana is here. That's what the military brought and we must not return to military rule," Mutfwang said.

Legal Luminary, Femi Falana said some lawyers in Nigeria deliberately sabotage the system, insisting that Nigeria must decide not to allow lawyers and judges to decide who is an elected representative.

"Electoral system is good. What we should remove is the intervention of the court.

"Let's make the electoral process transparent, transmit the results from the polling unit to the server and insist on electronic transmission.

"If you must know, judges are not suited to determine who wins election. Because they were not there. The winner should be determined by the electorates and not judges," Falana said, adding that Nigeria has the most election cases in the world.

"Pre-election matters should be decided before the election. All pre-election matters should be concluded before swearing in. Tinubu was sworn in, he became ECOWAS leader and we were still determining whether he won the election or not. So, it is a mockery of the system.

"As soon as the election is concluded, all the electoral materials should be made available to the aggrieved party. The rigmarole that goes on in an election has to stop," Falana said, adding that in appointing INEC chairman and Residents Electoral Commissioners, the position should be advertised.

"The best three names should be sent to the Senate for screening. We must go back to the Uwais panel report. All election petitions should be concluded before swearing in," Falana added.

Speaking, former President Goodluck Jonathan who declared the event open, said Nigeria must move forward through open conversation at the Haske Satumari Foundation Colloquium.

Represented by the Vice President during his tenure, Arch Namadi Sambo, Jonathan said he hopes that the outcome of the colloquium will help in the development of Nigeria.

The Mayor of Entebbe in Uganda, Facrice Rulinda, said Africa must look at things that can work for its democracy adding that even in the US, not everybody elects their president. "In Africa, we talk about one man, one vote. Civic education is lacking. The people must know that their vote is their voice, so they should not sell it," Rulinda said, adding that only action will lead to African integration.

The Convener of the colloquium who is also the founder of the Haske Satumari Foundation, Kudla Satumari, said the conversation will help in shaping political discussion in Nigeria as the country prepares to amend the constitution and the electoral act.

"Some of the discussions will be valid in the electoral amendment process. The keynote speakers made valid points. We must ensure that all pre elections causes are settled before the election. We must ensure that all cases are concluded before swearing in.

"Also, we must ensure that the Justice Uwais panel report is implemented. All election cases should be concluded before the swearing in. Judges should not determine the true winner of an election," Kudla added.

# Boko Haram: Zulum Disburses N255m, 5,513 **Bags Of 50kg Rice To CJTF, Hunters**

# Borno To Export Sesame, Cassava, Others From 20 Hectares Irrigation Farm - Zulum

overnor Babagana Umara Zulum of Borno State has said the state government is working assiduously towards attaining food sufficiency and exportation of cash crops and other farm products such as maize and cassava, among others.

The governor stated this on Wednesday at the Koiri Irrigation Farm, one of the pilot drip irrigation schemes of his administration.

364 tonnes of maize and sesame in one crop cycle, while with three cycles per year, the scheme is targeted at cultivating over 1,092 tonnes of maize and other crops annually.

Zulum also noted that his administration will focus on investing in irrigation agriculture to maximise food production in the state.

"Let's carefully put things in order. Borno State will start exporting sesame and other cash crops in the near future. "We will subsequently change focus and invest our resources in irrigation farming or, rather, food production. I assure you that we will provide the political will needed to achieve food sufficiency," Zulum said.

The governor however, ordered for the expansion of the scheme to 300 hectares, with 100 hectares to be cultivated in each senatorial zone," saying, "We need to expand our scope. We should identify bigger land; we can expand with another 100 hectares each in Borno Central, South and North.



# Fire Razes 4 Buildings In Lagos

By; RAYMOND TEDUNJAYE, Lagos n early morning inferno has reportedly razed four buildings in Idumota area of Lagos Island, New Nigerian Newspapers has learnt. One of the buildings was said to have collapsed due to the intensity of the fire which engulfed the structures located at the intersection of Nnamidi Azikwe and Dosunmu on Wednesday.

As gathered, the affected property included three structures of four-storey buildings and one five-storey building. Residents of the area and traders were said to have scampered for safety and held in panic as the fire which begun at about 8.00am rage.

As at the time of filing the report, emergency responders are already combating the inferno to prevent it from escalating to other area.

The Southwest Coordinator of National Emergency Management Agency (NEMA), Ibrahim Farinloye who confirmed the incident, said efforts were ongoing to prevent the inferno from spreading beyond it's present reach.

Speaking in the inferno, the Permanent

Secretary, Lagos State Emergency Management Agency (LASEMA), Dr. Olufemi Oke-Osanyintolu, hinted that the inferno started from the 4-storey building due to power surge after electricity was restored to the building.

According to him, the fire which started at No. 47 Dosunmu Street, escalated to four buildings at No 45, No. 47, No. 49A and No. 49B at Dosunmu Street, Lagos Island. The building at No. 47 collapsed as a result of the impact of the fire.

"The responders are currently combating the fire to prevent further escalation to other adjoining buildings.

"The LASEMA Response team at Lekki alongside LRU Fire, Lagos State Fire and Rescue Service, Federal Fire Men, Nigerian Ports Authority Fire men, LASAMBUS Officials, Lagos Neighbourhood Security Corps (LSNC) officials, Central Business District crew and Nigeria Police Force are all responders present at the scene of the incident under the supervision of the Hon. Commissioner for Special Duties and Intergovernmental Relations, Gbenga Oyerinde.", he stated.

ASWHAN made the advocacy at a press conference recently held at the Akwa Ibom State Agency for the Control of AIDS (AKSACA) in Uyo.

Reflecting on this year's theme of the International Women's Day, "Invest in Women, Accelerate progress", the Association noted the theme as a call to inspire inclusion so as to forge a better society.

Speaking through the State Coordinator of ASWHAN, Mrs. Rachel Ignatius, stressed the need for measures to be put in place for productive grassroot sensitization and functional awareness creation.

"The International Women's Day 2024 global campaign theme; Invest in Women: Accelerate progress is a call to Action for investment in women and girls living with HIV in all diversities to enjoy their rights as live a decent livelihood.

"The theme resonates with the need to empower women with life building skills to reduce their vulnerability and encourage National and International partners to demonstrate their commitment in providing platforms for

women to have access to economic resources." Mrs. Ignatius said.

She also highlighted that inclusion will be inspired when ASWHAN is included in Prevention of Mother to Child Transmission of HIV (PMTCT) interventions amidst other programmes to positively shape the narratives of those living with the virus.

"Federal and State Ministries of Health should engage ASWHAN in PMTCT program implementation and service delivery thereby positioning ASWHAN as the lead CSO for PMTCT in Nigeria to end Mother to child transmission of HIV. No child henceforth should be born with HIV.

"The burden lies with us. We urge all partners to recognize our role in this fight. We ask GLOBAL FUND, the PMTCT Implementing partners to include ASWHAN in the GC7 PMTCT Implementation," the ASWHAN coordinator added.

She also called on the Akwa Ibom State Government to consider the HIV Antistigma and discrimination bill which had not been assented to in the last administration, pointing out that having the law in place would protect the rights of women with HIV as well as those who are not infected with the virus.

Speaking also at the event, the Program Manager of Akwa Ibom State Agency for the Control of AIDS (AKSACA) Dr Enobong Akpan noted poverty as one of



the keys factors affecting the well being of those living with HIV and AIDS in the state.

He called for private and public collaboration to advance the empowerment of women that are infected with the virus with soft loans for business, skills acquisition, saying that it will go a long way in increasing their economic level an ending poverty.

Dr Enobong also mentioned Gender Responsive financing. According to him, funding for women is crucial to end violence against them.

"We join ASWHAN in advocating for funding fo women to end violence against women. We call on various stakeholders to implement what we call Gender Responsive Financing. There is a Global Annual deficit in budget for women especially in the area of violence against women" he stated.

Other organisations such as AKSACA, Ministry of Women Affairs, Ministry of Justice, Map-IT, UNAIDS, UNWomen, Heartland Alliance, among others, spoke on their commitments towards supporting and protecting the rights of women living with

HIV in the state.

The Joint United Nations Programmes on HIV/AIDS - UNAIDS, Dr IDAYAT Idayat Uthman said, "We will continue to support the state in ensuring that the Anti stigma law is enacted. We will not stop. We started the fight and we will see it through".

# Kaduna State APC-led Administration Lacks Coordination - PRP \*Predicts return of PDP to power

Kaduna Zone One Senatorial Candidate during the 2023 general election, under the platform of People Redemption Party (PRP), Abdullahi Ahmad Wakili (Wakilin Jama'a), has observed the unfolding events in the state, under the All Progressives Congress (APC)-led administration, saying it is evidently lacking in idea, direction and coordination.

In a statement issued by Wakili, he said, hence, that is the main reason why the administration is presently experiencing serious setback in execution of socioeconomic/human capital developmental projects.

"I feel duty bound therefore, on behalf of the silent majority, to call on the led administration to publish its 10-months scorecard, hence, explain reasons for

the decimal performance, particularly in the areas of security and infrastructural development, and also state its position on the status of the littered inherited abandoned projects".

"The administration is surrounded by political opportunists, with some appointed in various sensitive political offices, whom by all indication, many of them are not working towards the success of the administration, but instead, are silently advancing their personal political ambition comes 2027".

"The APC administration has

undoubtedly created good opportunity for the leading opposition party in the state, the People's Democratic Party (PDP) to maximally leverage on and possibly bounce back. Regrettably, Kaduna state chapters of the PDP is still in the state of disarray, still being hunted by its dark past.

"This has made the PDP to have failed to occupy the wide opposition space created by the present administration in Kaduna State," he said.

He said it is overdue for the opposition parties in Kaduna state to join hands in discharging their constitutional responsibility of righting the wrong in moving kaduna state forward.

In size, political stature and achievements, Sir Ahmadu Bello loomed large across the arena. Sardauna, as he was called, built people, edifices and institutions as Premier of Northern Nigeria. However, the Colossus was killed in 1966 and as yet, his political dexterity remains unparalleled in the north.

Specifically, Senator Uba Sani, the Kaduna State Governor, is approximating him in some respects. Similarly, in his strategic engagement, Senator Uba Sani chairs the quarterly Inter-Religious Harmony Committee, where he rubs minds with religious leaders. Likewise, the Chairman of Chikun Local Government, Mr Salasi Musa and his Councillors have left PDP, a party on whose platform they were voted into office. Similarly, Kajuru Local Government Chairman, Hon Ibrahim Gajere, has voted with his feet, so has Hon Mathias Siman, his counterpart at Kaura Area Council. Last Monday, Alhaji Muktar Ramalan Yero, ex Governor of Kaduna State, formally ditched PDP for the ruling APC. Likewise, financial inclusion tops the Governor's agenda, from signing an Executive Order, to empowering Micro, Medium and Small

Enterprises, as well as providing succour to individuals. Last Monday, Senator Uba Sani flagged off the distribution of palliatives, especially to the poor, vulnerable and underserved, as well as senior citizens of Kaduna State. Cumulatively, the Government is spending N11.4 billion for the exercise. Indeed, 128 trucks of rice and maize worth N3.4 billion, were distributed, targeting 200,000 households, in this second round of palliatives distribution. Approximately, 1,000,000 persons are expected to benefit across the three senatorial districts. Similarly, the sum of N4.2 billion has been earmarked for cash, grants, fertilizer a n d farm inputs distribution. Beneficiaries include vulnerable

households, smallholder farmers and MSMEs, as well as Persons With Disability, Internally Displaced Persons (IDPs), Orphans, including market women and youths. Likewise, N3.3 billion has been released for Pension and Gratuities, as well as Death Benefits to families of deceased civil servants. Besides, civil servants are benefitting from a N500 million Revolving Loan Scheme. From enabling religious harmony, to being evenhanded to all citizens and providing succour to the vulnerable, including extending a handshake to political opponents, Sir Ahmadu Bello fostered the concept of "one north, one people." Senator Uba Sani may as well be reading from that playbook.

# Nigerians, Where Is The Outrage?

HAVE said this before, one of my greatest fears about the future of Nigeria is our collective loss of the capacity for anger. The political class knows it, they can do what they want and get away with it because we simply note what they are doing, grumble and continue our daily hustle for survival.

It was the Cameroonian author, Prof Celestin Monga, who reminded us in his book, The Anthropology of Anger: Civil Society and Democracy in Africa, that the capacity of civil society and citizens in Africa to advance the democratisation agenda of their countries is a function of their ability to express outrage at the destruction of their societies and its assets by selfish ruling classes.

Today, Nigeria is in misery, suffering from a terrible cost of living crisis similar to the one experienced in 1945/1946, and all that happened is a one-day strike to make speeches about promises not kept. The second day of the protest was cancelled because the labour unions were afraid government could get angry and deal with them. That's our lot, we have lost the capacity to really get angry at those messing us up.

The nouns that define how we feel are important indications of our capacity to act. Anger, rage, fury, ire, wrath, resentment and indignation are vital elements in creating human agency and carrying out a real transformation agenda. The Labour Movement And The Politics Of Liberation In Nigeria – Part Three; By Omotoye Olorode

Fury denotes our marked displeasure at a particular situation and demonstrates we have not given up and substituted passive sadness for anger. Every week, Nigerians are inundated with news stories about massive corruption and bad governance. The least we can do is show our indignation at how our rulers are ruining our country.

Following the end of the Second World War, the anger of Nigerians at British misrule boiled. Nigeria had a leadership that could channel the anger. Herbert Macaulay, Michael Imoudu and Nnamdi Azikiwe organised a national strike in 1945 and in 1946, toured 153 communities to get the popular mandate to end colonial rule and use Nigerian resources for Nigerian development. In Kano, Ibadan, Enugu and Lagos, tens of thousands of Nigerians turned up in the "cost of living" demonstrations and the death knell of colonialism was sounded. Herbert Macaulay, the 82-year-old "angry nationalist", died on his way back from the Kano rally. The British authorities, seeing the anger of the people, were forced to stop making the claims that the nationalist leaders were talking for the elite and not for the masses. Today, Nigeria is in misery, suffering from a terrible cost of living crisis similar to the one experienced in 1945/1946, and all that happened is a one-day strike to make speeches about promises not kept. The second day of the protest was cancelled because the labour unions were afraid government could get angry and deal with them. That's our lot, we have lost the capacity to really get angry at those messing us up.


Over the past two decades, no general strike has lasted more than two days. It starts with apparent anger and ends with a whimper signalling some money have changed hands. The government knows the price it has to pay to "settle" a general strike. How can they take citizens seriously knowing the leadership to channel anger into effective results no longer exists?

Every day, there are reports on massive corruption by government officials who simply pocket billions and billions of public money and accountability mechanisms are almost never not activated against them. Nigerians simply watch and wonder at the depth of corruption and simply show no appreciation that these are public resources that could have gone a long way in addressing the crisis faced by the people but are privatised and accumulated by a few.

Today, Nigerians are suffering because they can no longer feed their families as stagnant wages and food inflation makes it impossible for them to get enough to eat. They should have been furious because they know that the decisions to remove fuel subsidy and float the naira were made precisely to produce this outcome. By these acts, Nigerians were guaranteed to suffer extremely high costs for transport, food and other essentials. It is a policy framework aimed at deepening poverty and the suffering of Nigerians.

Today, Nigerian citizens live in deep fear because of the insecurity that defines their daily existence. Millions of farmers can no longer farm their land because gunmen attack and kill them or impose taxes to "allow" them farm because they have the guns. Nigerians cannot travel anymore because they cannot afford the fare or because they are afraid of being kidnapped for ransom.

Nigerians cannot even worship in peace



because they are afraid terrorists could attack and kill them while worshiping in their churches and mosques. Where is the anger that flows from their knowledge that government has constitutional responsibility to provide for their security and welfare and it is simply not doing so? Increasingly, the rights of the citizens of Nigeria to protest against bad governance, the right to dissent and to freedom of expression as guaranteed by the Constitution is denied, frustrated and challenged by the governing class. Meanwhile, Nigerians continue to watch and wonder. Dear Nigerians, when will we get out of the trap of passive sadness? Where is the anger, rage, fury, ire, wrath, resentment and indignation against bad and irresponsible governance in Nigeria? Every day, there are reports on massive corruption by government officials who simply pocket billions and billions of

public money and accountability mechanisms are almost never not activated against them. Nigerians simply watch and wonder at the depth of corruption and simply show no appreciation that these are public resources that could have gone a long way in addressing the crisis faced by the people but are privatised and accumulated by a few.

In terms of the political process, the electoral choices made by or sought for by Nigerians are often subverted using money, violence or the courts that specialise these days in removing elected officials chosen by the people and replacing them with people "illegally imposed" by judges who interfere continuously with electoral outcomes. The judiciary which is supposed to be the last hope of the common people is today almost entirely controlled by the political class and the people continue to watch and wonder. Increasingly, the rights of the citizens of Nigeria to protest against bad governance, the right to dissent and to freedom of expression as guaranteed by the Constitution is denied, frustrated and challenged by the governing class. Meanwhile, Nigerians continue to watch and wonder. Dear Nigerians, when will we get out of the trap of passive sadness? Where is the anger, rage, fury, ire, wrath, resentment and indignation against bad and irresponsible governance in Nigeria? The governor implored the Special Advisers and the people of Kano to fervently pray for enduring peace, stability, and prosperity in the state and the nation as a whole.

Former Minister of Power, Dr Olu Agunloye is to appeal the Monday's ruling of a Federal High Court in Abuja, dismissing his suit to restrain the Economic and Financial Crimes Commission (EFCC), from harassing him and breaching his fundamental rights on the ongoing International Arbitration on Mambilla Power Project

It was reliably gathered that Dr. Agunloye's lawyers have expressed preparedness in respect of the appeal considering that the court admitted basing its ruling on the suit being, "an attempt to use the instrumentality of the court to shield the applicant from with the statutory authority of the Respondent to investigate crimes or allegations of same in line with the EFCCAct."

Sources stressed that it is believed that the duties of EFCC must be performed in accordance with the law, and the court has the powers to stop any infraction by the EFCC in the course of performance of its duties.

According to the sources, " Such does not amount to interference with the statutory duties of EFCC but a legal checkmate of its powers to deter likely abuse.

New Nigerian recalled that the suit filed by Dr Agunloye in June 2023 to restrain

breaching his fundamental rights because of the ongoing International Arbitration on Mambilla Power Project was on Monday, 18 March 2024 dismissed by Justice Obiora Egwuatu at the Federal High Court in Abuja. The points made by Agunloye in the civil suit which has dragged for over nine months had become irrelevant or expired in reality because the EFCC, the Respondent, had, while the case was in progress, declared Agunloye wanted, detained him, maltreated him in detention, arraigned him before another court and remanded him in prison until the court granted him bail.
