here's palpable fears in Kaduna yesterday morning over an outbreak of disease suspected to be Viral Haemorrhagic Fever otherwise known as Lassa Fever at the Nigerian Army 44 Reference Hospital in Kaduna.

It was gathered that already over 10 people

(though not confirmed) were affected as at yesterday morning, some are dead while others are in critical conditions as a result of the outbreak. Though details of the affected persons were not d is c l o s e d y e t, b u t information has it that a youth corps member, two medical doctors and a nurse are feared dead.

Some of those that have been confirmed dead include a Youth Corp

# **Dangote Cement Trucks Wrongfully Intercepted** In Adamawa - Management

\*Says they don't need to export to Cameroun where they have an existing cement plant

he management of Dangote Cement Plc has stated that two of its trucks that were wrongly intercepted in Adamawa State have been released.

The company said the two trucks loaded with 900 bags of cement each from the Obajana Cement Plant were on their way to Jamtari, Maiha Local Government, Adamawa State, based on a customer's request.

However, they were intercepted by security agents who accused them of trying to export banned products to the Republic of Cameroun through the Adamawa routes.

The interception, on

Friday, February 9, 2024, followed an executive order banning the transportation of food and building materials across the country's border through Adamawa routes by the Adamawa State Government.

A statement signed by the Group's Chief Branding and Communication Officer, Mr. Anthony Chiejina, revealed that the company has a functional cement plant in Cameroun and that, the allegation of attempting to export cement there is false and malicious.

Chiejina explained that the two trucks were on their way to deliver products requested by a customer and wondered why the security agents would intercept and accuse them of attempting to divert their load to the Republic of Cameroun.

Mr. Chiejina said: "It was surprising that on their way to deliver the products to the stated address, the security agents on that particular route intercepted them at a village called Wurolabi." He said the officers who made the arrest insisted the trucks were on diversion since they apparently did not pay attention to details of what was written on the waybill. The company said the two drivers tried to explain to the soldiers, but to no avail.

He added: "Our officials were thereafter invited by the DSS Adamawa State, and we explained to them

the true position of things. We had to show them the tracking movement of the trucks from the DCP Obajana to the last point where they were arrested by the soldiers, to convince them that the trucks were not crossing to the republic of Cameroon as was being wrongfully insinuated by some

media." In the same vein, the Government of Adamawa State, at a press briefing with the Adamawa State Police Headquarters, also on Friday February 16, confirmed that both trucks were intended to deliver within the state and were escorted by police to deliver the products to the customer.

# Tragedy: Pregnant Wife Throws Husband Out of Two-Storey Building In Ebonyi

pregnant woman has thrown her husband out of two-storey building as a result of unresolved family problem.

According to an eyewitness who wouldn't want his name in print, the tragedy occurred on Tuesday morning in Ebonyi, when the victim, Mr Nwoga Maduabuchi, a middle-aged man was pushed

away from a two-storey building.

The victim, Mr Nwoga Maduabuchi, from Akparata Village, Igbeagu community in the Izzi Local Government Area of Ebonyi State, was said to have been married to the suspect, his second wife, from Uburu community, in the Ohaozara Local Government Area and lived in Abakaliki, the state capital.

A security officer, who spoke to our correspondent on condition of anonymity, said the victim was arguing with his second wife over a family issue, when the incident occurred.

A source said, "The man is just a victim of domestic violence.

"He had two wives. The first wife is from Izzi Local Government Area; while the second wife is from Uburu, in the Ohaozara Local Government Area of the state.

"It's a family matter. But the second became so enraged over the matter and acted the way she did, by pushing her husband down from the two-storey building. That's the height of it. That's the height of wickedness." Another reliable source, who equally pleaded anonymity, said the suspect was heavily pregnant but was intermittently having quarrels with her late husband, adding that, "The second wife was constantly nagging." Speaking with a villager, Mr.Ogo Mike, he described the situation as horrible, saying the victim was an elder brother to his friend. When contacted for his reaction, the Police Public Relations Officer in Ebonyi State Police Command, DSP Ukandu Joshua, did not respond to all the calls placed on his phone as at the time of filling this report.

### Delta Govt Debunks Relocation Rumours Of Campus, Calls For Peace In Isoko Community

The Delta State Government has issued a resolute call for peace amidst swirling rumours and discord, In a bid to quell rising tensions in Ozoro,

Isoko North Local Government Area of the State Recall that hundreds of women and youth in a protest few days ago, blocked the Ozoro/Kwale/Asaba Expressway

in Isoko. Our correspondent earlier reported that the women and youth are protesting the relocation of the Faculty of Business Administration, Delta State University of Science and Technology, Ozoro to Orerokpe community, the local government of the current Delta State Governor, Sheriff Oborevworii.

The protesters had earlier said, "the relocation of the faculty from the institution will greatly affect the economic life of Ozoro town"

The Isoko Protesters bore different placards with inscriptions, demanded that the faculty be returned to the institution.

The youths were seen at the Owhelogbo junction, just as the women were dancing round the community.

Travellers going to Asaba and Onitsha in Anambra State have been forced to take alternative routes.

The protesters called on Governor Oborevwori, to as a matter of urgency, relocate the faculty back to the university's main campus.

Reacting to the protest, the Delta State Governor, Oborevworii Refuted the Relocation but said it's a rumor and called for peace in Isoko community.

Dr. Ifeanyi Osuoza, the State Commissioner for Information, delivered a stern message urging communities to steer clear of divisive narratives and embrace harmony.

According to Osuoza, "the alleged relocation of the Delta State University of Science and Technology, Ozoro, such claims were unequivocally false.

"This narrative is not only dangerously misleading, it is also deviously manipulated misinformation and negative propaganda, fueled by known political detractors to achieve selfish political gains," he started.

Osuoza expressed disappointment over recent protests purportedly instigated by certain factions within Isoko land, despite constructive engagements between the government and community leaders.

"The sponsored protest is uncalled for after the successful meeting with His Excellency, the Governor of the state," he lamented.

Osuoza further clarified that the institution in question was not undergoing relocation, but instead, celebrated a significant academic milestone.

"For the avoidance of doubts and to set the records straight, the Delta State University of Science and Technology is NOT being relocated and has not been relocated" he affirmed.

Meanwhile, He highlighted the approval by the National Universities Commission (NUC) for the establishment of crucial faculties at the university, emphasizing the government's commitment to bolstering educational standards.

# Nationwide Protest: Governors Sabotaging Tinubu's Efforts, Coalition Says

he Nigeria Civil Society Forum has warned the Nigeria Labour Congress (NLC) against its proposed nationwide protest against hardship scheduled to hold on February 27 and 28. The CSO forum said

Nigerians should rather blame the state governors for sabotaging the federal g o v e r n m e n t b y embezzling the palliatives meant for the masses.

Addressing a press conference yesterday in Abuja, Convener of the Coalition, Dr. Godwin Abutu said while it's a known fact that Nigerians are going through difficult times at the moment, the government has given assurances on a daily basis of rallying round the clock to ameliorate the sufferings of the people with different incentives. The CSO forum said NLC chapters in the state where state Governors sabotaging federal government efforts, the Labour leaders have played the toothless bulldog scenario they are known for, and Nigerians keep suffering under their watchful eyes.

Dr. Abutu said: "While we are not worried over the empty and baseless threats to drag the government through the strike, we are once again concerned that this groups has always used these threats to collect gratifications from government and betray the people, a situation we are out to arrest this time as spokespersons of the masses of this country.

"Even though the NLC further contradicted itself by abandoning the wage negotiation table set up by the government to improve the wages of workers to go and embark on this macabre dance that has no head or tail. We expected the leadership of these trade unions to have contributed their opinions of how we would come out of this quagmire with such a privilege rather than embarking on this wild goose chase."

The group emphasised

that it was common knowledge that embarking on strike actions has not resolved any problem faced by the Nigerian masses recently.

member serving at the hospital and three staff of the hospital.

The hospital as at the time of this report was sealed and restrictions placed to control and prevent further spread of the disease.

Some people seen around the hospital gate trying to catch up some appointments and those seeking medical attention lamented that the hospital management was yet to address them on what was going on and couldn't get them an alternative.

But in circular by the Nigerian Army Medical Corps, sent to all military hospitals and medical centres signed by the Ag, Corps Commander of the Nigerian Army Medical Corps (CCM), Brig Gen. S.O Okoigi, the Accident and Emergency (A&E) Dept of 44 NARHK witnessed the loss of three members of staff and a patient in the last 48 hours with some in critical condition.

According to the circular, "They are suspected to have died from Acute Viral Hemorrhagic Fever (VHF). This followed the management of a patient with febrile illness thought to have been the index patient with the disease 10 days ago, having presented with a febrile illness.

"The patient also died from the suspected disease condition. The common symptoms in those affected included fever, and nonspecific symptoms likened to malaria. However, the illness was complicated by abnormal liver function, acute kidney failure, encephalopathy, microangiopathy, elevated D-Dimer among others. "The A&E has been closed for thorough disinfection process and samples have been taken from suspected contacts and the deceased and sent to the Nigeria Centre for Disease Control (NCDC) laboratory in Kano for analysis. Similarly, the Kaduna State Epidemiologists have been invited to help in unraveling the actiology of the febrile illness with a view to curtailing the



2024 said Lassa Fever, generally infects victims with the following symptoms - fever, general body weakness and after a few days, headache, sore throat, muscle pain, chest pain, nausea, vomiting, diarrhoea, cough, and abdominal pain may follow. Currently, four deaths have been recorded all within the hospital premises while three other patients with similar symptoms are currently being managed. The Kaduna State Ministry of

spread of the disease. "This is in addition to strict disease Infection Prevention and Control (IPC) measures that have been directed to be emplaced. Ribavirin injection (antiviral agent) has also been commenced on other suspected cases and those identified on contact tracing. 44 NARHK have also been directed to suspend accepting new cases from the general public in the interim while the situation is being contained."

The hospital in a notification, explained that the Epidemiology Unit receive a report 20/02/2024 of outbreak of suspected Lassa fever and a team of surveillance officers from the LGA was deployed to investigate the report. The hospital has recorded four mortalities from the similar illness." They added.

They further explained that some of the actions taken so far includes "Six Lassa fever samples were collected and sent to Bayero University Kano for analysis and the result are being awaited. A total of 25 contacts have been line-listed for follow up. The close contacts were placed on prophylactic treatment.

"Ribavirin was supplied from the Ministry of Health to 44 Army Reference Hospital to support case management. suspected cases of Lassa Fever to the nearest health facility.

The State Governor Senator Uba Sani, in a statement signed by his Chief Press Secretary, Muhammad Lawal Shehu, said the State Ministry of Health has been directed to enhance surveillance across the state in collaboration with local government heath departments. "Additionally, all Infection Prevention and Control (IPC) measures have been instituted at the facility while it remains closed to the public until full management of 44 Nigerian Army Reference Hospital, are working assiduously to contain the situation as all those who came in contact with those infected have been identified and are closely being monitored while receiving urgent medical treatment.

Furthermore, samples have been carefully collected from contacts and sent for confirmation to the Nigeria Centre for Disease Control laboratory and are closely being followed up. Additionally, all Infection Prevention and Control (IPC) measures have been instituted at the facility while it remains closed to the public, until full containment has been achieved. Members of the public are hereby advised to maintain proper food and environmental hygiene as they remain hyper vigilant to immediately report any suspected cases of Lassa Fever to the nearest health facility. Kaduna State Ministry of Health has further been directed to enhance surveillance across the state in collaboration with local government heath departments.

The team confirmed that the index case was a female Youth Copper who resides in the quarters of 44 Army Reference Hospital, noting that her illness started a week ago with symptoms of fever, head ache and later convulsion.

"In the process of convulsing, she bites her tongue and started bleeding. Three other patients presented with similar illnesses. The hospital said why they await results of samples collected, and active case search within the hospital communities and the environs is already intensified. And that a follow up on the contact line-listed to intensify risk communication activities on prevention of Lassa fever is ongoing.

Meanwhile, the Kaduna State government has advised members of the public to maintain proper food and environmental hygiene as they remain hyper vigilant to immediately report any

enator Abubakar Halilu Girei has marshalled out strategies which the federal government can use to generate huge resources to be able to address the economic and security challenges rocking the nation.

Girei during a press conference in Yola on Wednesday, said Nigeria can generate over N500 trillion which is enough to cater for the yearnings and aspirations of all Nigerians and to combat the socio-economic challenges besetting the nation.

He advised President Bola Ahmed Tinubu to as a matter of serious national emergency constitute an independent judicial panel of enquiry to unravel the massive economic and financial crimes carried out in the last 12 years and to recover stolen monies which he said will be enough to resolve all our developmental needs and address food shortages and other critical national challenges.

"I'm calling on Mr. President to set up an independent panel of enquiry to carry out forensic investigation into the massive theft of our resources in the last 12 years.

It will enable us to recover humongous amount of money looted. I have no doubt we will be able to recover more than N500 trillion that have been stolen from Nigeria.

"These monies will be more than enough to revamp our economy. I have no doubt Tinubu has the capacity and political will to do that if only Nigerians continue to advise him appropriately.

Girei who represented Adamawa central senatorial zone between 1999 - 2003 in a ten point recommendation made case for the banning of Bureau de change markets and establishment of state police.

"I want to use this singular opportunity to appeal to President Bola Ahmed Tinubu to as a matter of critical urgency establish an Independent Judicial Commission of Enquiry with the mandate to carryout forensic investigation and recover all the funds that have been looted in the last 12 years especially as it concerns; mismanagement of petroleum subsidy; mismanagement and looting of forex by officials of CBN, commercial banks and other financial institutions; carry out forensic investigation on fraud associated with tax, VAT and other revenues accruing to the federation, including tax waivers over the period of 12 years.

"Those who rode our nation roughshod in the last 12 years, and looted our treasury with impunity should be brought to justice to answer for the atrocities they meted to our people and their loots confiscated. A special purpose entity should be empaneled by the presidency to investigate, recover and punish the ones found guilty," he said.

On the security turf, Girei advised the president to come up with a supplementary budget of two trillion naira to address Nigeria's social insecurity including putting up robust

structures for the take off of state policing.

"The sum of two trillion Naira to be approved by the national assembly as an additional supplementary budget to tackle insecurity challenges nationwide including the establishment of the state police when passed into law should be pursued," he said.

Girei also appealed to the president to come up with another one trillion supplementary budget for immediate approval for bank of agriculture to fund credit delivery to all value chains in the

agricultural and Livestock sectors in order to address the issue of hunger and create job opportunities for millions of Nigerians.

" I call on the president to present a supplementary budget of one trillion naira to the NASS for immediate approval for Bank of Agriculture to fund credit delivery to all the value chains in the Agricultural and Livestock sector," he said.

The politician who vouched for the commitment of president Bola Ahmed Tinubu to find a lasting solution to Nigeria's challenges urged well meaning Nigerians to come up with cogent suggestions on the way forward.

" I believe very strongly that



there is a great difference between Bola Ahmed Tinubu and other leaders because he is a thoroughbred politician who has demonstrated that he is listening to the yearnings and aspirations of Nigerians making him to be passionate about the cries of Nigerians by convening stakeholders meeting with governors, security operatives and other critical stakeholders including cement manufacturers so that he will be able to bring down the prices of goods and services in order to make life easier for the common man.

"This is not a time for blame games. This is a time for each and every Nigerian to contribute to help president Bola Ahmed Tinubu take the right actions that will bail us out. That is why I

came out to make about 10 recommendations here.

"This is a new government as far as I'm concerned. The president should be advised on how to go about leading the nation in a just manner and that is what I'm doing now. I'm urging other Nigerians who are concerned, who are patriotic who are interested in the well being of this country to assist our leaders to do something good.

"During the eight years of president Buhari we had almost on everyday basis hoped, wished and prayed that things will improve tomorrow but they never did. We cannot continue to do that now we must help our leaders with advise to salvage the situation," he added.

# Civil Service Reforms: Gombe Recruits Over 400 Personnel To Man Biometric Attendance Machines

\*Governor Inuwa Yahaya Flags-off Induction Training for Supervisors \*Biometric system not intended to witch-hunt civil servants — NLC

Grecruited over 400 personnel Biometric Attendance Supervisors (BAS) to oversee the operation of over 4,000 Biometric Attendance Machines installed in various state and local government offices aimed at boosting productivity and efficiency in the State's Civil Service.

This was disclosed by Governor Muhammadu Inuwa Yahaya CON during the inauguration of a 1-day induction training for supervisors numbering 305 who were recently selected after a screening process.

Governor Inuwa Yahaya, represented by his deputy, Dr. Manassah Daniel Jatau, reiterated that the implementation of the biometric system in the civil service was essential to identify ghost workers who have long imposed a significant financial strain on both state and local governments.

"The issue of uncertain number of employees at the local government council,state civil service and even the Federal Civil Service has bedeviled the governments and those in authority over the years. In Gombe State attempts by previous governments to solve the riddle by way of verification year in year out has not solved the problem. This is unacceptable, lamentable and a clear negation of transparency, integrity and even religious teachings".

He emphasized that during his tenure, funds earmarked for addressing socioeconomic challenges and citizen welfare would not be indiscriminately allocated to non-working individuals masquerading within the civil service.

"In 2019, upon assuming office, we initiated transformative policies to reform the civil service. Recognizing the previous administration's attempts to tackle the issue of an uncertain number of employees through annual verification exercises - which proved unsuccessful, we opted for a new approach. Our goal is

to identify ghost workers, facilitate employment opportunities for genuine workers, and improve overall productivity within the service. My dear 305 Supervisors and the 115 others engaged, the deployment of these machines is equally part of our reform initiatives in the civil service", the Governor said.

"We have no ill intentions on the implementation of this Biometric Attendance System. Our sole aim is to have a highly effective and efficient civil service in Gombe, one that fosters productivity and drives the development and prosperity outlined in our development plan. As a direct outcome of this initiative, Gombe now receives foreign grants, which we utilize to reshape the socio-economic landscape of the state. Furthermore, the implementation of the biometric system has enabled us to engage over 400 individuals on our payroll as new employees", the Governor added.

The Governor also noted that since the introduction of the biometric system in October 2021, Gombe has consistently saved over 23 million naira monthly, totaling over 1.4 billion naira.

He emphasized that these savings are part of what is being allocated towards settling the backlog of gratuity at both the state and local government levels.

In his remarks, the Commissioner of Finance and Economic Development, Malam Muhammad Gambo Magaji, explained that the implementation of the biometric system is an integral component of the financial management reforms initiated by the Inuwa-led administration, underscoring the importance of cleansing the state's payroll.

He announced that as a direct result of implementing the biometric system, Gombe State has successfully obtained a \$4 million grant from the World Bank's SFTAS programme.

He also highlighted that the introduction



of the biometric system, along with other initiatives, has positioned Gombe State as the top-ranking state in Nigeria for Payroll Management.

In their separate remarks, the Head of Service, Alhaji Ahmed Kasimu Abdullah, the Chairperson of the Civil Service Commission, Hajia Rabi Shu'aibu Jimeta, mni, and the Accountant General of the State, Dr. Aminu Umar Yuguda, emphasized the significance of the biometric system.

They urged the newly recruited employees to approach their roles with dedication and sincerity, recognizing the sacredness of their responsibilities and the importance they have towards the success of the system.

Earlier in his welcome address, the Biometric Programme Consultant, Dr. Isma'il Musa Jibrin, explained that the system is designed to promote fairness and accountability, guaranteeing that no worker is unfairly penalized as every diligent civil servants will continue to receive their monthly renumeration. The representative of the Gombe State Chapter of the Nigeria Labour Congress (NLC), Comrade Adamu Garba, expressed gratitude to Governor Inuwa Yahaya for his commendable reforms in the civil service and for the consistent payment of gratuity to retired civil servants at both state and local levels.

He affirmed that the implementation of the biometric attendance system in the state civil service is aimed at streamlining the service to enhance productivity and efficiency.

"Let me call on all the civil servants in the state to cooperate for the success of this exercise. The exercise is not meant to witch-hunt any worker. It is meant to sanitize the payroll of Gombe State and at the same time block leakages. It is based on the implementation of this system that these people are employed today. We appreciate the Governor for decreasing the number of unemployed persons in Gombe State through his various initiatives", NLC representative said.



# Power Supply: Nasarawa Govt Distributes 150 Transformers, Expresses Readiness To Build N500m Substation

Overnor Abdullahi Sule of Nasarawa State has said that his administration has so far distributed 150 transformers aimed at improving power supply across the state.

This is just as Governor Sule expressed readiness to build another power substation estimated at five hundred million Naira, in order to improve electricity supply especially in Lafia, the state capital.

Governor Sule made this known when he met with Regional Manager of the Abuja Electricity Distribution Company (AEDC), Engr. Baro Ahmed, at the Government House in Lafia.

The meeting, which was at the instance of the governor, was aimed at addressing the persistent power supply problem, especially in Lafia and environs.

According to the governor, though it shouldn't be the business of government to buy transformers, especially that AEDC is the only company responsible for collecting revenue from power consumers, his administration has gone ahead to buy 150 transformers in order that communities in the state could be linked to the national grid.

He showed his readiness to enter an agreement with the management of the AEDC with a view to constructing another power substation in Lafia, estimated to cost five hundred million naira.

The governor thereafter, directed the General Manager of the Nasarawa Electricity Power Agency (NaEPA), Engr. Yakubu Sulaiman Umar to arrange a meeting with the management of AEDC in Abuja where modalities for the agreement would be discussed.

Governor Sule said he called the meeting because of the persistent complaints from electricity consumers from across the state, who continously express their dissatisfaction with power supply recently.

He said he wanted to hear from AEDC why power supply especially in Lafia, the Nasarawa State capital has been epileptic.

On realizing that the issue is not even the matter of distribution, with Lafia that used to get 20 megawatts of electricity now only able to get seven megawatts, the Governor blamed the AEDC for lacking a robust communication system to inform their consumers of what is happening.

He added that sometimes the AEDC takes the heat that is not theirs because the company is not communicating for their consumers to get to understand what is happening.

"People of Lafia were supposed to be getting 20 megawatts every day. We are only getting seven megawatts. You need to create public awareness. The country is not generating enough but that you are having peculiar issues here in Lafia," he said.

Governor Sule insisted that AEDC should have opened up to the people of Lafia by telling them that four years ago, Lafia needed only 4 megawatts daily but that now it needs 20 megawatts because of the springing up of mini industries.

He explained that his

administration has invested huge resources in the area of power and is ready to take necessary steps towards ensuring steady electricity supply in the state, especially in Lafia, the state capital.

He reiterated the readiness of his administration to work with critical stakeholders in the power sector in order to ensure improved power supply to the state and especially Lafia, the state capital.

Also speaking, Secretary to the Government of Nasarawa State, Barrister Mohammed Ubandoma Aliyu, urged officials of the AEDC to proceed with caution when they go out to collect electricity dues, especially that the power supply in the month of February was poor.

The SGNS called on AEDC to consider the prevailing hardship being experienced across the country, and not to charge their customers exorbitantly, particularly that they did not enjoyed steady power supply in this month of February.

Earlier, General Manager, Nasarawa Electricity Power Agency (NaEPA), Engr. Yakubu Sulaiman Umar, said the meeting was at the instance of Governor Sule, for the officials of the power company to ascertain factors responsible for the poor power supply in the state especially Lafia and its environs.

Responding, Regional Manager of Abuja Electricity Distribution Company (AEDC) Engineer Baro Ahmed, disclosed that presently the country is generating only 4000 megawatts of power, which he said is grossly inadequate.

Engr. Ahmed pointed out that Lafia



that used to get 20 megawatts daily now gets only 7 megawatts.

He however explained that Lafia is currently experiencing power supply issues because of peculiar problems associated with overloading of available feeders.

The AEDC regional manager accepted to communicate further on the willingness of the state government to partner the power company with a view to constructing another substation that would serve to decongest the valuable feeders.

On his part, AEDC Lafia Manager, Isa Mohammed, said an additional power substation would greatly improve power supply especially in Lafia the state capital.

He commended Governor Sule for his efforts to attract investors into the state, which has brought improved revenue to the AEDC.

"Today, because of the emergence of mini industries, Lafia is needing about 20 megawatts daily," he said. He particularly appreciated the Governor for doing a lot to ensure that power is supplied across the state.

"I never new a governor will come, a cable you buy, transformer you buy. What are we talking about? Your people should appreciate you. You are doing a lot," the Lafia AEDC Manager said.

# **FRN Vs Ali Bello & Anor:** Co-defendant, Daudu Tackles EFCC On Competence Of Amended Charges

Trial could not continue yesterday, in the Charge m a r k e d FHC/ABJ/CR/550/2022: FRN v. Ali Bello & Anor, before Justice J. K Omotosho at the Federal High Court, in Abuja, owing to concerns about the competence of the charge, including the amended charges brought by the Economic and Financial Crimes Commission (EFCC).

Ali Bello's co-defendant,

Suleiman Daudu, through his counsel and Senior Advocate of Nigeria (SAN), Nureni Jimoh, raised objections against the fresh charges by EFCC.

Although the amended charges have not been read to them for their plea to be taken afresh, the co-defendant is praying the court to reject it outrightly.

However, the motion challenging the amended charges could not be entertained by Justice James Omotoso due to some flaws discovered in the motion.

Justice Omotoso subsequently ordered the lawyers to the 2nd defendant to re- file the motion and bring it back to the court on February 23.

The Judge said that he would unfailingly determine the motion first before proceeding with the trial of the defendants in the alleged offences filed against them by the anti-graft agency. The matter has been shifted to February 23 for the motion and objections of the EFCC to be heard.

When the matter was called, Nureni Jimoh, SAN told the court that he had filed an application challenging EFCC's amended charge.

The prosecutor, Oyedepo Rotimi, SAN, however, said that he had yet to receive the application.

The 2nd defendant counsel also objected to the presence of the prosecution's 4th witness in court, Yakubu Haruna, on the ground that his name was not listed on the witness list given to his team.

The prosecutor said that he had filed the amended charge against the defendants and that all the names of the witnesses he intended to call were listed. Ali Bello and Dauda Suleiman, are standing trial on a 10-count criminal charge, bordering on money laundering brought against them by the EFCC.

# **World Bank And IMF: In The Shadow Of Their Talons**

HE AMERICAN World Bank and the European International Monetary Fund (IMF), have in the past few weeks circled round Nigeria like vultures waiting for the prey to die.

The twin organisations have become more active and quite audacious since President Bola Ahmed Tinubu came to power on May 29, 2023. They are like predators, ready for the kill.

While Nigerians are hungry and their anger is beginning to boil over to street protests due to the stifling economic policies of the Tinubu administration, these organisations are praising Tinubu to the high heavens and telling him to tighten the noose round the necks of the people.

So, why are the IMF and World Bank so callous and inhuman? It is simply because that is why they were set up in the first place; to exploit poor countries, degrade and destroy their production capacity, control their resources and destroy their education system so they will be incapable of thinking.

Inflation is at 32 per cent. Fuel price increased from N238 per litre on Inauguration Day to N617-N700, and the naira has dipped from a depth of about N700 to the dollar last year to over N1,500. While these have resulted in devastating consequences, both institutions tell Tinubu he has not gone far enough.

In its Friday, February 9, 2024, statement, the IMF praised Tinubu for making "a strong start". It further encouraged him to heavily tax hapless Nigerians as part of a so-called "ambitious domestic revenue mobilisation agenda".

In the statement signed by its spokesperson, Julie Ziegler, the IMF, like a schoolmaster to an errant pupil, told Tinubu: "Fuel and electricity subsidies are costly, do not reach those that most need government support and should be phased out completely." In other words, it is instructing him and his team to further increase the current prices of fuel and electricity.

The IMF also encouraged Tinubu to take

control their resources and destroy their education system so they will be incapable of thinking.

Let me tell you a verifiable story. The World Bank told African countries in the 1980s that they do not need universities; what they need is technical education to run a basic economy. So, it discouraged African countries from developing education by seeking to destroy the existing university education.

For instance, while the twin agencies are insistent on increasing the price of fuel, they do not encourage the local refining of fuel by an oil producing country

like Nigeria. That will go against the belief they have instilled in the African people; that our role in the world is to produce raw materials while their Godgiven role is to manufacture.

This is why apart from raising what Franz Fanon called 'Black Skin, White Masks' as elites, they also go for the jugular by destroying our education system and convincing generations of Nigerian governments that we do not need to know about our past. That was why until 2022, they banned the teaching of history in all Nigerian schools.

Surely, it is dangerous to allow slaves to be educated. But where it becomes inevitable, the bosses of the IMF and World Bank, try to ensure that the education the former slave colonies receive, are uncritical, subservient, if not useless.

Let me tell you a verifiable story. The World Bank told African countries in the 1980s that they do not need universities; what they need is technical education to run a basic economy. So, it discouraged African countries from developing education by seeking to destroy the existing university education.

It got a listening ear in the Babangida



So, both sides in 1987 signed an agreement for the World Bank to carry out a "restructuring exercise" of all federal universities in Nigeria using a loan facility of \$120-150 million.

Under the "Eligibility Criteria for Federal Universities" the government accepted the conditionality of the World Bank which included the freezing of recruitment of all categories of staff, mandatory staff retrenchment, increase in tuition fees for remedial and non-degree students, cancelling remedial courses in the Arts and phasing out sub-degree programmes that are being offered in other tertiary institutions.

Other World Bank conditionality accepted by the Nigerian government, include eliminating post-graduate programmes in any department that had not yet graduated undergraduate students, phasing out any department that has been "in existence for more than ten years, but has less than 40 full time equivalent undergraduate students" and phasing out any department that has been "in existence for more than ten years, and has less than two thirds of the normally required academic staff."

whose salaries are to be heavily topped. The bank and the conniving Babangida regime agreed that Nigerian universities must meet all the conditionality between June 1990 and June 1994. All these were published by the World Bank under its "Progress Report on the World Bank-Federal Universities Adjustment Operation."

will be awarded One Million Naira, and the third-place team will receive Five Hundred Thousand Naira.





# Borno Govt, WHO, Introduce HPV Vaccine Into State's Routine Immunization

h e Borno State Government with support from the World Health Organisation has inaugurated the State Technical Working Group that will introduce Human Papillomavirus (HPV) Vaccine into the State's Routine Immunization in second quarter of 2024

While inaugurating the working group in Maiduguri, the Commissioner of Health and Human Services, Professor Baba Mallam Gana explained the negative impact of the HPV infections in the communities should not be considered as mere virus as it leads to cancer.

"The negative impact of HPV infections on our communities is significant. The HPV is not merely a virus, but it is a leading cause of several cancers, including cervical cancer, which tragically claims the lives of hundreds of thousands of women worldwide each year".

"Additionally, HPV infections can lead to other forms of cancer affecting both men and women, underscoring the urgency of our collective response. Today marks a pivotal moment in our ongoing commitment to public health and disease prevention. With the introduction of HPV vaccines, we are not just combating a virus; we are safeguarding the health and wellbeing of future generations" he revealed.

The WHO State Coordinator in Borno State, Dr. Ibrahim Salisu in his remarks thanked Governor Babagana Umar Zulum for giving the health sector the utmost priority, as demonstrated by the allocation of about 15% of the total state budget for 2024 to the health sector and pledged that WHO would continue to support the Ministry of Health and its agencies.

"We will continue to support the Ministry of Health, under the leadership of the Honorable Commissioner, Prof. Baba Mala Gana, and all the agencies and departments under the Ministry" "As you may be aware, vaccination is one of the most important public health interventions and constitute a cost-effective strategy to reduce both the morbidity and mortality associated with infectious diseases".

"Recently, Nigeria, and indeed,

Borno state, has recorded some improvements in the routine immunization coverage, which was accelerated by the introduction of new vaccines (Pentavalent, IPV2, Rotavirus vaccines etc.).
