ays after the Enugu State Government completed the demolishing of Ugwuoba Garki Cattle Market, traders are lamenting untold hardship, with women and children stranded, sleeping outside. Secretary of Ugwuoba Garki Tailoring Association, Lawal Musa disclosed this, in an exclusive interview with our correspondent yesterday.

According to him, more than 10.000 people lost their houses and shops as the state government in spite of pleas from several quarters, demolished Ugwuoba Garki Cattle Market after a one-week notice issued expired.

"The place we have been living more than 28 years a c c o r d i n g t o t h e government was targeted for demolishing after they alleged that there are suspected criminals, citing security purposes.

"They came the first time and searched everywhere,

ormer Vice President Atiku Abubakar, has asked President Bola Tinubu to adopt President Javier Milei of Argentina approach to reforms and stop blaming opposition political parties and his predecessor.

In a statement titled, 'Argentina's Javier Milei approach to reforms should serve as a lesson for Tinubu', the 2023 presidential candidate of the Peoples Democratic Party

(PDP) said both President Milei and Tinubu took over in 2023 and inherited a disoriented economy, but both applied different measures to recovery.

According to the statement he personally signed on Sunday, Atiku Abubakar said what President Javier Milei did to return his country to a place where investors are 'starting to believe' should serve as a lesson to Nigeria's Bola Tinubu.

The former VP said unless, and until there are clear-cut policies

and pathway to economic rejuvenation predicated on a leadership led sacrifice, there will be discontentment, especially among the youths, which may find expression in protests and for which it will be silly to continue to blame the opposition for.

"I read a recent report in the Reuters titled: Argentina's market double down on Milei as investors 'start to believe'.

"I took a keen interest in reading the report because I know quite well that Argentina and Nigeria closed the last quarter of the year 2023 on a similar path of economic downturn.

"In the case of Nigeria, a new government was installed at or about the middle of 2023, for Argentina, the new government came on board in December.

"Both leaders inherited a disoriented economy, but both applied different measures to recovery.

"President Javier Milei of Argentina was sworn into office

on 10 December 2023. He inherited a worse condition than Nigeria's.

"Nigeria is where we are today simply because of what Tinubu has done or did not do.

"His shifting the blame on the opposition and, even ridiculously, his predecessor is needless and myopic. Market forces don't play politics. They respond to your actions and inactions.

"President Milei's major campaign promise was to re-

Houses, Food Items To **IDPs In Dalori**

*Flags off closure of all informal IDP camps

ABUBAKAR, Maiduguri

orno State Governor, Babagana Umara Zulum yesterday, distributed 447 resettlement housing, food items and other basic necessities to Internally Displaced Persons (IDPs) at Dalori community in Konduga Local Government Council.

The Borno State Government constructed the houses to resettle families dislodged by the Boko Haram insurgency.

The newly resettled community have been provided with a hospital, school and water facilities. The resettled IDPs were drawn from two locations: 197 households from Kawar Maila camp and 250 families from Dalori

Each of the 447 households, comprising about 2,500 family members received food items, mats, blankets and clothing materials.

Speaking during the distribution, Zulum said the Borno State Government has provided essential humanitarian support to the returnees to enable them start life afresh.

The governor added that his administration will also provide agricultural kits and entrepreneurship support for the returnees to have sustainable livelihood sources

Since 2019, the Zulum-led metropolis before May administration has resettled over one million

S A D I Q IDPs and constructed over 10,000 resettlement houses across 20 locations. Governor Zulum also hinted at a plan for the reconstruction and resettlement of Dalwa and Sandiya communities, among other locations, which were dislodged and destroyed by the Boko Haram insurgents in Konduga Local Government Area.

Meanwhile, Governor Zulum also flagged off the closure of all informal IDP camps in Maiduguri, the Borno State capital, on Sunday.

"It is no longer sustainable to keep people at the IDP camps, and we want the people to be responsible members in their various communities by contributing to the development of the state," Zulum stated.

He added, "Therefore, we will return them to their ancestral homes so that they can start fending for themselves."

The governor noted that all official IDP camps in Maiduguri Metropolitan Council and its environs had been closed since last year.

He said his administration will ensure that all informal IDP camps in Maiduguri are closed before May 29, 2024.

"Today, we have commenced the closure of all informal IDP camps in Maiduguri, and we will Insha'Allah close all informal IDP camps in the 29th 2024," Zulum said.

head of the commencement **L**of planned nationwide strike by Nigeria Labour Congress (NLC) and the Trade Union Congress, (TUC), 65 Civil Society Organisations (CSOs) have pulled out with considerations that the strike might stir up anarchy and cause more hardship on citizens.

The Civil Society Organisations under aegis of Coalition of Civil Society Organisations Forum, also warned against going the Sudan's way.

"Any attempt to embark on a nationwide strike during these critical periods of hunger and harsh economy, could be hijacked by hoodlums and criminal elements, who have been waiting for the slightest opportunity to

public peace, loot business premises and markets.

On February 16, the NLC had announced a nationwide protest scheduled for February 27 and 28, over the failure to implement the agreements reached on October 2, following the removal of the fuel subsidy.

This decision followed the conclusion of a 14-day ultimatum issued to the federal government regarding the widespread hardship.

The coalition of the CSOs which disclosed this in a statement jointly signed by Comrade Buba Ibrahim Mohammed and Comrade George Phillips, the Coordinator and Secretary, insisted that the strike action will only stir up civil unrest and further worsen the already bad security situation as well as damage the fragile economy.

unleash terror; disrupt According the coalition, the views gathered from some of their members and citizens across the country are that the labour unions are trying to undermine the current Tinubu-led administration and create a process for breakdown of law and order to score cheap political points.

"As Civil Society Organisations, we do understand the depth of economic challenges facing the ordinary citizens, especially the workers, but we cannot fold our arms and support a move that will further damage and threaten our peaceful coexistence".

While stating that it's not unaware that the labour unions had the constitutional right to make demands and embark on strike to drive home their demands ,it maintained that NLC and TUC should know that Nigeria is already sitting

on keg of gun powder that must not be allowed to explode. "Part of reasons we have

refused to join forces with

labour unions to create anarchy and cause more hardship for the people. Instead, we are making frantic efforts to meet with federal government to discuss how to amicably resolve the issues at stake. "We recognise the importance of addressing labour-related concerns and advocating for workers' rights, we kindly urge the labour unions to explore alternative means of dialogue and negotiation with the

Buhari Destroyed Nigeria's Economy In 8 Years Tenure, Igboho Alleges

*Says Tinubu not responsible for hardships in Nigeria

he Yoruba Nation agitator, Chief Sunday Adeyemo Igboho has accused former President Muhammadu Buhari of allegedly destroying Nigeria's economy during his eight years tenure.

Speaking on Saturday at the burial reception held at Sablak Event Centre,

Sanyo, Ibadan after the funeral ceremony of his late mother, Mrs S.A. Adeyemo, he declared that President Bola Tinubu is not responsible for the present level hardship in Nigeria

Chief Adeyemo alleged that Nigeria's economy was destroyed before Asiwaju Tinubu was elected and sworn in as the President of Nigeria on May 29, 2023.

According to the Yoruba Nation agitator, a bad Nigerian economy was handed over to President Tinubu by the immediate past administration in the country.

Stressing that President Tinubu didn't destroy Nigeria's economy, he said, "my pain with Yorubas is that while Buhari was in power, I was shouting that we should unite and free ourselves from this suffering. Buhari has nothing to offer us. "Buhari handed over a government he had

destroyed to Tinubu. Now some Yorubas are crying that they are hungry, have you seen Igbos crying? They have sent all Fulanis out of their lands and they are farming, doing what they want with their

they saw nothing and then the second time, they also came with other security agencies such as the army, police and DSS and they saw nothing.

"After that, we got three days quit notice. We tried to ask what was happening but got no replies and the following day, our local government chairman came to tell us they were coming the following day to demolish Ugwuoba Garki Cattle Market, let everyone pack his things.

"We asked him why, he said there is no alternative, it's from Enugu State Government we had nothing to do and now our wives and children are sleeping outside and crying because rain and sun are beating them, that's

why we're praying and calling on our leaders to do something about this because we're facing a lot problems.

"Especially if you enter vehicle from Enugu to Onitsha, they insult you and say it is your people who voted President Tinubu please we are sleeping outside because we are all Nigerians.

"Many Igbos are living up North, we are in serious problem especially women and children. They should consider the fact that we have been living here for more than 28 years and now they have demolished everywhere, nothing remains. After all this, nobody said anything," he lamented.

position the Argentine economy after years of slow growth, high debt levels, triple-digit inflation (160% when he took over the Presidency in December 2023) and 40% poverty rate.

"His first task was to begin implementing measures to achieve greater macroeconomic stability and promote higher global competitiveness.

"He came into the office with a comprehensive stabilization plan, which seeks to implement far-reaching measures within the context of a market-oriented economy.

"He started off cutting government expenditure by cutting the size of government and wastages; blocked stealing of government funds, and attracted Foreign Direct Investment (FDI) through concessions, tax holidays, and improved ease of doing business. "President Milei flies regular

business class for all his travels and does not offer the presidential fleet of Argentina for his son's birthday.

"Likewise, there is no settlement for his hangers-on and political allies through unwieldy and burdensome appointments to public offices.

Argentina's Milei did not build the largest government like Tinubu did at a time when our economy was and still on its knees.

The examples set by President Milei are the requirement of leadership in a time when the economy has begun to fail the expectations of the people.

The reforms so far implemented by the Tinubu administration are ad hoc and hurriedly put together without proper review. Ours is unlike Argentina's Milei, who is sequencing his reforms.

President Milei anticipates the after-reform shocks and admits

that things will be tough for the people. But he is fully prepared for the aftershocks and has in place mitigating pills.

He walks the talk. He makes sacrifices himself by giving up perks of office.

It is not business-as-usual for the presidency while the people are called upon to make sacrifices.

Argentina runs a lean government by reducing the number of ministries, privatizing nearly 40 state-owned enterprises, and reducing wasteful spending.

"Conversely, Tinubu in Nigeria increased the number of ministers and ministries and is spending enormous resources renovating houses for himself, his deputy, and the first lady.

That is nothing short of Nero playing fiddle while Rome is on fire!

"Worse still, Tinubu has refused to roll up his sleeves and do the work that he signed up for. Instead, he and his team are preoccupied with behaving like Napoleon and Squealer, characters in the satire book Animal Farm, who made it a state policy scapegoating Snowball (the opposition) for their own failures arising from their illadvised policies."

Atiku said he was attracted to the reforms in Argentina because Javier Milei's stabilization plan bears a similar emblem with his Recover Nigeria Plan.

"It is a plan that I am more than willing to disclose details of its workings with the current government in order to take Nigeria out of the depth of hunger and anger that we find ourselves.

"The plan includes strategic steps we must take to recover the economy and make it stronger, dynamic, resilient, and competitive.

We had outlined plans to relax the fiscal constraints facing us to include:

Improving Spending Efficiency and Blocking Leakages Saving money through:

"a. A review of fiscal support for non-performing government enterprises and the privatization of those that can not sustain themselves.

"b. Steps to improve spending efficiency through a gradual reduction in government recurrent expenditures, ensuring that those expenditures reflect higher levels of service delivery. Over the medium term, recurrent expenditures should not exceed 45% of the budget.

"c. A review of government procurement processes to ensure high levels of transparency, competitiveness, and value-formoney and eliminate all leakages."
















Police Arrest Fake Philanthropist, Recover Fraudulently Obtained Bags Of Rice In Enugu

he Enugu state Police Command has apprehended a suspected fake philanthropist and recovered fraudulently obtained bags of rice within Enugu metropolis.

Spokesman for the Command, DSP Daniel Ndukwe, disclosed in a statement yesterday in Enugu, saying the swift response of police operatives serving in the Ogui Police Division led to arrest of one Joseph Nnamani, 45 years old.

Ndukwe noted that if not for police intervention, Nnamani would have successfully defrauded a businessman of 18 bags of rice valued at about N400,000 under the guise of buying and using the rice for charity at a church on February 14, 2024, Valentine's Day

"On Valentine's Day, Nnamani went to the premises of a church (name withheld) in Ogui, Enugu, from where he called the businessman (names withheld) on the phone, requesting 18 pieces of 25kg bags of rice with the pretense of wanting to use the same for charity to the church.

"The businessman accordingly supplied the rice and unsuspectingly followed Nnamani to the bank to receive his payment through bank

transfer.

"But in the course of effecting the payment, Nnamani secretly left the bank, went back to the church, and made away with the bags of rice to an unknown destination.

"The suspect, however, could not run or hide for so long, as police operatives, upon receiving the report, embarked on an intelligence-driven investigation, which led to his arrest on Feb. 20, 2024, at Enene, Enugu," he said. The PPRO noted that upon his arrest, eight out of the 18 25kg bags of rice were recovered from him, after he had re-bagged and sold the other bags at Oye Emene Market, Enugu.

Ndukwe said the suspect and his cohorts would definitely have a date with the court of law once investigations are concluded on the matter.

"The citizenry, particularly businessmen and women, are hereby advised to always be security conscious and wary of whom and how they transact businesses in such circumstances, to avoid falling prey to fraudulent suspects like Nnamani.

"Additionally, while the investigation lasts, person(s) who may have suffered a similar act of fraud by the suspect, are encouraged to report to the mentioned police division to volunteer relevant information,"

Ghanian Monarch, Albino Foundation, Physicians, Others Pay Glowing Tribute To Late Medical, Literally Icon, Prof. Okoro

he traditional ruler of Nandom Traditional Area, Upper West Region, Ghana, His Royal Highness, (HRH) Prof. Edmund Nminyem, Albino Association in Nigeria, as well as dignitaries from all walks of life on Tuesday, paid glowing tributes to the late medical icon, Prof. Anezionwu Okoro, the Author of the popular novel, 'Village Headmaster' saying he will not die in the history of Africa.


The Ghana Monarch and close ally of the late r e n o w n e d Dermatologist, spoke in Enugu on Tuesday, during the Night of Tributes organised in honour of Prof. Okoro who passed on January 20, 2024 at the age of 94 years.

Nminyem, however, described the late medical expert, author and poet who had over eighty books to his credit as the greatest dermatologist in Africa, stressing that he late prof Okoro, was a Pan Africanist per excellence who believed in the unity of African continent.

He said Okoro has done a lot in his literary writing and will not die in the history of Africa, science, politics and in humanities, saying he really touched lives during his time on earth.

According to him, "We should immortalize and celebrate him and if we have few people like him, Africa will be a great continent scientifically, politically and otherwise. "He was so humble, very great in scientific world or poetic and each time I wanted to give up, Okoro will encourage me. He will do all he can to help his friends which I benefited immensely,".

In his tribute, Founder of Albino Foundation, Mr Jake Epelle, who spoke on behalf of his members, said that the late Prof. Okoro was



more than a medical doctor to persons with albinism, as those who encountered him were thoroughly treated.

He recalled that the medical guru started treating them as far back as 1954 and continued to treat them until his demise in January this year, saying they will miss him a great deal.

"He was very inspiring, has touched lives and anyone with albinism that he treated, comes with clean and smooth skin. He was the second dermatologist in Africa, a father and a mentor.

On his part, founder of the popular Memphys Neurosurgery hospital Enugu, Prof. Sam Ohaegbulam, also extolled the qualities of the late Prof. Okoro, stating that he was a man with exceptional humility, who never quarreled with anyone.

"Okoro is a unique person who knows how to best resolve disputes. He served in very high positions as a director in the oil industries and nobody ever challenged his transparency and honesty, adding that he was a dedicated and committed teacher.

He said the "Medical field will miss him on the

treatment of skin diseases,".

National President of Old boys Association of Methodist College Uzuakoli, who is also Chairman of Enugu Sports Club, Sir, Victor Atuonwou in his tribute, said late Prof. Okoro who was an alumni of the prestigious college, lived a life worthy of emulation.

The late literally icon, was many persons rolled into one, adding that he impacted lives "and that is why we have come to celebrate the good life late Prof. lived.

Delivering a sermon earlier, Venerable Emeka Ezeji of All Saints Anglican Church, Enugu noted that late Okoro was a devoted member of the church, who lived his life for others, a lovely human being who rendered service to humanity.

The cleric noted that late Okoro wrote more poems than those in the university.

"He is a socialite who loved mingling with others, had his tentacles which were widely spread as he married from Edo and often reaches out to humanity which was the gospel of

Christ

The Anglican Priest added that "the late professor has touched a lot of lives and I pray that his children will continue the legacies that he left for them," the clergyman said.

Dr. Ogbonnaya Okoro, one of the deceased sons, expressed satisfaction that his father lived a fulfilled life, stating that he should be celebrated as he wrote children and medical books.

"My father is a gentleman. I will miss his gentle nature and his story telling," he said.

The late emeritus professor who served at the University of Ibadan, Oyo State, South West. Nigeria authored several works of fiction, medicine/health, environmental sciences, ecology, and over 200 poems.

Among them were the popular 'One Week One Trouble', 'The Village School' and 'The Village Headmaster'.

he National Coordinator, Federal Workers Forum (FWF) Comrade Andrew Emelieze on Thursday urged the Directorate of State Security Service, (DSS) to stop intimating labour on the planned two days protest by Labour unions in the country from Tuesday.

Comrade Emelieze in a statement made available to journalists, cautioned the DSS to desist from, "undemocratic, unconstitutional and primitive position of always trying to coerce the the citizenry."

According to the FWF National Coordinator, " The DSS should note that they are beneficiaries of tax payers money, protest is natural, constitutional and equally a fundamental human right.

The Bakers Association in Zamfara State ordered a halt to bread production due to the government's alleged ban on motorcycles delivering bread to bandit enclaves.

In a statement issued on Wednesday in Gusau, the spokesperson of the Zamfara Governor, Sulaiman Bala Idris, revealed that the government's decision only targets the supply chain to bandits across the

According to the statement, the ban on bread and fuel supply to volatile areas was implemented to disrupt the operations of bandits terrorising the state.

The statement read in parts: "The Zamfara State Government would like to clarify the news that has been circulating, claiming that bakers have been banned from producing bread in the state.

NDLEA Intercepts UK Bound Cocaine Concealed In Shoes, Headgear, Apprehends 26 suspects In Lagos, Kano, Others

t least, 540 grammes of cocaine concealed in canvas shoes and 225mg tramadol hidden in ladies headgear heading to the United Kingdom have been intercepted by operatives of the National Drug Law Enforcement Agency (NDLEA).

Similarly, 26 suspects have been apprehended by the agency in Lagos, Kano, Borno, Kebbi and Edo States in connection with their involvement in trafficking of assorted illicit drugs.

While three out of the suspects were linked to some imported drugs and arms uncovered at the Lagos Port in January, 12 others were said to have been arrested in Kano with different quantities of opioids and other illicit drugs were recovered from them.

The Director, Media and Advocacy of the Agency Mr. Femi Babafemi made the disclosure in a statement yesterday.

While giving a breakdown on the those arrested in connection with the arms and drugs at the Lagos Port, Babafemi as members of the syndicate as a clearing and notify party of the two containers, Falowo Samuel Kayode; a dock worker, Anjorin Idowu and Uzairu Ahmed Iguda, who is in charge of the Five Star terminal at the port.

He added that another dock worker at the terminal, Mohammed Muktar Sule (alias organizer) who is equally linked to the syndicate is currently at

" The agency swung into action following the operations of the organized criminal network behind the importation of two containers laden with illicit drugs, assorted arms and ammunition from Durban, South Africa to the Tincan Seaport in Lagos.

"Based on credible intelligence, the Agency had requested for a 100 percent joint examination of two containers marked MSCU 4581770 and TRHU 7968071 from South Africa. As a result, the exercise was conducted with other stakeholders on 18th and 19th of January, 2024 during which 56.39kg cocaine and 795kg Colorado, a synthetic strong strain of cannabis among other illegal items were recovered from the containers.

"Following a tasking order by the Chairman/Chief Executive Officer of NDLEA, Brig Gen Mohamed Buba Marwa (Retd) to a combined team of specialized units of the agency to unravel those behind the importation of the large consignments of the illicit drugs, ongoing investigations have led to the



discovery of more bags of Colorado weighing 192.7kg, a pistol, and rounds of ammunition removed from the container, MSCU 4581770 and hidden in an empty container before the 100 percent joint examination at the Five Star terminal.'

"Consequently, two suspects; Uzairu Ahmed Iguda who is in charge of the terminal's container positioning and stacking, and Anjorin Idowu who is a dock worker in the terminal have been

"Another suspect, Mohammed Muktar Sule (alias organizer) now at large, is also a dock worker in the terminal.

According to the statement, investigations revealed that the three suspects conspired with the agent and notify party, Falowo Samuel Kayode to remove the 192.7kg Colorado, pistol and rounds of ammunition from the container to an empty container in the terminal.

The latest seizure brings the total recovered from the two containers to 56.39kg of cocaine and 987.9kg of Colorado with a combined weight of 1,044.29kg. Similarly, it added that investigations revealed that three kingpins based in South Africa are connected with the importation of the containers. The kingpins; Odeyemi Taiwo Emmanuel, Akinyemi Olayinka and Adebayo Adewole Emmanuel are now on the Agency's wanted list.

The statement stated further that "At least 540 grams of cocaine concealed in canvas shoes heading to the UK were intercepted at a courier firm in Lagos on Friday 23rd Feb by NDLEA operatives of the Directorate of Operation and General Investigation, DOGI. Equally, a consignment of tramadol 225mg hidden in ladies headgear going to the UK was also seized same day at the courier house, while another parcel containing ecstasy concealed in body cream container meant for Cyprus was also intercepted."

It also mentioned that different quantities of opioids and other illicit drugs were recovered from at least 12 young men arrested in parts of Kano between Monday 19th and Friday 23rd February.

According to the agency, the suspects are; Yusuf Abdullahi, 20; Usman Muh'd,18; Sadiq Jibrin, 20; Ibrahim Lawan, 25; Ukasha Usaini,19; Sahabi Lamini, 15.

Others are Isiyaka Mohd, 28; Bashir Ayuba, 36; Ahmad Idris,18; Abubakar Sani, 29; Bashir Mohd, 21 and Udochukwu Ezekiel, 35.

In a related development, Operatives of Edo NDLEA raided a drug joint under powerline off Etete road, GRA Benin City on Tuesday, February 20 and they nabbed a 24-year-old sales girl, Jessica Destiny. As a result, they recovered assorted illicit drugs.

A follow up operation the following day led to the arrest of the owner of the joint, 36-yearold Ibrahim Sani who is the Commander, Arewa Association Vigilantes in the area.

Similarly, a consignment of 179kg cannabis was recovered by operatives at Badagry Waterside, Lagos on Wednesday, February 21 – and a 67-year-old grandpa, Rafiu Ogunro was arrested on Thursday, February 22 at Magbon, Ogun State with 57kg cannabis, 2,700 pills of tramadol, and 231 bottles of Codeine syrup, weighing 2.31 litres.

Elsewhere in Borno, a 25-yearold lady, Zara Mele was apprehended with quantities of cocaine and heroin at Baga check point on Tuesday, February 20; while 26-year-old, Usman Shuaibu and 22-year-old, Mohammed Lawan were also arrested with quantities of the same class A drug at Meri and Babban Layi areas of Maiduguri the same day respectively.

The agency said that no less than 44.820 pills of opioids being taken to Zamfara State by Tasiu Mohammed, 25, and Abubakar Tanko, 54, were intercepted along Jega-Sokoto road by NDLEA officers in Kebbi State, while a farmer Ali Abdulhamid, 35, was arrested in his farm where he grows tomatoes and some stems of cannabis sativa weighing 73 kilograms at Bakin Kasuwa village, Birnin Yero area of Igabi LGA, Kaduna State.

In addition, two suspects; Shuaibu Ahmed, 38, and Tanimu Abdullahi, 29, travelling in a commercial bus from Lagos to Kano with 99 blocks of cannabis weighing 37kg were intercepted by NDLEA officers along Kwali-Gwagwalada express road, Abuja on Monday, February 19; while one Michael Okefi was arrested at Upper Iweka area of Onitsha, Anambra State with 483 bottles of codeine-based cough syrup concealed in two 50-litre kegs. A follow up operation led to the arrest of the actual owner, Osinachi Jasper.








Governor Inuwa Yahaya Secures AfDB Partnership For Gombe's Agro-Allied Development, Livelihood Projects

he Africa Development Bank (AfDB) has assured of assured Gombe State Government of its strong commitment to support the State's development drive especially as it affects the Special Agro Processing Zone (SAPZ) and the Inclusive Service Delivery and Livelihood Empowerment Integrated Project (ISDLEIP).

He therefore assured of AfDB's commitment to supporting Gombe's endeavour to promote increased productivity, value addition, market access and private sector investment in agricultural value chain commodities like soybeans, maize, cotton, and sesame seeds among others.

"Our focus on the SAPZ is on the promotion of commodities that have a high potential to boost export revenues or import substitution. The programme is designed to enhance

complementarity with existing or completed projects financed by the AfDB including those in the power, transport, water and agriculture sectors".

He said with its three dams, strategic location, peaceful environment and visionary leadership of the Governor, Gombe State is destined for greatness.

arrest of a 54-yr old woman in possession
of 175 rounds of live cartridges topping
the list.

He said that the suspect, identified as one Efe David, 54yrs of Oria Abraka Ethiope East LGA, Delta State, was arrested with the exhibit on February 17, 2024 at about 2: 20pm by operatives of Eagle-Net special Squad while on routine patrol along Asaba/Ibusa road in a commercial Sienna vehicle coming from Onitsha.

Abaniwonda, who made the disclosure at his maiden press briefing on Wednesday, listed the achievements to include arrest of suspected notorious armed robbers, suspected cultists, drug dealers, recovery of assorted firearms, ammunition, cartridges amongst others.

His words, "ARREST OF A 54YRS OLD WOMAN IN POSSESSION OF ONE HUNDRED AND SEVENTY-FIVE ROUNDS OF LIVE CARTRIDGES: On the 17/2/2024 at about 1420hrs, operatives of Eagle-Net special Squad while on routine patrol along Asaba/Ibusa road, flagged down a commercial Sienna vehicle coming from Onitsha, during search of the vehicle and passengers one Efe David 'f' 54yrs of Oria Abraka Ethiope East LGA, Delta State was arrested with one hundred and seventy five (175) live cartridges. Suspect is in custody and investigation is ongoing.

"ARREST OF SUSPECTED NOTORIOUS ARMED ROBBERS: On 31/01/2024 at about 2200hrs, while acting on a tip off from a distress tricycle rider (name withheld) that three young boys hired him for from Effurun Junction to Ugholo community and diverted to a lonely road, stabbed him on his head and hands dispossessed him of his tricycle with registration number AS 8851 and fourteen thousand naira.

"On the receipt of complaint, DPO Oreropke detailed a team of detective who swung into action. Consequently, on 17/02/2024 at about 2200hrs, the team arrested one Okechukwu Gabriel aged 26 years 'm' of no. 23 Warri/Sapele road Effurun who specializes in snatching tricycle from it owners was arrested. The victim has identified the suspect as one of those who robbed him. Investigation is ongoing.

"ARREST OF A SUSPECT IN POSSESSION OF ONE LOCALLY FABRICATED BERETTA PISTOL: On 13/2/2024, at about 2055 hours, while operatives of Safe Delta were on visibility patrol along Utagbanor road, at Ukwani LGA, they sighted a black Toyota Camry with registration number KUJ 282CN, carrying three occupants, upon search of the occupants and the vehicle, one locally fabricated Beretta Pistol loaded with seven rounds of ammunition, weeds suspected to be Indian hemp were recovered from one of the occupants Chionyenedue Macdoff. Upon further investigation, the suspect confessed that he purchased the arm from one Timothy who is resident in Kaduna.

"ARREST OF SUSPECTED CULTIST, RECOVERY OF LOCALLY MADE CUT-SIZE-GUN: On the 12/2/2024, at about 2100hours, one Eze Emeruwa 'm' age 28yrs was arrested for assaulting his

During the course of investigation, suspect premises was searched and a locally made cut-to-size double barrel pistol, and seven rounds of live cartridges were recovered. "ARREST OF A SUSPECTED ARMED ROBBER, RECOVERY OF ONE FABRICATED REVOLVER PISTOL AND THREE ROUNDS OF LIVE AMMUNITION: On 15/2/2024, at about 0700 hours, Policemen attached to Eagle-Net special squad received a distress call that two young men jumped into a compound at Dublina Road, GRA, Asaba, the Police swiftly responded and moved to the scene, on sighting the policemen, the suspects fled, but one of them Isaac Victor 'm' age 31yrs was arrested and one fabricated revolver pistol was recovered from him. Investigation is ongoing.

"ARREST OF SUSPECTED CULTIST/ARMED ROBBERS: On 18/2/2024, the DPO Bomadi division received a distress call that some suspected robbers were on rampage terrorizing his area of responsibility, attacking and dispossessing shop owners of their belongings with cutlasses and other dangerous weapons. The DPO swiftly led men alongside vigilante and embark on aggressive patrol which led to the arrest of seven suspects.

"The suspects confessed to be members of BOBOS, Greenlander, and Icelanders confraternity and the following items were recovered, four cutlasses, two daggers, and one axe. Suspects are in custody and effort to arrest other members

FCID Arrests 4 Over Alleged Police Character Certificate Forgery

etectives of the Force Criminal Investigations Department (FCID Annex), Alagbon Lagos have smashed a syndicate that specialises in the forgery of Police Character Certificate, arresting at least four suspects.

The arrest of the suspects was consequent upon a complaint by one Mrs Mojisola who was issued a forged police character certificate, with some amount of money obtained from her under false pretence.

Investigation has also revealed that the suspects were involved in a criminal racket involving issuance of the fake police character certificate that led to the 10-years ban of one Mrs Shonekan upon the presentation of the fake Police Character Certificate at the UK Embassy. The Spokesperson FCID Annex,

Alagbon Lagos, ASP Mayegun Aminat who made the disclosure in a statement obtained by our correspondent, identified the suspects as Osinowo Olujimi Obafemi, 35,Sebastine Olamide, 21,Shittu Babatunde, 25 and Bilal Yekeen, 25.

According to the release, a plethora of fraudulent documents which include fake police character certificates, seven medical report issued from LASUTH belonging to several individuals, sixty-five fake international driving permits were uncovered when a search was conducted on their premises located at No. 267

Igbosere Road,off Obalende Area Lagos Island the detectives. Other exhibits recovered from the premises include 18 international driving license permit forms with different pictures belonging to different persons, one pack of both booklet of the traffic foreign vehicle regulation license among others.

The release reads, " Upon receiving a complaint from Mrs Shonekan Rukayat Mojisola bothering on falsification of police character certificate, obtaining money under false pretence, impersonation, forgery of signatures and official stamp. FCID Annex operative attached to X-Squad took swift action .This led to the arrest of Osinowo Olujimi Obafemi "M"

35 years, Sebastine Olamide "M" 21 years , Shittu Babatunde 'M" 25 years and Bilal Yekeen "M" 25 years .

Gov Sule Lauds Tinubu's Initiatives Towards Economic Revival

overnor Abdullahi Sule of Nasarawa State has lauded President Tinubu's initiatives towards reviving the economy of the country, saying that if there is any person that has the capacity to fix the economy of the country, that person is President Ahmed Bola Tinubu.

Governor Sule stated this when he hosted a delegation from the Christian Association of Nigeria (CAN), Nasarawa State chapter, who were at the Government House on a solidarity visit.

According to the Governor, President Tinubu has comparative advantage in the area of economy because that is his area of expertise.

"I always say it privately and openly. If there is anything I believe this president has a comparative advantage, it's in the area of the economy. I am always hopeful even with the hardships that if there is anything that this President shall get right first, it should be the economy," he stated.

Governor Sule pointed out that if Tinubu does not get the economy right then Nigeria is in trouble because nobody then could be able to fix the country's economy.

"If this President does not get the economy fixed, then I don't know who else is going to get it right. Honestly speaking, that I believe is his area of expertise. It is the area he has done well in the past. And it's the area we are hoping he will fix," he added.

The governor explained that his conviction is further strengthened whenever he had the opportunity to sit one on one with President Tinubu.

"Whenever I had the opportunity to sit with him, I saw the conviction in him that he was working on fixing the economy. It gives me comfort," he said.

He noted that since the removal of the fuel subsidy, the 36 states of the federation have received improved revenue because the money that would have gone in paying subsidy is now coming to the states and local governments. "Our money has improved. I am very transparent about this. It has improved from the over four billion that we used to receive to now six or seven billion since the removal of subsidy," he said.

Governor Sule said his administration is using the money to build needed infrastructure.

"The bulk of our money is going into infrastructure. Everywhere we are building infrastructure,

we pay between forty to fifty percent upfront. Because the cost of material are going up daily. But I am not doing that to the point of leaving the people hungry," he added.

The governor said his administration has distributed food items as palliative across the state twice and is already stocking up more food items to be distributed again across the state.

This is just as he called on the Christian leaders to go back and use the church to unite the people.

Governor Sule lamented that the 2023 general election has torned Nigerians across religious lines, with election further dividing the people of the state along ethnic lines.

"I want you to use the opportunity to call on you as leaders to use the church and go back to unite the people. The question of Muslim/Muslim ticket is over. For whatever reason, God said they are the winners. They won. They are there. We have no other option than to pray for them to succeed," he said.

He emphasized that the time of opposition is over and that it's time to support governments at the federal and state levels in order to succeed.


"We must continue to pray for the government. My message to you, is to use the church to unite the state because Nasarawa State is bigger than one individual, no matter who that individual is. Before I came here, there were three governors there were elected and served. There were two other governors who were military. All of them have left. Another time A. A Sule will be gone and somebody else will come. And they will continue. I am mature enough to know that. I am faithful enough to understand that. I believe that is what is going to happen," he

Governor Sule reiterated his resolve to put in his best and not to pay attention to any form of criticism.

"My business is that God has put me in a place to provide leadership, and leadership is what I will provide," he stated.

He also spoke on the issues regarding the protesting PDP women that were arrested and later released, as well as the controversy surrounding the alleged Fulani vigilante group.

Governor Sule said even when the women abused him and said all manner of things about him, he refused to respond, while



awaiting the outcome of the litigation challenging his election into office for a second term.

"Every day, there was a programme at the PDP secretariat where some women were exercising their freedom. Part of the exercise of their freedom was to abuse the Governor. I had never responded. I felt it was not time for me to respond. And the only day that God now says it's done, it's finished, A. A Sule is the winner, on that day, we knew it was over," he said.

He added that the women were only arrested when they took to the streets after the Supreme Court judgment and in the process, infringed on the freedom of other people when they blocked the roads.

He said his administration later reviewed the bail conditions to enable the women secure their release from detention.

On the issue of the Fulani vigilante group, the Governor said he came to Nasarawa State with two major dreams, with the first being to bring industrialization to the state so that people can gain employment with a view to reducing over dependence on politics.

"Security is key to the state. I have come from a background of entrepreneurship, the background of businesses, the background of building empires. That is the background where I came from. For me, I believe in industrialization. I believe in the independence of people. I know definitely if in Nasarawa State we have places where lots of people can work and become independent, many people would pay less attention to politics.

"A lot of people pay attention to politics because of not knowing what to do. As long as the government is moving smoothly, government is doing what it is supposed to do, providing what it should provide, and people are doing their work and feeding their families, they care less about what is happening or who becomes what. And that is the dream I cane with into Nasarawa State," he stated.

The governor said that informed the policy thrust of his administration to provide vocational and technical education to afford the people opportunity to set up their small scale businesses.

He assured that his administration is making every

efforts to ensure that the people are safe and comfortable and they are not afraid of anybody attacking them.

Then, the neoliberals told us it was imperative to allow free purchase and sale of foreign currency. They even encouraged us to open domiciliary accounts in our banks to store foreign currency which government guaranteed will be safe as the ideology of

free markets requires the assurance. The Central Bank of Nigeria licensed thousands of BDCs and asked them to trade in currencies.


The bigger issue is that for a rentier State, safeguarding the source of rent is an existential problem and simple logic should have prevailed and made the state stop the theft. The underlying reality, as we all know however, is that our political leaders and upper echelons of our security forces are beneficiaries of the oil theft. They have taken the decision to eat the goose that lays the golden egg and move to Dubai thereafter as rich refugees.

Why the hell are they being arrested today for doing what the law asked them to do? The other panic move is to place the blame on crypto-currency websites for stealing the value of the naira. The issue is that the few people with naira, conscious of its steady and daily loss of value, would seek to protect their asset anyway they can, won't they?

The fact of the matter is that we are simply not earning enough foreign currency to meet our high demands for imported goods. In so doing, for decades, we have relied on petroleum rent as our major source of foreign currency. Then, to our shock, in 2022, the Group Managing Director of NNPCL, Mele Kyari, explained to us in a State House media briefing that most of our petroleum was being stolen so the dollars are no longer coming in. Mr. Kyari blamed various sections of the Nigerian society for being complicit in the theft of millions of barrels of crude oil, mentioning even that makeshift pipelines and stolen fuel have been found in churches and mosques.

We were told that between January and July 2022, Africa's biggest oil producer lost an average of 437,000 barrels of oil a day to criminal entities and individuals who illicitly tap pipelines onshore and offshore in the Niger Delta region. The solution to the problem is therefore clear – stop the oil theft and more dollars will come in.

BusinessDay has asked us to open our eyes from now on. We should note the price of dollar one week before FAAC allocation, check back the price after the allocation and you will see clearly the difference. Let's all do that and know that

There is still an explanation needed for the astronomic collapse of the naira over the past few weeks. What the hell is going on? The answer, says the research done by BusinessDay, is that we should look at those with a lot of naira – government. Since the removal of fuel subsidy, the federal and state governments have been

receiving massive amounts of naira through the disbursement of money by the Federation Account Allocation Committee (FAAC).

BusinessDay learnt that portions of the funds from FAAC were often changed to dollars by some governments at the parallel market, putting more pressure on the naira. Their analysis shows that from July 2023 to January 2024, the naira depreciated in the black market for the six months immediately after the FAAC shared money to the federal, state and local governments:

"With the removal of fuel subsidy, more volumes of naira are being shared by the federal, state and local governments and some of these monies are changed to dollars at the parallel market." BusinessDay has asked us to open our eyes from now on. We should note the price of dollar one week before FAAC allocation, check back the price after the allocation and you will see clearly the difference. Let's all do that and know that those who should go to jail are some of our governors and ministers. President Tinubu, please stop panicking, just look around you and you shall see.

One Million Naira Minimum Wage And Road To Zimbabwe

he reality on ground is that economic hardship is getting worse since the removal of fuel subsidy by President Bola Ahmed Tinubu when he announced in his inauguration speech on May 29 last year, whereby queues were formed at petrol stations instantly.

The way things are going, we may eventually arrive at the N1 million minimum wage and that would surely be the road to Zimbabwe where you need a sack of naira notes to buy a basic item like soap.

Then, the depreciation of the naira to the dollar adds to the woes of Nigerians as price of goods is tied to the exchange rate as almost everything we use is imported or its components. Things are now so bad that the price of an item you bought in the morning would increase when you go to buy another one in the afternoon. Yet, the purchasing power of people have not increased as the minimum wage of N30,000 cannot even buy much for a family of six, much less take them for a whole month, not even including rent, school fees and medical care. However, even this inadequate minimum wage is not being paid by all the states.

Now a bag of rice is between N70,000-N80,000 and counting, and the Nigeria Labour Congress (NLC) is demanding N1 million as the minimum wage, though reports have it that they may shift ground on it

There is a video of the NLC president, Comrade Joe Ajaero, at a press briefing saying: "Why are we scared when we say pay a worker N1 million, while those in the National Assembly are collecting 16,17,30million...?"

The way things are going, we may eventually arrive at the N1 million minimum wage and that would surely be the road to Zimbabwe where you need a sack of naira notes to buy a basic item like soap.

Now the government says it would release grains from the Strategic Grain Reserve and distribute it free to the poor. But how many kilos could one get, two or three and for how long? What else afterwards? Can government afford to keep this up? Are we turning into a welfare state by making people poor, making them to loss their dignity and queue for a cup of rice, so to speak?

This is more so since as soon as the news filters out that the minimum wage is N1 million naira, the prices of items would rise as it usually happens, making the salary increase not much of a joy since the

traders literally take it away.

I know somebody who was not happy with salary increase in those days because the price of items increased as well.

In any case, though the government has so far tried many ways as palliatives to assuage the devastating impact of fuel subsidy removal, it is apparent that they have not made significant impact. Ironically when states were asked to buy food items and distribute to the people, the prices increased in the markets since the items were mopped up by the government!

Now the government says it would release grains from the Strategic Grain Reserve and distribute it free to the poor. But how many kilos could one get, two or three and for how long? What else afterwards? Can government afford to keep this up? Are we turning into a welfare state by making people poor, making them to loss their dignity and queue for a cup of rice, so to speak?

While the experts and advocates of fuel subsidy removal have gone mute, bereft of ideas, the lay people are saying instead of spending billions of naira on palliatives and the eventual N1 million minimum wage, I may add, why not bring back the fuel subsidy?

The government also said it would restart direct cash transfer to the poorest and most vulnerable people to twelve million households. There are already three million people on the programme. The issue is that the poorest of the poor have increased and this would be like a drop in the ocean.

Amidst all this, news magazines of the mid and late 80s are making rounds in the social media with cover stories of blackout, naira depreciation and hunger among others, mocking our leaders since then of not being able to solve those issues we are still facing today.

Therefore, the defenders of President Tinubu are correct in one sense that the problem did not start with this administration. But since you are elected, you campaigned to be elected as you have the 'solution' to Nigeria's problem, you are expected to wave the magic wand and not offer excuses however tenable.

While the experts and advocates of fuel subsidy removal have gone mute, bereft of ideas, the lay people are saying instead of spending billions of naira on palliatives and the eventual N1 million minimum wage, I may add, why not bring back the fuel subsidy?

Since the government is unlikely to do that, it should not pretend not to expect the rising cost of items to push us on to the road to Zimbabwe.

Don't Embark On Nationwide Protest, APC Chieftain, Tells Labour Unions Leadership

*Says it could set nation on fire

chieftain of the All Progressives Congress (APC), Alhaji Salman Akorede yesterday, cautioned the leadership of the Nigeria Labour Congress (NLC) against embarking on the planned nationwide protest.

On the economic hardships in the country, Alhaji Akorede tasked President Bola Tinubu to fashion out a more impactful and result oriented way of ameliorating the pains of the economic reforms on Nigerians as against continued dolling out huge resources to the state governors.

He maintained that one of the most effective ways to reach out to the people with government interventions, was for the government to consider factoring the already existing channels through the support groups for direct delivery of palliatives to the people at the grassroots.

According to him, these support groups delivered victory for the party are in every nook and cranny of the Federation, saying, the APC support groups are found in each of the 176,974 polling units in Nigeria, and the structure could be used to reach out

to every Nigerian at the polling unit levels.

Alhaji Akorede stated further that the Federal Government could employ the use of National Identification Number (NIN) or the Bank Verification Number (BVN) to reach out to all Nigerians for the equitable distribution of these palliatives, especially among the most vulnerable Nigerians.

The APC Chieftain said as at the moment, the political functionaries in Nigeria from the Governors to the Honourable Ministers, distinguished Senators, HoR Members, States Houses of Assembly Members have all disappointed Nigerians and Mr. President owing to lack of any effect of all the humongous interventions running into billions, sent through them to their people on a monthly basis since this administration took off in May 2023.

I did not hear much about him owing to my in-law's demise and my relocation from Yerwa until I learnt in the news that Bukar Abba Ibrahim was elected as the first Civilian Governor of Yobe State during the dual-party NRC/SDP era.

Thereafter, there was another break

with him especially after leaving office until he was in the news again in 1999 as Executive Governor of Yobe for the second time.

Amongst the variables for my admiration of him in later years was his marriage to Khadijah (a very modest lady), who is the daughter of the highly respected late Alhaji Waziri Ibrahim and whom I met several times in Lagos in the late 80s. May Allah admit both Alhaji Waziri Ibrahim and Alhaji Bukar Abba Ibrahim into Aljannat Firdausi.

He was indeed considerate and generous too. I had the privilege of meeting him in 2004 while on a study tour as a Major undergoing the senior command and staff course, Jaji. He hosted us very well in Damaturu during the tour. May Allah forgive and grant him Aljannat Firdausi.

After The AU Summit, Africa Continues Its Drift

F a family meets in a room, members give themselves pecks, exchange polite greetings, make flowery speeches and emerge laughing for group photographs, it is likely they have not been truthful to themselves. That was my impression following the 37th Summit of the African Union (AU), from February 17-18, 2024 in Addis Ababa.

The theme of the 2024 AU Summit: "Educate an African fit for the 21st Century: Building resilient education systems for increased access to inclusive, lifelong, quality and relevant learning in Africa", is quite fine. However, I find the Summit's adoption of the Second 10-year (2024-2033) implementation plan of Agenda 2063, christened the 'Decade of Acceleration', a bit problematic because we do not have the report of the First 10-year plan. It is going the way of the illusive AU 'Silencing the Guns by 2020' Agenda.

After attending a few AU Summits, I have learnt to look beyond the theme, to the recommendations and draft resolutions of the AU Permanent Representatives Committee (PRC). This body of ambassadors or representatives of Member States, sets the agenda and drafts the resolutions which, with a few amendments, are passed to the Summit by the AU Executive Council of Foreign Ministers.

As can be imagined, our Heads of State are quite busy. So, their two-day summits are actually for one day with large chunks of that day taken by goodwill messages from foreign dignitaries and bodies like the United Nations. When we add the speeches of our political leaders, there is virtually no time for discussions and debates at the summits.

This week's Summit was not different, except that it was worse in some aspects. Attendance by 35 countries was quite poor because it means 20 African countries were not at the Summit.

Secondly, the unusual happened: an alleged violation of a President's immunity and rights. Somalia President, Hassan Sheikh Mohamud, claimed that the security services of the host, Ethiopia, tried to stop him from leaving his hotel to attend the meeting. He said he had to join the convoy of Djibouti President, Ismail Omar Guelleh, to be able to leave. The Somalia President added that on arrival at the AU headquarters, armed Ethiopian guards tried to prevent him from entering the building. He claimed that: "A soldier with a gun stood in front of us and denied us access to this facility." He also accused the host of "...annexing part of Somalia to Ethiopia, and changing the borders of

The Summit appeared deaf to these

complaints and to the October 2023 statement of Ethiopian Prime Minister, Abiy Ahmed Abiy, that his country's landlocked state is an unacceptable "geographical prison" which has to be changed for peace to reign.

The theme of the 2024 AU Summit: "Educate an African fit for the 21st Century: Building resilient education systems for increased access to inclusive, lifelong, quality and relevant learning in Africa", is quite fine. However, I find the Summit's adoption of the

However, these and other talks of the AU joining the G20, do not address the immediate and fundamental challenges of the continent which include insecurity, hunger and economic integration. For Africa to be firmly on the road to economic integration, an effective free trade zone, realisable 2063 agenda, peace and development, it has to rebuild its broken regional blocs, and ensure transnational and regional peace.

The Arab Maghreb Union (AMU) in North Africa, made up of Algeria, Libya, Mauritania, Morocco and Tunisia, is like a kwashiorkor victim on life support. Its leaders met last on July 3, 2008, that is 16 years ago. While Tunisia is trying to recover, Libya is a failed state and Algeria holds a principled position against Morocco's occupation of Western Sahara by the monarchy in Rabat.

So, the AU Summit did not even scratch the surface of the continent's immediate security and economic challenges. When new AU Chair, Ghazouani, talked about the need to realise Africa's socioeconomic development ambitions, build continental stability and ensure that Africa has an assertive presence on the world stage, he should realise that the continent would need to be steered in a proper direction.

In trying to flee the regional bloc, Morocco sought asylum in the Economic Community of West African States (ECOWAS) but was denied. It had also sought to join the European Union, but was like an illegal migrant, denied entry. Ironically, the new AU Chairman, Mohamed Ould Ghazouani, is the



President of Mauritania, a country that broke away from ECOWAS in 2000 while remaining in a comatose AMU.

The East African Community (EAC), comprising the Democratic Republic of the Congo (DRC), the republics of Burundi, Kenya, Rwanda, South Sudan, Uganda and Tanzania, is one of the oldest and most viable. It has even gotten to the level of recognising the identity cards of member-states, as a substitute for international passports. However, it has been bogged down by serious conflicts, especially between war-torn DRC and Rwanda which allegedly supports the brutal M23 rebels. There is also the continuous disagreement between Rwanda and Burundi.

The Economic Community of Central African States (ECCAS) also suffers from the Rwanda-DRC- Burundi crises. Additionally, ECCAS member, Cameroun, has for years experienced a low intensity civil war in its Anglophone part, as well as a sick, gerontocracy under President Paul Biya.

Gabon is still in the grips of the military which on August 30, 2023 ousted President Ali Bongo Ondimba. Another ECCAS member, Chad, has been virtually under military rule for over three decades.

The Chairperson of the African Union Commission, Moussa Faki Mahamat, served as Chadian Foreign Minister. After General Mahamat Deby overthrew the Chadian government on April 20, 2021, Faki ensured the regime was not sanctioned by the AU.

The AU needs to call a proper summit dedicated to peacebuilding and economic integration where our leaders can tell themselves the truth, call themselves to order, and carry out joint work. Otherwise, Africa will continue to drift from one summit to another.

The Intergovernmental Authority on Development (IGAD) made up of Somalia, Ethiopia, Djibouti, Eritrea, Uganda, Sudan and South Sudan is one of the most conflict-ridden regions. Somalia has for decades been a failed state, Sudan has experienced a civil war between its military and the Rapid Support Forces since April 2023, and the scars of the civil war in South Sudan are still visible. Ethiopia has been engaged in serious conflicts with its Tigray and Amhara regions, while its Oromo nationality is still restive.

The Southern African Development Community (SADC) has been perhaps the most stable, while nine of the 15 members of ECOWAS are experiencing serious stages of instability. Guinea Bissau does not allow its parliament function; Guinea, Mali, Burkina Faso and Niger are under direct military rule; the Ivorian President, Alassane Ouattara, is in an illegal and unconstitutional third term; Senegalese President, Macky Sall, has blocked the general elections and Sierra Leone claims to have aborted a coup on November 26, 2023, while Nigeria is wracked by terrorism, kidnapping and banditry.

So, the AU Summit did not even scratch the surface of the continent's immediate security and economic challenges. When new AU Chair, Ghazouani, talked about the need to realise Africa's socioeconomic development ambitions, build continental stability and ensure that Africa has an assertive presence on the world stage, he should realise that the continent would need to be steered in a proper direction.

The AU needs to call a proper summit dedicated to peacebuilding and economic integration where our leaders can tell themselves the truth, call themselves to order, and carry out joint work. Otherwise, Africa will continue to drift from one summit to another.

Adamawa, Taraba Customs Command Seizes Items Worth Over N13m

he Nigerian Customs Service Adamawa/Taraba Area Command has seized assorted items worth over N13 million.

The area Comptroller, Salisu Abdullahi, who made the disclosure at a press briefing in Yola, Adamawa State Capital, said that the command made seizures of 245 jerry cans of 25 litres each on its way to Cameroon and brought them to the office.

He maintained that despite the subsidy removal on PMS, smuggling of the product from Nigeria to some other African countries persists.

"This is as a result of high fuel demand and higher prices in neighbouring countries like Cameroon, Togo and the Benin Republic, making illicit exportation of these products into these countries highly profitable for the unpatriotic Nigerians to fill the supply gap," he added.

The Adamawa/Taraba c o m m a n d, i n collaboration with NAFDAC, destroyed some expired and unregistered foreign juice and alcoholic bullet drinks that were seized by its operatives last year.

Comptroller Abdullahi therefore urged the smugglers to forsake economic sabotage and illicit trade into the command frontiers and embrace legitimate business, warning that the command will not relent on its oars until it rids all the borders of this illicit act

New Nigerian reports that the seized items include Premium Motor Spirit packed in 643 Jerry cans of 25 liters and three of 200 litres of drums, twenty bags of foreign rice and a Golf wagon with a big constructed fuel tank.

The petrol was auctioned immediately after the press conference and proceed realized will be remitted to the federation account.
