n a bid to improve healthcare system in ■Nigeria, the Vice Chancellor of David Umahi Federal University of Health Sciences (DUFUHS), Uburu, Prof. Jesse Uneke has said that the medical Institution is set to reverse both medical and educational tourism in Nigeria, stating that it has enough human and material resources to achieve this in line with global best practices.

He also added that in order to improve and inculcate research among students, the University has granted them access to international data bases for research proficiency and innovation.

The Vice Chancellor of David Umahi Federal University of Health Sciences, Uburu, stated this during the matriculation which took place at the University Ceremony Arena and was well attended by students, parents, members of the academia, leaders of religious organizations and people from all walks of life.

Speaking to New Nigerian, Hayab added, "The news about the release of children kidnapped from Kuriga school is a cheering news and further shows that we only need genuine commitment

"I commend our governor for his open and humane approach to finding a solution which is a departure from the rigid posture of previous leaders that did not give us this type of good news.I wish to remind Governor Uba Sani to stand firm and keep up the good work till total victory is achieved to others who are in captivity."

According to him, "Our appreciation goes to President Tinubu, Malam Ribadu, the National Security Adviser, the Chief of Defense Staff and other serving chiefs. In a related development, a Professor of Counselling Psychology and Peace Studies and

former acting Director of Centre for Peace and Conflict Studies (CEPACS), University of Ibadan, Prof. Ayobami Hammed has called for the creation of a National Crime Prevention Commission.

Presenting the 546th edition of the University of Ibadan inaugural lecture series Titled "We Die Here Today! Youth Violence, Social Dysfunction, and a Counselling Psychologist's Pathway to Peace", the University Don said this will go a long way in addressing the disturbing trend of youth violence across the country.

Prof Hammed maintained that the proposed agency would be saddled with the responsibility of designing, implementing and monitoring a national policy on peace education that is specifically tailored towards equipping the youth with such skills that will help them stay away from tendencies to get involved in violent acts.

According to the University Don, "Peace education can help prevent youth violence and radicalism by teaching youth about the advantages of peace and conflict transformation skills".



Prof Hammed added, The aim of this lecture has been to shine light on a problem or a series of problems that seem perennial and to argue for why it is important that we chart a path to an enduring solution".

"The pursuit of that solution has been my preoccupation for the better part of the last twentyeight years of my life as an academic on this campus,"

While expressing concern over the growing reported cases of youth involvement in violence and criminal activities across the country, he called for the active involvement of all relevant stakeholders including parents, the academia, private sector, media and all tiers of government.

Prof Hammed maintained that more was the rate at which the incident of violent acts are recorded among the younger generation of the youth population adding that the development poses potent existential threat to the sociopolitical and economic future of the country.

He also called for quality education, positive role model, economic empowerment, among others as ways through which the society can effectively combat the menace of youth violence.

"it has become necessary now more than ever for the authorities concerned to work on minimizing the involvement of Nigeria Army in civil or internal issues". He said.

Comrade Ugwu who is also the Secretary General of Africa Thinkers Union, stated that outside the issue of banditry and activities of extremists, gallant soldiers don't have any reason to go for any arrest or involve themselves in communal disputes.

"This is purely the work of other sister agencies and not the army. The army should be concerned with the territorial integrity of the country.

"Yes, soldiers are very important in maintaining peace and security. There is no doubt about it that the Nigerian Army is well-trained and equipped for internal security operations. But not every here and there, the soldiers are called upon to intervene. We must work together to avoid this temptation. We must work together to ensure this ugly incident does not happen

again

"There is a clear understanding of the role of the police and that of the military in Nigeria. The Nigerian police maintains law and order while the Nigerian Army protects the national borders from external invasion, quells insurrections, and carries out internal security operations especially those that threaten the existence of the country. The issue between Okoloba and Okuoma people in Delta State is purely a civil matter and soldiers shouldn't be

"We are using this opportunity to call on the Nigerian government not only to strenghten our police, but the Nigerian Police should be well funded and equipped to discharge their legal duties effectively to demilitarize the society. We make bold to state that the Nigerian Army is overstretched, especially on issues they shouldn't get involved in the first place.

"As a people, the peace and security of the country remain our responsibility

and no one should drag our soldiers into things ordinarily they shouldn't get involved. The event in Delta should serve as a warning to the general public especially those in authority to observe caution in involving the military in civil matters. We call on Nigerians to please as a matter of urgency assist the community whose houses have been burnt and livelihood destroyed.

"These people need our assistance in any way possible. We are calling on relevant authorities and agencies to provide these innocent members of the communities with the necessary aid to feed and provide shelter for the displaced members of the community." He stressed. Noting further that as an organization, Rescue The Vulnerable Initiative has not only come to rescue the country from its current state, "but we will do our best to assist both the bereaved families of the slain soldiers and those communities razed.

"Our skilled volunteers and donors will be on hand

to help provide shelter and items for the members of the communities. We will continue to support the government where necessary and work assiduously to deliver a new Nigeria.

n Akwa Ibom State, it is not going to be business as usual for medical students enjoying government sponsorship abroad to jettison the contract and find greener pastures in their country of training. This follows the growing number of students absconding after undergoing a training programme facilitated by the state government outside the country.

Member representing Ibiono Ibom State Constituency in Akwa Ibom State House of Assembly, Hon. Moses Essien disclosed this during a chat with journalists in Uyo last weekend.

Hon Essien, who is also the Chairman of the House Committee on Health Services, expressed displeasure over what he described as unhealthy trend in the state, just as government was also putting up measures to stop the trend forthwith.

According to lawmaker, the state government is deeply concerned about the incident and has brought out a policy that would address it. The state government,

Hon Essien added, was also putting up measures to bolster the health sector and reduce the incidents of brain drain. While noting that a large chunk of the 2024 budget was earmarked to revamp the health sector, Essien said one of his motions on "the need to implement the Akwa Ibom State Health Insurance Agency Law" when executed would also bring a better package to health professionals.

He said though the State House of Assembly was yet to come up with a legislation to checkmate such, the state government has issued a circular making it mandatory for those undergoing sponsorship to come back and bring their wealth of experience for the development of the state and the health sector in particular.

"In my interactions with the Commissioner for Health and other management of the health sector in the state, I have discovered that they are a lot of persons that were sent out for training abroad, but could not come back, just because they have found a better opportunity in the places they have gone for training.

"As a House of Assembly, we have not yet come out with a legislation to curtail that, but I think the Executive Order is enough to curtail exodus of doctors being sponsored by the state government.

"The State Government has sent out a circular to those undergoing sponsorship for advanced knowledge in their area of discipline, making it mandatory that they must come back and bring their wealth of experience to develop the state and the health sector.

"Not for you to take the government sponsorship and at the end you abandon the state sponsor of the programme to the detriment of the state and the health sector.

"There are so much the present government is bringing starting from remuneration and more incentives. It is trying hard to put all those things medical doctors are complaining in place so that they will not be lured to practice outside."

NDLEA Busts Drug Cartel, Arrests 8 Suspects, Seizes 11 Vehicles, Recovers 44, 948.1 Kg Illicit Drugs In Lagos, Ondo, Edo

t least, a total number eight suspects are now cooling their feet in the custody of the National Drug Law Enforcement Agency (NDLEA) following their arrest during massive raids across Lagos, Edo, Ondo and others by operatives.

Eleven vehicles were reportedly seized from the drug cartels and over 44,948.1 kilogrammes recovered from them.

The Director Media and Advocacy of the agency, Femi Babafemi made the disclosure in a statement made available to journalists yesterday.

He also revealed that a total of 7, 687.8kg of cannabis was destroyed in a warehouse in Ala forest, Akure, Ondo state with another 670kg evacuated, on Saturday March 23, 2024, while no less than 14,310.8625kg of same psychoactive substance was razed on 5.7 hectares of farms in Ohosu/Ugbogui forest, Ovia South West LGA, Edo State on Tuesday 19th March, where five suspects including 67year-old Sunday Otulugbu; Agbayeogor Joshua, 39; Kelvin Ofuasia,45; Williams Peter, 37; and Kamaru Onimisi, 44, were arrested.

Babafemi added that the operatives, in another operation in Uzebba/Avbiosi forest on Thursday 21st March, destroyed over 6,500kg cannabis on 2.6 hectares of farms where three suspects: Kabiru Idris, 36; Alaba Jimoh, 40; and Lekan Asobere, 35, were arrested.

Similarly, 5,000kg of same substance was razed in a warehouse in Okpuje forest, Owan West LGA by NDLEA operatives with support from the military on Friday 22nd March.

Giving a breakdown on the arrest an seizures of the vehicles, said " In Lagos, a well-coordinated operation on Wednesday 20th March, according to Babafemi led to the seizure of 10,534 kilograms (10.534 tonnes) of Ghanaian Loud, a strain of cannabis in Ajah area of the state where 11 vehicles were seized from the drug cartel.

" The recovered vehicles include: Iveco truck marked KRD 522 YE; Toyota sienna marked AAA 338 GL; Toyota sienna marked AAA 308 EP; Toyota sienna marked FKJ 381 JC; Nissan bus marked EKY



846 YG; Mercedes bus marked EPE 743 XT; an unmarked Iveco J5 bus; Toyota sienna marked LSD 744 GP; Toyota highlander SUV marked KTU 280 FN; Toyota sienna marked AAA 333 GH and Toyota sienna marked FKJ 208 HV", he stated.

" In another raid at Ago Palace way area of the state on Friday 22nd March, a suspect, Miracle Obi was arrested with 1,006 ampoules of pentazocine injection; 50 tablets of tramadol 225mg; 89 bottles of codeine syrup and 2,360 ampoules of Diazepam injection. Another suspect, Kareem Mustapha was earlier on Tuesday 19th March nabbed along the Lagos-Ibadan expressway with 25,000 pills of tramadol and 5,900 ampoules of pentazocine injection.

While 58kg cannabis was recovered at Jagindi village, Kafanchan LGA, Kaduna State on Friday 22nd March, Abdulqadir Muhammad, 34, was arrested with 45 kilograms of same substance by NDLEA operatives along Kaduna-Zaria expressway. In Borno state, Salisu Yusuf, 20, was nabbed with 30kg Arizona, a strain of cannabis at Njimtilo checkpoint on Saturday 23rd March, while another suspect, Rabiu Husseini, 27, was

arrested with 34kg cannabis along Gwagwalada/Abuja highway on his way from Lagos to Katsina state on Wednesday 21st March.

The following day, 22nd March, NDLEA officers on patrol along Gashua-Baymari road, Busari LGA, Yobe state arrested Haladu Hassan with 160 blocks of cannabis sativa weighing 50kg.

In Kano state, a syndicate dealing in cocaine and heroin was successfully dismantled with the arrest of 42-year-old Onyeka Uba at Sabon Gari area of Kano where 1.805 kilograms and 7grams of the illicit substances were recovered from him on Monday 18th March. Another suspect, Ubale Sani, 49, was also arrested with 51.5kg cannabis at Chiromawa area of Kano.

Operatives of a special operation unit of NDLEA also disrupted criminal activities of another cocaine syndicate in Abuja at the weekend with the arrest of three leaders of the group. While Nnajiofor Celestine Kenechukwu, 41, and Okoro Chigozie Christian, 35, were arrested.

On Friday 22nd March at Paint House Hotel, Umar Garba Benna Street, 21 Road, First Avenue, Gwarimpa Abuja with 718 grams of cocaine, a follow up operation at the residence of Okoro Chigozie at House 30, 69B Road 6th Avenue Gwarimpa, led to the recovery of 19 blocks of Arizona, a strain of cannabis weighing 9.823kg and monetary exhibits: N545,500 and \$250, as well as property documents. Two vehicles: Toyota Camry 2007 marked BWR 94 BM and Toyota Camry 2012 marked RBC 154 BS were also recovered from them.

The following day, 22nd March, NDLEA officers on patrol along Gashua-Baymari road, Busari LGA, Yobe state arrested Haladu Hassan with 160 blocks of cannabis sativa weighing 50kg.

In Kano state, a syndicate dealing in cocaine and heroin was successfully dismantled with the arrest of 42-year-old Onyeka Uba at Sabon Gari area of Kano where 1.805 kilograms and 7 grams of the illicit substances were recovered from him on Monday 18th March. Another suspect, Ubale Sani, 49, was also arrested with 51.5kg cannabis at Chiromawa area of Kano.

Another follow up operation to the residence of Nnajiofor Celestine Kenechukwu at 49 Mercy Orjiakor street, Becky Estate 11, Karu, Nasarawa state on Saturday 23rd March also led to the recovery of various quantities of Arizona and methamphetamine while his girlfriend and accomplice, Ifemenam Oge was arrested.

With the same vigour, the various commands of the Agency across the country continued with the War Against Drug Abuse, WADA, advocacy campaign in the past week. Some of them include: WADA sensitisation lecture for students and teachers of Government Day Secondary School, Damaturu, Yobe; Government Secondary School, Afaha Ukwa, Akwa Ibom; Total Child School, Awka, Anambra and Celestial Church of Christ High School Oke-Ado, Ibadan, Oyo state, among others.

While commending the officers and men of the Lagos, Edo, Ondo, Kano, Borno, Kaduna, and FCT Commands as well as the Special Operations unit of the Agency for their outstanding feats in the past week, Chairman/Chief Executive Officer of NDLEA, Brig. Gen. Mohamed Buba Marwa (Rtd) equally applauded their counterparts in all the commands across the country for intensifying their WADA advocacy lectures in schools, markets, motor parks, worship centres and work places.

Oyo CPN Advocates End To Child Kidnapping In Nigeria *Holds peaceful protest in Ibadan

Non-Government Organisation, the Child Protection Network (CPN), Oyo State Chapter and other stakeholders on Friday, staged a peaceful protest to decry the incessant and wanton kidnapping of children across Nigeria.

Speaking with journalists at the protest ground, Total Garden area of Ibadan, the CPN state Coordinator, Mrs Oluwatoyin Ogedengbe said CPN resolved into speaking up against the aberration and that major stakeholders including the government, public spirited individuals, religious/ community leaders, and families should rise up to the occasion of saying no to the menace of kidnapping.

Mrs Ogedengbe described the recent kidnapping of at least 287 school children by armed gunmen in LEA Primary and Secondary School in the Kuriga village of Kaduna's Chikun district as highly worrisome, adding that such occurrences has to be stopped at all

Stressing that contrary to the notion that such occurrences only take place in the North, she disclosed that the recent record of such in Ekiti State is a clear pointer that the life of all children matters, calling on the government at all levels to put mechanisms and structures in place to ensure the security of not just children, but for all and sundry.

Mrs Ogedengbe tasked the government to do more in increasing the budget and allocations of funds geared towards providing efficient and effective equipments for combating terrorism and kidnapping. According to Mrs Ogedengbe, the case of Chibok school girls abductors, The protesting CPN Advocates in Ibadan who are yet to be apprehended was an

indication that government still has so much to do in making sure the lives of all Nigerians is secured.

The CPN state coordinator then charged all Nigerians to join the fight against the kidnapping of children by staying vigilant and reporting whoever is involved and aiding or abating the practice of kidnapping children.

Representative of National Human Rights Commission, Mr Babatunde Onilari in his remarks said the pressure



of existing or impending kidnapping is becoming unbearable for families hence the need for the Northern Leaders Forum, Northern Governors Forum and the Northern Senators Forum to speak out against it.

The Executive Director of Youth Care Development and Empowerment Initiative, Dr Adefunke Ekine advised the government to nip kidnapping in the bud, adding that the economic benefit inclined with the nefarious practise is what is still keeping it going,

Executive Director of Child Development and Concern Foundation, Alhaji Iskil Yusuf noted

that the continued re-occurrence of child kidnapping ten years after that of the Chibok school girls was alarming and a clarion call for the government to wake from it's slumber and ensure necessary actions are taken to bring kidnapping to a close in Nigeria.



Prof Ujah who is the immediate past President of Nigeria Medical Association, informed the royal fathers that FUHSO students are doing well particularly those from Idoma extraction, pointing out that admission and employment are not influenced by favouritism, disclosing that the Remedial Science Programme was established to aid the immediate communities secure admission into degree programmes for their children, hence their deficiencies in science subjects, as one of its Corporate Social Responsibility.

o fewer than nine s u s p e c t e d kidnappers have been arrested during the week by police operatives in Lagos, New Nigerian Newspapers has learnt.

They were said to have been arrested after a shootout that lasted several hours at Ajah area of the state.

The operation was reportedly carried out around one of the suspects' hideouts in the Lekki-Ajah axis of the state.

The police said the suspects were members of a notorious gang of

kidnappers operating in the Lekki-Ajah axis.

The Force Public Relations Officer (FPRO) ACP Olumuyiwa Adejobi confirmed the arrest in a statement made available to newmen on Friday.

Adejobi said the arrest followed the resolution of the police to reduce crime to a manageable level.

He stated that the arrest followed series of complaints from members of the public to the state Commissioner of Police, Adegoke Fayoade, over an upsurge in kidnapping along the Lekki-Ajah axis. The force spokesperson added that during the raid.

three Point of Sales (POS) machines allegedly used for the collection of random money and 10 mobile phones were recovered.

Adejobi said over the past weeks, the operations had recorded several achievements.

"In a more recent happening, on March 17, 2024, at about 10:30 pm, the Commander PMF 20, Ikeja, Lagos led a joint team of mobile men and officers from Maroko Division to a suspected den of kidnappers where they arrested nine kidnappers.

"Three of their victims

were also rescued while 10 mobile phones and two PoS machines were recovered from the suspects.

"In a similar occurrence in the same Lagos State, on March 16, 2024, police operatives of the Badagry Divisional Headquarters, Lagos State arrested one Abass Taiwo Hassan, suspected of being the leader of a cult gang involved in the shooting of one Adeniyi Adebanjo, on February 26, 2024 and upon his arrest, the suspect confessed to the crime and admitted to being the leader of a 6-man cult gang," he said.

Delta Govt Confirms Cases of Lassa Fever In 4 LGAs

he Government of Delta State has confirmed the outbreak of the dreaded Lassa Fever disease in four local

government areas of the state.

The four local government areas include, Okpe, Oshimili North, Oshimili South, and Ndokwa East, with four cases so far recorded.

Announcing the outbreak,, the state Commissioner for Health, Dr. Joseph Onojaeme made the announcement while briefing newsmen in Asaba, the state

capital.

Onojaeme said the government is doing a lot of advocacy, especially to health workers, and sensitisation of residents to have a high index of suspicion when they see those cases.

"In week 12, we have four confirmed cases so far recorded with a fatality rate of 50% though the general fatality rate for Lassa fever is 1 - 15% so we are doing everything humanly possible to ensure that we curtail the transmission from patient to health workers and from patients

to relatives."

"The government is doing a lot of advocacy, especially to health workers, and sensitisation of residents to have a high index of suspicion when they see those cases.

"The State government is also working closely with Irrua Specialist Hospital, Edo State, and has been able to achieve less than 24 hours of getting test results on Lassa fever as against what was commonly obtainable which was within the range of 72 hours."

The State Epidemiologist, Dr. Mildred Igumbor said one case of Lassa fever is an outbreak, hence all hands should be on deck to ensure the elimination of the disease.

"To ensure prevention and control measures are in place in our health facilities, health workers must have a very index of suspicion. We are telling everyone that not all fever cases are malaria cases so if you are sick please go to any nearest health facility or qualified medical personnel to seek

medical attention.

"So, if you get there and the health personnel have a high level of suspicion you will be tested and with the result received such patient will be properly managed.

"The Isolation Center in Federal Medical Center Asaba, built by the State Government has the capacity for isolation and management of confirmed cases and if need be for referrals they would be transferred to Irrua Specialist Hospital, Edo State".

Water Day: Average Nigerian Consumes Only 9 Liters Of Water Daily, APWEN Laments

resident Association of Profession a 1 Women Engineers of Nigeria (APWEN), Dr. Adebisi Osim on Friday, lamented that average Nigerian consumes only nine liters of water per day. Osim stated this in Ilorin on Friday, while presenting a paper in commemoration of the 2024 World Water Day organized by APWEN. under the theme, "Water For Peace".

According to her, this falls below the national acceptable minimum standards of 12 to 16 liters per day.

She stated that statistics from the World Bank, approximately 70 million Nigerians do not have access to safe drinking

"Globally 122 million people have to collect resulting in over 600 unsafe water from streams or ponds. Two billion people lack safe drinking water and 114 million do mot have access to basic sanitation," she said.

Osim who was represented by Mrs. Nihinlola Olawuyi, the APWEN Kwara Chapter Chairman, enjoined all stakeholders to utilize water as potentials to foster harmony, cooperation, and peace among nations and communities worldwide. She observed that water is

not only essential to life

itself, but it also has the power to transcend borders, cultures, and ideologies.

"Throughout history, water has served as both a source of conflict and a catalyst for peace. It has been a cause for dispute over shared resources, yet it has also been a cornerstone for collaboration and diplomacy.

"However, we must recognize that water also possesses the transformative power to build bridges, reconcile differences, and forge pathways to peace," she said.

She observed that inadequate access to water and poor management practices majorly contribute to Nigeria's water and sanitation crisis. According to her, widespread flooding has also affected 3.2 million people in Nigeria, fatalities and displacing of over 1.4 million people.

Osim called on governments at all tiers and other stakeholders to collaborate with APWEN towards goals of securing water for peace.

Also in his presentation, Dr Lawal Olohungbebe, the Senior Special Adviser on community development to the Gov. AbdulRahman Abdulrazaq of Kwara observed the criticality of water and sanitation in pursuit of sustainable development.

He underscored the imporatnce that the state government attaches to partnership with APWEN, Organised Private Sector in Water, Sanitation and Hygiene (OPSWASH), to tackle societal challenges such as water and sanitation.

"The situation is further excerbated by the effect of climate change, population growth, rapid urbanization and socioeconomic factors.

Similarly, Dr Saheed Aremu, the Managing Director of Lower Nigeria River Basin Development Authourity emphasised the need to utilize water for peace in our nation.

He observed that there are many challenges that confront communities in terms of availability of water, including climate change and uncontrolled population.

The Managing Director explained that there is need to make the invisible, underground water, visible and accessible to generality of the masses.

Mr Usman Lade, the Kwara Commissioner for Water Respurces, observed that water is paramount to existence, while reiterating the commitment of the state government to collaborate with key stakeholders to achieve better results.

He disclosed that the state government has achieve 74 per cent success on access of water to communities, adding that the state will continue to

improve on this statistics. Lade also stated that the government has already taken initiative in training of youths on repair and maintenance of boreholes in thier respective communities.

In her Lecture, Mrs Oluwatoyin Babatunde, the OPS WASH Coordinator in Kwara, submitted that APWEN's commitment is in support of President Bola Tinubu's administration on community engagement. She explained that OPS WASH is an umbrella body conducting private sector engagement in SDG-6.

According to her, the focus is to create and source partner to make impact and accelerate the private sector coordination in Nigeria for SDG-6 and other related SDGs.

The expert explained that APWEN uplifts communities in various ways, offering career counselling session for female students in primary, secondary and tertiary institutions.

She noted that this is to increase the number of global engineering voices of women for Nigeria. The OPS coordinator

therefore, called for private sector organisation support in Kwara within OPS WASH objectives. Babatunde also advised better understanding of community needs, private sector support and needs among others.

epartment of State Service (DSS), Akwa Ibom command has arrested

four kidnap suspects alleged to have been terrorizing and masterminding kidnappings in the state in recent times.

The suspects, identified as Idris Abdullahi, Abel Attah Ekong, Itoro Edet Effiong and Nsisong Edet Effiong were arrested between February 16 to 28, 2024. Report from the command

informed that the suspects were syndicates who abducted Mr. Ayo Bambe, the Manager of Me Lounge, a popular recreational center located at Osongama Estate, Uyo and two others on January 27, 2024.

According to the report, the command arrested Abdullahi, the driver of the syndicate in Port Harcourt, Rivers State on February 16, 2024 in a Toyota Sienna vehicle used in the operation.

Another suspect, Ekong was apprehended at Otua Sega community of Ogbia Local Government Area in Bayelsa State on February 26, 2024, while Itoro and Nsisong, whose brothers were arrested in their residence at Mbak Etoi in Uyo Local Government Area of Akwa Ibom State on February 28, 2024.

"During investigation, the four (4) suspects confessed their involvement in the kidnap of the three victims at Me - Lounge and other attacks across the state.

'Consequently, the suspects will be arraigned by the command at Federal High Court Uyo while a manhunt for other fleeing members is still ongoing". The report from the command said.

Tor therefore, maintained that it was high time all the purported suspended stakeholders came back and rebuilt their home for the success of the President Tinubu and APC led Federal Government.




Furthermore, the Vice Chancellor highlighted various achievements of the university, including infrastructural developments and improvements in student welfare.

> "SGBV is prevalent in this two communities, coupled with conflict between them, so to address cultural norms and SGBV issues, we felt that we should address the concerns of women that could lead us get the men and we can promote peace within the communities. Both Dangoma and Goska had been worrying communities and now they are back together, talking together and they are supporting us in all that we do to promote peace.

> "For us, we think that one major hindrance is their women not having except open environment, so we felt that we should provide them protective safe space that the women and young girls can have time to sit down and discuss issues that concern them and address them holistically as a body.

"Before we came in, Goska and Dangoma were not sitting together, they were in war-torn, we brought them together for the first time after a long time of crisis".

Speaking on behalf of the two communities, the village heads, Mr. Samuel Barde of Goska and Malam Muhammad Bayi of Dangoma respectively, thanked the NGOs for providing the safe space.

"It will also reduce much of the cases of SGBV in our communities because justice is bound to be served to perpetrators and would serve as deterrence to others". They said.

UK, Taking Medicines For Russia's Headache

HE United Kingdom (UK) has become the chief mourner, wailing over the presidential election in Russia which gave President Vladimir Putin a new term.

For a country at war and under all sorts of sanctions, it might have been expected that the Russian election would be postponed indefinitely. But it not only held, there was also a reported voter turn-out of 74.22 per cent.

The UK, from its colonial history, assumes that democracy is what it thinks, and any election it does not like, is not democratic. So, it supported the 'democracy' of Apartheid South Africa, and declared that those like Nelson Mandela, Joe Slovo and Walter Sisulu who rejected the Apartheid system, were "terrorists".

The British media reported that: "Reuters journalists saw an increase in the flow of voters, especially younger people, at noon at polling stations in Moscow, St Petersburg and Yekaterinburg, with queues of several hundred people and even thousands."

There are also some facts about the election which have not been disputed. There were over 94,000 polling stations which opened daily for 12 hours from 8am. Russians in 144 countries abroad, including the UK, cast their votes in 295 polling stations. Voters also voted on online. Given the country's size, the world-wide election, and the fact that Russia is at war, only eight electoral incidents were recorded where there were attempts to set polling station buildings on fire.

Internet service providers in Russia reported that there were over 90,000 Denial-of-Service (DdoS) cyberattacks from Ukraine and North America targeting the Central Election Commission, State Services portal and other government websites.

Additionally, Ukraine tried to sabotage the election by repeatedly shelling Russian regions and oil refineries during the three-day election. Also, thousands of anti-Putin demonstrators protested at polling stations inside Russia and abroad over the February 16, 2024 death of jailed opposition leader, Alexei Navalny.

In the final outcome of the election, Putin defeated the presidential candidates of the New People Party, Vladislav Davankov; the Liberal-Democrat Party of Russia, Leonid Slutsky; and the Communist Party's Nikolai Kharitonov.

The UK could not condemn Putin for having a fifth term probably because

like Russia, its Prime Minister has no term limit. A British Prime Minister like Sir Robert Walpole spent 20 years, 314 days in office, while William Pit the Younger, spent 18 years, 305 days in office.

I do not subscribe to a president spending more than two terms in office, but it is not in our place to dictate term limits for countries.

Expectedly, the Russian election was condemned by many Western countries. Studying their statements, one got the impression that some might have been drafted

before the election was held.


Although Western countries have lined up to condemn the Russian election, they are generally silent on the refusal of Ukraine's Voldymyr Zelensky to conduct election which fell due this March. He said the martial law which he had declared, precluded election from being held. So, he is likely to stay in power without election for as long as he wants, or until he is thrown out.

Perhaps the most strident was that by the UK, issued by Foreign Secretary, David Cameron. Without providing any evidence, it claimed that there was "suppression of opposition voices during the Russian election". Expectedly, it was unhappy that elections also took place in some of the breakaway regions of Ukraine

Although the turnout was far higher than the 66.7 per cent in the 2020 United States presidential election and, the 67.3 per cent in its 2019 general elections, the UK claimed that: "These Russian elections starkly underline the depth of repression under President Putin's regime, which seeks to silence any opposition to his illegal war." It added that: "Putin removes his political opponents, controls the media, and then crowns himself the winner. This is not democracy." Really, the turnout does not mean anything?

The UK, from its colonial history, assumes that democracy is what it thinks, and any election it does not like, is not democratic. So, it supported the 'democracy' of Apartheid South Africa, and declared that those like Nelson Mandela, Joe Slovo and Walter Sisulu who rejected the Apartheid system, were "terrorists".

But it is not only external elections it



rejects; the British establishment also condemns elections won by those considered to be anti-establishment. For instance, there was a by-election on February 29, 2024 into the Rochdale Constituency in the UK Parliament. This followed the death of Labour MP Sir Tony Lloyd. The established parties were in for a rude shock as George Gallaway, the outsider from the Workers Party of Britain, caused a Tsunami. He won 40 per cent of votes, overturning a 9,668 Labour votes at the 2019 general election.

Gallaway won 12,335 of the votes, David Tully of the Independent came a distant second with 6,638 votes, Paul Ellison of the Conservative Party was third with 3,731 votes, Labour's Azhar Ali was fourth with 2,402 votes and Iain Donaldson of the Liberal Democrats came fifth with 2,164 votes. All hell seemed to have broken loose, especially when Galloway is not only pro-people but also campaigned openly for a stop to the on-going Israeli genocide in the Palestine.

A shocked Prime Minister Rishi Sunak called a hasty press conference outside No 10 Downing Street where he said Gallaway's victory was "beyond alarming". He wondered how British voters could have voted overwhelmingly for a candidate who "dismisses the horror of what happened on October 7", when he said Hamas murdered 1,200 people in Israel.

Putin in defending Russian democracy said: "The whole world is laughing at what is happening (in the United States). This is just a disaster, not a democracy". Apparently, in reference to the four criminal cases against Republican

candidate Donald Trump, Putin added: "... Is it democratic to use administrative resources to attack one of the candidates for the Presidency of the United States, using the judiciary among other things?"

But Gallaway after being sworn-in said he had not come to parliament to make friends: "I've always loved the building –the people in it not quite so much."

On Prime Minister Sunak's attack on him for winning the election, Gallaway said: "I despise the Prime Minister. And guess what? Millions and millions and millions of people in this country despise the Prime Minister. I do not respect the Prime Minister at all."

wo penalty goals, one in each half, were all Nasarawa United needed to end Wikki Tourists' unbeaten run in the 2023/24 Nigeria National League Season.

In a feisty match-day eleven encounter at the Lafia City Stadium on Saturday afternoon, former Wikki player, Anas Yusuf, thought he had put United in the lead when his breathtaking acrobatic ball found the back of the net in the 12th minute only for the goal to be ruled out as offside.

A statement signed by the Media Officer, Nasarawa United FC, Eche Amos, made available yesterday, said that the energetic winger wouldn't be perturbed for too long as he rose to the occasion to put the his side in the lead in the half-hour mark after menacing attacker, Ibrahim Umar Ada was hacked down inside the box in the first-half.

Upon the restart, United effected some tactical changes, with the introduction of midfield maestro, Chidera Nduka, and attacking sensation, Adamu Hassan in places of Habibu Alakija and Umar Ada, to add both depth and bite upfront.

In the 71st minute, Peter Eneji struck the cross bar with a powerful shot before Wikki replied with multiple attempts on goal but for the bravery of Goalkeeper, Ameh Godwin, who saved each attempt to the applause of the home fans.

With twenty-three minute before regulation time, substitute, Adamu Hassan, was brought down inside the box with the referee pointing to the spot without hesitation.

Former Nigerian junior international and fellow substitute, King Osanga, stepped forward to convert from the spot to bring score to 2-0 in favour of the home side.

As the game approached fulltime, tempers began to flare as Wikki's Bismarck Duah shoved down one of the ball boys, but the referee was able to bring the situation under control.

Further attempts by either side couldn't make any difference to the scoreline as Nasarawa United brought to an end the unbeaten form of the Bauchibased Wikki Tourists this season as Goalkeeper, Ameh Godwin, of Nasarawa United was voted Man-of-the-Match for his spectacular goalkeeping ingenuity.

The win means United are head-to-head with the Big Elephants on 23 points, with the latter team having played a game more.

Wikki are ahead of the Solid Miners only on goals' advantage, United having nine goals against Wikki's thirteen.

The Solid Miners will be on the road to Yobe to face Yobe Desert Stars FC on Saturday, 30th March, 2024, but before then, they will take on Nationwide League One side, AYD FC of Doma in the Nasarawa State Federation's Cup Semi-Final clash on Monday, 25th March, 2024, by 3pm at the Lafia City Stadium, in their bid to pick one of two available tickets for the National Federation's Cup competition.

The Solid Miners' next home clash is against El-Kanemi Warriors FC on 6th April, 2024.

Mighty Jets of Jos will be United's second to the last away game this season on 13th April, 2024, with their last home game against EFCC coming up on 20th April, 2024.

The game away to Zamfara United will be the Solid Miners' last game of the Season on 27th April, 2024, primus interpares.


