

Youth Criminal Activities In Nigeria Becoming Worrisome

he nefarious activities of our youth in several criminal activities across the nation is becoming disturbing, worrisome, and negatively impacting the image of the nation.

Investigations showed that in spite of the stiff penalties against acts of same sex relationships offences, there is an upsurge in youth engagements as various incidences recorded at Police Stations across the country are discouraging.

Recalled that one Odiri Rachel Ogezo who was arrested on July 29, 2018 by the Police in FESTAC Area of Lagos while engaging in samesex with her partner confessed that her involvement was a product of her indoctrination while in a boarding

school.

Also, in April 2019, Marvis Osarodon Ogbemudia was arrested, detained and interrogated by the Police in Aguda, Lagos State along with other accomplices following their conduct of public nuisances while holding a LGBTQ party at Carlsbad Lounge and Nite Club located at Adeniyi Jones, lkeja, Lagos. They confessed to engaging in same sex affairs and subsequently granted bail.

In a similar case, a lady named Osarumwense Cole was arrested along with other females in June 2022 at a birthday party held at Club Raptor and Lounge along Stadium Road, Ogogugbo in Benin City where they constituted themselves into public nuisance and breached public peace by participating in a

lesbian party, thereby committed an offence contrary to the law.

In Delta State, the Police in Sapele Divisional Heaquarters granted bail to one Goodluck William of 33, Awolowo road, Sapele who was arrested in July 2022 along with other male offenders while engaging in acts of same sex at a gay birthday party at MK Lounge, Sapele.

The culprits confessed to the crime, and some of them have been charged to the court while Goodluck William has absconded in order to evade prosecution.

These disturbing trends have the potential to escalate unless the prosecution and convictions of suspects are timely effected in order to serve as deterrent to other youths with similar cases.

Tension In Enugu Community Over Alleged Imposition Of King 9 Years After Death Of Ex-Monarch *Natives disrupt purported election by govt

he chieftaincy tussle rocking L Isienu Amofu Autonomous Community. Nkerefi in Nkanu East Local Government Area of Enugu State on Saturday, took a new twist as natives of the locality disrupted a purported election fixed by the state Ministry of Chieftaincy Affairs to elect a new traditional ruler for the community, over alleged imposition. The aggrieved members of the community made up of five villages namely, lsi-Uga, Umuogbi, Umunama, Umuezeochi and Umuokala said they rose against the purported election because some officials in the state Ministry of Local Government, Rural Development and Chieftaincy Matters, connived with some selfish individuals in the community to impose one Christian Ogbonnaya

1. Whether any other person or group, apart from the General Congress of Ishienu Amofu, can validly set up the Igweship Pre-election screening committee?

2. Whether any other person or group, apart from the Ruling Council in consultation with the Traditional Council, can validly call for the election of a new Igwe to replace a dead one.

been duly served, the Ministry officials still came to conduct the jamboree election, an act they said is disrespectful to the court, adding that they will not allow them to disrespect the court in their

Onyeabor regretted that despite the service of court processes on the town union and Ministry of Chieftaincy Matters on the subject matter pending in court, the ministry still went ahead to fix March 30 for the botched election He called on the state governor, Peter Mbah to as a matter of urgency, intervene by ensuring level playing ground for all interested aspirants in the stool to participate before the situation degenerates into crisis.

Also speaking, one of the aspirants to the throne and the 1st plaintiff in the pending suit, John Njoku said he purchased form with a huge amount of money but was never communicated with any information by the town union leadership on the proposed election.

ormer lawmaker, Senator Shehu Sani has called on all religious leaders across the country to shun selfish and mischievous politicians, who hide under guise of religion and ethnicity to divide the people during elections.

According to him, there is the need for clerics to avoid such politicians, especially, those who have lost power and are now weeping all sorts of sentiments against government of the day.

Speaking during a dinner (breaking fast) held on Saturday evening at in Kaduna, Senator Shehu Sani said, "Poverty and hunger have been so weaponised, to control the masses for self aggrandizement."

While stating that clerics should use places of worship to preach messages of peace and unity as well as enlighten adherents on power of voting good leaders during elections, Senator Sani said democracy can only survive if there is equity; justice, progress and development.

Sani, who said the country does not belong to one ethnic group, stressed, "Power has resided so long become so toxic.

"Power in the North has not helped Northerners, the region is still backward in all aspects of human and capital development."

He however, advised Northerners who are ganging up against President Tinubu, to instead support the government in the interest of progress and development of the north as against quest for return of power to the region.

"Politicians, who failed to secure appointment under Tinubu-led government can't manipulate us for personal interests. They have lost their sense of entitlement and are now trying to whip sentiments of kinds to be relevant."

On issues of security and economy, Senator Sani blamed former President Muhammadu Buhari for failing to improve on the economy and ensure adequate security of lives and property of the citizens.

According to him, the whole security apparatus was controlled by northerners and Muslims, yet banditry and terrorism

onference Of Nigeria Political Parties (CNPP) has accused the leadership of Labour Party (LP) of mismanaging the ongoing leadership crisis in the party, urging the embattled national chairman of the party, Barr Julius Abure to resign now that the ovation is loudest.

The CNPP stated this while reacting to the newest twists to the leadership tussle in the party.

According to a statement issued yesterday by its Deputy National Publicity Secretary, Comrade James Ezema, the umbrella body of all registered political parties and political associations in the country equally hailed the Independent National Electoral Commission (INEC) for resisting what it described as obvious pressure to use its officials to endorse the outcome of the recent contentious fractional national convention of the party.

"In view of the obvious lack of internal democracy in most of the political parties in Nigeria, INEC has done well for the sake of advancing our democracy by resisting obvious pressure to use its officials to endorse the outcome of the recent contentious national convention organised by a faction of the party.

inclusivity that characterised the build up to the convention held in Anambra State, making it contrary to the Federal High Court's judgment of Friday, July 23, 2021, which ordered parties in the Labour Party leadership tussle "to maintain status quo ante bellum in order not to disturb the res of the matter pending further order of the court."

"In the same vein, in the judgment of the Federal High Court in Suit no. FHC/ABJ/CS/866/2014 between Labour Party and 3 Ors. vs. Com. Salisu Muhammed, the court unequivocally declared Labour Party as an institutional political party founded, promoted, and registered by the Nigeria Labour Congress (NLC) on behalf of the Nigerian Workers.

"In this light, the Julius Abure faction of the party misfired by holding the purported national convention of the Labour Party when it fell short of "an expansive and inclusive" exercise as ordered in a widely publicised subsisting court order.

"Leaving out NLC and other critical stakeholders in its consultations ahead of the convention was a miscalculated move as we recall that the former national chairman of Labour Party, High Chief Dan Nwanyanwu, on leaving office, submitted the Labour Party's certificate of registration to the union in recognition of Labour Party as an institutional political party founded, promoted, and registered by the NLC. "For us, the current leadership crisis rocking the Labour Party is needless and avoidable if basic ingredients of democracy, including inclusivity, justice, and accountability, were observed", the CNPP stated.

Kogi Govt Debunks Allegation Of Attack **On Opposition Party**

ogi State Government has frowned at the spurious allegation by the Social Democratic Party (SDP) that its members spanning through the central senatorial district, have been attacked by supporters of the ruling All Progressives Congress (APC) for testifying against it.

SERAP Gives 36 Governors, FCT 7 Days Ultimatum To Provide Loan Agreement, Spending

he 36 states governors and the Minister of the Federal Capital Territory, Nyesom Wike, have been given one-week ultimatum by the Socio-Economic Right and Accountability Project to provide the loan agreements and spending details of the loans obtained by their states and the FCT.

A statement issued yesterday by the organisation's Deputy Director, Kolawole Oluwadare, explained that details and locations of projects executed with the loans that amount to N5.9 trillion and \$4.6 billion are requested to be included. It urged the state governors and the FCT minister to widely publish copies of its requests as it would help keep Nigerians in the know of how their states' governments spent their loans, and also ensure that persons with public responsibilities are answerable to the people for the performance of their duties in the management of public

funds. SERAP also urged them to promptly invite the Independent Corrupt Practices and Other Related Offences Commission (ICPC) and Economic and Financial Crimes Commission (EFCC) to investigate the spending of the domestic and external loans obtained by their state and the FCT.

The statement noted that its request followed the disclosure made by Sani, on Saturday, when he lamented the huge debt inherited from his predecessor, Nasir El-Rufai, on May 29, 2023, saying that the state is now left with a few amounts. not enough to pay salary, as his administration inherited a total of \$587m, N85bn and 115 contract liabilities from the exgovernor.

The organisation said that in the Freedom of Information requests dated March 30, 2024 and signed by SERAP deputy director Kolawole Oluwadare, the organisation said that it is in the public interest to publish copies of the loan agreements and details of how the loans obtained are spent.

It added, "Widely publishing copies of the loan agreements and spending details of the loans obtained would ensure that persons with public responsibilities are answerable to the people for the performance of their duties in the management of public funds."

The FoI requested that it would be grateful if the recommended measures are taken within seven days of the receipt and/or publication of the letter, stressing that if they have not heard from them by then, SERAP shall take all appropriate legal actions to compel them and their state to comply with their request in the public interest.

It said that it is seriously concerned that many of the country's 36 states and FCT are allegedly mismanaging public funds that may include domestic and external loans obtained from bilateral and multilateral institutions and agencies, saving that according to Nigeria's Debt Management Office, the total public domestic debt portfolio for the country's 36 states and the Federal Capital Territory is N5.9 trillion, while the total public external debt portfolio is \$4.6 billion.

The statement observed that many states and the FCT reportedly owe civil servants' salaries and pensions, while several states are borrowing to pay salaries with millions of Nigerians resident in your state and the FCT continue to be denied access to basic public goods and services such as quality education and healthcare.

It said that it is concerned that the domestic and external loans obtained by the state and the FCT are vulnerable to corruption and mismanagement, stressing that the government has a responsibility to ensure transparency and accountability in how any loans obtained by the state are spent, to reduce vulnerability to corruption and mismanagement.

The effective operation of representative democracy, the statement explained depended on the people being able to scrutinised, discussed, and contribute to government decision making, including on the spending of loans obtained by your state and the FCT, pointing out that to do this, they need information to enable them to participate more effectively in the management of public funds by their state government and the FCT.

The organisation further stated that there is a significant risk of mismanagement or diversion of funds linked to loans obtained by state governments including the state, saying that the accounts of Nigeria's 36 states and the FCT are generally not open to public scrutiny.

The state, the statement explained has obligations under international anticorruption and human rights law, including a responsibility to promote transparency and accountability in the management of public funds, prevent mismanagement or diversion of public funds, and redress any abuse of public trust.

Opacity in the spending of loans obtained by states, according to the statement has continued to have negative impacts on the fundamental interests of the citizens and the public interest.

It said that the state cannot hide under the excuse that the Freedom of Information Act is not applicable to the state to refuse to provide the details being sought, as the state also has clear legal obligations to provide the information as prescribed by provisions of the Nigerian Constitution 1999 [as amended], and the African Charter on Human and Peoples' Rights (Ratification and. Enforcement) Act.


Easter: Unilorin VC Greets Christians

▼ rand Knight Emeritus, Sir Tonna Okei (Ikuku Oma)an Ekuku-agbor, Agbor, Ika South Local Government Area of Delta State born, but South Carolina, United State of America based Nigerian, is globally recognized as President of South Carolina Organization of African Unity(OAU), a Honourable member of the board of trustees of knight of Columbus and a man that exudes torrents of energy when it comes to promoting Ika and Anioma cultures and tradition.

Now look, when you were interviewing me last year, I am not sure you knew I was passing through a lot. People did not know. I did not tell much. I was still functioning, I was still smiling. And that's the intention. I tell people that when you pass through challenges, you don't have to wear it on your face. You can still be functioning well. Just believe that tomorrow, things will get better.

Tonna who ruled out spiritual attack as being responsible for the harrowing health challenges that he underwent, further explained that the book is about the story of a man who passed through the very worst or what we call the biblical Jonah and lost almost everything but by the grace of God and the goodwill of men and women, survived and decided to write and capture it, using his African ancestral language - Ika. So, the book relates with Ika proverbs, theories and prayers. It is a mixture of what happened, a lecture on Ika proverbs and to inspire people using biblical verses also. Never in the history of Anioma was a book so well celebrated in the International Circle. Asked of his next line of action, Tonna responded this way; You know, a journey of a thousand miles starts with a step. We've launched the book here. It's a bestseller here because African Americans have been waiting to read a book that would capture

spirituality and African proverbs. They've seen it. Now, how do we go back home? That is the next issue.

I am discussing with the very high and mighty in Agbor if they could coordinate it so we can do a book launch and I would give 80% of the profit to Agbor so that they can build a gastroenterology center because that's my medical diagnosis.

I don't want Ndi-Ika and Ndi-Anioma to suffer this again. So, I am willing to partner with Ika leaders to open a GI center in Agbor, so we can begin to help our people that have Gastroenterology and abdominal issues, colon cancer. So, I'm talking to them now. Let's see what we can do to set up a GI center. I've spoken to A m e r i c a n Gastroenterologists and they are willing to train those doctors and nurses for two years. So, if Ika leaders fail to take up these projects, I'll rather decide to import the books from America and

begin to sell them in Nigeria or look for a good printer in Nigeria that would print it and we'll come and launch it privately.

On how to access the book, Tonna said; officially, it is now on Amazon for 50 dollars. But we know that that price will be too high for our people back home, so that is why we're looking at what we can do; If it's to launch it in Nigeria and bring the price down.

As to the level of support he received during his trying moment, Tonna again hinted that most times, it's only in suffering you know your true friends. In his words, "I would say I have been blessed with people who I didn't even know before this. They always told us that it may not be your children or family that will help you during your difficult times. I had some family members who I thought would have helped. But they're nowhere to be found. Some have not called, some have not given a dime but those who don't know me, maybe they read my articles in the past, they've truly helped me. Most family and friends sure supported but unfortunately very few, very few decided to stay away. Some I even empowered have now become scarce 'I have been blessed by friends,



mostly those I do not know. Some of them we've never seen face to face. They just know my name and what I've done. Most family and friends I've helped, Some Ndi-Ika I've helped, and they all just abandoned me at the most trying times'.

Away from support to a message of appreciation, Okei emphasized that his message to Ndi-Ika is to thank all those who have supported particularly members of Ika people's Congress.

Also, I want to inform them that through God and their support, I have written a book to document their journey, and the book is laced with Ika language, Ika proverbs. This is a book all Ika's should not only get but should keep. So all those who are not good at celebrating their culture can see that an Ika who was not born in Ika land and has lived abroad for about thirty years now, is celebrating Ika culture. That should inspire Ndi-Ika to be appreciative of their culture, to celebrate their culture. And this book will inspire them that a fellow Ika passed through all this and is still standing". On the relevance of the book to students of tertiary institutions in the state, the Ekuku Agbor born

Ambassador pointed out that the book is not a full history book but can help deepen our pride in our language. It can help both the medicine students, can help in philosophy, and can help mostly education students.

I believe that this book can serve as a reservoir and fountain of knowledge for those in medicine and education too, to understand medical challenges, to inspire people in philosophy and psychology. And for those studying African languages, this book will help them to say 'look, somebody in America can be so proud of his language and document it in a book celebrated in America. If the State Government should agree with it, they can make it a part of the curriculum for tertiary students. Anything is possible but let them see it first, let them read it. Then, we'll take it up from there. He concluded. For me, there are big lessons that bother on resilience, perseverance and need to keep faith alive to draw from the above narrative. Why Should Nigeria Not Breakup?

wo weeks ago, in my article entitled "Tinubu, beware the gathering dark clouds (2)", I touched on our unity and rhetorically ended by asking if going our various ways would be better for all.

I said, "To stitch the "merely a geographical entity" that we currently have, therefore, is a task that must involve all of us. We do not have any other country to call ours. And we cannot afford to see the country put together by God through the British rendered asunder.

"Another reason I always look at some Nigerians from the south and north who shout 'let Nigeria be divided:' "Do they know what they are saying? Do they think that is feasible anymore? Would it be beneficial to all concerned? We will look at this next."

NDLEA Uncovers Qatar Bound Illicit Drug Concealed In African Salad, Rejects N5m Bribe In Lagos

ttempt by a drug peddler to export 20 parcels of cannabis sativa weighing 10.70 kilograms concealed in African salad popularly called Abacha and dried vegetables to Doha, Qatar through the Murtala Muhammed International Airport (MMIA) Ikeja Lagos State has been busted my operatives of the National Drug Law Enforcement Agency (NDLEA), New Nigerian Newspapers has learnt.

Similarly, move by another drug dealer to compromise officers of the agency with a bribe of N5 million cash was rebuffed while the money was documented as part of exhibits to prosecute the suspects in court.

The Director Media and Advocacy of the agency, Femi Babafemi made the disclosure in a statement issued yesterday. He said, the Qatar bound drug peddler identified as a 35-yearold lady, Chidinma Chinenye Agbazue was apprehended by NDLEA officers at the Lagos airport working in partnership with men of the Department of State Security (DSS) had on Thursday March 28, while boarding from Lagos to Doha, on Qatar Airways during clearance of passengers at the screening point of terminal 11 of the MMIA.

According to Babafemi, preliminary investigation revealed that Chidinma was based in Qatar, but returned to Nigeria last December for Christmas celebration.

He explained that, Chidima, preparatory to her return to




