Our correspondent who was at some local markets to ascertain the commodity price situation, gathered that the price of all types of food items are currently dropping at markets and retail shops in many communities, which is an indication that in the near future, food items would become more affordable to consumers.

At Bichi Market, the price of food items like local rice, maize, sorghum, millet, beans and other related consumables have

After Yobe Records 20 Deaths From Meningitis Outbreak, WHO Hands Over Medical Kits

he World Health Organisation (WHO) has handed over assorted medical consumables to the Yobe State Government in its quest to control Cerebrospinal Meningitis (CSM) and Diphtheria outbreaks in the state.

Handing over the items at Yobe State University Teaching Hospital Damaturu on behalf of Dr. Kumshida Yakubu Balami, the World Health Organization (WHO) Interim Northeast Emergency Manager, Pharmacist Katugwa Emmanuel, said, the items will not only provide care for the healthcare workers but patients as well as their relatives.

"As you are aware, Yobe State is bedeviled with multiple outbreaks of diseases from last year to the beginning of this y ear. We started responding fully to the Diphtheria outbreak and by the grace of God, we are containing it but suddenly we had this cerebrospinal meningitis outbreak which started in February, 2024.

"We are seeing a different trend of meningitis that is type 'C' in our routine immunization vaccine which we give children under two years. This presentation hopefully we expect that our healthcare workers, patients and their relatives will all be protected so as to contain the outbreaks to its barest minimum" he said. The World Health Organization (WHO) as the lead agency in international health response is supporting the State Government to provide on-the-job mentoring, capacity building to healthcare

workers and coordinate

partners to ensure effective response across the hotspot Local Government Areas (LGAs). Additionally, the organization is strengthening pillars such as the Surveillance pillar to ensure early reporting and investigation, Case Management/IPC/Labor atory pillar, Risk Communication and **Community Engagement** pillar, and the Vaccine and Logistics pillar.

While appreciating the W or 1 d H e a 1 t h Organization (WHO) for their unyielding support and the gesture after receiving the items on behalf of the Yobe state G o v e r n m e n t, th e C o m m i s i o n e r f o r Health, Dr. Lawan Gana e x p 1 a i n e d t h e consumables would strengthen the healthcare system in the state.

"As a reliable partner to the state, these assorted medical consumables donated by the World Health Organization (WHO) will definitely support the state in controlling the outbreaks (Meningitis and Diphtheria). We have been working together with the World Health Organization (WHO) right from the beginning when we established the **Emergency** Operation Centre (EOC) in Potiskum, which is the

current epicenter of the Meningitis outbreak.

"We will continue to work closely to contain the outbreak and with this donation of items, it will further enable the health care workers to protect themselves and the patients they are providing services to," he said.

About 15 different medical consumables made of thousands of cartons were handed over to the Yobe state government.

Police Arrests 9 Suspected Ritualists, Including 2 ABU Students

By; SANIALIYU, Zaria he Kaduna State Police Command has confirmed the arrest of a nine-man gang of suspected ritualists under the name of 'Neo Black Movement (NBM) at a Cemetery in Dutsen Abba Ward along Zaria -Kaduna expressway with one full jerry can of human blood.

Their arrest followed a tip-off by the formation, after a source drew the attention of the service formation that some group of people were sighted at the said cemetery, which in turn Saye Lowcost Division was alerted.

Those arrested for alleged involvement in ritual activities are, Samson Ezekiel (32), Samuel Francis (27), Usman Nura (34), Gabriel Sheba (23), Haruna Sa'id (37), Bala Lukman (27) and Jabir Rilwan (37).

A search was conducted on their vehicle, a Lexus sedan, with registration number RSH 712 CW, where two locally made pistols, one Beretta pistol, two jacket knife, two calabashes and a jerry can,

full of human blood were recovered. The suspected ritualists,

comprising the new and the old members, were apprehended while initiating the new members.

They explained how they got the human blood while confessing to have slaughtered an aged man and have disposed his body along Jaji military cantonment, in neighbouring Igabi Local Government Area, where his vital body parts were dismembered, but were taken away by other gang which came from Kaduna. Following the arrest of seven suspected ritualists along Zaria -Kaduna expressway, two other suspects were apprehended by the locust, at ABU Congo Conference Hotels, along old Jos road, they are Austin Ifinju from Ondo State, aged 28 and Yoruba by tribe and Aliyu Ali Yahaya, resident of Hadu Nasko road Abuja, aged 24. Agatu by tribe and a

student of ABU Samaru.

Their arrest followed the recent arrest of the seven suspected ritualists, who specifically mentioned the duo during the interrogation by Lowcost, as their active members. The two have joined the

other seven in the custody of Lowcost Zaria Area Command for further investigation.

ASP Mansur Hussaini Public Relations Officer of the Command confirmed the arrest, explains that investigations are on going.

he National Human Rights Commission (NHRC) on Friday, hinted that Nigeria recorded 1,580 human rights violations in last month (March) alone.

NHRC Senior Human Rights Adviser, Mr Hilary Ogbona who dropped this hint, said the rights violations included killings, kidnapping, domestic violence, abductions, children's right among others.

Speaking at the National Human Rights Commission

the list of the complaints of human rights violations recorded with 468 cases. He stressed that the police, military, and Department of State Service DSS as state actors recorded 94 rights violations cases, adding that the killings of the military and police personnel in Delta State formed part of the report and that 542 cases of violation of children's rights were also recorded during the period.

Mr Ogbona maintained that domestic violence is becoming too rampant in some part of the country

and private actors have 32 and 36 respectively while 3 cases of violation of rights were recorded against disabled people. Stressing that other sectors including social economic and cultural rights accounted for 157 while referred cases was put at 24, he said killings and kidnapping accounted for 499 while another 71 violations of rights to life were also recorded by the commission during the period.

While maintaining that the 1,580 human rights violations were the entire

commission and Abuja, he expressed worry over the increasing cases of human rights violation, saying about 301 school children were abducted in Kaduna state alone while 40 people were killed in Benue state. he Peoples' Democratic Party (PDP) Kaduna State Chapter, has frowned at the revelations of Kaduna State Governor, Sen. Uba Sani, about the state of finances and misappropriation of funds of the State, by the former Governor of the State, Nasir el-Rufai, during a Town Hall meeting held on the 30th March, 2024. This was expressed in a statement signed by the PDP Kaduna State Publicity Secretary, Abraham Alberah Catoh, dated Friday April 5, 2024. "Though it did not come to

"We, as opposition party, are in full support of any plan by the government that would bring development to our dear State, bearing in mind that we shall always kick against anything short of that," PDP said.

The party recalled that, "in 2018 and 2022, the PDP in Kaduna State drew the attention of the Nasir el-Rufai-led government and the citizens of Kaduna State about the improper use of public funds, the criminal sale of landed properties belonging to the people of state and the unconstitutional mass sacked of qualified teachers and replacement of same with unqualified ones that have even deserted most of their duty posts; the PDP has been vindicated".

The PDP therefore, urged Governor Uba Sani to set up and mandate a Judicial Commission of Inquiry for full investigation into all the allegations to unravel the state of affairs of the \$587 million foreign loans, N85 billion local loans and N115 billion contractual liabilities of unpaid abandoned contracts inherited from the Nasir el-Rufai government.

Kogi: I Was Not In Disputed Areas During Election, SDP Witness Tells Tribunal

h e Social Democratic Party (SDP) on Thursday, presented one witness at the Kogi State Election Petitions Tribunal, who admitted that the SDP had agents across the polling units in the state.

The witness, Benjamin Ikani Okolo, from Dekina Local Government Area (Kogi East), tendered an inspection report and also adopted his deposition on oath before the threemember panel of justices, led by Justice Ado Birnin-Kudu. His confirmation that the SDP had agents across the polling units in the state, was of interest, considering the fact that only one polling agent, who said he couldn't produce an evidence of his role, had been presented by the SDP as witness in the ongoing hearing. The Respondents' counsel had, in earlier sittings, asked why the polling

agents were not

complaining, while random voters were being produced as witnesses.

When he was being crossexamined, Respondents' Counsel, Kanu Agabi SAN, said the witness, a former local government chairman of Dekina, should tell the Tribunal how many polling units were being challenged in the petition, but he said he did not know.

He was shown INEC manuals, regulation exhibits, BVAS screenshots and other Electoral documents as earlier tendered by the petitioners, and he identified them, but admitted that he didn't "make" any of them. He noted that he only saw the result sheets and other documents he identified in court during inspection, adding that he did not also make any input to the BVAS devices.

where the results were being challenged.

According to him, there was no signature of INEC staff on the inspection report that he tendered. The Respondents' counsel pointed out one of the scores of the APC as indicated in the witness statement on oath, which was different from the one in the inspection report, in a d d i t i on t o other discrepancies found in the BVAS to the Tribunal, and that the figures in the BVAS contradict what is in your deposition?"

He responded that he could not confirm that the figures in the BVAS were contradictory to what was in the deposition on oath because he didn't see the figures in the BVAS.

It was also observed that the accreditation figures quoted in his witness deposition were at variance with what was contained in the BVAS as presented in earlier sittings. The sitting was adjourned to April 5 2024 for continuation of hearing. While Pius Akubo SAN represented the petitioners, Kanu Agabi SAN appeared for INEC. A.M. Aliu SAN represented Gov. Indian Bound Drug Trafficker Excretes 80 Wraps Of Illicit Drugs At Lagos Airport *NDLEA uncovers other concealed in bag's false bottom

By; RAYMOND TEDUNJAYE, Lagos n Indian bound passenger, arrested at the Murtala Mohammed Airport, Ikeja Lagos, has reportedly excreted 80 wraps of a substance suspected to be cocaine, New Nigerian Newspaper has learnt.

Identified as Freeman Charles Ogbonna, the Delhi, Indian bound drug trafficker was said to have been apprehended by operatives of the National Drug Law Enforcement Agency (NDLEA) at the screening point of terminal 2 of the Murtala Muhammed International Airport, MMIA Ikeja Lagos.

Similarly, NDLEA officers at the Lagos Airport also intercepted a drug mule identified as Imran Taofeek Olalekan at Gate C departure of terminal 1 travelling to Oman with a check-in luggage and a backpack with a false bottom where hard drugs were concealed.

The Director Media and Advocacy of the Agency Femi Babafemi made the disclosure in a release made available to journalists yesterday.

According to Babafemi, Ogbonna was arrested on Sunday March 31, while attempting to board a flight to Delhi, India via Doha on Qatar Airways, with a Liberian international passport, bearing the name: Carr Bismark.

He was taken for body scan, which tested positive for ingestion of illicit drugs.

Babafemi said, "preliminary checks revealed his real identity as Freeman Charles Ogbonna and was subsequently placed under observation in NDLEA custody where he started to manifest signs of discomfort.

"Obviously choked by the volume of illicit drugs in his stomach and another substance taken to hold back excretion, the suspect soon began to retch before starting to vomit and excrete wraps of cocaine he ingested almost simultaneously.

"The suspect who claimed he was recruited into drug trafficking by one of his relatives eventually passed out a total of 80 wraps of cocaine weighing 889 grams through his mouth and anus over a period of four days.

The great risk that almost took his life notwithstanding, Ogbonna said he was given the drugs to swallow at a hotel in Ipodo area of Ikeja with a promise to reward him with №300,000 cash if he successfully delivers the consignment in India".

" In the same vein, NDLEA officers at the Lagos airport on Wednesday 3rd April intercepted a drug mule, Imran Taofeek Olalekan at Gate C departure of terminal 1 travelling to Oman with a check-in luggage and a backpack.

"When his check-in bag and backpack were subjected to thorough search, the operatives discovered a false bottom concealment of drugs in the check-in luggage and in the walls of the backpack.

"The NDLEA officers swiftly moved in on a man who accompanied the suspect to the airport. He was later identified as Ishola Isiaka Olalekan who recruited the trafficker.

"Imran Taofeek Olalekan said he returned from Dubai some years ago but still has a valid residence permit on his old passport. He claimed he was promised ₩1,500,000 if he successfully delivers the consignment in Oman, while his recruiter, Ishola was to be paid ₩200,000.

"Curiously, when the two bags were completely unpacked at the NDLEA office, a charm was found in one of the bags while another one was found on the drug mule who confessed that he traveled to Ibadan, Oyo state to meet with an 'Alfa' that prepared the charm for him to ensure he was not caught during the trip.

"Another charm was also found on the intermediary, Ishola Isiaka Olalekan who accompanied Taofeek to the departure

area of the airport. Ishola claimed he procured the charms for the sum of ₩70,000."

The NDLEA spokesperson, who also revealed other breakthroughs of the agency hinted that " At the Tincan seaport in Lagos, NDLEA operatives also on Wednesday 3rd April, intercepted 2,144 parcels of Colorado, a synthetic strain of cannabis weighing of 1,072kg.

"The seizure was made during a joint examination with Customs Service and other stakeholders of a container marked GAOU 6699215 coming from Montreal, but originated from Toronto, Canada.

"The drugs packed in 46 jumbo bags were found concealed in used 2009 Lexus RX 350, 2011 Toyota Sienna, and 2009 Lexus ES 350 as well as used engines, automobile doors, tyres, and used household goods as well as big drums loaded into the container.

"In Kano, a 48-year-old suspect, Gidado Sani who jumped the bail granted him by a Federal High Court in Kano on drug offence charges, was on Friday 5th April re-arrested in Sharada area of the state with 85 blocks of cannabis weighing 50.1kg, while NDLEA operatives in Ogun state on Thursday 4th April, arrested another suspect Wasiu Jimoh, during a raid operation at Ilese Awo, with 84 parcels (62kg) of cannabis sativa.

"Operatives in Lagos on Wednesday 3rd April intercepted a suspect, Emeka Umeh with 506.2kg cannabis at Igbede, Ojo area of the state, while another suspect, Victor Okeke was nabbed on Friday 5th April at Igbo Elerin, Ojo, with 142grams of cannabis sativa and 175 litres of skuchies recovered from him. Attempt by 35-yearold Ifeanyi Udogwu to smuggle 1.5kg cocaine concealed in music speakers from Lagos through Aba, Abia state to his uncle, Ifeanyi Udogwu based in Cameroon was thwarted on Wednesday 3rd April when NDLEA officers working



Enormity Of Killings In Kogi Community, Agojeju-Odo Unsettles Gov Ododo

Kogi State Governor, Ahmed Usman Ododo has expressed deep shock over the recent wanton killings by bandits in Agojeju-Odo Community in Omala Local Government Area of the state.

A statement issued on Saturday by Special Adviser to the Governor on Media, Ismaila Isah said that the governor was bemused by the ugly dimension that the communal clashes between people in the area have assumed startling dimension over time as he promised immediate intervention by his administration to forestall a reoccurrence of the unfortunate incident.

Governor Ododo assured that the perpetrators of the dastardly act will not go unpunished, adding that security agencies are on the trail of the assailants whose acts of mindless cowardice resulted

in the destruction of lives and property in the area.

Disturbed by the spate of wanton destruction of lives and property, the governor who has since sent a delegation led by his deputy, , Elder Joel Oyibo Salifu on a condolence visit to the area, further assured that kinetic and non-kinetic measures deployed by the state government have led to relative stability in Omala Local Government Area until the recent escalation of the conflict. Governor Ododo further said that the state will deploy a detachment of the recently established Metropolitan Quick Response to the area to reinforce

the existing security architecture in the Omala Local Government Area.

The governor commiserated relatives of those killed in the crisis and promised that the government would provide support for those injured and

others whose houses were razed by the marauding beasts.

It would be recalled that unknown gunmen believed to be bandits on Thursday, invaded Agojeju Odo in Omala Local Government Area of Kogi State and killed staggering number of people while many houses were set ablaze.

According to reports gathered, about 34 people were killed last Thursday, while another 15 bodies were recovered from the bush on Friday morning as the search for more bodies continues.

The armed men encircled the community and launched a violent assault, resulting in fatalities and the destruction of homes.

A community leader, who narrowly escaped the attack, said that the sudden onslaught caught the residents off guard.

News of a potential invasion had

been circulating for the past three weeks, and the newly appointed Local Government Council Caretaker Chairman, Mark Edibo, had been notified, despite assurances of safety and security. According to a source, the violence stemmed from a disagreement between a young man in Agojeju-Odo and a herder whose cattle damaged the farmer's farm. Despite intervention by the caretaker chairman, tensions escalated.

Meanwhile, the Kogi State Police Public Relations Officer, SP Williams Aya, confirmed the incident, stating that the Commissioner of Police had deployed a tactical squad comprising Mobile Police, Soldiers, and Vigilante men to restore order in response to a distress call.

SP Aya could not provide an exact casualty figure, but assured that he would gather information

from the Divisional Police Officer in charge of Omala Local Government Council and provide an update.

"As for the figure of dead persons, I can't confirm now. I will call you after I have spoken with the DPO in charge of Omala, but I know that so many people sustained gunshot injuries," he said.

He stated that the Commissioner of Police Kogi State Police Command, CP Bethrand Onuoha had deployed more policemen to the communities, assuring that the perpetrators of the heinous act would be apprehended.

The community appealed to Kogi State Governor, Usman Ododo and security agencies to come to their aid by deploying more personnel to the area, as the police in the local government council have been overwhelmed by the attackers.

el-Rufai And The Short Trek To Posterity

The chickens, the saying goes, always come home to roost. But some people would prefer to be Shakespearean by quoting the insightful words uttered by Marc Antony in William Shakespeare's play, Julius Caesar, "the evil that men do lives after them while the good is oft interred with their bones."

The first is a long-established English idiom that was used as early as 1390 AD in Chaucer's The Parson's Tale. It means that wicked deeds or words return to trouble their originator.

In the second, spoken at Julius Caesar's funeral, Mark Antony, referring to Brutus, Caesar's murderer, was saying that when someone dies, the bad things they did continue to afflict the living, but the good things they did often do not, and therefore are buried along with the corpse.

The first one tells us that the law of karma is for the living and that like Frankenstein's monster, every wrong and everything not done with good intention, especially against people, always turns around to torment the doer. The second has now been overtaken by events, as we can see in today's world. The bad ones do not wait for the leader's death before they begin to haunt the person, as we shall soon see. Likewise, the good things they do, they leave them behind and we see them everywhere. Posterity is now, no longer tomorrow or left to be regurgitated by future generations.

About four years ago, my friends from Kaduna started being ecstatic whenever we met, beating their chests and clapping wildly, sometimes with even their feet, and telling me that El-Rufai was doing wonders constructing roads and fly-overs, tunnels and bridges, even telling me that he constructed one flyover with four roundabouts under it.

I always did my best to calm them down. I would ask, with which revenue are the constructions being executed: locally generated or from the federation account? They would say he collected a foreign loan of hundreds of millions of dollars. And being "smart", to get the loan, apart from local politics at the National Assembly, including ensuring that his lackey, now successor, was made chairman of a committee that could help facilitate the loan, he made someone from the loan givers an "honorary adviser" in his government. But this is for another day. Then I would ask them simple but pointed questions like which construction companies are doing the work? Who owned them openly and who owned them through "blind trust" as with Obasanjo and Transcorp? I will then ask by how much the roads, bridges

and fly-overs would increase the state's Internally Generated Revenue (IGR) and service the loans collected. To all these questions, their faces looked blank.

I believe that if a state must take a loan, then it should not go into servicing a lifestyle or financing projects that cannot repay the loan or improve IGR, except in the health sector.

I told them that the way things were going, a time would come when the state would not be able to pay salaries and render basic services to the people, by which time the loan taker would have since left the stage. Those who do not know would start accusing the new government of incompetence, whereas it was the past government that made the state "ungovernable".

Fine, the roads and all have increased the value of houses and plots around them, and so what? In what way does that affect the poor man and his struggle to survive? The temporary appointments offered by the constructions are gone because the companies, not indigenous, have returned to base, boosting their areas of domicile.

Utilised differently, those loans could have been used to resuscitate moribund industries - and God knows Kaduna has a lot of them, build more, especially agro-allied ones. That would have offered direct and indirect employment to thousands of people who have dependents and eased the food insecurity in the land. The employed would pay taxes as that would have boosted the state's IGR from which it can now embark on road constructions to open up rural and industrial areas and upgrade the infrastructure in the towns out of necessity.

Without taking anything from the above, part of the loans can also go into building world-class hospitals that could turn the state into a medical tourist centre. Intra-town transport service, which may include light rails, could have been done. With massive employment at every corner, the crime rate in the state would have reduced significantly and the insecurity, especially incessant kidnappings bedevilling the state, wouldn't be as it is now. And so there is nothing wrong with Governor Uba Sani coming out to tell the citizens their situation: the state cannot pay salaries because out of its №10 billion share of the monthly dole outs, sadly, №7.5 billion goes into the payment of the debt of \$587 million, №85 billion, and 115 contractual liabilities it inherited from the government of Mr el-Rufai.

Electricity Tariff Increase And The Big Lie

WWITHOUT warning, the Nigerian Electricity Regulatory Commission (NERC) raised the electricity tariff for most urban households by 300% on the basis of a big lie.

According to the Vice Chairman of NERC, Musliu Oseni, Band A electricity consumers regularly get 20+ hours supply of electricity a day and should pay much more than other consumers who get much less.

The DISCOS, for example, have refused to provide metres for most consumers so that they can be charged what they have not been supplied to consume. In the years since 2012, rated or installed capacity was supposed to have increased to 12,522 MW in 2015 but this is fiction. The average generation has been between 3,500 and 4,000 MW.

These privileged Nigerians do not spend much money on fuel for their generators so have all the extra money that accrues to them to pay their DISCO. The problem is that everybody in this country knows this is a lie and no sector of society regularly gets a minimum of 20 hours of electricity a day. You cannot build a new policy on lies and such a huge increase in the middle of the most severe cost of living crisis in Nigerian history cannot stand. The new tariff is also aimed at eliminating the annual electricity subsidies of NGN1.14 trillion we are told.

Mr Oseni said that the federal government had indicated a transition in policy direction towards introducing a more targeted subsidy regime aimed at mitigating the impact of changes in macroeconomic parameters "while largely protecting vulnerable customers and fostering investments targeted at providing efficient service delivery in the Nigerian Electricity Supply Industry (NESI)." The problem is that the sudden increase is so vast that every consumer is in reality vulnerable and such increases need to be spread over time to reduce the impact on consumers.


I seriously doubt the argument that the review process is a necessary part in achieving the objective of the commission in the creation of a financially sustainable electricity market providing adequate and reliable power supply to drive the Nigerian economy. It is fiction. While the tariff applies currently to socalled Band A category which is about 15 per cent of the customer population, NERC has also announced a plan to extend it to other bands as soon as they reach the fake level of 20+ hours supply a day. Since the level is determined by DISCOS rather than reality, I expect a rapid extension based on fake declarations which is a tradition that Nigerians know and understand too well. The original sin was the mode of privatisation of the Nigerian electricity sector. It was a much-anticipated reform

exercise that created much hope for Nigerians. Launched in 2010, the exercise was intended to modernise the sector and cater to the country's growing demand for electricity. However, over a decade later, the desired outcomes have not materialised and the electricity available on the national grid to light homes and power the economy has stayed at an almost constant 4,500 megawatts (MW), well below the 8,400 MW projected for 2018. One reason for this is the technical inefficiency of the grid, beginning with inefficient gas supplies, the inability of the transmission system to deploy adequate electricity, and the lack of investment by production and distribution companies.

Such inefficiencies in the sector are compounded by 'legacy' corruption that has led to poor maintenance of the transmission network during stateownership and to the presence of politically connected bidders in the privatisation process.

It is clear that Nigeria's power sector is unsustainable, which has repercussions for inclusive growth. The current crisis is a liquidity crisis as a result of deep structural distortions in the sector. The design of contracts post-privatisation has led to adverse selection with only politically connected bidders participating in the process rather than technically competent ones.

The design of contracts and lack of regulatory oversight has further deterred credible and technically competent investors during the bidding process. The politically connected nature of many of the acquisitions also mean the government is reluctant to take any tough decisions with regard to the sector. The conditions in which consumers lack supply and firms are unable to make profits have given rise to a host of interdependent corruption mechanisms. As the sector moves deeper into loss, the space for formal earnings becomes narrower, and the perverse incentives to be corrupt deepens. This has now pushed the sector into a state of low-level equilibrium, with significant restructuring needed in order to turn things around. The DISCOS, for example, have refused to provide metres for most consumers so that they can be charged what they have not been supplied to consume. In the years since 2012, rated or installed capacity was supposed to have increased to 12,522 MW in 2015 but this is fiction. The average generation has been between 3,500 and 4,000 MW. As a recent ACE-SOAS study of the Nigerian power sector reveal, the reality is that we Nigerian consumers spend more to purchase and maintain petrol and diesel generators than on electricity from the grid. The reform has been a total failure and for that reason, Nigerians are reluctant to pay more for a supply that is erratic and fails repeatedly.

These bidders used Nigerian banks for financing, which have ended up assuming much of the systemic risk. The financial health of the sector was based on tariffs and projections that could never be politically implemented.

'In a joint press conference organised by the 11 companies, the Chief Executive Officer of the Jos DisCo, Tukur Modibbo, announced that they were ready to give up their licence if the federal government could refund the money invested in the utility. He said: "We bought Jos DisCo for \$82 million. We are ready to give it away Nigerian power stations were operating at full capacity, the transmission network would not be able to 'wheel' or transmit no more than 6,000 MW due to ailing infrastructure. For the past decade, the actual wheeling capacity is no more than 3,000 to 4,000 MW.

The Nigeria Bulk Electricity Trader (NBET) was meant to be a governmentowned Special Purpose Vehicle (SPV) that pooled the electricity generated and acted as an institutional backstop. This agency was meant to inject confidence in the sector but has been facing liquidity challenges. Distribution companies are unable to provide enough power to meet demand.

The DisCos have openly admitted that their companies are not viable. The Punch newspaper reported some years ago: 'In a joint press conference organised by the 11 companies, the Chief Executive Officer of the Jos DisCo, Tukur Modibbo, announced that they were ready to give up their licence if the federal government could refund the money invested in the utility. He said: "We bought Jos DisCo for \$82 million. We are ready to give it away for \$72 million if we see buyers now. If government refunds the investors their money, we will guit the business." Projections for the performance of the sector were based on distribution and generation companies (which are not publicly listed) reinvesting in the sector to build technical capacity. Instead, the companies started paying themselves. Dramatic increase in tariff leads to more corruption rather than improvement in power supply. The companies have no intention of investing to improve supply. The entire reform has to be reviewed because the dual goals of increasing efficiency and investment have failed dramatically.

In addition, the transmission sector wasn't privatised in 2012 and government has not invested to improve it. As a result, even if

Afenifere Rejects Over 200% New Electricity Tariff Increase *Says it will frustrate businesses, ask Tinubu to compel Ministry of Power to reverse I hike

he Pan-Yoruba socio-cultural and announcement. political organization, Afenifere at Emphasizing that, L the weekend rejected the over 200 per cent electricity tariff increase in the country as announced by the Nigerian Electricity Regulatory Commission (NERC) on Wednesday, April 4, 2024. Afenifere in a statement signed by its National Publicity Secretary Comrade Jare Ajayi on Saturday, said the electricity tariff increase will thwart the President Tinubu led administration's effort at boosting the economy as businesses will shrink. In the statement, Afenifere maintained that businesses cannot flourish when the amount to be paid per kilowatt hour (kWh) of electricity jumped from N68 to

N225 just within 24 hours of its Afenifere added, "A rough calculation of gas was used as the reason for the hike indicated that a person on Band A who was paying an average of N50,000 per month (on N68 per kWh) would now have to pay N170,000 for the same service. " It is noteworthy that the Ministry and its agency, the NERC, are interested in the revenue that would be generated rather than first ensuring regular and efficient supply. This is in contradition to the claim that the government agencies care about the pains of Nigerians". Afenifere stressed further, "It is clear that rather than exploring ways to reduce the cost of producing energy thus reducing the pains of Nigerians, the relevant government agencies are passing the price of their own inefficiency on the people", saying, "For instance, increase in the cost

in electricity tariff.

"Yet, it is clear that even the present cost of producing gas, and by implication electricity, can be made more efficient. In other words, both the price of gas as well as electricity would be far lower than what they are presently if the agencies concerned had gone into research and/or take advantage of available information on cost-efficient production of energies'. Afenifere then asked President Bola Tinubu to compel the Ministry of Power, to reverse the present hike, go into alternative energy sources like solar and wind, review the terms with which the 2013 exercise was carried out and be more innovative.
