Ensure Safe, Immediate Release Of Kidnapped Channels TV Reporter, NUJ urges Rivers Govt, **Security Agencies**

he Nigeria Union of Journalists (NUJ) on Friday, demanded immediate release of the Channels TV reporter Joshua Rogers who was abducted from his residence in Rumuosi, Port-Harcourt, Rivers State, on Thursday night.

NUJ in a statement by its National President, Dr Chris Isiguzo, urged the Rivers State Government and security agencies to prioritize efforts towards securing the safe and immediate release of the kidnapped reporter.

According to NUJ in the statement, "Rogers was taken by unknown gunmen around 9 p.m. as he returned from an official assignment at the government house", adding, "The assailants intercepted him and forcefully took him away in a Channels Television-branded vehicle". " It is distressing that individuals involved in the vital work of informing the public have become targets of criminal activities. The NUJ appeals to the Rivers State

Government and relevant security agencies to prioritize efforts towards securing the safe and immediate release of Joshua Rogers", it said.

NUJ added, "We emphasize the importance of ensuring his well-being and safety during this critical time. The NUJ underscores the gravity of the situation and stresses the need for concerted action to address the rising threats against journalists across Nigeria".

" We urge swift and effective measures to be taken to secure Joshua Rogers' freedom and bring an end to this distressing ordeal.

The NUJ stands in solidarity with Joshua Rogers and his family, and we demand immediate action to secure his safe return.

The union stressed, " Following the abduction, the kidnappers contacted his wife, demanding a ransom of N30 million for his release", saying, " The NUJ is deeply concerned about the escalating insecurity faced by journalists and media practitioners in the country".

NDLEA Apprehends Pregnant Woman, Widow, 12 Others **Over N3.2 Counterfeit Cash, Large Quantities Of Illicit Drugs**

t least a pregnant woman, a widow and 12 others have been nabbed by operatives of the National Drug Law Enforcement Agency (NDLEA) in connection with N3.2 million fake cash and large quantities of illicit drugs in Kano, Kogi, Imo, Edo, Ondo and Ekiti states.

While the pregnant woman and two others were arrested in connection of the counterfeit cash at Jabi park, Abuja, the widow and others were apprehended over alleged possession of 900,000 opiod pills and 1,347.4kg of cannabis in Kogi, Kano, Imo, Edo, Ogun, Ondo and Ekiti States during raids.

The eight-month pregnant woman, identified as Favour Peter, 24, was said to have been arrested along side one Esther Adukwu, 27, and Ochigbo Michael, 39, at Jabi park in Abuja in a follow up operation on Tuesday 9th April following the seizure of the fake naira notes in Lokoja, Kogi State.

The Director Media and Advocacy of NDLEA Femi Babafemi who made the disclosure in a statement yesterday, said this happened just as

NDLEA officers in collaboration with men of the Nigerian Navy Ship Lugard base, Lokoja intercepted 37-year-old Aliyu Lawal along Lokoja-Abuja road on Monday 8th April and recovered 620 blocks of cannabis weighing 310kg from

He also disclosed that 10 sacks of the same psychoactive substance weighing 98kg were seized along Okene-Lokoja-Abuja express way by NDLEA operatives from one Jama Obodo, 44, in a commercial bus coming from Ilesha, Osun state enroute Taraba state on Wednesday 10th April.

On the widow, Babafemi identified her as one Mrs. Theodora Ita, 40, mother of two and was arrested on Monday 8th April at Bassey Edom, Calabar, by NDLEA operatives for producing and selling a lethal new psychoactive substance, NPS, locally called 'Combine', which is a mixture of different strains of cannabis and opioids soaked in raw gin.

As at the time of her arrest, according to the release, she was in possession of 18 litres of the dangerous substance in used paint drums were recovered from her.

It added that the woman her statement claimed she started the illicit drug production and distribution in October

The NDLEA spokesperson while speaking on the others suspects said, "Another suspect, Godwin Okon Samuel, 48, was apprehended at Essit Ebum area of Calabar with 39.4kg of cannabis sativa on Tuesday 9th April.

"While two suspects: Sani Mohammed, 43, and Christopher Eze, 64, were arrested in Sabon Gari area of Kano on Tuesday 9th April with 900,000 pills of opioid recovered from them, NDLEA operatives on patrol along Owerri-Onitsha road, Imo state on Friday 12th April intercepted a logistics truck with registration number JGB 403XB and recovered 230 blocks of cannabis sativa weighing 119kg hidden under household items after a thorough

"At least 252 kilograms of cannabis were seized during a raid at Ijesa Isu forest, Ekiti state on Saturday 13th April while four suspects: Adamu Umar, 39; Abdullahi A Gimba, 27; Julius Uduakhomu, 28; and Micheal Sunday, 24, were nabbed loading 40kg of same substance to the engine compartment of a

gas truck at Agho village, Owan East, Edo state.

T motorcycles used in conveying the consignment to where the gas truck heading to the North was parked, were also recovered.

"In Ogun state, a suspect, Ismaila Ogun was arrested on Friday 12th April with 79kg cannabis at Imeko, while 18year-old Friday Abah was nabbed with 410kg of the same substance when NDLEA operatives raided Obatedo camp, Itaogbolu forest, Akure North LGA, Ondo state."

20 Arrested Over Attempt By Suspected Yoruba Nation Agitators To Take Over Oyo Govt Secretariat

*Police recovers 3 Pump Action Guns, 291 live cartridges, other dangerous weapons

wenty persons suspected to be members of Yoruba Nation Agitators were on Saturday, arrested by the Police after a failed attempt to take over the Oyo State Government Secretariat at Agodi Ibadan.

It was learnt that trouble started when the Yoruba Nation Agitators invaded the state secretariat with charms and other dangerous weapons to allegedly declare a Yoruba Nation and reportedly hoisted Yoruba Nation flag at the secretariat.

Oyo State Police Command in a statement on the invasion by the Yoruba Nation Agitators, said hoodlums suspected to be members of the "Yoruba Nation Agitation Group" driven by a separatist agenda, in an attempt to forcefully takeover the Oyo State Government Secretariat, Agodi-Ibadan, stormed the secretariat at about 9.15am.

Public Relations Officer (PPRO) SP Adewale Osifeso for the state Commissioner of Police, CP Adebola Hamzat, it stressed that the Yoruba Nation agitators," who were on Military Camouflages came heavily armed in an unregistered Silver Coloured Nissan Urban Caravan Bus containing Cutlasses, Pump Action Rifles, Cartridges, assorted charms and an O'dua Nation Agitation Flag'.

According to Oyo Police command, "In all, (20) Twenty Suspects have been arrested in possession of; (3) Three Pump Action Guns, (291)Two Hundred and Ninety-One life Cartridges, (2) Two Expended Cartridges, (67) Sixty-Seven Cutlasses, (5) Five Bullet Proof Vest, (6) Six Pair of Boots, (10) Ten Megaphone (Public Address System),(3) Three Oodua Styles Beret Caps, (7) Seven Belts, (11) Eleven Oodua Nation

Army Camouflage Uniforms, (1) One Unregistered Nissan Urban Caravan Bus and (3) Three TVS Motor Motorcycles", it said.

The Police command stressed, "Thankfully, they were overpowered and completely suppressed by Officers and Men of the Command on concert with sister security agencies who acted in swift response to intelligence gathered in accordance with Standard Operating Procedure (SOP) to the situation'

There was also an Arise News programme on April 3rd, 2024, on the morning show, titled: Freed Chibok Girls Wed Captors in Borno. The Arise news program dwells on the BBC article but expands it with more insight.

"What the two media outlets were saying is that some of the freed/rescued Chibok secondary school girls, abducted on April 14, 2014, by Boko Haram, have chosen to remain with their de-radicalized, former insurgent husbands at an accommodation provided by the Borno State government under its de-radicalisation programme," it said.

According to CSWN, the BBC article added that seven of such girls are staying in the government-provided accommodation with their de-radicalised insurgent husbands, while other girls are engaged to former fighters they met at the de-radicalisation camp.

"One among them is Jinkai Yama, who was among the 276 girls abducted but recently freed. She is now staying

with a former insurgent who married her while she was in captivity.

"Her father thought his daughter was living with other freed Chibok captives in a special welfare programme, not knowing his daughter was continuing in the marriage initiated while in Boko haram captivity," it said.

The statement stressed that while trying to justify the marriage, the Borno State Commissioner for Women Affairs and Social Development, Hon Zuwaira Gambo, said, "The women were in no way coerced into staying with their spouses in the housing estate".

It said she added that, "the freed girls usually insist that without their husbands, they would not stay in Maiduguri."

The statement lamented the development, saying, "CSWN worryingly notes that this is a case of Stockholm Syndrome, which occurs mostly among victims of kidnapping, domestic abuse, or human trafficking. Experts describe it as the psychological condition of a victim who identifies with and empathises with their captors or abusers. It's a coping and defensive mechanism victims develop over time to stay alive, which they continue with even when freed.

"However, CSWN insists that criminals should never benefit from their criminal activities. These girls were forcefully taken from their school and married off while in captivity to the same people who masterminded their abduction.

"They are now freed, but staying together, in a government-supplied accommodation, as husband and wife based on the marriage conducted while they were in Sambisa forest.

"Their husbands, though de-radicalised now, were responsible for the trauma their parents went through and are further traumatised by the fact that the same people who stole their daughters are now being referred to as their husbands in a civilised setting. This means these former insurgents have been allowed to enjoy the fruit of their crime.

"Even though the excuse could be given that the girls are now adults to make their own decisions, but a traumatised child in an adult body can never make a rational decision. Their childhood was stolen from them, and adulthood imposed on them — without their approval. There is no justification for the Borno State government to allow a marriage conducted in the forest to remain valid.

"Like, one of the panellists queried in the Arise interview: were these girls subjected to trauma counselling when brought back? Did they go through physiological health treatment? Were they taken to qualified therapists who could expertly walk them back from the orientation/indoctrination they were subjected to while in captivity?

"The freed girls, after going through all the necessary trauma counselling, should first be allowed to go and live with their parents and then let the de-radicalised insurgent go to the parents to formally ask for their hands in marriage; that is after the girls have been subjected to trauma counselling with experts," it pointed out.

"The excuse by the Borno State Government looks like a tactical support for the forceful marriage these girls have gone through. That the traumatic condition their parents have been in is not put into consideration by the government is appalling. We urge the government to retrace its steps and make sure these freed girls get the necessary psychosocial support and be reunited with their families for holistic healing," said the Chief Executive Officer of CSWN, Reverend Yunusa Nmadu.

He further explained that the speed at which Nigerians got the Kuriga school children from Kaduna State back is a huge progress in handling insecurity compared to how



The group threatened to fight and secure Aladja Community land with all legal instruments available to them.

This is contrary to claims by the Governor Sheriff Oborevwori's led Delta State Government that the boundary dispute between the two communities has been resolved.

The group's coordinator,

Comrade Simon Sibitor and Comrade Ejovwo Tietie made the assertion during a chat with our correspondent in Warri.

The group expressed shock over saying, "it has only played into the hands of the Ijaw nation through the Aladja/Ogbe-Ijoh crisis."

It insisted that the land in dispute belongs to Aladja Community and the government should be ready to kill all Aladja citizens if it wants to acquire their land forcefully.

"The land in dispute belongs to Aladja and if the government wants to acquire the land by force, the government must be ready to kill everybody."

It would be recalled that the office of the Secretary to the State Government, Dr. Kingsley Emu had announced that the

boundary dispute between the Aladja and Ogbe-Ijoh Communities in Udu and Warri South-West local areas have been resolved.

the claims by the government In a reaction to the announcement purportedly made by the Secretary to the State Government, group said, "The Government by that pronouncement by Dr. Kingsley Emu is invariably giving to the Ogbe-Ijoh people and by extension the Ijaw nation what they could not forcefully take from Aladja through the barrels of the gun."

> The group explained that a meeting was convened by the Delta State Government headed by the Secretary to the State Government to discuss the way forward of peace between Aladja and Ogbe-Ijoh Communities.

> "But representatives of Aladja

Community were shocked to see that there was already a prepared resolution by Emu for the people of both communities to sign using the minority report of Ogbe-Ijoh in the Professor Abednego Ekoku Panel Report instead of the Majority report that was adopted by the then Government of Okowa."

According to the group, "from the foregoing, it will not be out of place if we say Kingsley Emu has been compromised and he is doing the biddings of his paymasters.

"We the people of Aladja say No to the acquisition of Aladja land by Government."

The group noted that, "Since the outbreak of the crisis, the Ijaws have been clamouring for the acquisition of the land in dispute but the position of Aladja people has always been that the

government must as a matter of neccesity, tell the whole world who owns the land."

The group said the administration of former Governor Emmanuel Ewetan Uduaghan did not accede to the demands of the Ijaws on that ground from acquiring the land from Aladja people by force neither did the government of former Governor Arthur Ifeanyi Okowa did same.

"These two governors passed, must have seen that the land does not belong to Ogbe-Ijoh hence, they did not accede to the demands of the Ijaws.

"But surprisingly, the government of Sheriff Oborevwori which has not deemed it fit to visit the area in dispute has acceded to that dangerous demands by the Ijaws to acquire the land by the Ijaws."

ABU Signs Agreement For Construction Of 1600-bed Space Student Hostels Under PPP

*TETFund to pay 25% of project cost, while APPNL to provide 75% of counterpart funding

hmadu Bello University (ABU), has signed an agreement with the Student Housing Company Limited for the development of 1600-bed space hostels in the institution under a Public Private Partnership (PPP) arrangement.

This was contained in a statement made available by the Public Affairs Directorate, Office of the Vice-Chancellor, Ahmadu Bello University, Zaria, dated Sunday, April 14, 2024.

It explained that the pact was jointly signed by the university and the development holding company at Ahmadu Bello University, Zaria on Monday, 8th April, 2024.

It followed a proposal for the "Development of Student Housing in Ahmadu Bello University" by Africa Plus Partners Nigeria Limited (APPNL), an infrastructure fund manager duly licensed and accredited by the Nigerian Securities and Exchange Commission (SEC).

On financing structure, the project cost is agreed to be funded by a collaborative effort of both TETFund and APPNL.

For example, TETFund shall provide counterpart funding of 25% of the project cost under a Special Intervention framework to Ahmadu Bello University, while APPNL shall provide 75% of the total cost.

The funds, under the agreement, shall be used by APPNL to undertake the construction of the project.

And, upon completion of the facility, APPNL shall appoint a facility management entity to manage the structure for a period of 21 years after which control shall revert to Ahmadu Bello University.



The parties involved in the agreement signed four legal documents in fulfillment of the project. They included Stakeholders' Agreement, Deed of Lease, ESCROW Agreement, and Concession Agreement.

The Vice-Chanellor, Ahmadu Bello University, Prof. Kabiru Bala; and the institution's Registrar, Malam Rabiu Samaila, signed on behalf of the University, while Head, Deal Origination and Investment, Dipo Lawore, signed for Africa Plus Partners Nigeria Limited.

The Deputy Vice-Chancellor, Academic, Prof. Raymond B. Bako; the Director, University Legal Services, Dr. Ishaq Abubakar; the Head, University Public Private Partnership Unit, Dr. Mu'awiya Abubakar; and the Head, Department of Building, Ahmadu Bello University, Dr. Mansir Dodo, attended the agreement signing ceremony.

Others present at the brief event included the Managing Director,

Ahmadu Bello University Consultancy Services (ABUCONS), Dr. Faruk Yaya; the Director, Public Affairs Directorate, Malam Auwalu Umar; and the Special Assistant to the Vice-Chancellor, Malam Auwal Yusuf Mohammed.

Speaking at the event, the Vice-Chancellor, Prof. Kabiru Bala, expressed delight over the development and assured that the project would greatly help stem the huge shortfall in the availability of good accommodation for students of the institution.

Earlier in his remarks on the scope of the project, the Head, Public Private Partnership Unit, Ahmadu Bello University, Dr. Mu'awiya Abubakar, explained that the project was facilitated by TETFund.

Dr. Abubakar also explained that ABU is one of the six public universities across the six geo-political zones of Nigeria that will benefit from the national student housing project.

Also speaking, the Head, Deal Origination and Investment, Africa Plus Partners Nigeria Limited, Dipo Lawore, pointed out that the development of the 1600-bed space student hostels for Ahmadu Bello University would be completed in 12 months time.

The Africa Plus Partners Nigeria Limited is a Securities and Exchange Commission (SEC) licensed specialist infrastructure asset management company with a mandate to invest an optional mix of debt and equity in strategic infrastructure projects within Nigeria and sub-Saharan Africa.







Northern Groups Blast NEF's Statement Regretting Voting Tinubu

The President of the group, Muhammad Ibrahim, in a statement issued on Saturday, said, "The Coalition of Concerned Northern Groups (CCNG) finds it pertinent to

He lamented, "It baffles us that the NEF was silent when the former President Muhammadu Buhari's regime killed hundreds of innocent men, women and children when it clamped down on Shi'ites members in Kaduna in 2015. Were they not northerners that were murdered in an extrajudicial manner?

"Was it not during the Buhari regime that the banditry became more prominent in the Northwest, a situation that has virtually killed the farming profession in the region and destroyed lives and property. Yet the NEF never rose against that."

Muhammad noted that the country is hardly two years into the regime that started on a very difficult footing with many things to be put aright after being detracted by the immediate past regime, lamenting it would be un-elderly of an elders' forum to demonize the regime instead of giving it the benefit of doubt.

"Reviewing the NEF claims that they mobilized the north in favour of President Tinubu, even as his major contender, Atiku Abubakar was a northerner, cannot be substantiated because they have no such influence over the electorate in the region," he explained.

ASUU ABU Calls For Ending Usurpation Of Powers Of University Council

events bordering on the
alleged usurpation of
powers of University
Governing Councils by the
Minister of Education with
the active collaboration of
Vice Chancellors.

Addressing a press conference at the union secretariat in Samaru, the branch chairman, Professor Haruna M Jibrin said this illegality undermines the sacred university autonomy, being a product of a persistent and noble struggle for a better nigerian university system.

He said the autonomy is deeply embedded in extant laws among which is section 2 AAA of the U n i v e r s i t i e s (M i s c e l l a n e o u s Provisions) (Amendment) Act, 2003.

"Specific ways adopted by Vice Chancellors to usurp the powers of university councils include, but are not limited to the creation of the office of a Deputy Vice Chancellor (third Deputy Vice Chancellor in the case of Ahmadu Bello University).

"Confronted with a recent incident here at the Ahmadu Bello University, the Academic Staff Union of Universities (ASUU) proactively engaged the University administration, demanding the immediate stoppage of the election of a third Deputy Vice Chancellor that had been scheduled to hold during the recently held 534" (Regular) meeting of the Senate".

According to him, ASUU ABU reports that, following a letter of protest from ASUU to the Vice Chancellor, the said creation of the office of a third Deputy Vice Chancellor in the absence of a Governing Council violates the laws governing the affairs of Ahmadu Bello University. The union also argued that at the Universities (Miscellaneous Provisions) Act, 199, 3 and the Universities (Miscellaneous Provisions) (Amendment) Act, 2003 confer the power to create the office

of a Deputy Vice Chancellor solely on the Council of a University.

According to the ASUU, Section 2AAA of the Universities (Miscellaneous Provisions) (Amendment) Act, 2003, provides that "the powers of the Council, shall be exercised, as in the Law and Statutes of each University and to that extent, establishment circulars that are inconsistent with the laws shall not apply to the universities.

"By this section, approvals from the Minister of Education, especially on matters that do not threaten the ordinary cause of business of the University, but which conflict with extant laws have no binding force.

"We, at the Ahmadu Bello University Branch of ASUU, hold strongly that the sad developments that are currently being witnessed in the universities are exacerbated by the failure of the government to immediately reconstitute councils as section 2A of the Universities (Miscellaneous

Provisions) (Amendment) Act, 2003 demands.

"Mindful of its far reaching positive impact, ASUU holds University autonomy in high regard and has, therefore, consistently clamoured for its actualization; something that can be entrenched only by allowing the various organs (including and especially Councils) of the University to carry out their exclusive statutory collegial functions".

The chairman noted that this clamour is reflected in the decades-long struggle embarked upon by the union; from the call for the empowerment of councils, to outright rejection of imposition of the Integrated Payroll and Personnel Information System (IPPIS),

Against this background, ASUU called on the government to immediately appoint external members of the council so that an indispensable University organ, the Council, is properly constituted to carry out its vital functions.

The union also enjoined vice chancellors to rather insist on the appointment of external members of councils.



Niger Delta Region And NDDC's Agricultural Initiatives

representation of the perverse and unintended consequences of the discovery of oil in Nigeria are that governments have almost completely abandoned agriculture in the mad quest for petrol dollars.

The nation is a mono-economy, depending on the volatile fortunes of oil. Added to this governance failure is the further deterioration in agricultural fortunes caused by oil pollution. Thereby, oil pollution becomes an indirect violation of the right to life, even as it is a violation of the right to a safe and habitable environment.

In view of the above ecological challenge, many environmental analysts have in the past argued that It will be futile to hope that investment of inputs and skills into the sector will boost food supply in rural communities without first addressing adverse oil operation activities. Environmental regulations, they added, must be enforced in order to aid rural development.

To others, the first step is for the government to recognize that destruction of agricultural prospects in rural communities through irresponsible oil operations is an indirect violation of the right to life and the right to a safe environment, and also a negation of the policy of economic diversification.

In fact, greater chunk of concerned Niger Deltans were of the view that the federal and state governments should take practical steps to empower communities to protect their environment through policies and legislations that obligate oil companies to apply best practices and grant communities the right to determine how and when oil operations are compatible with human conditions in the communities. They concluded.

In the face of all these conflicting arguments and inordinate postulations, Niger Delta youths waited patiently for a leadership that will offer a sustainable road map for inventing the agricultural sector in the region, to create employment and guarantee food security for the people of the region and beyond.

The above understanding fully explains the perception by stakeholder, as a right step taken in the right direction, the recent decision by Barrister Chiedu Ebie leadership of Niger Delta Development Commission (NDDC), to move beyond rhetoric via its project HOPE' initiative, and create youth employment opportunities, especially in agriculture through support to small-holder farmers in order to ensure operational growth while shifting from traditional to mechanized farming methods.

"The Niger Delta region because of the arable wetlands, rainfalls and other favourable ecological factors is in a better position to plant various crops and vegetables at least four times within a farming season. We are trying to move away from the oil economy and the sector which can accommodate our youths in large numbers is the agricultural sector."

Essentially in my view, aside from confirming as true the age long believe that every leadership of an institution develops a culture of their own and the success or failure of such an institution is closely tied to that culture, there are glaring reasons that characterizes the present move Barrister Chiedu Ebie led board and management, to support job creation for the youth through agricultural initiatives in the region, as not only welcoming but loaded with leadership lessons for other public office holders in the country to internalize.

For a better understanding of where this piece is headed, youth in every society, says a study report, has the potential to stimulate economic growth, social progress and our national development. The strategic role of youths in the development of different societies of the world such as Cuba, Libya, China, Russia and Israel are obvious. Youth unemployment is potentially dangerous as it sends a wrong signal to all segments of the Nigerian Society.

Here in Nigeria, the story is not different as rate of youth unemployment is equally high, even at the period of economic normalcy i.e. the oil boom of the 1970s (6.2%); 1980s (9.8%) and the 1990s (11.5%). Youth unemployment therefore is not a recent phenomenon.

But if what happened in the 1980s/90s were a challenge of sorts, what is happening presently, going by the latest report by the National Bureau of Statistics (NBS), is a challenge.

Beyond the above sorry account of protracted youth unemployment in the country, there are also, vivid imageries of how successive government's neglect of agricultural sector not only set the stage for the galloping unemployment situation but engineered poverty among Nigerians.

Take as an illustration, development professionals have in the past expressed concern that it is not right how state and federal governments of Nigeria created agencies that dole money to Nigerian youths with the aim of eradicating poverty, as such huge resources do not have economic value. They argued that considering the slow growing economy but scary unemployment levels in the country as at that time, such amount should have been invested in the agricultural sector or used to build industries and factories of production to assist in

ending the economic life cycle of unemployment in the country.

Closely related to the above is the reality that in the past, managers of our nation's economy in their attempt to disengage governance from public sector control of the economy only played into the waiting hands of the profiteers of goods and services to the detriment of the Nigerian people.

Others were of the view that less emphasis on university education should be done. Technical and Commercial colleges should be established and funded to produce graduates that are technically fit. The state they argued should engage in agriculture and owning business and manufacturing outfits like what was obtainable in the 1970s-1990s in Nigeria. Companies and factories wholly owned by state governments under a new management system should be built to absorb graduates and skilled workers. It is still possible to operate profitable businesses by the state government using the Indian/Lebanese system of business model.

To the rest, Cooperate organizations and entrepreneurs should engage in production of domestic and industrial goods. And a long term goal of exporting such goods to West/African markets should be brought into focus. Commercial farming into such specialized areas of dairy farming, essential fruits such as apple, etc. will help to reduce unemployment. And a long term goal of exporting such goods to West/African markets should be brought into focus.


For me, there are even more reasons that go beyond job creation, why the present NDDC agricultural initiative should be applauded.

Separate from the worrying awareness that by 2050, global consumption of food and energy is expected to double as the world's population and incomes grow, while climate change is expected to have an adverse effect on both crop yields and the number of arable acres, we are in dire need of solution to this problem because unemployment has diverse implications.

Security wise, large unemployed youth population is a threat to the security of the few that are employed. Any transformation that does not have job creation at its main objective will not take us anywhere. An agricultural sector has that capacity to absorb the teaming unemployed youth in the country.

The second reason is that globally, there are dramatic shift from agriculture in preference for white collar jobs-a trend that urgently needs to be reversed.

Reports indicate that over the past century in the United



State of America (USA), study has it that there exists a

shift in the locations and occupations of urban consumers. In 1900, about 40% of the total population was employed on the farm, and 60% lived in rural areas. Today, the respective figures are only about 1% and 20%. Over the past half century, the number of farms has fallen by a factor of three. As a result, the ratio of urban eaters to rural farmers has markedly risen, giving the food consumer a more prominent role in shaping the food and farming system. The changing dynamic has also played a role in public calls to reform federal policy to focus more on the consumer implications of the food supply chain.

In a similar vein, averting malnutrition which constitutes a serious setback to socio-economic development of any nation is another reason why Nigeria must embrace agriculture-a vehicle for food security and sustainable socio economic sector.

More specifically, it was noted recently that in Nigeria, governments over the years have come to realize that sustainable growth is achievable only under an environment in which the generality of the people are exposed to balanced diet, not just food. This explains why agriculture production should receive heightened attention. In Nigeria, an estimated 2.5 million children under-five suffer from severe acute malnutrition (sam) annually, exposing nearly 420,000 children within that age bracket to early death from common childhood illness such as diarrhoea, pneumonia and malaria.

To therefore, achieve this objective in agriculture in the region that will guarantee food security as well as bring about development that is sustainable, this piece holds the opinion that the Federal Government should assist NDDC provide the needed support-funding, technical know how and other specialized training and good road infrastructure to aid distribution of such food products and other economic products from advantaged to less advantaged areas. Evidence abounds that such towns/cities referred to as disadvantaged often always hold the domestic trade and market prices of such commodities.

Good means of transportation, as we know, will contribute to lower food prices through its impact on the operation of the market, increase the welfare of households and improve food security, increase trade, lead to lower prices and lower price dispersion, and offer farmers incentives to commercialize while leading to a reduction in price competition.

Power Minister Adelabu's Lies, Disrespect For Facts

hile Nigerian Muslims were busy with the Rsmadan fast and making last minute arrangements to celebrate this year's Eid el Fitr with pomp and pageantry in the midst of scorching hard times brought about by President Bola Ahmed Tinubu's withdrawal of fuel and energy siubsidies, Nigeria's Minister of Power, Adebayo Adelabu was quoted by the ministry's spokesman as saying, "that there was no progress on the Siemens project since the death of the late Abba Kyari. The lie is in the claim that the death of Abba Kyari stalled the implementation of the Siemens project".

For the records, Abba Kyari died on April 17, 2020 and work on the Siemens project continued up to May 2023.

He further shamelessly, added that the pilot or first phase of the project "only progressed significantly when the Tinubu administration emerged."

The Minister also claimed that the "10 mobile substations and the mega transformers only arrived in Nigeria now."

Indeed all well meaning Nigerians and those keenly watching developments in the power sector, know that the statement by the minister which was widely published in the media, is full of lies, distortions and outright disregard for glaring facts and figures at the disposal of the public.

This deliberate mixing and juggling of of facts with fiction for selfish reasons by Minister Adelabu is nothing short of a deliberate attempt to reap where his ministry did not sow.

The minister also claims that the Siemens project only continued after the visit of the German Chancellor to Nigeria in November 2023.

To say the least, the part of the minister's briefing about Siemens project is far from the truth and full of misleading narrations.

At this critical time in the history of Nigeria's power sector, what is expected from the minister, is to highlight the project's progress since 29th May last year towards improvement of the entire value chain of the power sector.

Instead of being innovative enough focusing on making things happen in



the power sector by building on the solid foundation laid by the previous administration, regrettably, the minister chose to indulge in desperate revisionism to score cheap political points and take credit for what was already done by the ex President Muhammadu Buhari's administration. The simple undeniable truth is that Siemens project was never stalled after the death of the late COS, Abba Kyari. The project moved on and made significant progress through timely funding and implementation of Nigeria's component of the agreement. Even though COVID-19 and the war in Ukraine affected the project's timelines, but former President Muhammadu Buhari kept

the project going.

One can vividly recall that in March 2022, then Minister of Power, Engineer Abubakar D. Aliyu, led a government delegation to Berlin and Frankfurt, Germany, where a meeting with the leadership of Siemens Energy fast-tracked the deliveries of the first phase of the project.

While delivering President Muhammadu Buhari' administration's scorecard in January 2023, former Minister of Power's presentation included videos and images of the mega transformers and mobile power sub-stations delivered to Nigeria.

Progress report showed that as at January 2023, six of the 10 Mega Power Transformers had already arrived on the shores of Nigeria and installation of the ones delivered was ongoing in various locations. However, the remaining four were onshore.

Indeed, as at that time, the first mega transformer was being installed in Ajah Lagos, while the second one being installed at Apo Abuja, was energized on May 15, 2023.

As official records released have shown that by 1st May 2023, the FGN Power Company had received delivery of 80 per cent of the equipment for the pilot projects, which were deployed to critical sites across the lengths and breadth of the country to improve power transmission capacity.

The progress recorded on the Siemens project could not have been possible without the commitment of President Muhammadu Buhari and the former minister of power's dedication to making sure that the project was successful.

The then Minister of Power, Aliyu secured the approval of the Federal Executive Council of €63m for the procurements under the Presidential Power Initiative, PPI.

One of the last official engagements of the PMB administration in the power sector was testing and commissioning of the 700 megawatts Zungeru Hydroelectric Power Station which is the biggest power

project delivered in recent times. Details of the testing of the project were widely in the news on May 15, 2023.

Since government is a continuous process, Nigerians expect nothing less than an improved power supply for the country by the Tinubu administration.

The recent withdrawal of subsidy in the energy sector and consequent increase of electricity tariff by as much as 300% should worry the Tinubu administration and take a closer look at their consequences on the economy and Nigerians.

never thought I could attend the Eid prayer held on 10th April, a day after I clocked the definitive age of 60: I have now joined the senior citizens' rank. Not being confident I could attend the Eid prayer seems an understatement; for actually, in February, the way I was feeling within me, it was looking to me that I would not witness Ramadan, not to talk of participating in the Eid marking its end.

I easily get exhausted from the littlest of tasks, making me always gasping for air to fill my lungs. It reached a stage where I could not walk ten metres without bending down, holding my knees and inhaling from both my mouth and nose.

It all came to a head when the news of the death of my mother reached me in the early hours of January, 8. I could not walk at the Nnamdi Azikiwe International Airport, Abuja which made the flight authorities move me in a wheelchair to the base of the plane, where I climbed the stairs with great effort, stopping at the plane's entrance to gather myself.

The same routine was enacted when our plane landed at the Malam (don't know why they spelt it MALLAM with a double l) Aminu Kano International Airport, where I had to be wheeled to the vehicle that conveyed me to Potiskum. To ease my difficulty, I had to be injected intravenously with bronchodilators on the three-hour journey.

Throughout the week I was at Potiskum for her seven-day prayers, I was ensconced in my room and couldn't be at the family house where the main gathering took place. And I became dependent on my wives for many things a healthy person would do for himself.

And it is not as if I had not sought medical attention. God knows I had always advocated for our leaders to attend hospitals at home. I did the same. Some seven years ago I went to the Asokoro General Hospital where an x-ray was done for me. They said there was nothing wrong, but I knew something was wrong with me. Even then, I started feeling exhausted because I could not do what I

normally did easily. And it had nothing to do with ageing.

I did some tests in some private laboratories, and the results were normal. Then I went to NISA Hospital in Abuja where I was looked after by a pulmonologist, Dr James Agada. It is not a run-of-the-mill hospital and not cheap, moreover, I paid for VIP treatment. Yet, my case kept deteriorating till I became almost an invalid.

Then I had an opportunity to visit my governor, Honourable Mai Mala Buni, over an issue that needed some clarifications and he saw

my condition. He became alarmed and sought to know what happened. I explained what I could to him, including my voyage to hospitals here that were quick to give me a clean bill of health that I knew was not true.

He undertook the process to reverse the ailment and give me back some lost health. He got in touch with an agent, Shettima Alkali, a kind-hearted professional, who got me a visa to Saudi Arabia. Buni, a man of faith, said: "To be there, drinking the holy Zamzam water and praying at the Ka'aba itself would do you wonders."

And so began my journey in search of health.


I left Nigeria on 12th February from the Malam Aminu Kano International Airport via Peace Air. I will talk about Air Peace and its wonderful, friendly crew another day.

As had become the norm, I was wheeled into the plane from Abuja to Kano to board the Saudi flight and at the Kano airport too I was wheeled into the plane. It was the same procedure at Jeddah Airport until I reached the apartment where I was to stay. Once there I found it easier and more convenient since I had my son, Abubakar Sadik, a big, strong fella to do the wheeling.

In Saudi Arabia, one goes through the healthcare system from the Primary Health Care Centres except if one wants to go straight to a private hospital. To conserve funds and also see how their system works, I started from the former despite my almost desperate condition.

However, if you are an Umrite (my coinage for one undergoing the Umrah), you have an inalienable right to be accepted and diagnosed in government hospitals free of charge, even though there are fee-paying options.

Relying on that right, I started by going to the Jeddah East General Hospital where various tests were carried out on me: blood tests, electrocardiogram (ECG), xrays, computerised tomography (CT) scans, etc., and the results were good. With all health issues eliminated, everything pointed to problems to do with

pulmonology.

Still, I went to a Primary Health Centre this time around. Their primary health centres are as equipped as our general hospitals, if not better. Being the entry point to the health system, every General Hospital has a PHC that refers patients to it. And so this one referred me to King Abdul Aziz General Hospital, Jeddah, where the same tests conducted at Jeddah East were repeated with the same

conclusion.

With the certainty of what my ailment was, I left Jeddah for Madinah, arriving at Makkah the next day. I searched online for a good pulmonologist and each search result had one Egyptian, Dr Hebatullah Kamal Taha of Saudi-German Hospital, Makkah, coming up tops. She also comes a bit more expensive than the others. I then booked and paid for an appointment with

her for the next day.

At exactly 10 am the next day, accompanied by my wife, Dr Aminat Zakari, and son wheeling me, I was ushered into Dr Heba's office. A petite, friendly, middle-aged woman. After analysing the results from the two General Hospitals we went to in Jeddah, she made us do a test to ascertain the level of oxygen in my blood and then prescribed some drugs, telling us to return after five days.



Elders Forum: Northern Group Passes Vote Of Confidence On Tinubu's Administration
