Set Aside Arrest Warrant Against Me, Yahaya Bello Urges Abuja Court

he embattled former Governor of _ Kogi, Alhaji Yahaya Bello yesterday prayed a Federal High Court, Abuja to vacate the arrest warrant order issued to the Economic and Financial Crimes Commission (EFCC) against him on April 17. Bello, through his lawyer, Adeola Adedipe, SAN, made the application following an order by Justice Emeka Nwite, directing the EFCC to effect the service of the charge and proof of

evidence on the exgovernor's lead counsel. Abdulwahab Mohammed, SAN

Justice Nwite had, earlier, ordered the EFCC's lawyer, Kemi Pinheiro, SAN, to serve Mohammed, the leading counsel of Bello, with bundles of the charge and the proof of evidence in a ruling yesterday.

Relying on provisions of Section 382v(4) and (5) of the Administration of Criminal Justice Act (ACJA), the Judge held that Mohammed, who announced an unconditional appearance

PDP Will Retain All Positions In Oyo April 27 LG Polls, Gov Makinde Boasts

yo State Governor, Engr Seyi Makinde yesterday said the Peoples Democratic Party (PDP) will retain all positions in the April 27, 2024 Local Government Elections in the state.

According to the governor while presenting flags to the PDP chairmanship candidates in Isevin Federal Constituency at Ode Oba, Iseyin, his confidence is based on the unprecedented achievements of his administration across the state.

Engr Makinde emphasized the need for the people of Oyo State to vote en masse for all PDP candidates, saying the government at the grassroots will toe the line of his government in delivering sustainable development.

"I congratulate the Chairmen and the Vice Chairmen in advance. I believe our people will vote massively for them. Those who said we are planning to write results, can you see them campaigning?", he said Engr Makinde added, " They are not. Gov Makinde stressed, " For eight years, the only road the last administration did in the whole Oke-Ogun zone is just the road within Iseyin

IPU Nominates Senator Akpabio, 15 Others To Prepare Grounds For World Conference Of Speakers Of Parliament

By; BAYO AKAMO, Ibadan The Inter-Parliamentary Union (IPU) has named President of the Nigerian Senate, Senator Godswill Akpabio as a member of the Preparatory Committee for the Sixth World Conference of Speakers of Parliament 2025.

A statement made available to journalists by the Special Assistant on Media to the Senate President, Jackson Udom stated that Akpabio's nomination was contained in a letter signed by the General Secretary of the Inter-Parliamentary Union (IPU), Martin Chungong and addressed to the Senate President.

According to the statement, the nomination letter reads: "I wish to congratulate you upon your nomination as a member of the Preparatory Committee for the Sixth World Conference of Speakers of Parliament (2025) and to invite you to a first meeting of the Preparatory Committee at IPU Headquarters in Geneva on 16-17 May 2024'.

"As you are aware, every five years since 2000, the Inter-Parliamentary Union has convened a World

Conference of Speakers of P a r l i a m e n t. T h e Conferences are organized in close cooperation with the United Nations and aim t o r e i n f o r c e t h e parliamentary dimension in the work of the UN and to bridge the democracy gap in international relations", it said.

The statement added, " At the recently concluded 148th IPU Assembly, further to consultations with Member Parliaments and the Geopolitical Groups, the composition of the Preparatory Committee spearheaded by a Preparatory Committee composed of some 20 Speakers of Parliament, a select number of representatives of the IPU Executive Committee, and the senior representative of the UN Secretary-General". It maintained that," the Preparatory Committee usually meets four times during the 18-month preparatory period, with the fourth and final meeting taking place on the eve of the Conference." Food Security: ABU VC Excited As IAR Introduces Over 10 Crop Varieties To Farmers

By; SANIALIYU, Zaria he Vice Chancellor, Ahmadu Bello University (ABU) Zaria, Professor Kabiru Bala said that over 10 crop varieties have been introduced to farming communities in Nigeria including 3 Bt maize which are resistant to the dreaded fall army worm and stemborers by the Institute of Agriculture Research (IAR).

He stated this at the opening ceremony of the Annual Research Review and Planning Meeting and RECILS at Institute for Agricultural Research (IAR).

Professor Kabiru Bala said it is the university's ardent believe that these technologies are developed to ease hunger and starvation, thus ensuring food security in the midst of of the challenges of insecurity in Nigeria.

Represented by the Provost College of Medical Sciences, Professor Mohammed Sani Shehu, he said, IAR has become a household name among farming communities in terms of technology generation and dissemination.

The Vice Chancellor said it is collective resolve to ensure availability of food in a sustainable manner to enhance academic and social well being of all and sandry within the purview of the ABU through the Agricultural Veterinary complex research efforts. In his address, the Executive Director Institute for Agricultural Research Professor Ado Yusuf said the Challenge of global warming resulting in droughts and floods ravaging nation's behoves on us to develop climate resilient crops and technologies in save farmers from huge economic looses.

He said in the last decade the institute have imbibe the use of cutting-edge technologies using the tools of biotechnology to develop and release climate smart crop varieties for the benefit of the farmers.

Professor Ado added that IAR will not relent on their ongoing efforts on the development of crop varieties that exhibit tolerance or resistance to both biotic and abiotic stresses, including drought, extreme heat, floods, pest and diseases in order to address the challenges of climate change.

According to him, IAR Crop varieties will be c o m p l e m e n t e d b y production technologies focusing on improved soil m a n a g e m e n t a n d agronomic practices that will assist in attaining their maximum potential as well as various simple tools designed to minimize labour in both crop production and post harvest activities.

for the defendant to receive the charge. However, shortly after the ruling, Adedipe argued that the arrest warrant order, having been made before the charge ought to be set aside suo motu (on its own accord, without any request by the parties involved).

The senior lawyer argued

that contrary to Pinheiro's submission that the exgovernor must be in court first before any application could be entertained being a criminal case, he said the anti-graft agency also made an application on April 18 after the warrant arrest was issued to EFCC on April 17 and that the court granted it.

According to him, the complainant made an application for substituted service on 18th day of April after the arrest warrant had been issued on 17th day of April and today, my noble lord granted it.

"The court must satisfy itself that the defendant (Bello) will not be prejudiced in fairness if the warrant of arrest continues to hang on his neck, having been made before service of the charge contrary to Section 394 of ACJA," Adeola argued.

Timi Frank Commends EFCC For Pursuing Arrest Of Yahaya Bello *Calls for expanded anti-corruption efforts

ormer Deputy National Publicity Secretary of the All Progressives Congress (APC), Comrade Timi Frank, has praised the Economic and Financial Crimes Commission (EFCC) for its efforts to apprehend and prosecute former Kogi State Governor Yahaya Bello.

In a statement made available to newsmen yesterday in Abuja, Frank urged the commission to broaden its investigation to include other allegedly corrupt individuals, particularly former governors, ministers, and public officials associated with both the past administration of ex-President Muhammadu Buhari and the current administration of President Bola Tinubu.

Frank stressed the importance of extending the probe to avoid giving the impression that the EFCC's actions against Bello were merely a witch hunt.

While commending the EFCC's steps to hold Bello accountable, Frank highlighted the need for equal scrutiny of other individuals accused of corruption.

"We commend the EFCC for its efforts in pursuing Yahaya Bello's prosecution. However, we urge the agency to also investigate other former governors, including Minister of the Federal Capital Territory (FCT) Nyesom Wike, whose alleged corrupt practices have been reported to the EFCC," said Frank.

According to him, EFCC's efforts to apprehend Bello and bring him to trial would appear to be a deliberate and malicious witch hunt simply because he contested the Presidential primary election of the All Progressives Congress (APC) against President Bola Tinubu.

"Furthermore, we have yet to witness the arrest of several allegedly corrupt public officials who served under ex-President Muhammadu Buhari, despite petitions against them before the EFCC. These

individuals include former Attorney-General of the Federation and Minister of Justice, Abubakar Malami; former Governor of Benue State, Samuel Ortom; former Governor of Abia State, Okezie Ikpeazu; former Minister of Aviation, Hadi Sirika, among others.

"Additionally, there are those like former personal assistant to President Buhari, Tunde Sabiu; former Director General of the Nigerian Maritime Administration and Safety Agency (NIMASA), Bashir Jamoh; immediate past Chairman of the Federal Inland Revenue Service (FIRS), Muhammad Nami; the Group Chief Executive Officer (GCEO) of the Nigerian National Petroleum Company Limited (NNPCL), Dr. Mele Kyari; and Senate President Godswill Akpabio, who remain unprosecuted.

"Similarly, former Minister of Finance, Budget and Economic Planning, Zainab Ahmed; former Director General of the Nigerian Ports Authority and current aide to President Tinubu, Hadiza Bala Usman; former Governor of Ebonyi State and present Minister of Works, Dave Umahi; and former security chiefs who are the subject of petitions before the EFCC continue to evade prosecution."

Frank, representing the United Liberation Movement for West Papua (ULMWP) in East Africa and the Middle East, emphasized that by bringing these individuals to court to face trial, the EFCC would demonstrate to Nigerians that their actions against Bello are not politically motivated.

He said: "Someone like Wike has a petition against him before the EFCC, but they have never invited him to defend allegations against him. Is it because some of these people supported and campaigned for Tinubu to emerge President in 2023 that makes them untouchable?'

He acknowledged that the EFCC's action

against Bello is a positive step in the fight against corruption. However, Frank emphasized the need

for the EFCC to show the same level of commitment in addressing allegations against other corrupt individuals.

He added: "For instance, we have seen the recent revelation of the Governor of Abia State, Alex Oti, against the former governor of the State, Okezie Ikpeazu, concerning humongous money paid for the

construction of a non-existent airport and other bogus projects by the immediate past administration in Abia state.

The political activist, who hails from Bayelsa, asserted that the failure to prosecute former governors and ministers accused of corruption would undermine the credibility of the anti-corruption efforts. He criticized the EFCC for appearing selective in its prosecutions, targeting only those who may not be in favour with the President.

He said that individuals who support the current administration seem to evade prosecution while those critical of it are pursued.

Frank warned that if the EFCC continues to neglect its duty to investigate allegations against individuals like Nyesom Wike, they will make the petitions public to shed light on their actions while in office and compel the



EFCC to take action.

"Hence, we urge the EFCC to demonstrate its commitment to combating corruption in Nigeria by actively pursuing all individuals accused of corrupt practices, not just a select few.

"If the EFCC truly aims to gain the trust of both Nigerians and the international community in the fight against corruption, it must extend its investigations to all relevant parties mentioned. Additionally, we demand swift prosecution of those implicated in corruption allegations to ensure accountability and fairness.

"Furthermore, we call upon the EFCC to cease the harassment and intimidation of individuals like Yahaya Bello. Doing so will signal to the public that the EFCC is dedicated to upholding justice and integrity in Nigeria, thereby restoring faith in the anti-corruption efforts of the current administration."

Water Scarcity: Gov Buni Directs Supply Of Free Diesel To Private Boreholes

"Government has recently increased the supply of diesel from 40,000 litres to 60,000 litres to over 100 government boreholes in Damaturu, but we came to realize that some areas that are overpopulated still have the challenges of getting water at a subsidized rate from the water vendors".

"We are giving 10 litres of diesel each to

some selected private boreholes in Damaturu the state capital to cushion the sufferings of the buyers. The borehole

operators charges N300.00 per truck thereby forcing the water vendors to sale the truck at about N1,000 to residents operator and Babagana Ali a resident of Nasarawa community in the state capital; thanked the government for cushioning the sufferings of the people during the hot season.

It would be recalled, the suspected Boko Haram insurgents vandalized poles number 377 and 378 of the Nigeria Transmission Company (TCN) in the last eight weeks thereby causing epileptic power supply to the state capital, as most government boreholes depend on electricity for source of energy.

With the efforts put in place by the government, the residents look forward to when the electricity supply will fully be restored.

By; PATRICK TITUS, Uyo Ardship bites harder in Akwa Ibom State as fuel scarcity hit the state following allegations of extortion and impounding of products by Natural Oil and Gas Suppliers Association (NOGASA), forcing marketers to close stations.

According to the state branch of the Independent Petroleum Marketers Association (IPMAN), the decision to suspend operations was taken after a stakeholders meeting following a series of "refractions into our businesses caused by the activities of Natural Oil and Gas Suppliers Association (NOGASA) where members' products were impounded on the road and extorted."

It directed members to close stations/outlets from the public effective Monday April 22, 2024 adding that any non compliance would attract a fine of N300,000 which it said would be enforced.

Checks in Uyo, the Akwa Ibom State capital revealed that many of the service stations did not open since Sunday forcing a few that defied the directive to sell their products at N800 litre as against the current price of N700 per litre.

The check further showed that though the price of petrol is said to have been slashed in some parts of the country, the looming strike has worsened the current situation in Akwa Ibom State.

The effect however, is the hike in transport fares. A drop by bus or Keke that was formerly between N100 and N150 depending on a distance, now charge N200, N250 and N300.

Those, especially students and low income earners who cannot afford to pay the high fare trek distance to their destinations. Reacting to the development, Petroleum Products Retail Outlets Owners Association Of Nigeria (PETROAN) however urged the public to disregard the threat while its members should go about their businesses. Udeme Esset, chairman of the group in Akwa Ibom state in a statement made available to newsmen in Uyo, said the association would release their enforcement team from

today (Monday) "to monitor the operations of the retail outlets and report to the (Nigeria Midstream and Downstream Petroleum Regulatory Authority)" adding that the "necessary security agencies for action should there be any encumbrance from any unauthorised person or group."

It urged the state government to take necessary actions against those stopping petrol tankers on the road therefore causing unnecessary traffic and endangering the residents in an event of a possible accident or explosion from any of the inflammable petroleum tankers impounded.

Reacting to the scenerio, Governor Umo Eno said he has directed the Commissioner for Internal Security to liaise with the Co-ordinator of Ibom Community Watch, a government owned security outfit and other security outfits to mount surveillance at the boarders to checkmate the unscrupulous elements from carrying out their evil intentions.

According to the governor there is fake news in circulation from an unknown group saying they want to withdraw their service of fuel delivery in Akwa Ibom state, we have contacted the original and authentic group who have since c o u n t e r e d t h a t announcement.

"In the wake of the prevailing hardship in the country, if any group believes it can constitute themselves into a nuisance and create additional hardship for the people of Akwa Ibom, we will confront that group," he said.

The governor who spoke during a special service and fundraising for church building project in Onna local government council noted that Nigerians have been severely impoverished by the present economic realities and warned groups not to worsen the situation. Until the threat by IPMAN, nothing was heard of PETROAN in the state which many believe is a faction within the marketers which is sympathetic to the state government.

Makarfi Education Endowment Trust Fund Pays Fees Of Over 300 Students

Non Governmental Organisation under the aegis of Makarfi Education Endowment Trust Fund (METEF) has announced that it has paid tuition fees for over 300 students, particularly those from vulnerable homes in the LGA.

According to the foundation, the payment aims to support the students in focusing on their education without financial challenges.

Secretary of the foundation, Sama'ila Aliyu Makarfi, stated this following a courtesy visit by the foundation's leadership under the chairmanship of Mahmud Bako Gazara to stakeholders of Makarfi Local Government Area origin in the state, including the former state governor, Ahmed Makarfi. He disclosed that the benefiting students were from Nuhu Bamali Polytechnic and Kaduna State University, emphasizing the foundation's efforts to secure a JAMB registration center for Makarfi LGA due to the absence of one in the town, forcing students to travel to Zaria for exams.

"We have supported approximately 300 youth within Makarfi LGA, covering their tuition fees to facilitate their education. Most of these beneficiaries are students of Nuhu Bamalli Polytechnic and Kaduna State University," he said. Similarly, Chairman of the foundation, Mahmud Bako Gazara, addressing journalists, expressed the foundation's commitment to combatting school dropout rates in the LGA.





We Are Not Part Of Call For Yoruba Exit From Nigeria - Afenifere

he Pan-Yoruba socio-cultural and sociopolitical organization, Afenifere on Monday, described the call for the exit of Yoruba from Nigeria as undesirable, self-serving and unnecessary 'at the moment at least'.

Afenifere in a statement by the organisation's National Publicity Secretary, Comrade Jare Ajayi rubbished the call by a group, "Yoruba Self-Determination Movement' (YSDM) in an open letter to President Bola Tinubu on Saturday for a peaceful secession of the Yoruba nation from Nigeria.

The Pan Yoruba socio political and socio cultural organization stated in its statement that the problems bedeviling Yorubaland and Nigeria as a whole "are not merely because multi-ethnic groups make up the country". According to Afenifere,

" Rather, the country's multi various problems can be traced to lack of good governance", adding that it faulted "the reason adduced for the request to exit Nigeria which was on the basis of perceived marginalization that Yorubas are suffering in Nigeria. "There is no doubt that the lot of Yorubas can be better than it presently is. But whatever deprivation Yorubas may be experiencing today in the Nigerian nation is not due mainly to the fact that they are Yorubas", it said.

The Pan Yoruba organization added, " The deprivations they may be suffering could be traced to the general mis governance that corporate Nigeria had been subjected to over the years if not decades. Meaning that marginalization, deprivation, injustice, misgovernance etc that Yorubas may be experiencing today is, if truth is to be told, not peculiar to Yorubas alone".

"We are not, by this submission, claiming that Yorubas are getting the best or should not be better served. Far from it. What we are saying is that it would be unfair to use the excuse of the deprivations in the land as an alibi to want to leave Nigeria.

"What we should clamour for is good governance that will enable every segment of the society to have a better lease of life".

It noted further " when, during the First Republic, the country Nigeria ran a semblance of true federalism in which each region was able to determine its own affairs, life was relatively better and the agitation for separation was not rife". FG Announces Recovery Of N57bn Debt From 10 MDAs

The Federal Government has announced the recovery of N57 billion from the N5.2 trillion liaibilities owed the Federal Inland Revenue Service (FIRS) and other bodies by Ministries, Departments and Agencies (MDAs) of government

The Permanent Secretary, Special Duties, Federal Ministry of Finance Mr. Okokon Ekanem Udo made the disclosure yesterday in Enugu, the Enugu State Capital, during a Sensitisation Workshop on Federal Government Debt Recovery Drive through Project Lighthouse Programme for South-East geo-political zone.

A statement signed by the Director, Information & Public Relations, Mohammed Manga, dated Tuesday April 23, 2024, said that while declaring the event open, Ekanem stated that the debts came to the spotlight from data aggregated from over 5,000+ debtors across more than 93 MDAs.

Represented by the Ministry's Director, Special Projects, Aisha Omar, the Permanent Secretary informed that it also received refunds to the government from companies who failed to deliver on projects for which payment had been made, adding that others are unpaid credit facilities granted to both corporate entities and individuals by the Bank of Industry (BOI), Bank of Agriculture (BOA), Judgment Debt in favor of Government and debts owed Pension Transitional Arrangement Directorate (PTAD) by Insurance


O Companies amongst others. Mr Udo added that data

Mr Udo added that data from Project Lighthouse revealed that many companies and individuals, who owe government agencies and refused to honour their obligations were still being paid. This, he said, was done through government platforms such as GIFMIS and Treasury Single Account (TSA) due to lack of visibility over these transactions. According to him, in actualising debt recovery goal, the Federal Ministry of Finance initiated *Project Lighthouse*, which has enabled the aggregation of relevant economic and financial information from multiple agencies who hitherto did not share data.

Ekanem explained that, generally, revenue loopholes have been aided by poor information sharing and enforcement. *It may interest you to note that the Ministry, through the consolidation efforts of the Debt Analytics and Reporting Application, has been able to aggregate monumental debts of approximately N5.2 trillion*, he said.

The Permanent Secretary who informed further that the debt aggregation effort is still ongoing stated that *currently, approximately N57 billion has been recovered so far* *from this amount due to concerted efforts on the part of stakeholders*

and the Federal Government He hinted that similar sensitization workshops have been held in the five geopolitical zones of the country, namely South- West, North-Central, North-West, South-



South and North-East respectively

Ekanem explained further that important part of the policies and strategies was to leverage big data technology to help block revenue loopholes, identify new revenue opportunities, optimize existing revenue streams, especially non-oil revenue as well as improve fiscal transparency, in line with the policy objectives of the President Bola Ahmed Tinubuled Administration

He disclosed that the Ministry, in this regard has however taken steps to address this major revenue loophole, through the issuance of a Ministerial directive to all MDAs to aggregate all Government debt across the Public Finance Space as well as having a single window on the credit profile of Government.

*It extends the functionalities of

Debt Recovery Capability of Lighthouse to enable the Federal Ministry of Finance to fully automate the debt recovery process and make settlements of debts as seamless as possible*.

The usefulness of this platform is that, our revenue generation effort will be dependent on your cooperation and commitment in providing quality and relevant information (debt-related data) to populate the platform, he added

The Permanent Secretary who expressed optimism that participating Organizations stand to benefit immensely from the Lighthouse Project called for their continuous support to ensure the full realization of the Programme's goals and aspirations.

Responding, one of the participants at the sensitization workshop Mrs. Ifeoma Ojukwu, applauded the initiative, noting that it had created more awareness on the benefits accruable to participating MDAs.

In his vote of thanks, Deputy Director (PICA) Federal Ministry of Finance, Mr. Johnson Oludare commended President Bola Ahmed Tinubuled Administration, the Minister of Finance and Coordinating Minister of the Economy, Mr. Wale Edun, the Permanent Secretary Federal Ministry of Finance Mrs Lydia Shehu Jafiya as well as the Management and Staff of the Ministry for creating the enabling environment for the operationalization of the Project Lighthouse which he said, is a data-driven initiative aimed at collecting, integrating and analysing data from revenue generating agencies in order to create insightful information for improved decision making.


He noted that a new template for recruitment in Nigeria which gives room for collective and inclusive participation has been put in place by the Commission and which he is recommending to other Agencies of Government.



We Will Not Rest Until Last Abducted Chibok Schoolgirl Is Released - Borno Govt





The Borno State Commissioner of Information and Internal Security, Professor Usman Tar has said that, "the state government will not rest until the least remaining abducted Chibok schoolgirl is released from captivity and hands of the Boko Haram insurgents.

He also assured that the government of Professor Babagana Umara Zulum' is working assiduously with the federal government to ensure total repatriation of Borno State indigenes taking refuge in the neighbouring country of Chad Republic, as those in the Republic of Niger have been relocated and resettled in Damasak town and others memory and we shall not rest on our oars until the last of our innocent girls are back home with their families.

" On this auspicious occasion of the 10th Anniversary of the abduction of Chibok Girls, the Borno State Government identifies and sympathises with all those who are affected by a b d u c t i o n. The Government wishes to inform the public that we shall continue to struggle to salvage our abducted girls on behalf of the parents and relatives of the Chibok girls who are still in captivity.

"The Borno State Government is committed to rescuing and reuniting the remaining Chibok girls and reuniting them with their families. We understand the pain and anguish that the families of those still in captivity are going through, this is our sorrow! "We also wish to use this occasion to take stock of the rescued girls and provide an update on how the girls are coming to terms with adjusting to normal life after captivity, and efforts of the Borno State Government to sustain the momentum on the rescue of the remaining girls." According to him," Borno State Government will not rest until every missing person is found and returned home safely. We call for unity

and support from all citizens as we navigate these challenging times together."

"We remain hopeful and determined that, with the combined efforts of our security forces, intelligence agencies, and community support, all abducted persons will be safely returned.

"Our thoughts and prayers are with the families of the abducted Chibok girls and, indeed, all missing persons. We will continue to stand together during this difficult time.

""So far, out of the 276 abducted Chibok Girls,187 have been rescued and reunited with their families. Most of the rescued girls have, over the years, been enrolled in different schools or graduated under the supervision of the Federal Ministry of Women Affairs. A number of the girls have been enrolled into local and foreign scholarships o r empowerment programmes. "Many have since been reunited with their immediate families and are continuing to receive psychosocial support to reconcile them with normal life. Furthermore, 16 recently rescued girls are being rehabilitated by the Borno State Government and attending the 2nd Chance School where they learn skills in various vocations that will

provide them with sustainable livelihoods, while their kids are also placed in nursery schools. Four rescued girls have voluntarily decided to return to their parents," Tar said.

On the Return of IDPs to their Ancestral Homes, Fire Outbreaks " he said, "Borno State Government is fully committed to the return of all IDPs - both those in formal and informal camps - back to their ancestral homes.

"So far, over 90% of active IDP Camps have been decommissioned and the displaced persons resettled, while the balance shall be resettled within 2024 In Sha Allah.

"The dismantling of each IDP Camp and resettling of the displaced persons is normally preceded by the restoration of security, clearance of farmlands initially within a 5 kilometer radius and restoration of vital infrastructure especially schools, water systems, electricity and mobility. "This, village-by-village; town-by- town; and household-by-hold our people are being resettled with military precision and meticulous logistic engineering. We thank the agencies of the FGN, especially the armed forces and security agencies, for their unflinching support in this regard, "the commissioner added

Professor Tar said in addition to the domestic IDPs, ,"we are also dealing with the issue of Nigerian refugees who are seeking asylum in Niger, Chad and Cameroun."

"The Borno State Government is deeply grateful to our neighbouring countries and our neighbourly kiths and kindreds for their magnanimity and hospitality in accommodating our citizens in their territories. The relocation of Nigerian refugees is in the radar of the Federal Government.

"Recently, the Executive Governor of Borno State Governor, Prof Babagana Umara Zulum had sought an audience with the President CnC, Asiwaju Bola Ahmed Tinubu GCFR, on the issue of relocation of Nigerian refugees to their ancestral homes within Nigeria. "The President has pledged to support this process, and provide the federal might that is needed to ensure a seamless return of our people back home after a decade of stay as refugees. This process requires patience on the part of our people. "The return of our teeming displaced citizens require careful logistic work and restoration of security and



places.

Professor Tar who stated this on Saturday at a press conference held at the NUJ Press Center Maiduguri with journalists to commemorate the 10th Anniversary of the abducted Chibok schoolgirls by Boko Haram insurgents in Chibok village of Chibok LGA of Borno State.

"Ten years ago, the Boko Haram insurgents criminally abducted 276 innocent girls at their hotels at Government Girls Secondary School Chibok. This painful date is engrained in our collective

vital infrastructure as a precursor to the actual relocation and resettlement. We urge our people to exercise patience while the state and federal governments find sustainable solutions to our security and developmental challenges," Prof. Tar said.

The Borno State Government is not oblivious of the extant challenges that may be associated with the relocation of the IDPs and refugees. While we relocate our IDPs and refugees, we also have a solum duty to maintain law, order and security in the remaining camps. We are dealing with the risk of attacks by unscrupulous elements and the remnants of the Boko Haram insurgency, and the rising cases of crime and

criminality in our active IDP Camps. A case in point is the recent breach in security and issues surrounding the missing IDPs near Ngala town. Certain narratives suggest that these IDPs numbered between 200 and 300 were abducted.

It is important to clarify that while there have been cases of missing internally displaced people, the number, according to the available data, stood at 106 boys and girls, and so far 8 have since returned to their respective camps. On March 3, 2024, these youth left their camps to look for firewood in the bush far beyond the distance that security agencies permitted and considered secure. These IDPs may have come into contact with violent non-state actors in the bush.

The Borno State Government is working closely with the Federal security agencies to safeguard the lives and property of the citizens in the state. In particular, the government is working on the rescue of the missing IDPs and all others in captivity. The Government calls on all stakeholders, including the media, humanitarian partners, and the general public, to approach this issue with sensitivity and understanding. We must work together to address the root causes of displacement and provide support to those in need.

The Borno State government is also not ruling out criminals who take advantage of the security situation to commit atrocities. However, security forces are on the trail of these criminals. Meanwhile, investigating is ongoing on alleged cases of crimes, and we urge citizens to exercise patience while we deal with this all alleged crime. Our citizens should be rest assured that anyone or agency who is found culpable shall face the fill wrath of the law.

Despite the recent challenges in Ngala, the Government wishes to confirm that peace has gradually returned to Borno state, and the "Build Back Borno Better Project" is on course. We would also like to state that about a million IDPs have returned to either their local government headquarters or ancestral homes.

The reconstruction and rehabilitation of destroyed communities and public infrastructure is ongoing, and the public's trust in our government and security agencies remains high.

The Borno State Government is working tirelessly to improve conditions in the IDP the camps, enhance security measures, and facilitate the voluntary return and reintegration of displaced persons into their communities.

While fully cooperating with security agencies to carry out the kinetic approach against the insurgents, the Borno State Government is also investing heavily in nonkinetic measures, particularly the mass clearance of farmlands for agriculture and the involvement of community leaders and traditional rulers in alternative dispute resolution.

Kwankwaso's Plot To Oust Ganduje

Political power play, power game as well as high political interests aggregation, are normal variables that define partisan politics. However, when these correlates are stretched beyond certain limits, there may be the likelihood of ushering in very dangerous instinctual reactions that have huge capacity for destabilizing the polity.

For all followers of the politics of Kano, Northwest Nigeria, particularly between May 29, 1999, to May 29, 2007, there is a tie-back to the historical precedence of the joint electoral victory between Alhaji Rabiu Musa Kwankwaso as then governor-elect and Alhaji Abdullahi Umar Ganduje, PhD, as deputy governorelect, respectively.

These two gentlemen were members of the same political party, the Peoples' Democratic Party {PDP}, but they had definitely passed through varying and divergent socialization processes. Even as it is a known fact that all deputy governors in Nigeria are hardly allowed to exercise full political authority, the duo of Alhaji Rabiu Musa Kwankwaso and Alhaji Abdullahi Umar Ganduje managed to work together in harmony during their first tenure.

For Alhaji Kwankwaso to consider the inclusion of Ganduje as running mate for the second term, however, it was a tug-ofwar. Elders of the party, eminent citizens and significant others, intervened, persuaded and eventually prevailed on Kwankwaso to restore Ganduje to the joint gubernatorial ticket as running mate. They expectedly won the elections. So, they worked together for eight years.

Ganduje was to succeed Kwankwaso as governor, perhaps against the wishes of his former political principal and leader who, after his tenure as governor, was rewarded with a high end political portfolio as Nigeria's minister of defence by the then President Olusegun Obasanjo. Over time, Ganduje has achieved a solid political stature which tended to overshadow his former principal. The result is that Kano has been split between the two tendencies. The particular human behavioural trait at play here is none other than the human Ego. As a student of the Freudian tradition, one is quick to point out that the major behavioural set back that any political leadership, must avoid in his or her political career, is by avoiding a negative inter-play of the different roles of the three major clinical psychology properties that regulate the impulse of all human, namely, Id, Ego and Superego, respectively. These three, when negatively influenced, can bring about the downfall of anybody who is somebody, irrespective of his or her social stratification in the larger society. It is therefore imperative to point out within this medium that the ongoing struggle for political power, relevance and advantage between a former political principal, Alhaji Kwankwaso, and his "junior" associate, Dr. Ganduje — who by way of chronological and mental age is much more senior and better educated than his erstwhile political boss— can all be traced to politics. That is why there is a

desperate plot by Kwankwaso and his group to oust Dr. Ganduje as the National Chairman of the All Progressives Congress (APC).

Part of the plot is the sinister scheme to destabilize the Tinubu administration using veiled propaganda, campaign of calumny and allied methods to tarnish APC and its leadership with the hope that such a distraction will add to the political fortunes of Kwankwaso and his NPP in Kano. The calculation is that once Ganduje is out of the way, Kwankwaso and his acolytes can have the whole of Kano to themselves.

Not surprisingly, the whole machinery of the Kano State Government has been deployed to achieve this end.

that Ganduje is an urbane intellectual who obtained his Doctor of Philosophy degree {PhD} at the famous University of Ibadan, in 1993, following his first degree in 1975, when Alhaji Rabiu Musa Kwankwaso had not dreamt of enrolling in any Higher School Certificate program. The conditioned behaviour, which had always propelled Alhaji Rabiu Musa Kwankwaso, who has an affinity for wanting to show political dominance over every citizen from Kano State as an infallible dictator, was what made eminent personalities like Alhaji Ibrahim Shekarau and Distinguished Senator Jibrin Barau, just to mention a few, not stay in the same political camp with him.

In Kwankwaso's world, his word is law. He cannot tolerate democratic tenets. He cannot work with intellectually endowed people. For him, getting Dr. Ganduje out of his current position as the National Chairman of the APC is his greatest headache. He is probably calculating that Ganduje's ouster will enable him (Kwankwaso) grab a ministerial position as a pre-electoral bargaining condition and convince President Bola Ahmed Tinubu that he has the entire Kano State in his pocket and that his NNPP is waiting in the wings to play ball. The NNPP gang is full of hypocrites. They demand integrity from others while lacking it themselves. An example: Governor Abba Kabiru Yusuf has appointed Kwankwaso's son as a member of the Kano State Executive Council. It's payback time. They are sharing the spoils as all the other parties do. In their desperation to pull down Alhaji Abdullahi Umar Ganduje, NNPP hirelings have embarked on senseless moves to procure fake "APC Executive Members", at the ward and state levels, who are their sidekicks. They've tried impersonation, blackmail, open threats and all sorts of sabotage to no avail. From the grapevine, Alhaji Rabiu Musa Kwankwaso's most pressing need now is how best he can penetrate the APC federal administration to get a plum ministerial appointment when the president rejigs his cabinet as expected. To achieve this, he is persuaded that he has to destroy Dr Ganduje. But, if history is anything to go by, all their schemes will fail. For, history teaches us that those who plot the destruction of others often fall on their own sword.

Dr. Ganduje in his eight years as governor of Kano State produced a very credible democratic scorecard, whose sectoral achievements are cogent and verifiable by any interested member of the public. Apparently not getting adequate results from all the failed plots so far executed by him and his lackeys, Alhaji Rabiu Musa Kwankwaso does not seem to have any iota of respect for seniority and civilized order.

Devoting and ploughing all his energies towards clandestine schemes aimed at pulling down the personality of Alhaji Ganduje who had paid his dues in society by Allah SWT's divine blessings, is akin to trying the patience of the Almighty ALLAH SWT. The bitter jealousy of Kwankwaso and his men can be further understood when one considers the fact

How To Escape Lawsuits, Jail Terms

any a time, people carelessly suffer as a result of being ignorant of the laws until after offences or crimes have been committed. Majority only get to discover they have committed an offence at a Police station or other law enforcement facilities after being arrested. In their defence, it is always -"I don't know it's a crime". Incidentally, ignorance of the laws is not an excuse. For instance, recently, Idris Okuneye, widely known as Bobrisky, a controversial transgender was arraigned in the Federal High Court in Lagos for money laundering and abuse of naira notes. He was convicted and in allocutus, pleaded 'ignorance of the law. Of course, the law accordingly took its course. During the sentencing, the court handed him a 6-month jail term without option of fine. What an avoidable predicament!

This defence has also been the lot of many people on trial or convicted already by our courts. The reason is that societies are guided by laws and when broken, knowingly or unknowingly, the law takes its cause in wrath. It's immaterial if the offender is aware of the law or not as long as it has become operative. So, many learn from these bitter experiences which shouldn't be so. This oversight also affects most business owners who simply register a business name or incorporate a company but don't know their mandatory civic obligations on such a venture. For example, there are statutory annual returns businessowners are duty bound to file yearly which may result in striking out the company or business name from CAC (Corporate Affairs Commission) alongside other sanctions. To make it worse, the law empowers another person to acquire, register and use any business names or company names struck out from the CAC register as a new business. Imagine your business name or company name for decades suddenly acquired by another person, maybe your competitor. Presently, the federal government is putting actions together to go against such defaulters. In the United States, former President Donald Trump has been in court to clear himself from the charges of tax evasion. So, it is a conventional standard practice. In a nutshell, it is dangerous to register a business or own a company but not file the statutory returns yearly. As we speak, thousands of business and company owners are liable to this. Some are not even aware of these obligations as many were probably not thoroughly briefed about registering a business name or owning a company.



This is among the risks of not engaging a legal practitioner.

Implementing Oronsaye Report: The Domestic Cat Is Not A Lion

HE TINUBU administration picked up the courage to **L** implement the Oronsaye Report on restructuring the federal public service and cutting cost of governance. It was a courage lacking in his two immediate predecessors.

The Report recommends the merger of 220 of the 541 agencies, reducing agencies from 263 to 161. In all, 31 agencies are to be abolished, 54 merged, and 14 reversed to their previous status in the ministries. It is not clear yet how much of the Report will be implemented, but it is off to a good start.

There has been some controversy about the decision to implement the Report with some accusing Tinubu of seeking to divert attention from the punishing economic crises Nigerians are going through. However, for me, the issues of reform, change and effective service delivery to the populace, should not be wished away or thrown out purely on such basis. I also do not buy the argument that rather than implement the Oronsave Report, the administration should concentrate on creation of more jobs.

The architect of the reforms is Stephen Osagiede Oronsaye, a rather conservative public servant who was appointed Head of the Civil Service of the Federation in June 2009 and left office on retirement on November 16, 2010. As Head of Service, he had pushed through a new policy limiting terms of permanent secretaries and directors to eight years. Armed with this, he forced nine permanent secretaries and some directors to retire from service.

Impressed by this unprecedented reform in the service, President Goodluck Ebele Jonathan appointed him to head a team that would reform the public service. His team turned out an 800-page document that became known as the Oronsaye Report. But Jonathan found it too hot to handle and dropped it like hot potato. President Muhammadu Buhari came into power singing an anthem of change. After a number of declarations and vows to implement the report, he dropped it. Oronsaye, himself, might not be too happy with the country. He supported an Executive Bill presented to the National Assembly in 2013 for the creation of an Independent Nigerian Financial Intelligence Unit outside the Economic and Financial Crimes Commission (EFCC). A visibly angry EFCC opposed the bill. Shortly after, it accused Oronsaye of carrying out a N190 million pension fraud back in 2010-2011. Two years later, he was hauled before the courts and, for the next eight years,

dragged before two different judges before a third, Justice Iyang Ekwo, discharged and acquitted him.

The judge ruled that the entire investigation and subsequent arraignment of the reformer, was a witch-hunt. He had wondered how, over the years, Oronsaye was not even availed a copy of the petition against him, so he had no way of responding or defending himself against the charges. In a sense, the

commencement of the implementation of his 12-

year Report is a further vindication of the 74-year-old Oronsaye.

There has been some controversy about the decision to implement the Report with some accusing Tinubu of seeking to divert attention from the punishing economic crises Nigerians are going through. However, for me, the issues of reform, change and effective service delivery to the populace, should not be wished away or thrown out purely on such basis. I also do not buy the argument that rather than implement the Oronsaye Report, the administration should concentrate on creation of more jobs. I do not see both as being mutually exclusive. Again, those who argue that we need more, not less agencies, have missed the point because the multiplication of bureaucracy does not translate to more government.

If anything, so long as the implementation does not result in job loses, I think it is not even going far enough. For instance, I do not see the reason for the existence of the Police and the Nigeria Security and Civil Defence Corps as two distinct civil security bodies. No serious country gives a single senator N21 billion as 'constituency projects' for which there are no competitive biddings, no specific projects approved and no proper accounting system. If we were to be serious with cutting cost, the Bicameral Legislature would give way by the scrapping of the 360-Member House of Representatives. Its duplicated functions can be carried out by the Senate. It makes a lot of sense to me that the Directorate of Technical Cooperation in Africa and Directorate of Technical Aid Corps are merged under the Ministry of Foreign Affairs with the Nigerians in Diaspora Commission also brought



under the Ministry. Why should the National Metallurgical Development Centre and National Metallurgical Training Institute be different agencies or, the Nigeria Army build a university separate from the Nigeria Defence Academy?

I think those who claim that with the implementation of the Oronsaye Report, the Tinubu administration has begun the much-needed restructuring and cutting cost of governance, are widely off the mark. It is like claiming that because the domestic cat and the lion share a common ancestry and belong to the same feline family, they can be interchanged. In comparison, the Oronsaye Report Implementation is cosmetic.

To begin with, the Presidency is so ubiquitous, with so many officials and aides, that they can in themselves constitute a country. A supposed Federal Government has 68 items on the exclusive list, including fishing in local waters, police, marriage and divorce!

Despite being the economic capital of the country and housing a mega city, Lagos State is not allowed to create local governments that can service its populace. To be able to do so, is what true restructuring means.

An agency of massive wastage is the Independent National Electoral Commission (INEC). In some Third World countries like Venezuela, all the voter has to do is show up with his national identity card at any voting centre, cast his vote by touching the symbol of his preferred party as provided on the secluded screen. In contrast, INEC developed temporary voter's card which is then replaced by permanent voter's card, display of voters list for every polling station, printing of voters' cards, movement of non-sensitive electoral materials, followed by the sensitive materials which are escorted by armed security men. At the voting centre itself, it has deployed card readers, the Bimodal Voter Accreditation System (BVAS) and the INEC Result Viewing (IREV) portal. Disregard For Rule Of Law: Yahaya Bello Media Office Raises Alarm, Asks President To Call EFCC To Order

The media office of the immediate past Governor of Kogi State, Yahaya Bello, has urged President Bola Tinubu, to call the Economic and Financial Crimes Commission (EFCC) to order.

The media office made this known in a statement issued on Wednesday.

The statement read, "About 9:30 am today, the 17th day of April 2024, persons who described themselves as officers of the Economic and Financial Crimes Commission (EFCC) arrived the Wuse Zone 4 Residence of His Excellency, Alhaji Yahaya Bello to effect his arrest.

"This is despite a subsisting Order of injunction granted on 9th February 2024 by the High Court of Justice, Lokoja Division in Suit No. HCL/68M/2024 between Alhaji Yahaya Bello v. Economic and Financial Crimes Commission, restraining the Commission either by itself or its agents from harassing, arresting, detaining or prosecuting Alhaji Yahaya Bello, pending the hearing and determination of the substantive fundamental rights enforcement action. "The EFCC was duly

served with that Order on 12th February 2024 and on 26th February 2024; the EFCC filed an Appeal (Appeal N o . : CA/ABJ/CV/175 /2024: Economic and Financial

and Financial C r i m e s Commission v. Alhaji Yahaya Bello) against the said Order to the Court of Appeal Abuja division.

The Appeal was accompanied by a Motion for Stay of Execution of the Order of the High Court which the Court of Appeal adjourned for hearing till the 22nd day of April 2024.

"Furthermore, Judgment in the substantive case between Alhaji Yahaya Bello and the EFCC is to be delivered at 12 Noon today in Lokoja.

"Contrary to all of the above, the EFCC has now laid siege to the home of H.E Yahaya Bello seeking to arrest him in contravention of the extant orders!

"It is a surprise that an agency led by a lawyer could flagrantly disobey a subsisting court order by taking actions contrary to the reliefs granted.
