# **NYLF Seeks Clipping Wike's Wings** In PDP, Demands North Central

National Chairman Says Nigeria must not be allowed to slide into one-party state

rontline group, Northern Youth Leaders Forum (NYLF) has described those attempting to make the main opposition, People's Democratic Party (PDP) collapse as undemocratic, while insisting that the national chairman of the party should be retained by the North Central Zone.

NYLF expressed this at a press briefing in Lafia yesterday, with the text of the briefing, read by its President, Comrade Elliot Afiyo.

"We have observed with great dismay the efforts of these political opportunists in destroying whatever the nation has benefitted through democratic governments. "This is why we have been consulting with the stakeholders in PDP starting with the North -Central Zone of the country, to ensure equitable distribution of National Offices to guarantee justice and equity which are the basic democratic ingredients necessary for checks and

## **EFCC's Actions: Anti-Corruption CSOs Raise Concerns Over Yahaya Bello's Safety**

By; ADEBOYE ADO, Akure rontline anti-Corruption Civil Society Organisations (CSOs) have again advised the Economic and Financial Crimes Commission (EFCC) to toe the path of the rule of law and not continue to give credence to the impression that its anticorruption mandate is being politicized by some interests

According to them, what is happening currently, in the ongoing controversy surrounding the commission's handling of its allegations against the immediate past Governor of Kogi State, Yahaya Bello, "connotes nothing but that."

whose intentions are neither

patriotic nor altruistic.

They also noted that, with the way the EFCC had handled the matter, especially the threats from the lawyers and the Commission's boss, it was justifiable to say that Yahaya Bello's life might not be safe in the custody of the EFCC as being expressed by his supporters. "And we believe this is a legitimate fear."

The scores of activists, who gathered in Lagos on Tuesday for a well attended press conference on the state of Nigeria's fight against corruption, noted that "the principle of justice presupposes that its scales are

always balanced and it is blind to personality, creed, gender, race or status."

They specifically pointed out that what had led to the overheating of the polity was a simple factor - unwillingness of the EFCC to obey a court and follow the due processes of law.

"If the EFCC had gone ahead to defend its appeal against the Kogi State High Court's order without the premeditated drama of attempted arrest of a citizen who had a subsisting Court order against such action, we will not be here today," they said.

The Chairman, Centre for Anti-Corruption and Open Leadership, CACOL, Debo Adeniran, who led other CSOs at the press conference, said, "The question will still remain a subject of legal interrogation whether charges filed against a subsisting Court order can stand the test of legal scrutiny. If a court of competent jurisdiction has ruled that you must stay action on a particular matter pending the determination of the matter before it but that action was executed in spite of that order, one wonders how valid such charges could be in the long

He stated, "If your enemy falls victim of injustice today and you are happy and mute, when the same hand of injustice slaps your friend tomorrow, you will be under no moral or legal obligation to be angry or complain because society will remind you of the saying that 'what is good for the goose is equally good for the gander'. Worse still, you may even eventually become a victim of the same hand of injustice that you once celebrated.

"In this hazardous duty of rights activism, we are under permanent obligation to speak and rise up against injustice even if the person concerned is our mortal enemy or even a total stranger. It does not matter to us your religion, your ethnicity, your status in the society, whether rich or poor, powerful or powerless, popular or obscure; our commitment to the cause of justice is a perpetual service to humanity for which no sacrifices, including insults, blackmail and deliberate misreprentation of facts can be too heavy for us to bear. It is our cross. Some of us have carried this cross for over four decades.

"They say there is no morality in politics. We say there is no sentiment in justice and rule of law. Every citizen is equal before the law and must be seen to be treated equally."

The activists added, "In the current matter between the Economic and Financial Crimes Commission, EFCC, and the immediate past Governor of Kogi State, Alhaji Yahaya Bello, our position remains that the due processes of law be followed to the letter and unconditionally.

"As you may have noticed recently, more prominent Nigerians, including legal luminaries and politically exposed persons, are coming out to speak truth to power on this matter of arrogant disobedience to lawful court orders...

"Let us reiterate the fact that the EFCC could still have achieved its objective of prosecuting Yahaya Bello simply by following the due processes of law and even might have achieved more but for its decision to act ultra vires. We need not go into the details of that again as it is already in the public domain in large volumes."

They advised the legal teams of the Commission to pay more attention to the technicalities of their cases before presenting them before their lordships, saying that "the EFCC loses too many cases that either should not have been taken to Court in the first instance, or badly prosecuted whilst their lawyers continue to smile to the banks."

"With the way the Commission has handled the Yahaya Bello case thus far, especially the Gestapo-style employed, threats of military invasion to arrest him, and the needless public outburst of the Commission's boss on the

matter, it is justifiable to say that Yahaya Bello's life may not be safe in the custody of the EFCC as being expressed by his supporters and we believe that this is a legitimate fear.

"To that extent, all legal procedures can continue as they are now without Yahaya Bello being put in EFCC's custody. The Court knows what to do to ensure that he presents himself in Court whenever his presence is required.

"It is our well considered position that an error has been committed which can only be remedied by the well established judicial processes of Nigeria if truly this is strictly about corruption investigation and nothing else," the human rights crusaders said.

## Katsina Govt Establishes First Ever Council On Health

> Others include funds mobilization for the completion of Zango General Hospital."

> Governor Radda also revealed that the Ministry of Health has initiated the contracting process to upgrade the Kankara and Dandume Comprehensive Health centers to General Hospitals.

> He emphasized that the state council on health, which is the first of its kind, serves as a platform for collaboration between government agencies, healthcare providers, and community organizations to address public health issues in the state.

Outlining the terms of reference of the national council on health are effectively council, Governor Radda named the implemented, monitored, and aligned commissioner of health, Dr. Bashir Gambo Saulawa, as the chairman with the administration. Director of Planning, Research, and Statistics of the Health Ministry as the secretary.

He said the committee's mandate includes reviewing the current performance of the state's health sector and identifying gaps and challenges. This is in addition to mobilizing and allocating resources and ensuring accountability and transparency in the health sector, among others.

Earlier, in a welcome address, Katsina Commissioner of Health, Dr. Bashir Gambo Saulawa, said the State Council on Health would play a crucial role in the state's journey towards ensuring the wellbeing and health of its residents.

## ACF Hails FG Denial Of Foreign Military Base In Nigeria

### \*Slams HURIWA over support of the military bases

By; AMOS TAUNA, Kaduna he Arewa Consultative Forum (ACF), has expressed delight with the statement made by Alhaji Mohammed Idris, Minister of Information and National Orientation stating that the Federal Government of Nigeria (FGN) has no plans to allow foreign military bases in Nigeria. A statement issued by Prof. T. A. Muhammad-Baba, National Publicity Secretary of ACF yesterday, said, "The FGN must be appreciated for taking such a bold and reassuring stance. Every African must be proud of

this development." For ACF, the statement added that the development is a victory for the imminently patriotic Nigerians who signalled readiness to campaign against the rumoured plans to host US and French military bases in Nigeria following their rejection in Republics of Burkina Faso and Niger.

Still on the issue, ACF said that it is greatly disappointed with a statement, credited to a supposedly non-governmental organisation concerned with promoting human rights, going by the name the Human Rights

Writers Association (HURIWA), supporting the possible establishment of the said military bases.

ACF said it finds such support patently shocking, shortsighted and against everything Nigeria stands for, saying, "We are an independent, sovereign African country in uncompromising solidarity with all sister African, especially ECOWAS, states in the struggle against all vestiges of the intolerable stranglehold of colonialism and neocolonialism, that have for far too long continued to hold down Africa in conditions of underdevelopment."

It added, "Enough is known about the experiences of countries like Burkina Faso and Niger that have hosted foreign military bases for years. Such bases have to date served only the interests of the advanced countries. Wheresoever they are located, the foreign military outposts operate outside of the control and in utter disregard for the national laws of their hosts, respecting only their own convenient rules."

The statement explained that that sister African countries will, on the basis of their experience with the foreign military units, reject their presence is enough reason to dissuade Nigeria from even contemplate hosting them, stressing thag it does not make any sense that such bases as rejected by sister ECOWAS would be welcomed by any nextdoor neighbour.

"HURIWA ought to realise that the presence of the bases has undeniably failed to result in any demonstrable decline in the activities of terrorist and insurgent groups that have been wrecking political, economic and social conditions in the sister countries," the statement emphasized.

The statement said, "For Nigeria, it is inescapable that whatever is unhelpful and/or detrimental to the interests of African countries cannot be good for us, due to shared destinies in unbroken historical, socio-cultural, economic and political ties which predated and antedates the artificial balkanisation of our societies by European colonial control.

"Africans will forever decry the imposition of ridiculous international boundaries, which often cut across the very heart of communities, as systematised at

the infamous1884/1885 Berlin Conference at which no African country participated. It is thus instructive that the desire to establish the military bases emanate, not from African countries, but from the foreign powers themselves. It is as if the Berlin Conference is being updated and re-enacted now, in the 21st Century."

ACF observed that HURIWA is being quixotic and perhaps delusional in thinking that military and civilian personnel in the bases would respect Nigerias sovereignty or help them fight terrorism and insurgency, pointing out that a good question to ask is where (and why now) have the foreign forces been all the while with the body counts in the thousands, recorded disrupted livelihoods, internally displaced populations. ACF stated that it is also disappointing that HURIWA would seek to trivialise the patriotic call against foreign military bases as emanating from some Northern leaders, as if HURIWAS condemnation is itself, by equal measure, a southern" Nigerian agenda!

The forum noted that clearly the terrorism and banditry problem in Nigeria has gone beyond the prism of killer herdsmen and Boko Haram, as HURIWA would have it, saying that looking at the problem from such a simplistic and reductionist perspective is unhelpful in the fight against terrorism.

"Our security forces know this only too well. No one should be lulled into complacency, thinking that anybody but ourselves can solve the problem. Nigeria should not be tempted by Trojan Horse-promises from foreign interests that had, until now, at best remained benignly neglectful or uninterested in our insecurity woes," the forum observed.

For ACF, the prospect for locating foreign military bases is disconcerting because their many consequences would impact on the lives of the people, and will only exacerbate and not reduce the security risks and threats that people of the North

ACF, therefore, commended President Bola Ahmed Tinubus governments denial of plans to host foreign military bases on Nigeria soil, while calling on the FGN to forever refuse to entertain, let alone accede, to requests to site any foreign military base in Nigeria.



enry Danjuma, Chairman of the LA d h o c Committee set up by the Kaduna State House of Assembly to investigate financial dealings that have to do with loans and contractual obligations by the Kaduna State Government under Malam Nasir el-Rufai, had said that the committee will receive more testimonies from those invited to appear before it.

He noted that some testimonies succeeded in indicting persons not originally lined up for an invitation, saying that they would be invited to appear before the committee based on the indictment.

The Committee was recently inaugurated by the Kaduna State House of Assembly to investigate the financial dealings of the 8-year administration of the former governor, Nasir el-Rufai, following an outcry by the incumbent governor, Uba Sani, over the inability to pay salaries and complete contracts because of inherited huge debts.

The village head of the community, Prof. Efanga Usua who spoke on the situation, expressed fear and disappointment saying that such occurrence was strange in the area until recently when a mentally deranged woman was dispossessed of her baby by unknown bike men.

He said plan are underway to call a meeting of the East Itam Northern Traditional Rulers to find lasting solution to such frightening occurrences.

According to him, the issue is with the police even as investigation is ongoing to unravel the mystery behind the abducted child.

The Divisional Crime Officer (DCO), Ayadehe Police Station, Itu LGA, Bokime Bassey, when contacted said the matter was reported since Saturday and police was not resting as investigation is ongoing to make sure perpetrators of the evil act are brought to book.

faith-based Civil S o c i e t y Organization (CSO), Independent Hajj Reporters (IHR) has called on the various Amirul Hajj Teams being appointed by state governors not to usurp the powers of statutory officials during the forthcoming Hajj operations.

IHR said the call became necessary owing to past experiences in which some state Amirul Hajj Teams, who are supposed to be ad-hoc committees formed to offer support to appointed officials and pilgrims often assume powers a n d responsibilities beyond their scope which leads to chaos and negatively affect operations during hajj exercise.

IHR stressed that there should be a clear term of reference for the Amirul Hajj Teams and such schedules should not involve operational issues to avoid conflicts.

The CSO in a statement Monday by its national coordinator, Ibrahim Mohammed said Amirul Hajj Teams are sometimes led by respected traditional rulers, or members of the Ulama with wide following and high regards and they are expected to simply support Hajj officials carry out their responsibilities diligently while also offering advice and guidance to pilgrims on what is expected of them.

"From experience, we know for a fact that once appointed, some state Amirul Hajj Teams try to Lord it over Hajj officials, especially while in Saudi Arabia, and any resistance to that effect by these officials often leads to unnecessary crisis.

"State officials are often forced to satisfy the needs of Amirul Hajj teams because they wield Influence that can lead to their removal from office. Valuable time is therefore, dedicated to managing the crisis instead of fixing the onerous task of serving pilgrims.

"While we appreciate the role of leadership and guidance of the Amirul teams, there are instances when the Amirul Hajj teams usurped the critical operation of a tion all responsibilities of state Muslim pilgrims' welfare board officials, especially in the areas of airlift schedule and the allocation of accommodation to pilgrims.

"We have seen cases where some high profile and politically connected A mirul Hajj team members will be requesting for VIP services.

"While we have no problem with Amirul Hajj Teams, we urge that these teams should not go to Saudi Arabia and constitute themselves as an unnecessary obstacle to the smooth running of Hajj operations.

"They should see their appointments as a call to serve the pilgrims, who are the guests of Allah (SWT) from their states and the country at large and should, therefore, strive to offer their best to gain maximum reward.

"In the same vein, we call on the various officials from the states not to be antagonistic to the members of the Amirul Hajj Teams but see them as partners in progress for the common good of the pilgrims.

"We know that differences may arise, but we also know that both members of the Amirul Hajj Teams and officials can always settle the differences without recourse to animosity". "Let everyone act with the hope of getting Allah's favour and nothing else" IHR said.

#### Foreign Military Bases In Nigeria, Threat To National Security, Sovereignty - PRP

he Peoples Redemption Party (PRP), has joined other Nigerian patriots who have cautioned President Bola Ahmed Tinubu and members of the National Assembly on the dangers of the ongoing attempts by the USA and some European countries to relocate their military bases in the Sahel, where they have been kicked out by host nations, to Nigeria.

New Nigerian recalled that High Chief Rashidi Ladoja in July last 2023 instituted the suit against Gov Seyi Makinde over the beaded wearing crown, after the approval of the elevation of the Ibadan High Chiefs to Obas following Olubadan's recommendation.

It was learnt that few weeks ago after the demise of late Oba Lekan Balogun and with the intervention of some stakeholders' in Ibadan, High Chief Ladoja indicated his willingness to withdraw the suit.

High Chief Ladoja was said to have gave a condition that the two parties must sign the terms of settlement as prepared, sayıng, "Myself and other members of Olubadanin-Council have been sitting together and talking. We have agreed to withdraw the case from court".

"I heard that they have started signing the agreement. After all of them have signed, I will also sign my own aspect, and the next day, we will file for withdrawal of the case from court." he said.

#### Enugu Police Command Confirms Killing Of 2 Policemen, 3 Neighborhood Watch

#### \*Says 3 suspects arrested so far

he Enugu State Police Command has confirmed the killing of two of its personnel and three m e m b e r s Neighborhood Watch Group by harboured criminals of Igga Community in Uzo Uwani Local Government Area of the state.

Spokesman of the Command, DSP Daniel Ndukwe who confirmed the sad development via a press statement he issued on Sunday evening, said the incident occured on Friday.

He said the Enugu z Command "wishes to inform the public of the unprovoked and unwarranted attack and gruesome murder of two (2) Policemen and three (3) Neighbourhood Watch Group members by harboured criminal members of the Igga Community in Uzo-Uwani Local Government Area, in the evening hours of Friday, May 3, 2024.

"On the same date, a combined security team of three (3) policemen and four (4) Neighbourhood Watch Group provided security for a team of visiting investors from Lagos on a tour of a proposed agricultural investment site in the area. However, the team was ambushed and attacked by a large group of the criminal elements, who opened fire on them.

"Upon the unprovoked sudden attack, members of the team scampered for safety, while an Assistant Superintendent of Police (ASP), who led the team, one Neighbourhood Watch personnel, and the three (3) member team of investors were later rescued by a policemen team that immediately mobilized to the crime scene. But the eventually murdered members of the team went missing and unaccounted for.

"However, in the course of a full-scale investigation and a search and manhunt operation launched thereafter, three (3) males suspected who masterminded the attack were arrested.

" Their revelations during interrogation led to the discovery and recovery of the slain policemen and Neighborhood Watch Group members in the forest on May 4, 2024. Their lifeless bodies were taken to the hospital, confirmed dead by doctors, and deposited in the mortuary for preservation and autopsy. "Meanwhile, the state Commissioner of Police, CP Kanayo Uzoegbu has described the unprovoked criminal act of the

inconceivable, dastardly,

and unwarranted.

"The Commissioner has also advised members of the Igga community, particularly the criminal elements directly involved in the unthinkable and wanton act of murdering serving police officers and others, to voluntarily surrender themselves to







### APC Chieftain Asks Court To Stop Ganduje From Parading Self As Party National Chairman

he former National Chairmanship Aspirant of the ruling All Progressives Congress (APC) Mohammad Saidu Etu has sought interlocutory injunction to stop Dr. Abdullahi Umar Ganduje from parading himself as party National Chairman.

Besides, Etsu has faulted the power of the National Executive Council (NEC) of the APC that certified the appointment of former Governor of Kano state as the party National Chairman which he considered as ultra vires to the provision of the party's constitution.

In a motion on notice brought before the Federal high court, FCT division, the plaintiff through his counsel J. O. Obono-Obla Esq, urged the court to restrict Dr. Ganduje from attending or presiding over the National Executive Committee (NEC) and National Working Committee (NWC) of the party. In the interlocutory injunction, Etsu wanted the court to further restrain the former Kano state Governor from "carrying out the functions, powers, and responsibilities and those ancillary thereto, prescribed by Article 13 of the APC constitution, 2013 as (amended) pertaining to the office of the national chairman of the party, pending the hearing and determination of the substantive case".

The matter under case suit no. CS/CV/2258/2024 also is challenging four defendants including Dr. Abdullahi Umar Ganduje, All Progressives Congress (APC), National Executive Committee (NEC) and National Working Committee (NWC).

According to the notice, Dr. Ganduje has been purporting to be the National Chairman of the APC contrary to the Constitution of the party since August, 2023 and illegally presiding over or carrying out powers vest on the National Chairman, in defiance of the APC constitution, rules, guidelines of electoral Act, 2022. Etsu insisted that the prevailing action of Dr. Ganduje has elicit the party into a laughing stock among other opposition political parties in particular, thereby turning APC to an edifice of lawlessness.

Etsu is calling for immediate return to the zoning system of the position of the party chairman insisted that Dr. Ganduje who is clearly coming from the North western zone is wrongly occupying the position reserved of candidate from the North Central zone.

The party Chieftain argued that NEC of the party had no modicum or scintilla of power to so appoint Dr. Ganduje as National Chairman when the party guiding principles clearly stipulated the procedure of nominating a replacement in any case of vacant into the position of the national chairman.

The plaintiff worried that APC NEC has violated the party constitution which provide a replacement of National Chairman, who is has not completed his tenure before exit, from the same zone that produced the exited National chairman.

Etsu argued that Senator Adamu's resignation should ordinarily pave ways for a now National Chairman from the North West who would be entrusted to complete the mandate of the former.

It would be recalled that two factions of the APC Exco from Ganduje ward in Dawakin Tofa had in a separate decisions suspended Dr. Abdullahi Umar Ganduje from being a member of the APC for his alleged involvement in corruption charges, anti-party activities and none payment of party dues at his hometown.

# Water Scarcity: Gov Uba Sani Will Rescue Kaduna Corporation - Commissioner

n an effort to tackle water scarcity in Kaduna State, Governor Uba Sani has put machinery in motion to ensure the revival of Kaduna State Water Corporation to provide potable drinking water for the people of the state.

The State Commissioner of Public Works and Infrastructures Architect Ibrahim Hamza Soba made it known during a press conference held in Kaduna.

According to him, not satisfied with the state of water supply facilities in Kaduna the governor in November and December 2023 decided to commit the sum of over N600 million to provide succor to the people in areas of water supply as he embarks on restructuring the water corporation.

Arc. Soba lamented that upon assumption of office in 2023, the administration met a lot of challenges, saying the government is on the top of the game to ensure issues of water scarcity are addressed.

The commissioner also expressed dismay that a lot of investments have gone into the water facility noting that about 200 million dollars has been committed to the sector but the present administration came on board and yet the issue of water supply has not been tackled.

"We realized as at the time we came, the capacity utilization of our facilities was less than eight percent. So it was a very poor performance with all the investment in the sector. Our

revenue collection, our billing system, our connection system, the plant, and the whole three to four components of the sector were not working.

"When you go to the plant, that is where we get the water production component, very poor performance, when you get down to the transmission and reservoir, it is also below expectations, very poor performance, and getting down to revenue collection, water lost and everything was just on a high level of percentage.

"So the government had to sit down and see how we can remodel the whole structure and you know, this is not an easy job, it is a challenging situation because a lot of models have been tried before and it never worked. So we had to go back to the drawing board, we had to identify our mistakes in the past to see where we had gone wrong and see why things were this way."

ARC. Soba disclosed that the state is doing well and he is assuring the public that with the structure and plans we are trying to come up with after an intensive study, we will come back in the next two weeks to say what we have been able to do.

"We have other interventions coming up from the federal Ministry of Water Resources, we are trying to develop an Urban Investment Master plan, and last week, we did the final draft review we also have a low-hanging fruit which is the budget line under the WASH program which is also a World Bank



project which we are going to get some funding for.

"The Kaduna State Government is also willing to make some commitment to see that the whole water system, especially the urban water supply system, all challenges come to an end.

"I think that the new management of Kaduna State Water Corporation is doing well. "I think that the new management of Kaduna State Water Corporation (KADSWAC) is doing well.

"They are trying to undo some damages that were done by the urban renewable which took place some three or four years back where a lot of pipes were vandalized and that is why some areas that used to have water, no longer have access to the supply of water.

"So going forward, we are

hopeful that some of these things will be revived and we are going to see some level of progress.

"Already, some areas have started to see some progress after the intervention by the government at the end of 2023.

"I can assure the public that we have almost finished all the strategies and only implementation is left now." He said

he Governor of Kano State, Alhaji Abba Kabir Yusuf, officially assented to the Kano State Premarital Health Screening Law, which mandates premarital health screening for all prospective couples.

As per the new law, no wedding will be permitted in Kano without the presentation of a health screening certificate for genotype, hepatitis B and C, HIV/AIDS, and other related illnesses.

In a statement issued by the governor's spokesperson, Sunusi Bature Dawakin Tofa, the law was deemed necessary to

reduce the likelihood of children being born with underlying health issues such as sickle cell anemia, HIV/AIDS, and hepatitis.

This initiative aligns with the Kano state governor's commitment to enhancing and providing a conducive environment for the healthcare sector, aiming to make Kano free from or significantly reduce health challenges.

The law necessitates mandatory testing for HIV/AIDS, Hepatitis, genotype, and other relevant examinations before marriage.

It also prohibits any discrimination or

stigmatization against individuals living with HIV/AIDS, sickle cell anemia, hepatitis, and related conditions.

During the signing ceremony, Governor Abba

Kabir Yusuf emphasized that the purpose of implementing the law is to uphold the sanctity of marriages in Kano State and ensure the birth of healthy offspring, free from any preventable illnesses.

Upon approval by the state house of assembly and endorsement by the Kano state governor, the law was signed on the 6th of May 2024 and will come into effect on May 13, 2024.

It is mandated by the law that any

individual intending to marry must undergo testing for HIV, Hepatitis B and C, genotype, and any other relevant tests before marriage.

Furthermore, the law prohibits the formalization of any marriage contract for individuals planning to marry without presenting a test certificate from a government-approved health facility.

Moreover, the law specifies that any individual found in violation of its provisions commits an offense and, upon conviction, may face a fine of up to five hundred thousand Naira, for a minimum of five years, or both.

## Kwara Gov Presents 16 Ambulances Purchased By LGAs For PHCs

\*Says govt committed to improved healthcare delivery

wara State Governor, A b d u l R a h m a n A b d u l R a z a q h a s presented 16 Toyota ambulances for the use of primary healthcare facilities across the state, effectively strengthening the health emergency response system at the grassroots.

The ambulances were purchased by the local government authorities, each to be stationed in the various primary healthcare centres.

Presenting the ambulances on behalf of the local council on Monday evening, the governor said that it is part of the efforts to fortify the healthcare system in the rural communities.

"This is the initiative of the local government areas. It is their money. It is basically to support the health services, especially the primary healthcare centres," he said at a brief ceremony that was attended by the Chief of Staff Alhaji Abdulkadir Mahe; Commissioner for Health Dr. Aminat Ahmed el-Imam; Counsellor and Adviser to the Governor Alhaji Saadu Salau; Chairman for Association of Local Government of Nigeria, (ALGON) Kwara State branch, Hon Jide Ashonibare; and TIC Chairman for Baruten Local Government Hon. Abdulrasheed Lafia; among others.

"For now, this is placing one ambulance per local government to move patients from basic healthcare centres to secondary or tertiary health facilities in a way to fortify the healthcare system. Of course, there are a few others with ambulances that our administration had donated

to them in the past."

Ashonibare, for his part, described the intervention as laudable and one that will improve the healthcare services across the sixteen local government areas.

Governor of the state has said, in most of our health clinics in all the local governments there aren't vehicles that can be used in case of wanting to carry patients during an emergency to where proper medical treatment can be given to them. But with this now, the challenge is over, and it can get better. It is a laudable programme that will help all the LGs, especially our people in the remote areas", Ashonibare said.

"A situation whereby it will be difficult carrying patients from one place to another will no longer be there. We appreciate

the Governor for his leadership and good example."

Commissioner for Health, Dr Amina Ahmed el-Imam, said the development aligns with the objective of the administration to bring quality healthcare services to the doorsteps of all Kwarans, irrespective of their financial status.

"The objective of the state government is to achieve universal health coverage for people of the state, regardless of their position on the socioeconomic ladder. The presence of one functional standard ambulance in every local government of Kwara state is no mean feat, while more will definitely be done to strengthen healthcare delivery", she said.

"We can rest assured now that the people in the hardest reached areas which are typically the least fortunate among us now have almost the same access as people living in the capital city as long as we know that there are ambulances that can transfer them immediately if there are medical emergencies.

"Why this is particularly dear to my heart is because His Excellency the Governor of Kwara State has undertaken and is still undertaking a massive statewide renovation of facilities. We are working assiduously to improve the quantity and quality of manpower in our facilities, and this (by the local governments) is just again to complement the existing structure that he had put in place and the ongoing activities that we have in the health sector."



#### Yoruba Youth Ask Tinubu To Sack Chief Of Naval Staff Over Allegations

#### \*Pass vote of no confidence on Ogalla

he Yoruba Youth Council (YYC), has called on President Bola Ahmed Tinubu to sack the Chief of Naval Staff, CNS, Emmanuel Ogalla for allegations of supporting oil thieves levelled against him.

Besides, it passed a vote of no confidence on Ogalla, and called on the President to order a thorough investigation of the CNS, in view of what it described as recurring allegations of large-scale corruption and support for oil theft syndicates against him.

In a statement on Sunday by its National President, Comrade Eric Oluwole, the coalition, which is an umbrella body of Yoruba youths nationwide, accused the CNS of sabotaging the President's efforts against oil theft in view of allegations levelled against him.

The coalition spoke against the backdrop of allegations by another group of Nigerians of large-scale corruption and involvement in procurement fraud and contract splitting, in violation of the Procurement Act against the CNS.

That group in January had levelled the allegations against the CNS in a petition to the Fedral Government Tunubu led administration, who had vowed the administration's zero tolerance for corruption.

The YYC said that it was disturbed that allegations were still flying around that the CNS

is sabotaging Mr President's efforts in fighting oil theft.

For instance, it said there are allegations that a ship recently arrested by private security for oil theft was released to its owners after series of agitation by stakeholders; and that tank vessels were being allowed to evacuate or dilute exhibit in the name of taking samples, which ideally are taken in small bottles for laboratory tests.

The YYC said it gathered that the President had ordered the rearrest of the said ship and sanctioned full investigation.

It named the vessels involved in the alleged recent oil theft incident tagged MT PRESITGOUS AT BONNY ANCHORAGE.

Oluwole said: "It is in view of

these disturbing allegations, and a strongly-worded petition to His Excellency, President Bola Ahmed Tinubu in January that we the YYC call on the President to sack the CNS and order a full-scale probe into his activities while in office.

"We are fully in support of the ongoing efforts of the President and his administration to fight head-on oil theft, and stop its long-term bleeding of the Nigerian economy.

"Therefore we call on the President to remove any stumbling block on his path to successfully fight this monster called oil theft which he inherited, and sanitise the entire oil sector."

A group of concerned Nigerians comprising of lawyers, human

rights activists and anticorruption crusaders, had in January petitioned Federal Government expressing concerns over some allegations against the CNS.

According to their petition: "At a time when the country is grappling with significant revenue losses due to crude oil theft, it is distressing to discover that the Chief of Naval Staff, whose primary responsibility it is to safeguard Nigeria's waterways against oil theft and other forms of criminality, is allegedly colluding with the perpetrators of these heinous crimes against the Nigerian state."

dumping" people who worked for the victory of the President in 2023, while those who were against the President and even insulted him, were being given priorities "over authentic supporters and genuine Batists." Onokpasa, who was also a member of the APC Presidential Legal Team and Chairman, Tinubu Media Support Group, said, "Of recent concern to me is the case of my younger brother, His Excellency, the former Governor of Kogi State, Yahaya Bello. In this party, we have had our brother, the former governor of Kaduna State, Nasir El Rufai basically chased out of our party despite what he did for us to make us win. Now, it is Yahaya Bello. All these people, if they don't repent, Asiwaju will attend all of their funerals. They are mad! ## Mercy Corps Trains Media Practitioners On Conflict-Sensitive Reporting In Digital Era

he media landscape has evolved significantly from offline to online platforms, remarked Danjuma Dawop, Chief of Party at Peace Action for Rapid and Transformative Nigerian Early Warning Response (PARTNER). Dawop made this assertion during a one-day training on Conflict-Sensitive Reporting workshop for media practitioners held in Kaduna on Monday, May 6.

Traditionally, journalists sourced information by directly engaging with participants, subjects, or individuals. However, Dawop highlighted the paradigm shift caused by digital media, stating that it has deeply impacted the profession. He emphasized that the unregulated digital media space allows anyone to disseminate news items, leading to widespread belief and action based on often unverified information.

"In the past, people trusted journalists and esteemed the media as a source of reliable, verifiable news. But now, with social media, everyone can claim to be a journalist. The lack of regulation in social media makes it challenging for genuine journalists striving to share

accurate information," he remarked.

Addressing the workshop's theme, "Digital Peace-building Approach," Dawop emphasized the necessity of a robust risk assessment framework. Such a framework, he argued, empowers local actors, social media platforms, and international partners to anticipate and prevent potential harm resulting from the interaction between digital platforms and offline conflict dynamics.

"We believe it's crucial for media practitioners to understand the impact of social media on journalism and peace-building. Journalists serve as agents of peace, and through social media, they can disseminate information fostering unity among communities," Dawop stressed.

He further highlighted the role of journalists in mitigating the adverse effects of social media, portraying them as the ultimate source of information for the common populace.

"Media outlets have the platform to educate and provide clarity, particularly on peace and conflict issues. They can analyze conflicts, present various perspectives, highlight needs and interests, and inform people about the underlying issues," he



added.

Dawop outlined key elements of the risk framework, including sources of risk facilitating social media weaponization, intergroup conflicts, governance failures, and socioeconomic frustrations.

Expressing concern about the abundance of unverified news circulating, Dawop noted the challenge faced by journalists when individuals seek verification of trending social media information, of which they may not be aware.

Steve Agbo, Coordinator of the PARTNER project at the

Institute for Peace and Conflict Resolution (IPCR), Abuja, emphasized that the workshop targeted peace journalists in Kaduna state. He underscored the project's objective of fostering sustainable peace in Nigeria, particularly in the nine intervention states, supported by USAID to enhance the Early Warning Early Response (EWER) system in the North-Central and North-West regions. Agbo stressed the vital role of journalists in disseminating accurate information about the PARTNER project across

targeted regions and ensuring the incorporation of "Do No Harm" and conflict-sensitive reporting practices.

The consortium of PARTNER includes the West African Network for Peace-building (WANEP), Kaduna State Peace Commission (KSPC), Plateau Peace Building Agency (PPBA), Mambayya House (Aminu Kano Centre for Democratic Studies), and The Kukah Centre. The intervention areas span nine states: Benue, Kaduna, Katsina, Kano, Kogi, Niger, Nasarawa, Plateau, and Zamfara.

A'ishatu Ezra, Damaris Nathan, n another fresh attack in Justina Afis, Gabriela Nathan, Daniela Nehemiah, Jackson Sadam, Amame Ezra, Benedict Monday, Enoch Yohanna and Igwe Saleh.

According to him, "since November last year, terrorists have been constantly disturbing the people of the Gefe community and they cannot recount the monies spent as regards the payment of ransom." He observed that the community is in dire need of Government support in order to their major occupation which is farming, pointing out that with the rainy season fast approaching, most of them cannot access their farmlands for fear of being kidnapped.

"They've sold all that they harvested and some even sold their lands just to raise money for the ransom of their loved ones, they have no food and money to buy fertilizer. They need government intervention like; food and fertilizer to help cushion the effect of hunger in our community," he observed.

He appealed to government to assist deploy security operatives in the area to help restore the confidence of the community, saying that some victims had earlier told them that they trek with terrorists passing different Villages and crossing major roads to their destination.

# Zulum Flags Off 113km Construction Of Ring Road In Maiduguri City

orno State Governor, Babagana Umara Zulum on Monday, flagged off the construction of Maiduguri's 113-kilometre ring road project linking the east, west, and southern parts of the city.

The project is part of Governor Zulum's urban renewal drive, which aims to solve city congestion problems, address housing deficits, job creation and spur economic growth.

Zulum noted that the project would be executed in phases, starting with Maiduguri-Kano Rd. to Maid-Monguno Rd. via Maid-Gubio Rd., covering

16.5km

"Maiduguri, the capital of Borno State, is experiencing serious challenges as a result of the influx of internally displaced persons, which is putting huge pressure on the resources that we have inside Maiduguri to cater to the needs of the population, especially shelter and housing, among others. We are taking deliberate steps to decongest the city," Zulum said.

He added, "Borno State Government decided to start the first phase of the project, which is about 16.5km. In sha Allah, we shall not hesitate to expand this scope of work to cover the entire 113km

on the ring road."

The Governor also charge the Ministry of Works and Housing to ensure quality work that can stand the test of time. He said, "I want you to be very careful and ensure that this road, after completion, stands the test of time. Don't look at the cost, and do not compromise standards. I want this road to stand fresh for the next 30 years."

The Commissioner of Work and Housing, Engr Mustapha Gubio, has assured the Governor of the timely completion of the project while observing all the engineering specifications strictly.

Briefing the Governor, the Executive Secretary of Borno State Road Maintenance Agency, Engr Sadu Auno, said the road is a dual carriageway with 7.3 width thickness complying with federal government standards considering all engineering specifications.

Also speaking, the Executive Secretary of the Borno State Geographic Information Service (BOGIS), Engr Adam Bababe, said a compensation of over N1.6b was paid to 732 persons whose farmlands were affected due to the project.

He also noted that a residential, commercial, industrial, recreational, and institutional layout will be established along the ring road in a land mass of about 2,000 hectares.













# Ikpeazu Vs. Otti: Falsus In Uno, Falsus In Omnibus

igerian politics is far too divisive and toxic. In addition to the toxicity, there is a pervasive self-fulfilling prophecy that holds that all public servants are corrupt. As a result, both elected and appointed public officials in the past and present are unfairly subjected to relentless media trials based on this assumption, usually on trumped charges.

This sets the scene for understanding the current media trial that Dr. Okezie Ikpeazu, the former governor of Abia State, is facing. Among other defamatory claims, his successor, Dr. Alex Otti, asserted that his predecessor had paid N10 billion for an Abia state airport that did not exist. Otti claimed to be quoting from a forensic audit report that he had ordered, though it hasn't been released to the public or printed in a government gazette.

Otti appears to be acting like a magician, pulling what he pleases from the audit report—if it truly exists—and presenting it to the angry public, who act as juries and judges in media trials. The report is already accomplishing its goal of running Okezie Ikpeazu down.

However, it appears a boomerang is in the making. Otti's credibility could be damaged, as will that of his young government, which many believe is off to a smooth start if the information he released against Ikpeazu and released to the public to facilitate a media trial turns out to be false. Nobody will ever believe Otti again, and that will be pathetic.

"Falsus in uno, falsus in omnibus" is a Latin aphorism that translates to "false in one thing, false in everything." At common law, it is the legal principle that a witness who falsely testifies about one matter is not credible to testify about any matter. A witness who makes a false statement regarding one issue is not credible to testify about any other matter, according to common law.

The Stuart Treason Trials in the late seventeenth century are where the common law doctrines of "falsus in uno and falsus in omnibus" first appeared. The notion served as a required presumption that a witness was untrustworthy if they had previously lied in court.

English courts started advising juries way back in the nineteenth century that they could assume a witness who gave a false statement was not trustworthy. A required presumption of unreliability for witnesses or sources that have previously provided misleading testimony must also be upheld by discerning minds. A person must enter equity with clean hands.

Applied to the accusations made by the current governor of Abia State against his predecessor, whom he accused of embezzling N107 billion from the state during his tenure, including the assertion that Okpeazu spent a whooping N10 billion for an Abia state airport that never existed. Otti said his claim was the outcome of a report by one of the three best worldwide audit firms, as he defined them, which he said he commissioned to carry out a forensic audit as soon as he took office. Ikpeazu's aides and some informed Abians have dismissed Otti's claim of Ikpeazu paying N10 billion for a nonexistent airport as a malicious fabrication, saying that no additional money was ever paid beyond the N10 million paid for the preliminary spade works, such as site identification, clearing, and the like. They posit that the project was halted because it was widely believed that an airport was not a priority for Abians at the time.

The forensic audit report has reportedly not yet been made public, despite attempts to obtain a copy of it. Subsequent inquiries have shown that the aforementioned audit report has not yet been formally presented to and approved by the Abia State Executive Council. Otti hasn't even allowed his executive council to see it and is still keeping it close to his chest.

Furthermore, what is in the public domain points to the fact that the payment for a nonexistent Abia Airport used to stigmatise and mock the former governor, Ikpeazu, does not exist, just as the Abia State Airport does not exist either. So one might wonder why there is a rush to selectively release to the public portions of the audit report that is not yet been adopted.

The question is: Is Governor Otti simply trying to play politics with the public's perception for optics' sake, providing something for the media trial of his predecessor, and igniting a media frenzy? If Governor Otti did fabricate the N10 billion tales, he may have unintentionally destroyed any credibility that may have been in the forensic audit report since it is laced with lies that may have been injected to mask the truth.

It is right to state that Section 308 of the Constitution prevents Otti from being sued while he is in office for defamation. According to Section 308 of the Constitution, "no civil or criminal proceedings may be instituted against the President, Vice-President, Governor, or Deputy Governor, and they may not be arrested or imprisoned, nor may any process of any court requiring or compelling their appearance be issued against them." So, Otti is safe.

However, Ikpeazu still has some recourse (after the harm he sustained is confirmed by Otti's inability to substantiate his claim). Once the falsehood is confirmed, the audit report will be rendered meaningless, and the public will perceive it as more of a witch hunt than anything else.

When Nyesom Wike became the governor of Rivers State, a similar situation occurred there as well. He launched a comparable audit inquiry into the tenure of Chibuike Amaechi, his predecessor. Because the report was a witch hunt, it never saw the light of day. It was a precedent Otti should have been familiar with.

In particular, Otti should officially receive the report without further delay, have the Abia State Executive Council adopt it, and leave it available for public review as well as impartial, independent interrogation and investigation. If it is true that Otti did not fabricate at least some parts of the report to get media conviction against his predecessor, making the audit

report available to the media shouldn't be an issue at all. The fact that this procedure was the one that ought to have been followed also underlined the fact that Otti was essentially putting the cart before the horse when he released portions of the forensic audit report piecemeal, which many have trashed as untrue.

Ikpeazu's experience demonstrates that the media trial of public officials in Nigeria has deep ramifications and implications for the battle against corruption. Even if the victims can prove their innocence, they are not granted real relief because the accusers never go back to debriefing the Nigerian public about the lies they peddled or offering an apology to the good Nigerians who have been maligned and falsely shown to other people as criminals.

In Ikpeazu's case, Governor Otti must come clean by providing the media with proof of the funds made for the fictitious Abia State Airport, along with the name of the receiving firm or firms. If Ikpeazu never paid such money and there is no such evidence, Otti owes Ikpeazu a public apology.

The media should keep a close eye on this case, as it is a seriously developing story. Either Ikpeazu paid N10 billion for the airport or he did not, or Otti made up the tale or he did not.

As required by both the ethics of journalism and the law, the media should continue to hold public officials innocent until their guilt is proven by the courts and should assist in advocating for justice for those who have not been found guilty as charged. In addition, the media must continue to follow the two golden laws of journalism: hear the other side of the story and, when in doubt, leave out, while also conducting more in-depth investigations.

To determine if this is a case of falsus in uno or falsus in omnibus—"false in one thing, false in everything," as many now suspect—Nigerians are waiting for the declassification of the Otti's forensic audit report. He who alleges must prove.

Okezie Ikpeazu should take turns laughing last and should have his integrity back if indeed the phantom airport payment is a fabrication and politics.

# Niger Delta Region; NDDC And Sustainable Development

eports have it that at Harvard Business School, United States of America (USA), the code of belief about entrepreneurship is quite simply this: It can be taught, and it can be learned. Entrepreneurship is, to use HBS's quasiofficial definition, "the pursuit of opportunity without regard to resources currently controlled." It is not so much a set of skills as it is a process, a belief, and a commitment. It is a mode of thinking and acting - a war of observing the world, of figuring out how to change it (hopefully for the better), and, perhaps most important, of becoming the person who is capable of implementing the change'.

Likewise, there is a veiled agreement among critical stakeholders that one of the outstanding boards in the present day Nigeria that is visibly capped with skills, belief, commitment, mode of thinking and in vigorous pursuit of opportunities to sustainably remove obstacles on the part of its targeted beneficiaries without regard to resources currently controlled, is the Barrister Chiedu Ebie led governing board and management of the Niger Delta Development Commission (NDDC), a Federal Government agency created in the year 2000 by enabling Act, to offer a lasting solution to the socio-economic difficulties of the Niger Delta Region and to facilitate the rapid and sustainable development of the Niger Delta into a region that is economically prosperous, socially stable, ecologically regenerative and politically peaceful.

Adding context to the discourse, ever since crude oil was discovered in the region more than 50 years ago, the people of the region could not have imagined that they would bear the brunt of the country's main source of revenue. The people must have expected that the exploitation of the rich natural resources they have in their environment would have brought them development and prosperity. But alas, it has been a very painful experience for the people of the region.

Essentially, it is not as if past administrations in the country did not, at different times and places make efforts to address the region's challenges. But noble as those efforts were, considering the level of underdevelopment in the region, such effort appeared too insignificant and short of what is required to carter for the region's development and more particularly, remains a far cry from what was needed to exorcise the ghost of youth unemployment in the region. This ugly narrative persisted in the face of concerns raised by the global community who were chiefly not convinced that what now rested administrations were doing was the best way to solve the problem of the region.

Understandably, there is some truth in those concerns as expressed just as there is presently, a silver lining in the horizon. What we have today is an exact opposite! Niger Deltans of goodwill are equally of

the views that what the region is experiencing this time around may no longer be the second half of a recurring circle, rather the beginning of something new and different.

Aside from the fact that the new governing board and management have to their credit, a well-established healthy relationship with critical stakeholders within the region and beyond, also worth underlining and of course, a lesson other agencies and Commissions must imbibe, is the frantic efforts to put the Niger Delta region in order via youth empowerment, human capital development and democratized infrastructural provisions.

A delectable account further indicates that the policy thrust and programmes coming from the new governing board and management of the agency amply qualify as development-based. This particular point partially explains why this piece is interested in the ongoing developmental strides in the region.

Prominent among these projects, programme and initiative include, namely; Building Partnerships, Lighting Up the Niger Delta region, Sustainable Livelihood, Improved Youth Capacity and Skills Base, Efficient and cost effective projects, Project Hope for Renewed Hope, Carbon Emission Reduction, Stakeholder Engagement, Effective and Professional Workforce, Improved Peace and Security among others.

From what development professionals are saying, a programme is said to be development based, when such a programme entails an all-encompassing improvement, a process that builds on itself and involves both individuals and social change. It requires growth and structural change, with some measures of distributive equity, modernization in social and cultural attitudes, a degree of political transformation and stability, an improvement in health and education so that population growth stabilizes, and an increase in urban living and employment. Viewed broadly, it is public knowledge that throughout the early decades, the world paid little attention to what constitutes sustainable development. Such conversation, however, gained global prominence via the United Nations introduction, adoption and pursuit of the Millennium Development Goals (MDGs) which lasted between the year 2000 and 2015. It was among other intentions aimed at eradicating extreme poverty and hunger as well as achieving universal primary education, promoting gender equality, reducing child mortality, improving maternal health, among others.

Without going into specific concepts or approaches contained in the performance index of the programme, it is factually supported that the majority of the countries including Nigeria performed below average. And, it was this reality and other related concerns that conjoined to bring about 2030 sustainable agenda- a



United Nations initiative and successor programme to the Millennium Development Goals (MDGs)- with a collection of 17 global goals formulated among other aims to promote and cater for people, peace, planet, and poverty. And has at its centre; partnership and collaboration, ecosystem thinking, co-creation and alignment of various intervention efforts by the public and private sectors and civil societies.

Very remarkable is that all the NDDC's projects/programmes were crafted in line with the above initiatives.

If in doubt, checkout the agency's scheme known as Holistic Opportunities, Projects and Engagement, (HOPE); It is primed to provide a platform to empower youths of the region on sustainable basis, designed to create a comprehensive resources database of the youth population of the Niger Delta region to enable NDDC see clearly what the youths want in their strive for sustainability in conformity with international best practices and development.

The project HOPE' initiative is positioned for creating youth employment opportunities, especially in agriculture through support to small-holder farmers in order to ensure operational growth while shifting from traditional to mechanized farming methods. "Because of the arable wetlands, rainfalls and other favourable ecological factors to plant various crops and vegetables at least four times within a farming season, the agency is proactively moving away from the oil economy to the agricultural sector which can accommodate our youths in large numbers is the agricultural sector."

For me, NDDC's solutions to youth

unemployment and development of climate for sustainable future and innovation will assist promote the critical thrust of governance and maximize the benefits citizens derive from governance. For example, talking about the youth unemployment in Nigeria, a report recently puts it this way: "We are in dire state of strait because unemployment has diverse implications. Security wise, large unemployed youth population is a threat to the security of the few that are employed. Any transformation agenda that does not have job creation at the centre of its programme will take us nowhere".

As we know, youths challenge cuts across, regions, religion, and tribe, and has in the past led to the proliferation of ethnic militia as well as youth restiveness across the country.

What the above information tells us as a nation is that the ongoing creative and transformative leadership at NDDC calls for collective support as well as should be used as both a model and template by all strata of government in the country, for correcting public leadership challenges via adoption of approaches that impose more leadership discipline than conventional, and less extractive but more innovative in operation. it is in doing this that we can achieve sustainable development as a nation.

#### Under Tinubu, Corruption Is Fighting Back With Gusto

ESTERDAY, civil society organisations under the leadership of Auwal Musa Rafsanjani of the Civil Society Legislative Advocacy Centre (CISLAC) held a press conference in Abuja to express their alarm at the bold, supported and fearless manner politically exposed individuals are fighting against all attempts by anti-corruption agencies seeking to investigate and prosecute them. It was Nuhu Ribadu, the former Chairman of the EFCC who told Nigerians so many years ago that if you fight corruption, it fights back

This has eroded public trust in the government and undermined the legitimacy of the democratic process.

Today, fighting back has reached the critical phase where state institutions are being subverted and domesticated by the corrupt. Today, across the country, millions of Nigerian citizens have invested their hopes in our democracy. There is a groundswell of expectations that as our fledgling democratic system of government takes shape; it will address the deprivations faced by long-suffering citizens. Citizens are now waking up to the fact that their aspirations are continuously dashed by the ruling class. It's widely accepted that transparency and accountability are crucial elements that enable democracies to flourish. In Nigeria, however, our so-called "democracy" has persistently functioned under a veil of secrecy and lawlessness. The management of the country's resources has consistently disregarded the fundamental principles of democracy.

Over the past few weeks, we have observed with great concern, the malicious attacks and deliberate efforts to blackmail anticorruption agencies through sponsorship influencers, incentivised opinion publications in some national dailies. online and electronic platforms, all targeted at discouraging anti-corruption efforts and shielding the kleptocrats from thorough investigation. The pattern is clear, there is an unfolding plot of surreptitious moves to backpedal on the progress made by anticorruption agencies that we outline below: Judicial corruption constitutes a major challenge to anti-corruption work in Nigeria. The looters have repeatedly used their influence to manipulate the judicial process and system, to block and/or delay the arrest or prosecution of suspects. This blatant disregard for the rule of law has eroded public trust and reinforced the perception that Nigeria's democracy is

nothing more than a facade.

Clearly, the judiciary is not living up to its responsibility of ensuring that the rule of law and provisions of the constitution are upheld.

There have been several allegations of judicial officers receiving bribes from politicians and politically exposed persons in-order to circumvent the law. This has watered down the respect, trust and confidence of citizens in the judiciary and negatively impacted the fight against corruption. Nigerians have witnessed too many situations where courts have granted injunctions which deterred anti-corruption agencies from inviting and prosecuting corrupt government officials and politically exposed persons.

Nigerians have witnessed with alarm numerous cases featuring a high number of foreign enablers from Switzerland, Monaco, Panama, British Virgin Islands and the United Kingdom (UK) facilitating corruption. Enablers from the UK are particularly strongly linked to Nigerian cases. Of course, Nigeria also has a large coterie of internal enablers who facilitate and protect the corruption process and its key actors.

The key issue is the procurement of political appointments by treasury looters serving under the current administration as ministers, legislators, or occupying leadership positions of the ruling party. They have exposed anti-corruption work to serious setback and deliberate sabotage that cripple the efficiency of the anti-corruption agencies. It is distressing to see people facing corruption allegations being appointed by the President to handle various positions of authority. Today, many serving law makers and ministers have corruption allegations against them. This is producing a culture of impunity, where politicians engage in corrupt practices without fear of consequences. This has eroded public trust in the government and undermined the legitimacy of the democratic process.

The budgetary allocations to the Economic and Financial Crimes Commission (EFCC), Independent Corrupt Practices and Other Related Offences Commission (ICPC), Code of Conduct Bureau (CCB) and Nigeria Police, among others are inadequate. Poor resource allocation is a calculated attempt to gradually push these agencies towards extinction. By limiting their resources, the government is effectively crippling their ability to function effectively and independently.

We are also concerned by the recent withdrawal of police from the Kano State Public Complaints and Anti-Corruption Commission. This withdrawal of about 40 police officers who were responsible for security and investigative tasks has not only hampered the work of the anti-corruption agency in Kano State, but also endangered the police's obligation to operate with impartiality and independence. It appears that this move is not unconnected to the attempt to frustrate the ongoing investigations into corruption allegations levelled against the National Chairman of the ruling All-Progressives Congress (APC) and former governor of Kano State, Abdullahi Umar Ganduje.

One of the most dangerous developments in the country is the massive recruitment of young persons into different forms of criminality. These include traditional sectors such as political thuggery and cultism but also new sectors such as cybercrimes, human and drug trafficking. More youth are daily becoming engaged in criminal activities including ritual killings, cyber-crimes, kidnapping, prostitution, robbery and banditry. In the process, the youth, whose collective future has been continuously


mortgaged by our morally bankrupt and corrupt politicians have to take a clear stand today. A good future for them would require that they take a clear stance in the struggle against corruption and all forms of criminality.

# May Day Calls And Clashes In A Year Of Genocide

HE STREETS of the world exploded on Wednesday as workers and students, marchers and protesters, sent May Day calls and, in several cities, clashes erupted over local needs and international concerns.

In Nigeria, for instance, where Cuban Ambassador Miriam Morales Palmero on behalf of the international community addressed the May Day rally in Abuja, the Nigerian unions declared: "The economic embargo placed on the nation by the US is an unacceptable punishment for the citizens of Cuba as it seeks to restrict their ability to access the basic necessities of life. The US as the bastion of democratic expressions ought to show leadership in this direction so that the people of Cuba can breathe."

The streets of France, Greece, United States, Chile, Cuba and several cities around the globe, quaked over the Gaza War.

In Nigeria where abysmally low wages, fuel scarcity, a drowning currency and a run-away inflation ruled the waves, the primary international concern for the world-wide protests, was expressly stated. The Trade Union Congress of Nigeria (TUC) and the Nigeria Labour Congress (NLC) made a joint declaration about the on-going genocide in the Palestine: "The UN mechanisms have unfortunately become undertakers and not life savers or peace-making."

Echoing the universal calls on Workers Day, the twin labour centres stated unequivocally: "War does not benefit workers and the masses. It is mainly workers and the people that die in wars! These wars are therefore not for the protection of the people of the world and neither in our interests. It is purely driven by those who profit from wars — the bourgeoisies either in the West or in the East. We call for global peace and cessation of hostilities so that the killing of men and women and the massive suffering will end."

This message of Nigerian trade unions was re-echoed in German cities with a youth in Berlin carrying the message: "The rich want war – the youth want a future." Christening the 2024 May Day as "Revolutionary", German workers displayed solidarity symbols with Palestinians and protested against Israeli violation of Palestinians' right to life.

In Greece, thousands of workers marched through Athens bearing twin demands: pay rises that would bring wages to average European standards, and against the war in Palestine. They massed on the Greek parliament waving Palestinian flags, singing solidarity songs and letting balloons fly.

In the United Kingdom, workers marched on the Trade Department in London and blockaded arms factories in Lancashire, Wales and Scotland, demanding that arms export licences to Israel should be revoked. There were pickets at Barclays and BNY Mellon banks in Manchester for investing in Ebit System. The company produces 85 per cent of the land and air munitions used by the Israeli military. Members of the Palestine Action group which initiated the picketing said: "We will not tolerate genocide profiteers on our streets."

Brazilian President Luiz Inacio Lula da Silva, a former leader of the labour centre, CUT, announced tax cuts for the poor. He told Brazilians: "In our country, there will be no

tax breaks to favour the richest, but to those who work and live off their wages." In Cuba, the people practically emptied into the streets of Havana, at the foot of the giant statue of Jose Marti, the prophet of the South American independence movement. The Cuban Institute of Friendship with the Peoples (ICAP), stated at the rally: "We demand an end to genocide in Gaza, and Cuba's removal from the false list of countries that sponsor terrorism."

These twin demands resonated in some countries. In Nigeria, for instance, where Cuban Ambassador Miriam Morales Palmero on behalf of the international community addressed the May Day rally in Abuja, the Nigerian unions declared: "The economic embargo placed on the nation by the US is an unacceptable punishment for the citizens of Cuba as it seeks to restrict their ability to access the basic necessities of life. Clashes broke out in some French cities. In Paris, the clashes led to a number of injuries. The victims included a dozen policemen. The workers led by the labour confederation, CGT, protested for better cost of living, reform of unemployment benefits and, against the genocide in Palestine.

President Cyril Ramaphosa, the country's President and former scribe of the Mine Workers Union, told the rally: "You as workers, need to join this fight to fight for those who are oppressed around the world. And today as South Africa, we have stood up for the rights of those in other parts of the world (who) are currently being subjected to torture, to violence and genocide." Early morning May Day, pro-Israeli protesters launched attacks on the pro-Palestinian encampment on the University of California, Los Angeles (UCLA) campus in an effort to overrun it. On the eve of May Day, protesters set up barricades in Santiago, Chile and three persons were wounded by gunfire. On this, progressive President Gabriel Boric regretted: "We are normalising violence, we cannot allow criminal gangs to take over the streets of our country." His words appeared to have sunk in as there were no untoward incidents during the May Day activities organised by the Central Unitaria de Trabajadores (CUT).

In Istanbul, where thousands took on security forces with 210 persons detained, the protests were over inflation, demands for higher wages, labour rights and for a free Palestine.

The pro-worker Bolivian President, Luis Arce, who joined the workers march, announced a 5.8 per cent wage increase in the country.

Brazilian President Luiz Inacio Lula da Silva, a former leader of the labour centre, CUT, announced tax cuts for the poor. He told Brazilians: "In our country, there will be no tax breaks to favour the richest, but to those who work and live off their wages."

In Lebanon, the workers marched against the economic crises which had also involved banks insolvency, and against the genocide in the Palestine. The crowds poured into the streets of Sri Lanka, a country that declared bankruptcy two years ago. The protests mainly focused on rising prices, especially of electricity and higher taxes.

Some of the largest pro-Palestinians rallies on May Day took place in South Africa. Supporters of the ruling African National Congress (ANC) organised solidarity marches in the streets before heading to the Athlone Stadium where they joined the May Day rally hosted by party ally and, the largest labour centre, the Congress of South African Trade

Unions (COSATU).

Alongside Palestine, was the support for the people of the Sahrawi Arab Democratic Republic, better known as Western Sahara. Large portions of the country are occupied by Morocco in an attempt to recolonise the former Spanish colony. The Nigerian trade unions declared: "Humanity remains in bondage as long as the United Nations continues to allow the aberration by Morocco to continue."

President Cyril Ramaphosa, the country's President and former scribe of the Mine Workers Union, told the rally: "You as workers, need to join this fight to fight for those who are oppressed around the world. Large portions of the country are occupied by Morocco in an attempt to recolonise the former Spanish colony. The Nigerian trade unions declared: "Humanity remains in bondage as long as the United Nations continues to allow the aberration by Morocco to continue."

The strident 2024 May Day calls will continue, so long as portions of the human race face extinction.


